The ornamental design for an adhesive sticker set for shoe, as shown and described.

FIG. 6 is a bottom view thereof;

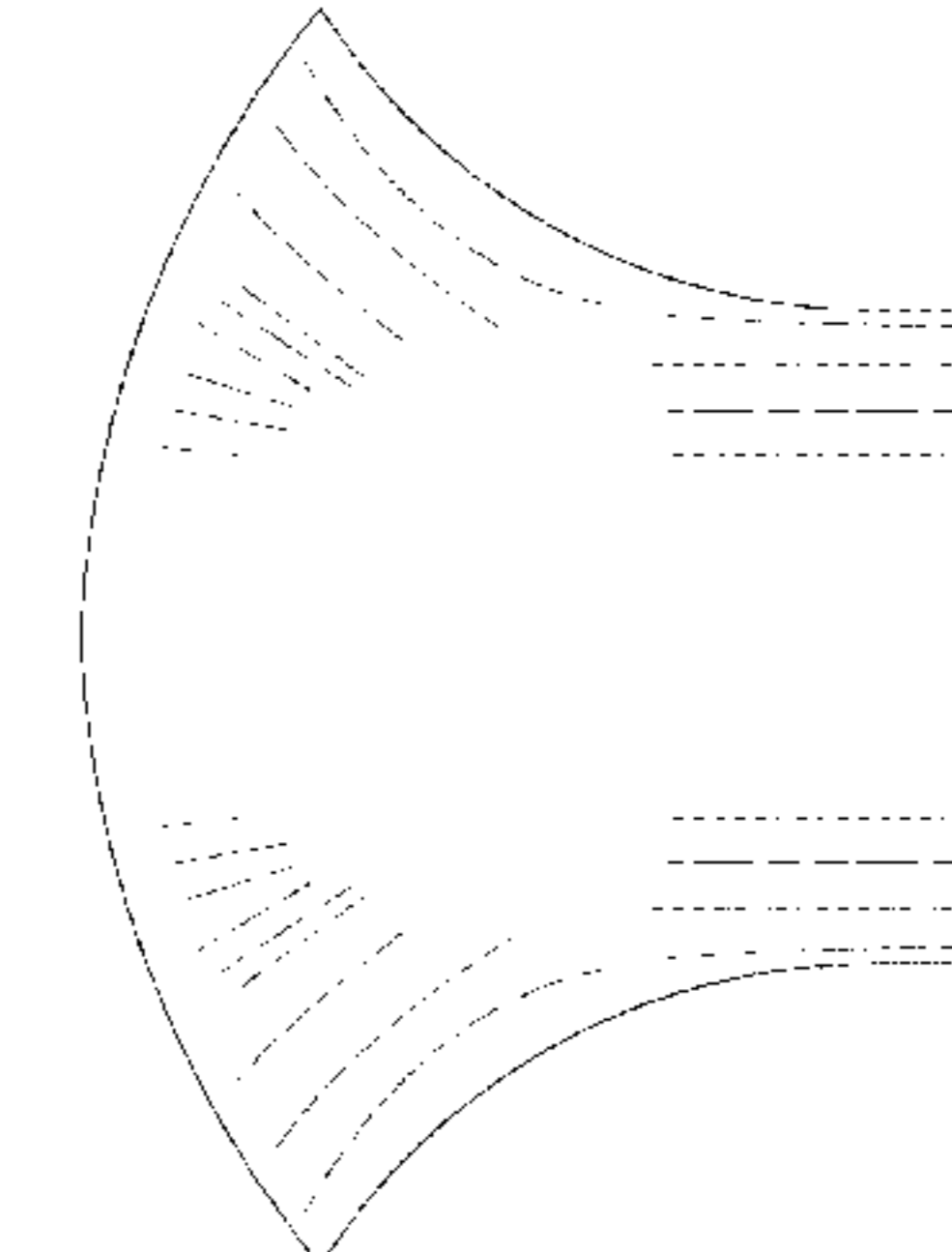
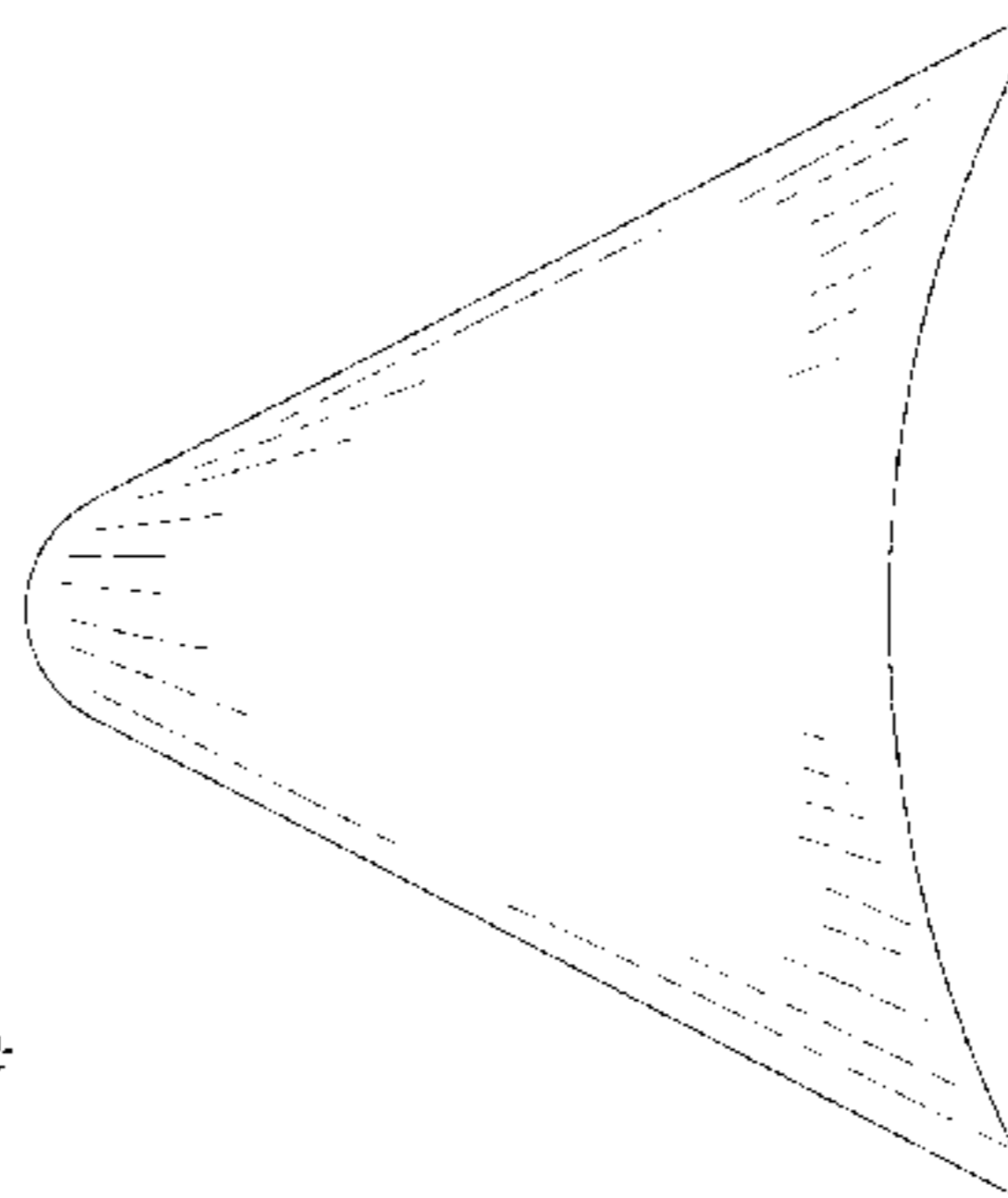
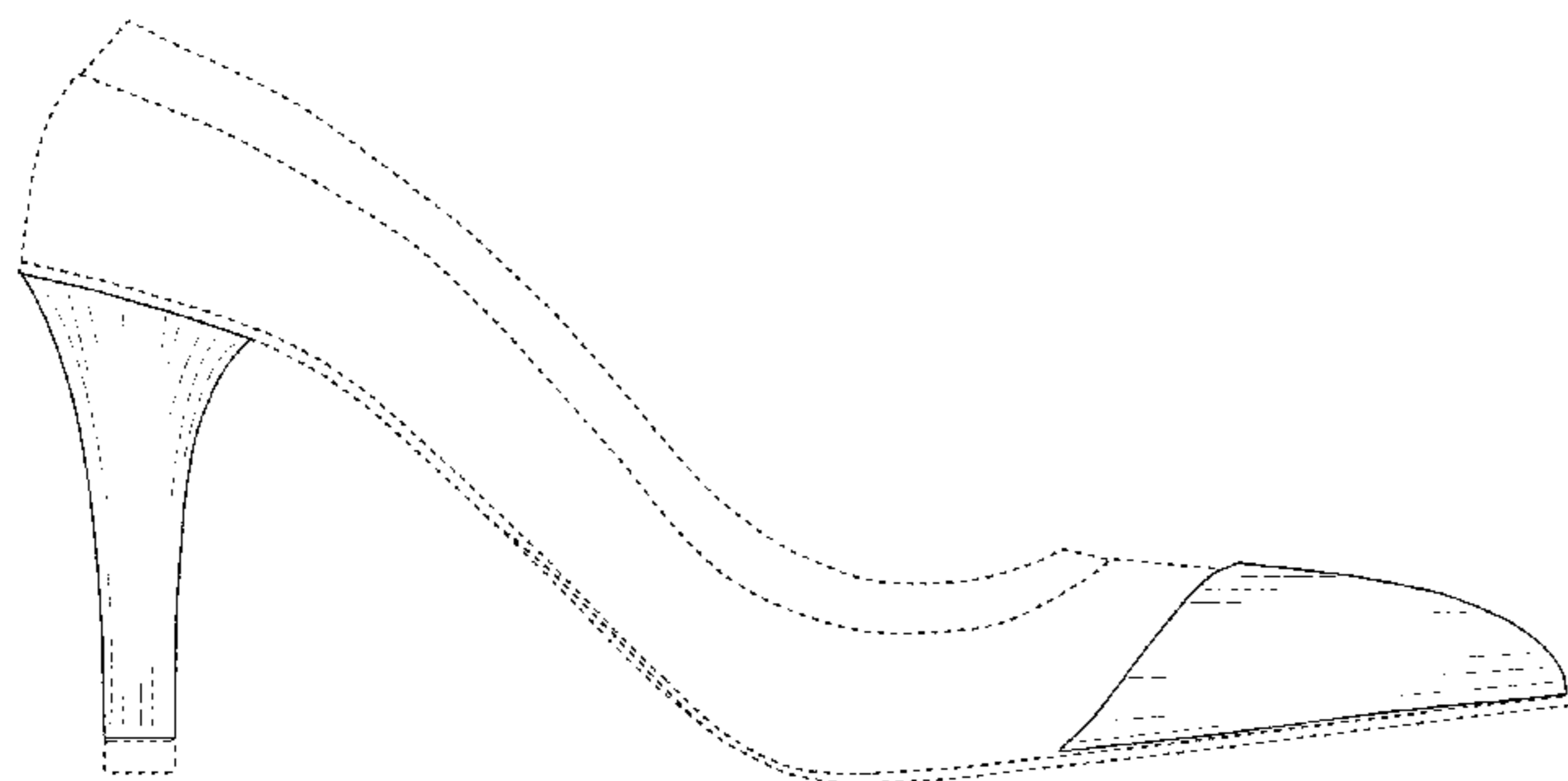
FIG. 7 is a left view thereof;

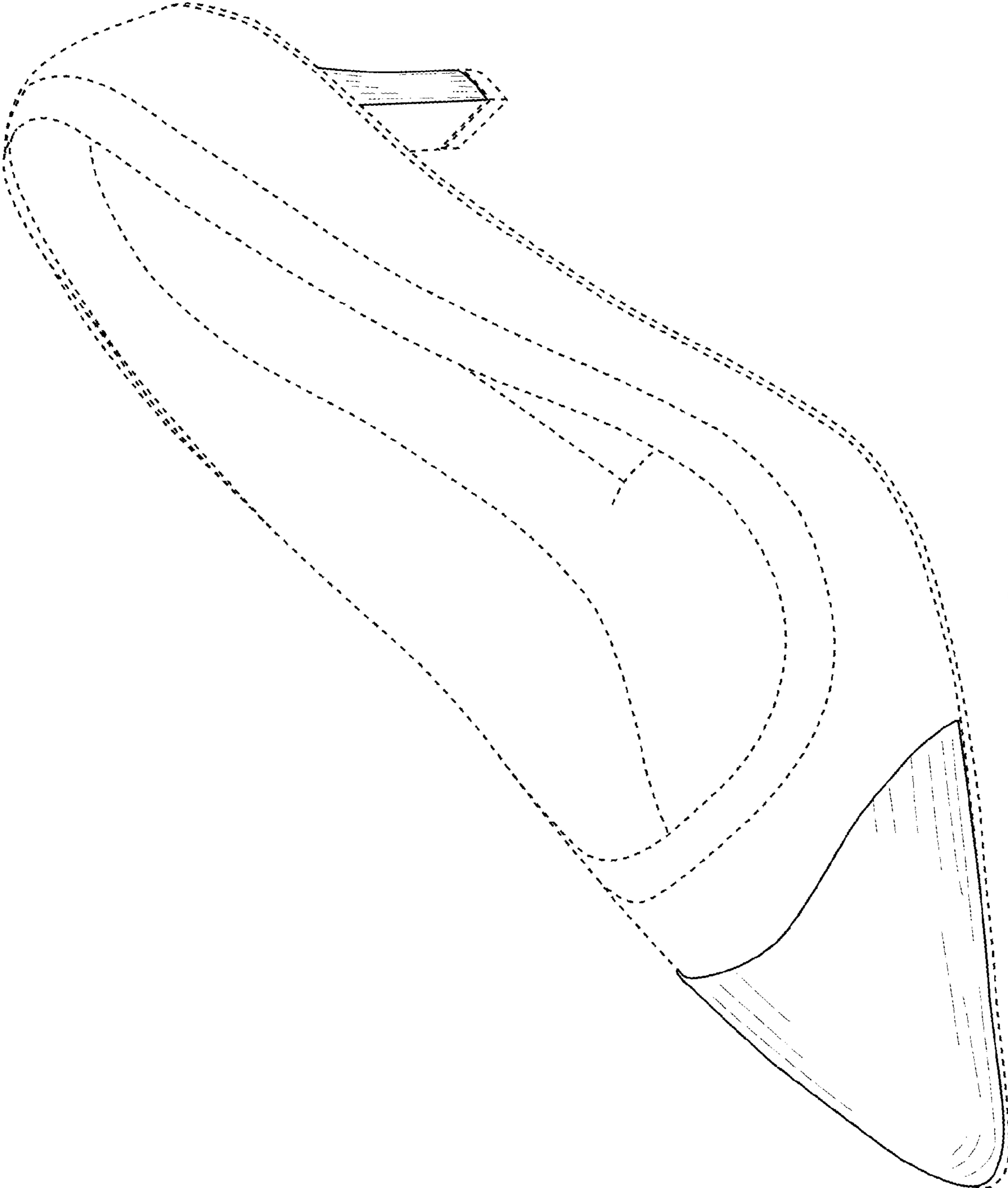

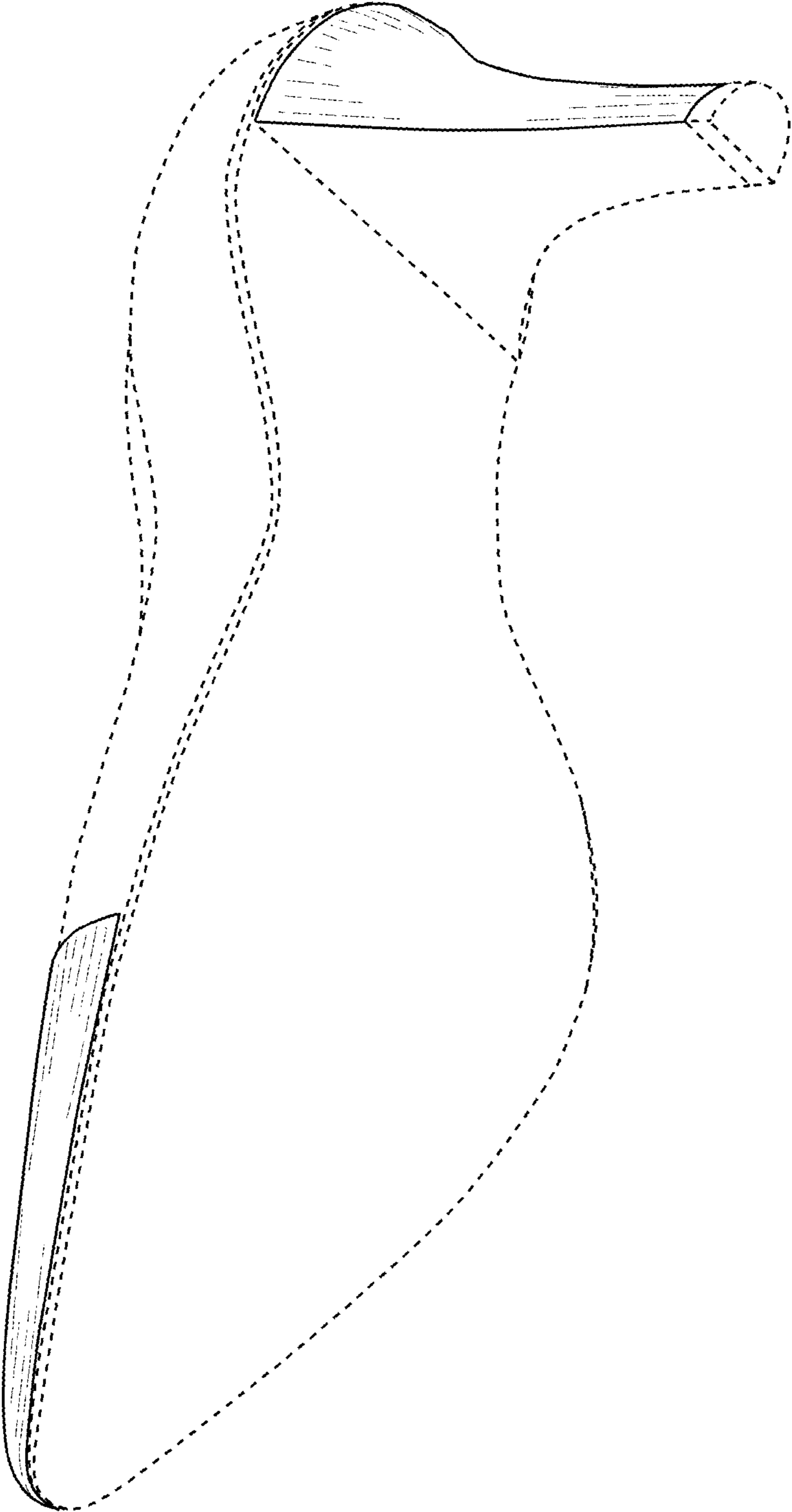

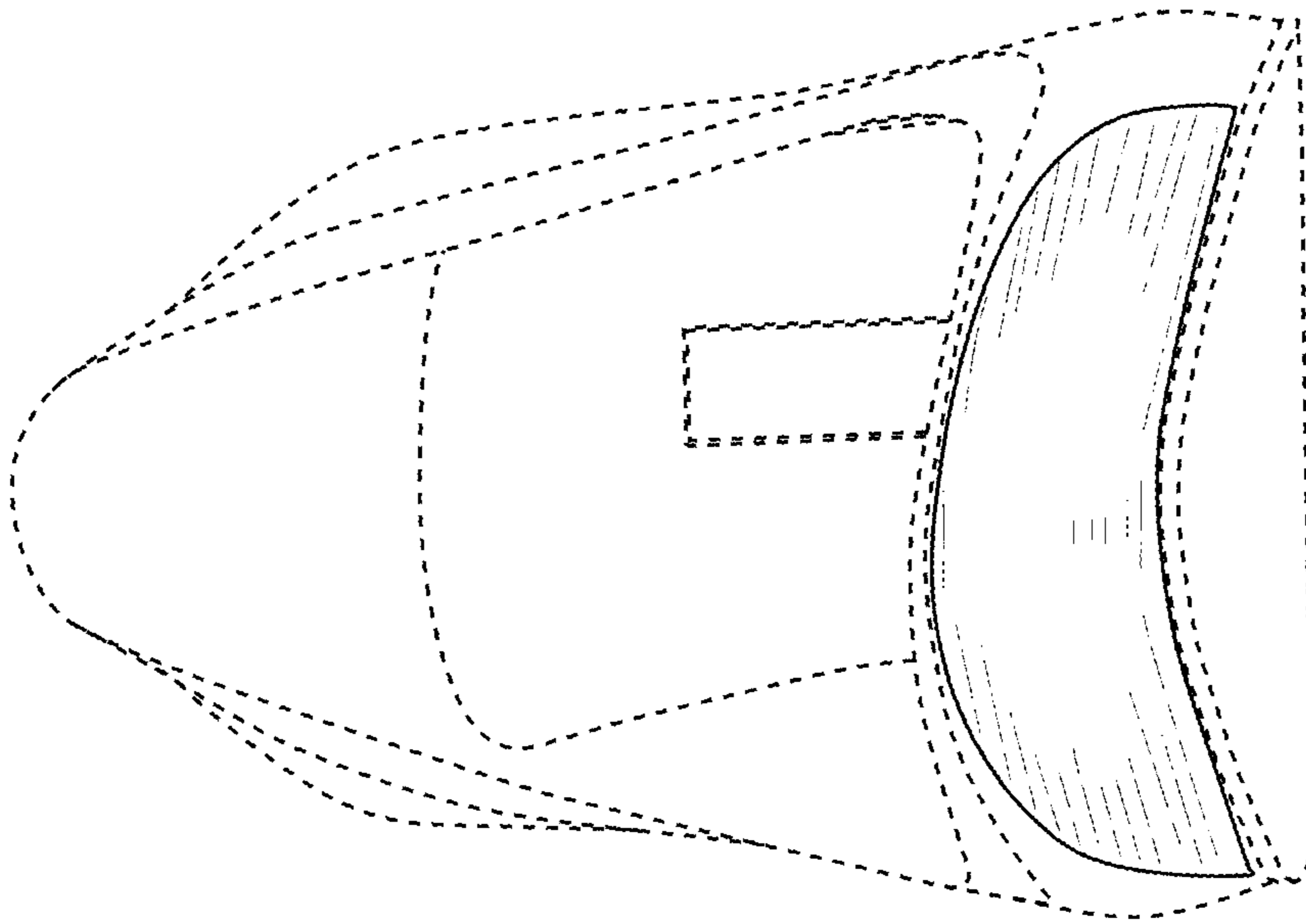

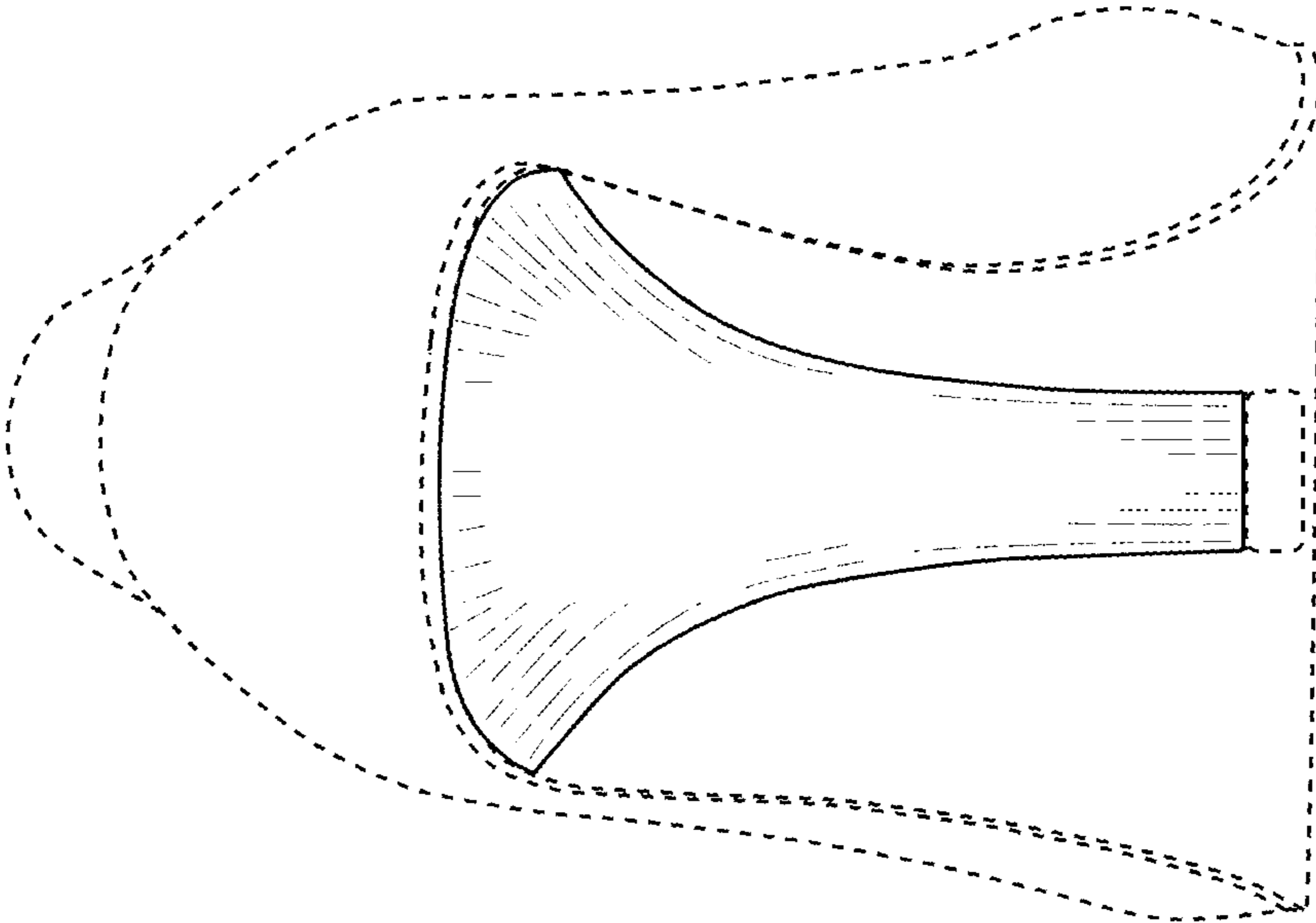

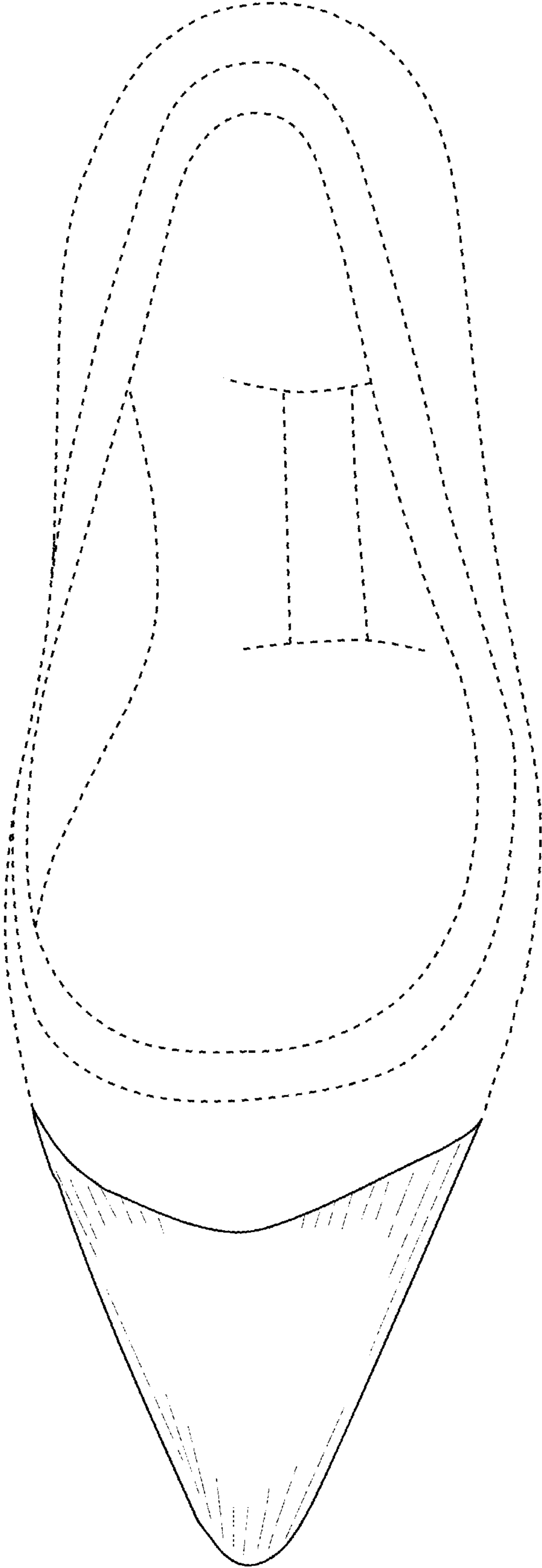

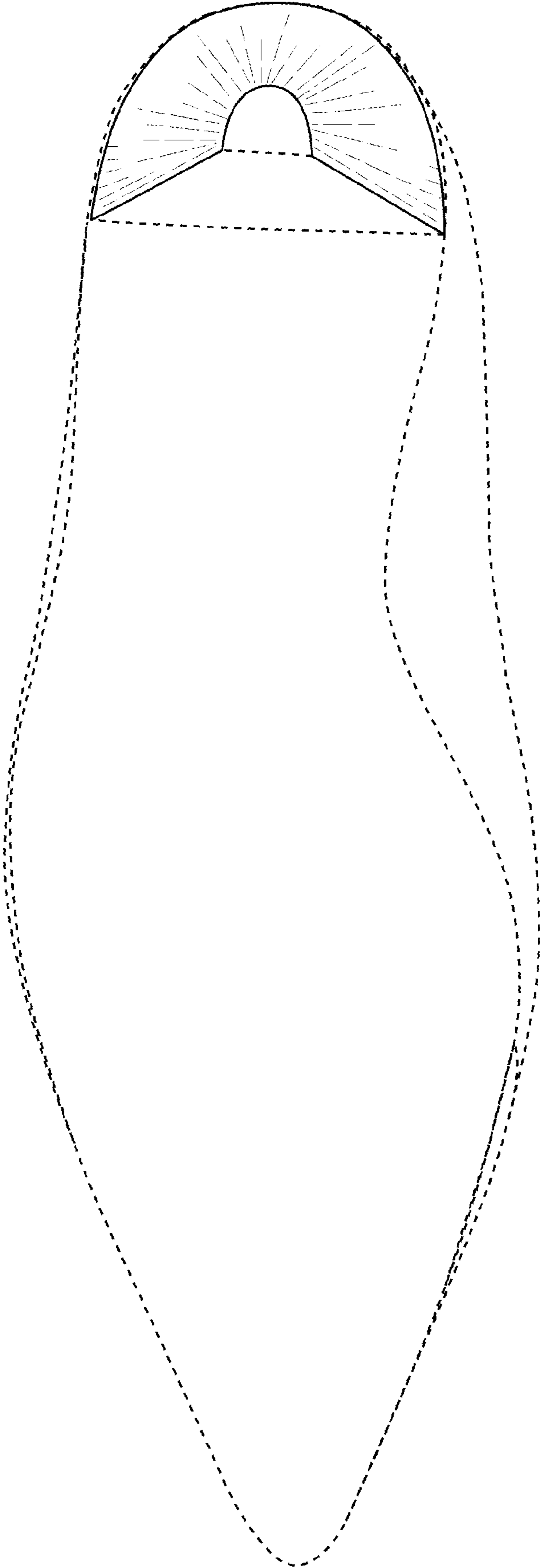

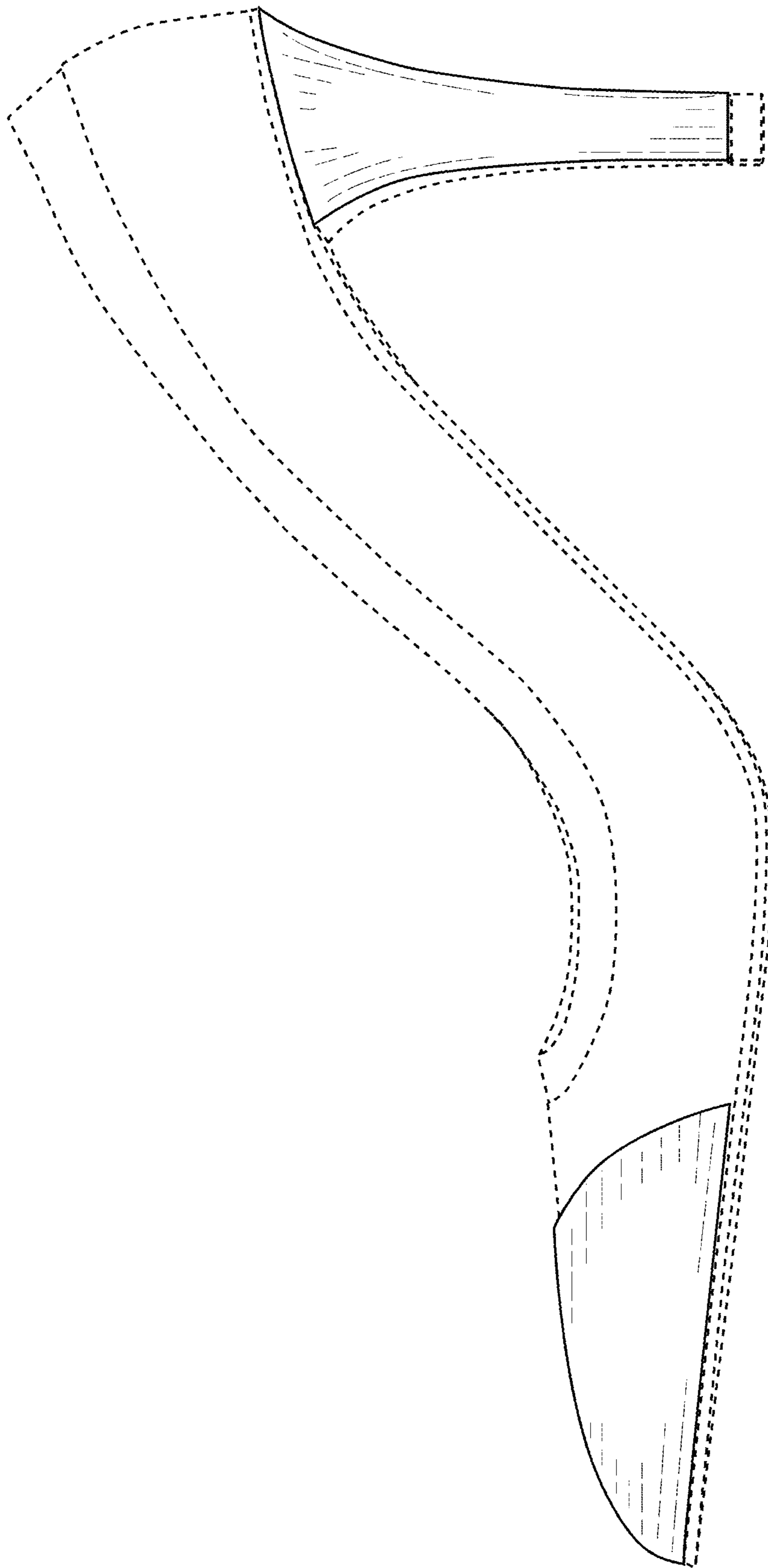

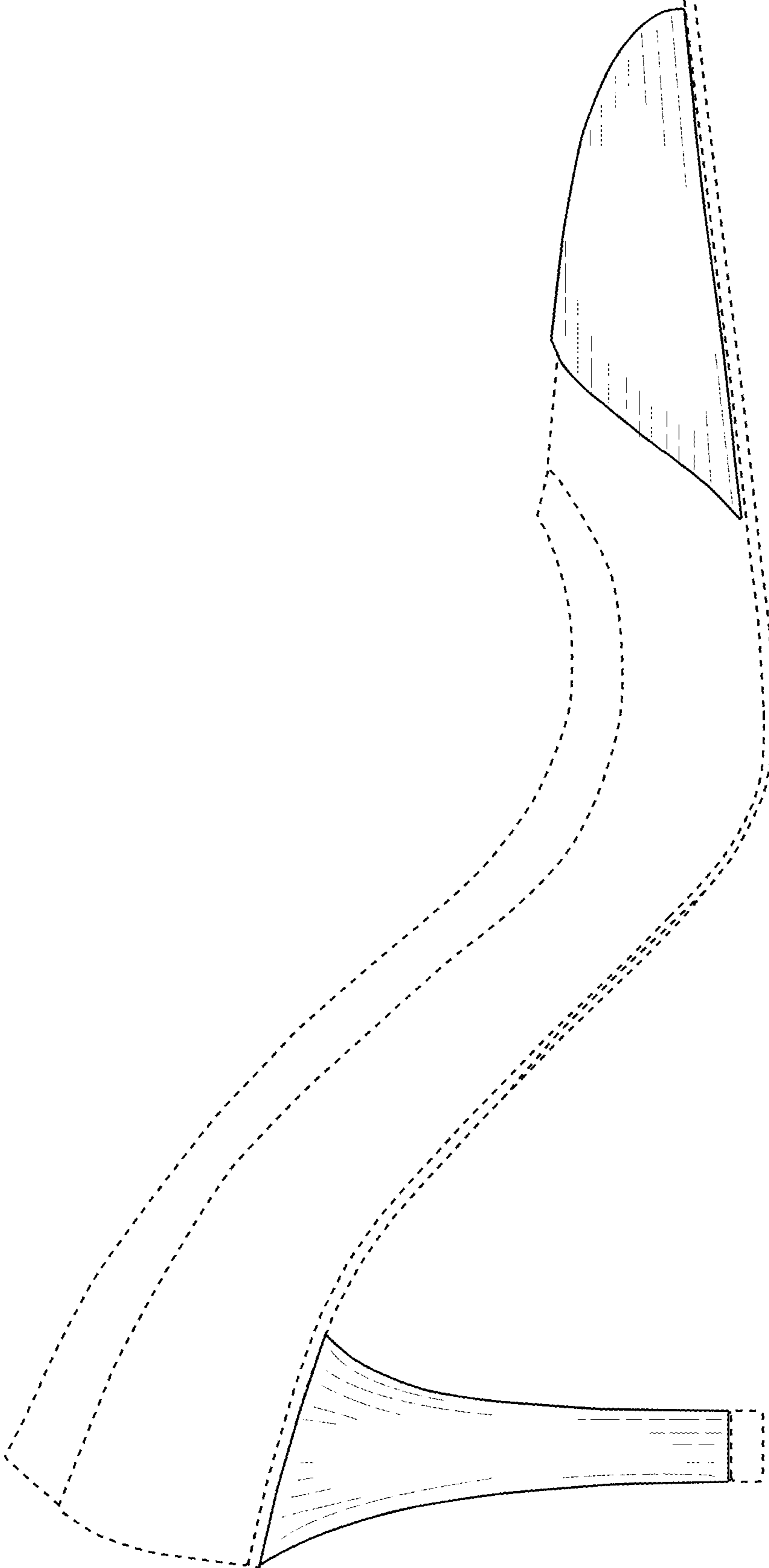

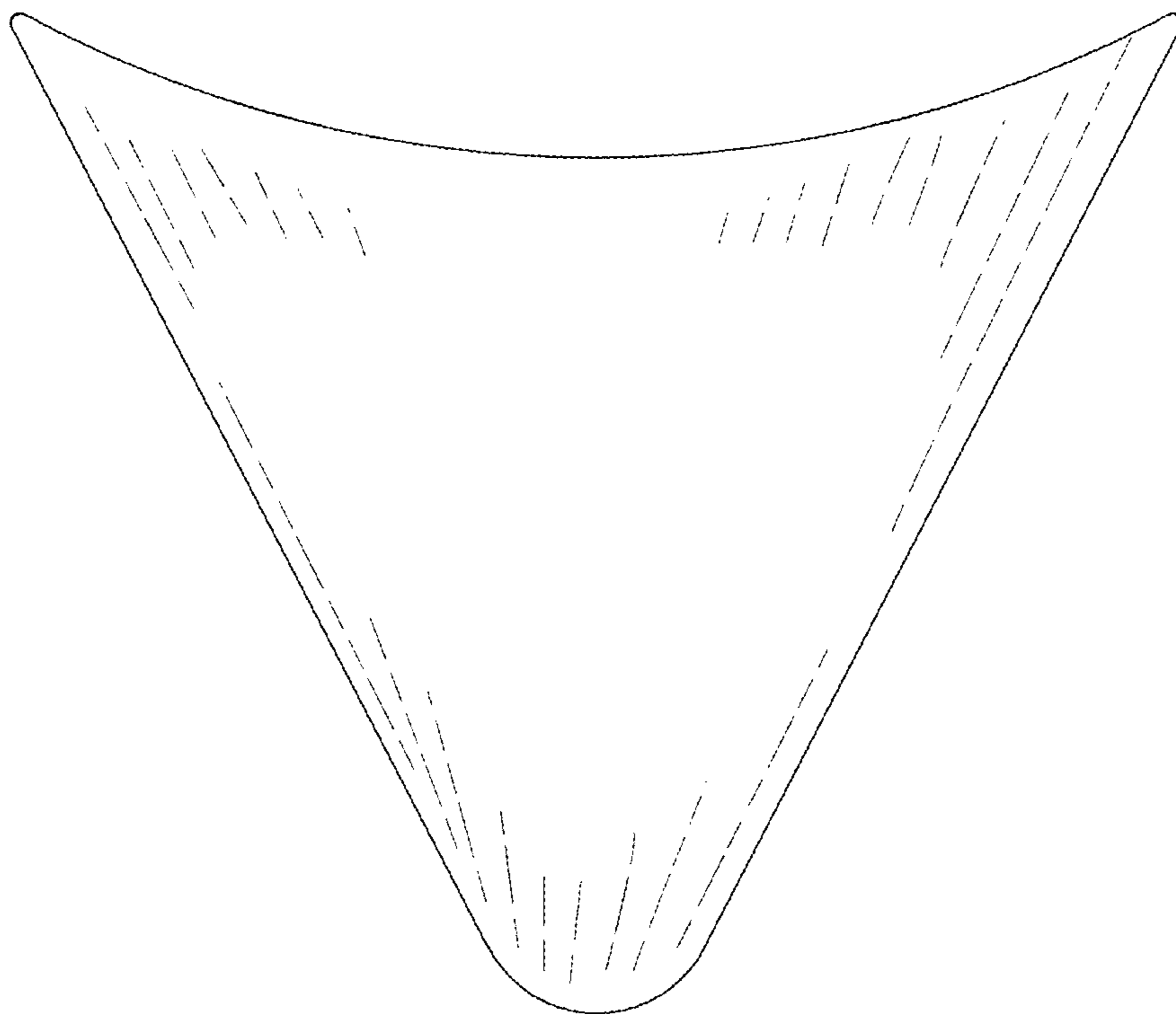
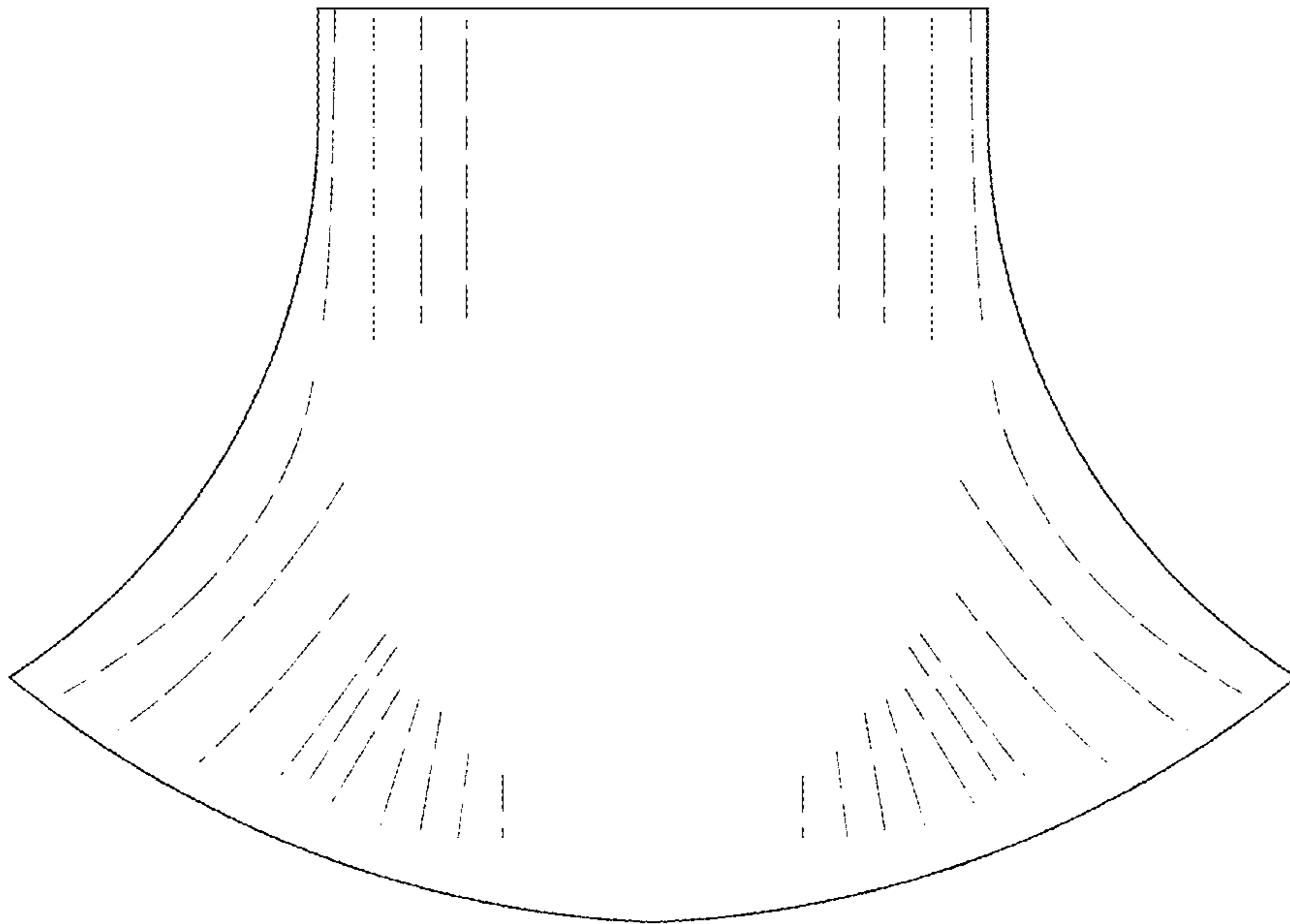
