(57) **CLAIM**

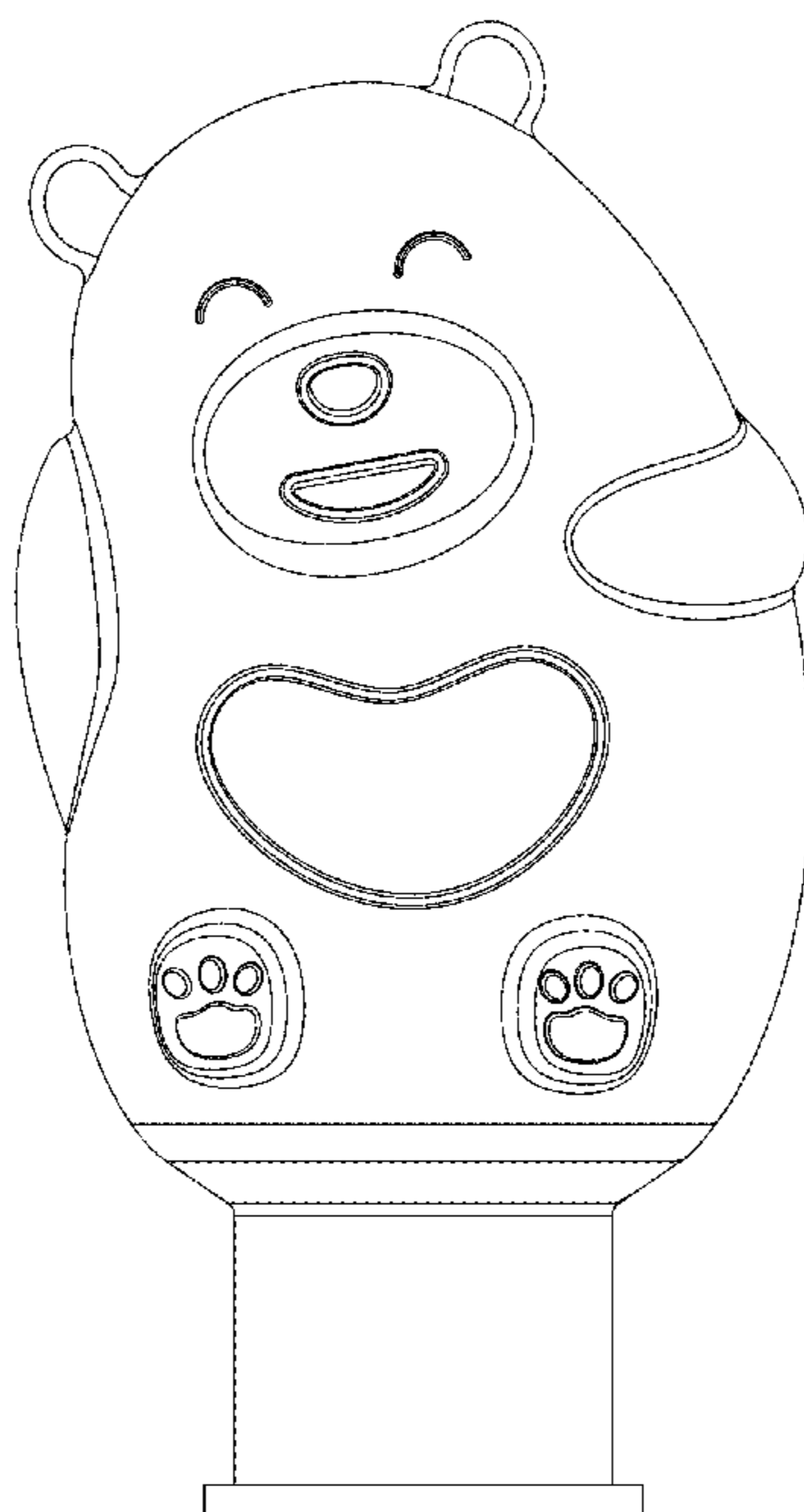
The ornamental design for a travel packing bottle, as shown and described.

DESCRIPTION

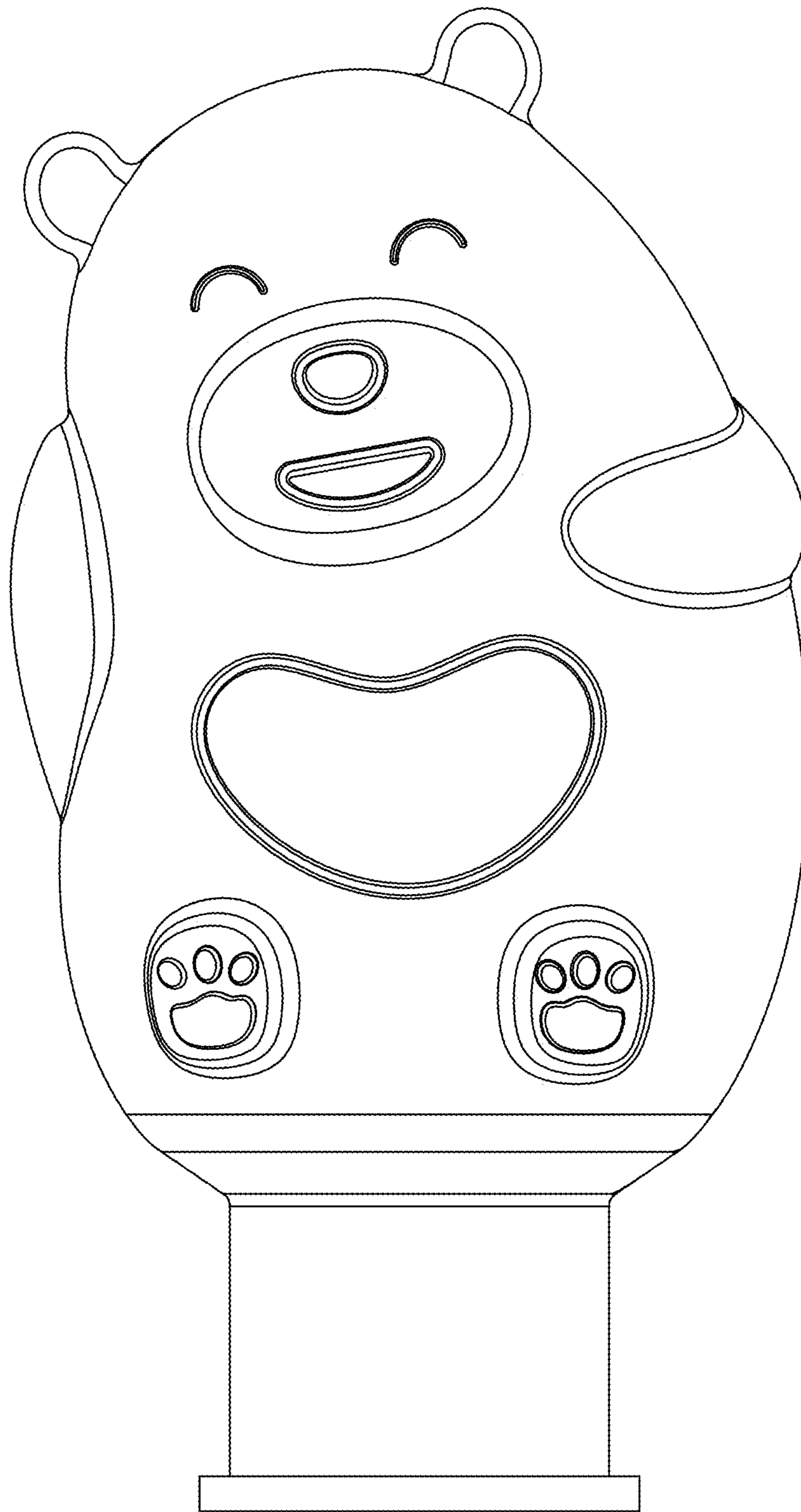

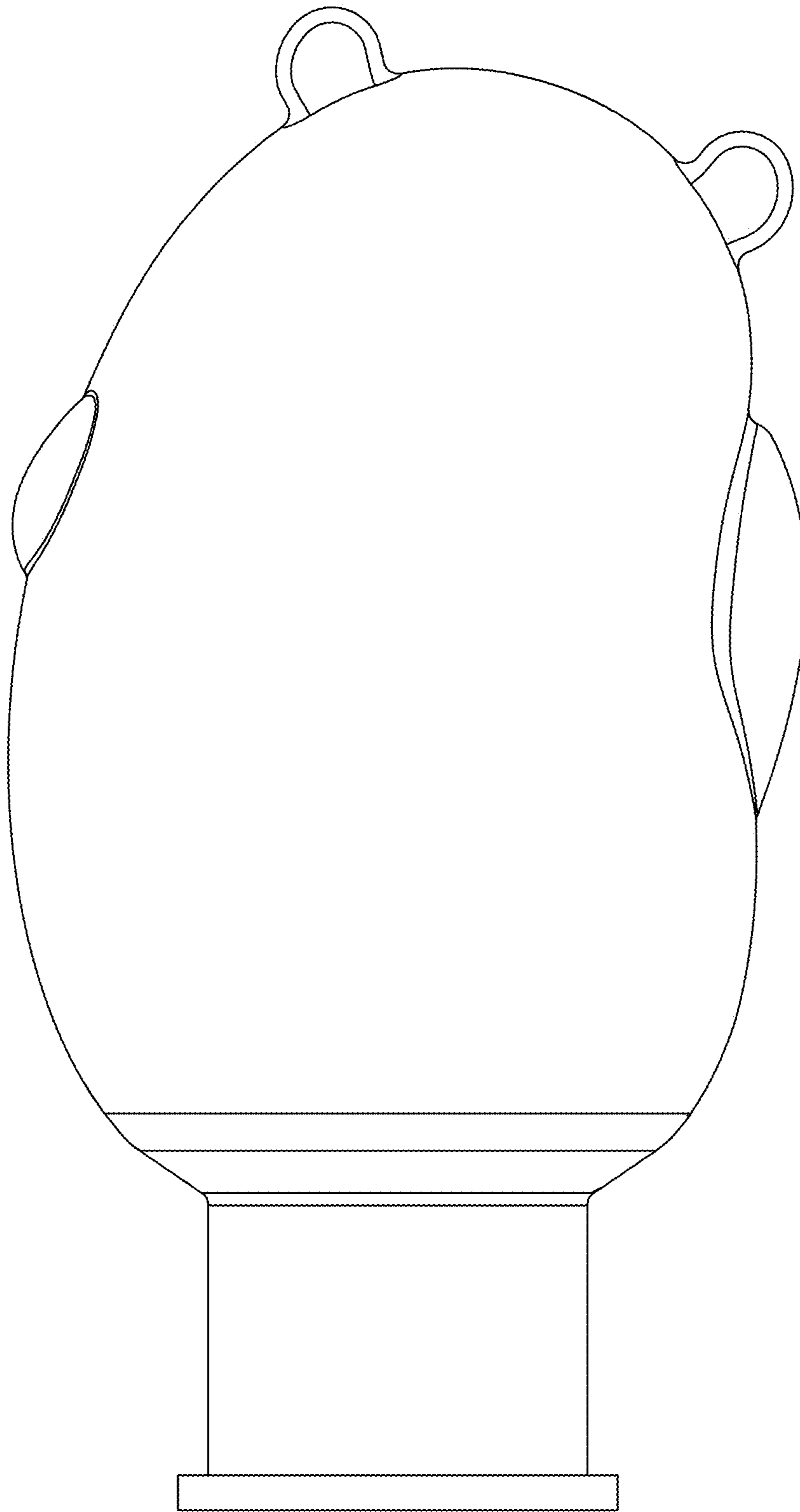

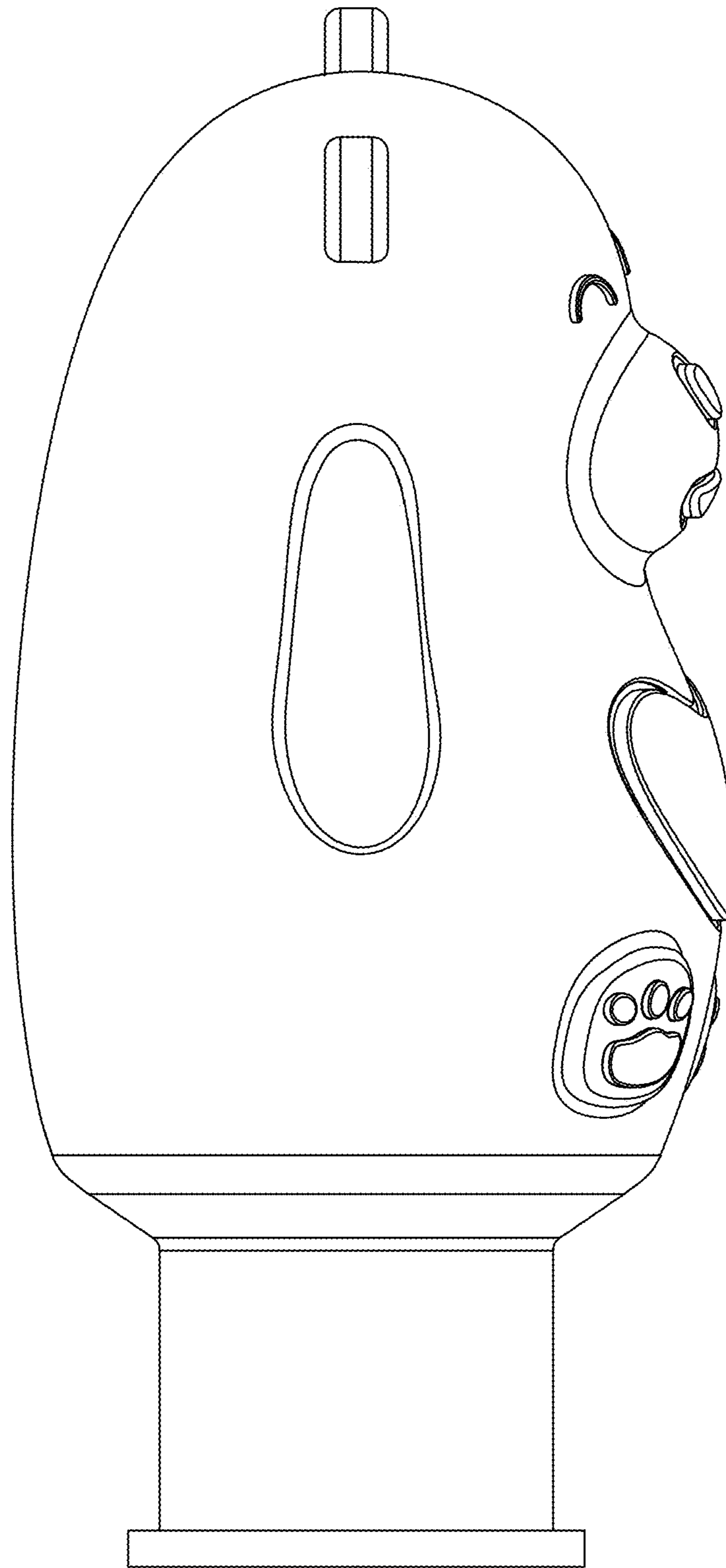

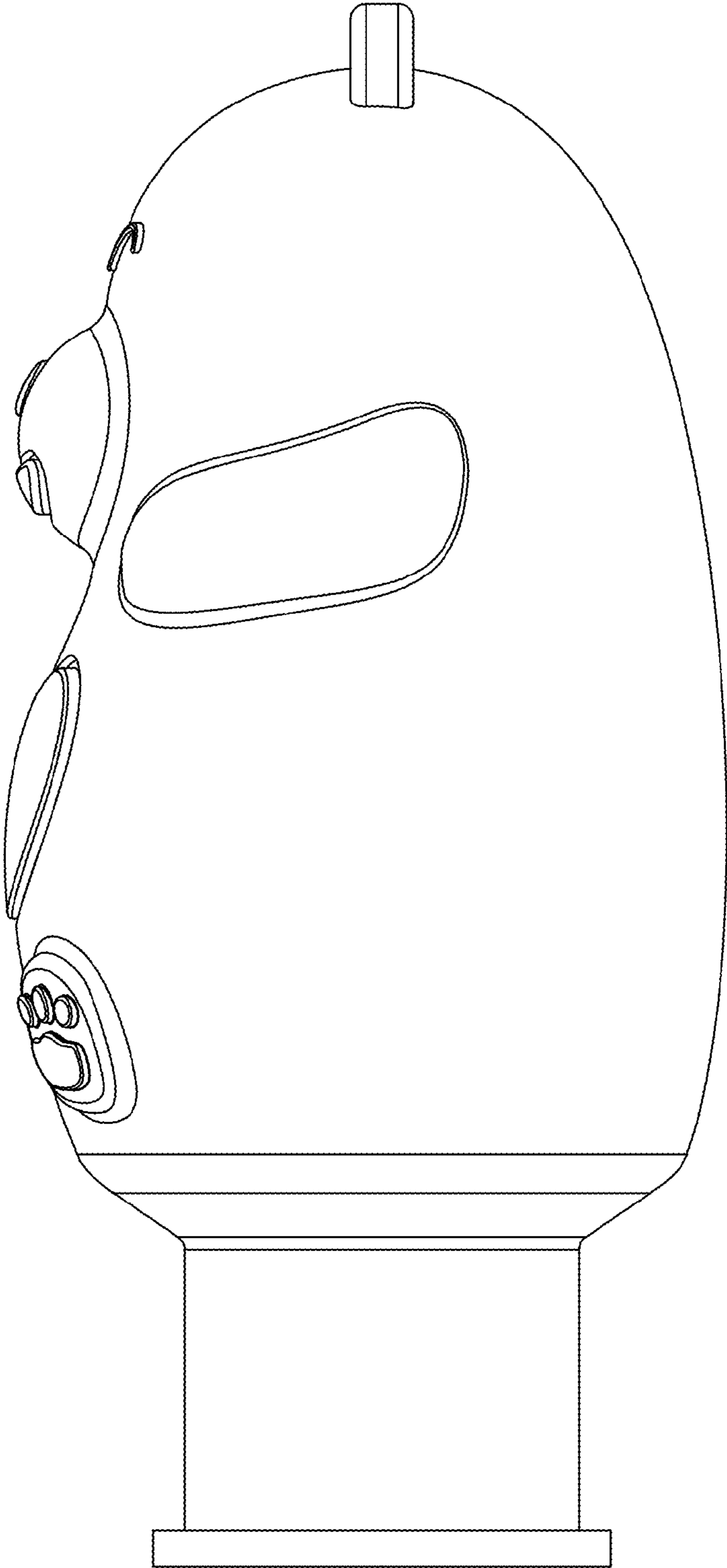

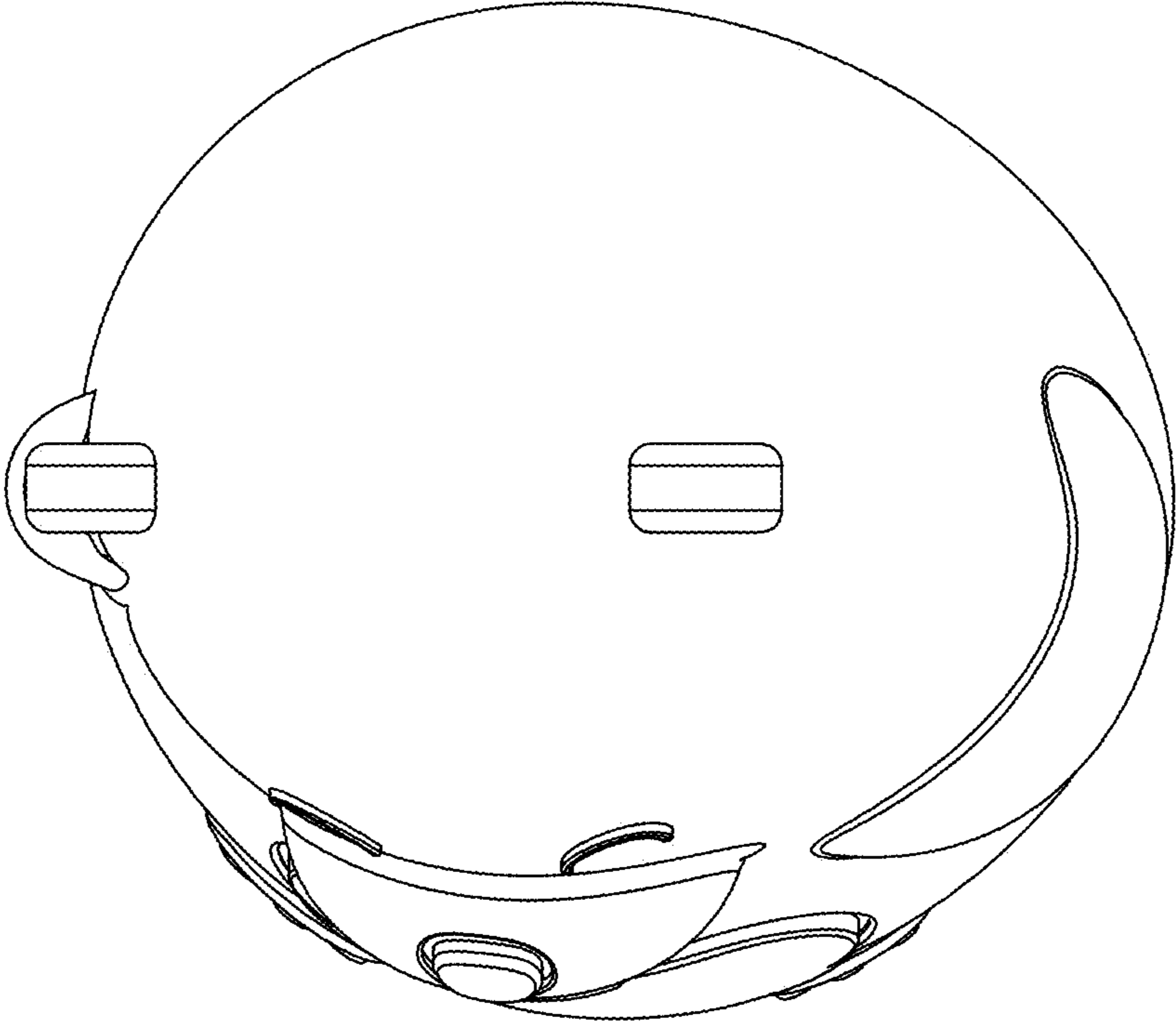

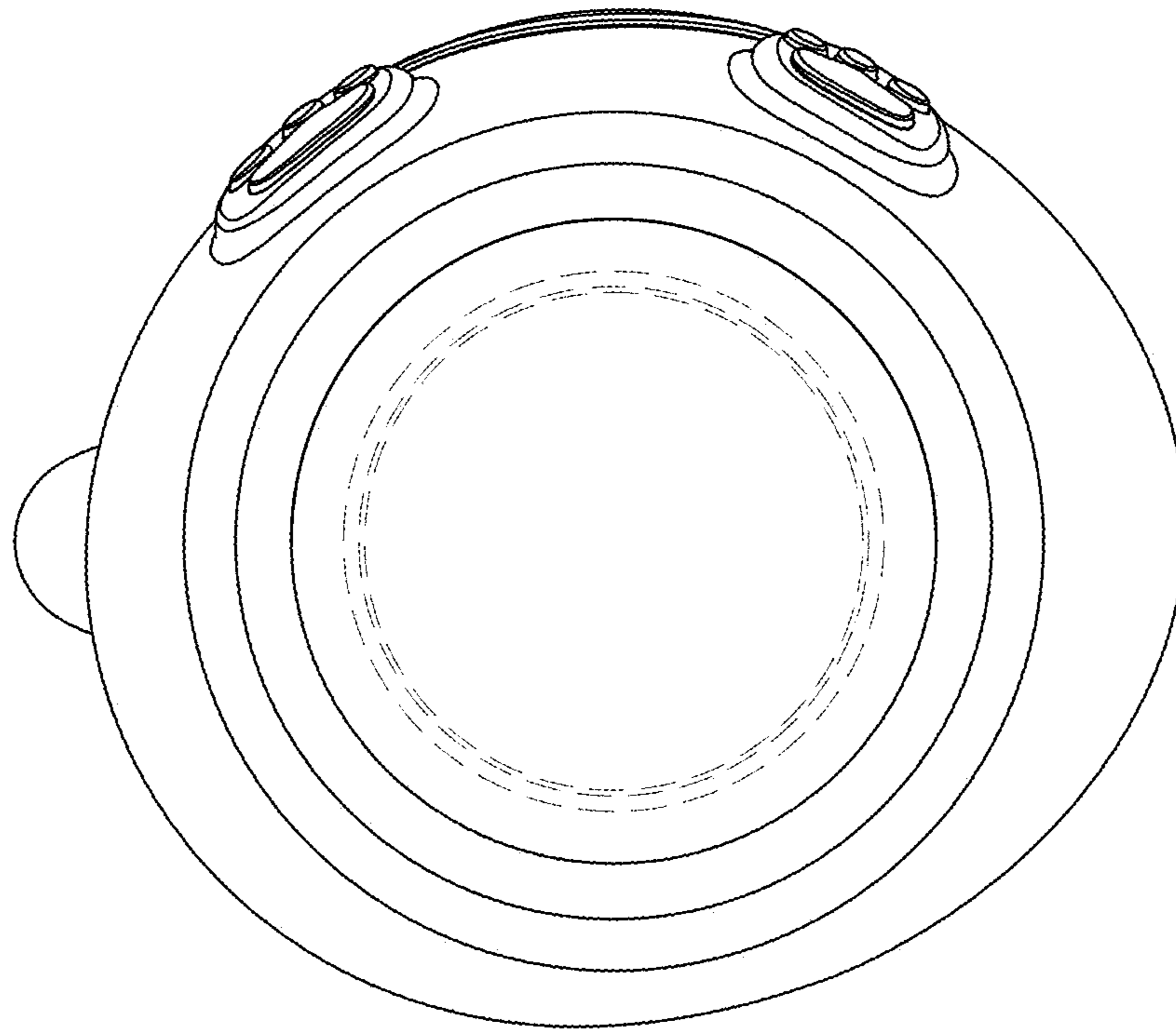

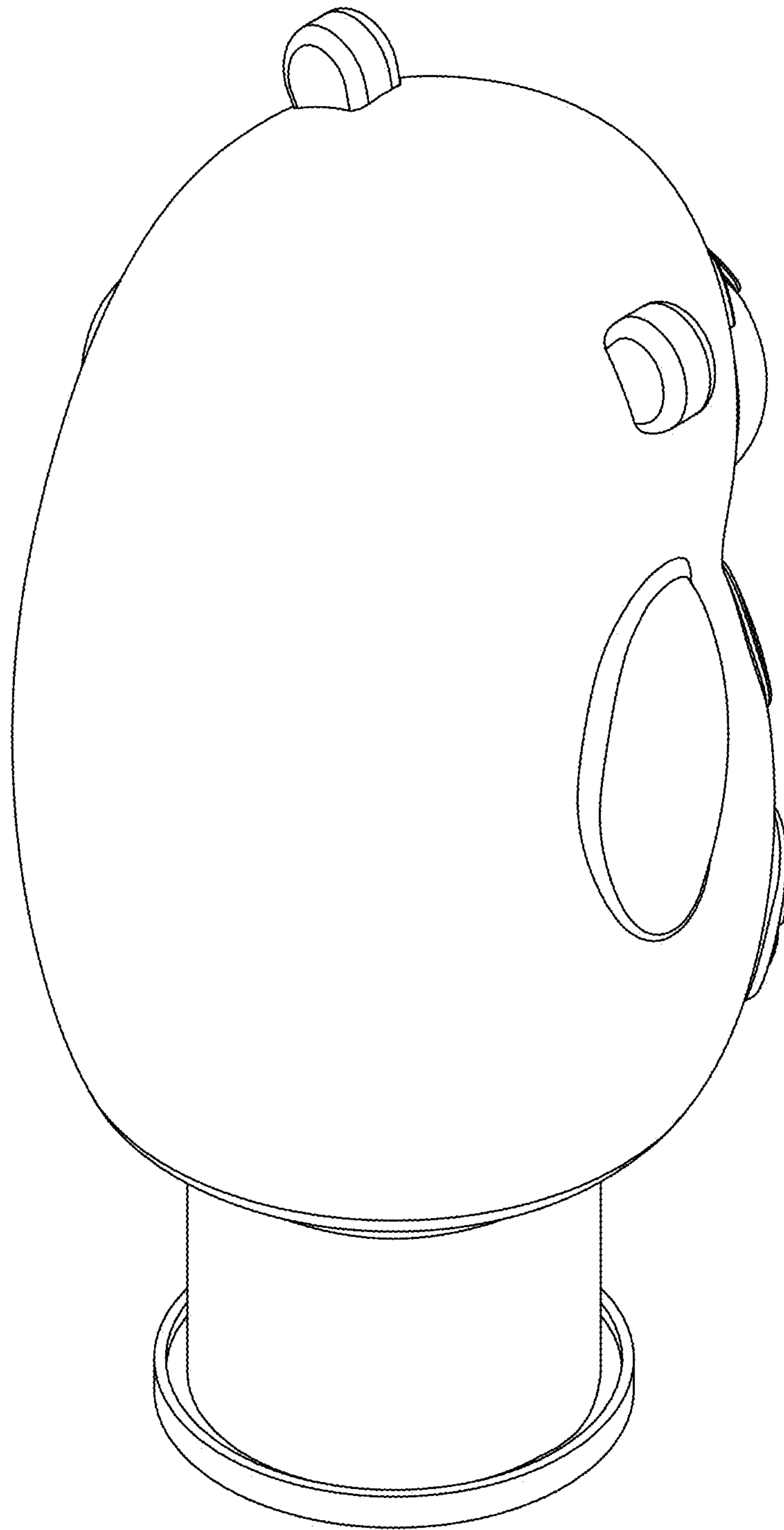

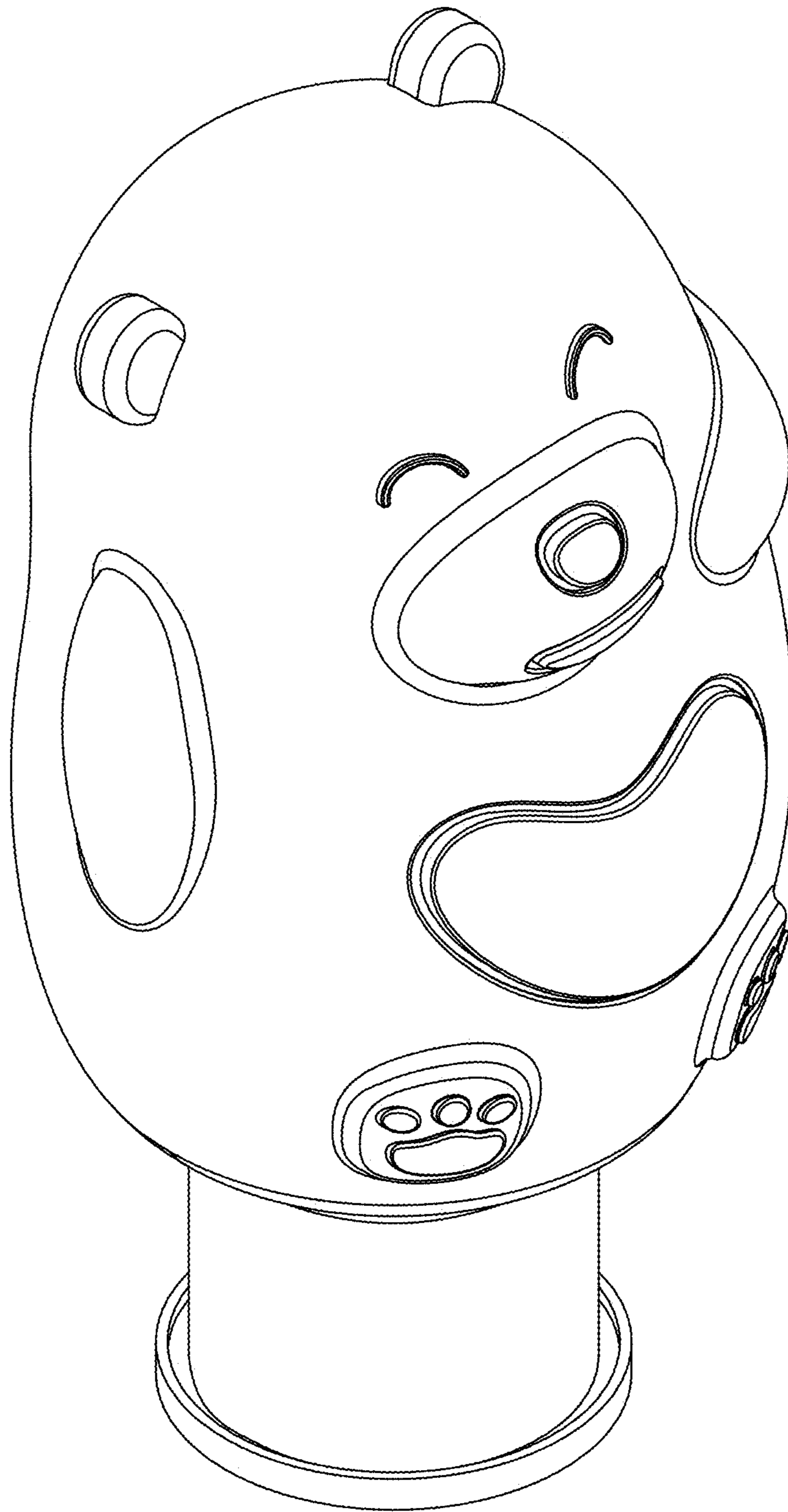

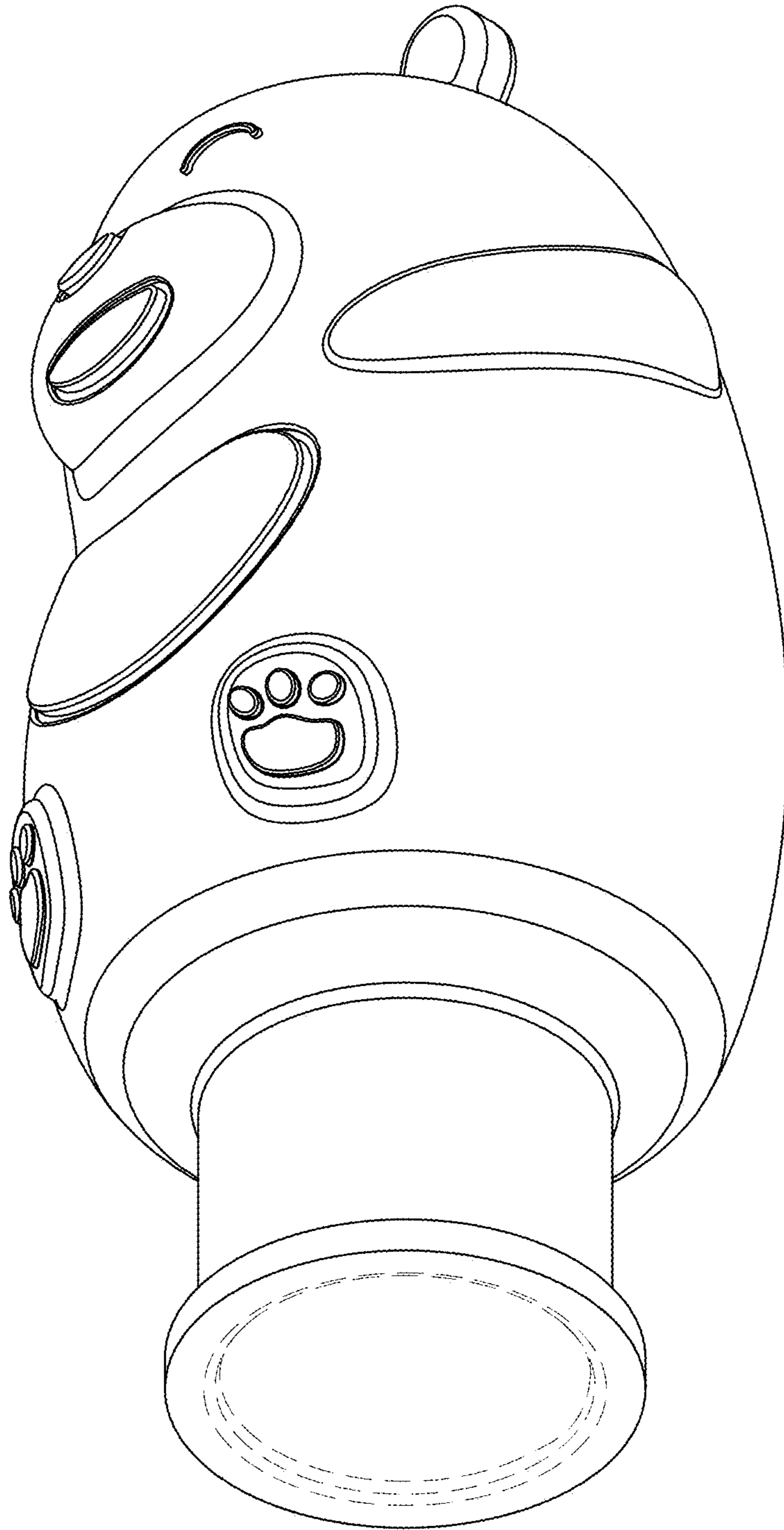
