DESCRIPTION

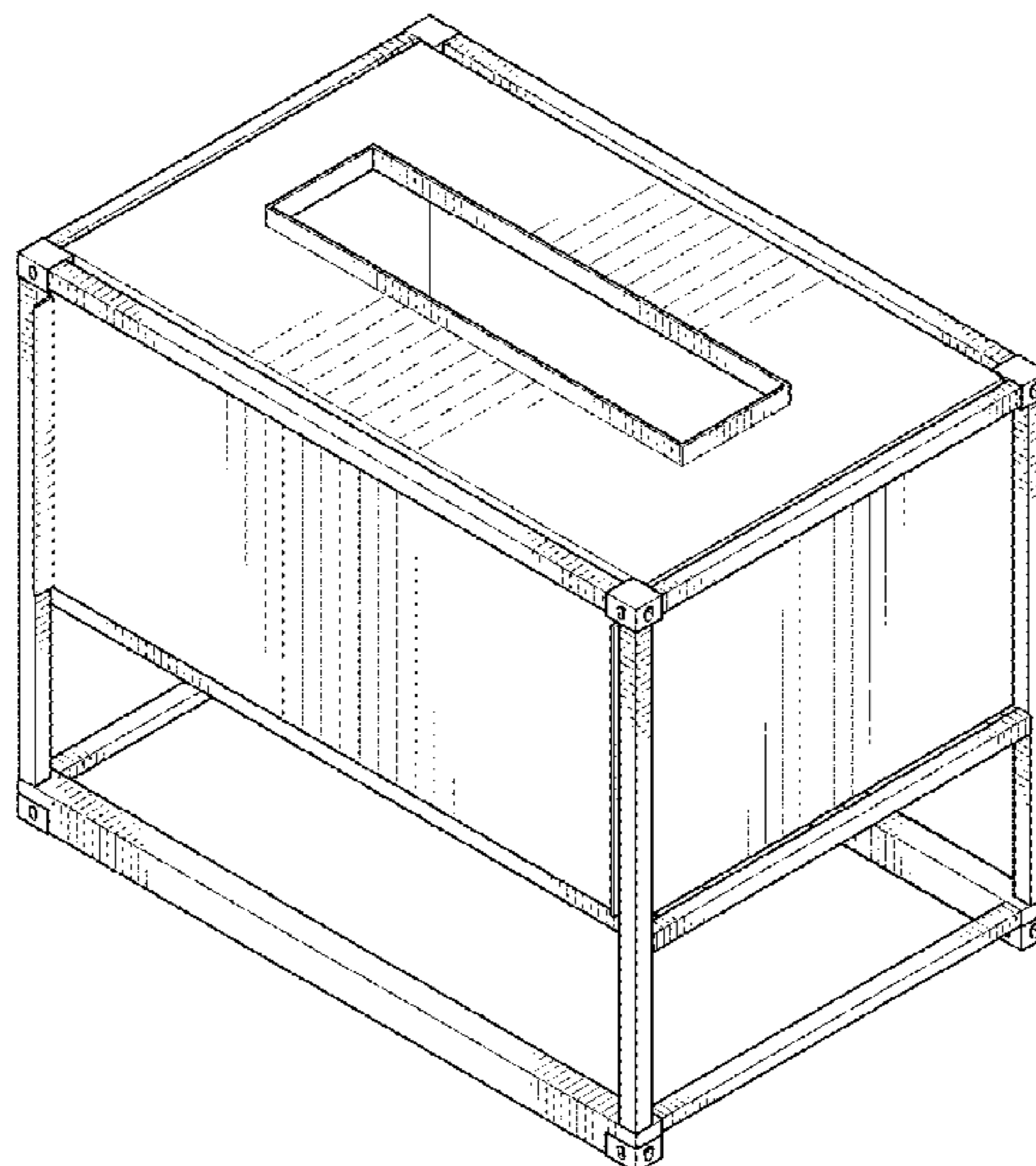
FIG. 1 is a top front perspective view of a container that is removably housed in a frame showing my new design;

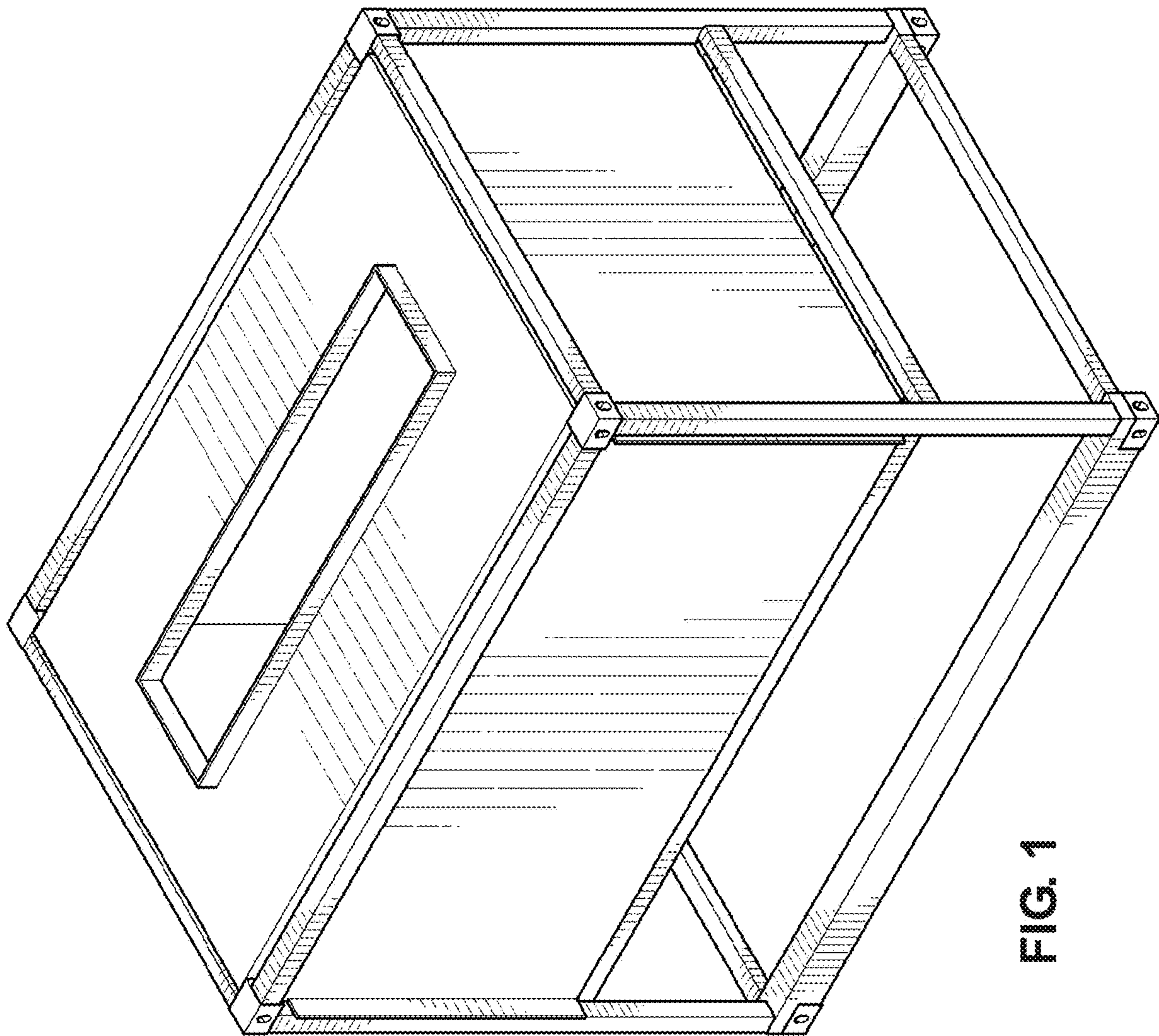

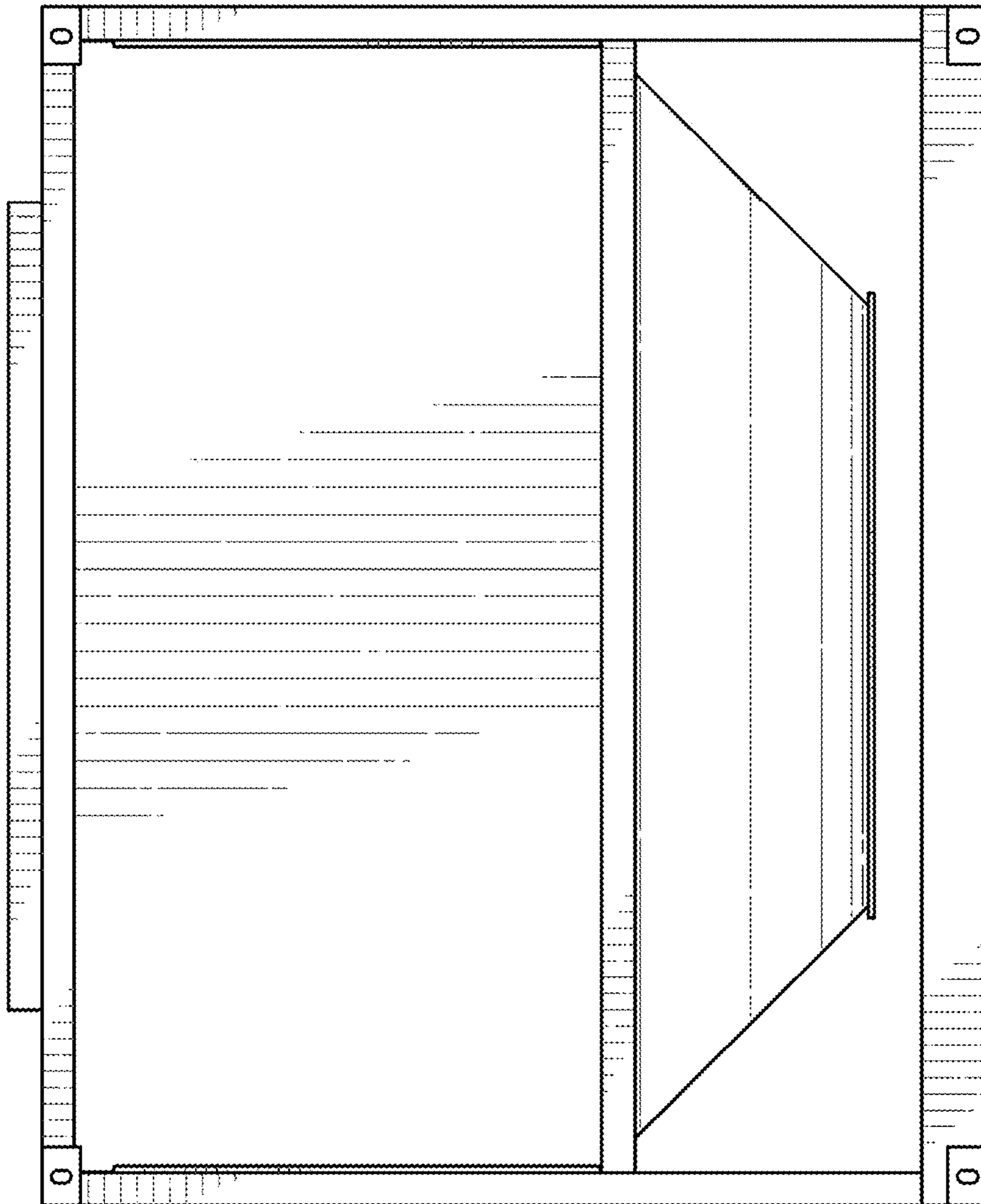

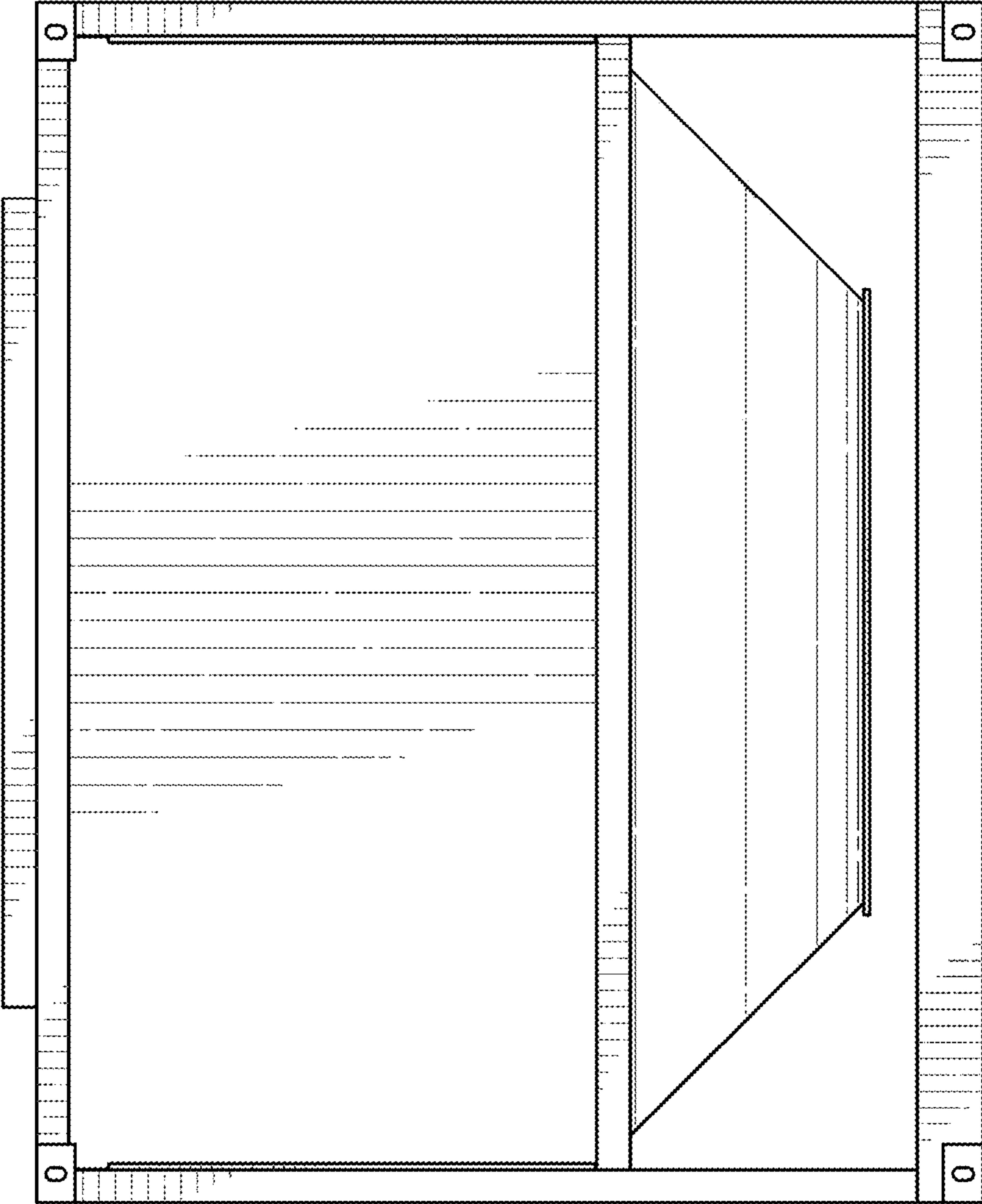

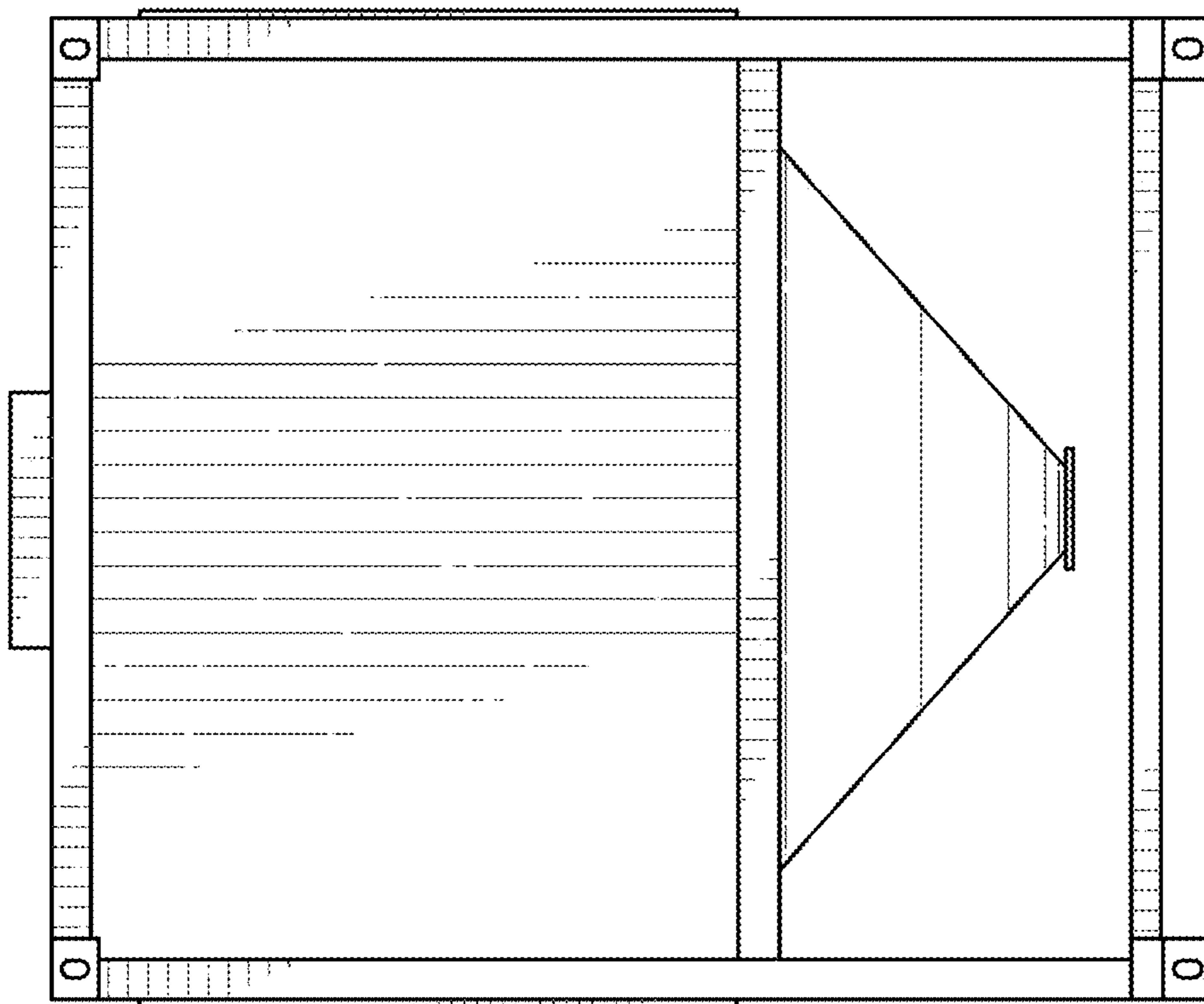

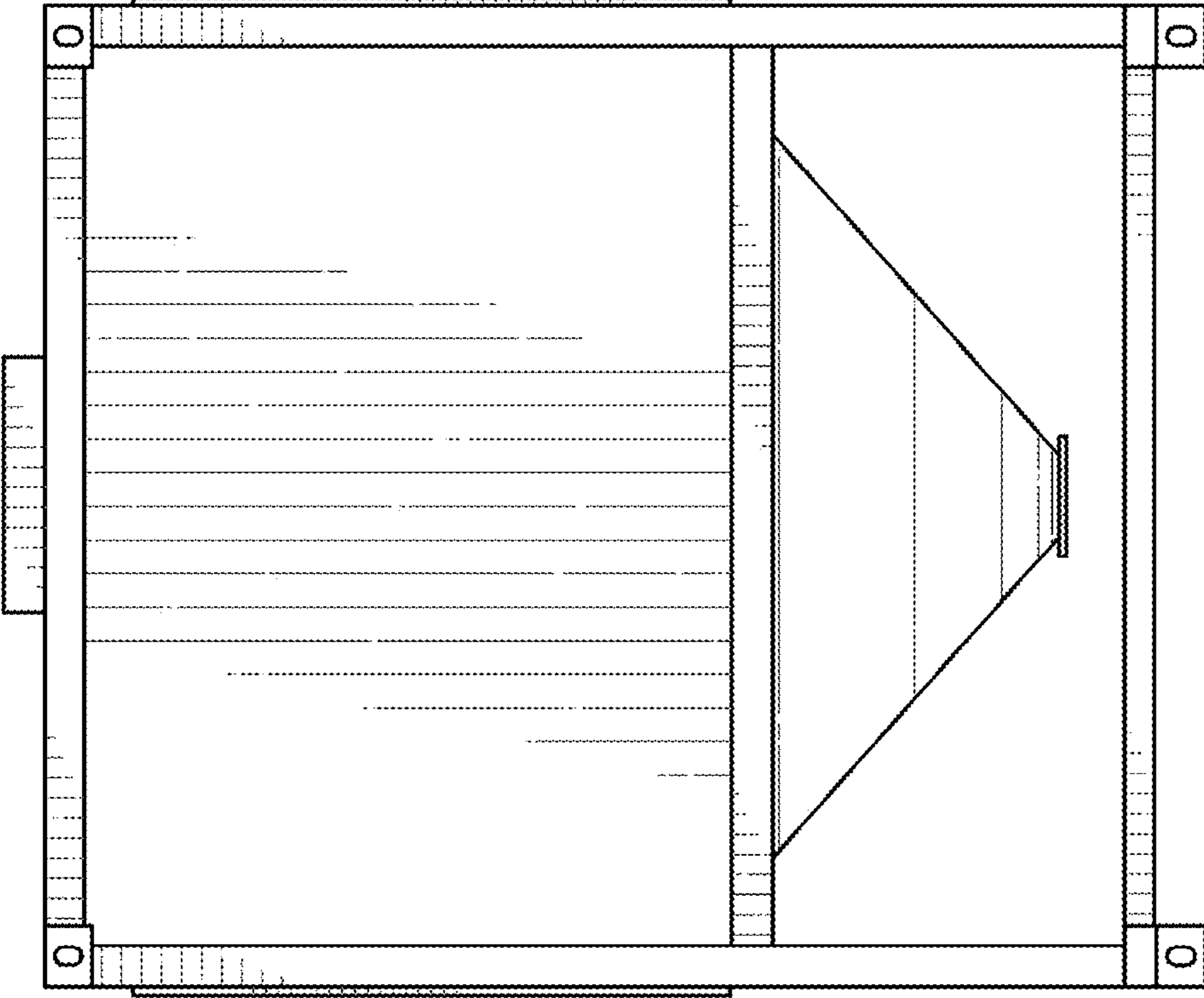

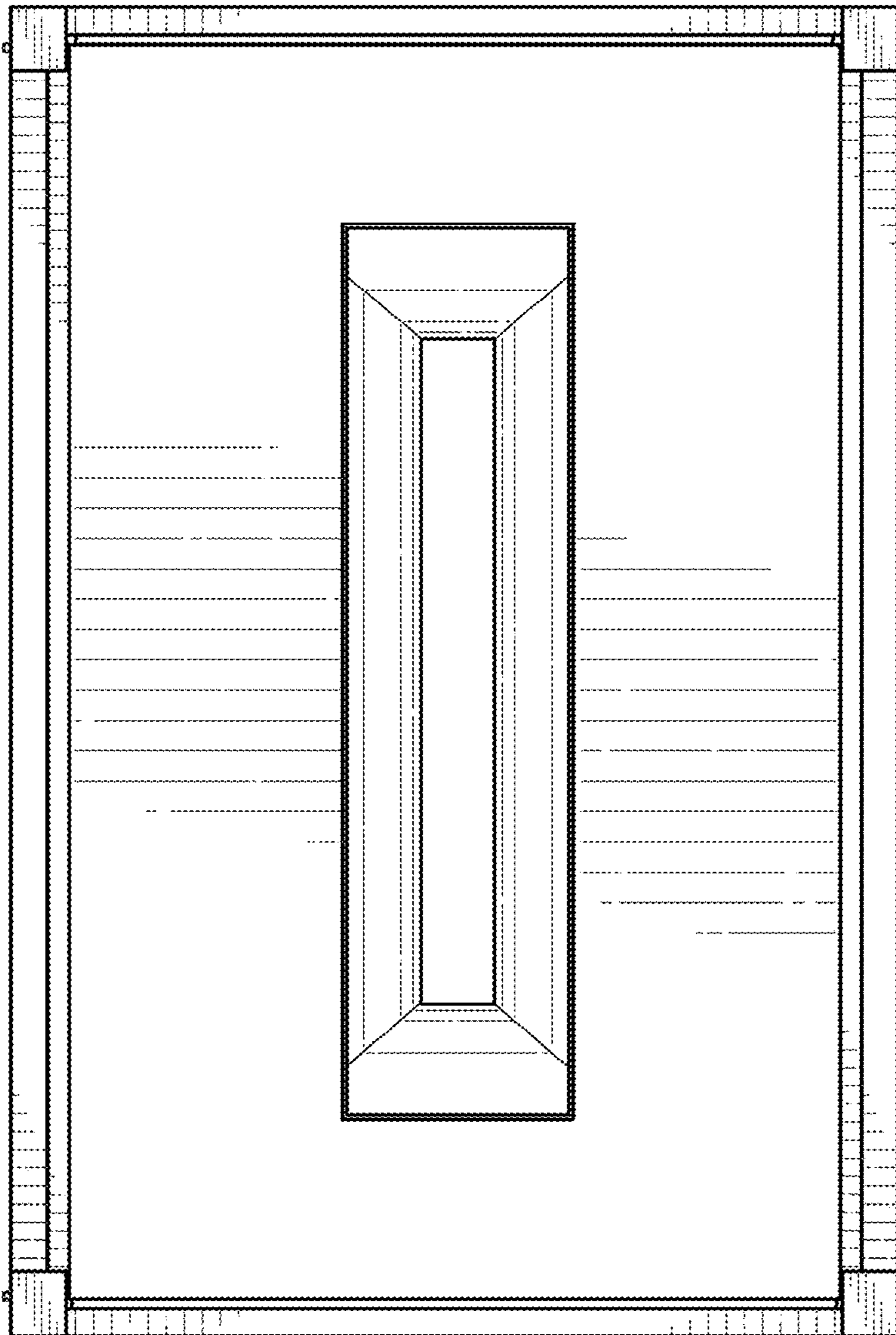

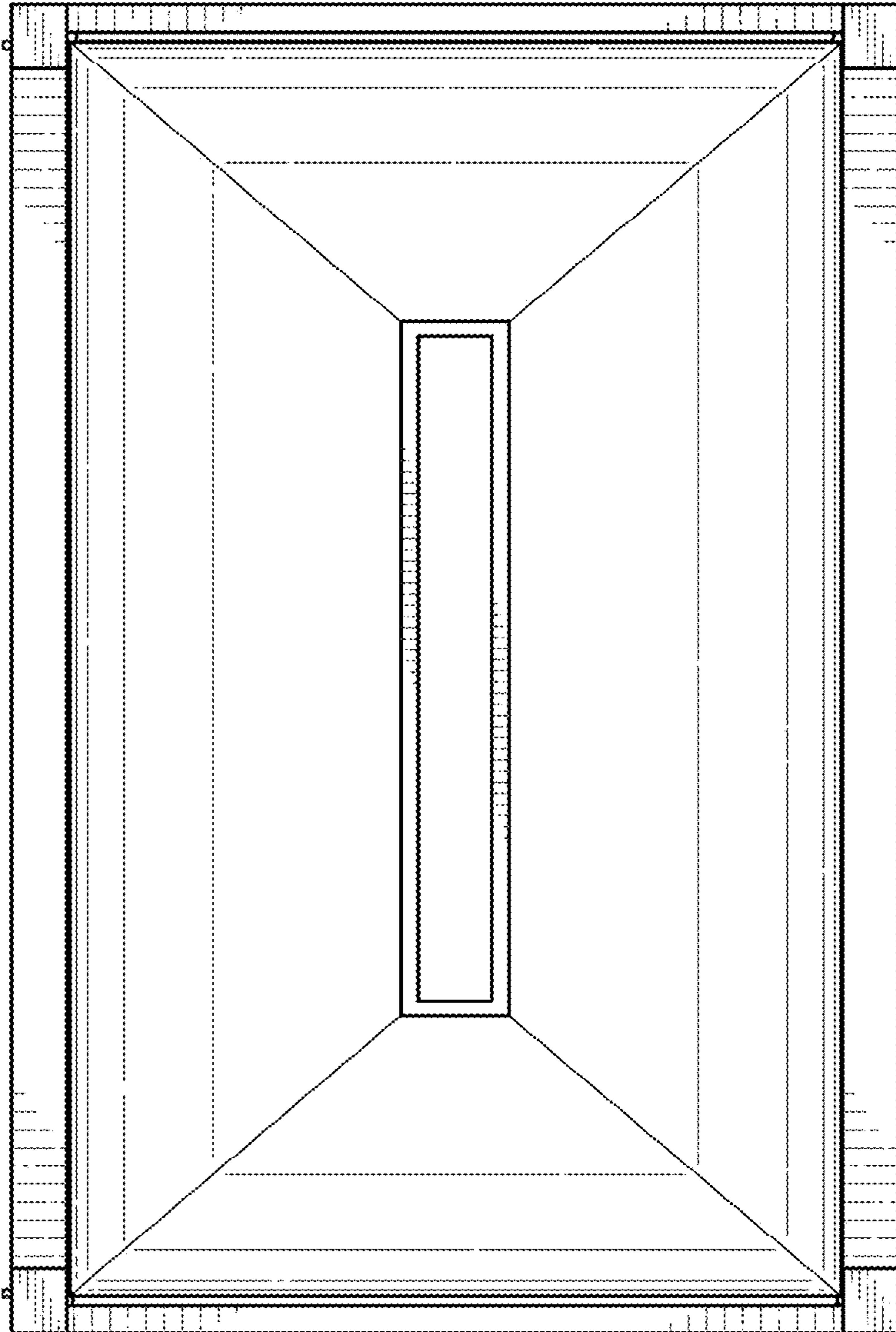

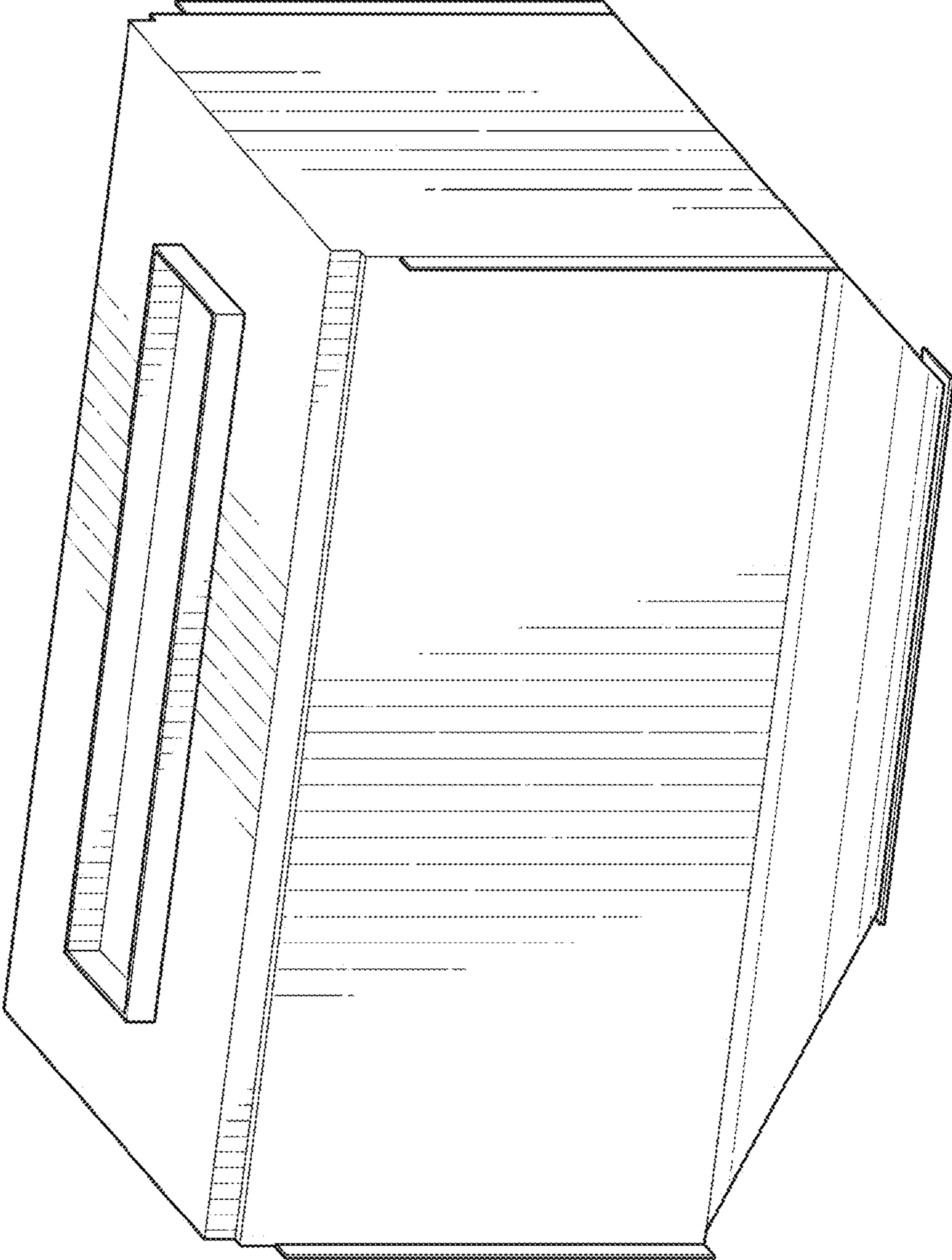

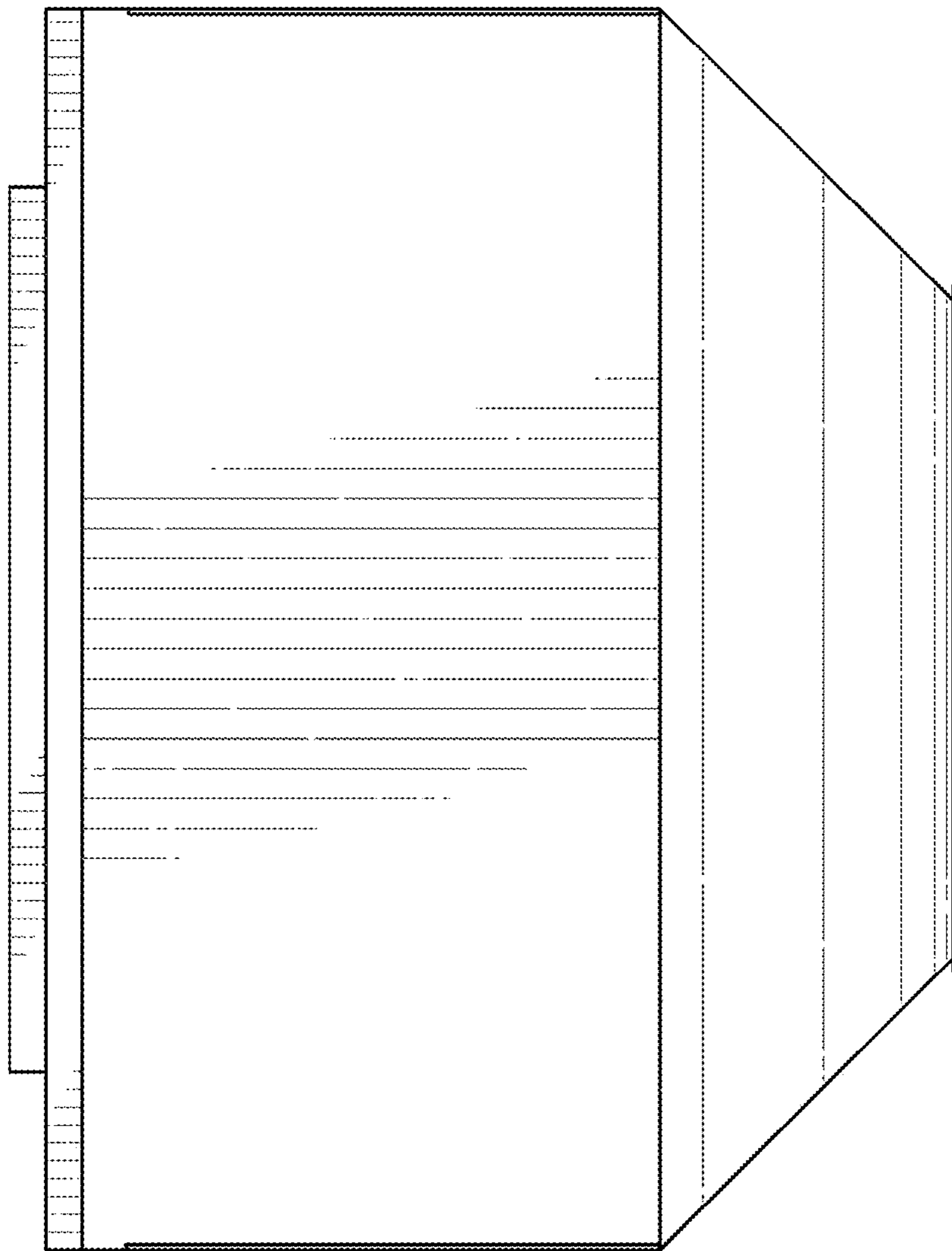

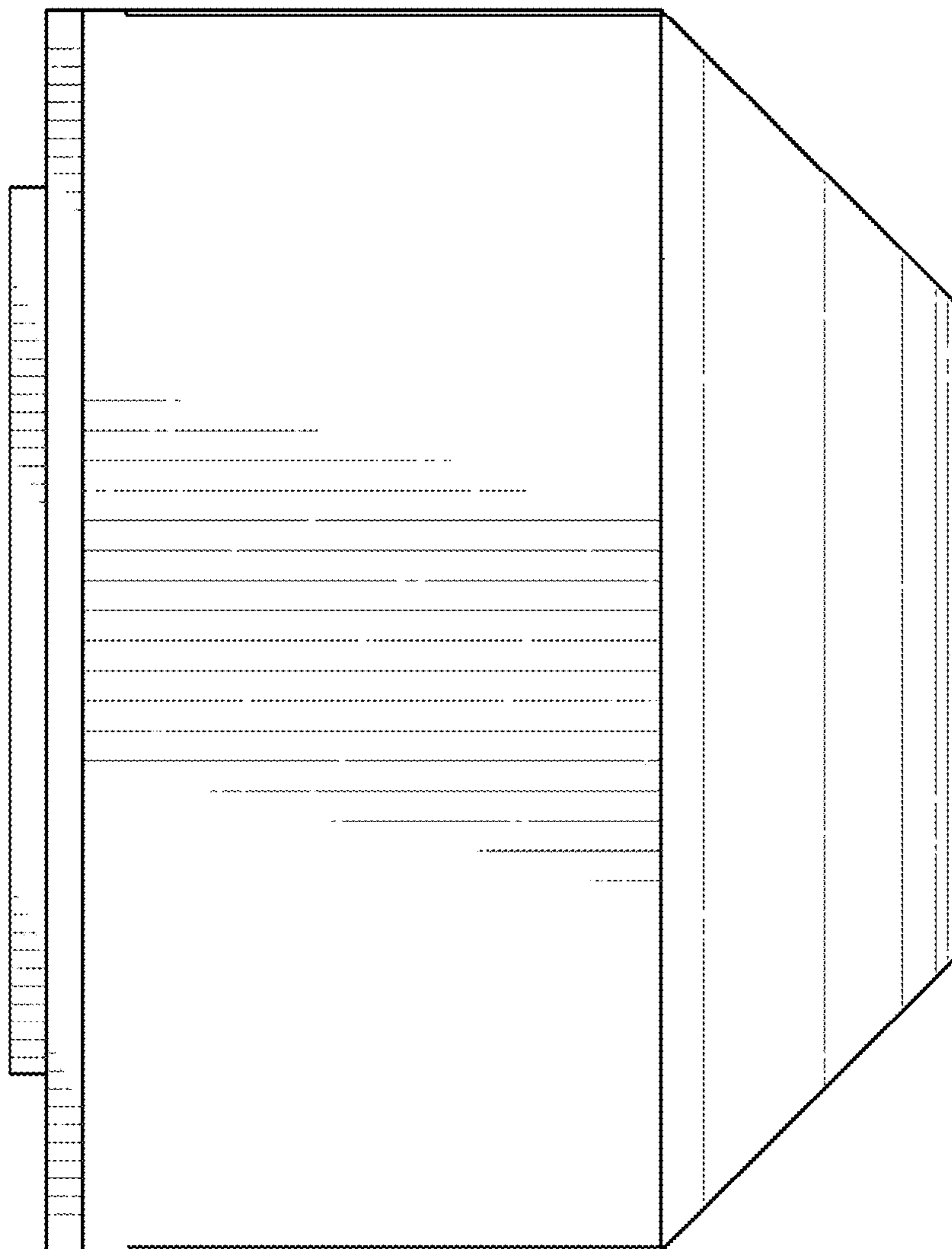

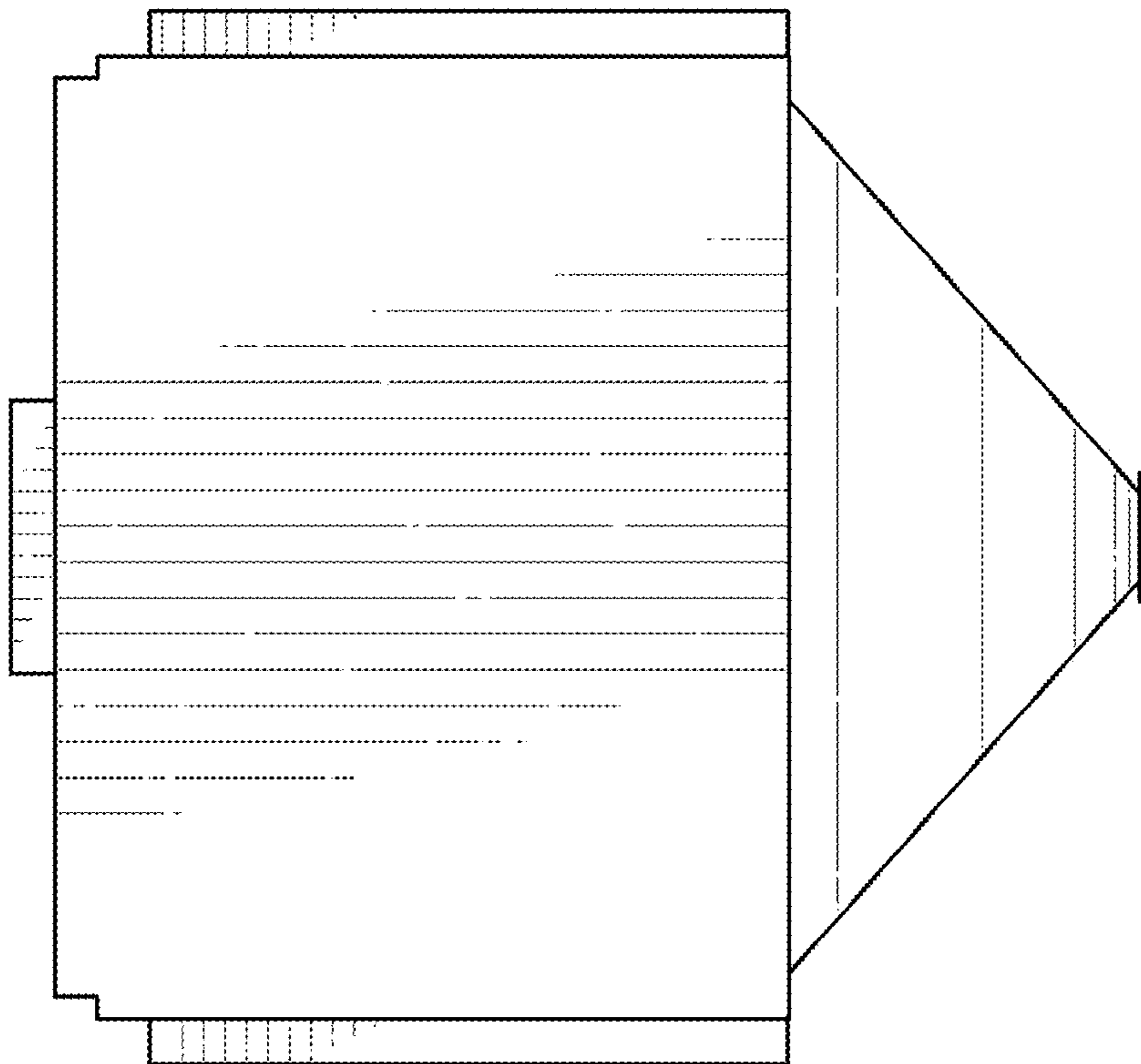

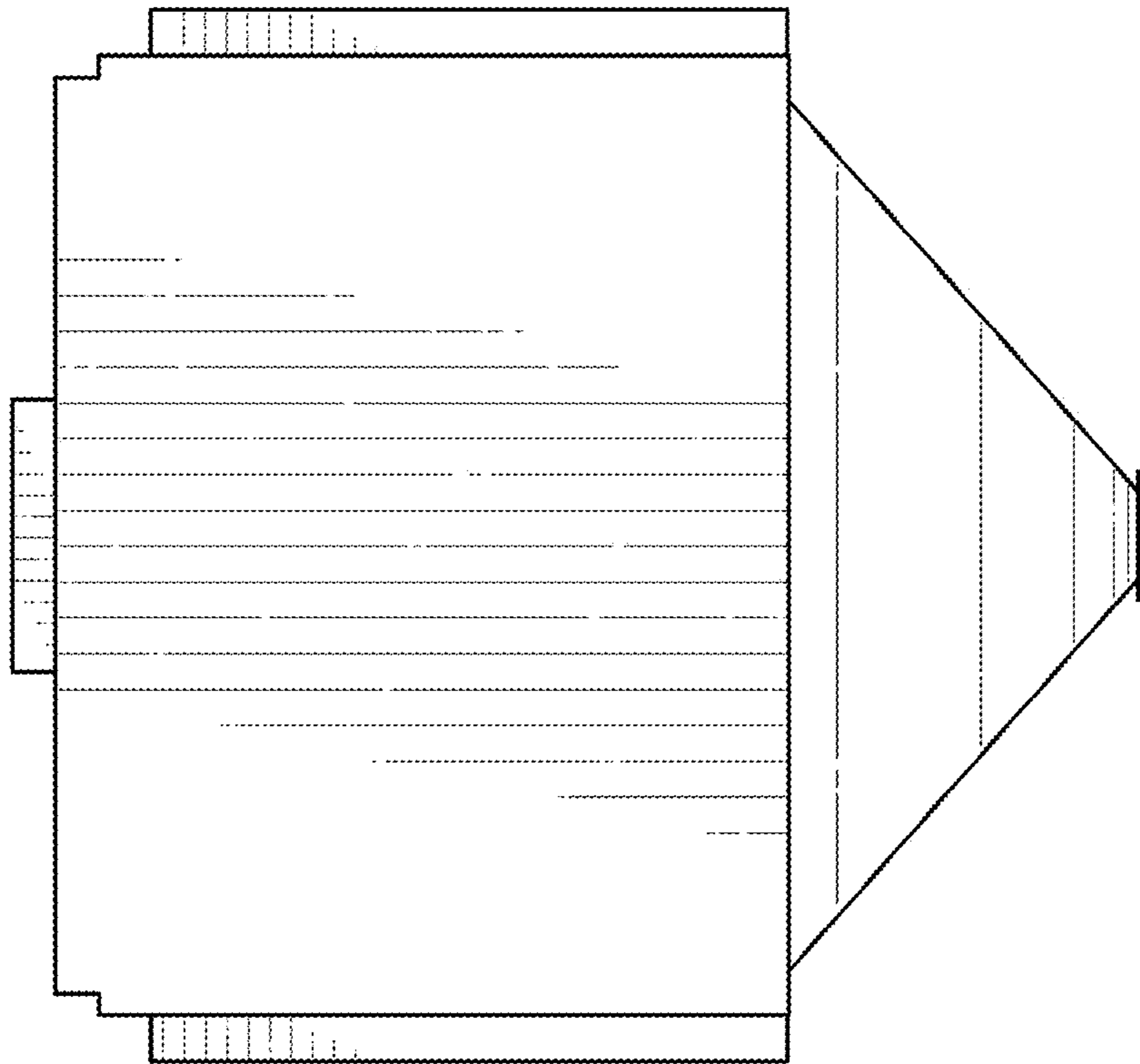

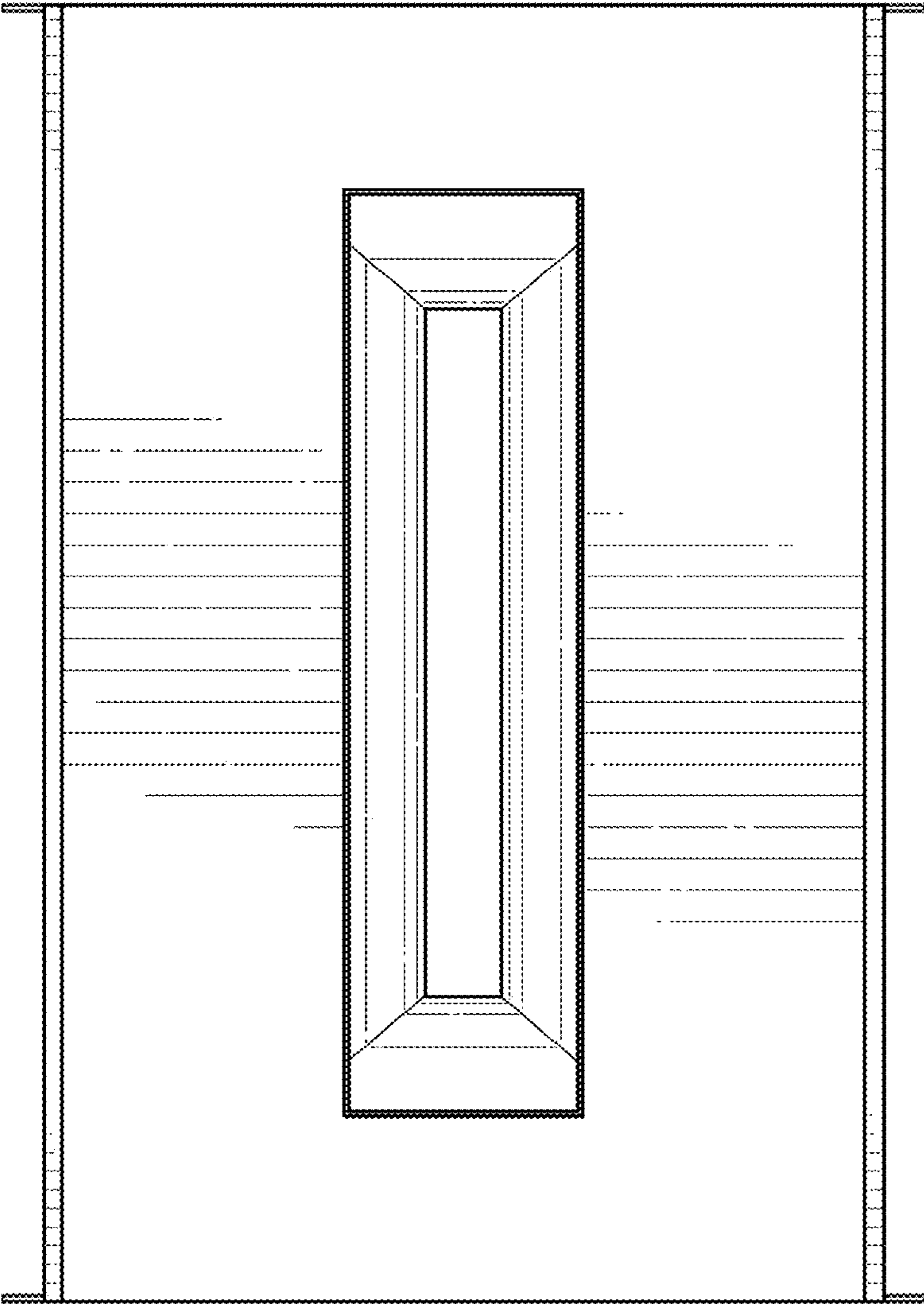

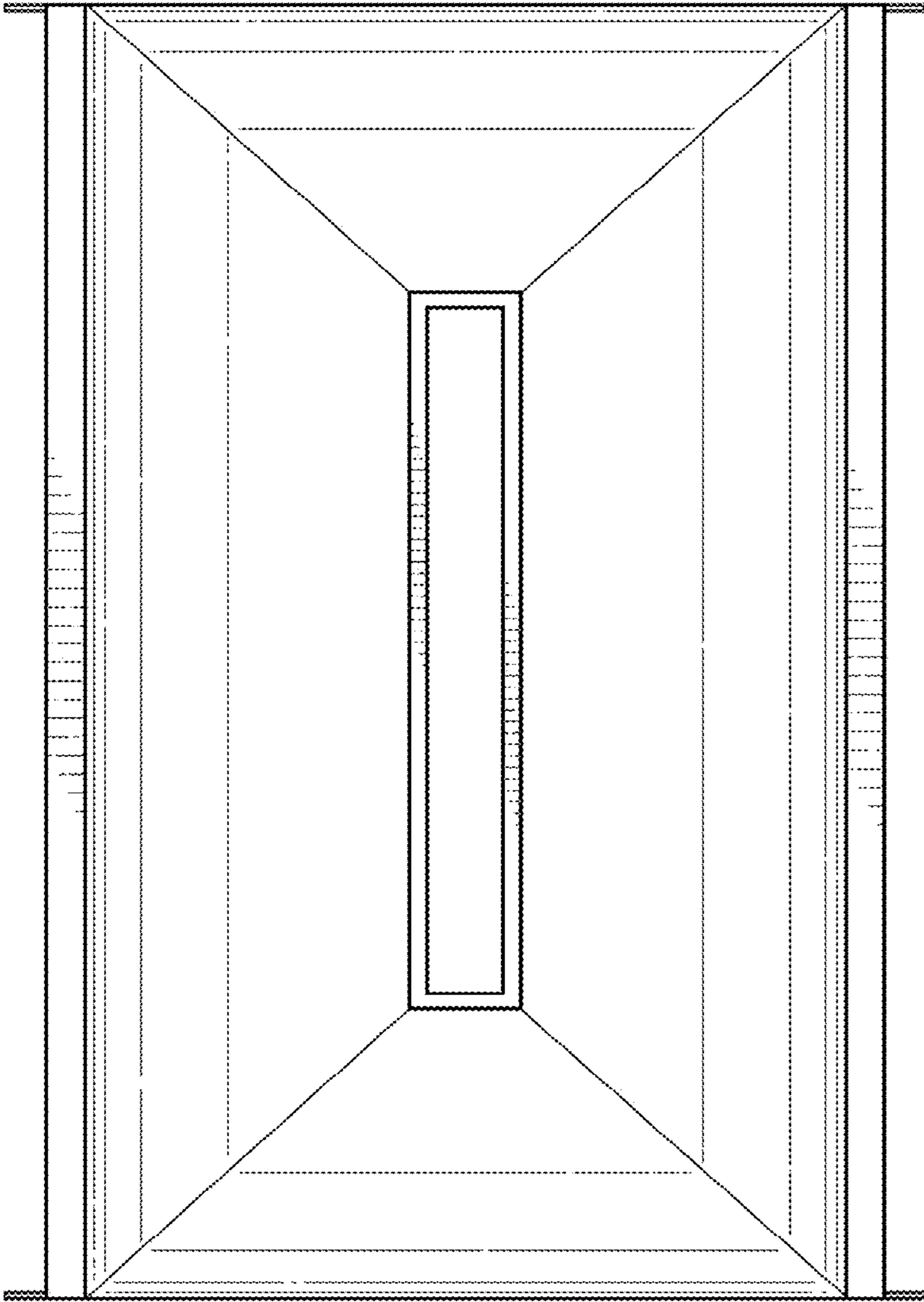
