(57) **CLAIM**

What is claimed is an embossed raised jewel pattern for fashion accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handbag fashion accessory having an embossed raised jewel pattern.  
FIG. 2 is a front view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1.  
FIG. 3 is a rear view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1.  
FIG. 4 is a left side view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1.  
FIG. 5 is a right side view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1.  
FIG. 6 is a top view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1; and,  
FIG. 7 is a bottom view of the handbag fashion accessory having the embossed raised jewel pattern of FIG. 1.  
An embossed raised jewel pattern for a fashion accessory, such as a handbag, is depicted. In FIGS. 1-7, portions of the handbag that are indicated as forming no part of the design are rendered in broken lines and have no shading. Transitions between the claimed design and the portions of the handbag forming no part of the claimed design are indicated through the presence of black dash-dot-dash boundary lines that separate the claimed design from the portions that form no part of the claimed design.

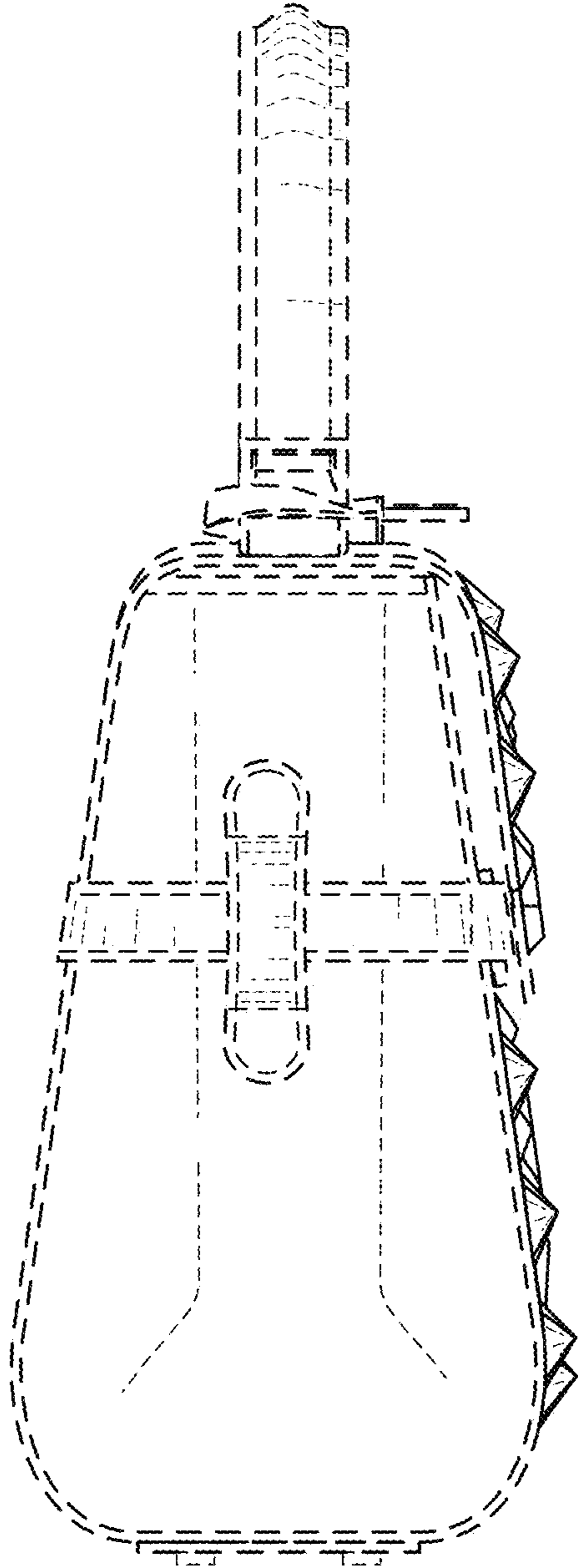

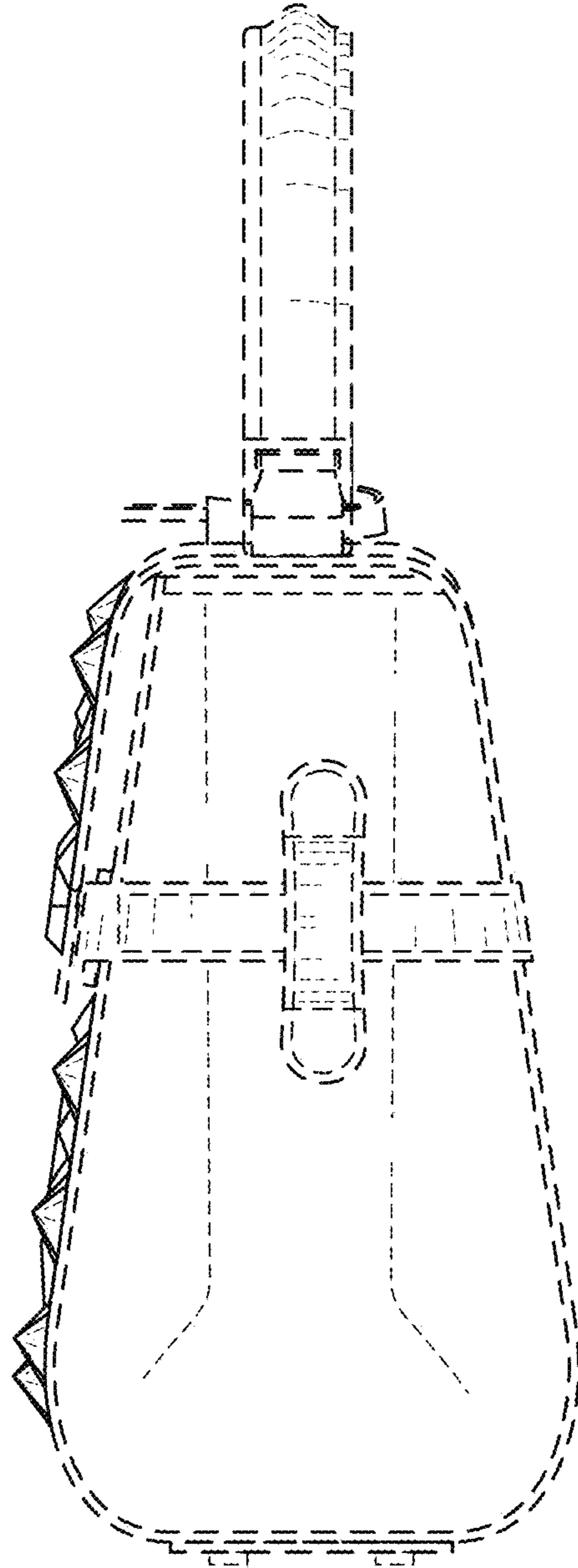

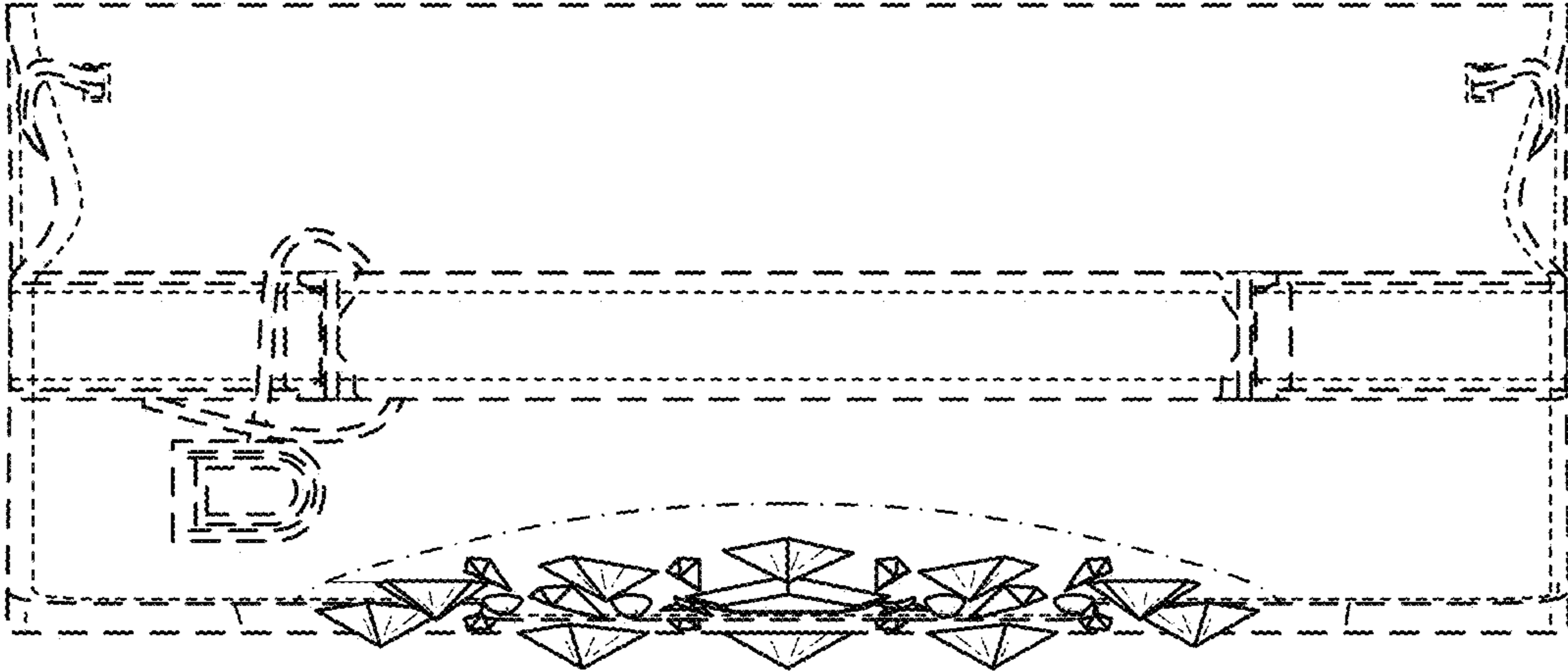

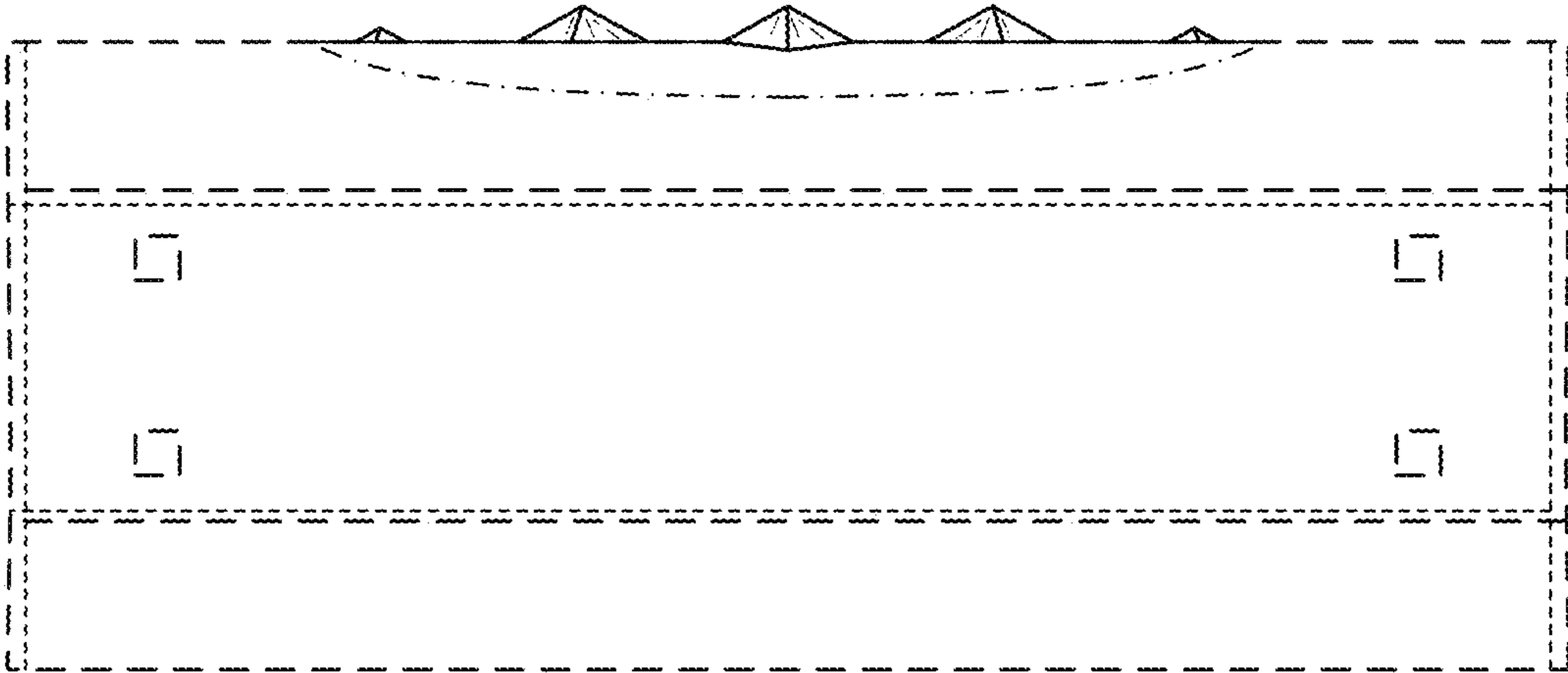
