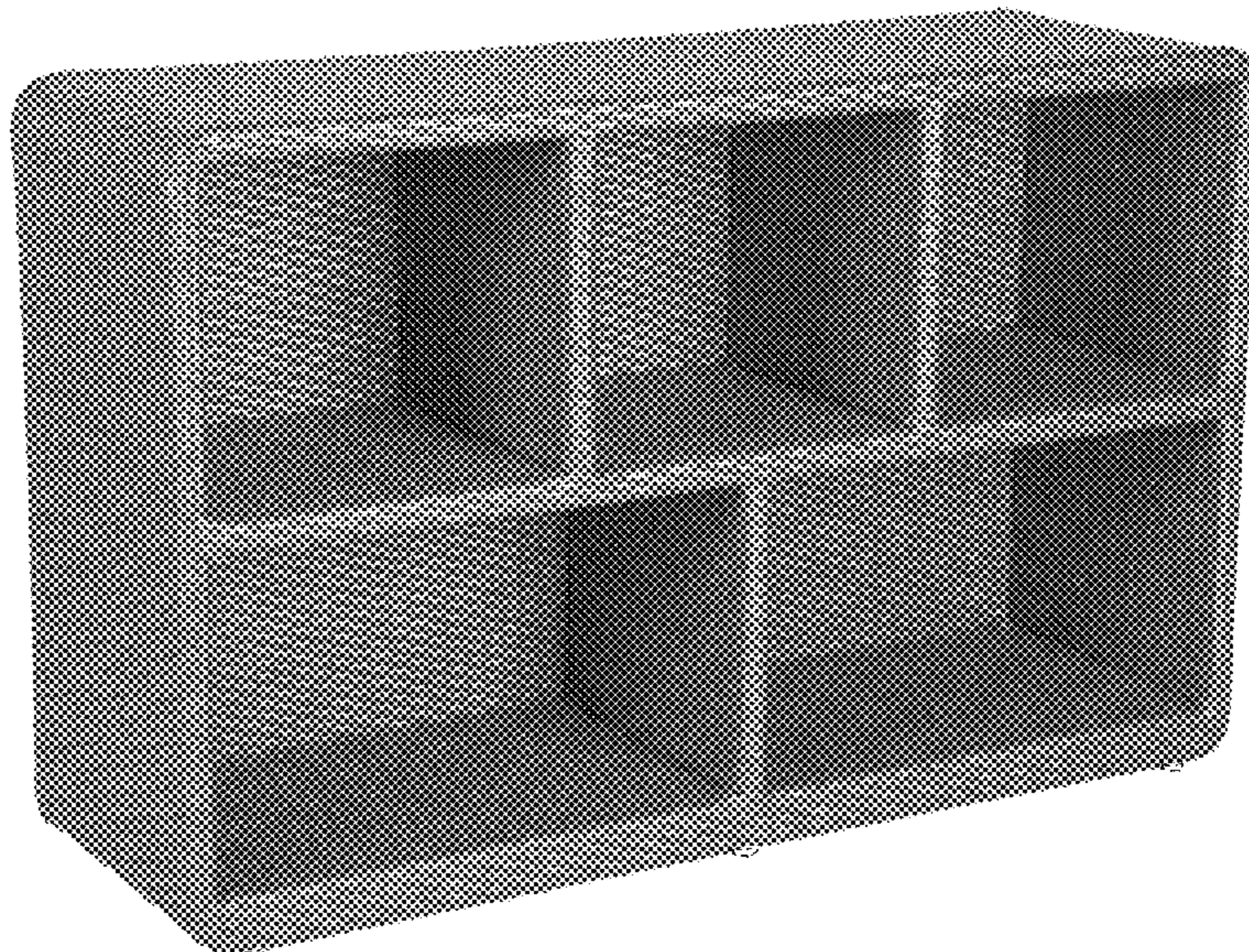
(57) **CLAIM**

The ornamental design for a storage unit, as shown and described.

DESCRIPTION

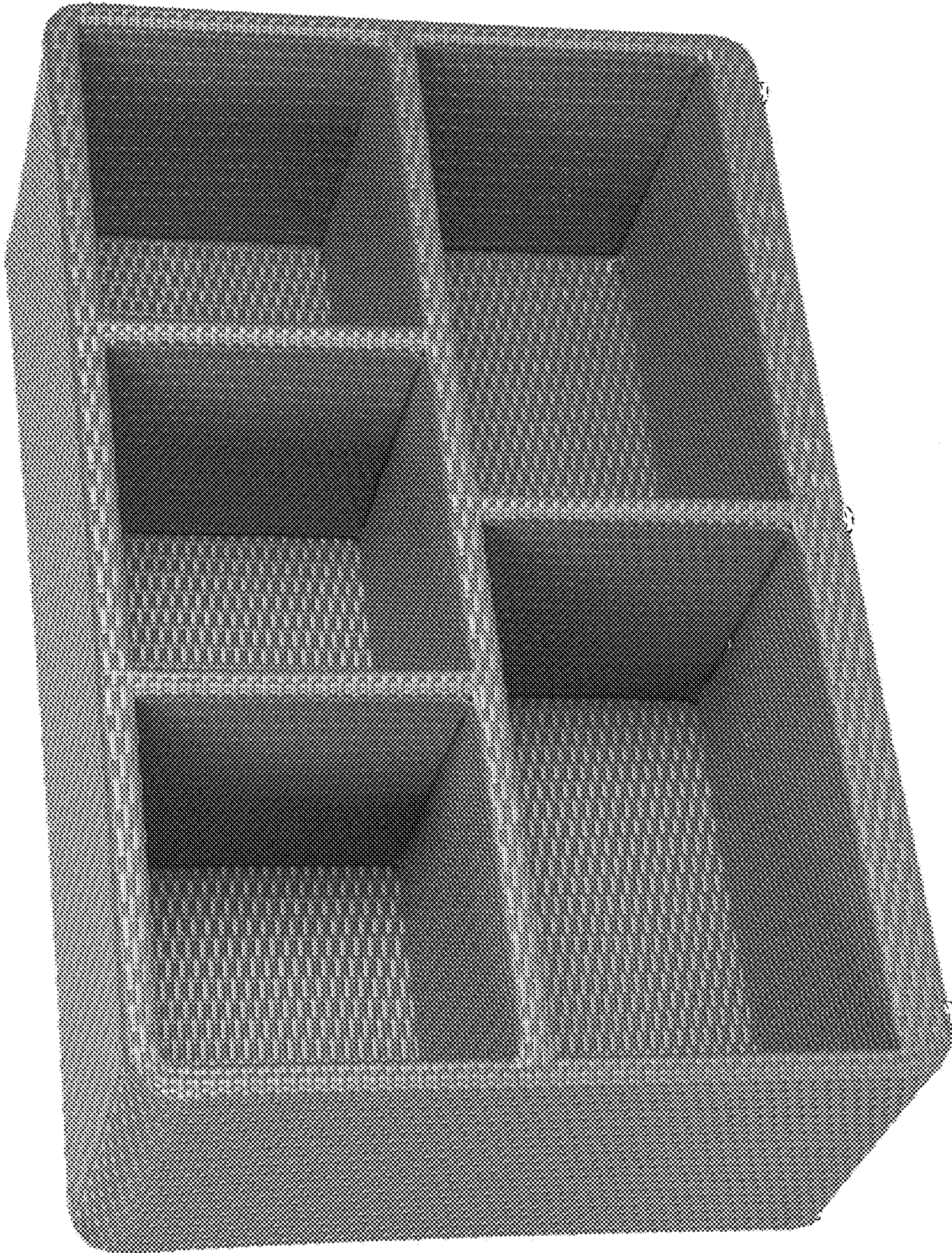

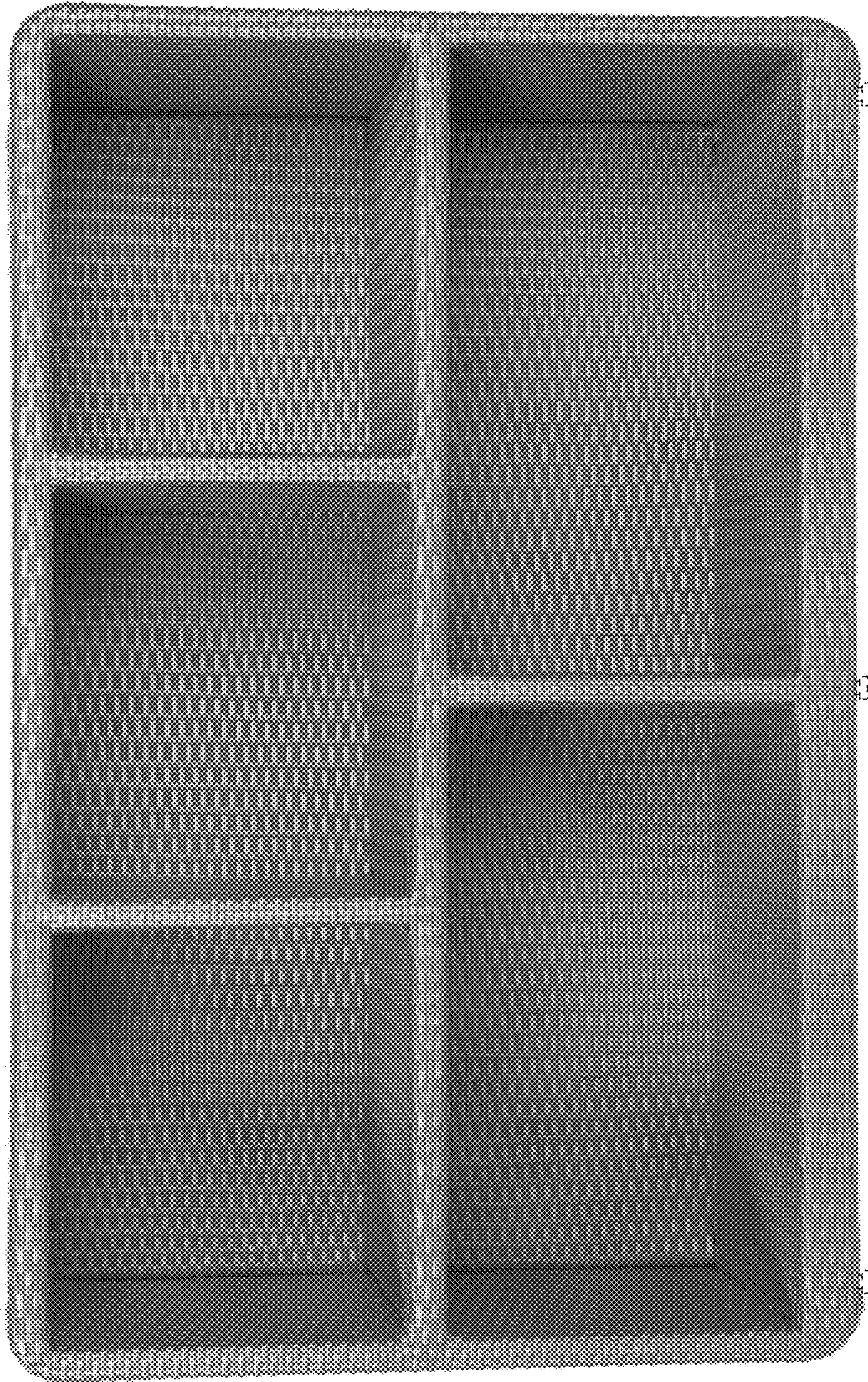

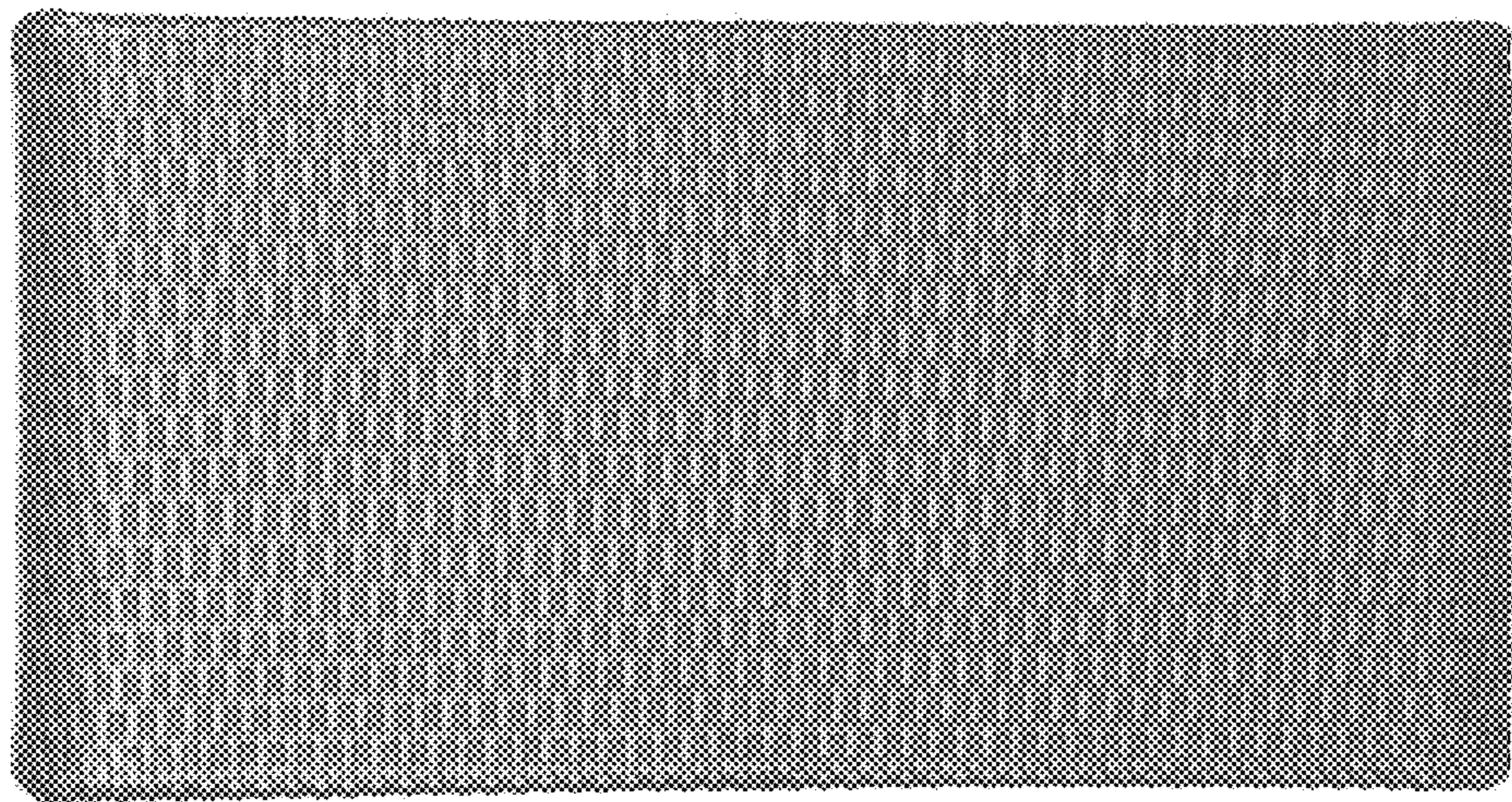

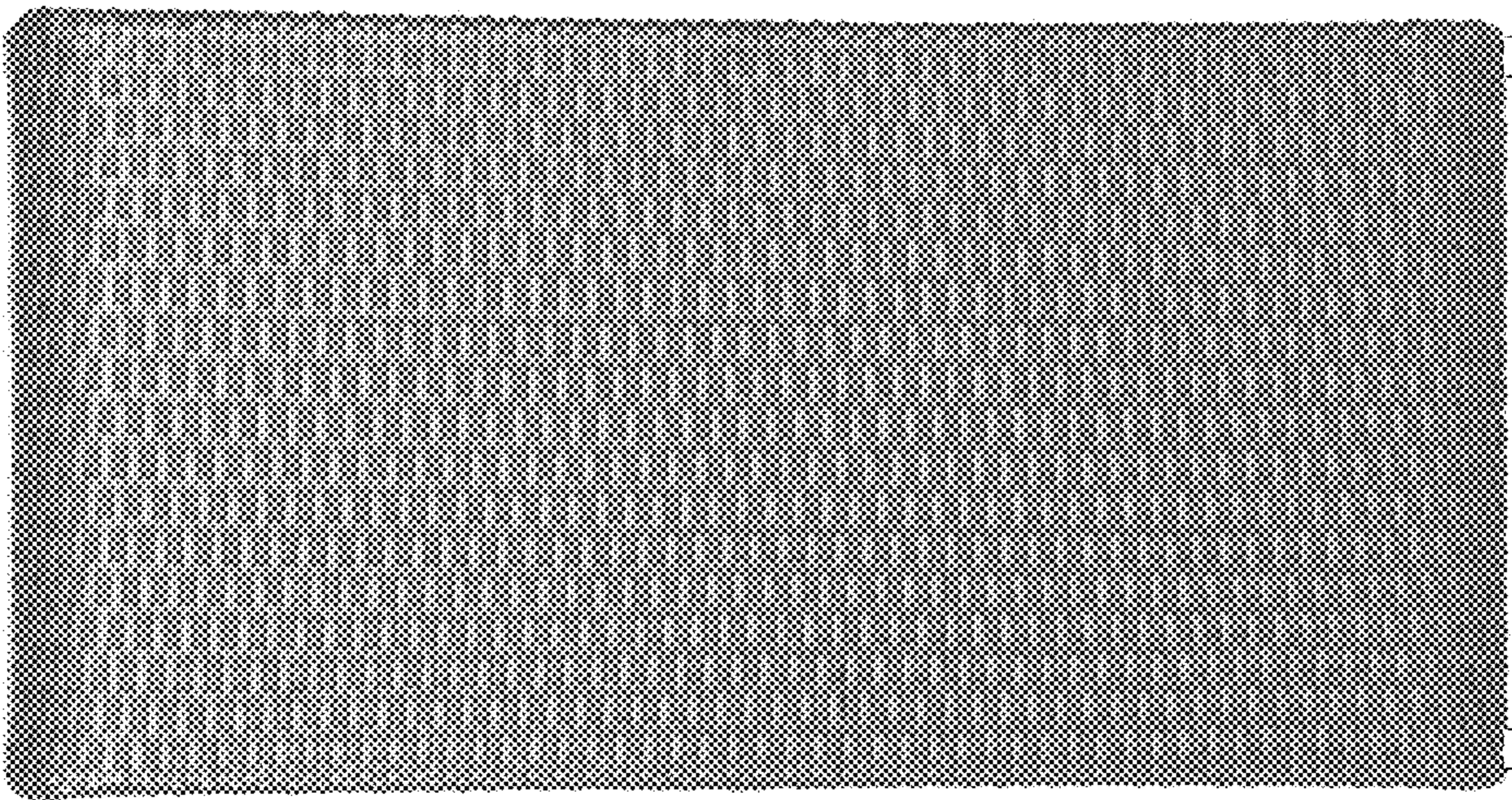

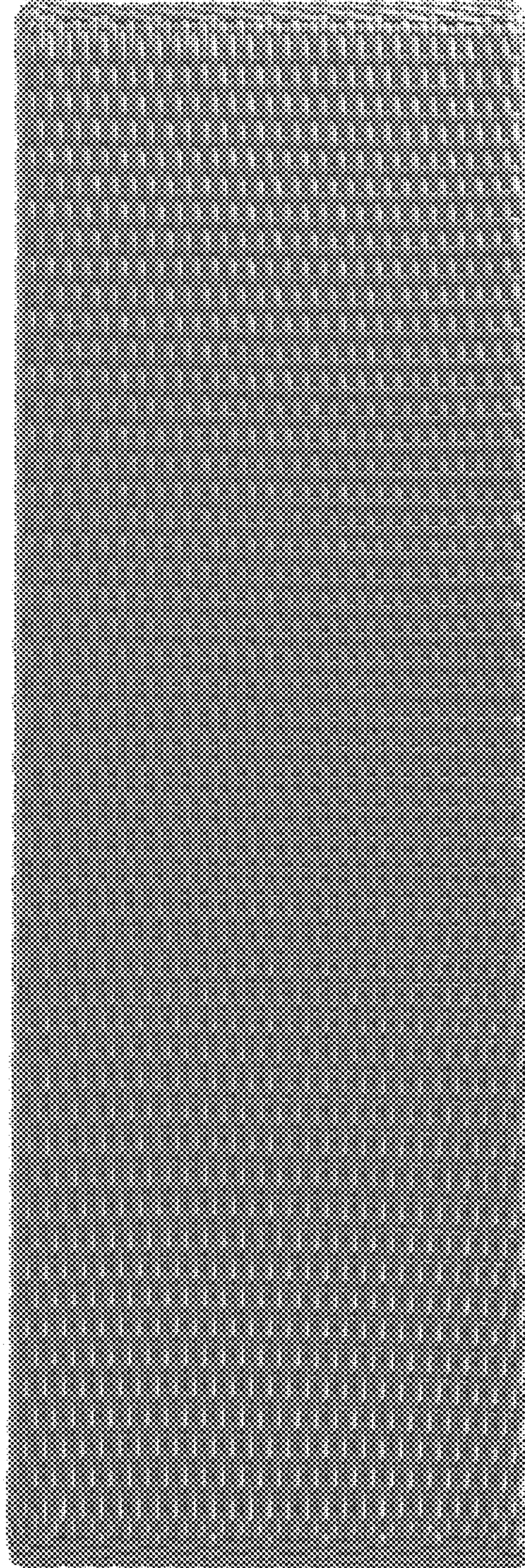
