**DESCRIPTION**

FIG. 1 is a top front perspective view of a lid with carry loop showing our new design;

FIG. 5 is a left side view of the lid with carry loop shown in FIG. 1;

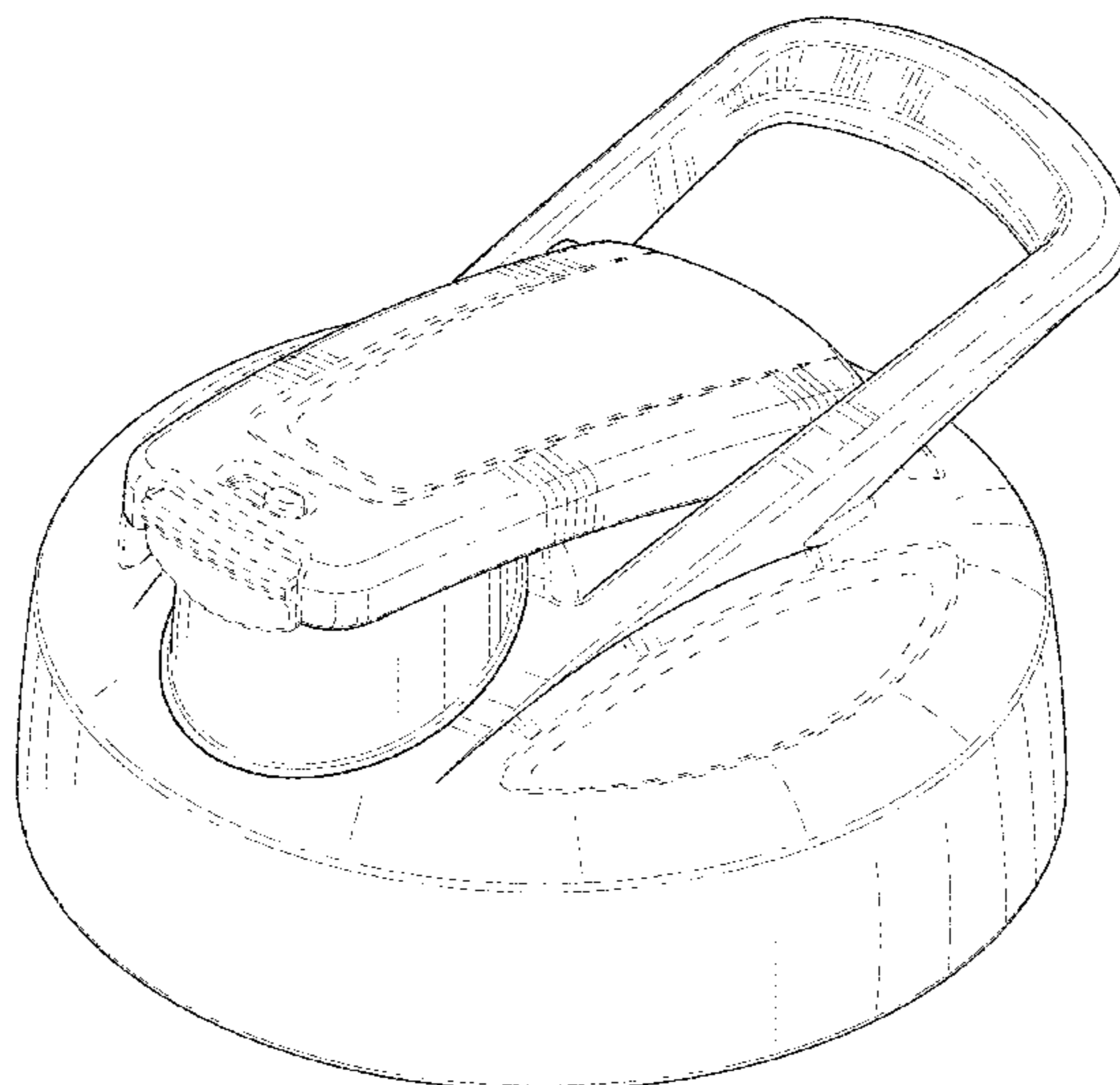
FIG. 6 is a right side view of the lid with carry loop shown in FIG. 1;

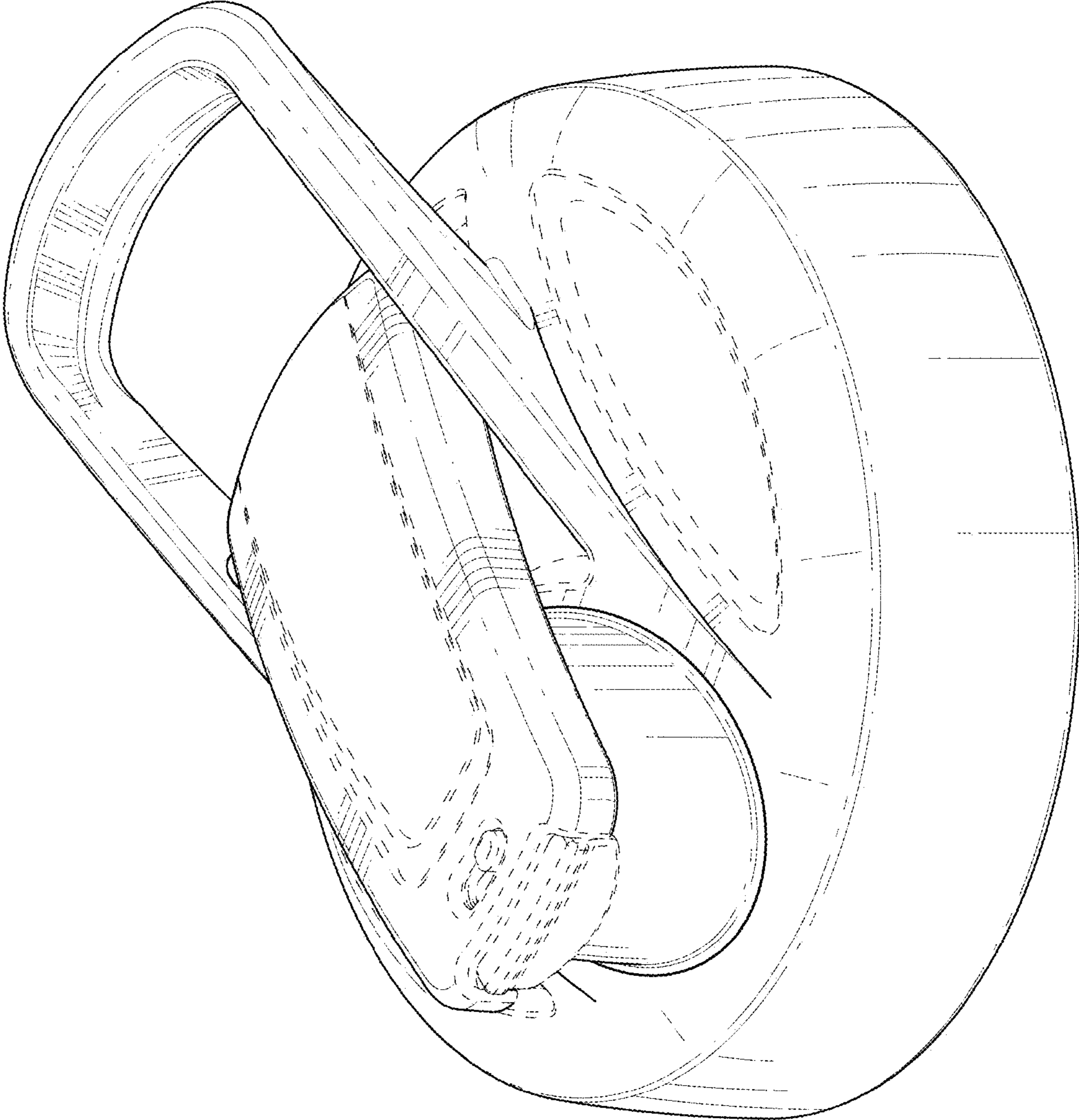

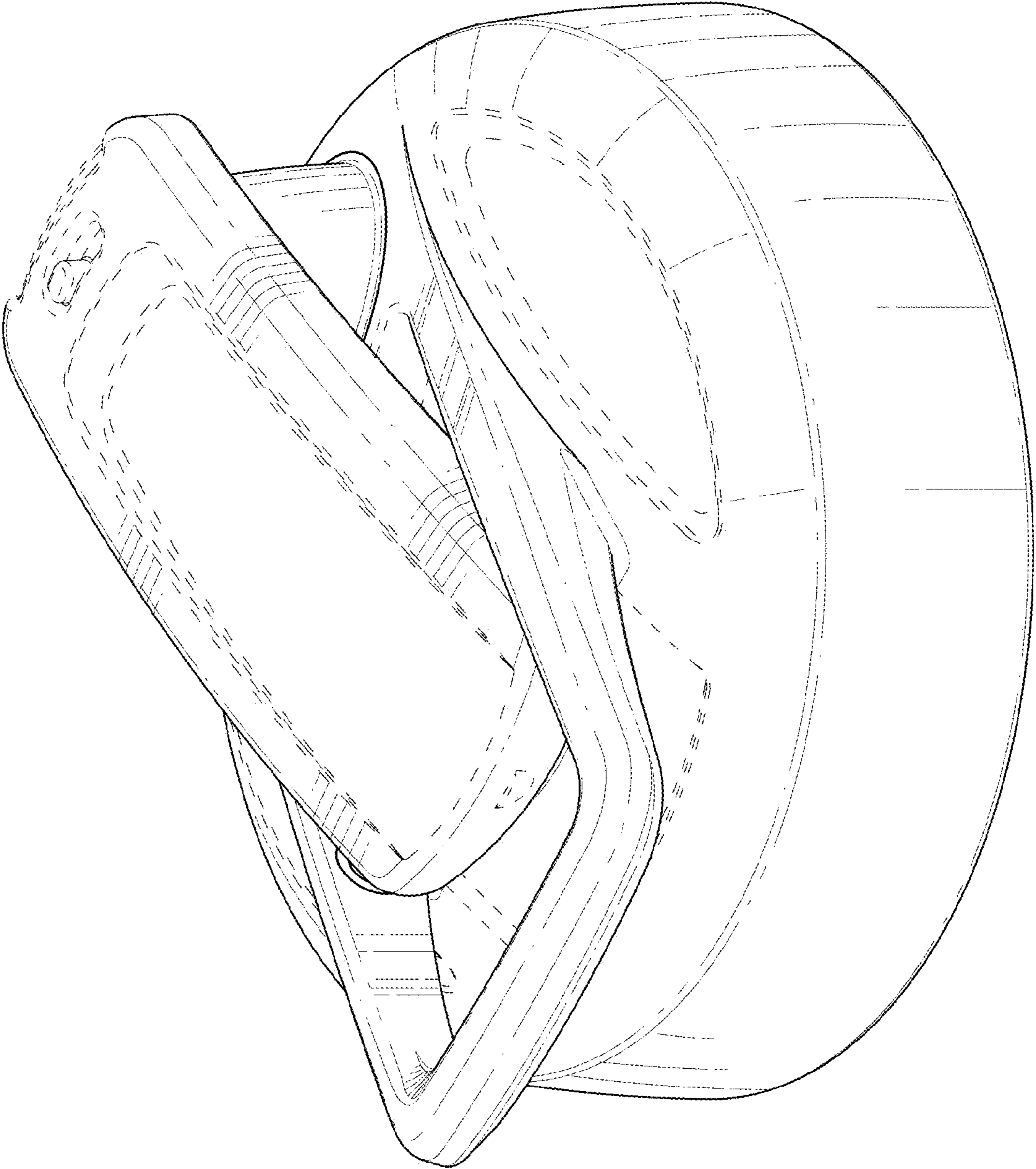

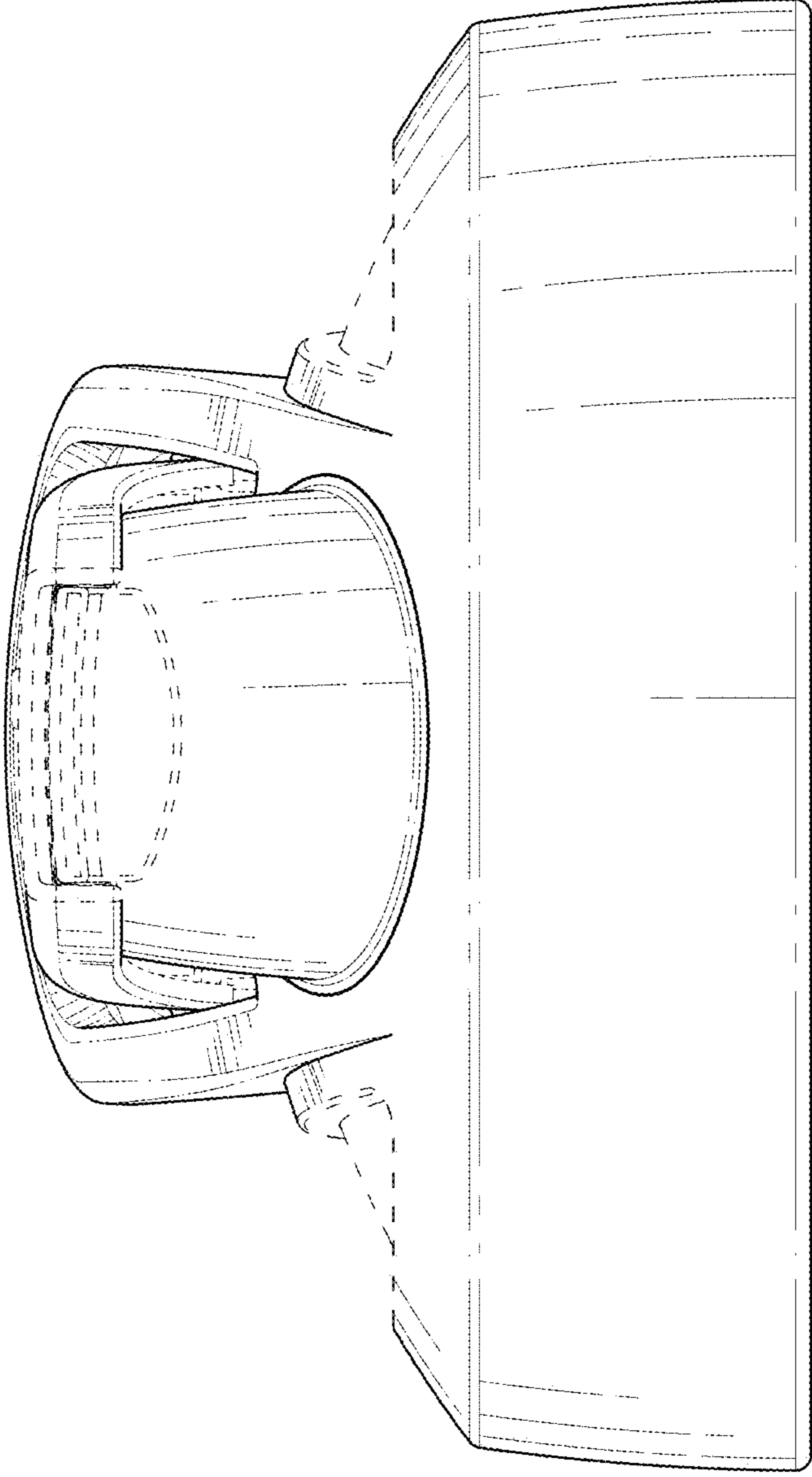

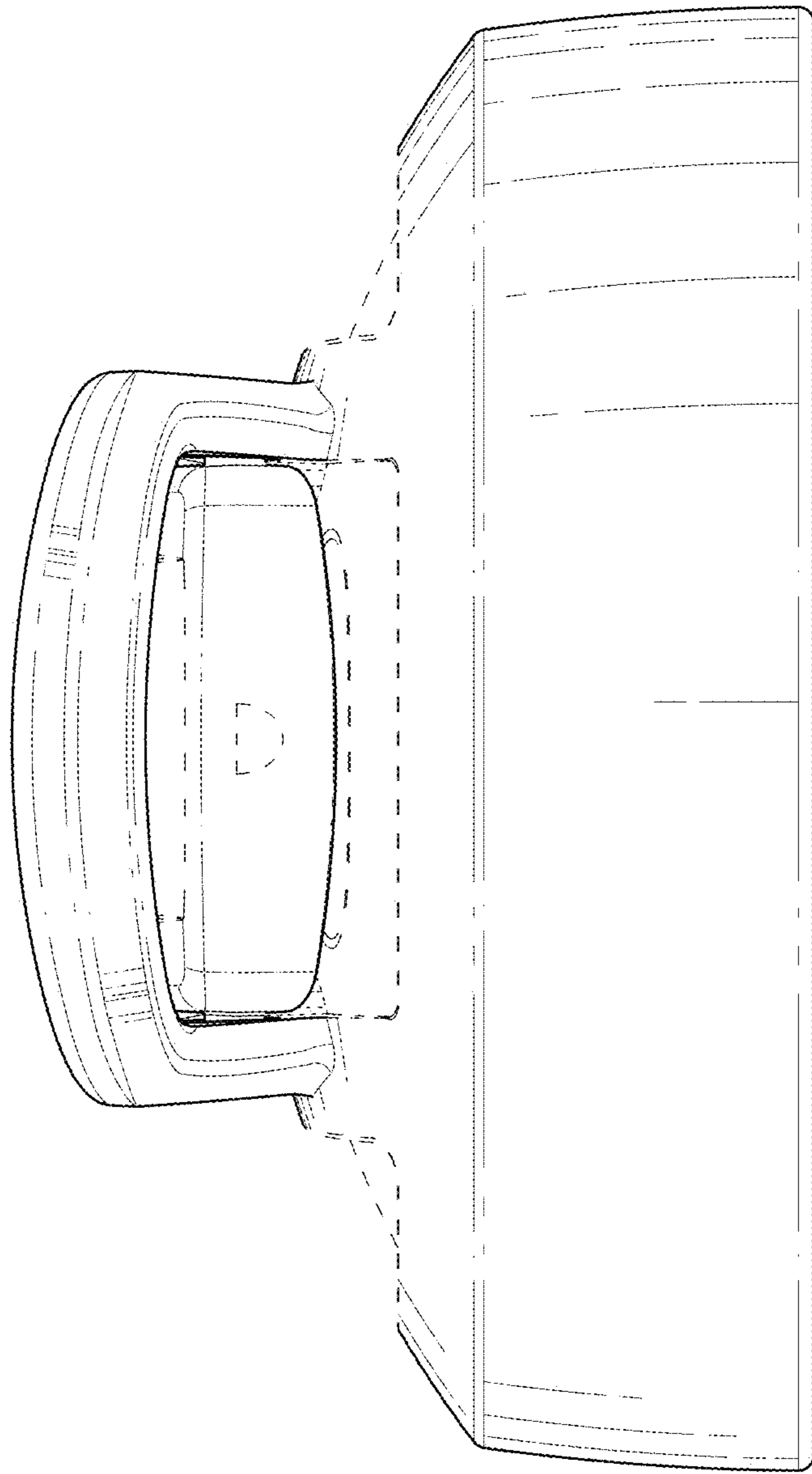

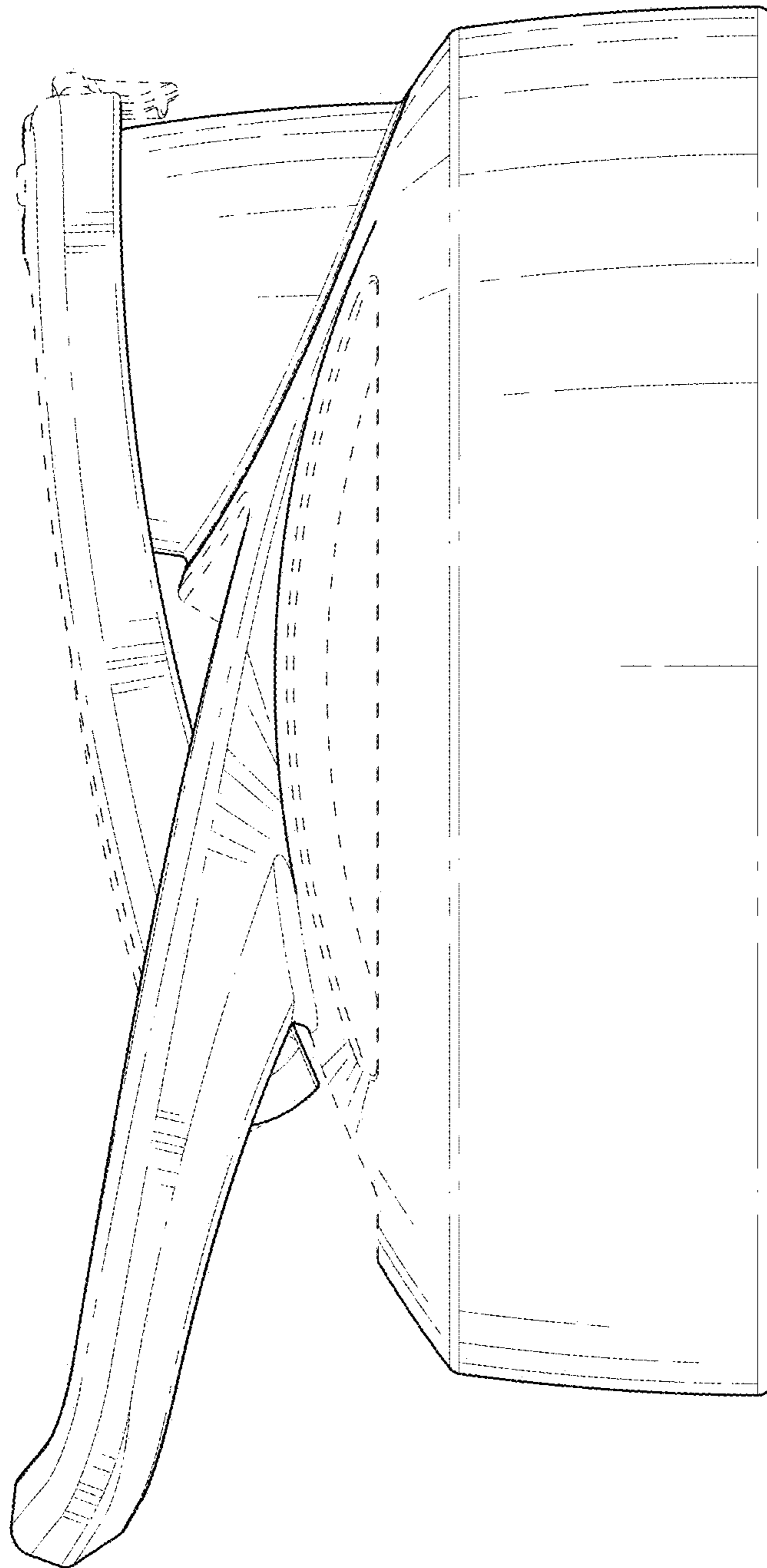

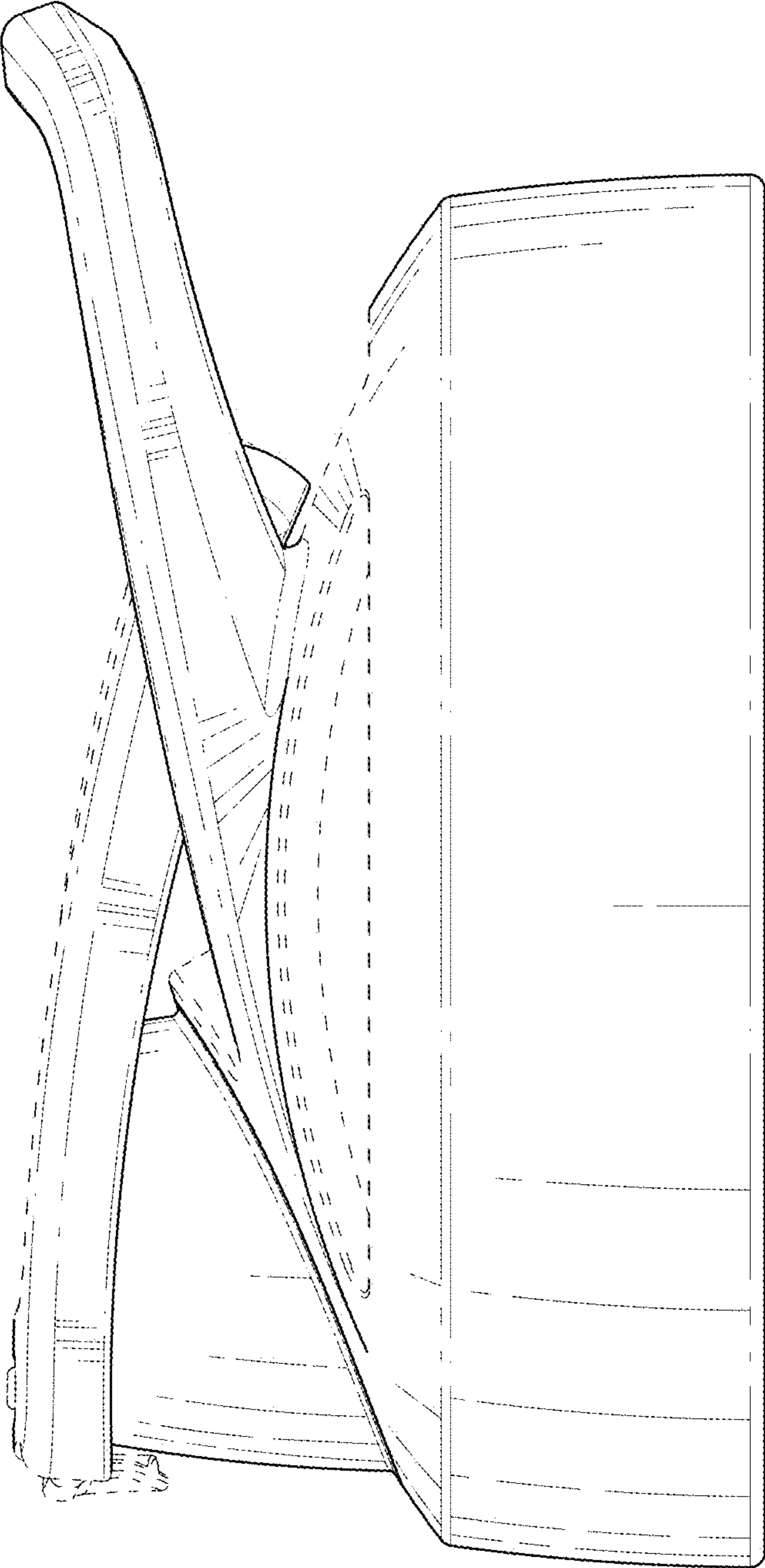

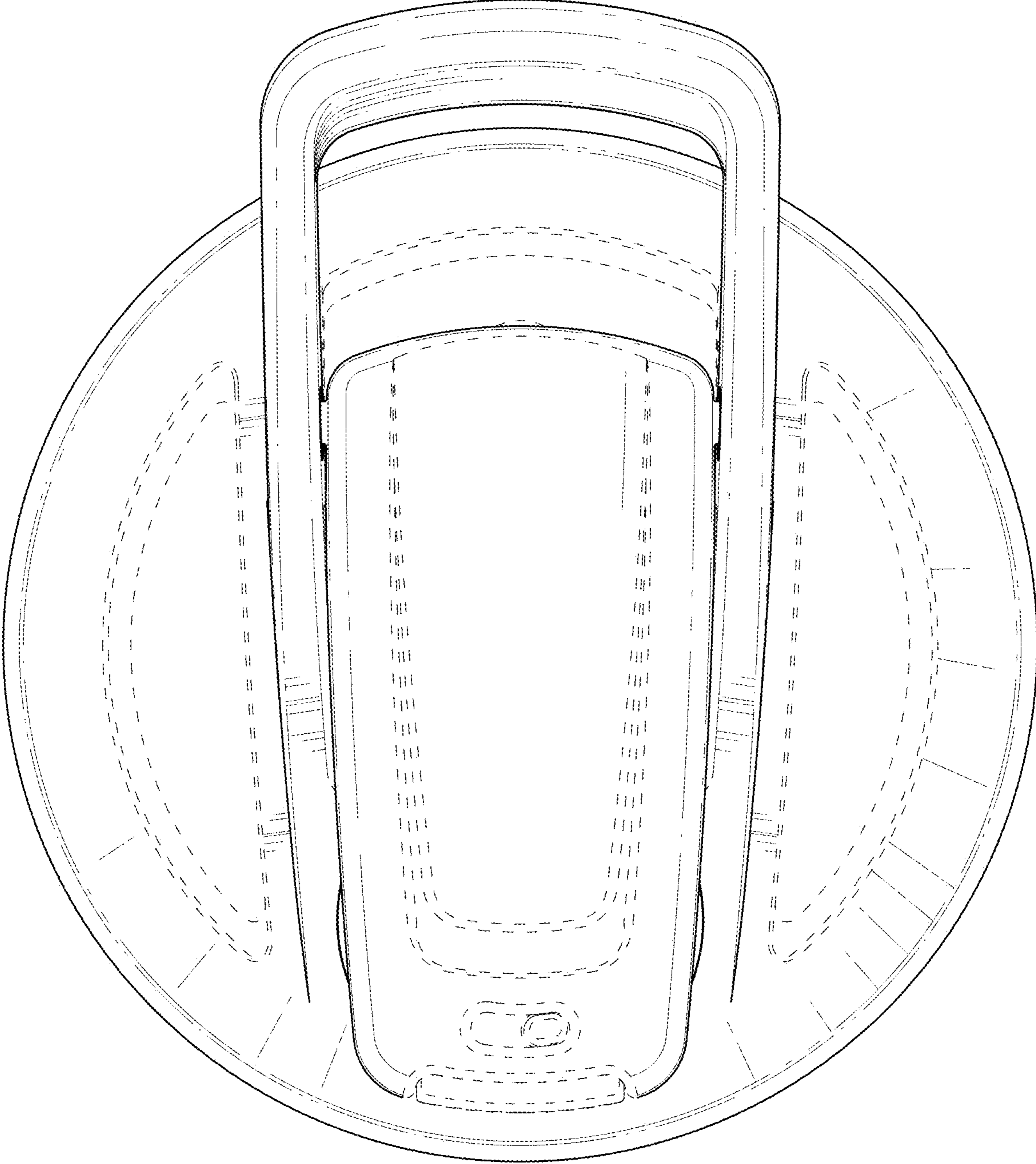

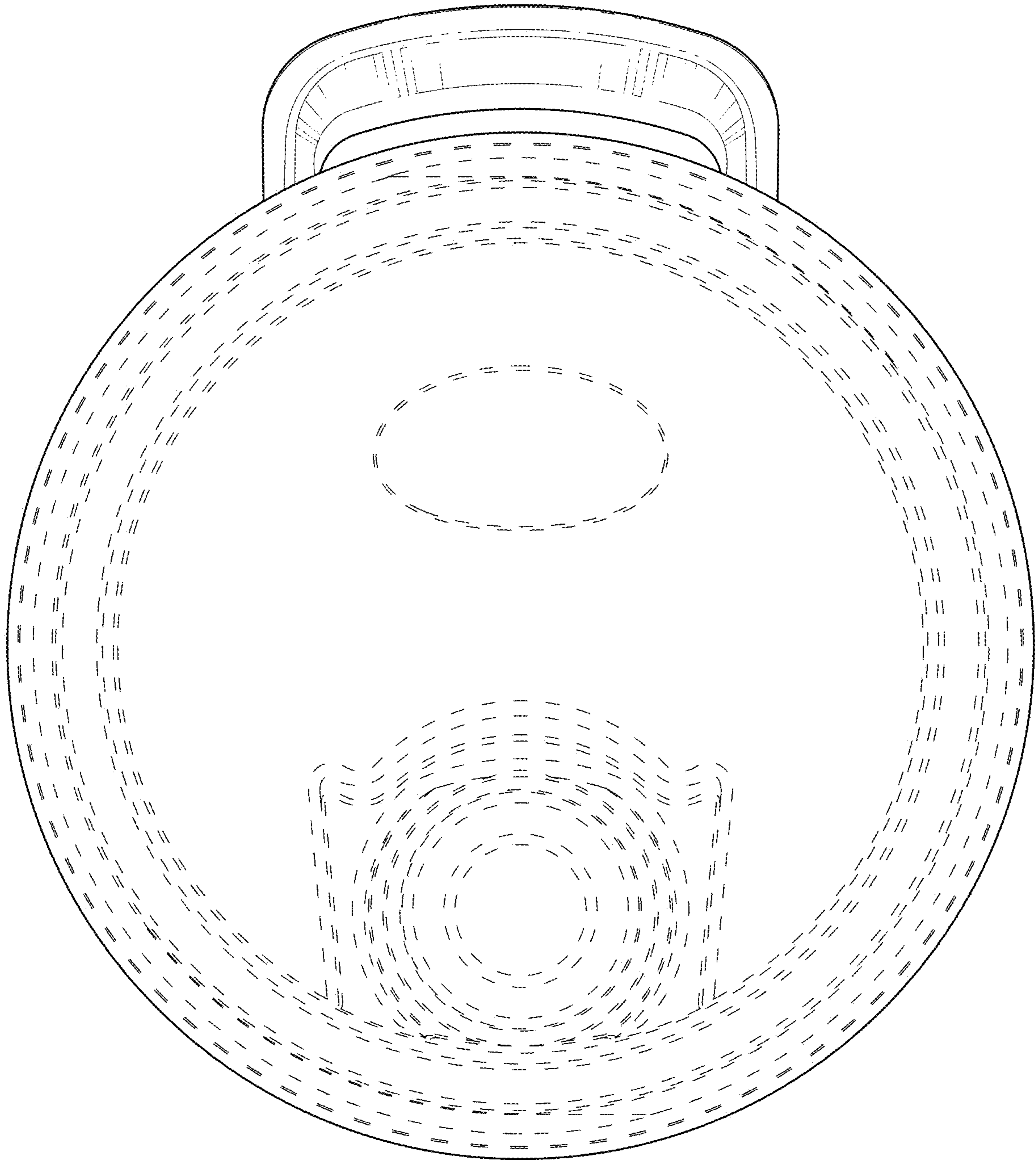
