The ornamental design for a tool, as shown and described.

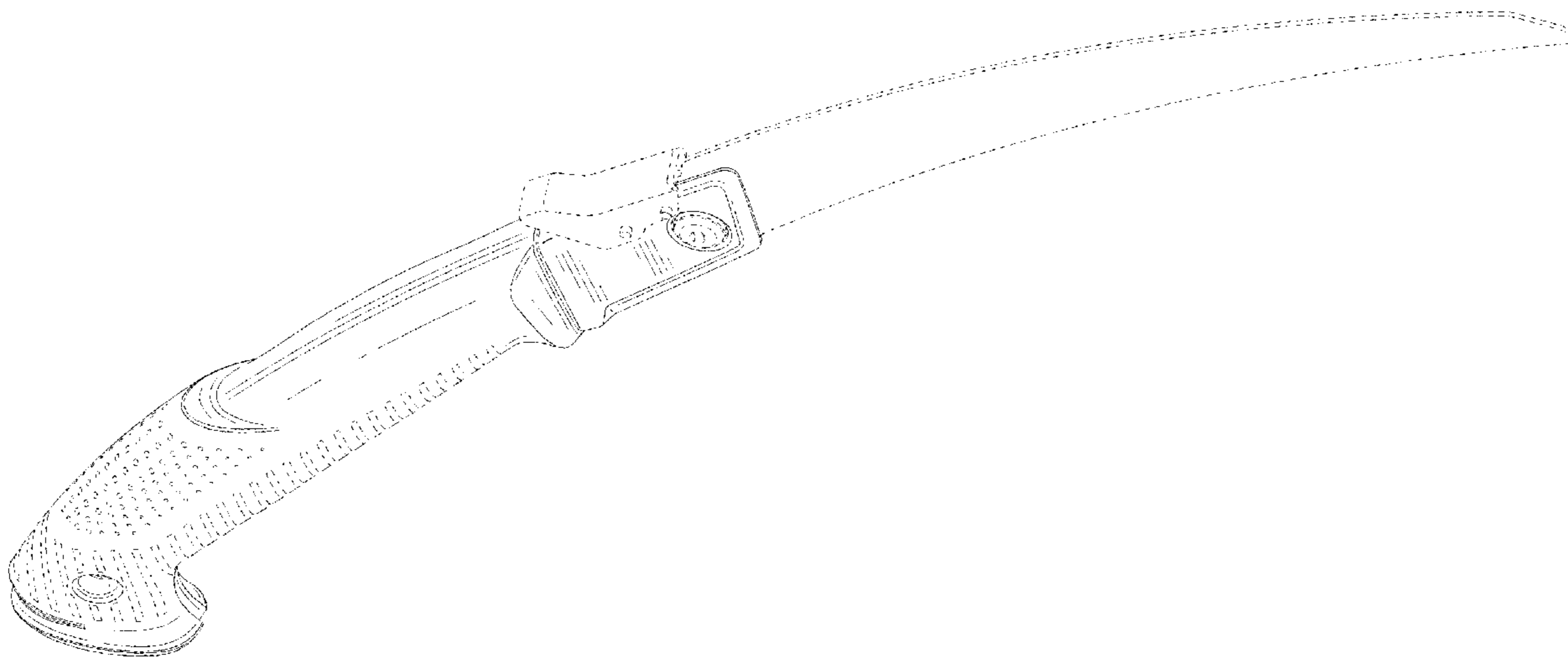
DESCRIPTION

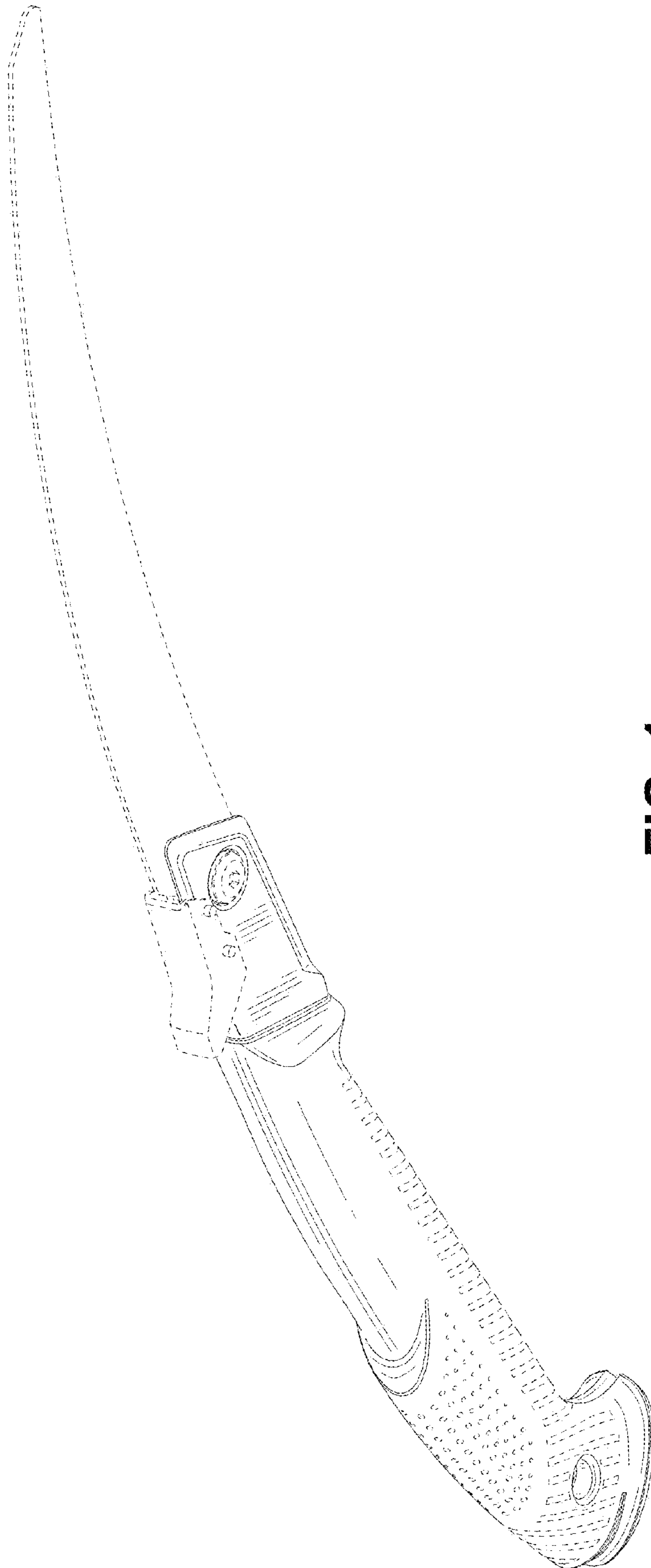

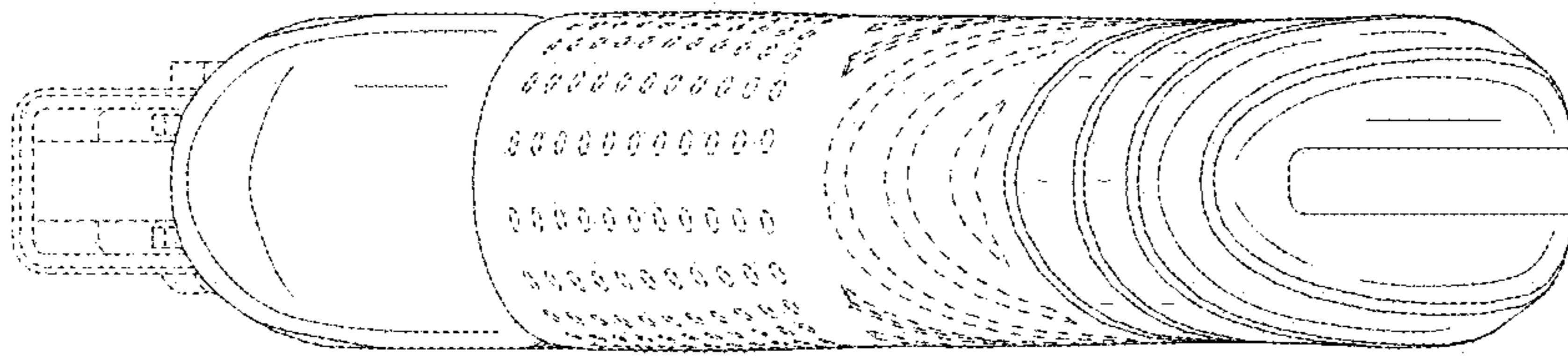

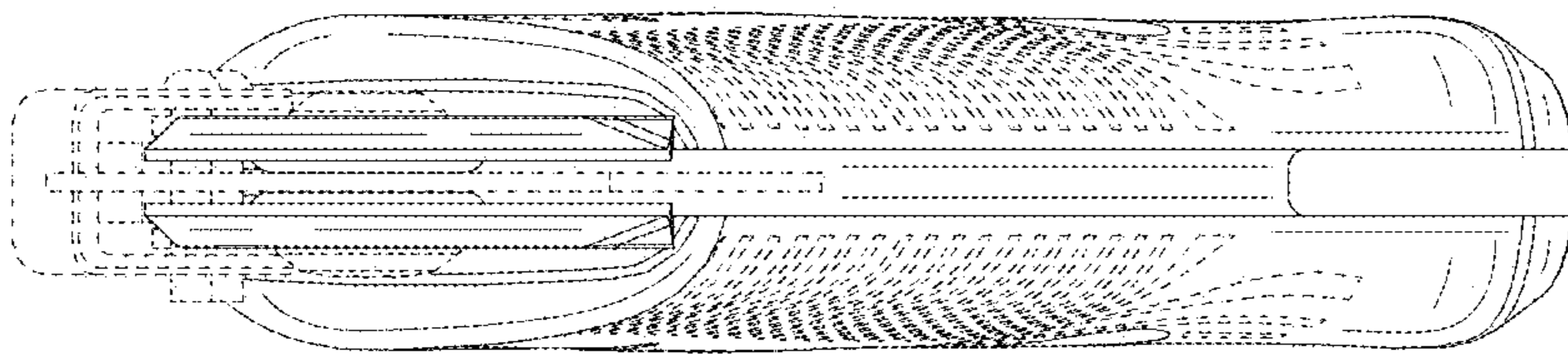

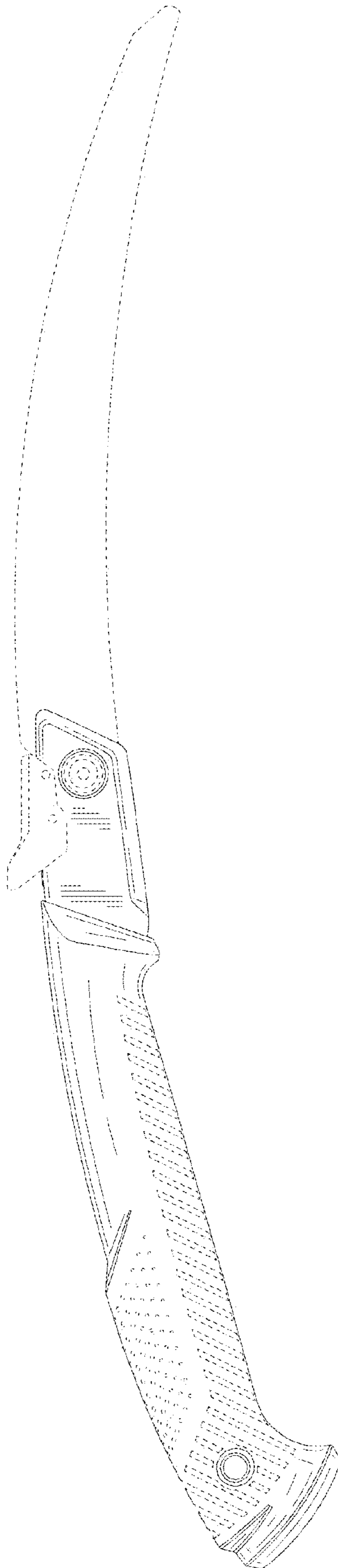

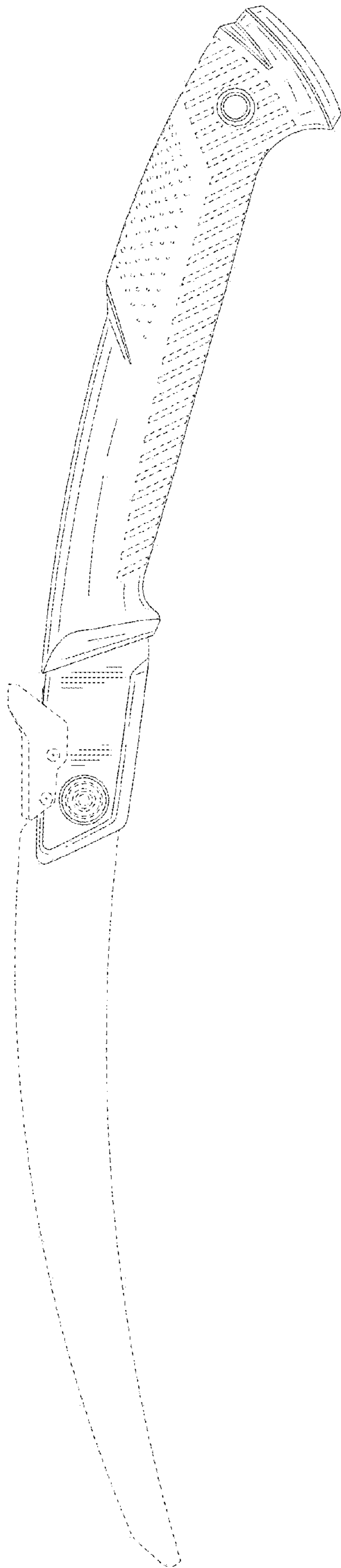

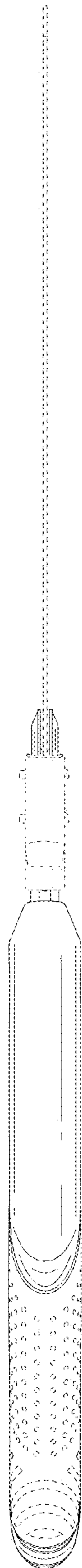

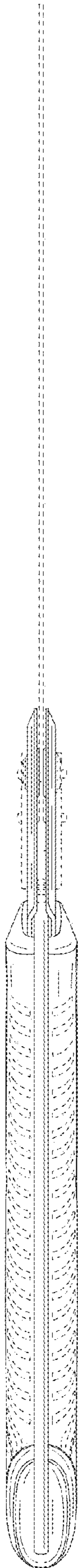
