(57) **CLAIM**

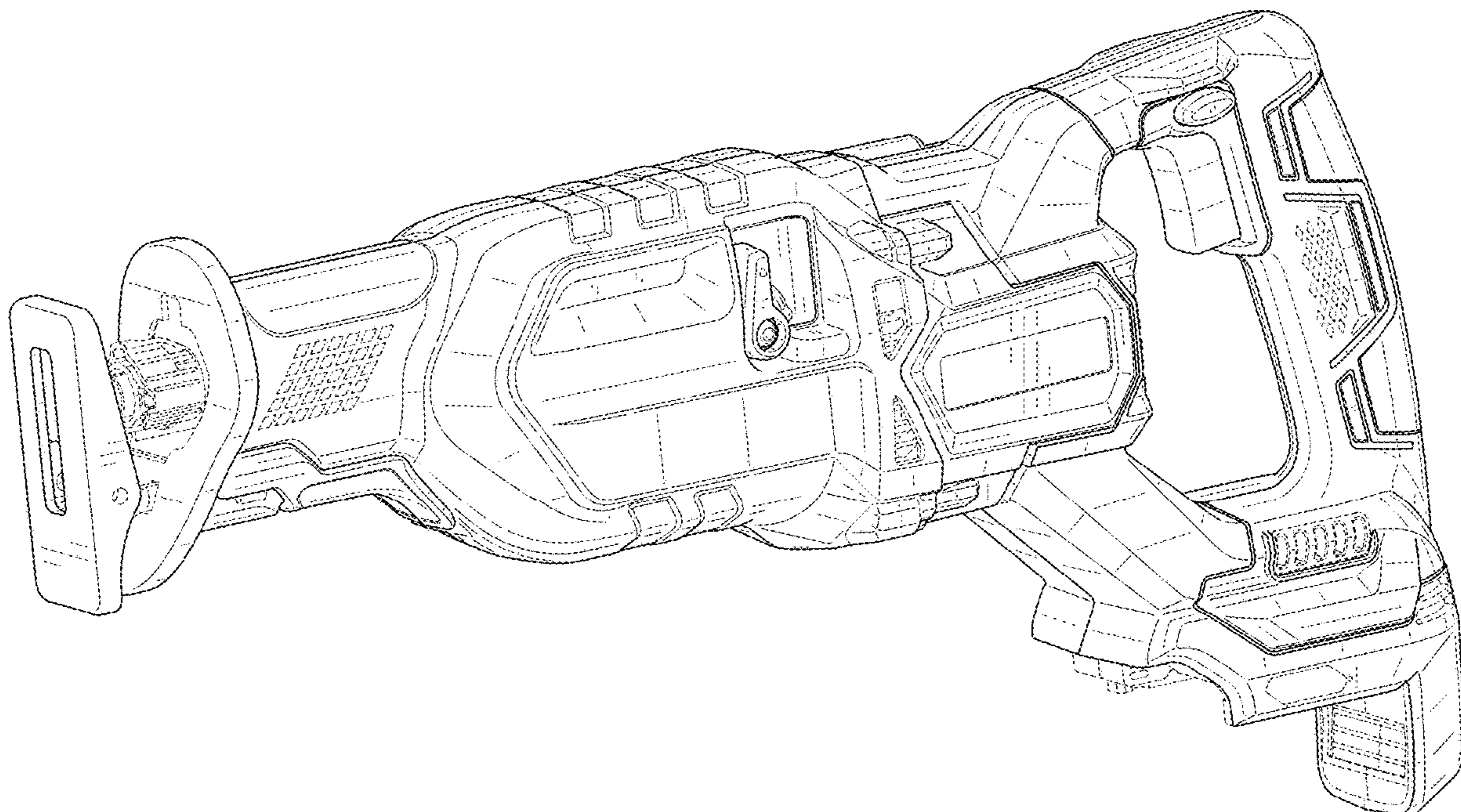
The ornamental design for a portable electric saw, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portable electric saw showing our new design;

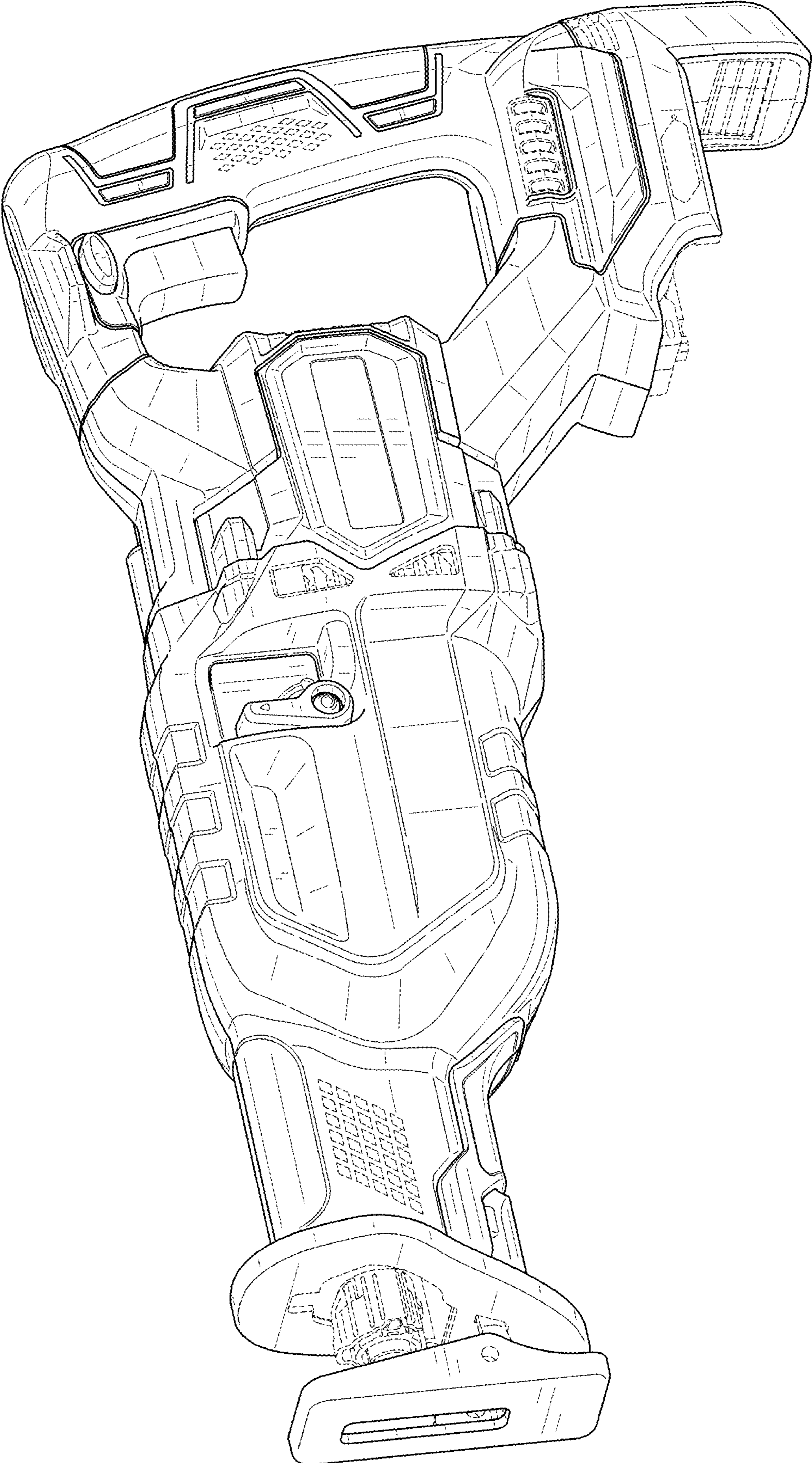

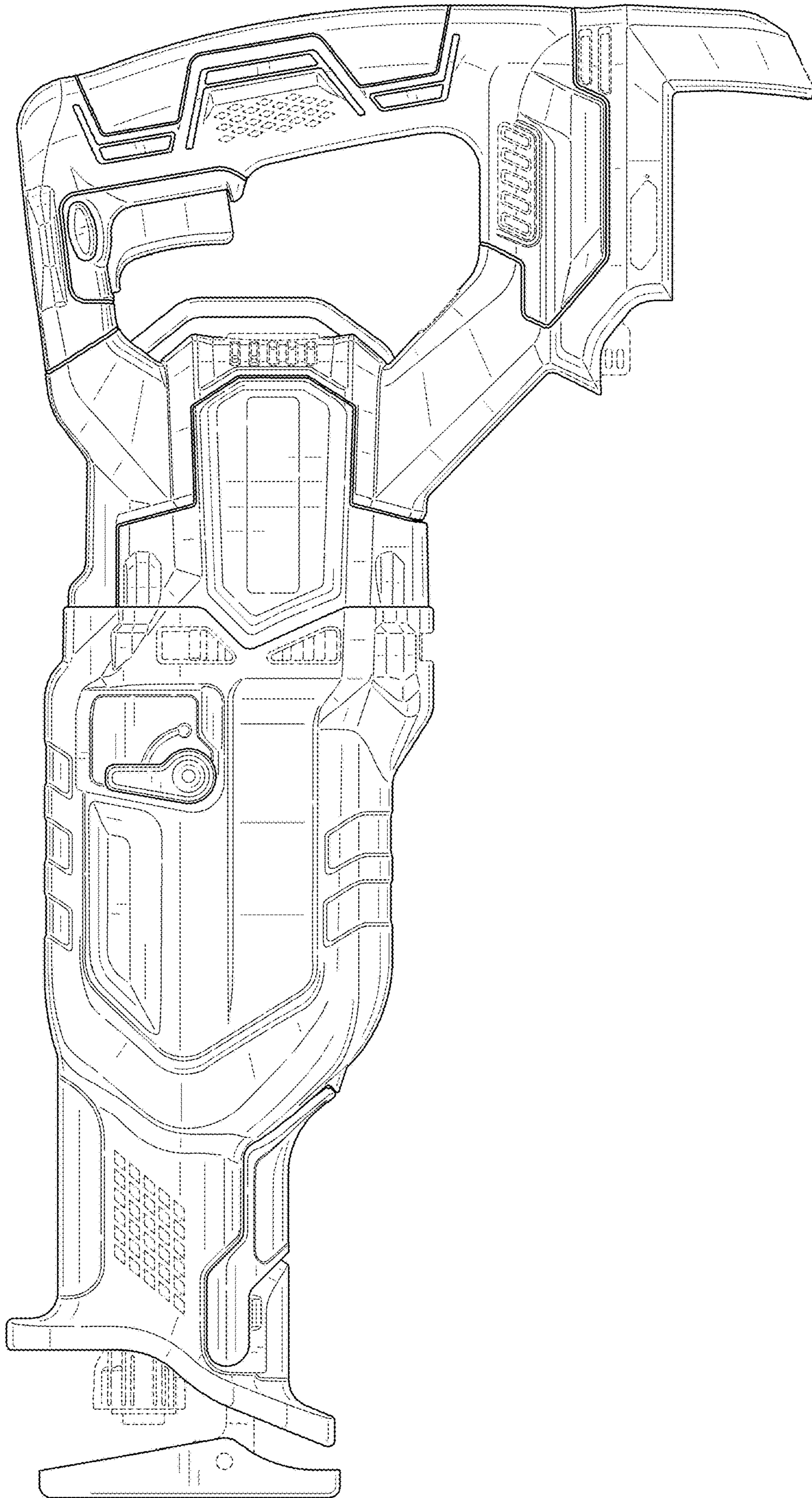

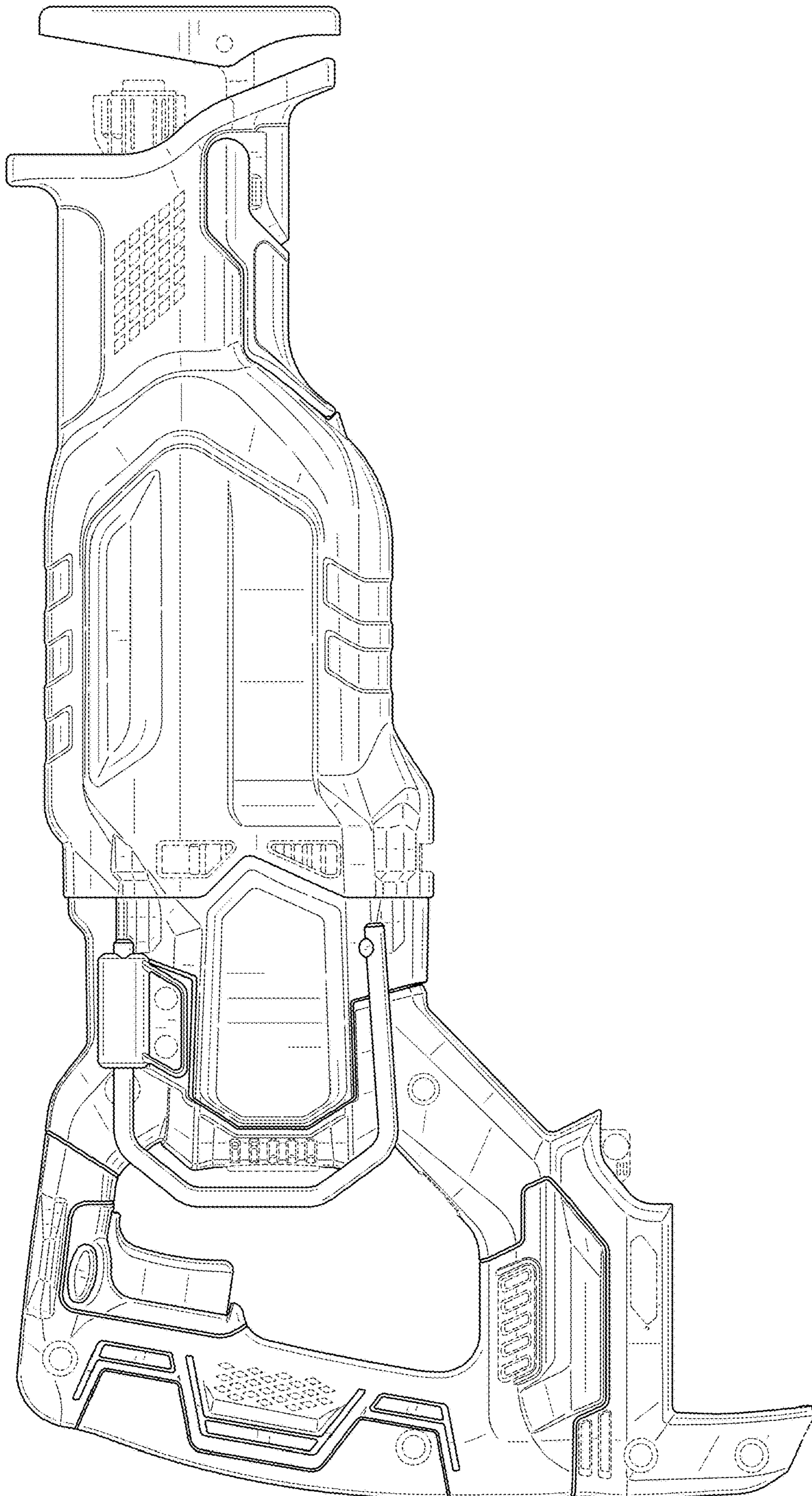

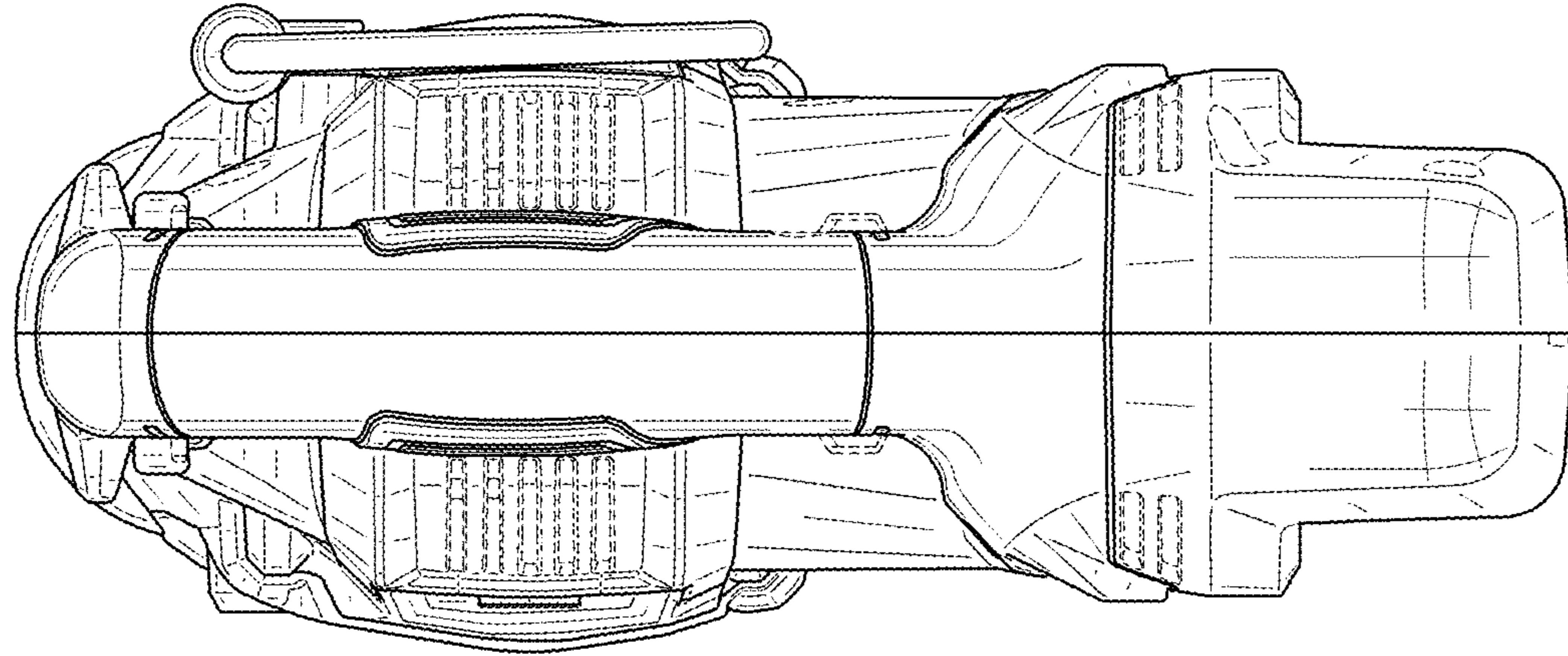

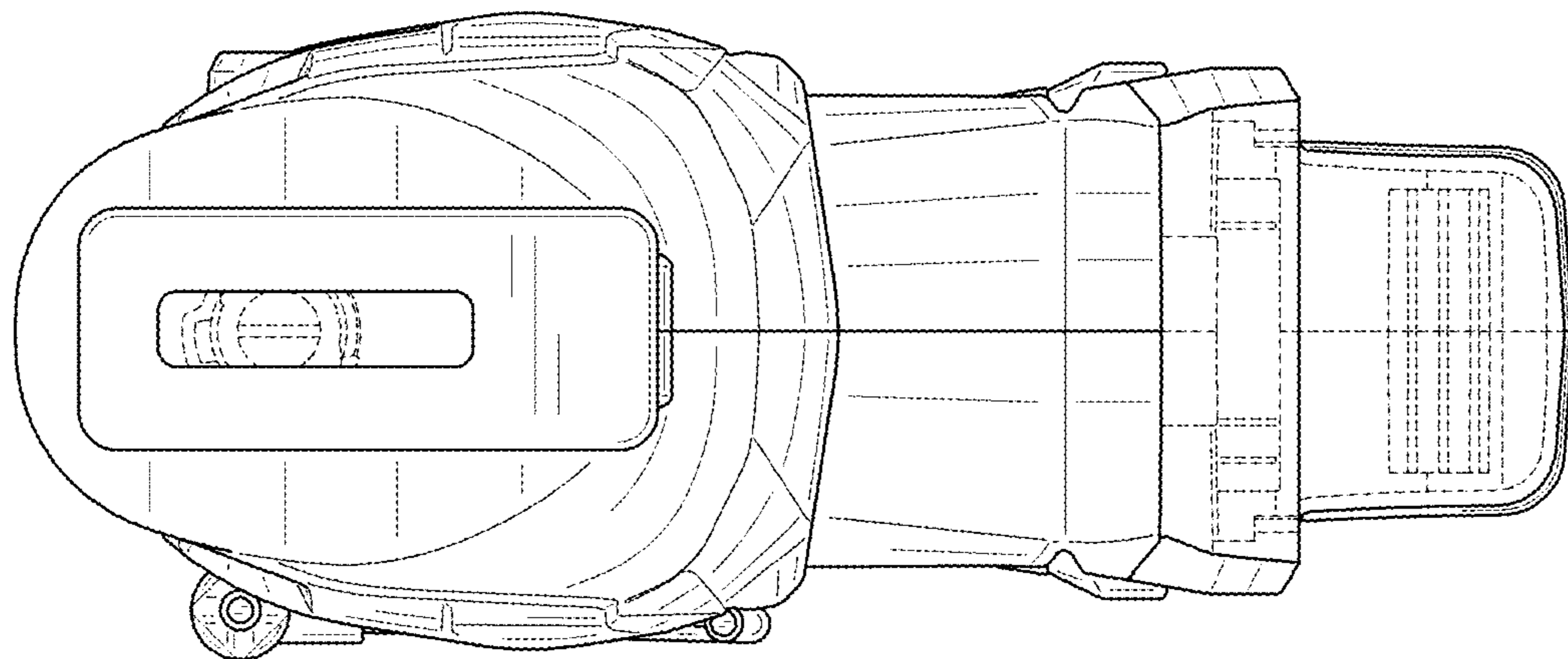

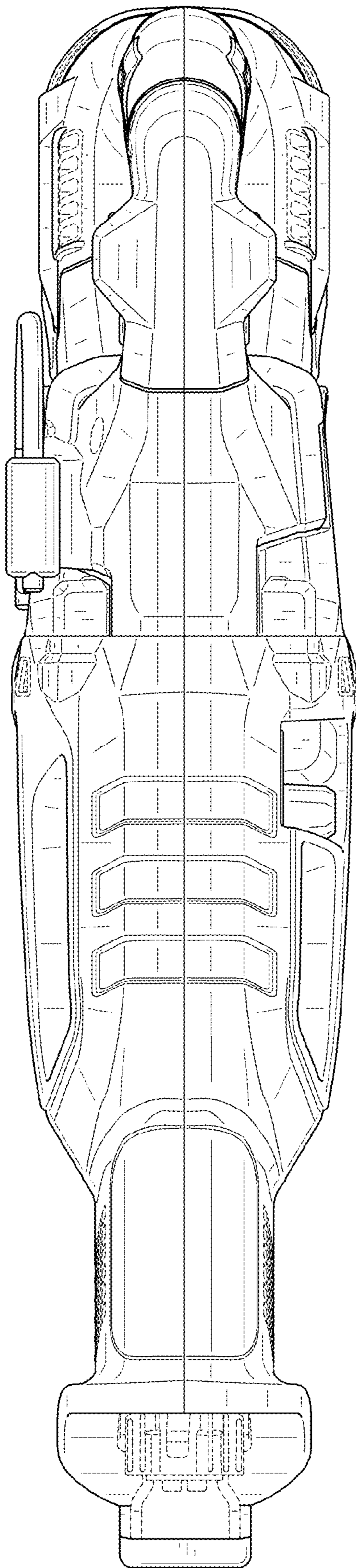

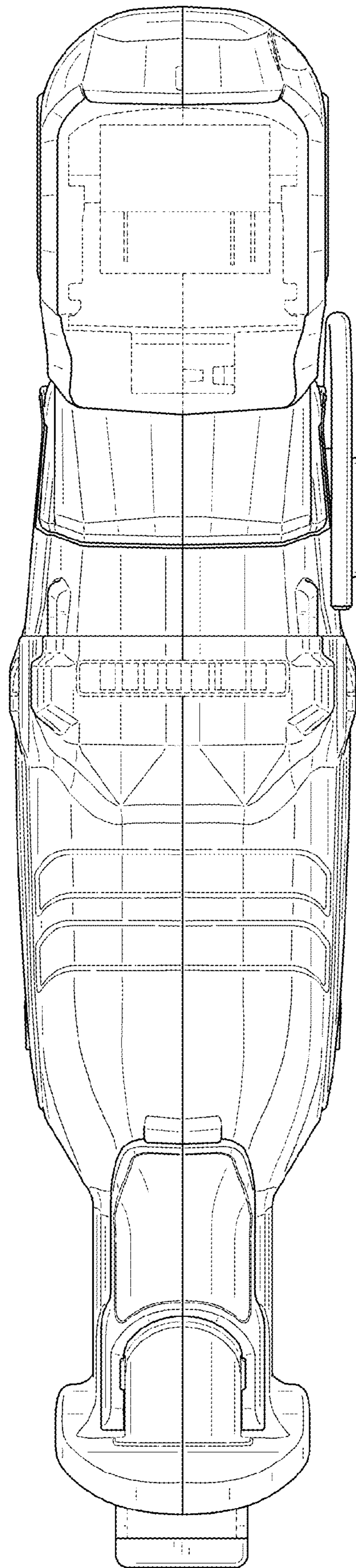
