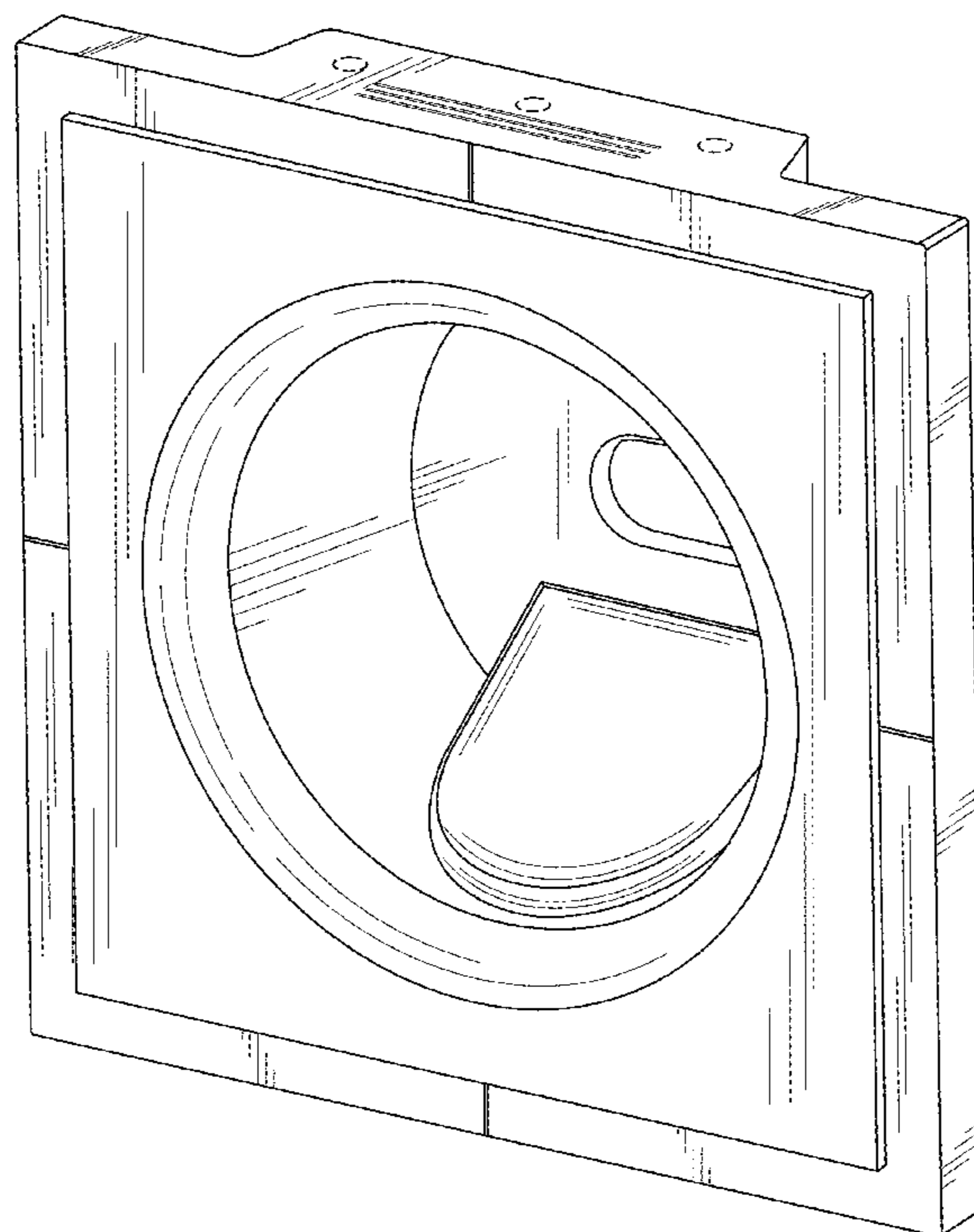
(57) **CLAIM**

The ornamental design for a mount for electronic personal assistant, as shown and described.

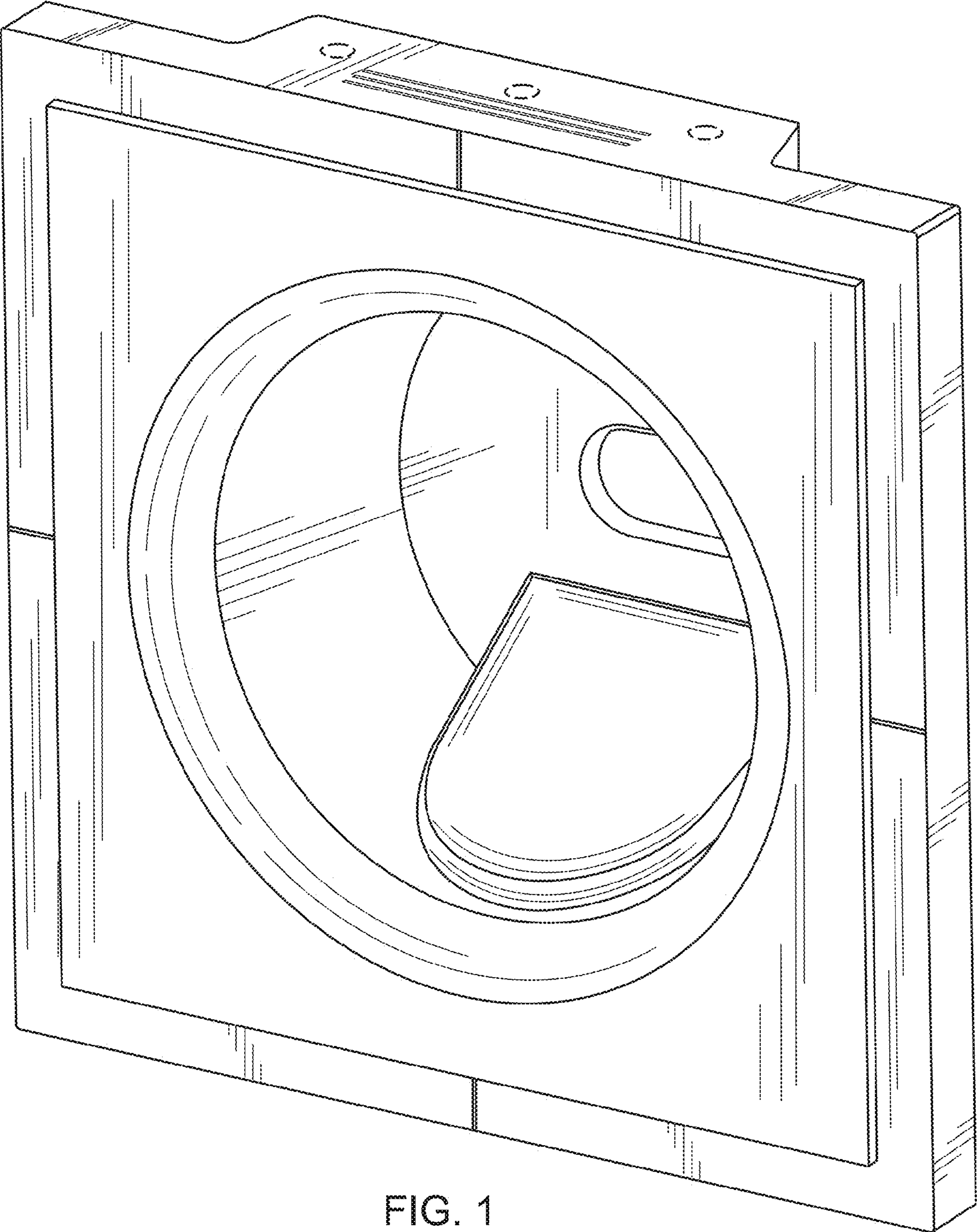

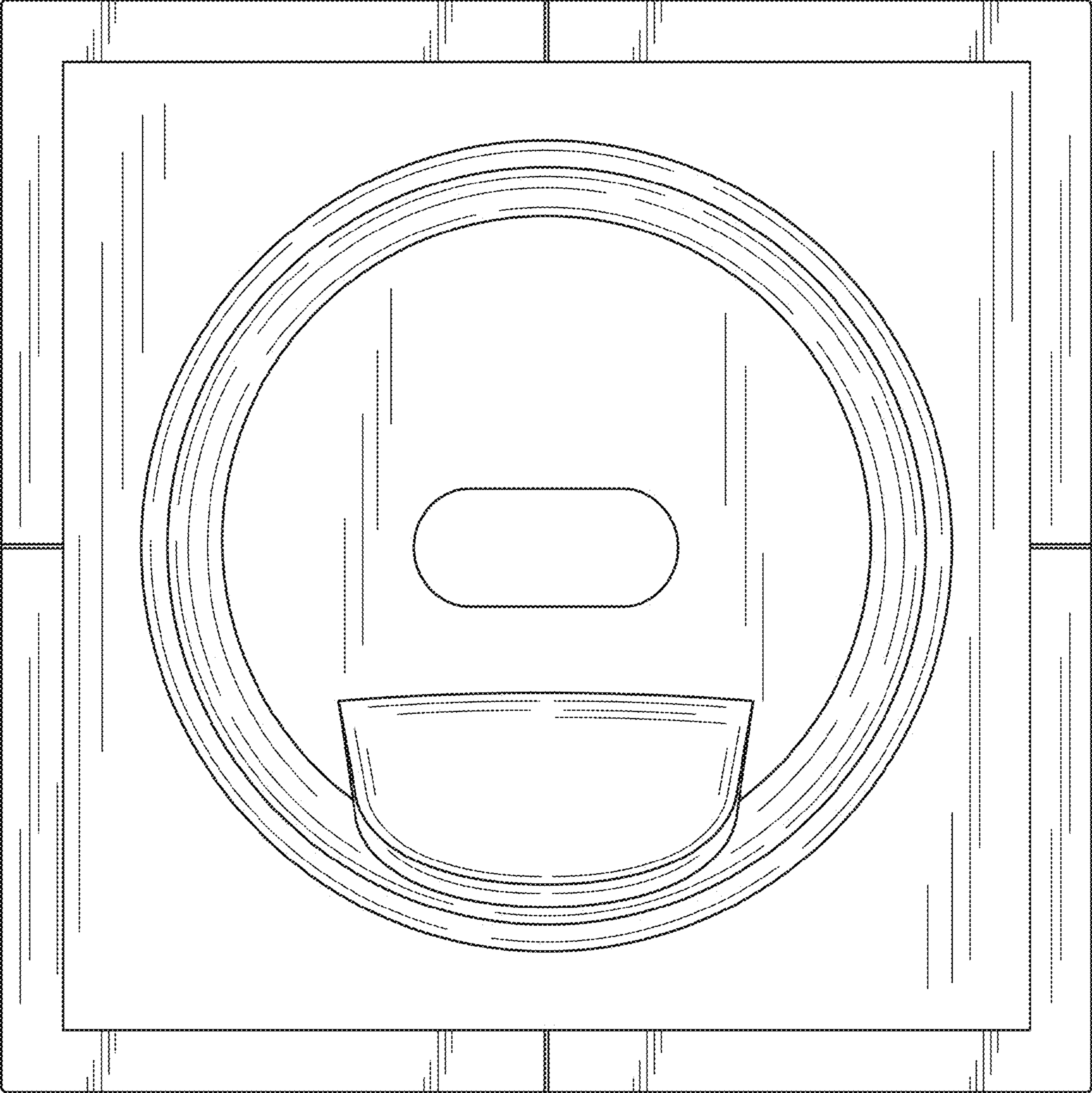
