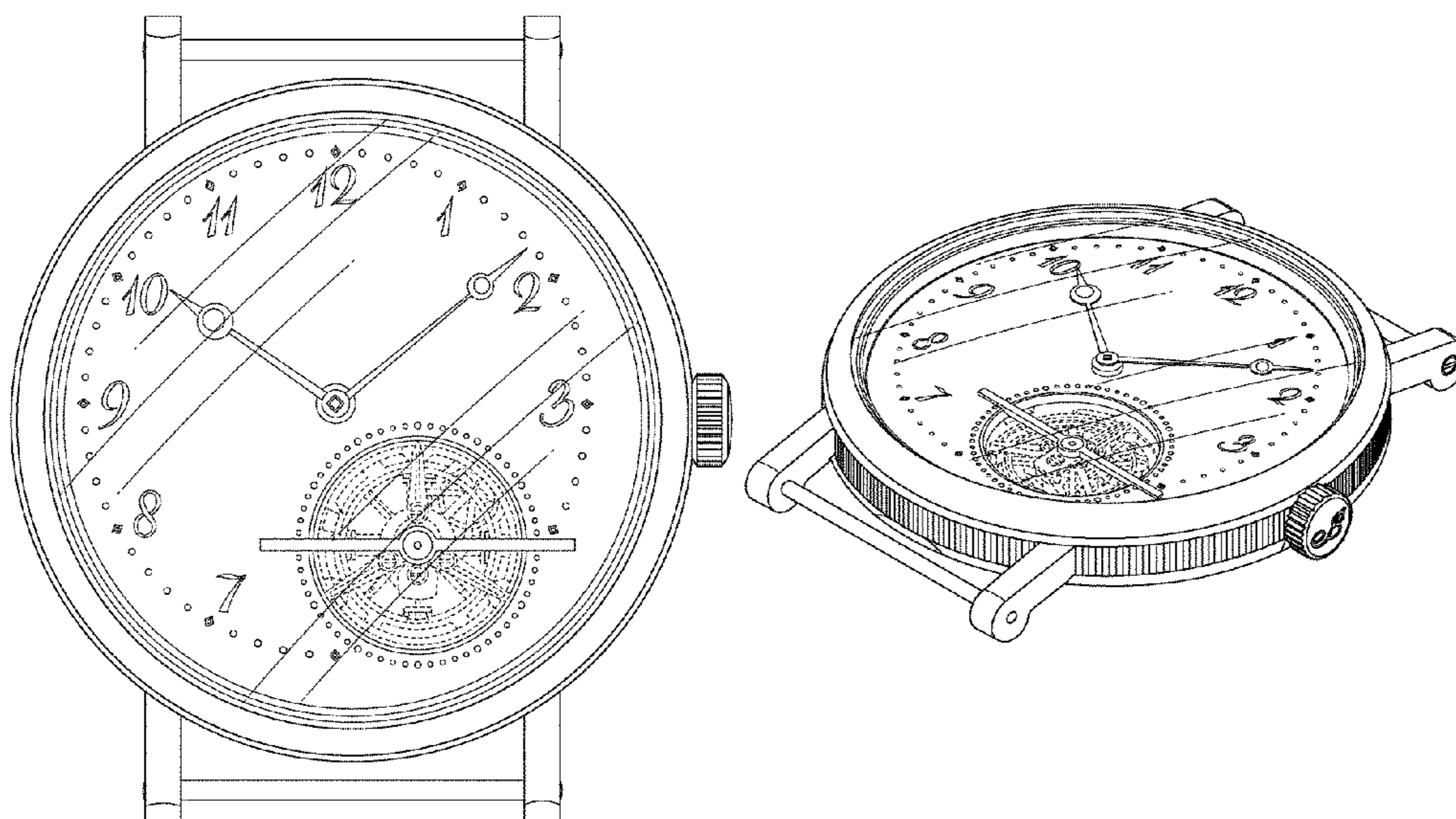
(57) **CLAIM**

The ornamental design for a watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a watch of the present design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; and FIG. 7 is a top perspective view thereof; and, FIG. 8 is a bottom perspective view thereof. The broken line showing of the watch is for the purpose of illustrating portions of the article and forms no part of the claimed design. The cursive letter “B” disclosed on the crown forming part of the claimed design is a registered trademark of Montres Breguet S.A., which is the Applicant and Assignee of this application.

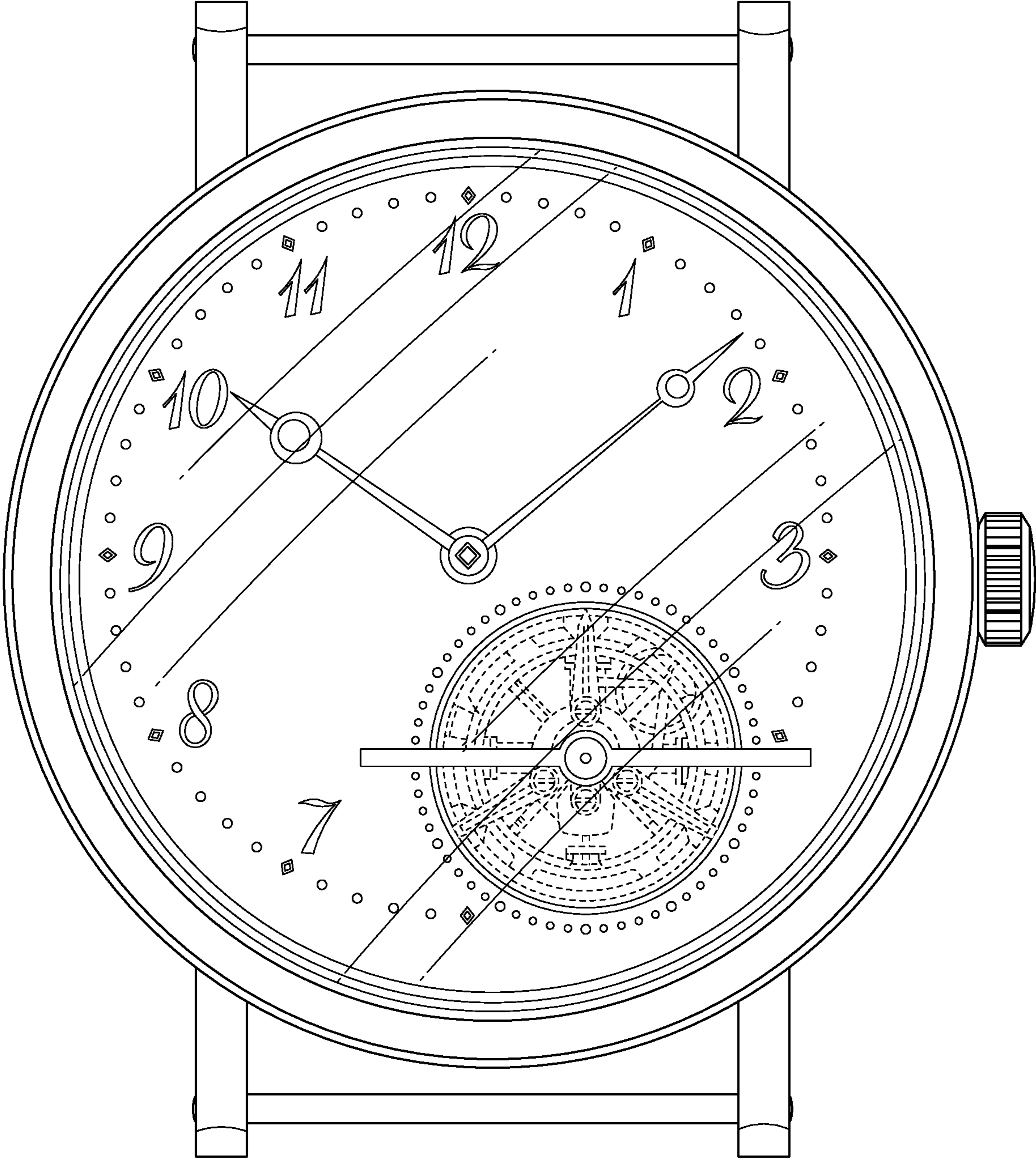

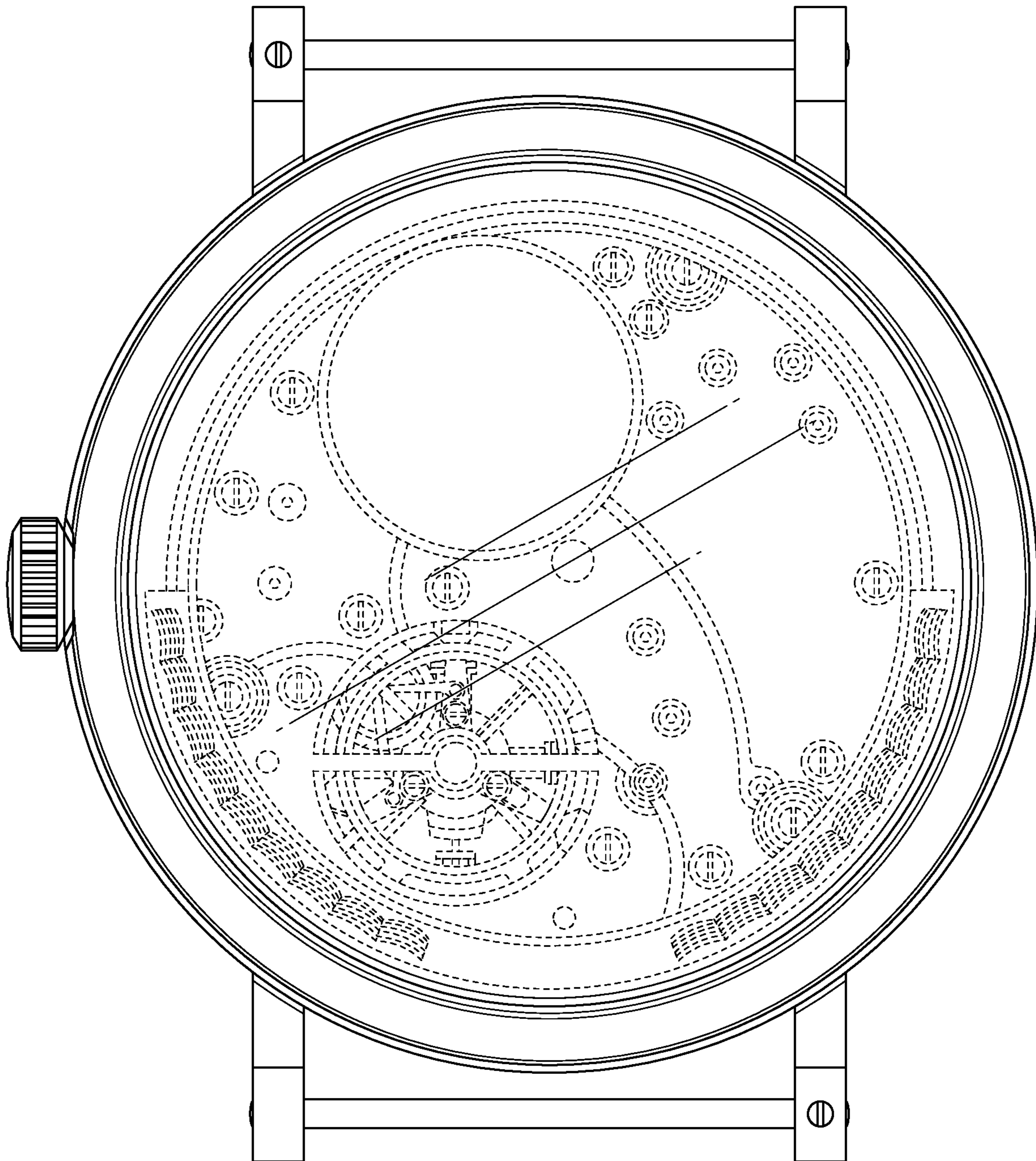

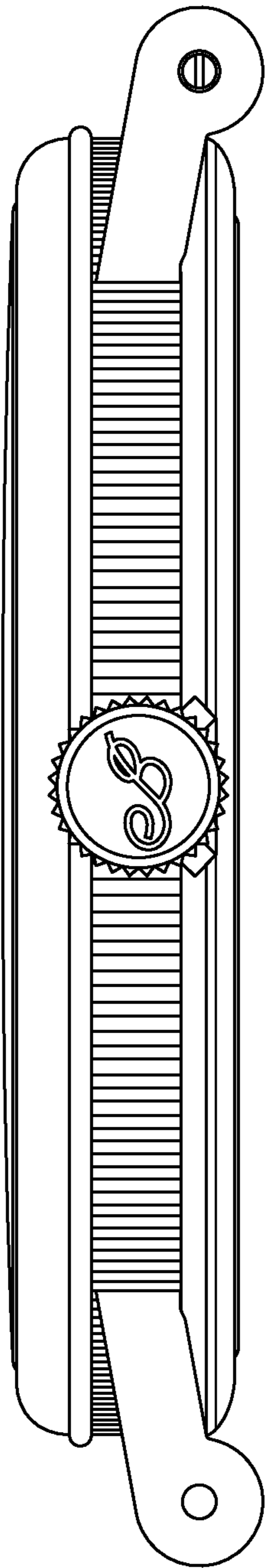

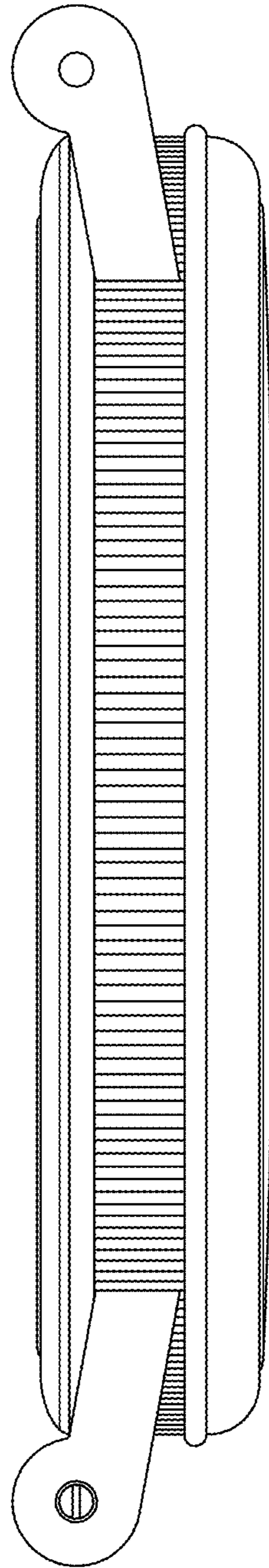

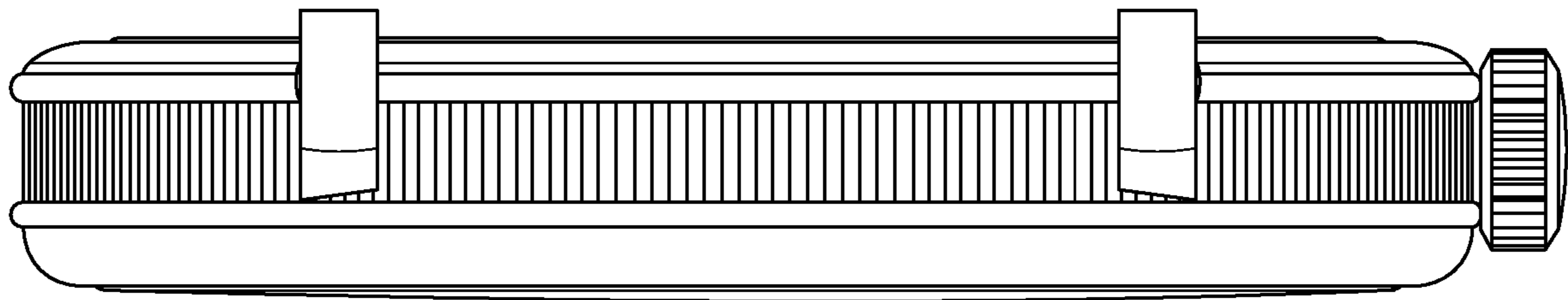

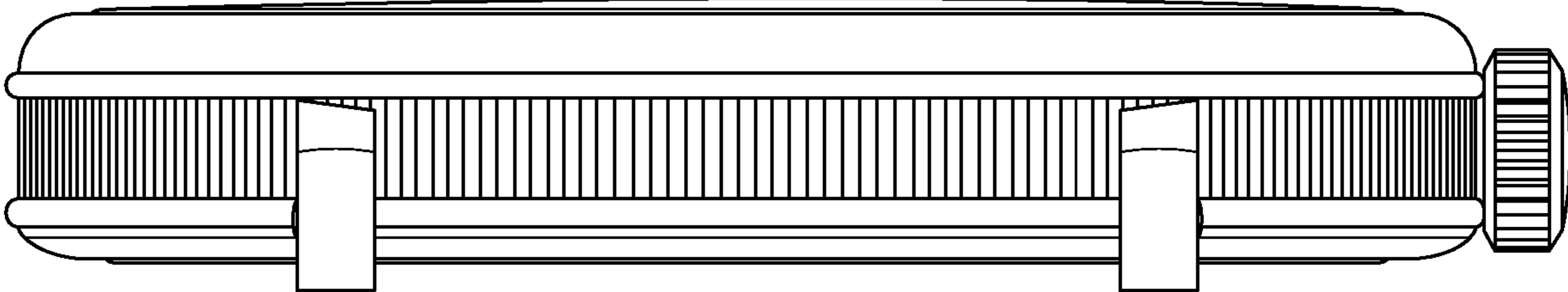

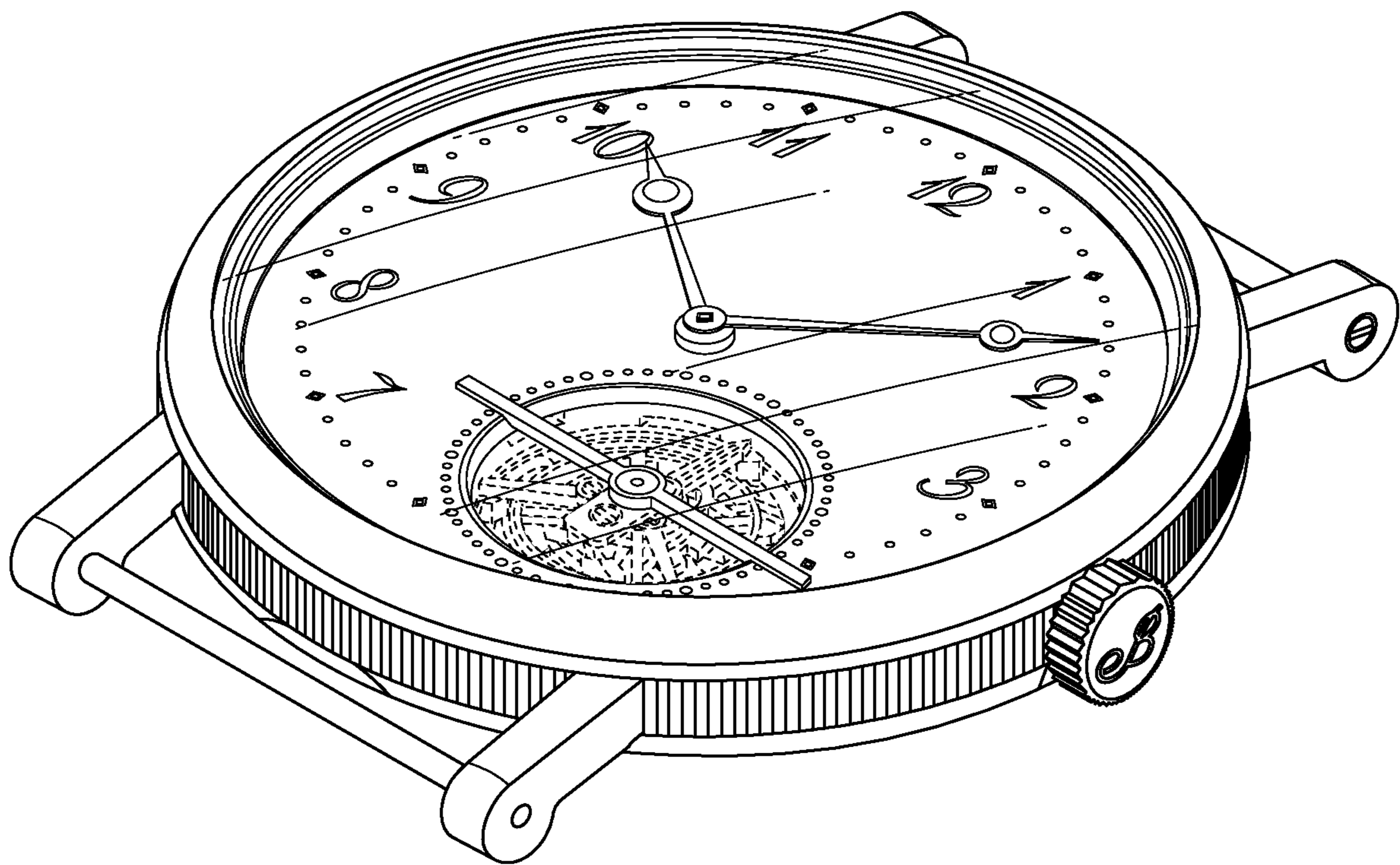

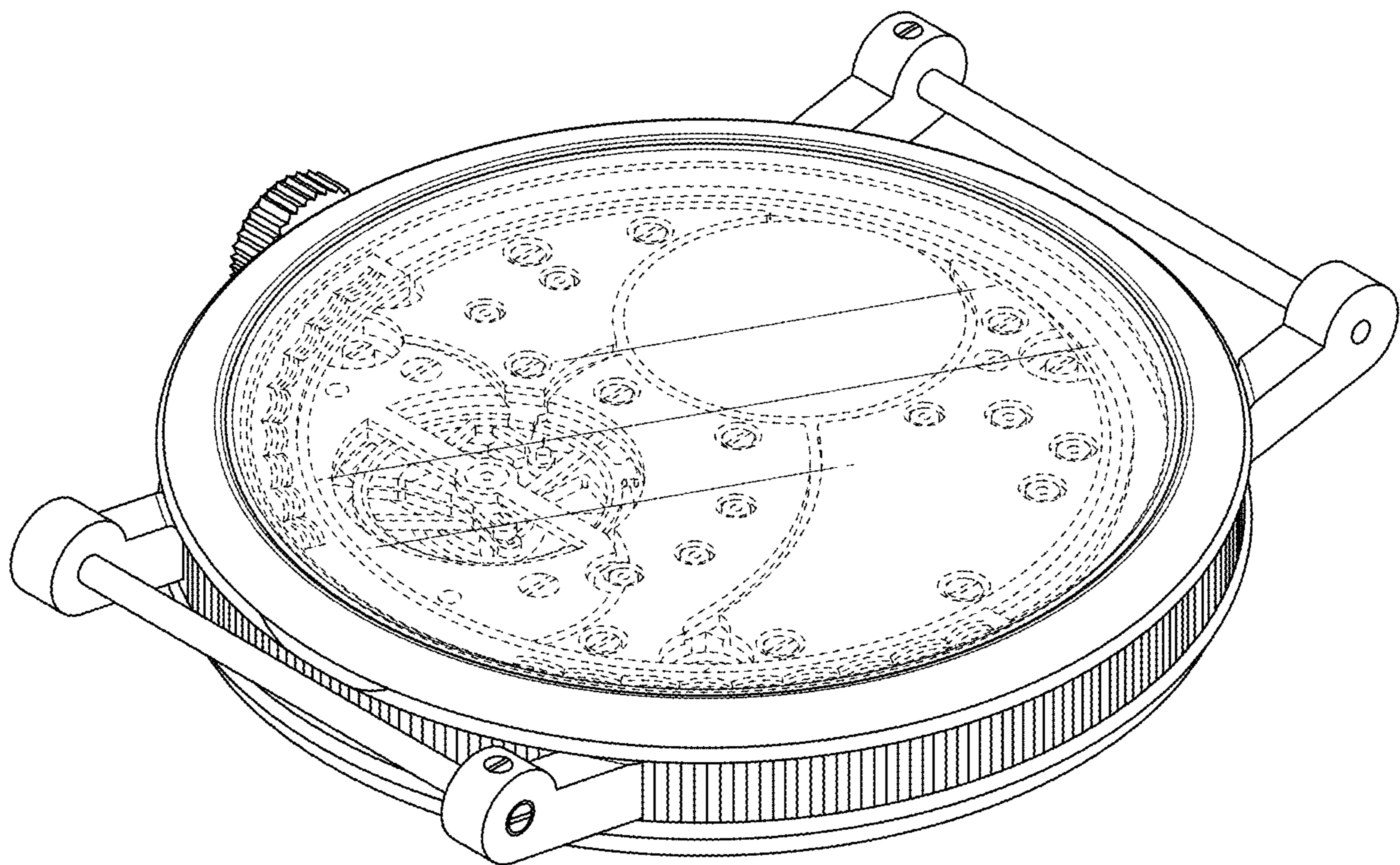
