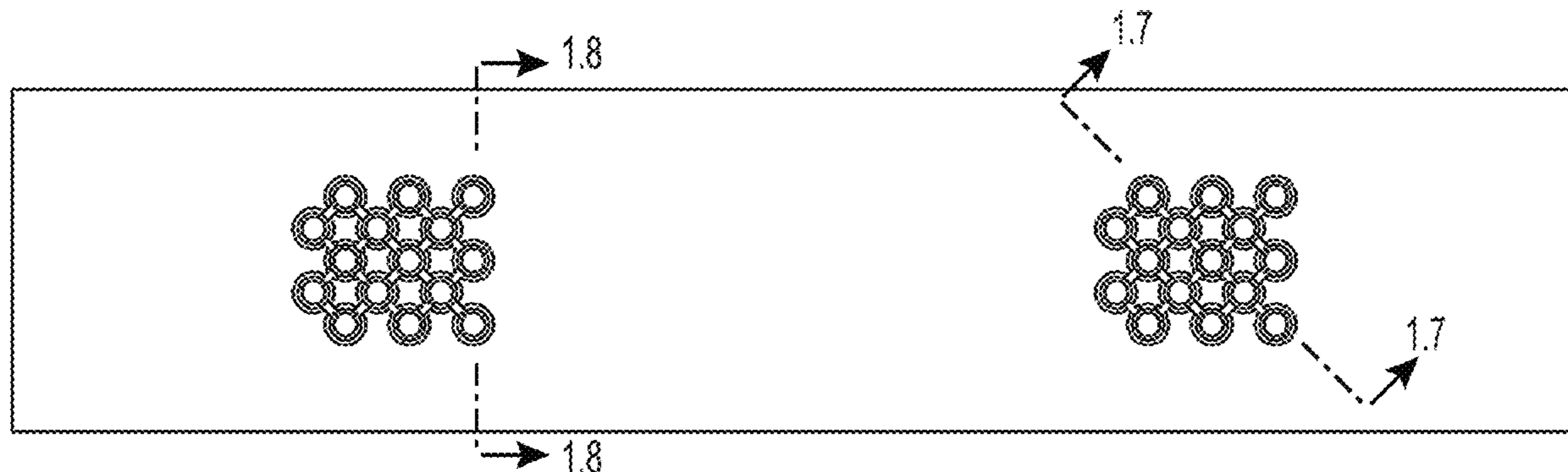
(57) **CLAIM**

The ornamental design for a fastener-mounted tape for clothing, as shown and described.

DESCRIPTION

1. Fastener-mounted tape for clothing
1.1: Top
1.2: Bottom
1.3: Front
1.4: Back
1.5: Right
1.6: Left
1.7: Cross-sectional view taken at an angle of 45 degrees to the tape along line 1.7-1.7 of Fig. 1
1.8: Cross-sectional view taken at an angle of 90 degrees to the tape along line 1.8-1.8 of Fig. 1
1.9: Reference view showing state in use
1.10: Reference view showing state in use
1.11: Enlarged partial perspective view taken from bottom showing a partial portion of the fastener tape
1.12: Enlarged partial perspective view taken from top showing a partial portion of the fastener tape

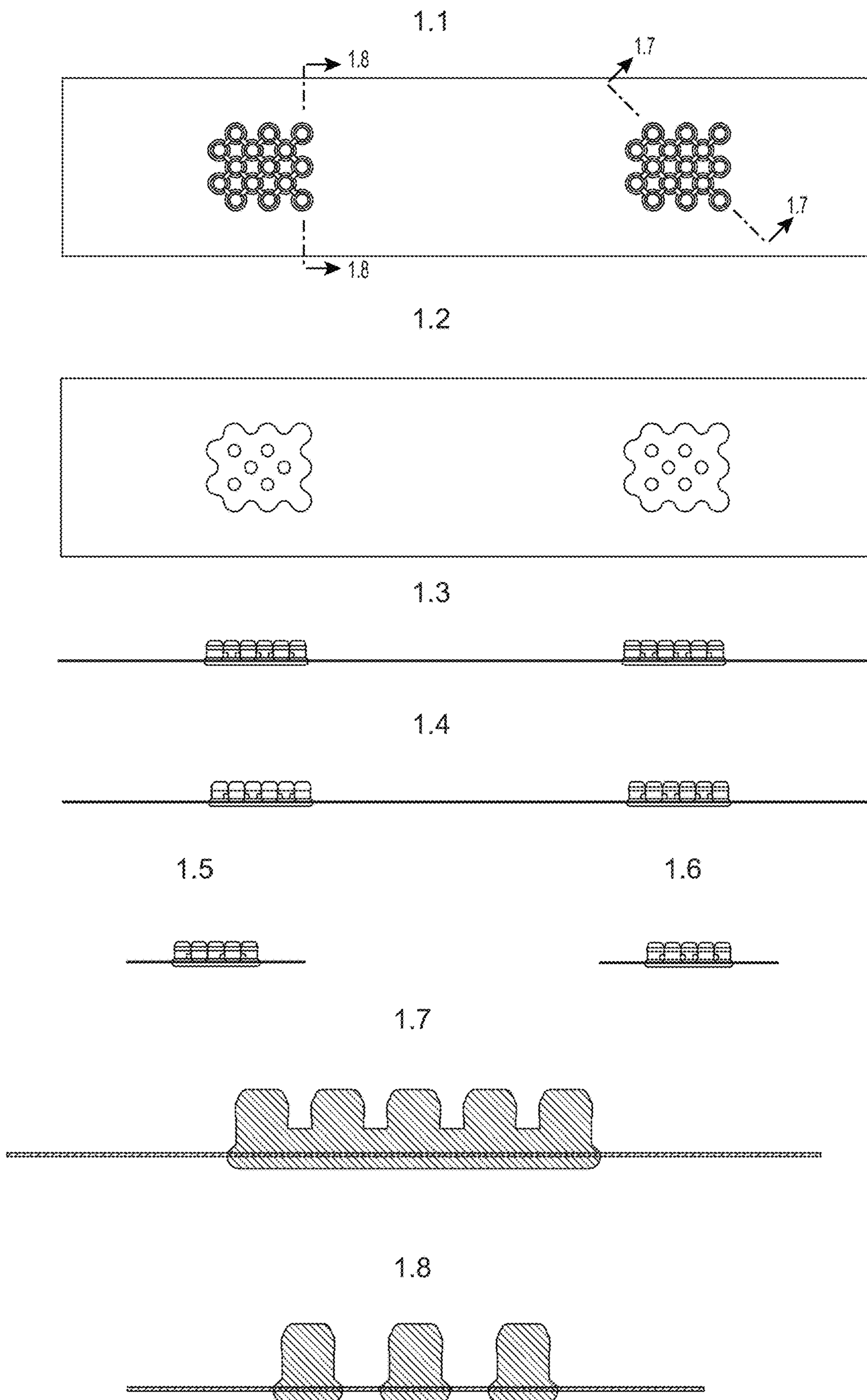

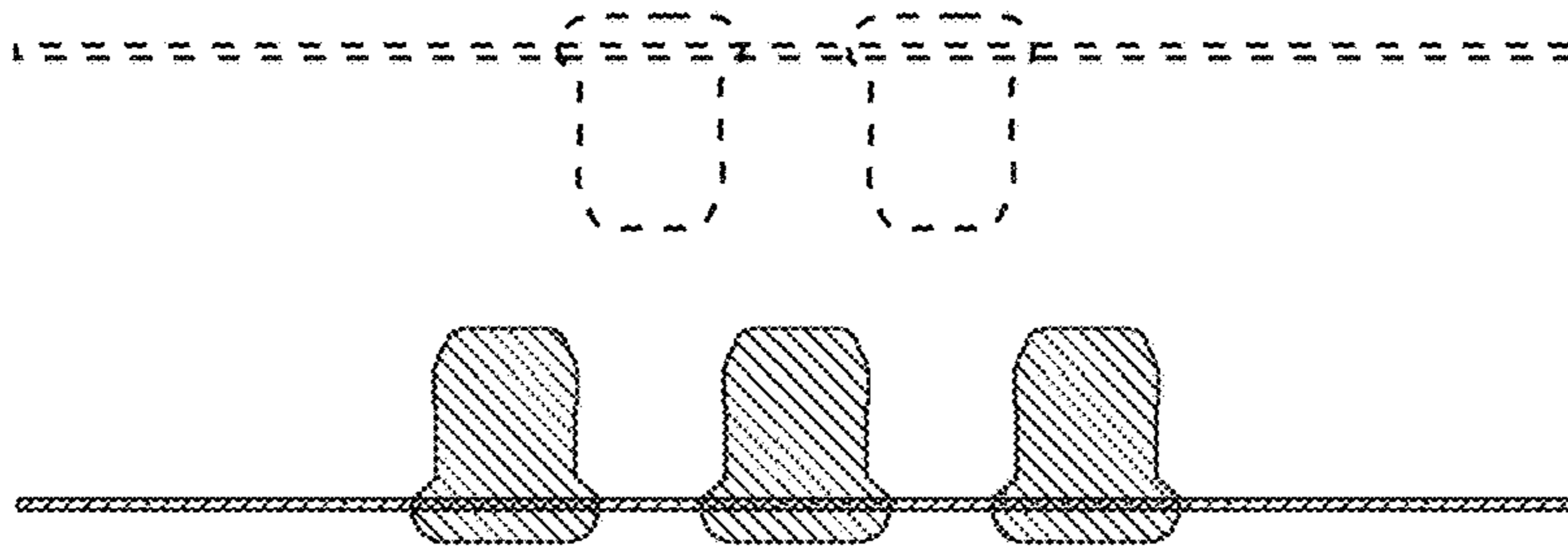

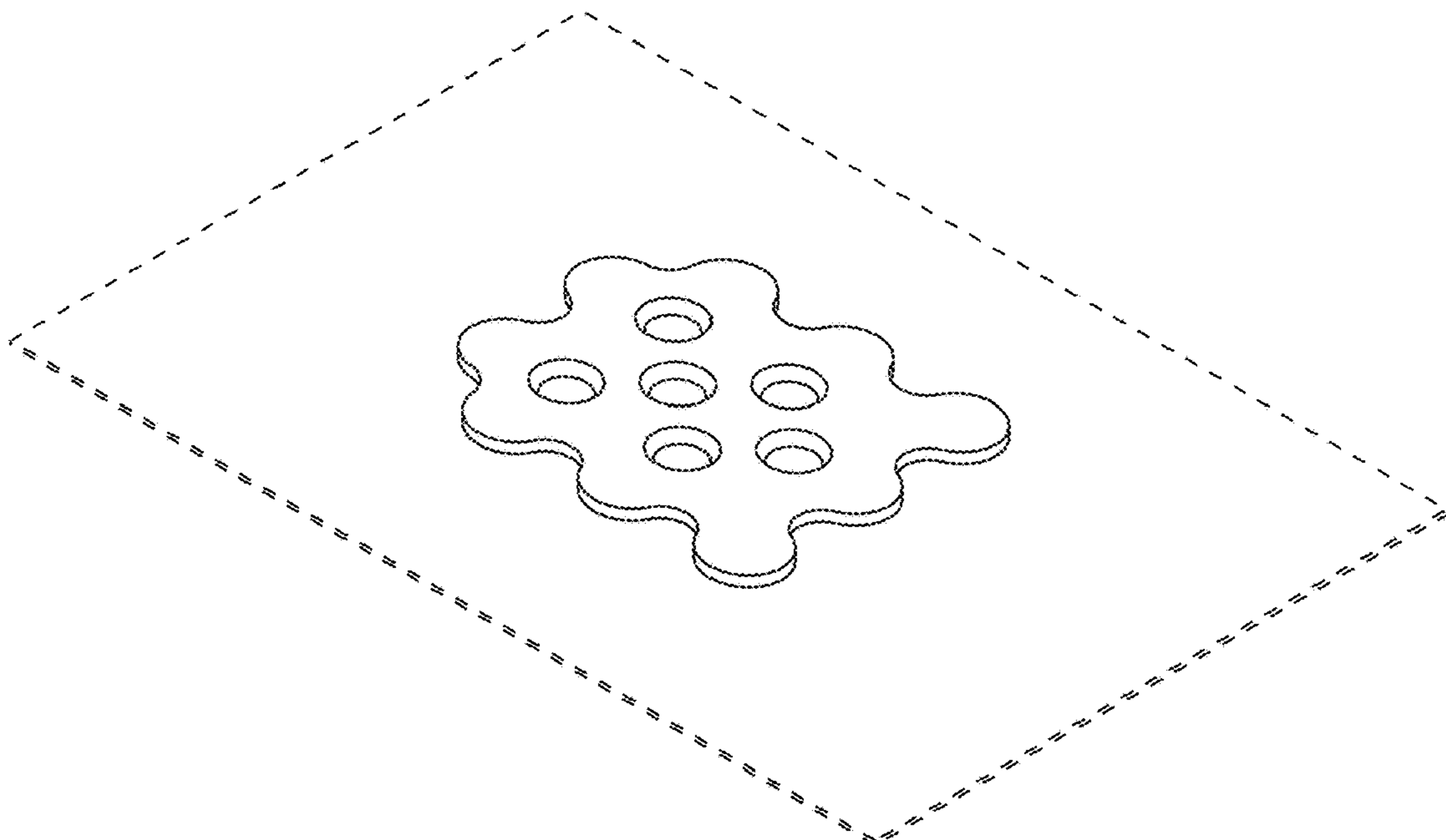
