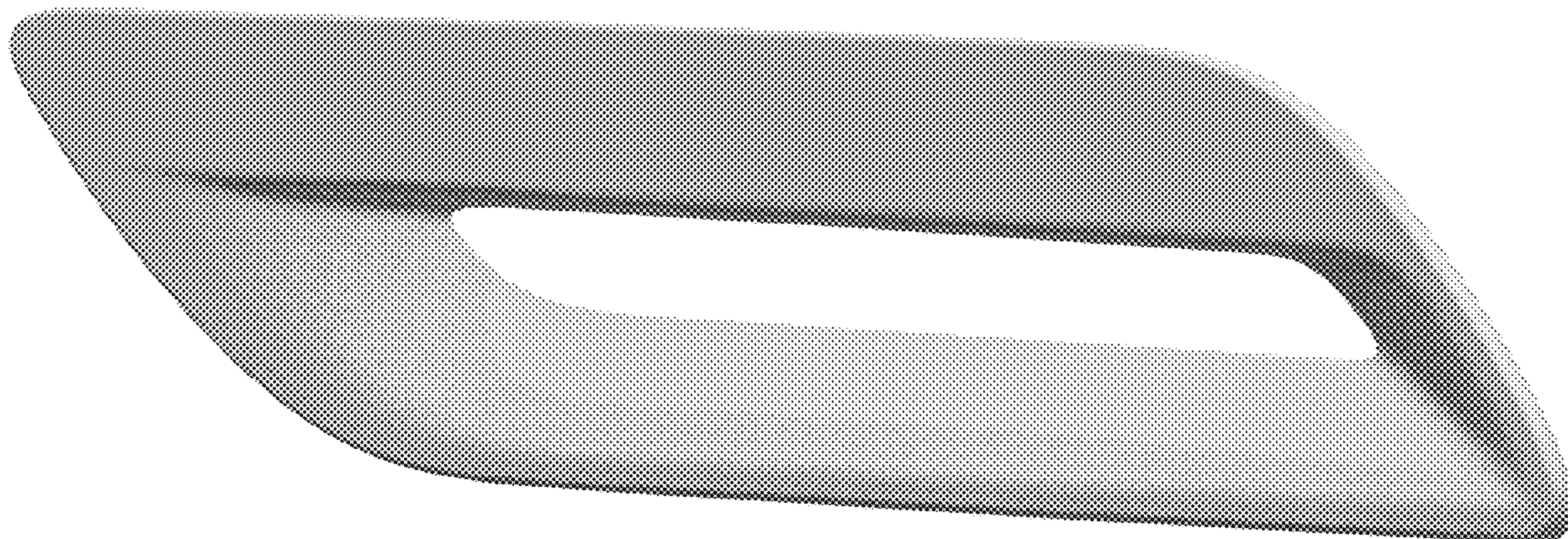
(57) **CLAIM**

The ornamental design for a fender vent, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a fender vent for a vehicle according to the present invention.
FIG. 2 is a front left perspective view of the fender vent shown in FIG. 1.
FIG. 3 is a rear left perspective view thereof.
FIG. 4 is a rear right perspective view thereof.
FIG. 5 is a front view thereof.
FIG. 6 is a rear view thereof.
FIG. 7 is a right side view thereof.
FIG. 8 is a left side view thereof.
FIG. 9 is a top view thereof.
FIG. 10 is a bottom view thereof; and,
FIG. 11 is a front view of the fender vent illustrated in FIGS. 1-10, shown in a condition of use.
The broken lines and the lighter tonal quality showing a vehicle in FIG. 11 illustrate environmental structure which forms no part of the claimed design.

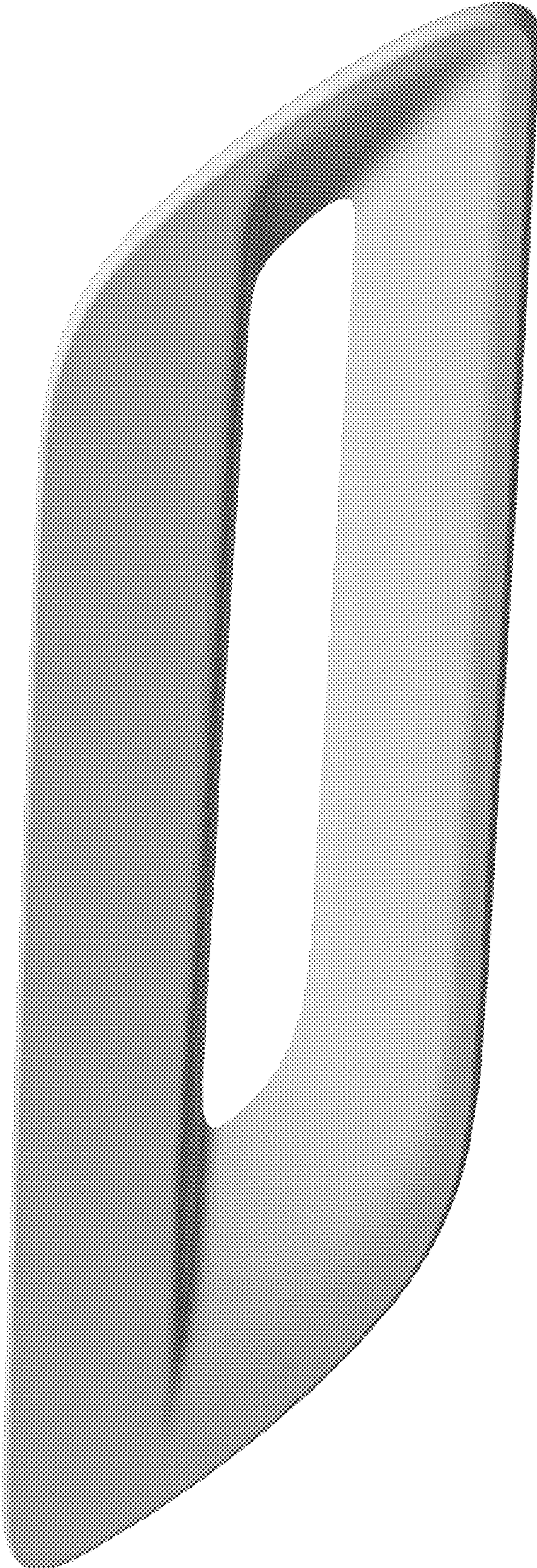

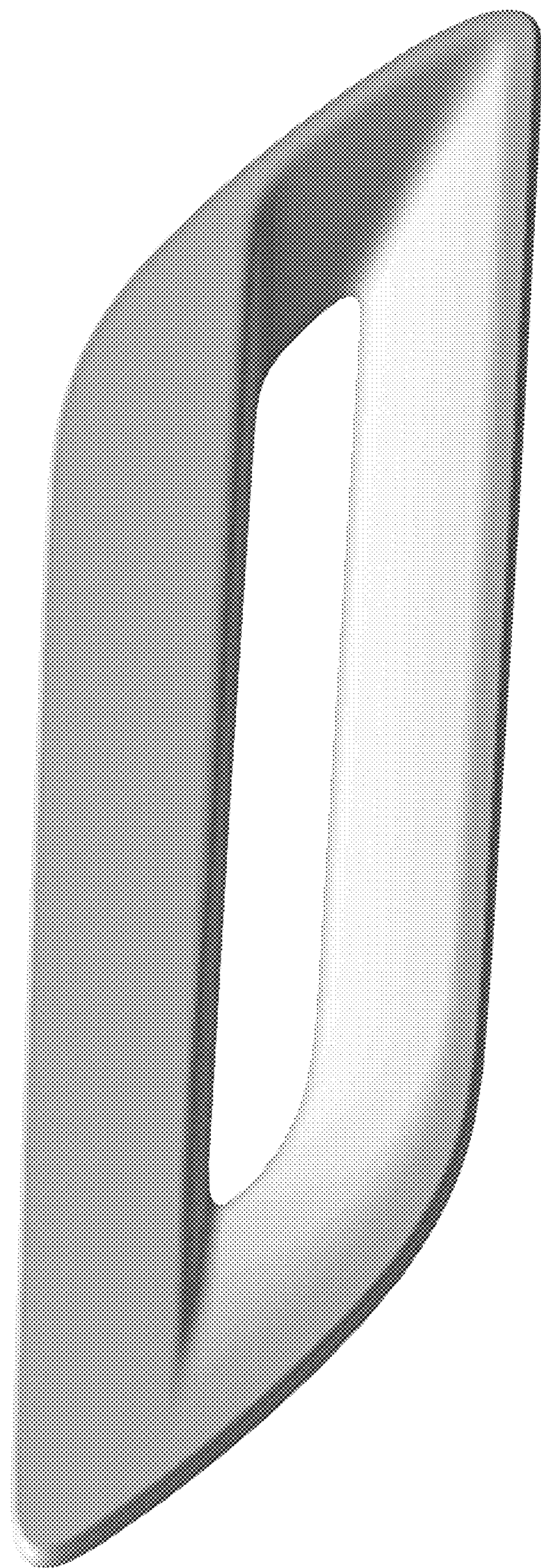

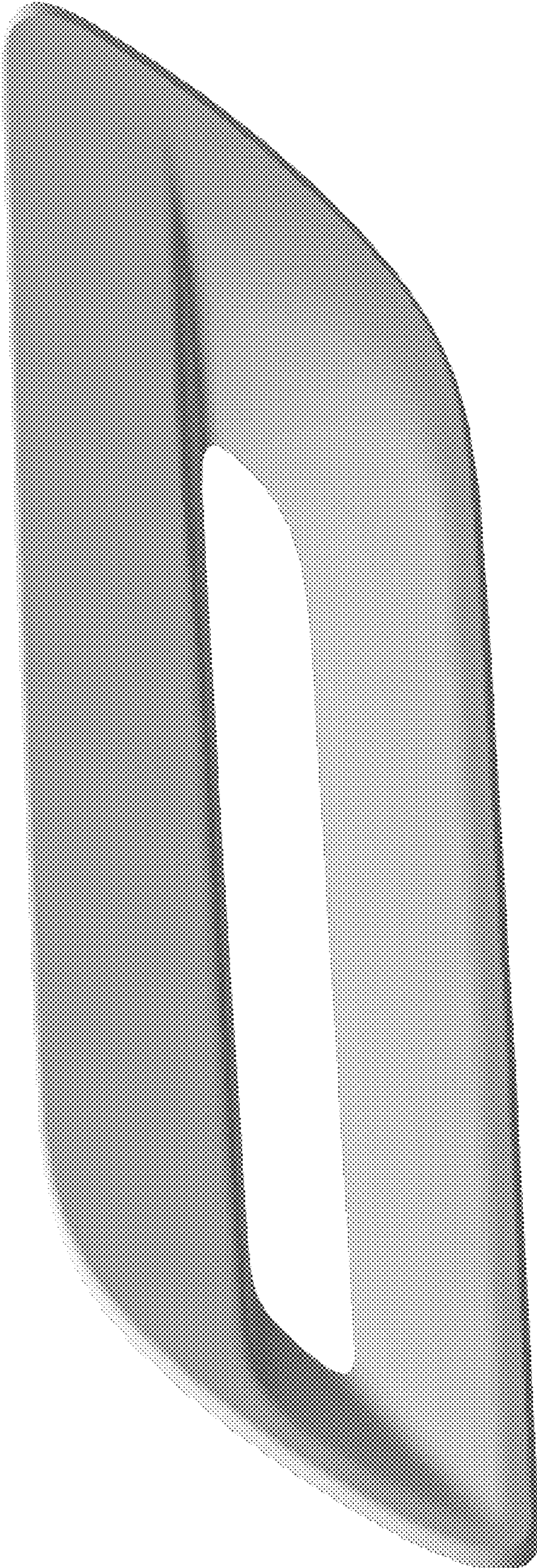

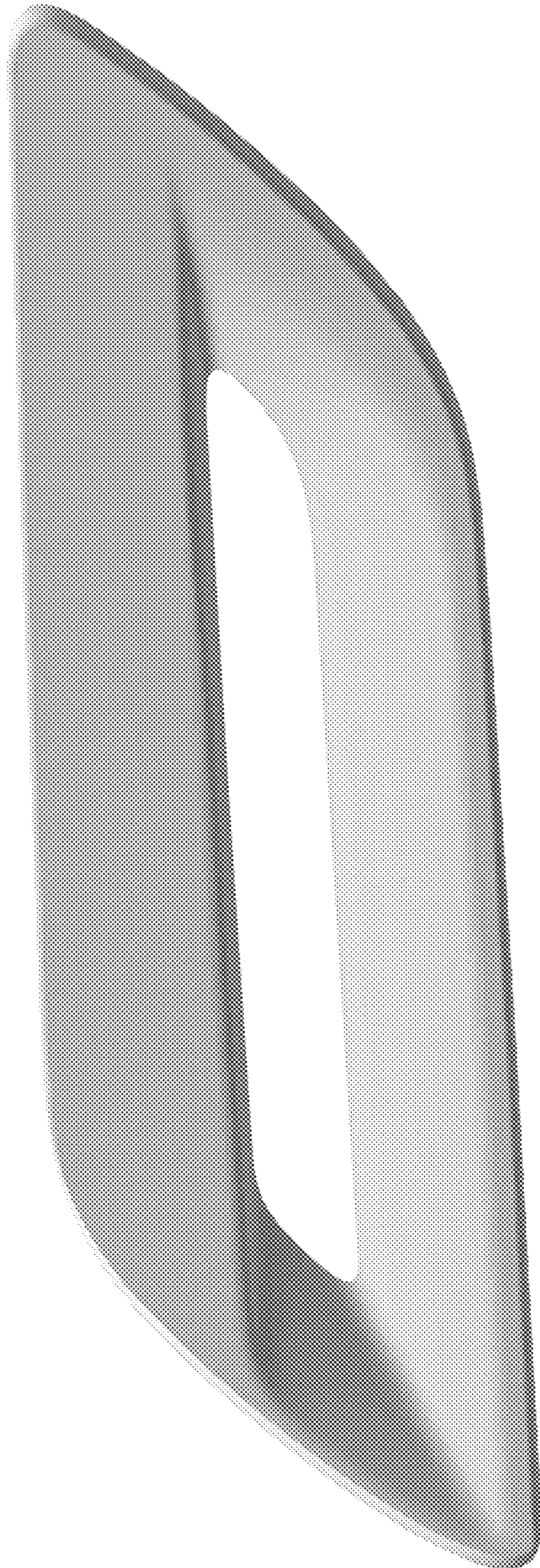

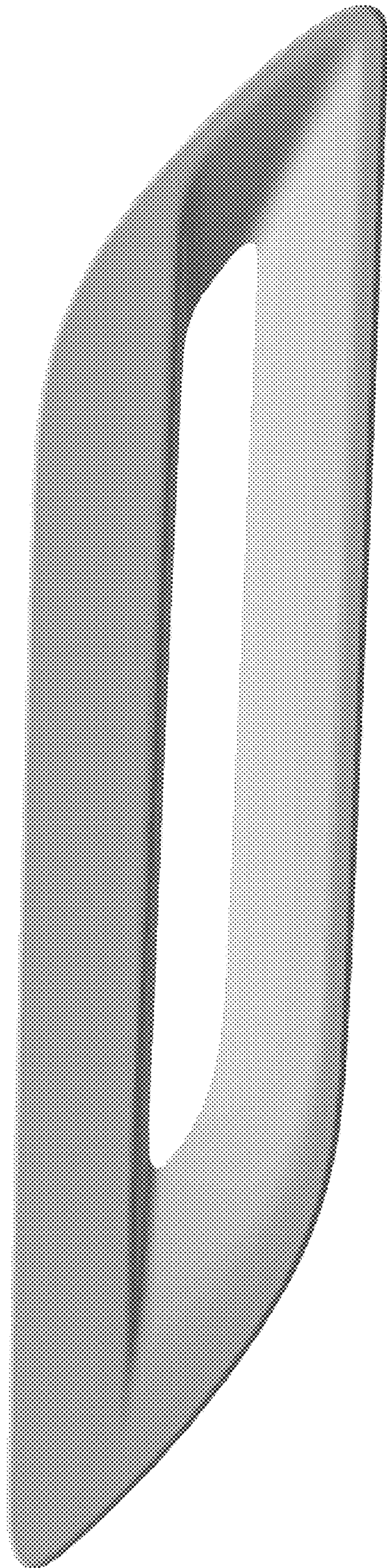

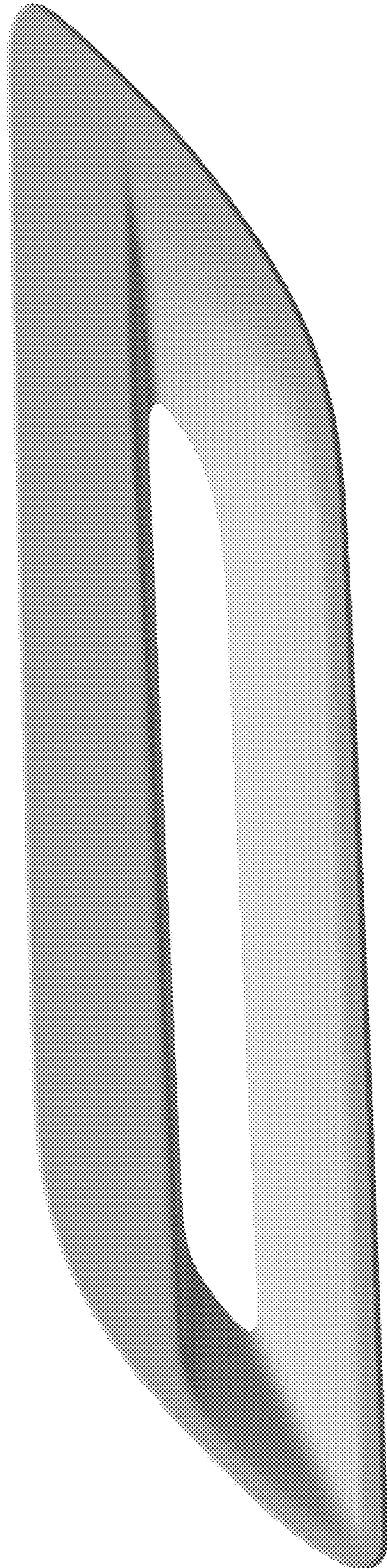

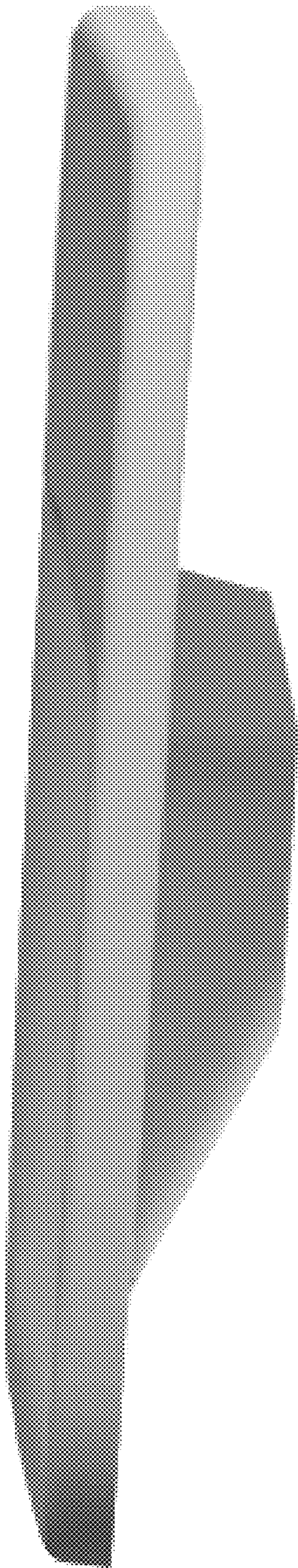

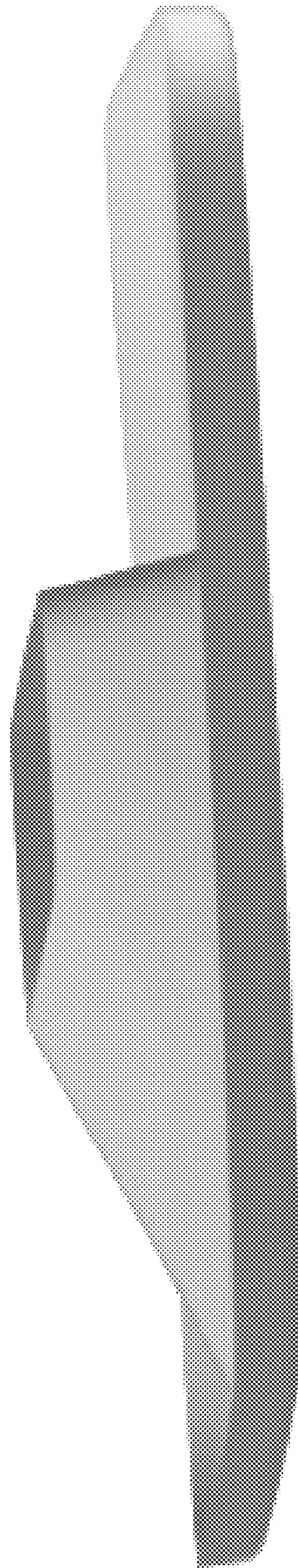

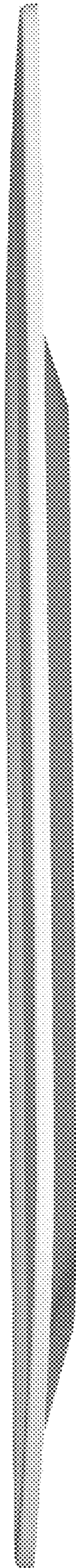

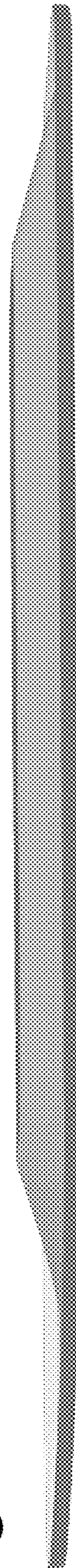

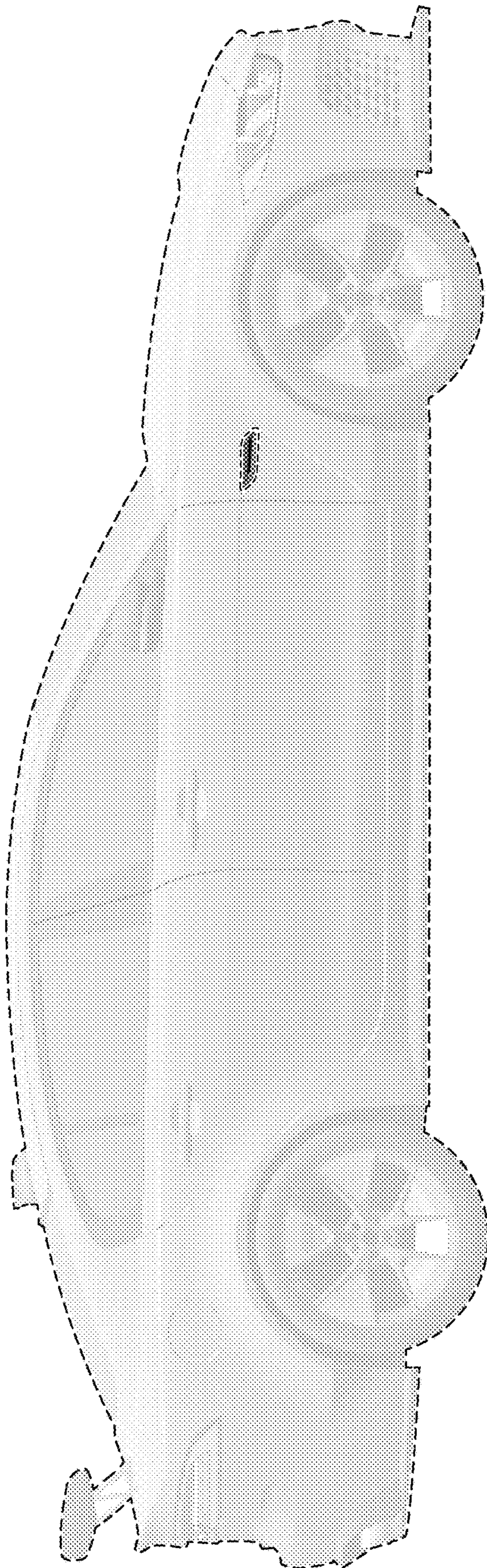
