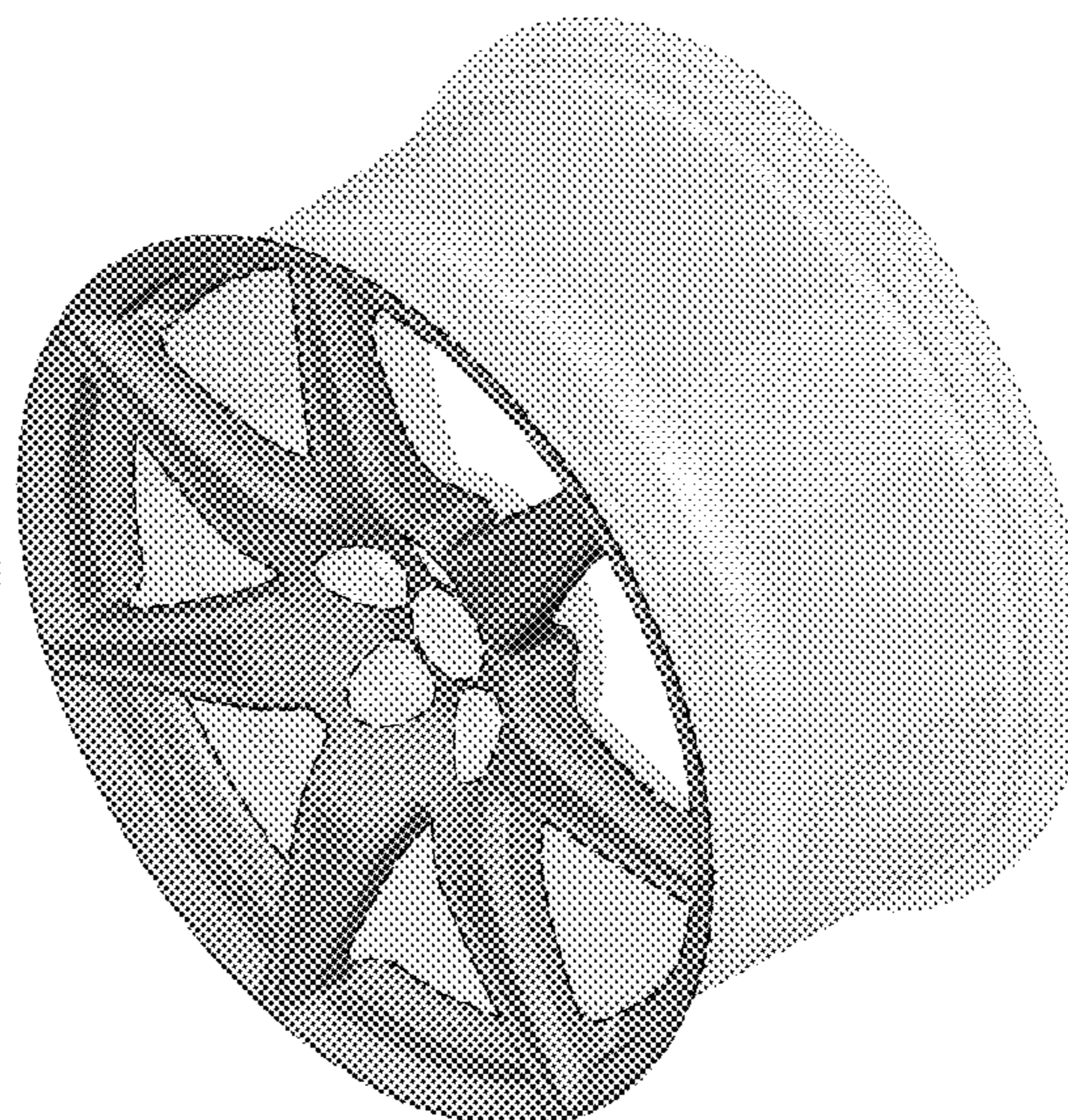
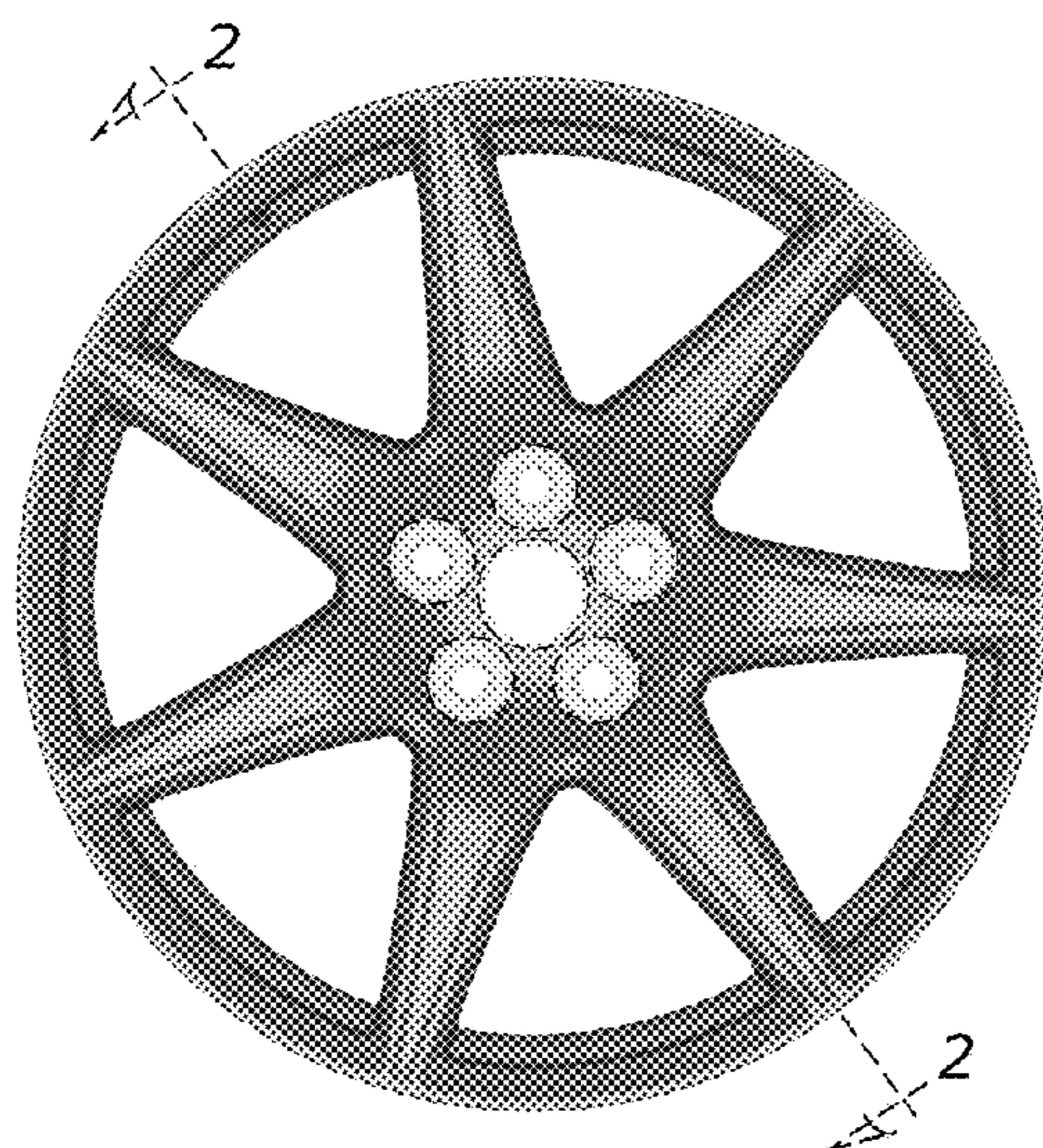
(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a vehicle wheel showing our new design;

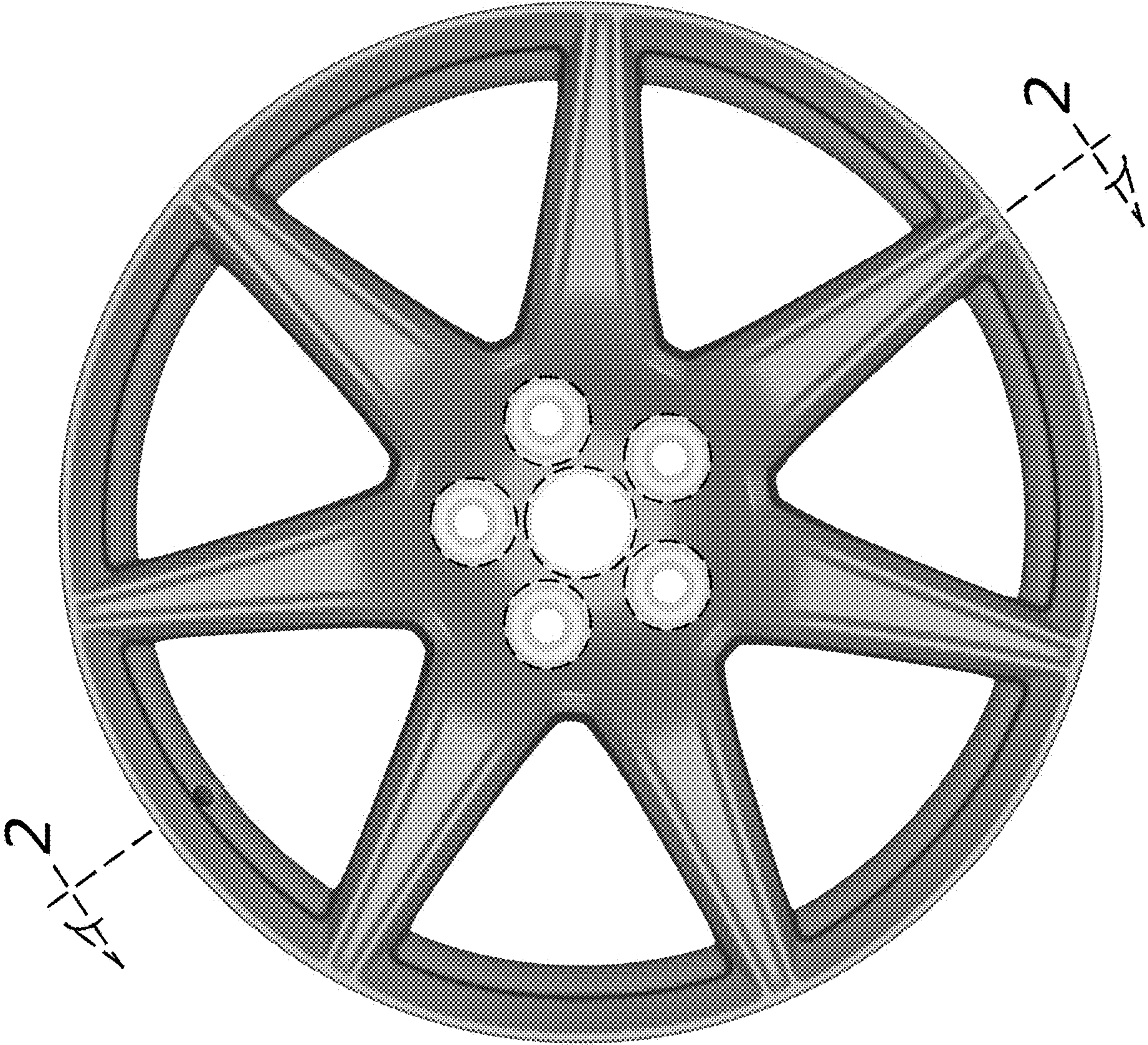

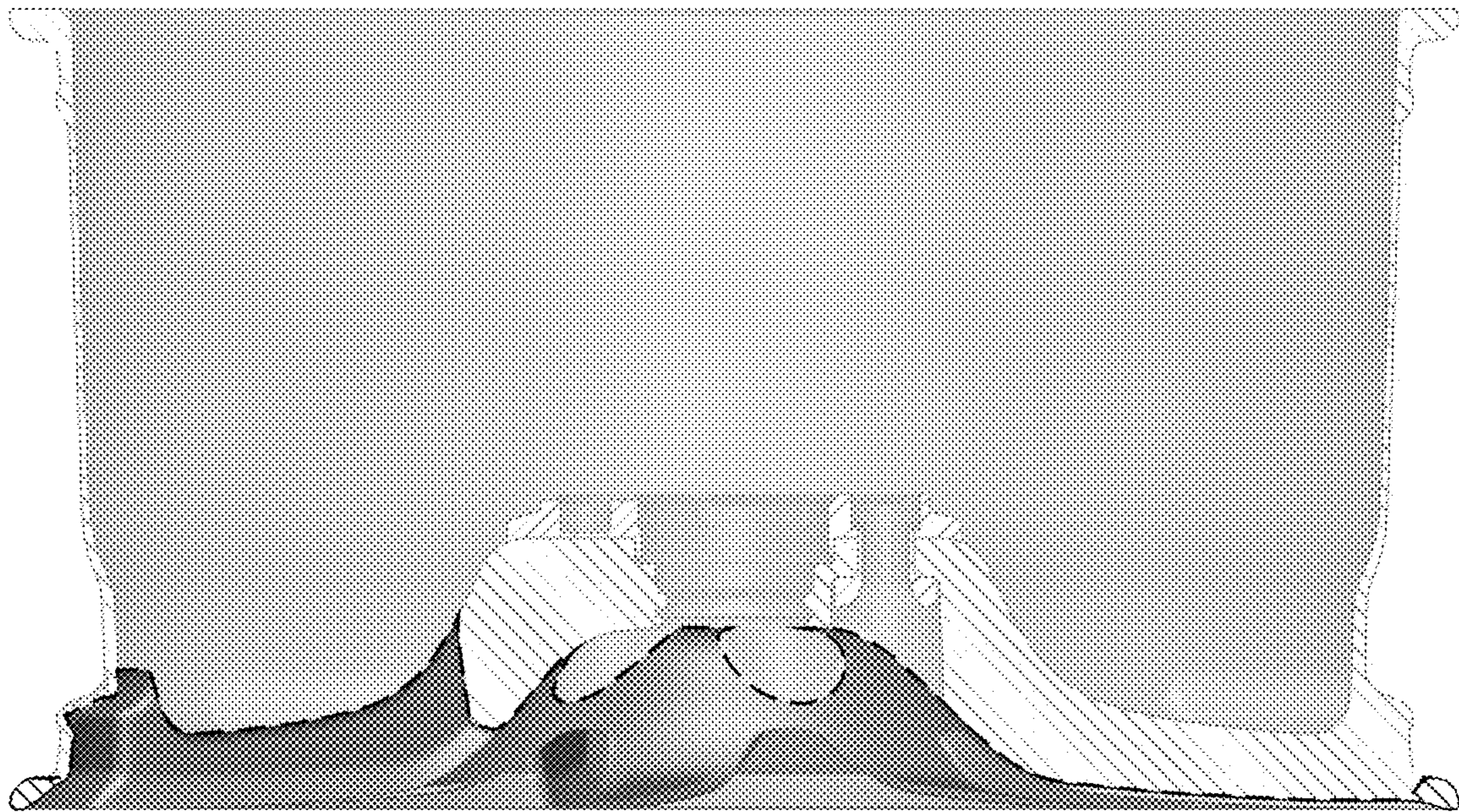

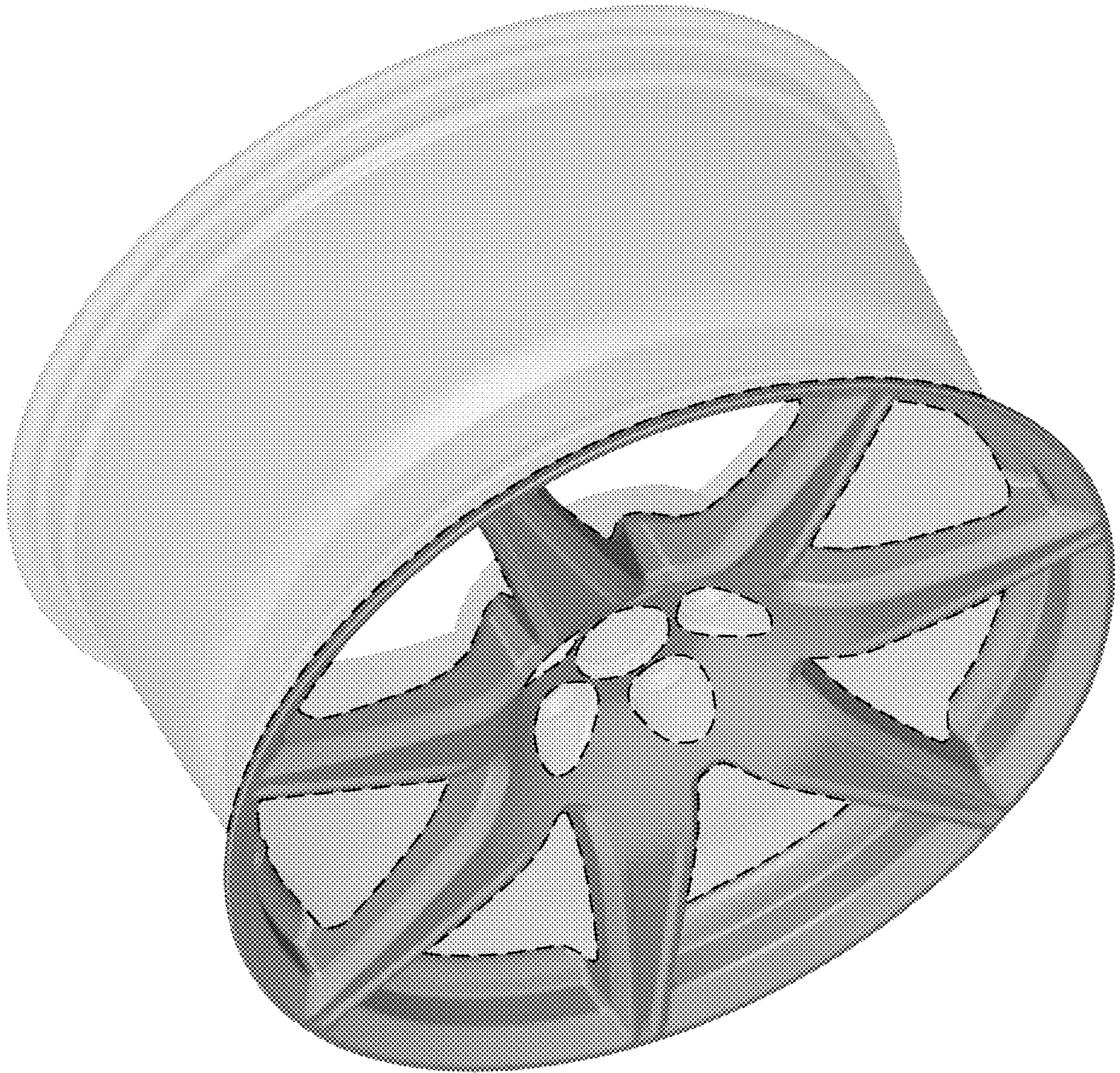
