(57) **CLAIM**

The ornamental design for a bicycle cover, as shown and described.

DESCRIPTION

FIG. 1 is a front and right-side perspective view of a mountain bike version of a bicycle cover, showing the new design;

FIG. 2 is a right-side view of the bicycle cover of FIG. 1;

FIG. 3 is a left-side view of the bicycle cover of FIG. 1;

FIG. 4 is a front and top perspective view of the bicycle cover of FIG. 1, viewed in the direction of arrows 4-4 of FIG. 3;

FIG. 5 is a rear and top perspective view of the bicycle cover of FIG. 1, viewed in the direction of arrows 5-5 of FIG. 2;

FIG. 6 is a front and right-side perspective view of a road bike version of a bicycle cover, showing the new design;

FIG. 7 is a right-side view of the bicycle cover of FIG. 6;

FIG. 8 is a left-side view of the bicycle cover of FIG. 6;

FIG. 9 is a front and top perspective view of the bicycle cover of FIG. 6, viewed in the direction of arrows 9-9 of FIG. 8;

FIG. 10 is a rear and top perspective view of the bicycle cover of FIG. 6, viewed in the direction of arrows 10-10 of FIG. 7; and,

FIG. 11 is a rear and left-side perspective view of the bicycle cover of FIG. 6.

Any portion of the bicycle cover that is not visible in FIGS. 1-11 forms no part of the claimed design.

The broken lines in FIG. 1-11 represent portions of the bicycle cover which form no part of the claimed design.

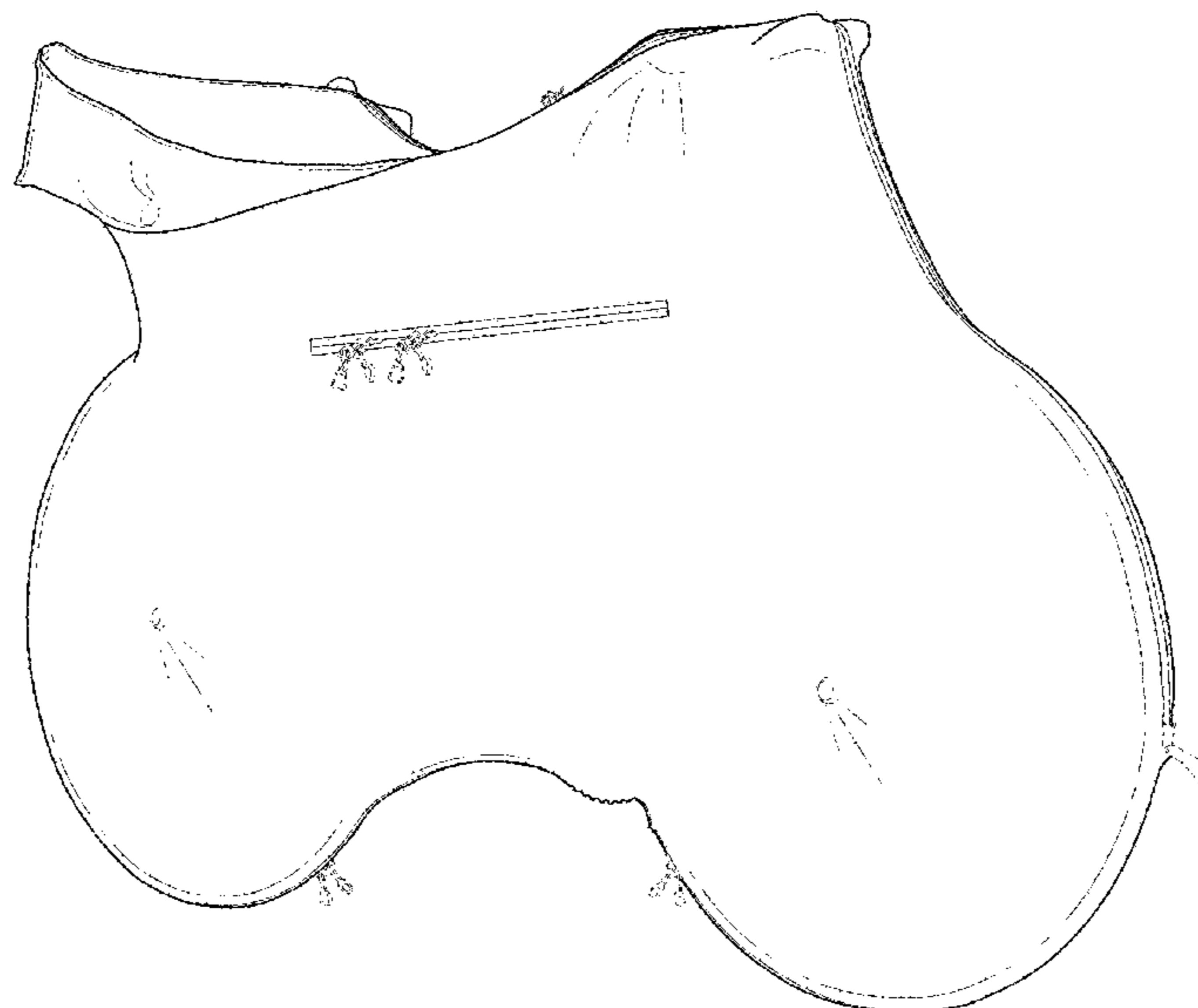

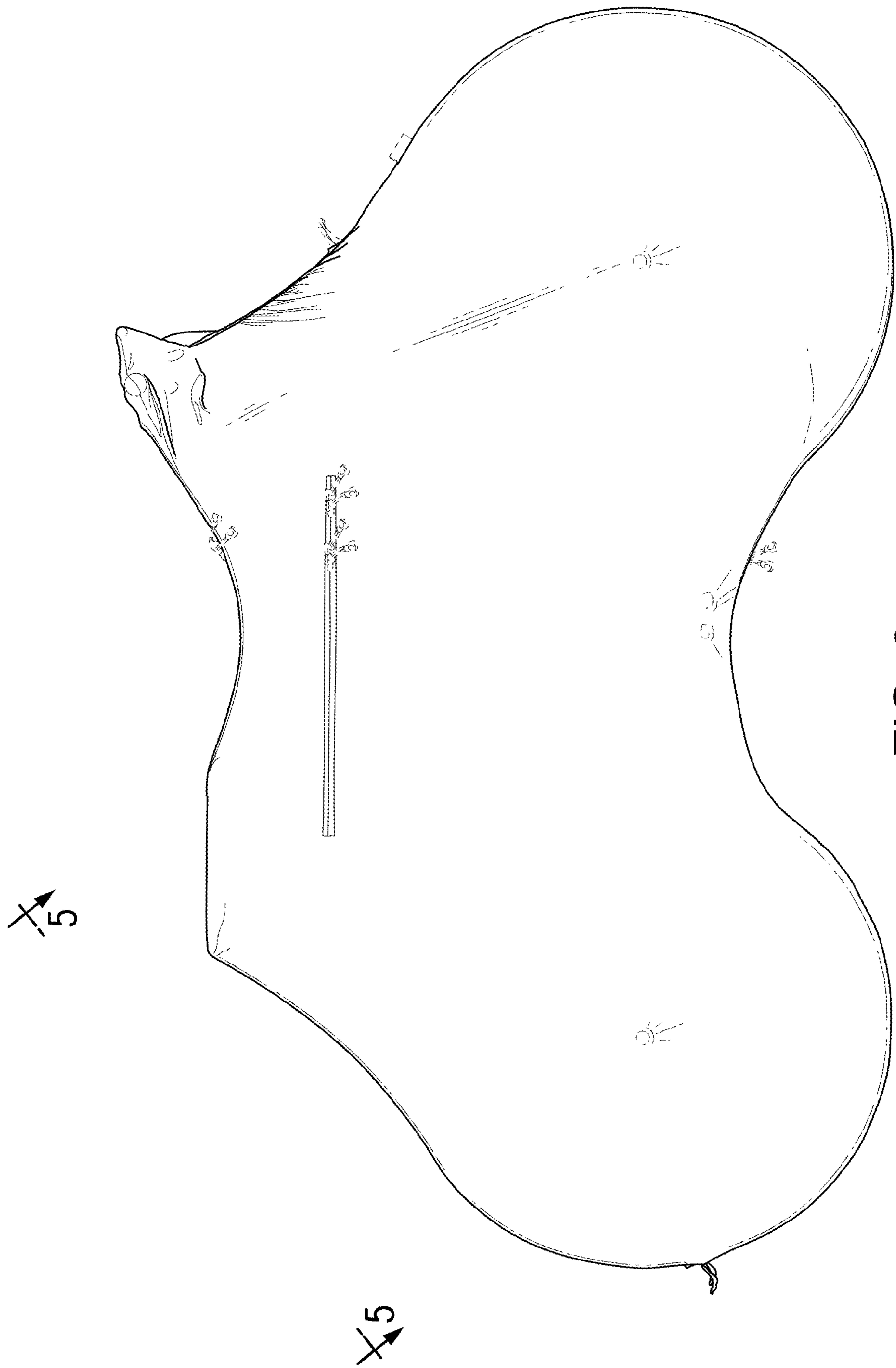
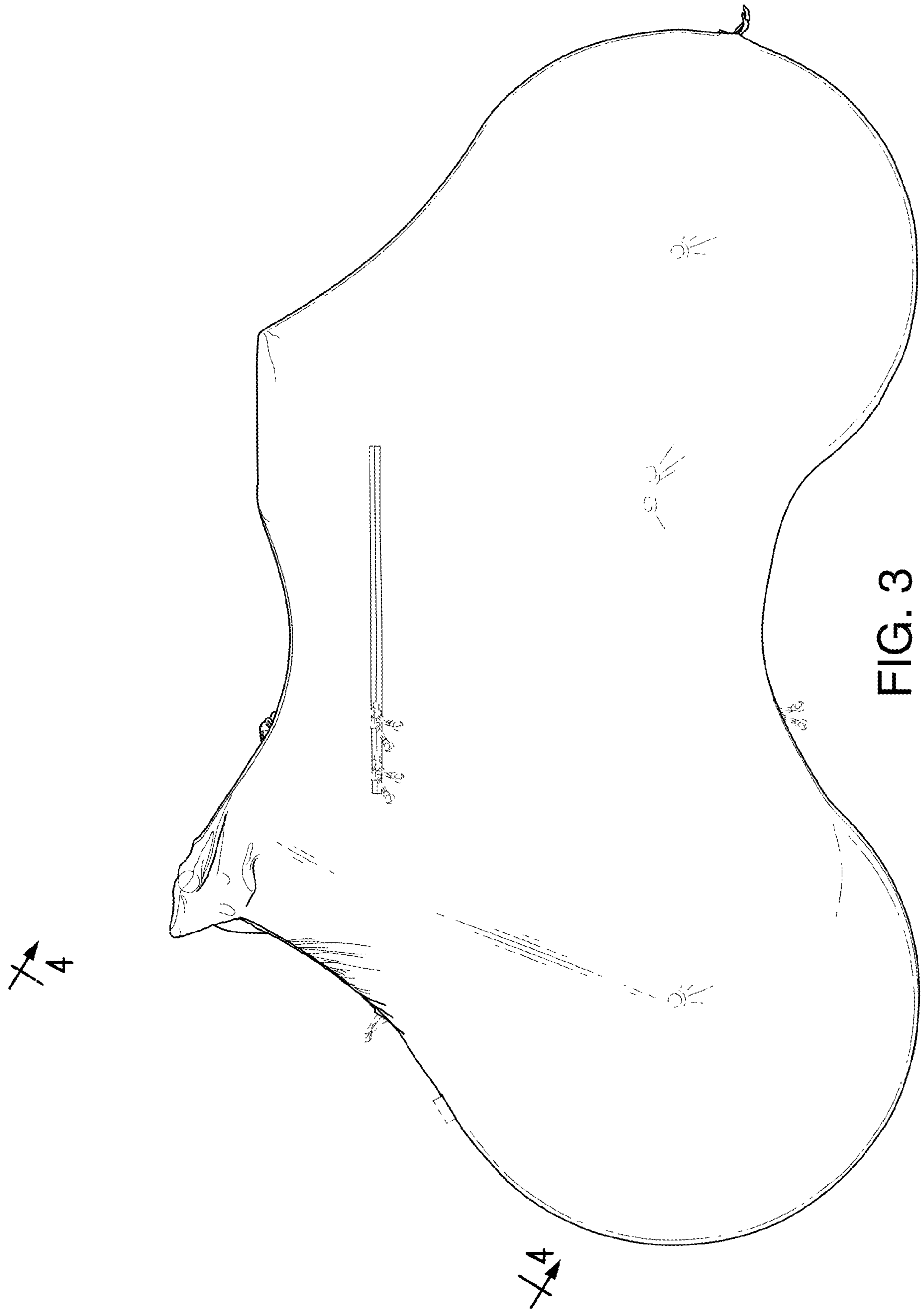

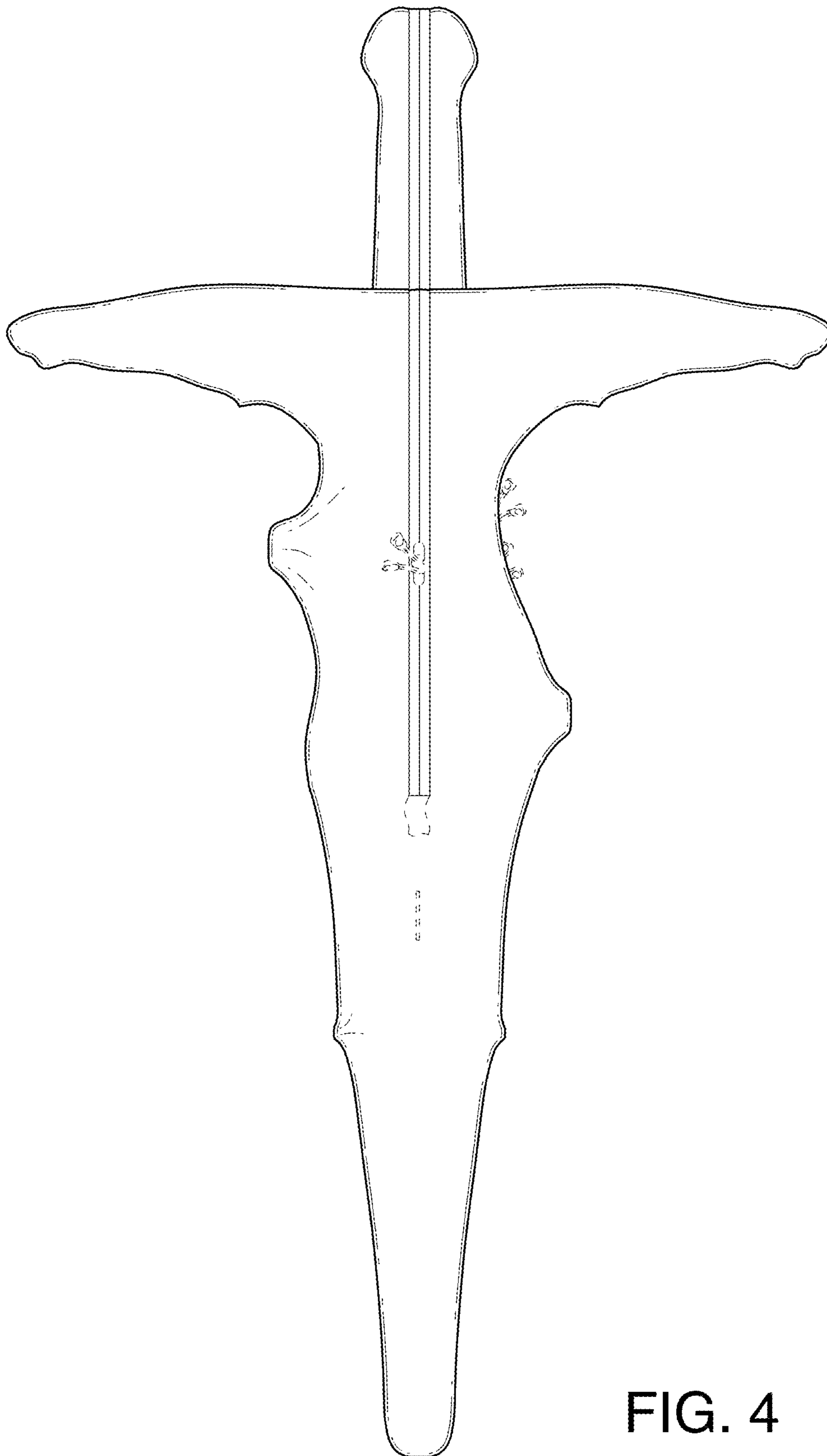

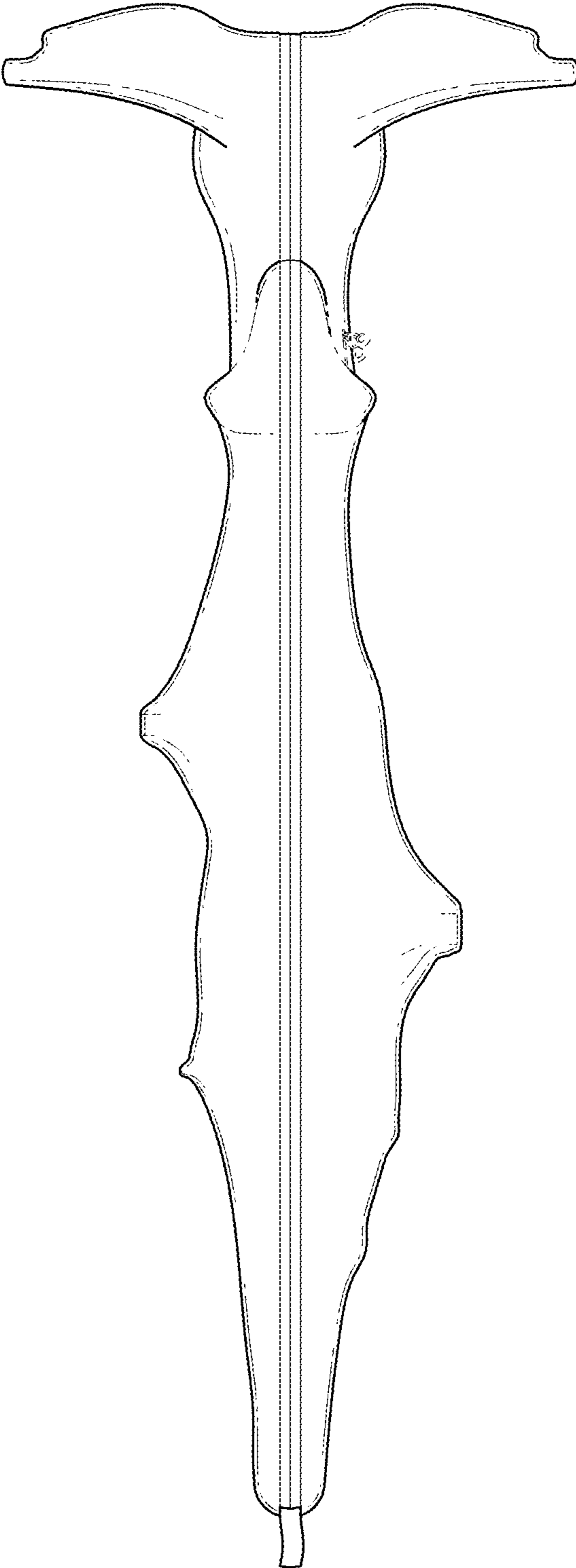

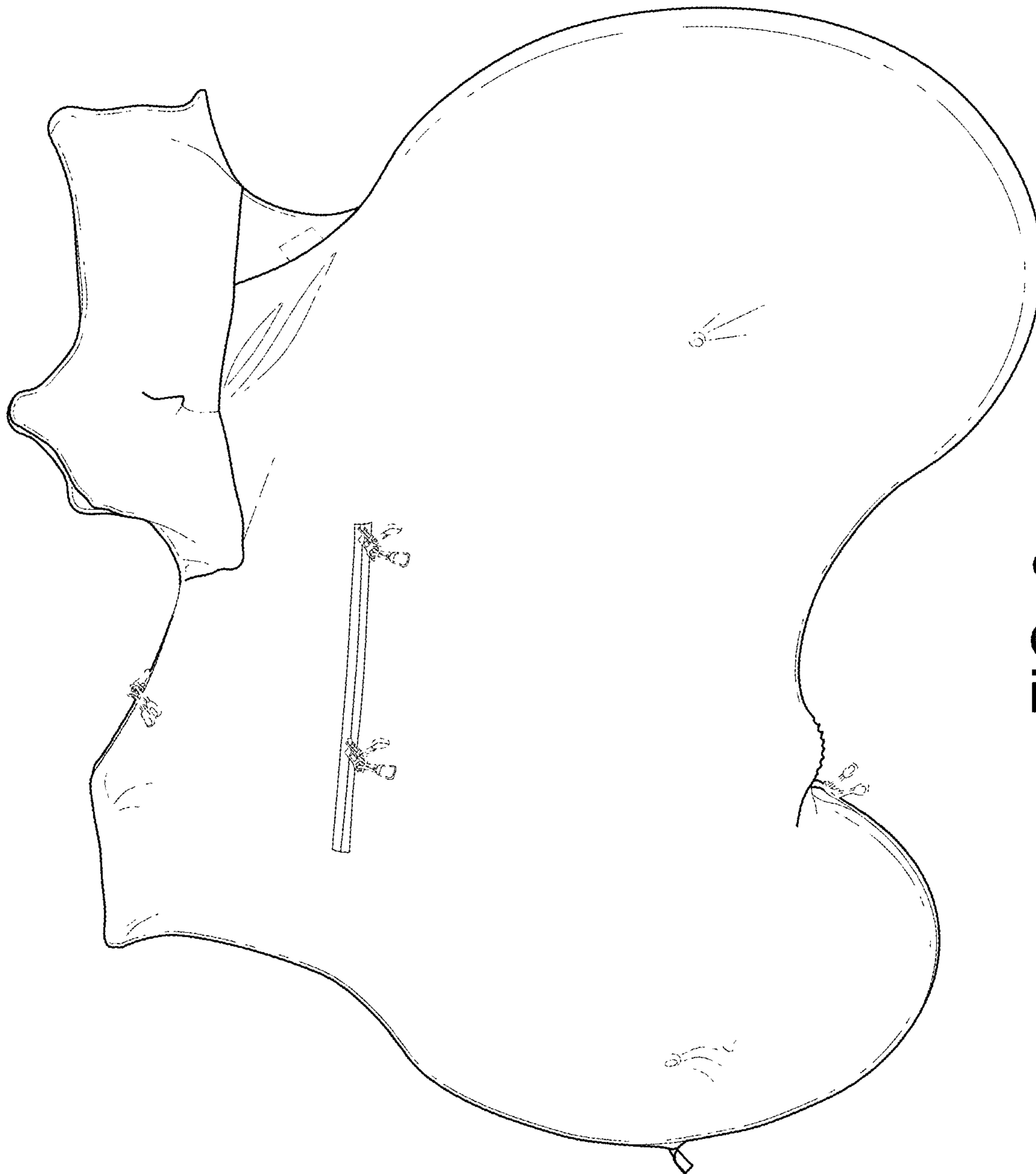

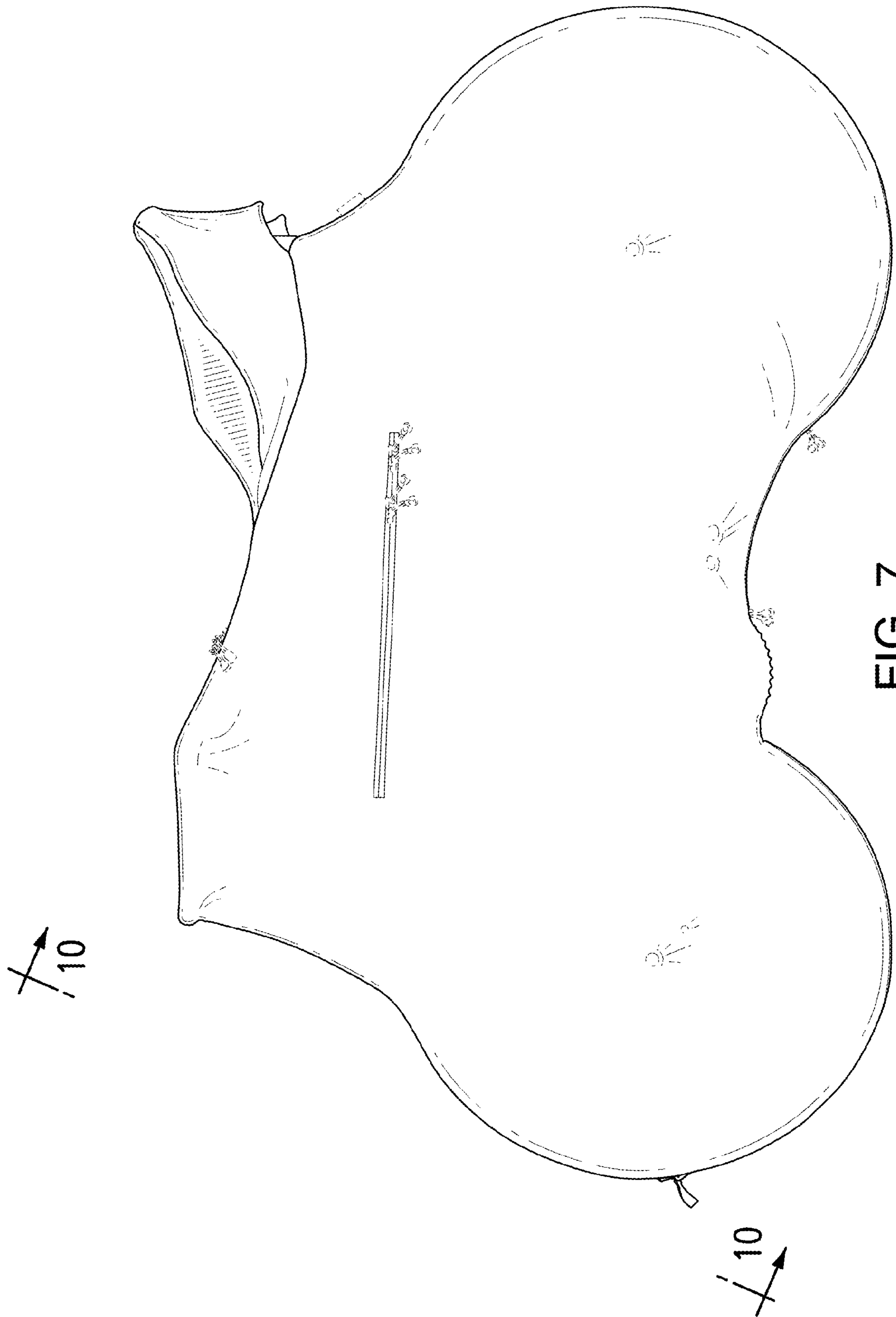

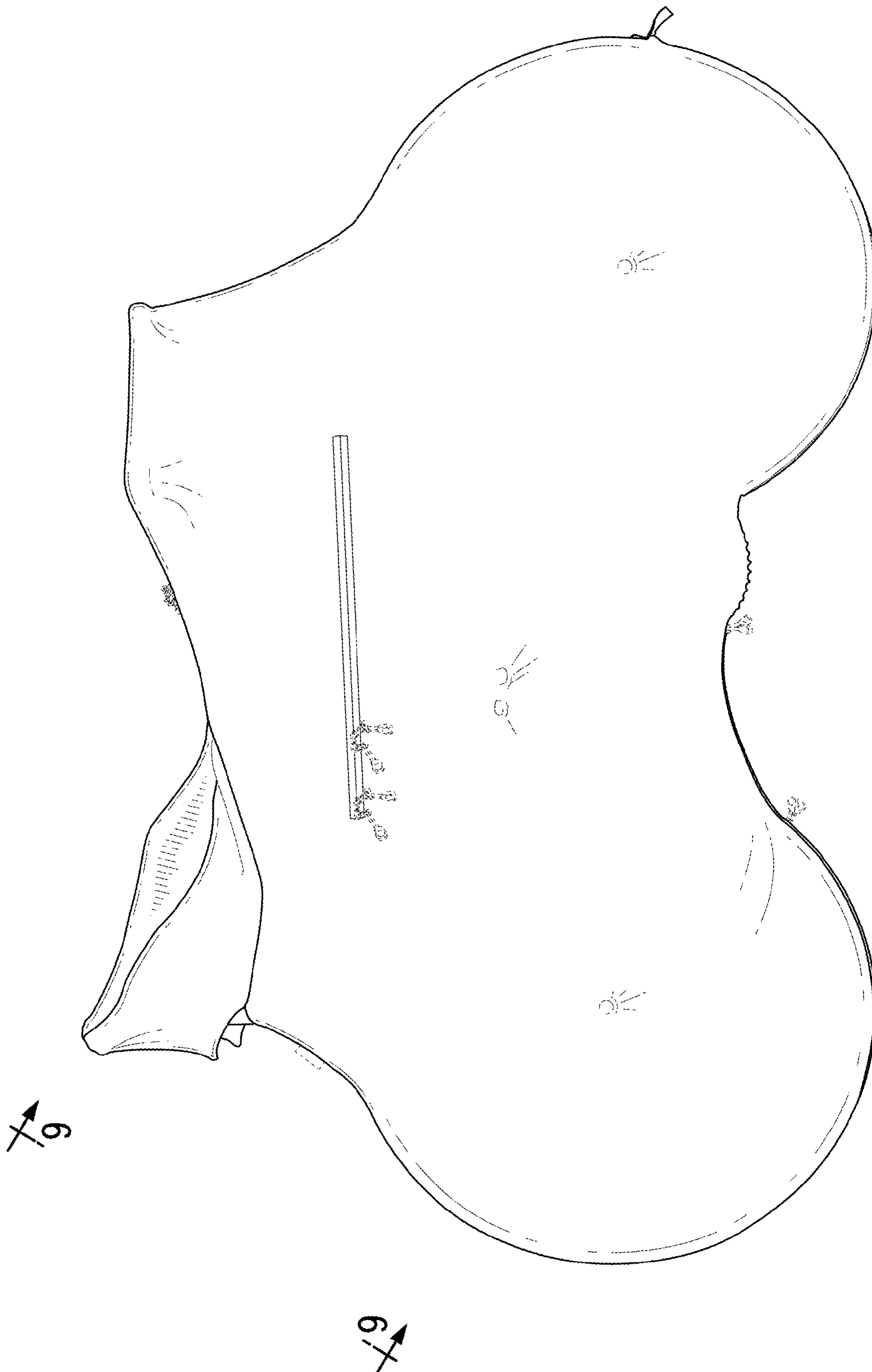

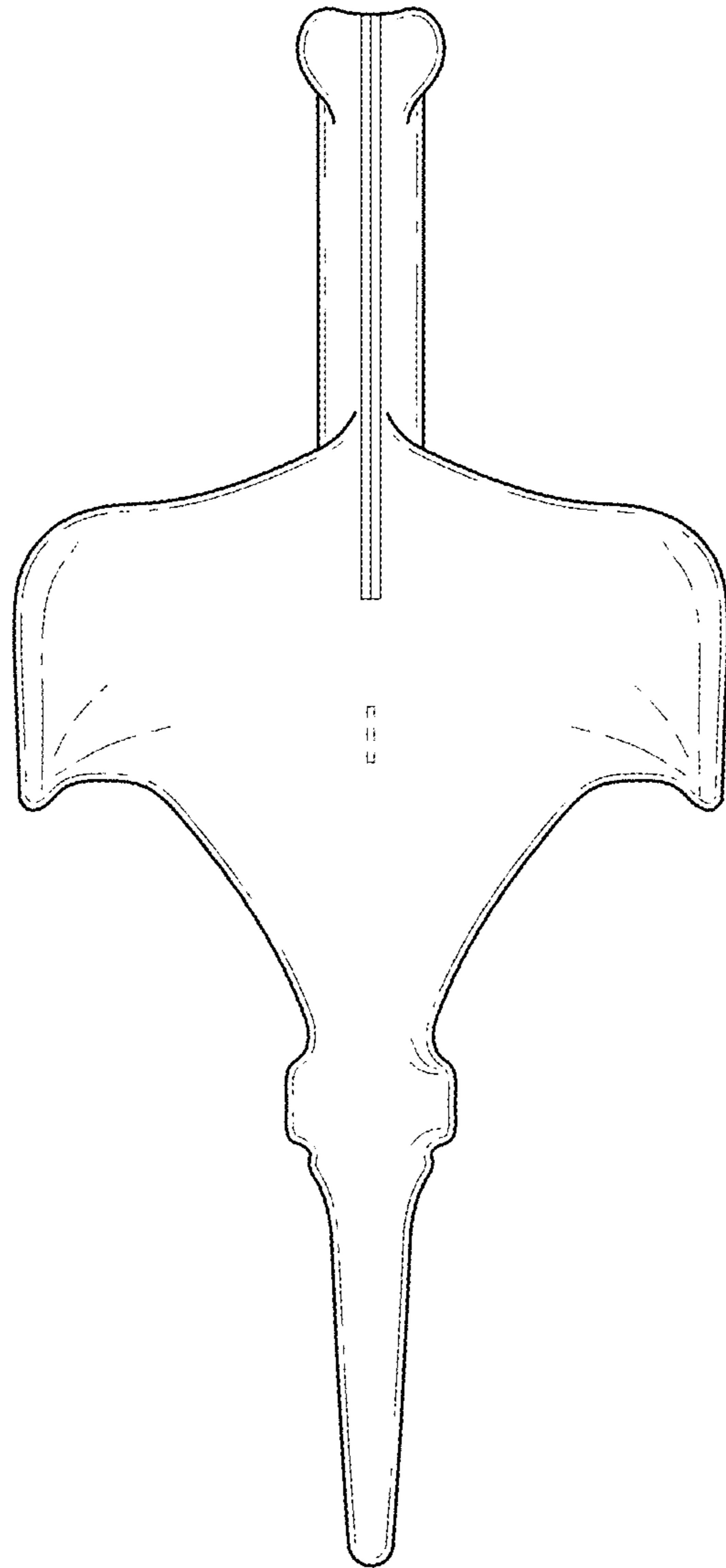

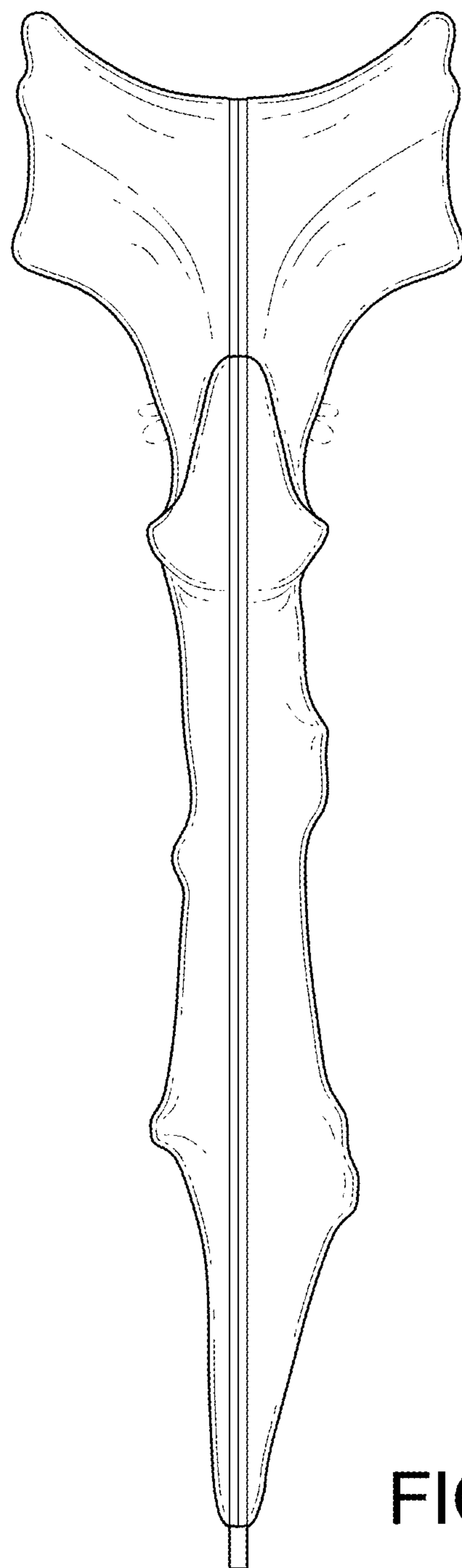
