1.2 is a top view thereof, fig. **1.3** is a bottom view thereof,

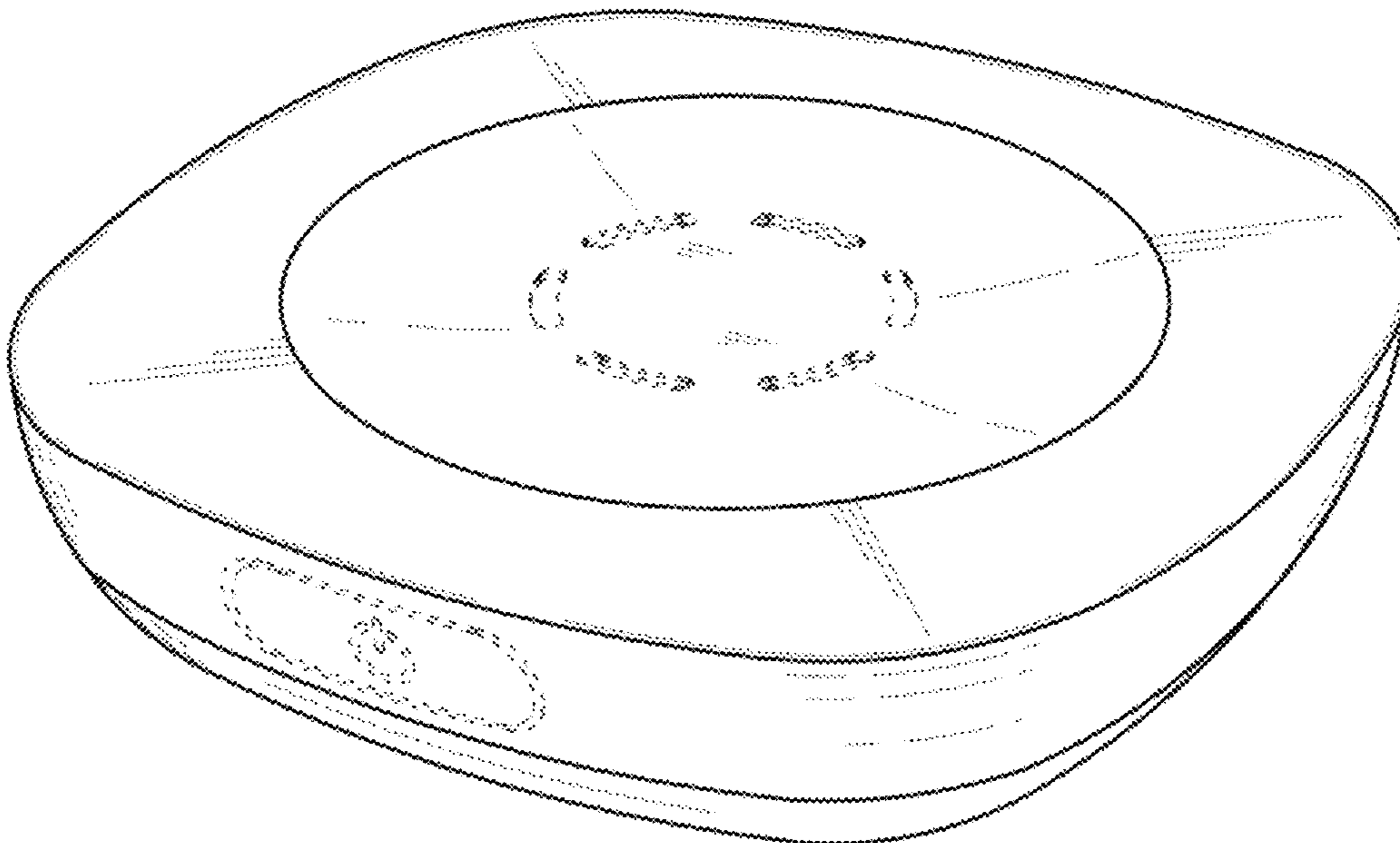
fig. **1.4** is a front view thereof, fig. **1.5** is a rear side view

thereof, fig. **1.6** is a left side view thereof, fig. **1.7** is a right

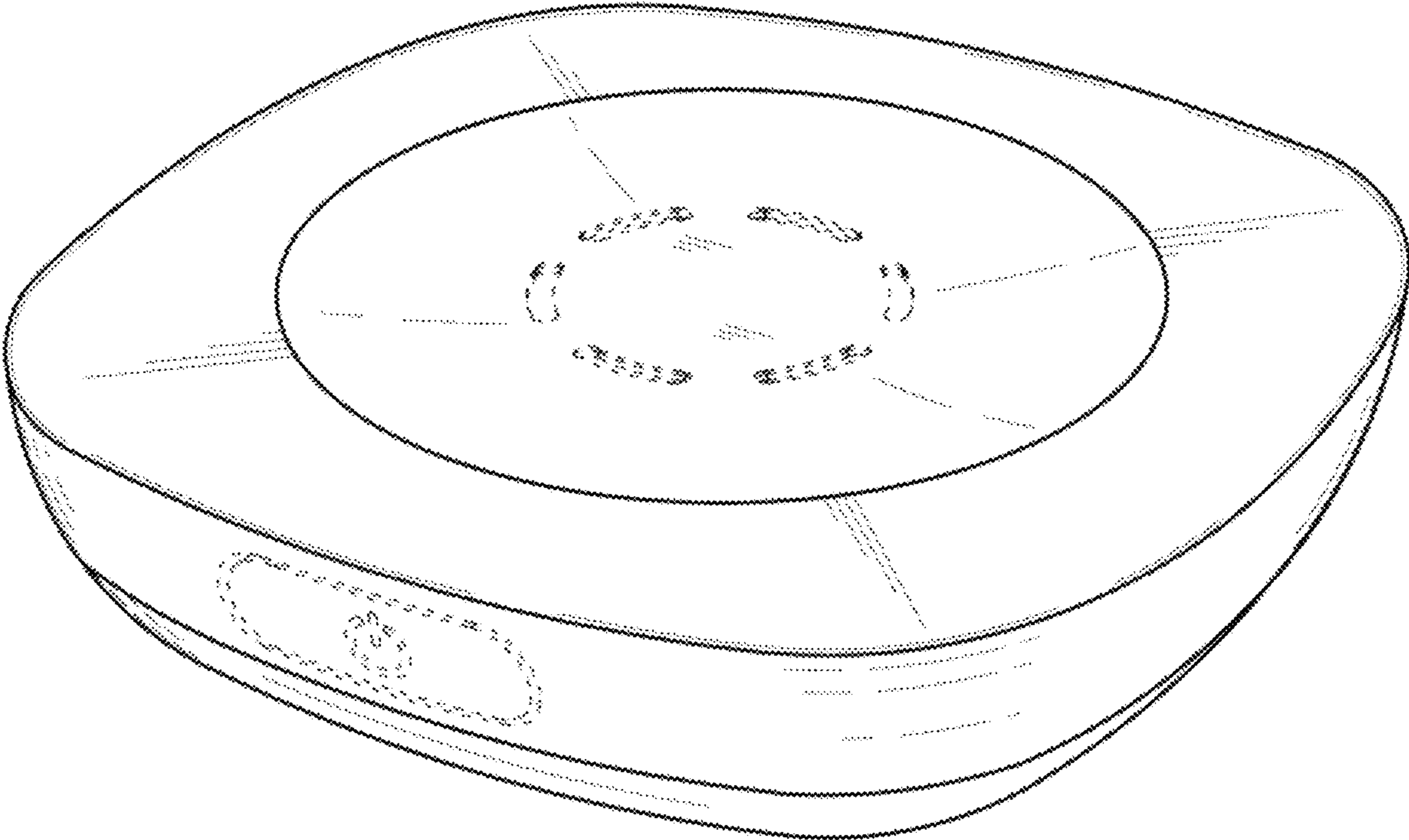
view thereof.

The broken lines shown in the figures depict portions of the table microphone that form no part of the claimed design.

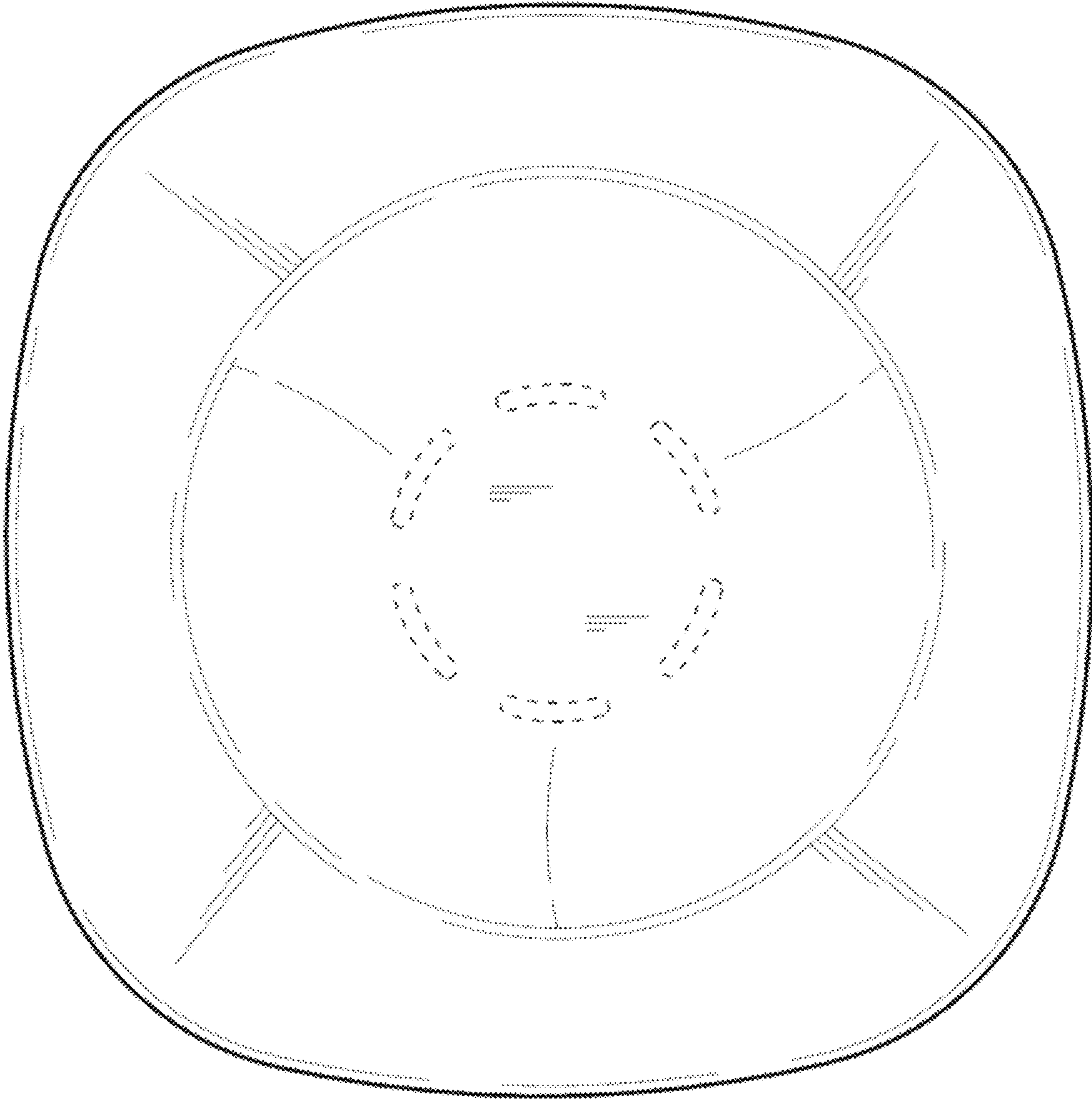

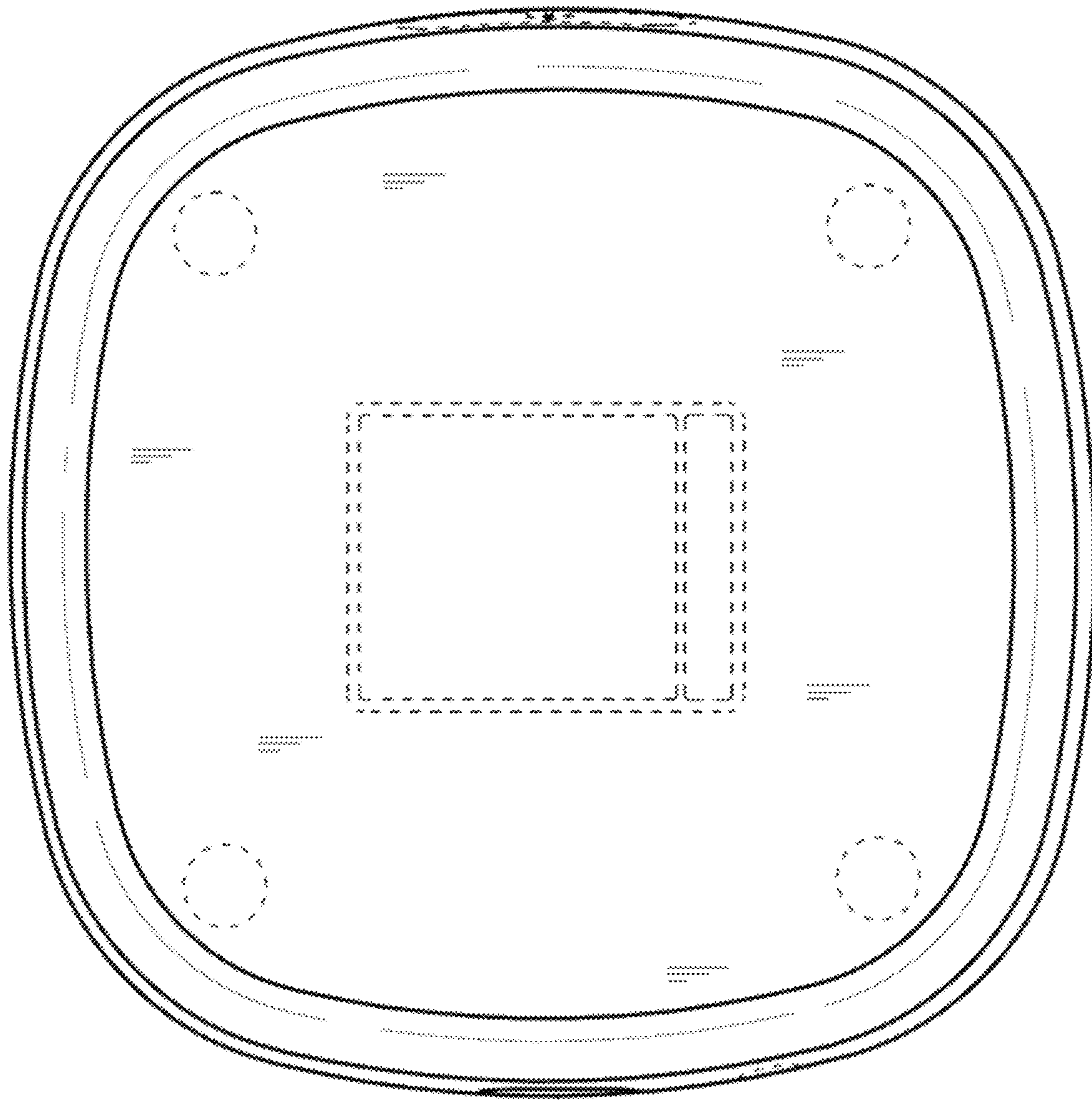

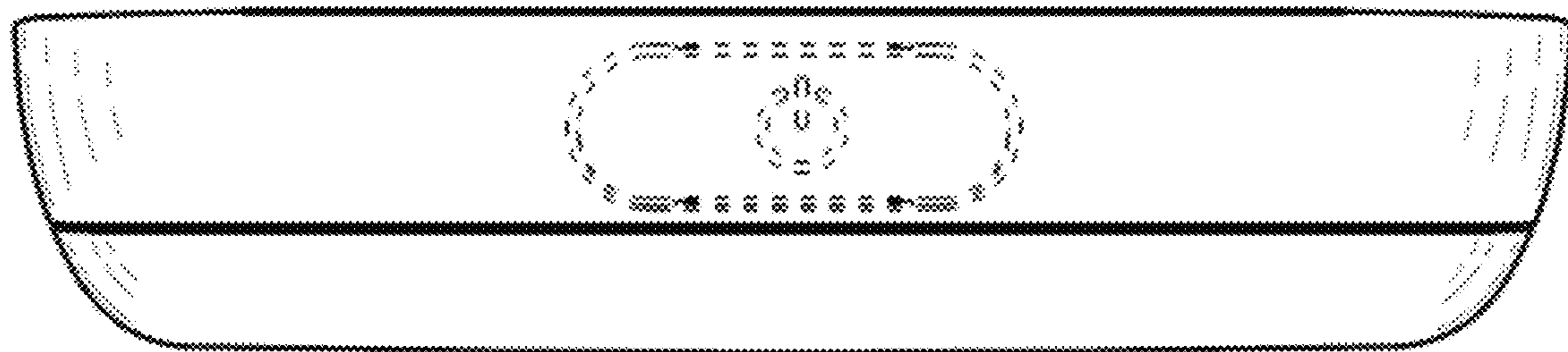

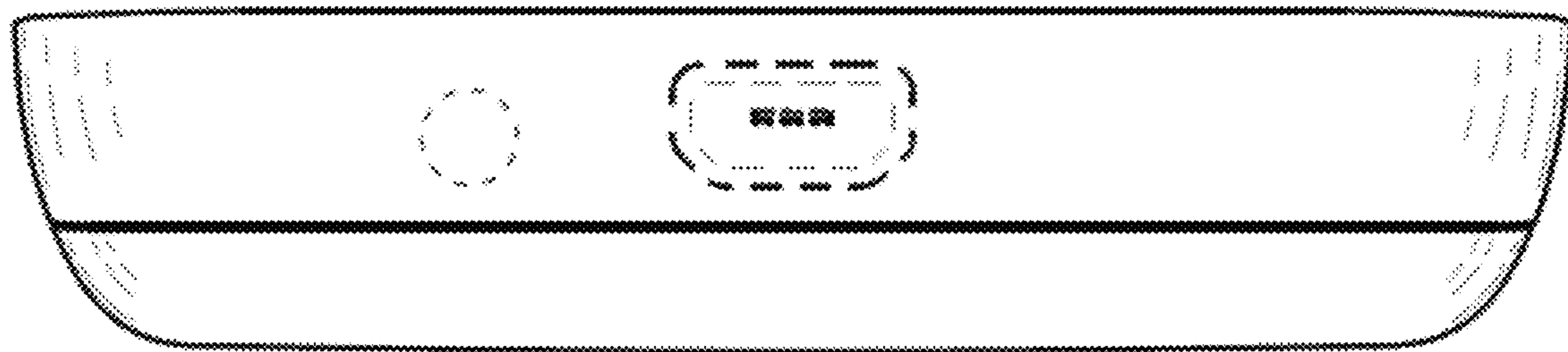
