FIG. 6 is a top view of the presently claimed design; and, FIG. 7 is a bottom view of the presently claimed design.

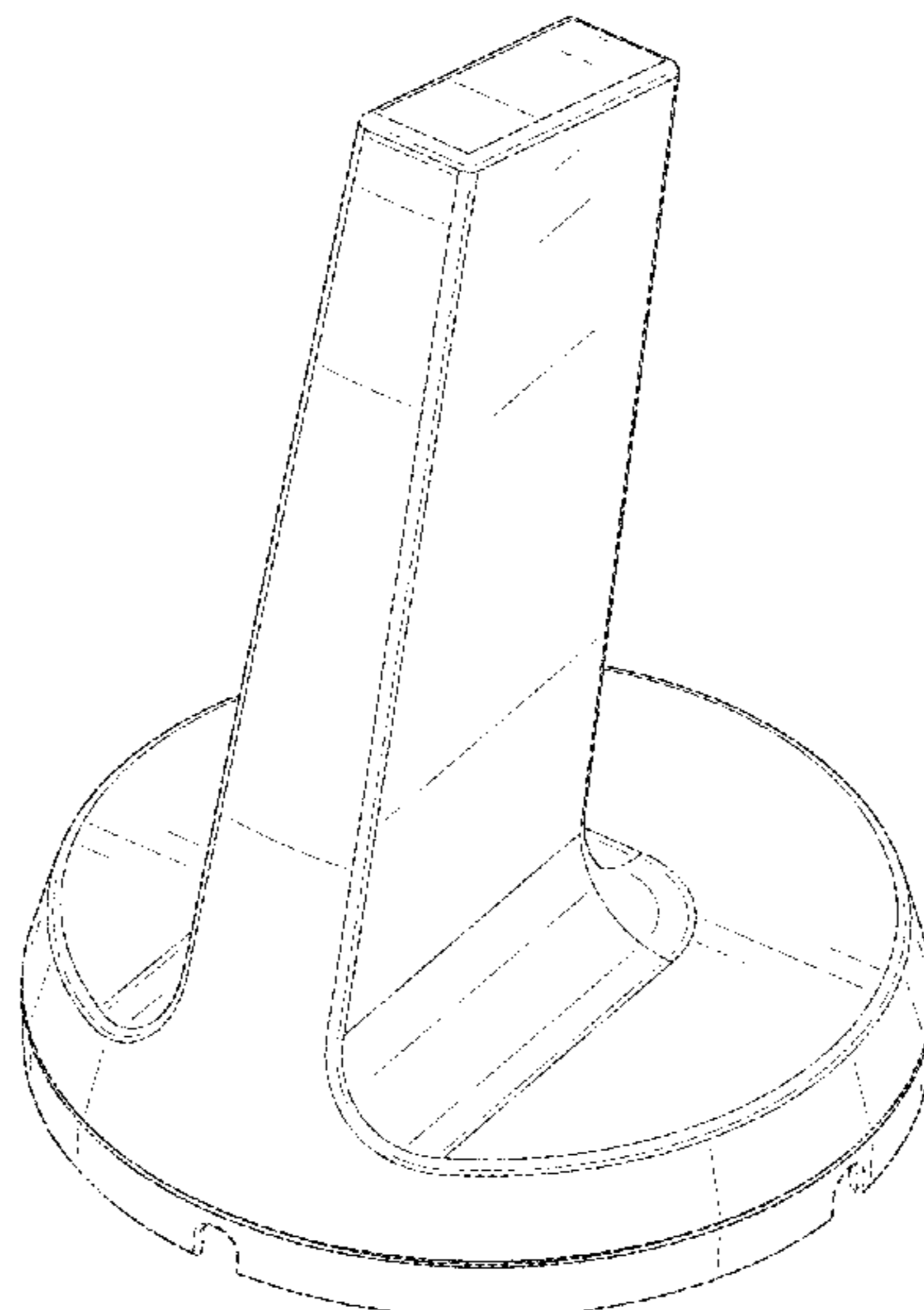

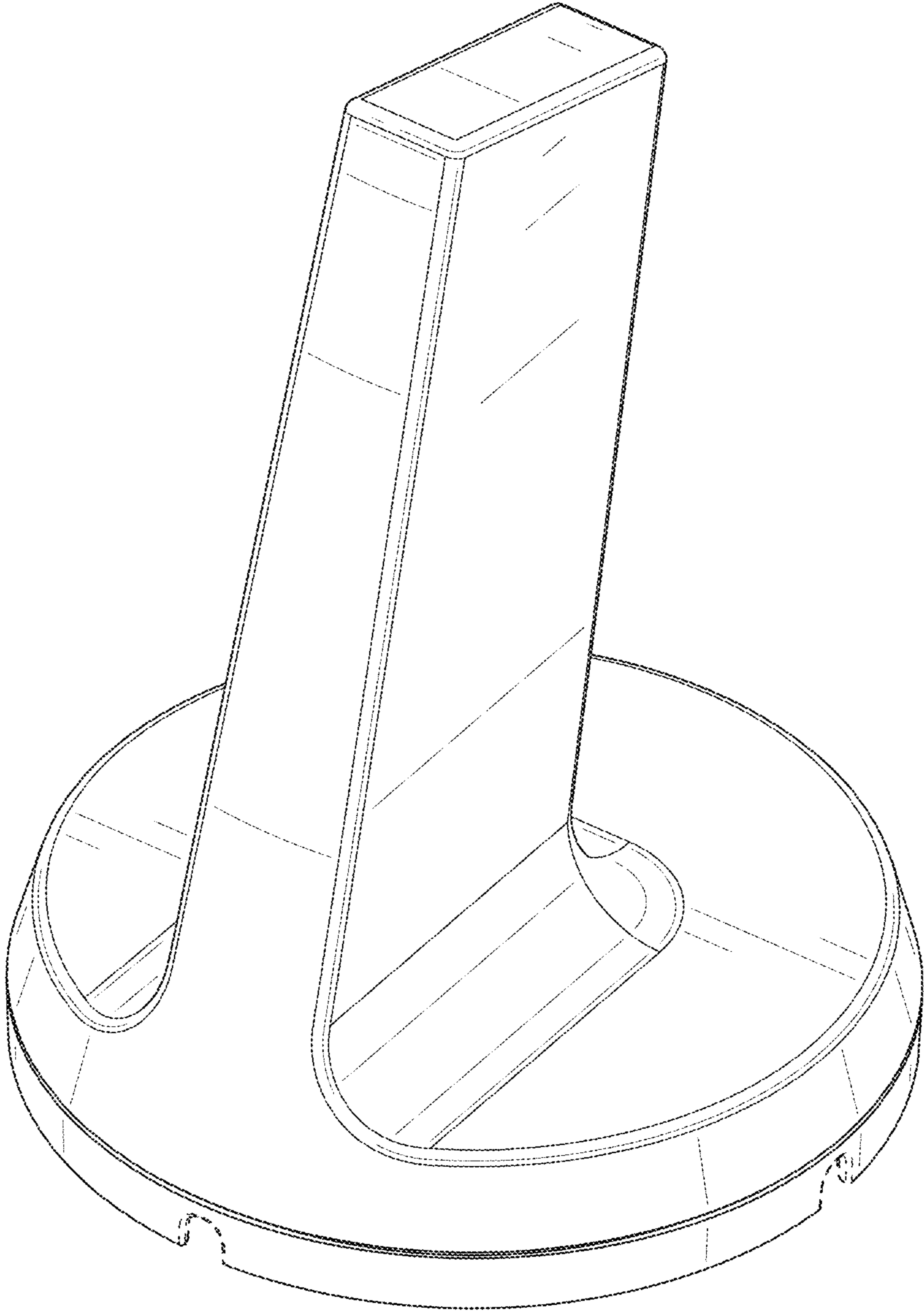

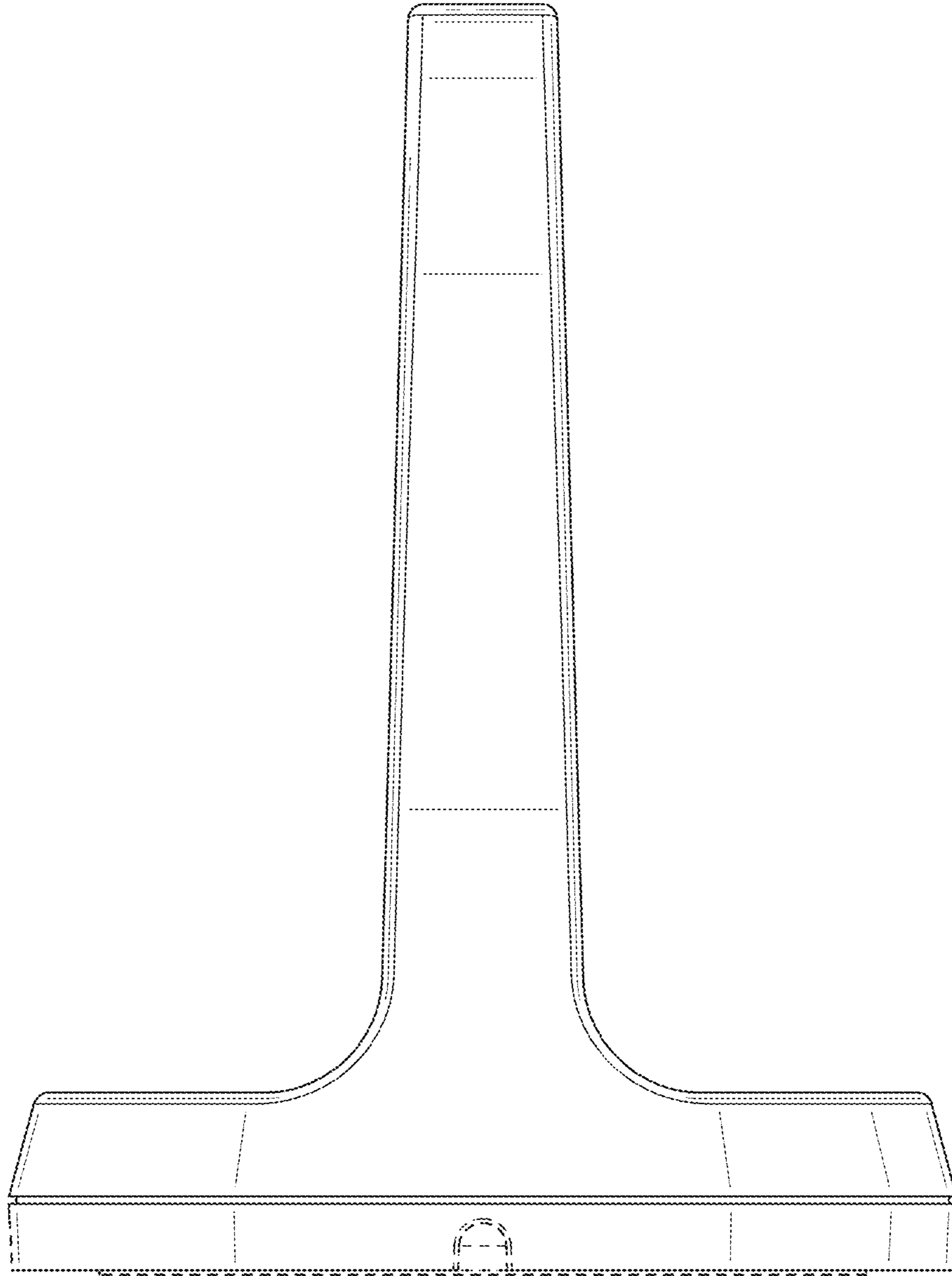

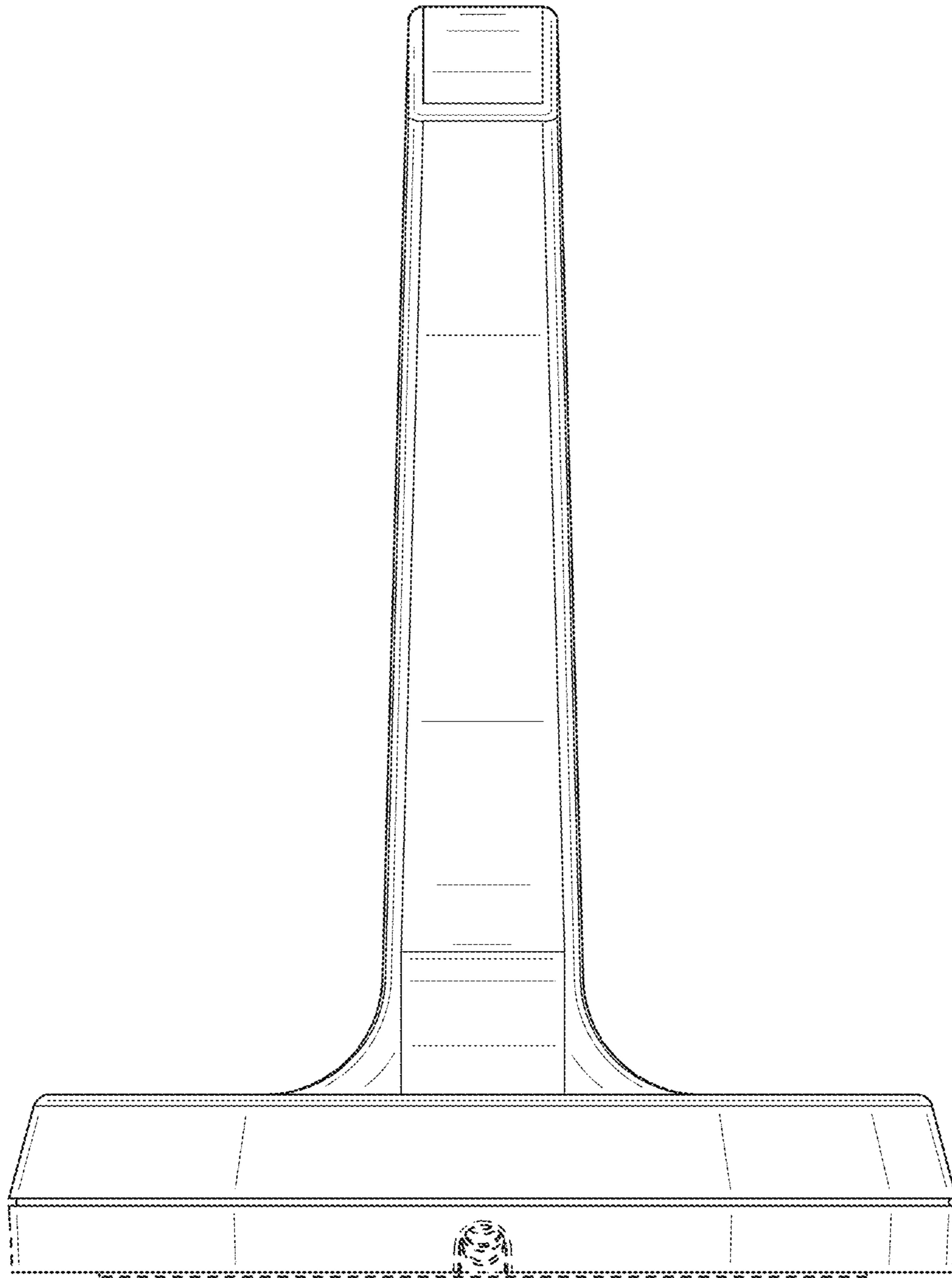

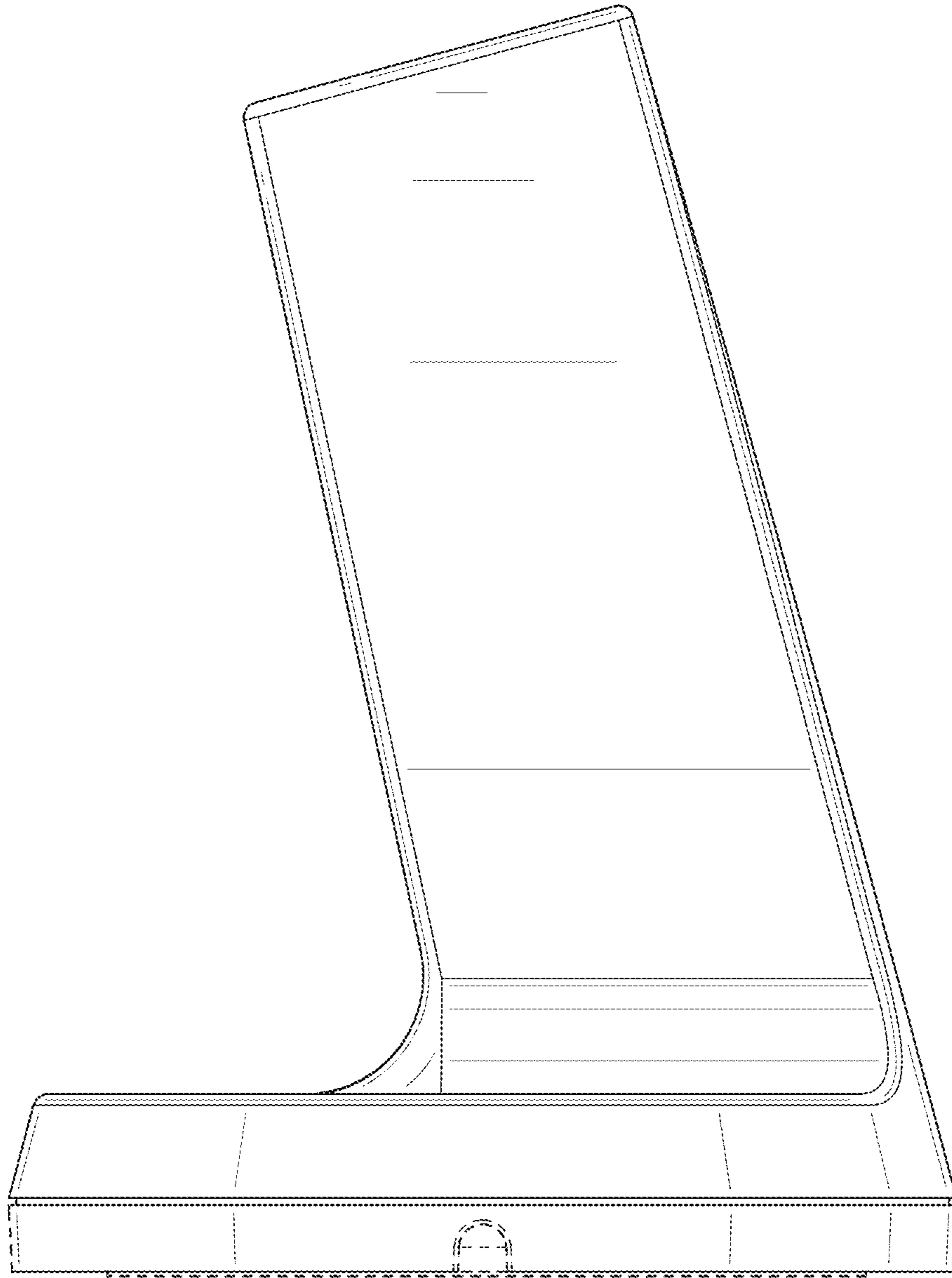

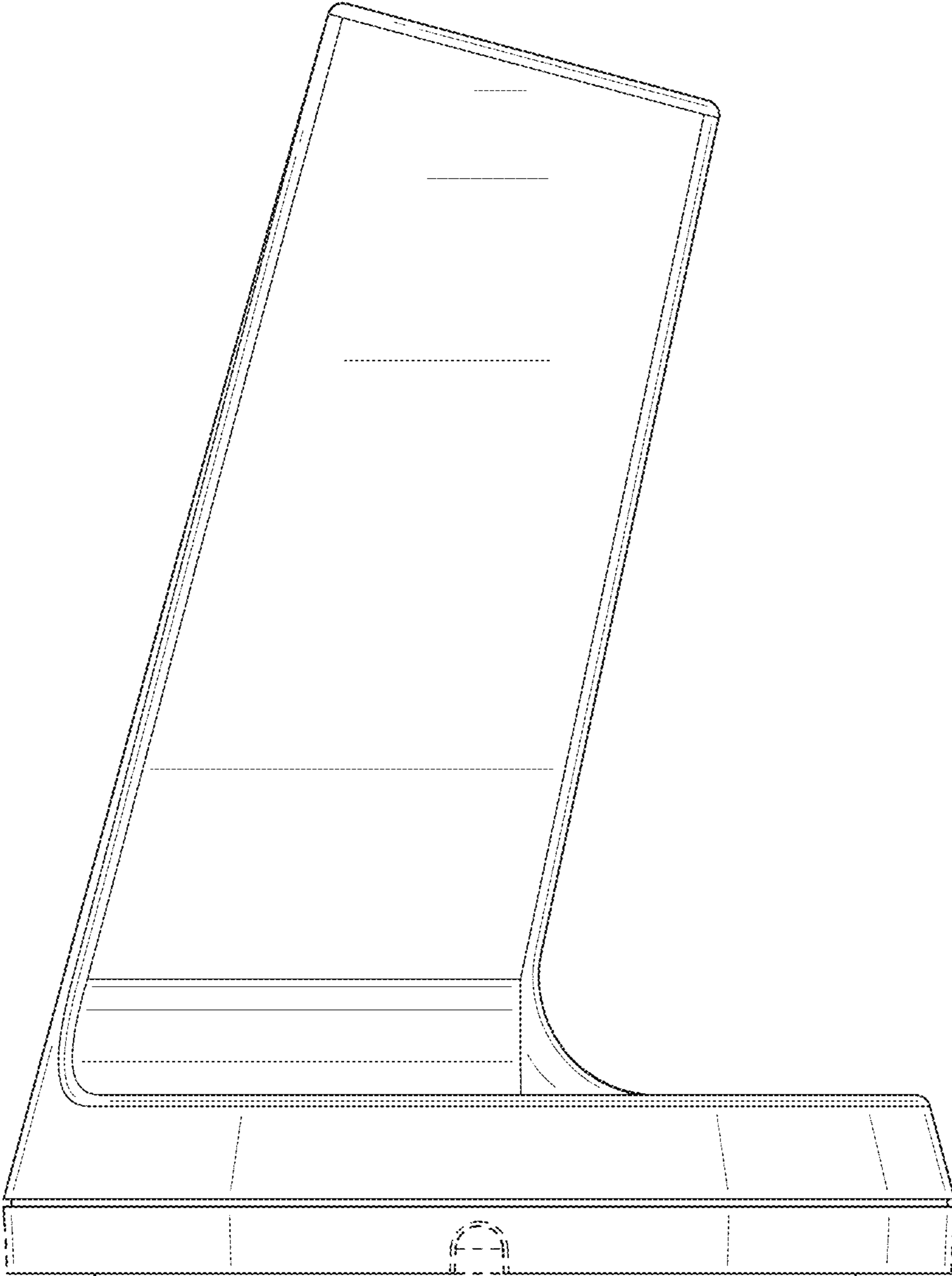

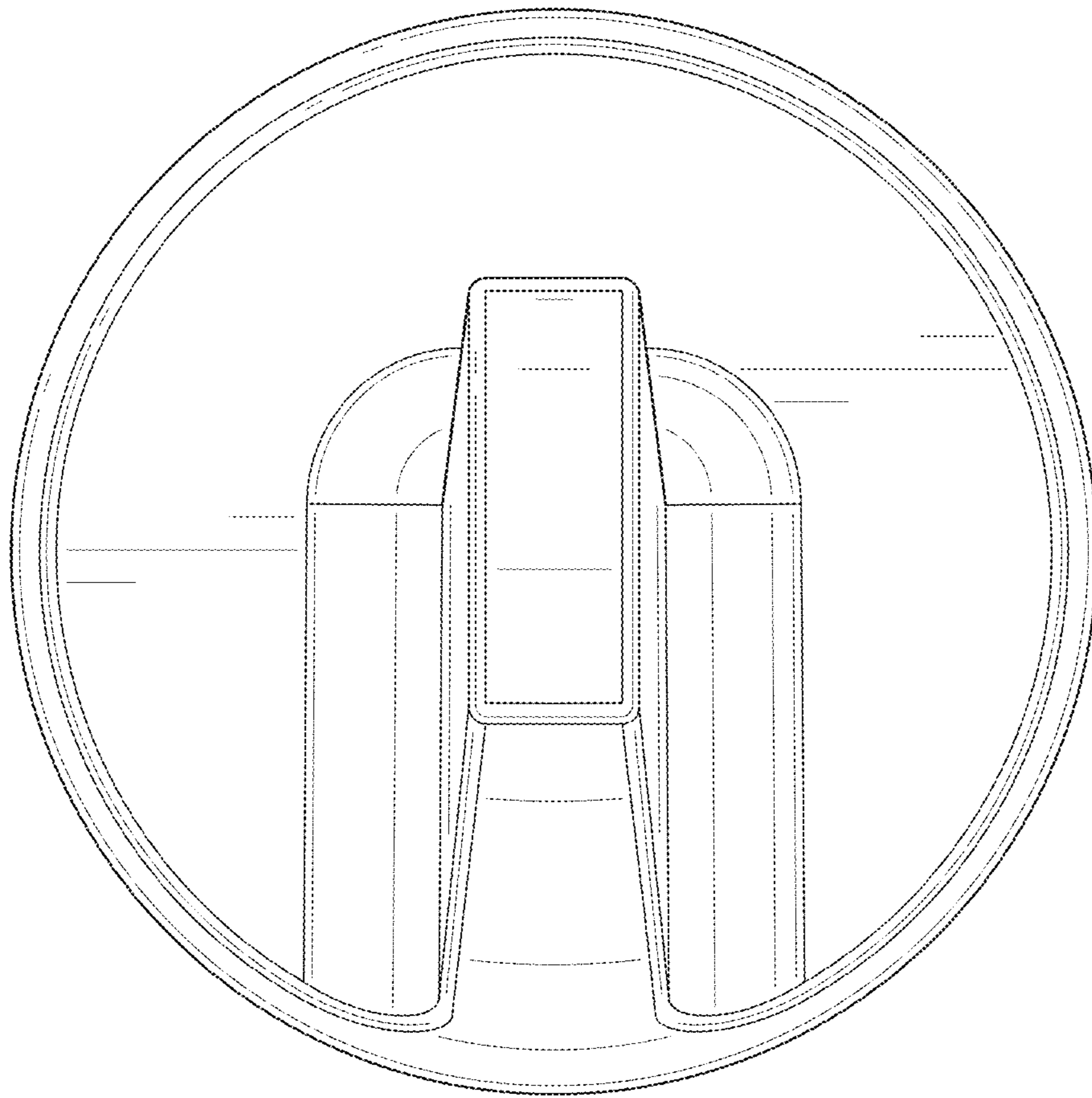

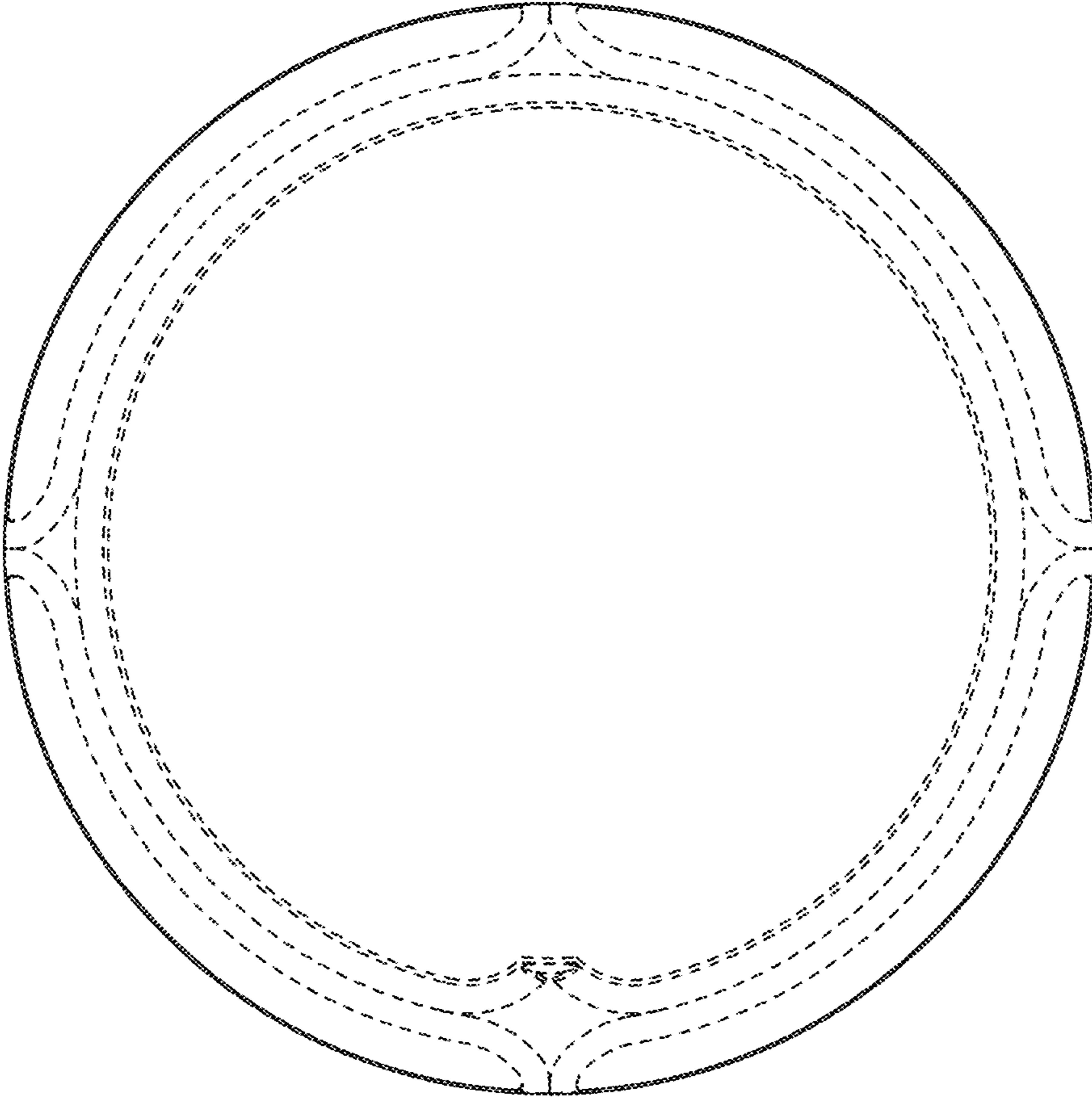
