The ornamental design for a display screen with animated graphical user interface, as shown and described.

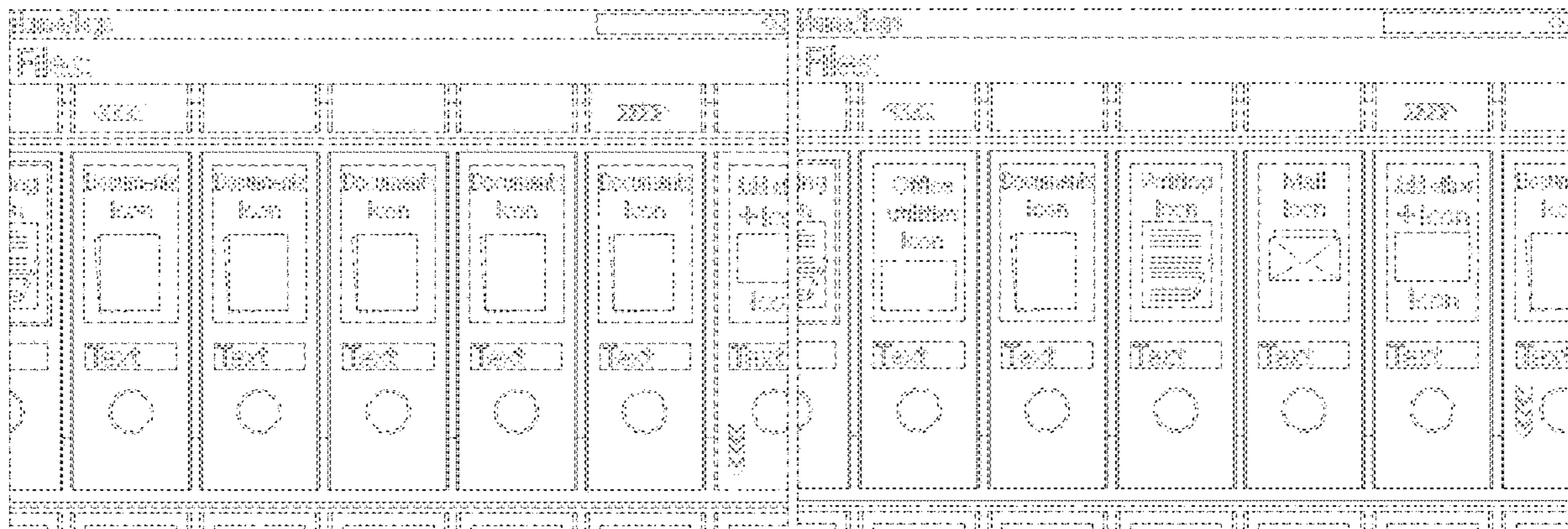
DESCRIPTION

FIG. 1 is a front view showing a display screen with animated graphical user interface showing a first image in the sequence thereof;
 FIG. 2 is a second image in the sequence of the display screen with animated graphical user interface;
 FIG. 3 is a third image in the sequence of the display screen with animated graphical user interface;
 FIG. 4 is a fourth image in the sequence of the display screen with animated graphical user interface;
 FIG. 5 is a fifth image in the sequence of the display screen with animated graphical user interface;
 FIG. 6 is a sixth image in the sequence of the display screen with animated graphical user interface;
 FIG. 7 is a seventh image in the sequence of the display screen with animated graphical user interface; and,
 FIG. 8 is an eighth image in the sequence of the display screen with animated graphical user interface.

The outermost broken line perimeter illustrates a display screen and forms no part of the claimed design. The remaining broken lines illustrate portions of a graphical user interface which form no part of the claimed design. The two groups of arrow features that are depicted in solid line toward the right side of the screen are included in the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-8. The process or period in which one image transitions to another image forms no part of the claimed design.

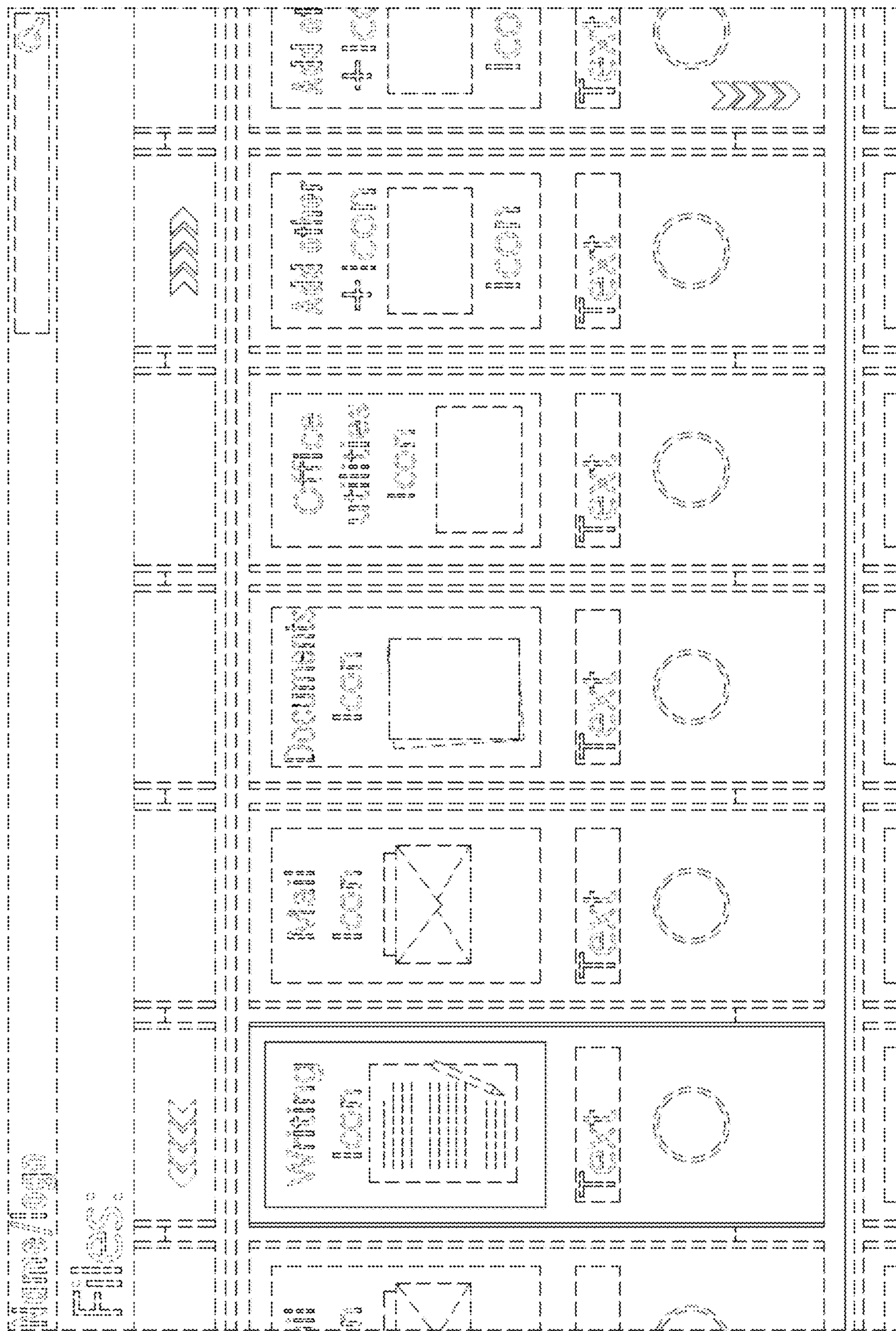

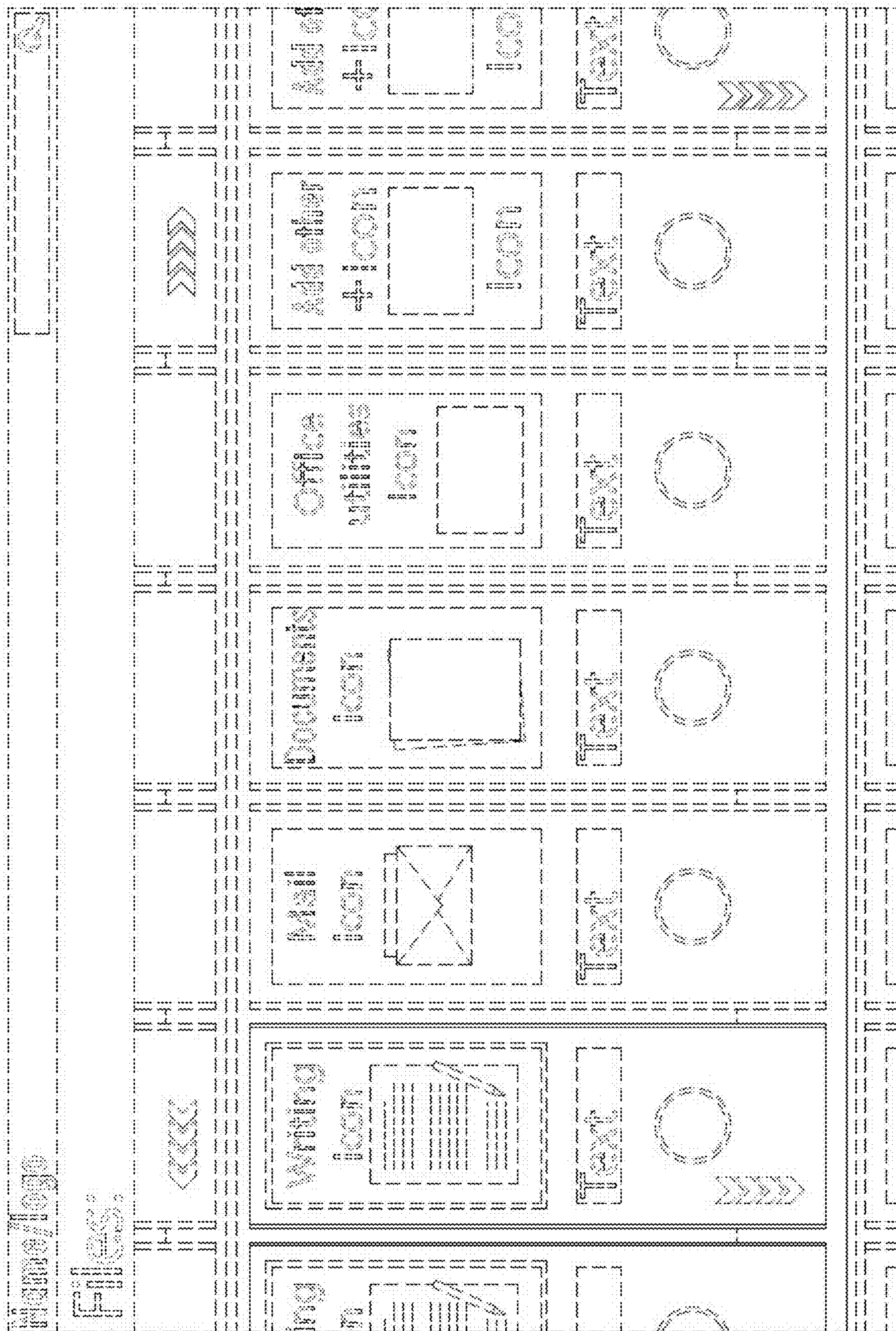

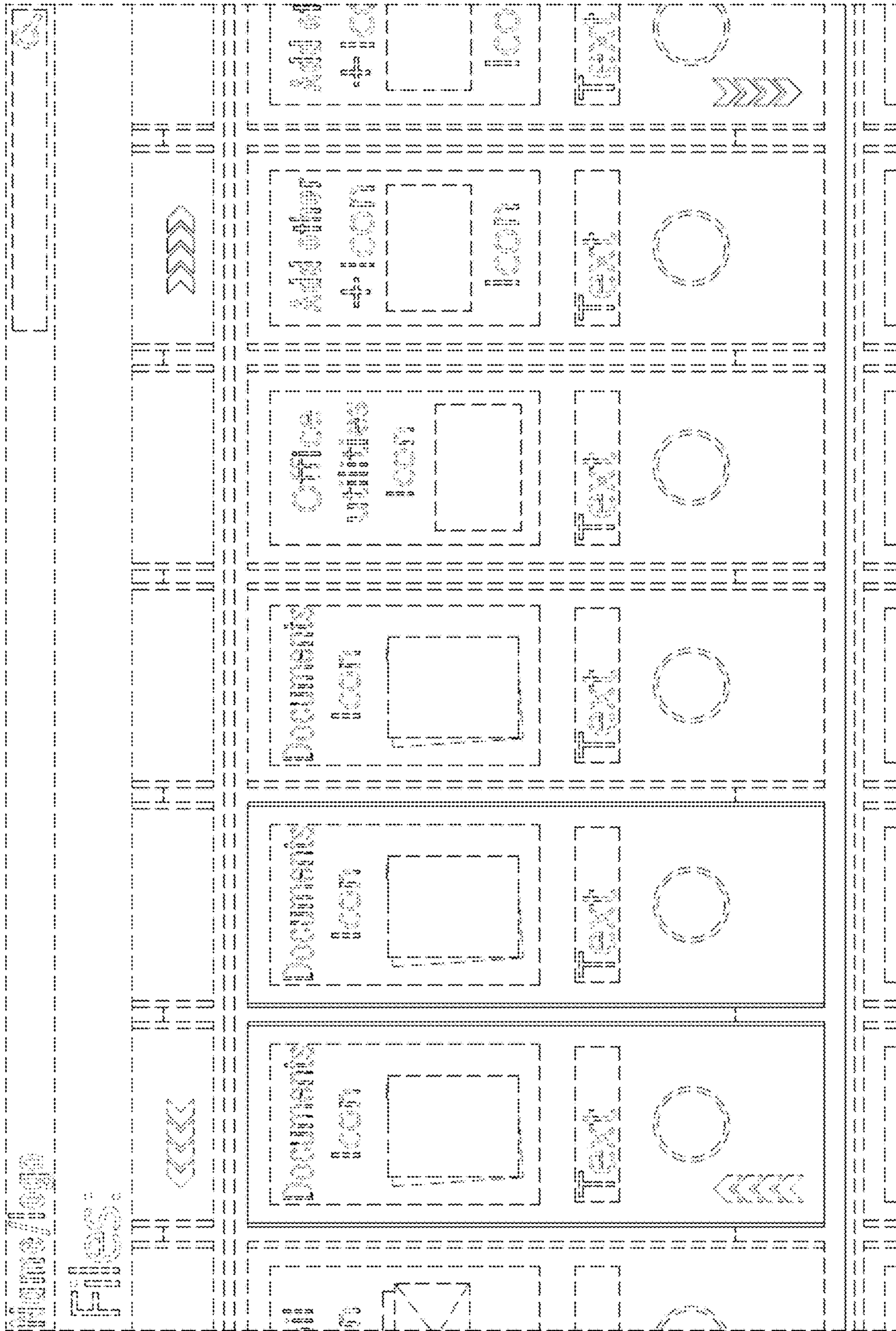

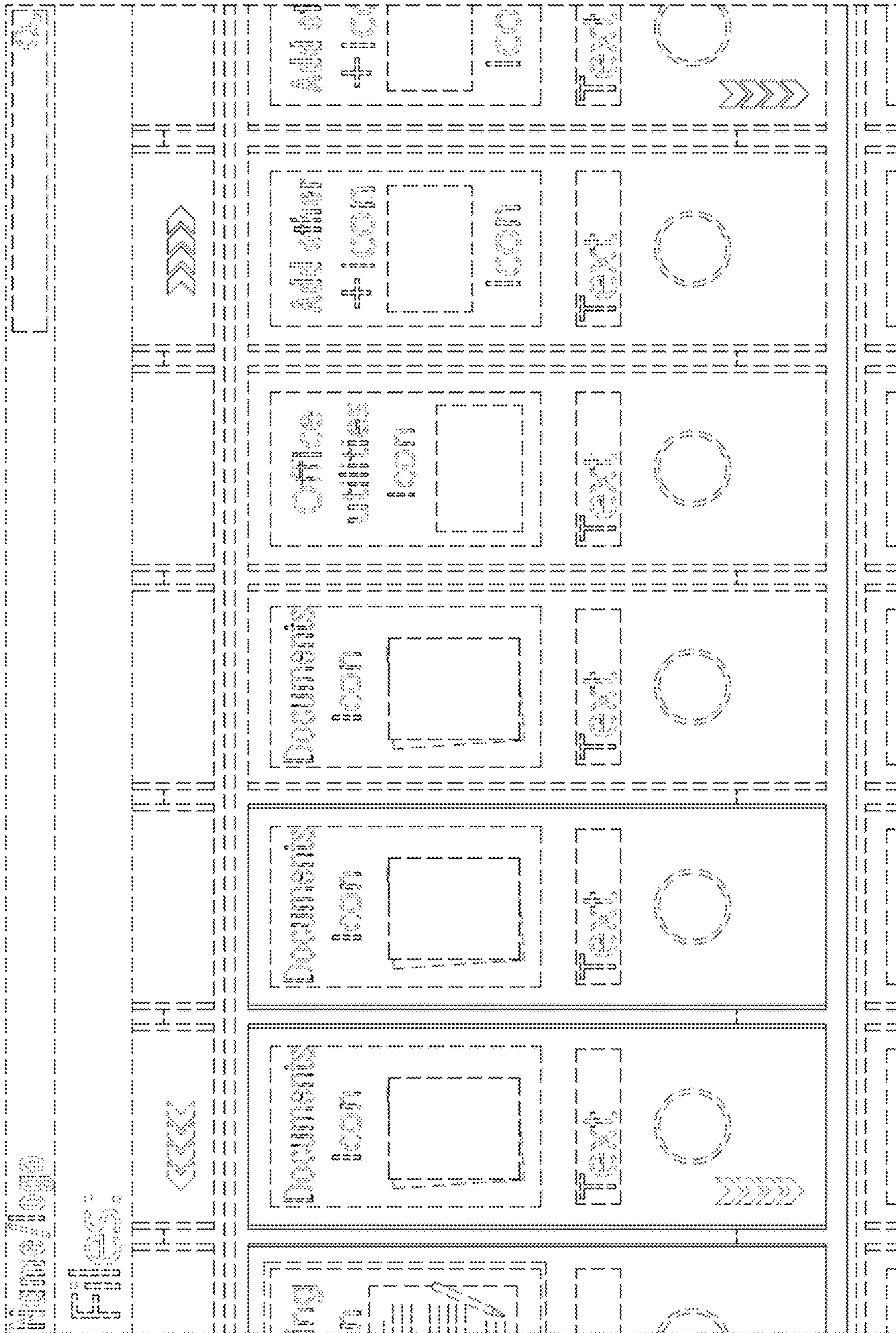

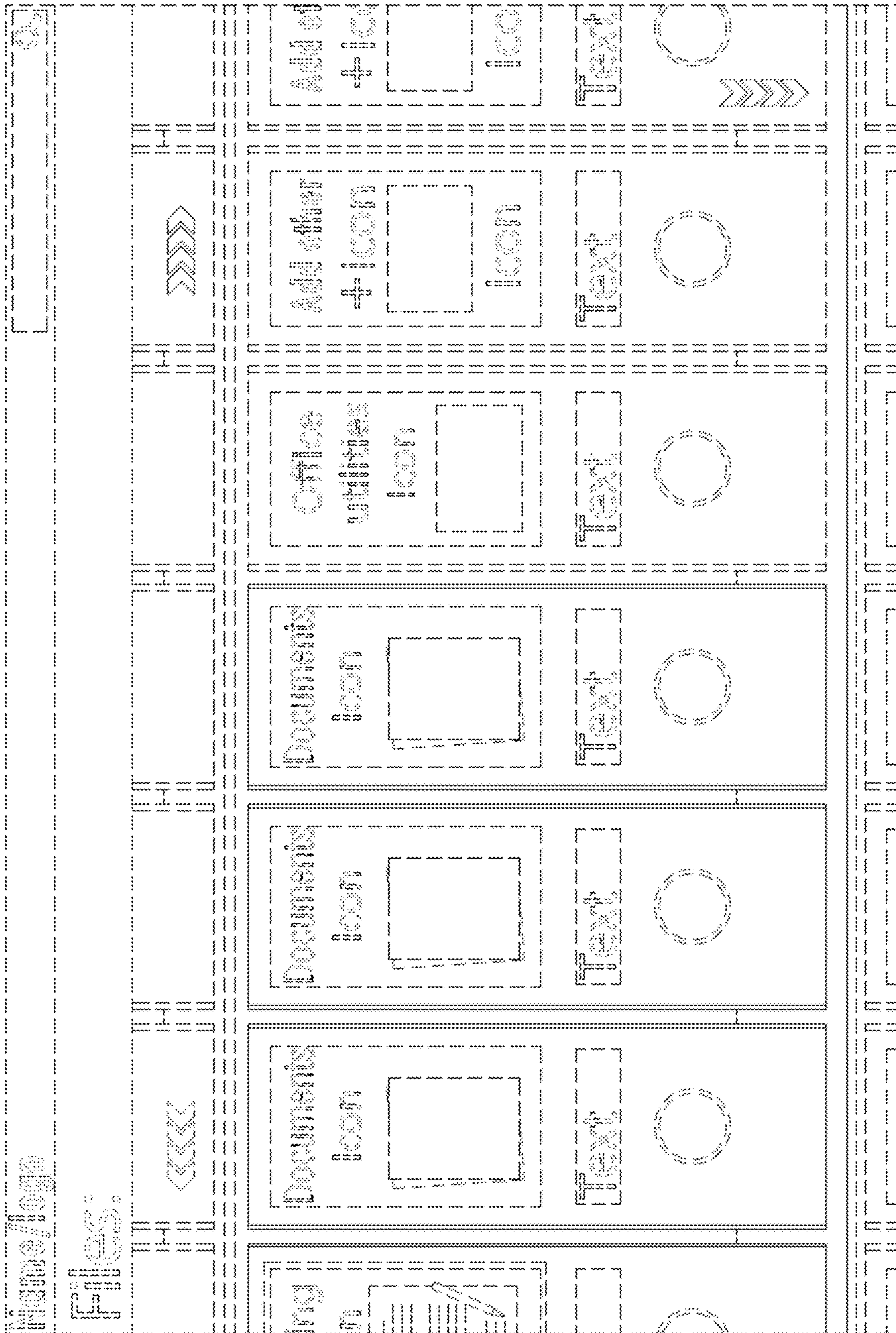

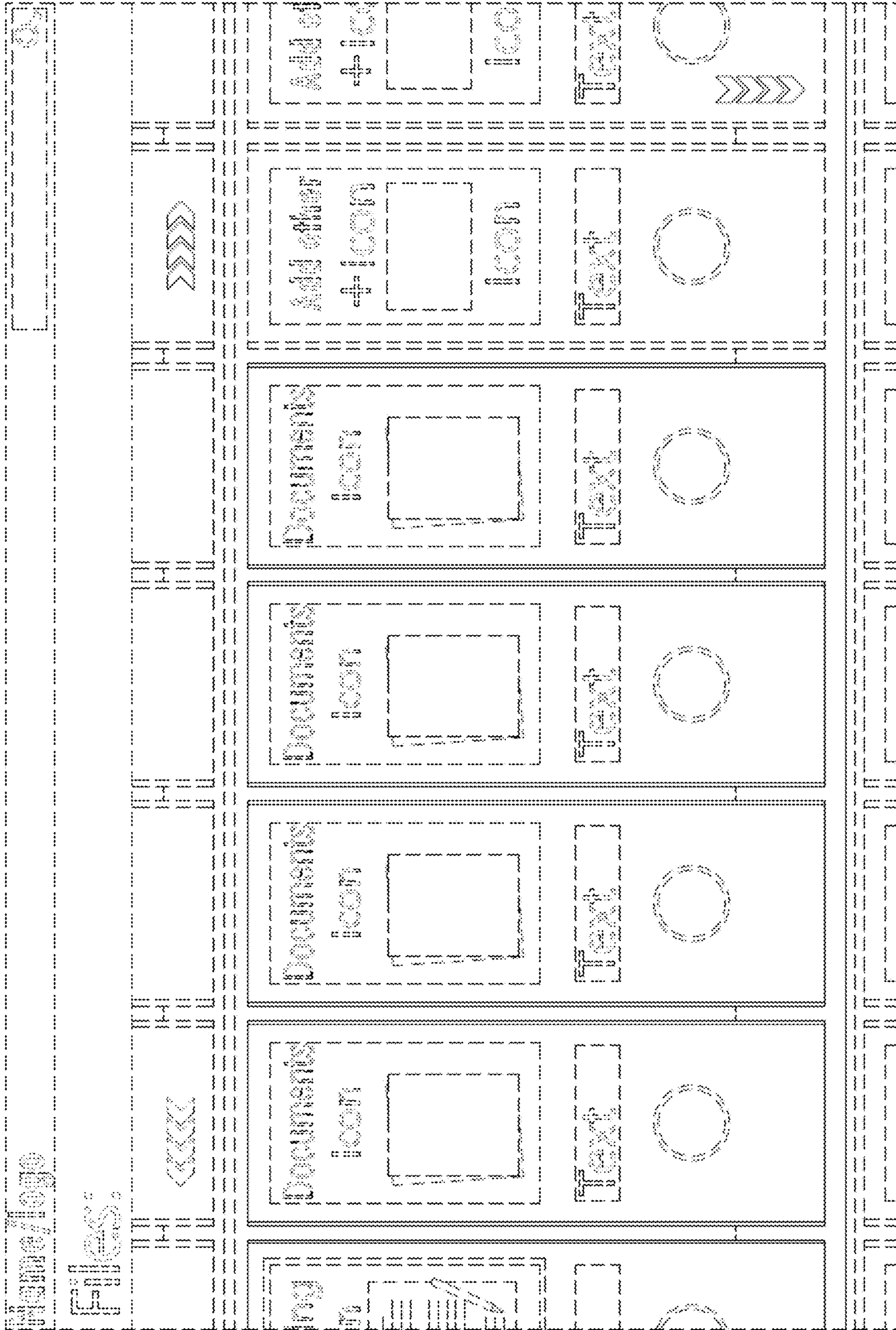

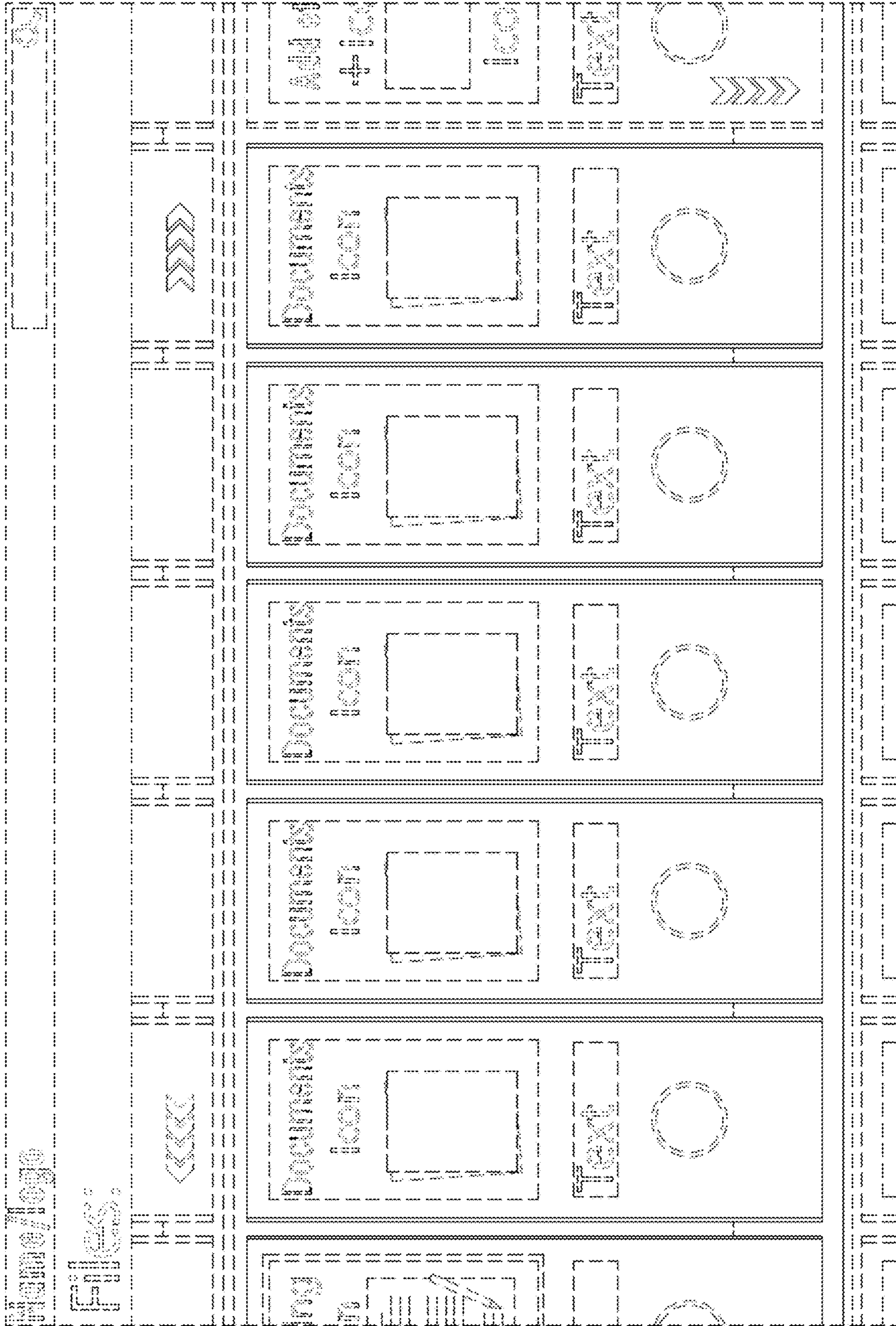

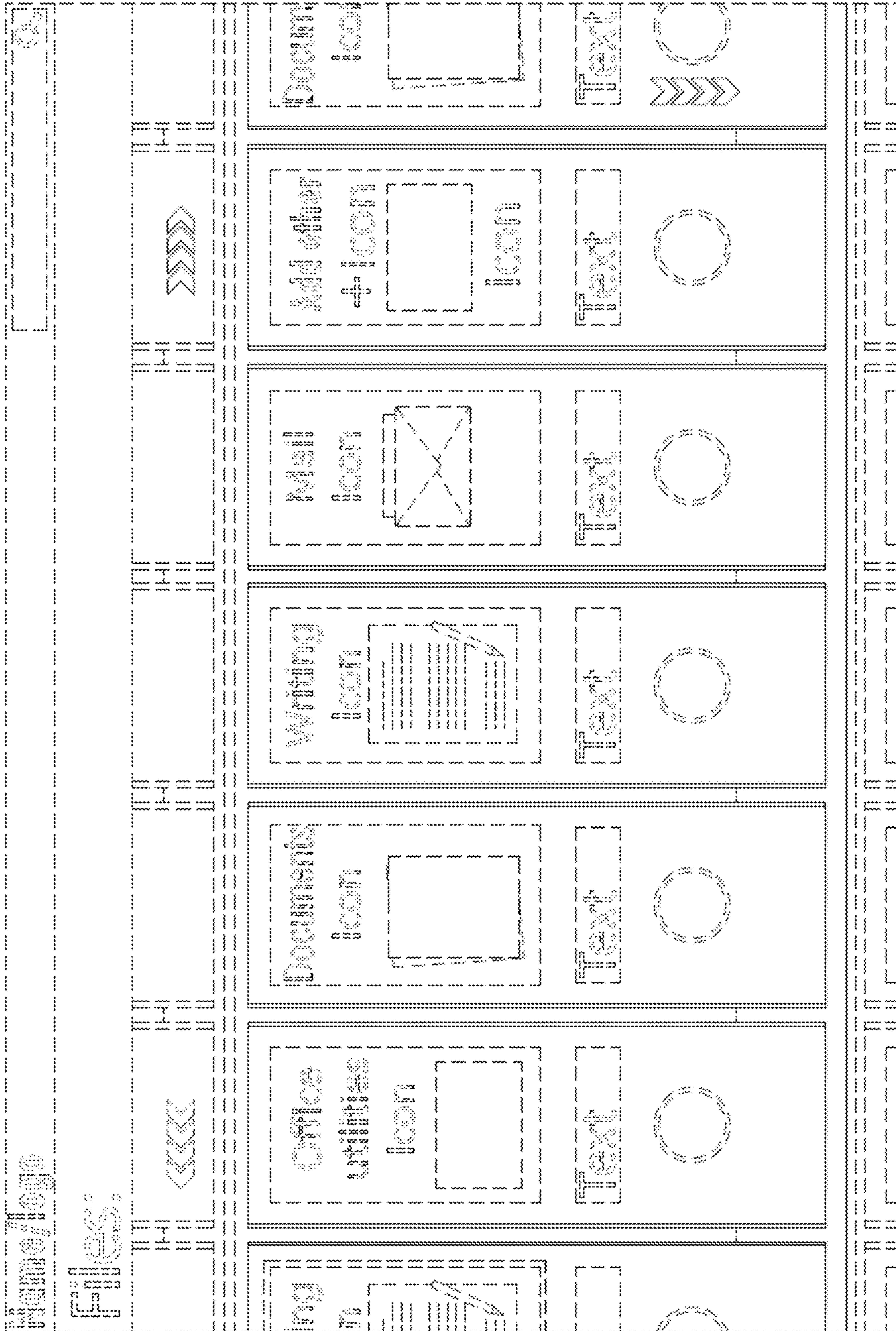
