(57) **CLAIM**

The ornamental design for a display screen with icon group  
and display screen with icon set, as shown and described.

**DESCRIPTION**

FIG. 1 shows a front view of a display screen with icon  
group according to a first embodiment of the claimed design.  
FIG. 2 shows a rear view of the display screen with icon  
group of FIG. 1.

FIG. 3 shows a left side view of the display screen with icon  
group of FIG. 1.

FIG. 4 shows a right side view of the display screen with  
icon group of FIG. 1.

FIG. 5 shows a top view of the display screen with icon  
group of FIG. 1.

FIG. 6 shows a bottom view of the display screen with icon  
group of FIG. 1; and,

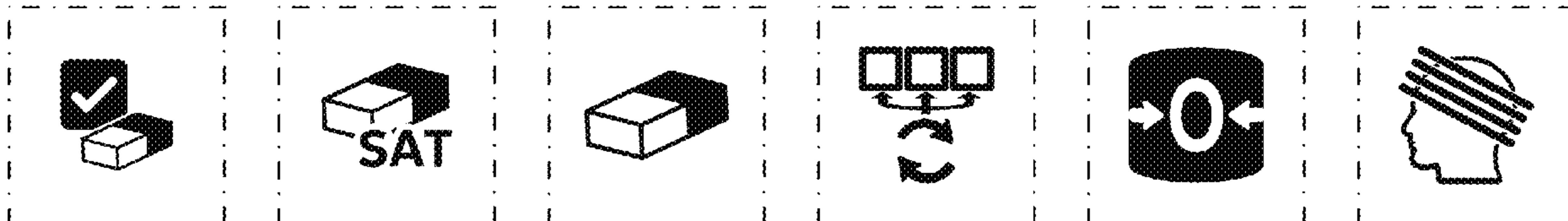
FIG. 7 shows a front view of a display screen with icon set  
according to a second embodiment of the claimed design.

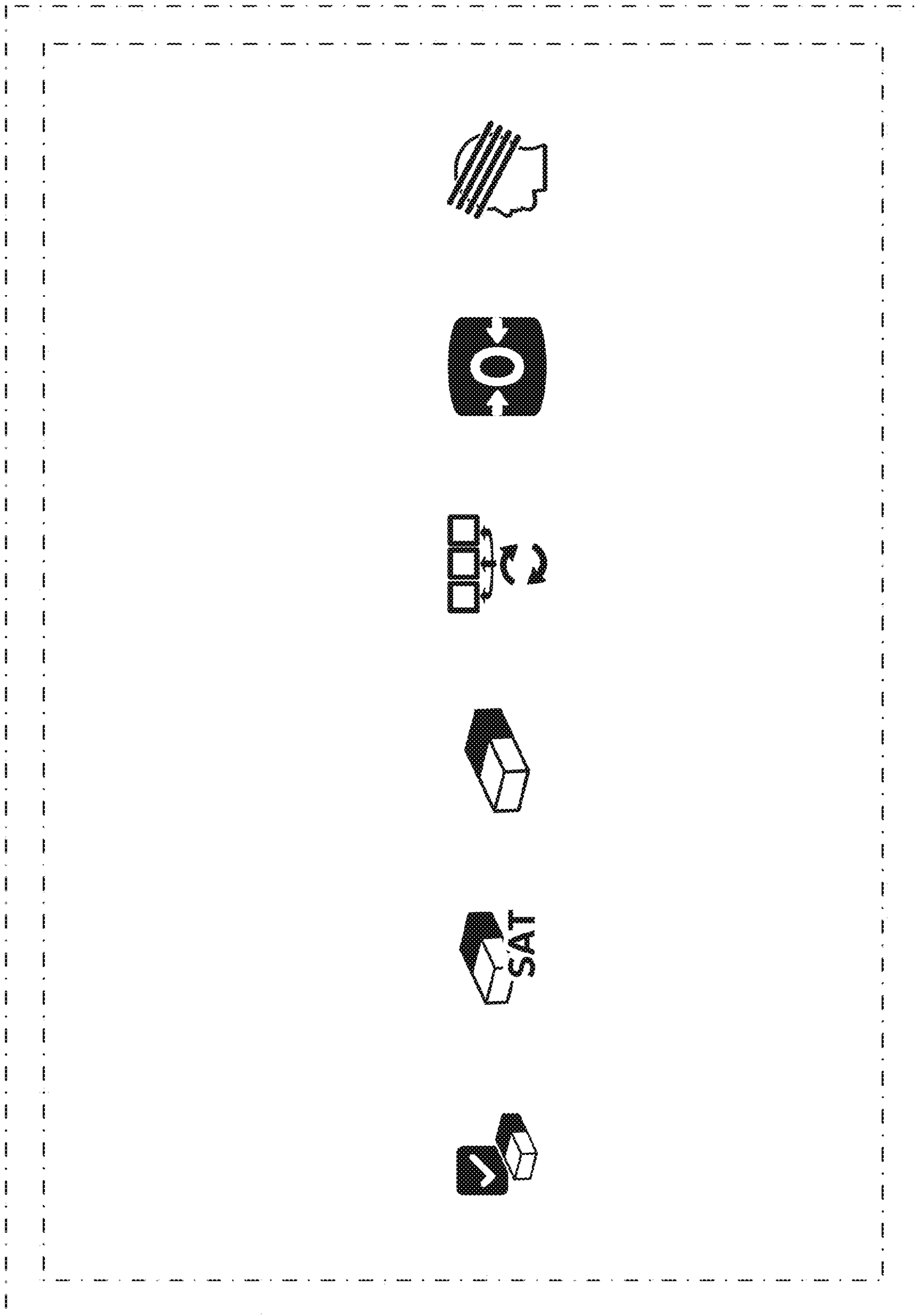

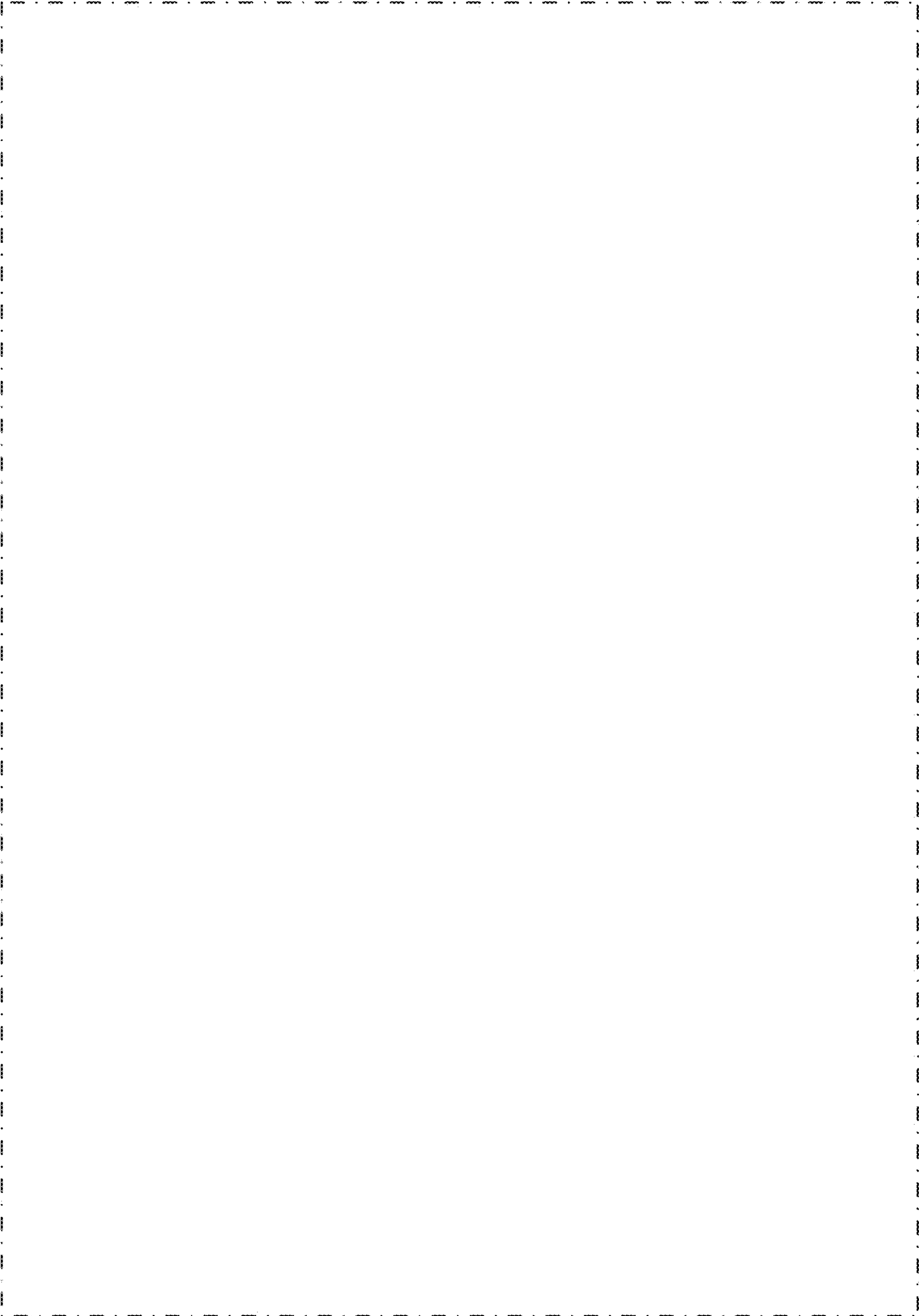

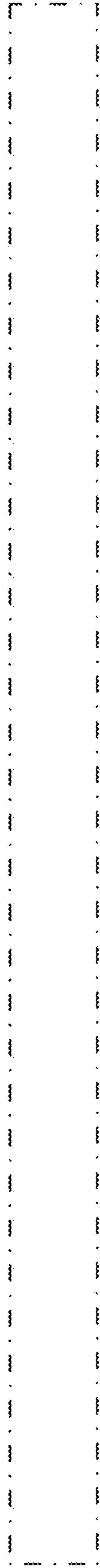

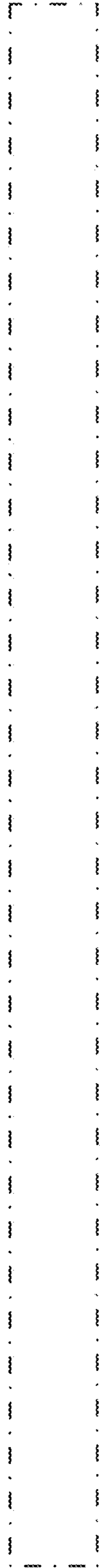

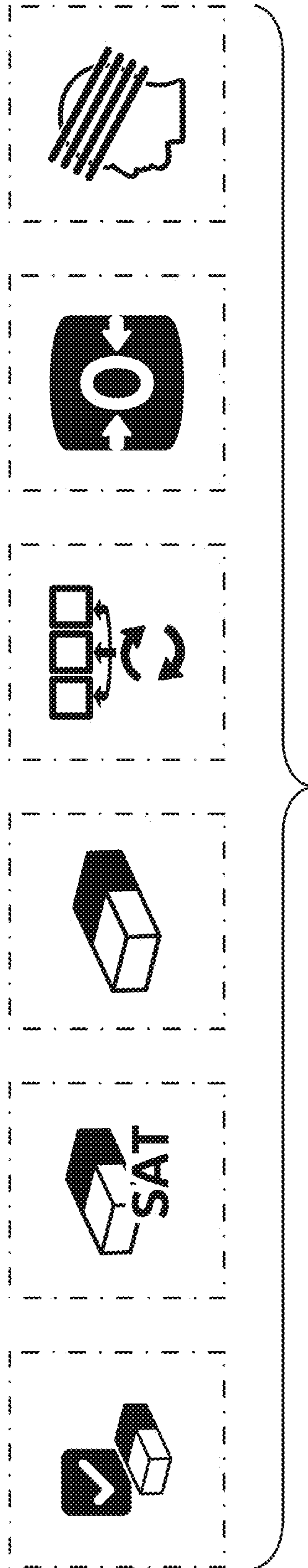
