We claim the ornamental design for a vanity, as shown and described.

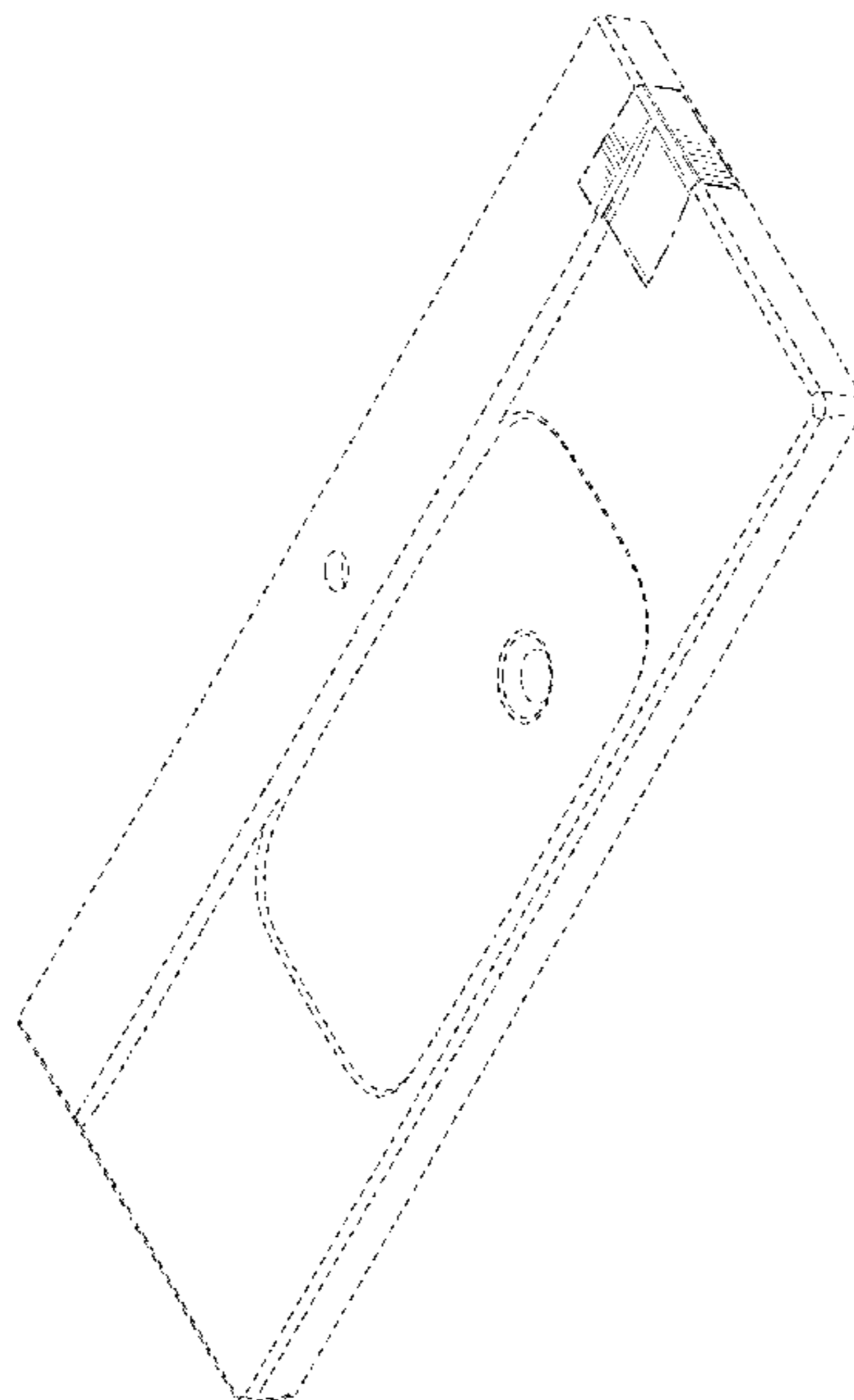
DESCRIPTION

FIG. 1 is a perspective view of the claimed design; FIG. 2 is a side view of FIG. 1; and, FIG. 3 is a top view of FIG. 1. The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings form no part of the claimed design. Broken lines formed by equal length dashes show unclaimed subject matter. Broken lines formed of unequal length dashes (i.e., dash-dot) define bounds of the claimed design.

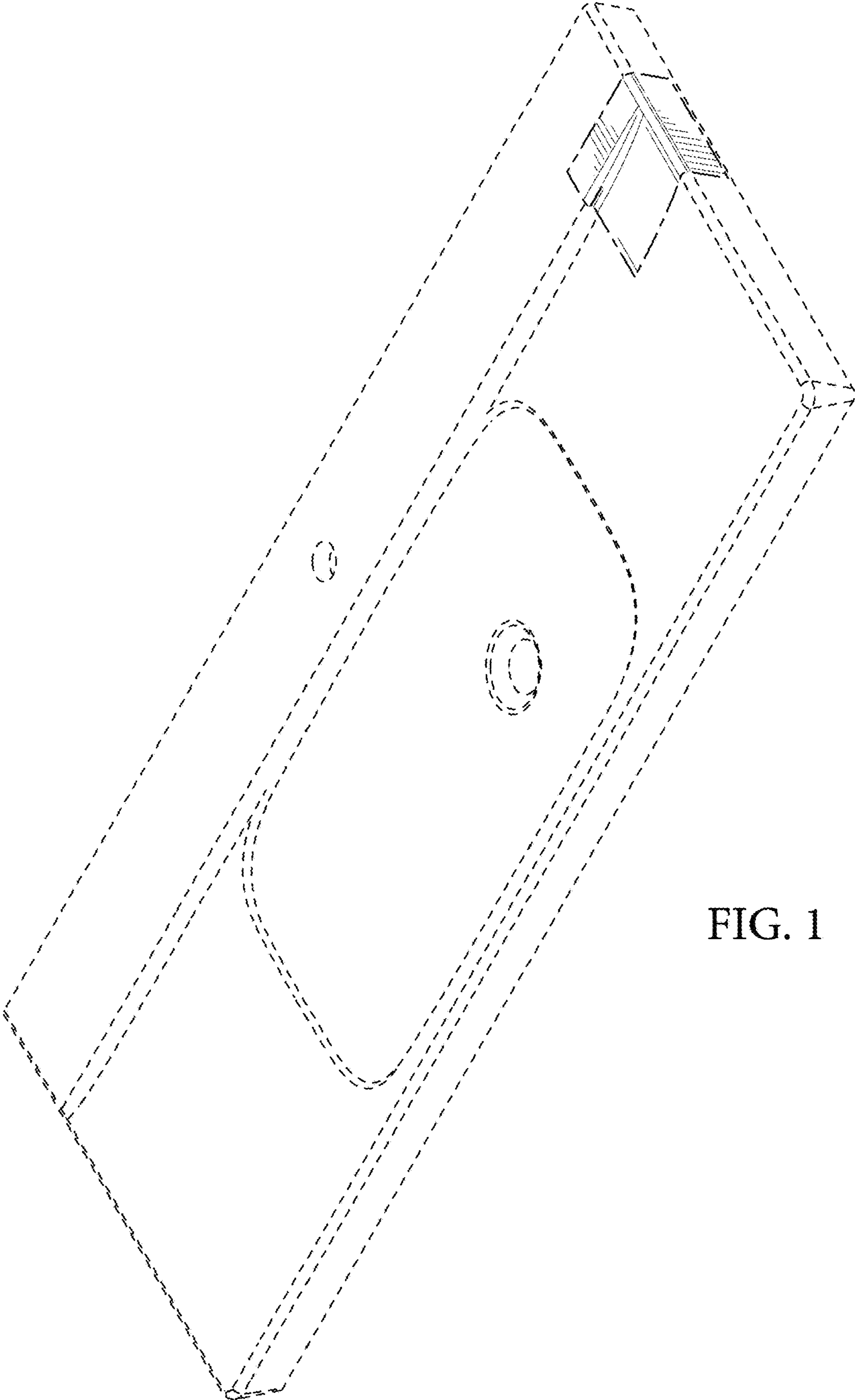

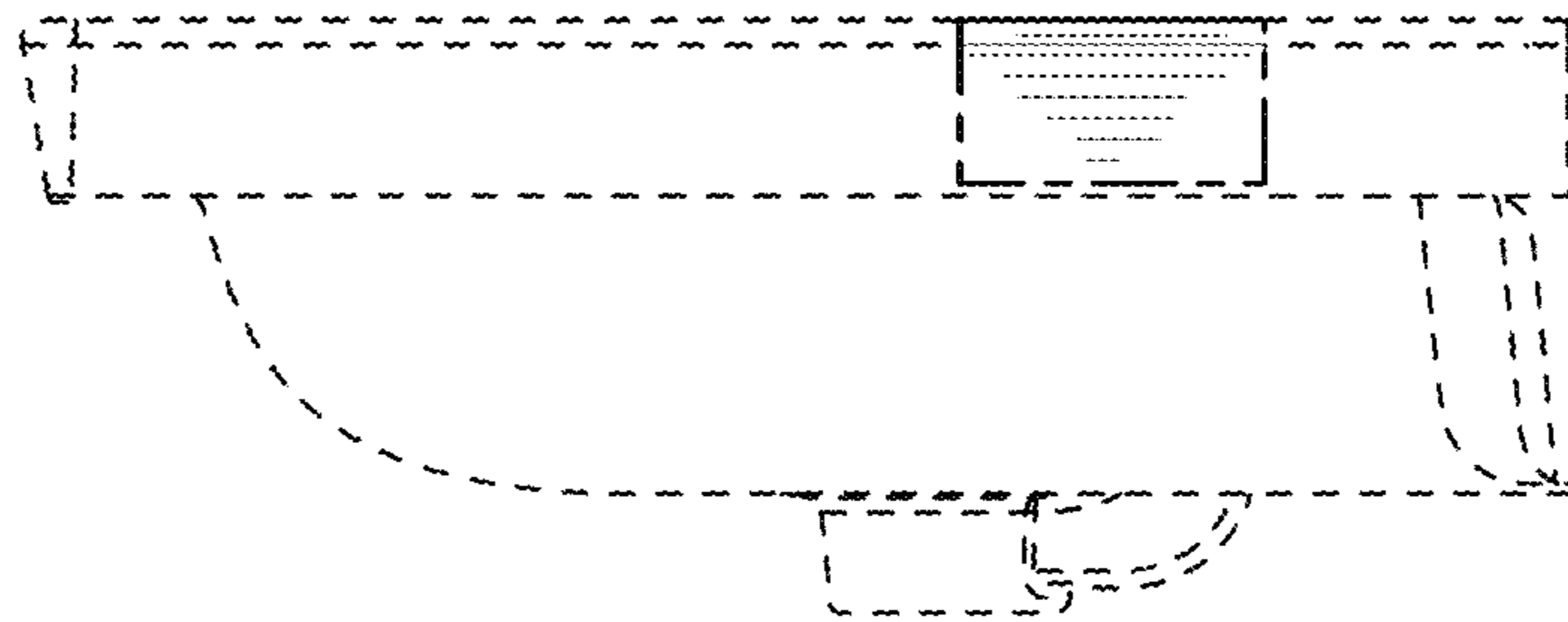

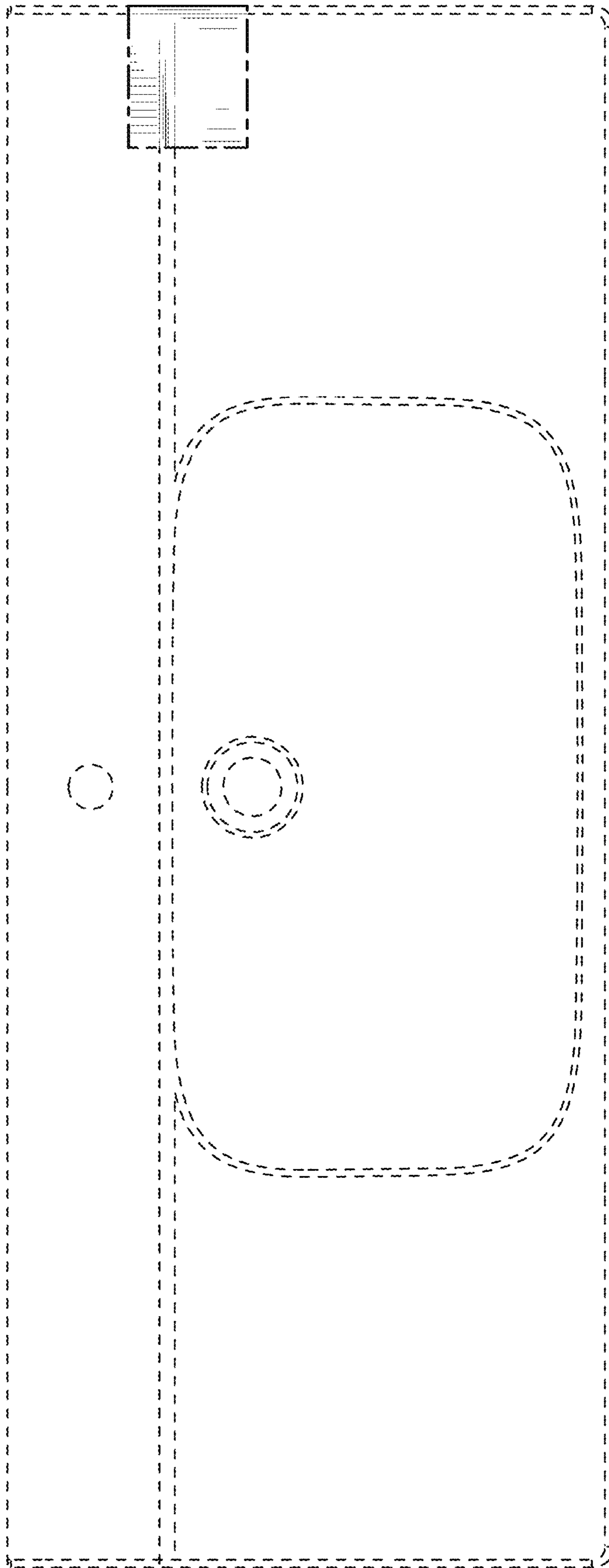
