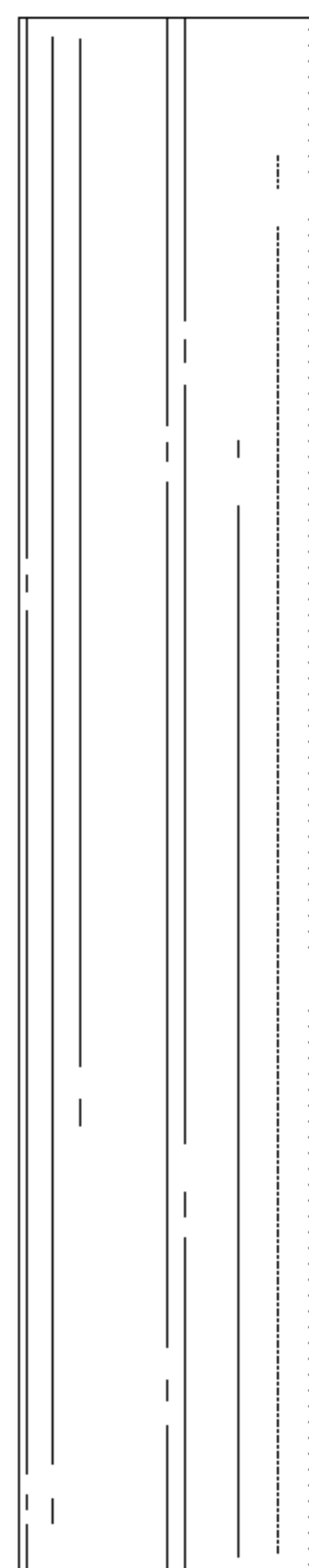
(57) **CLAIM**

The ornamental design for a rail for a ladder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a rail for a ladder showing our new design; the rear elevation view being a mirror image thereof;
FIG. 2 is a right side elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a front, top, and left side perspective view thereof;
FIG. 6 is a front, top, and right side perspective view thereof; and,
FIG. 7 is a front, bottom, and right side perspective view thereof.

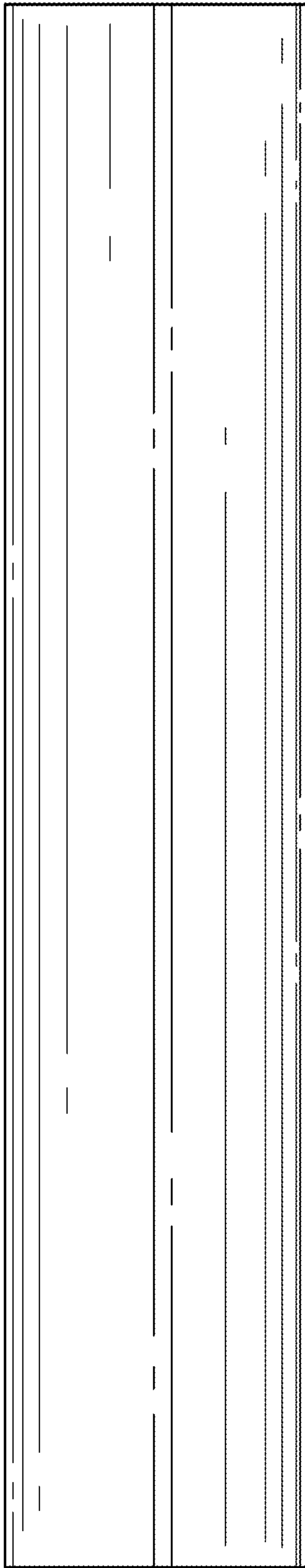

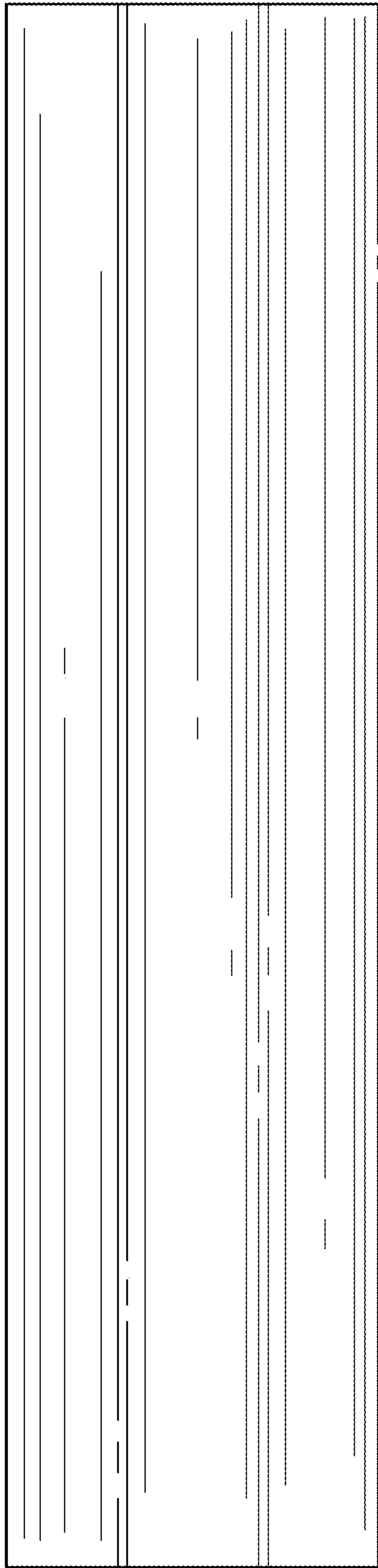

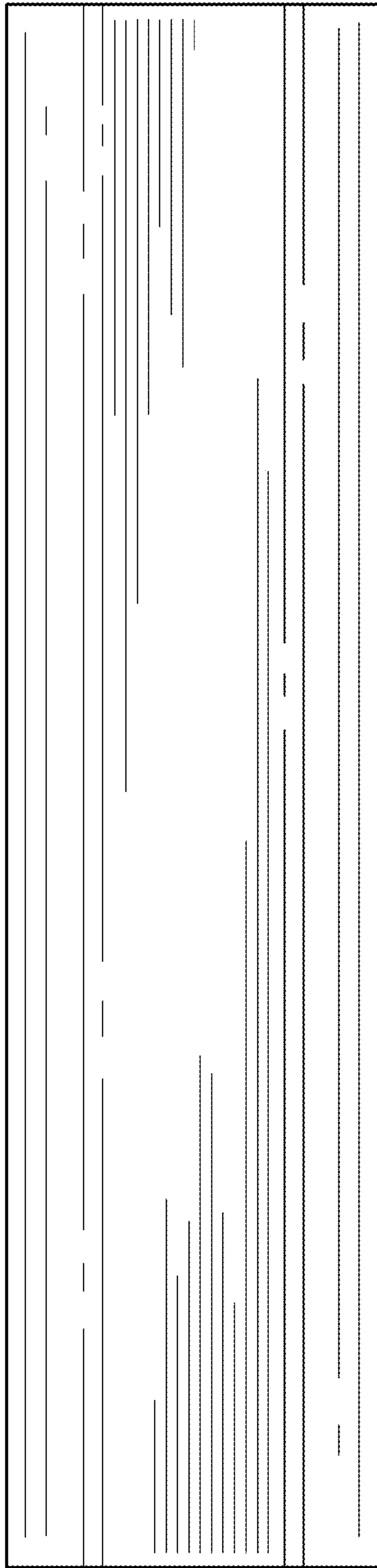

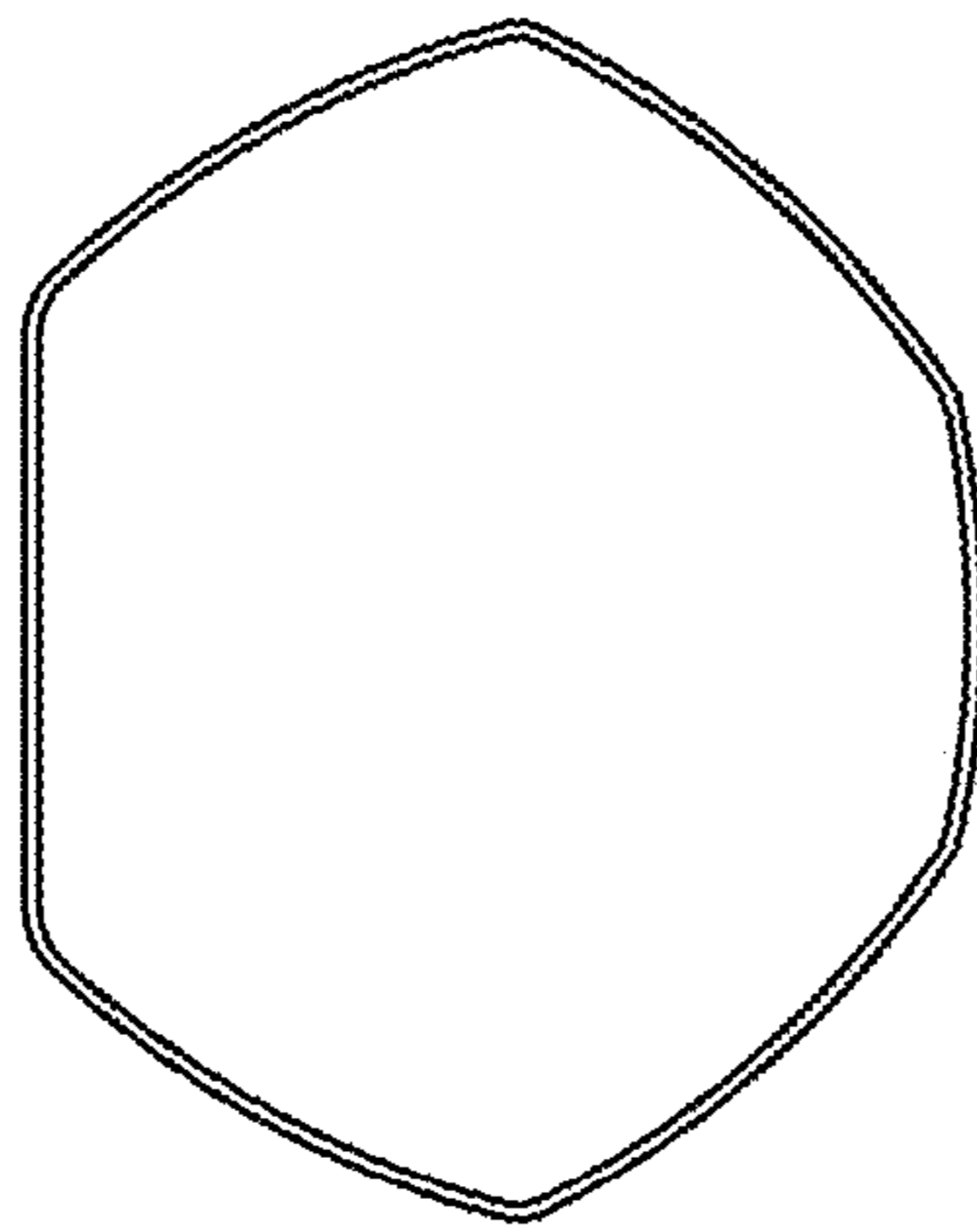

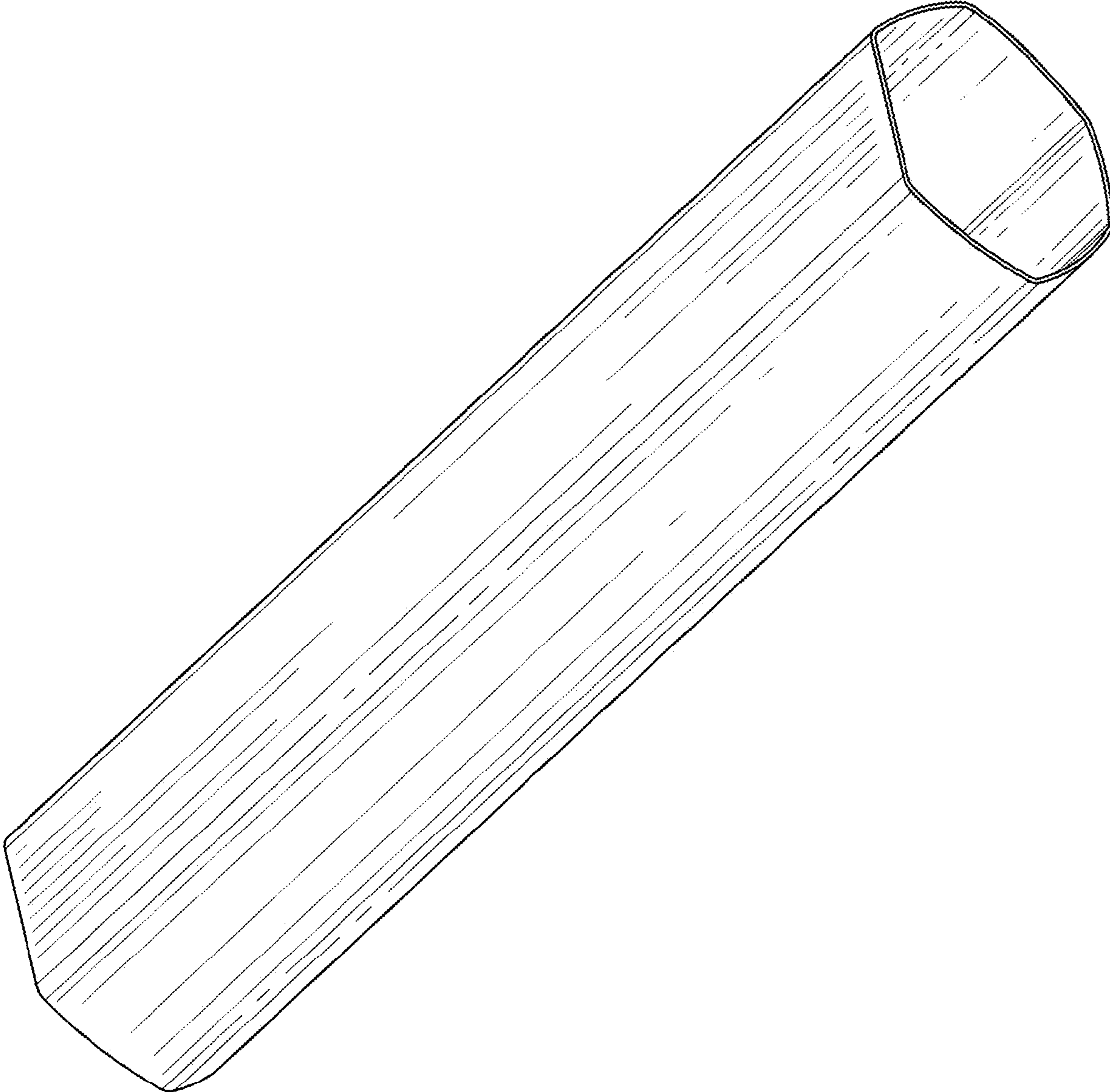

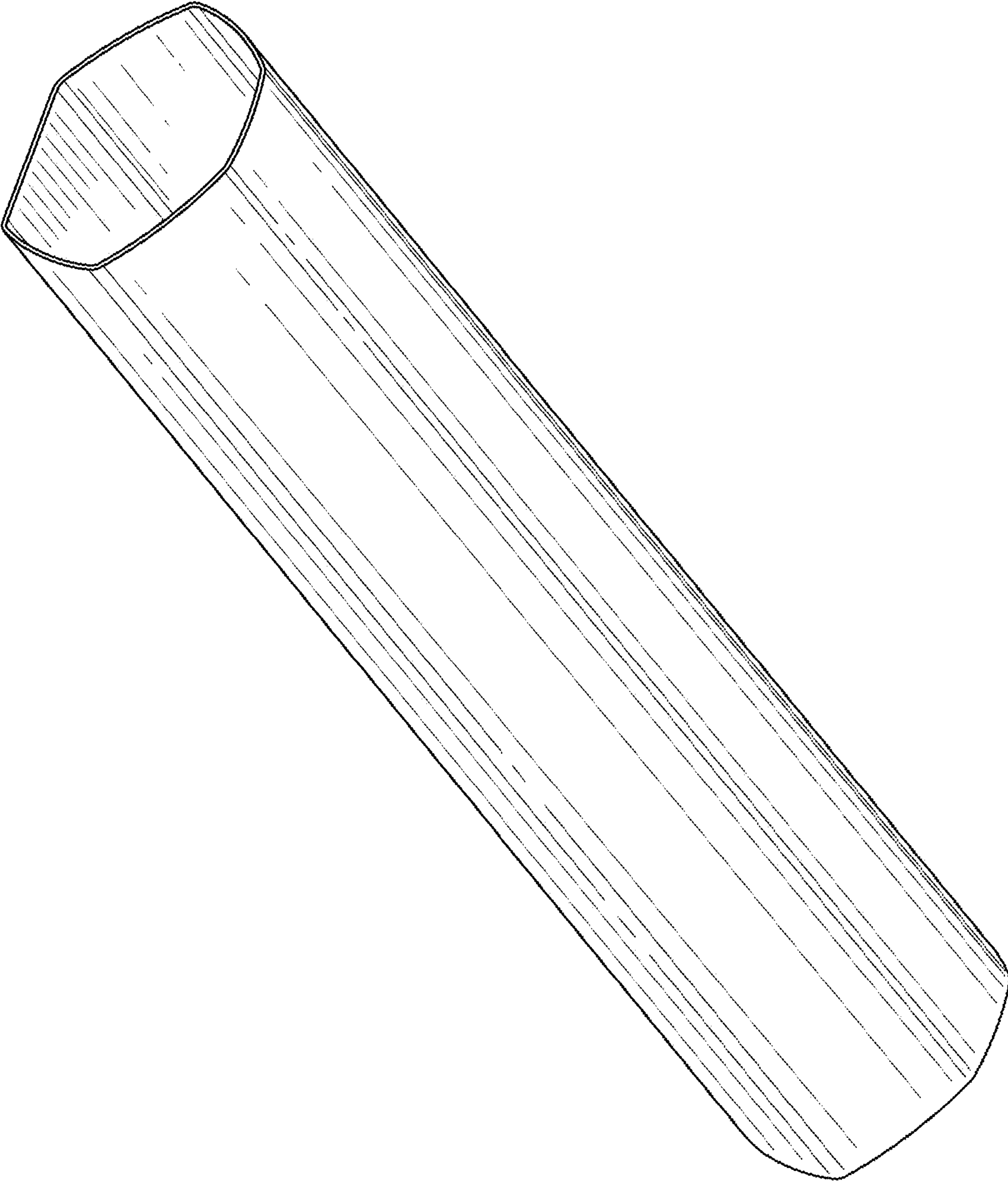

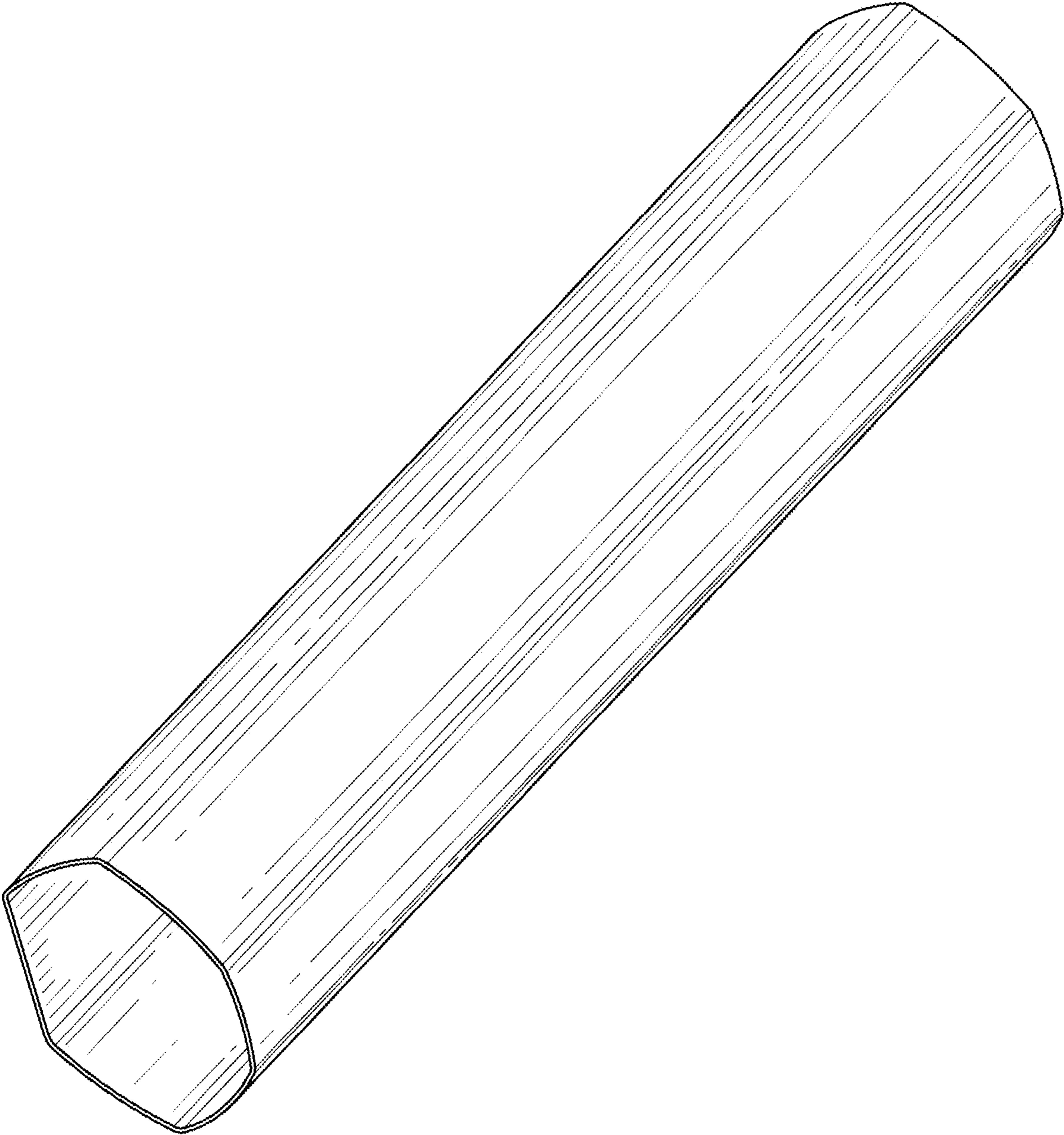
