DESCRIPTION

Figure 2.4 is a bottom plan view of the lamp of Figure 2.1;

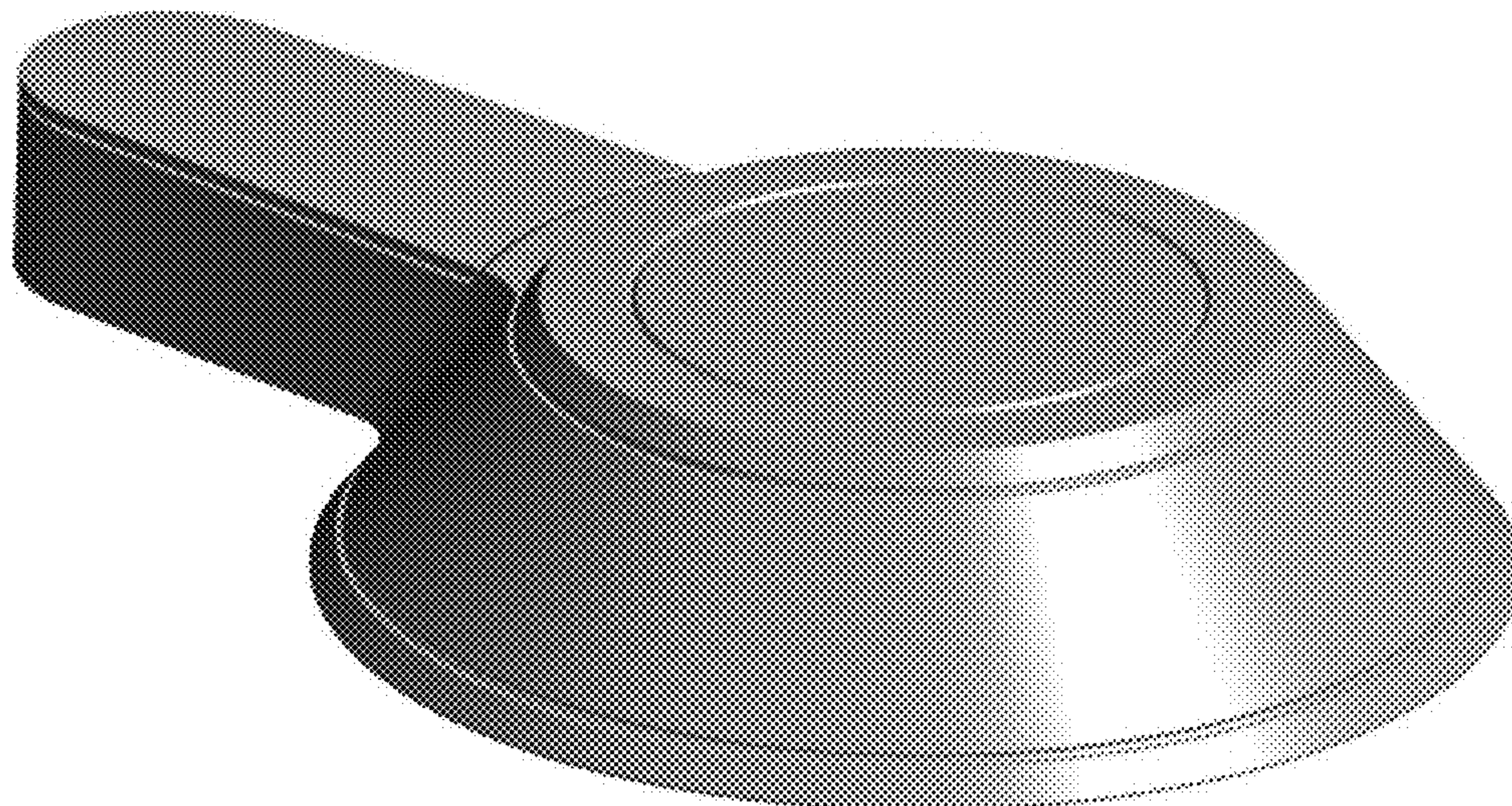
Figure 2.5 is a right side view of the lamp of Figure 2.1;

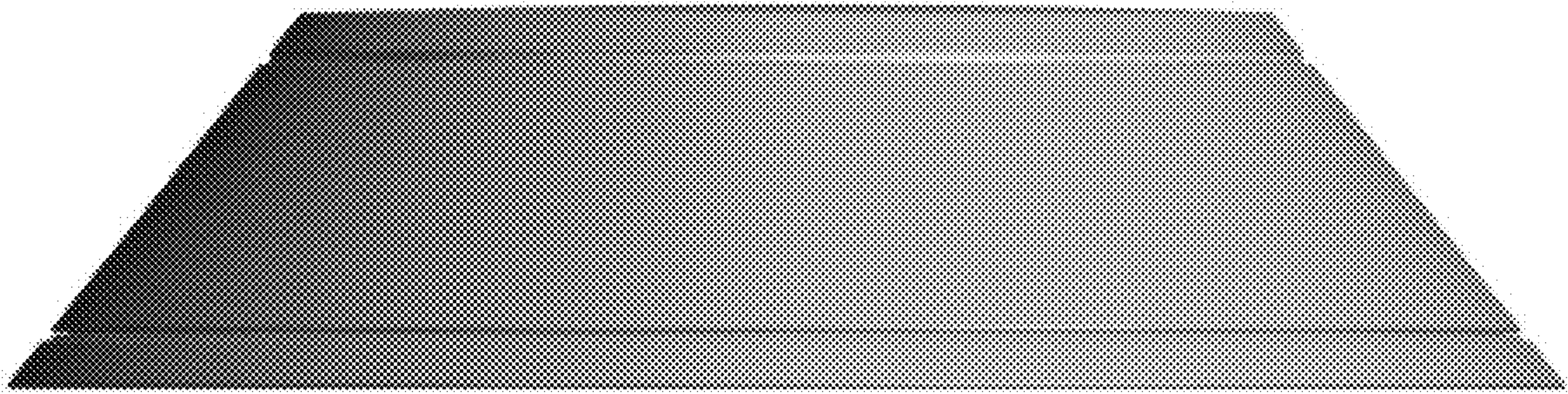

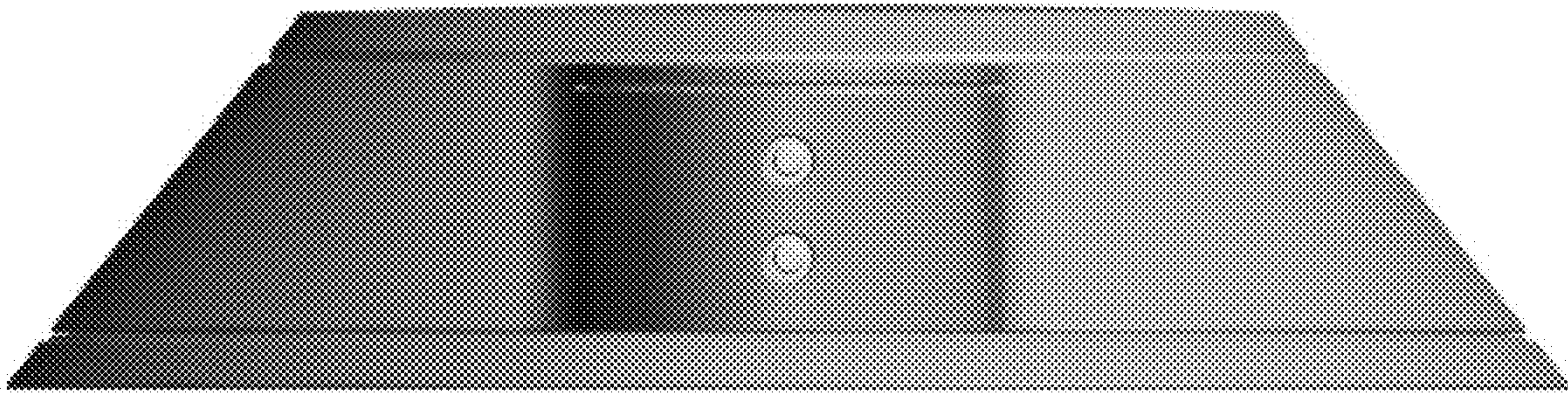

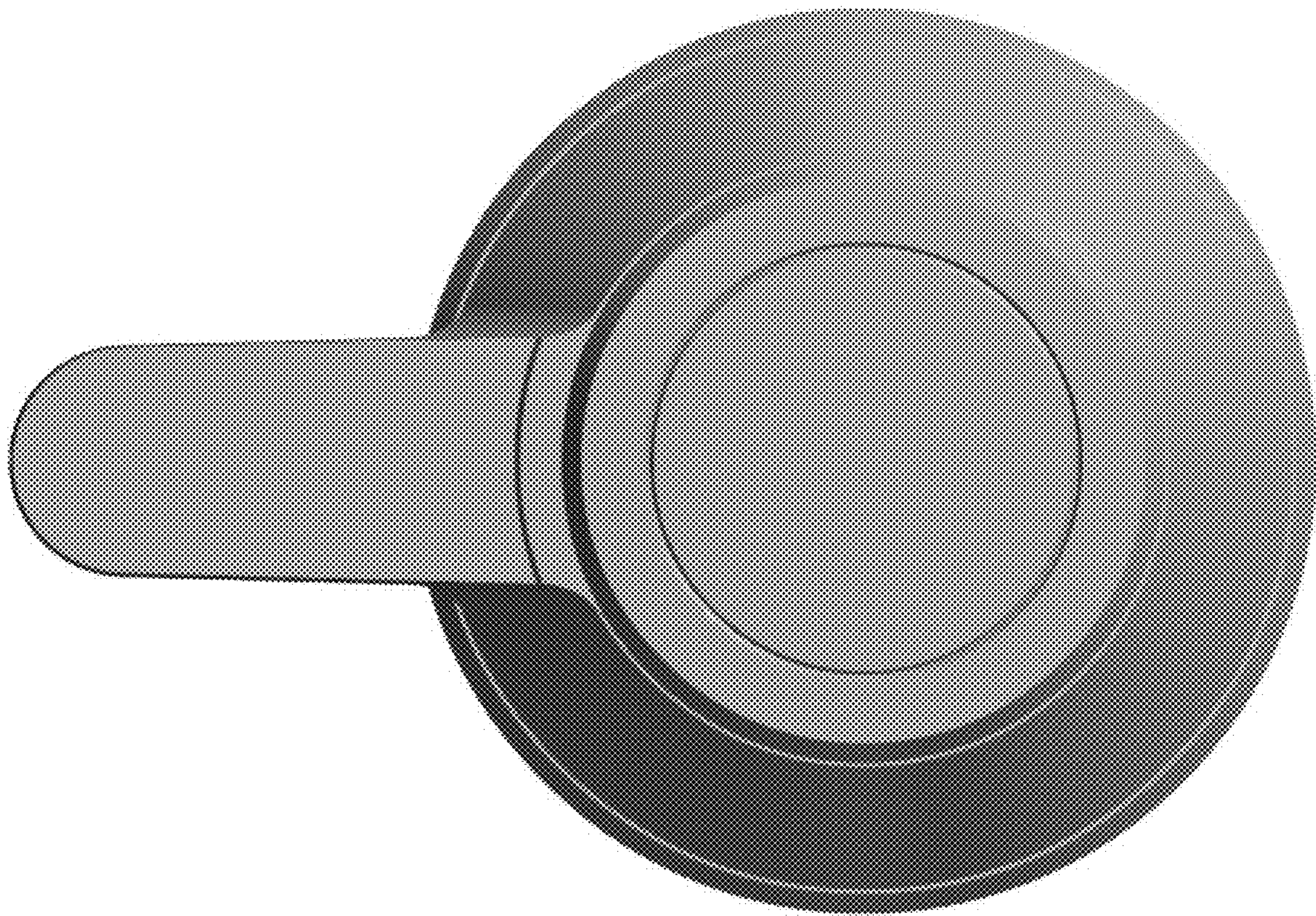

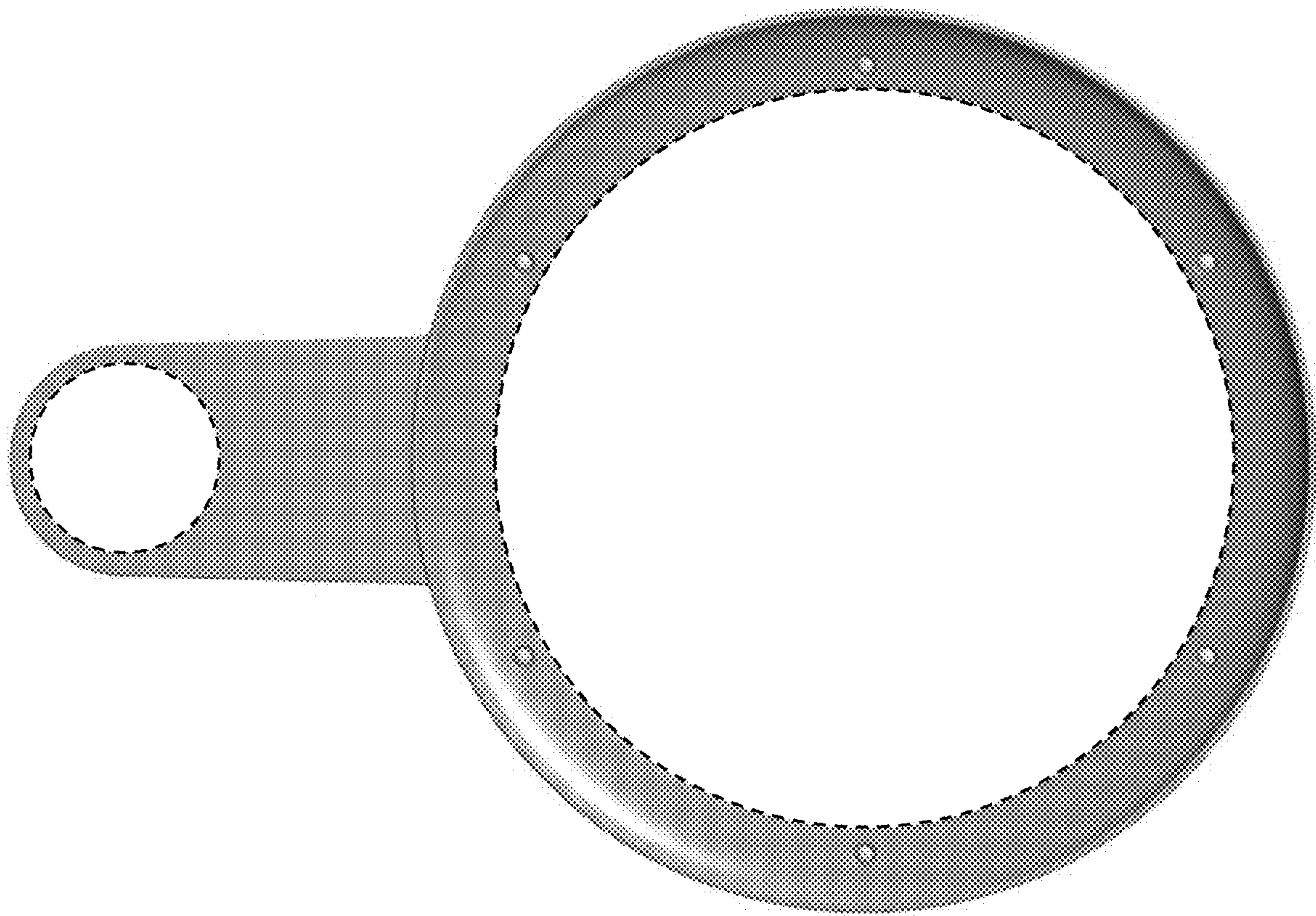

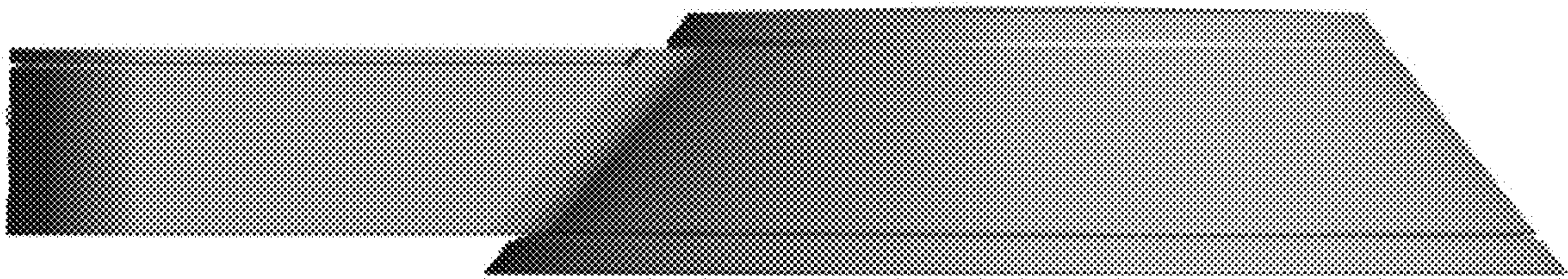

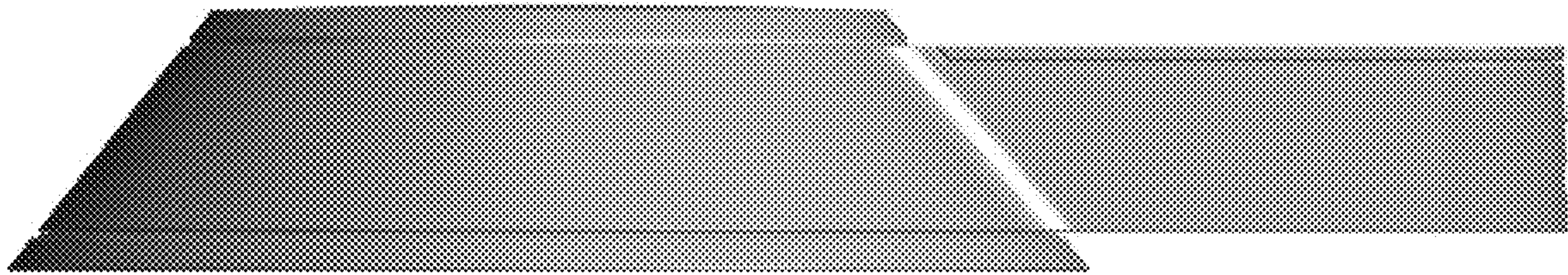

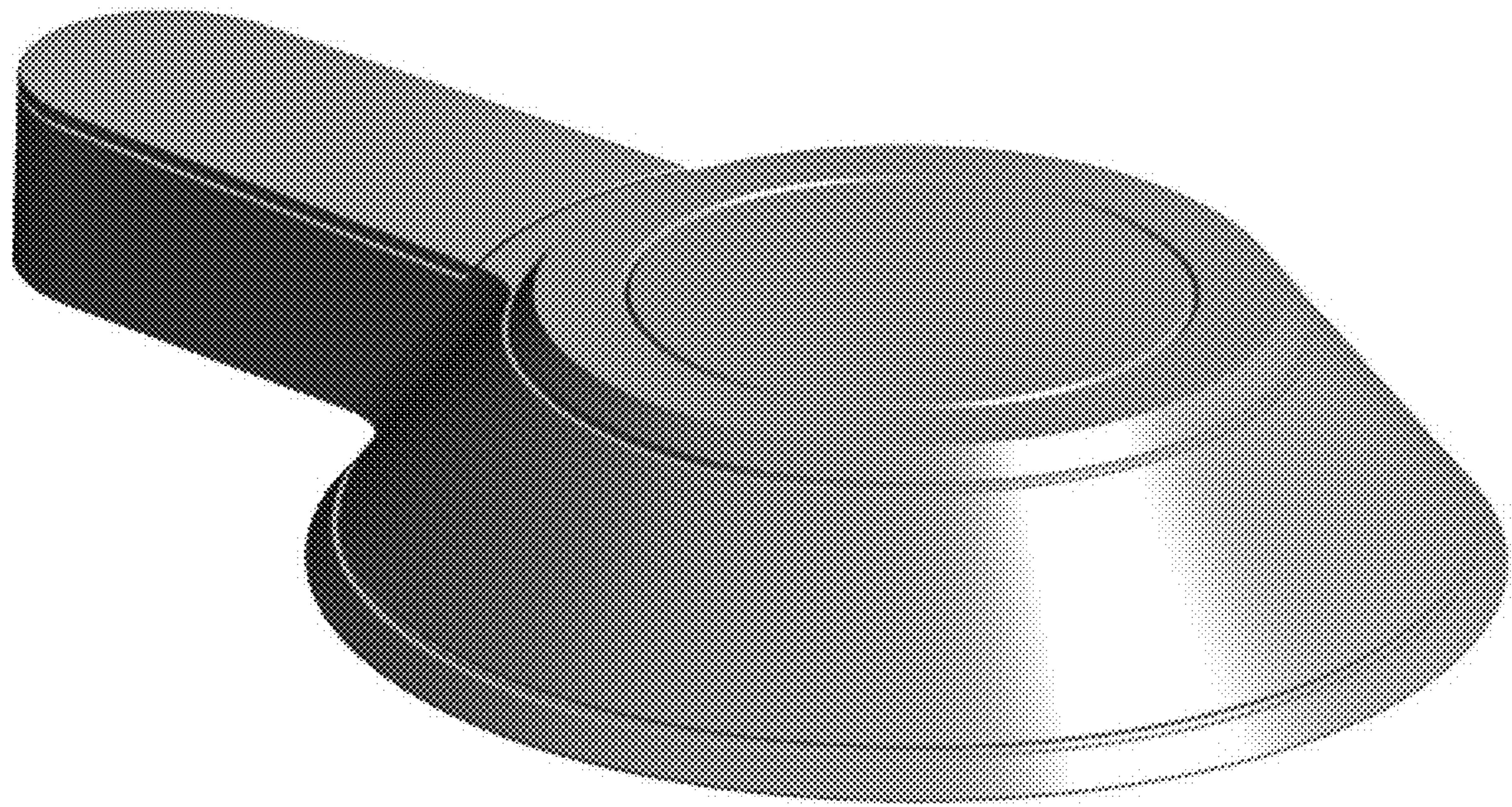

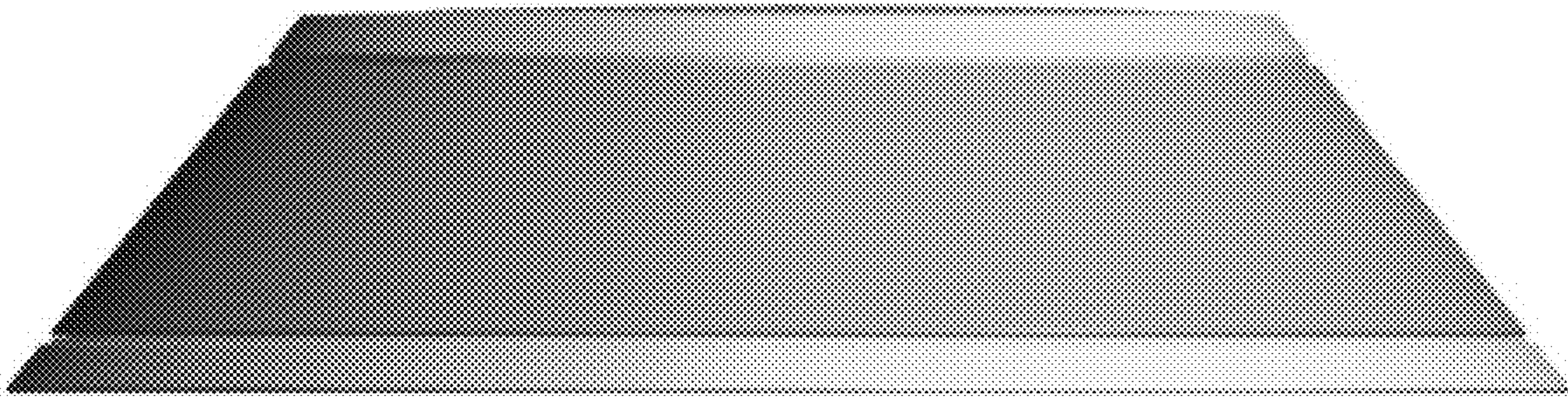

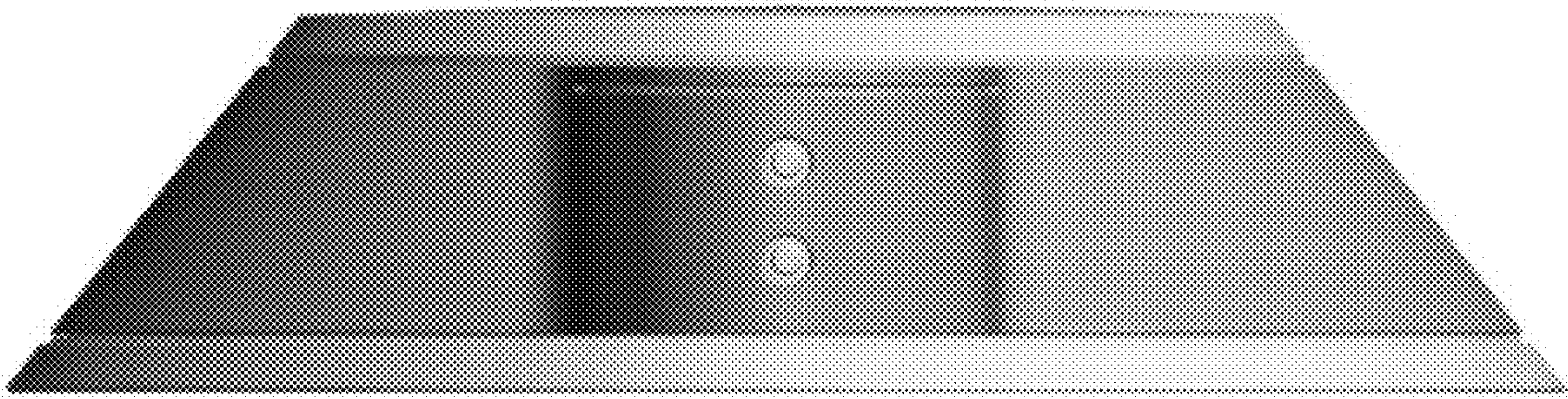

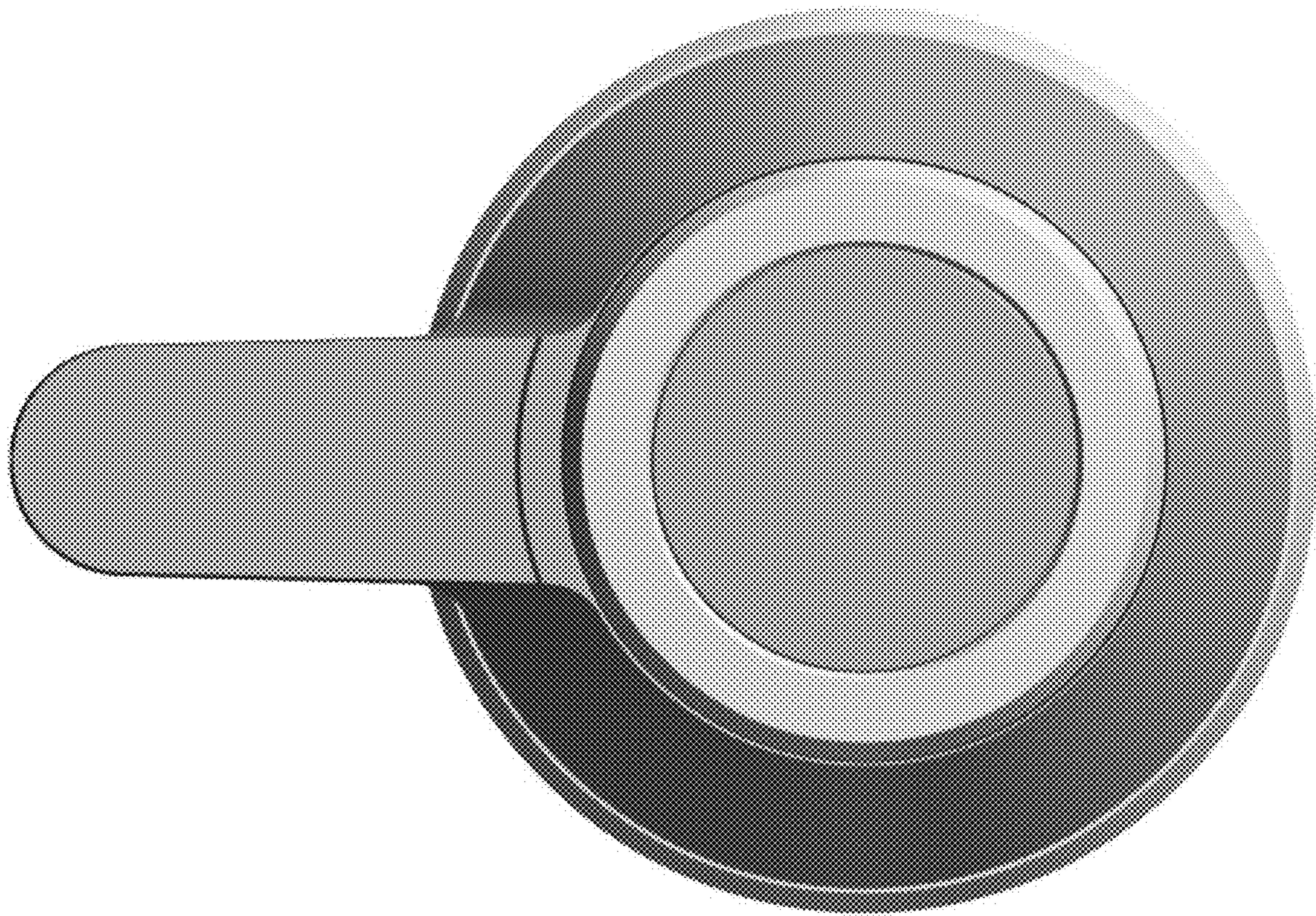

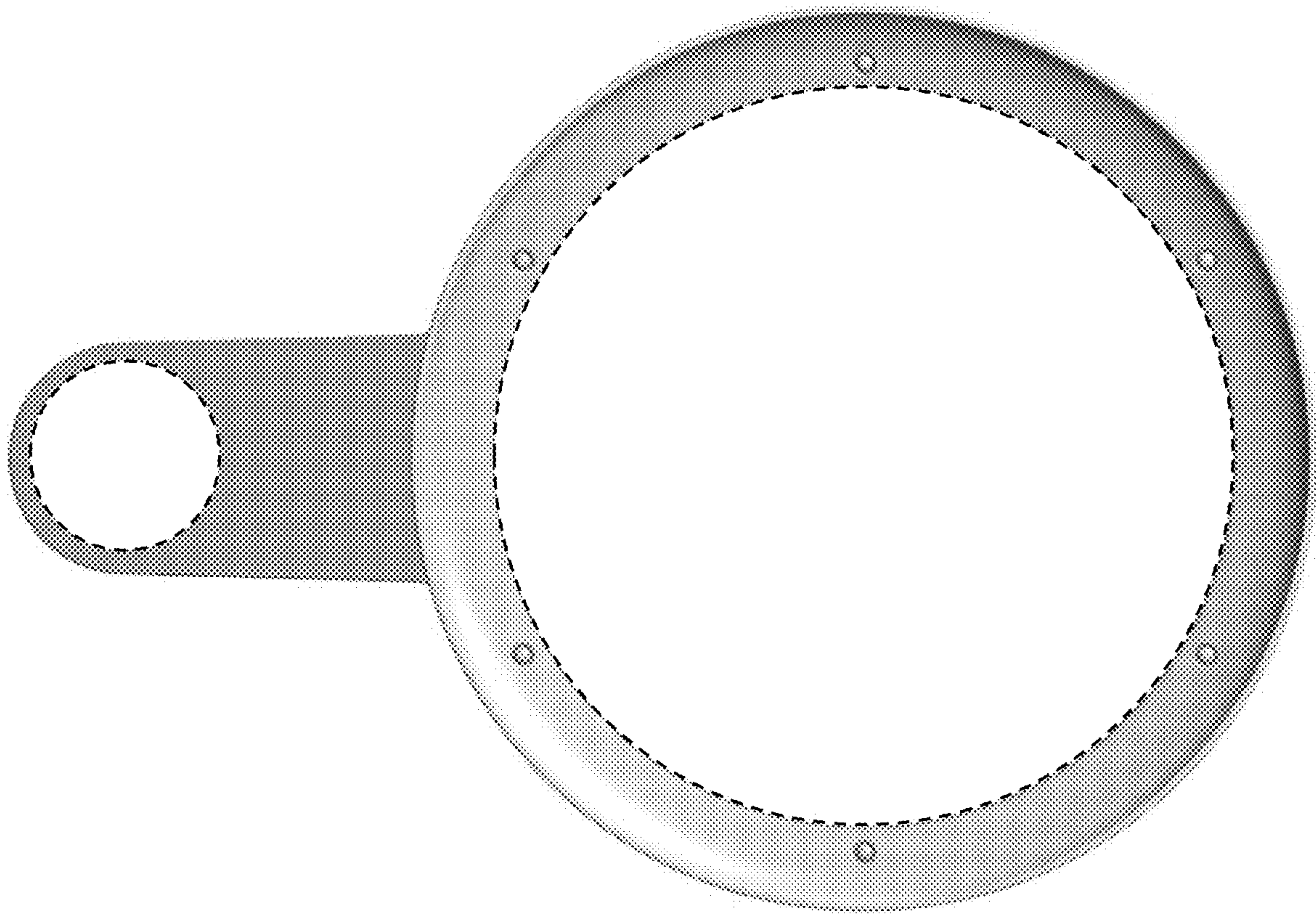

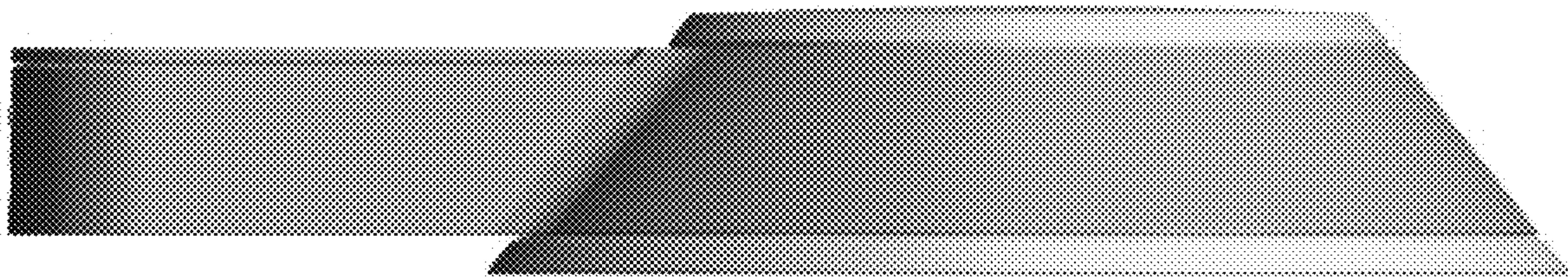

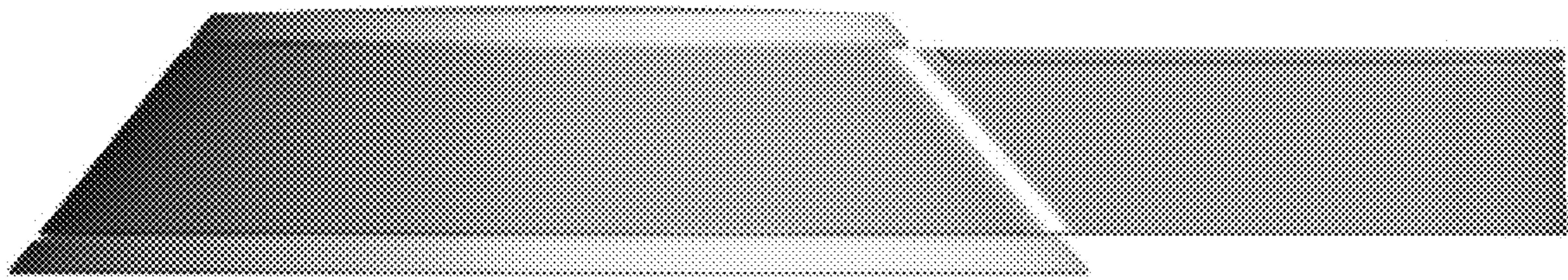

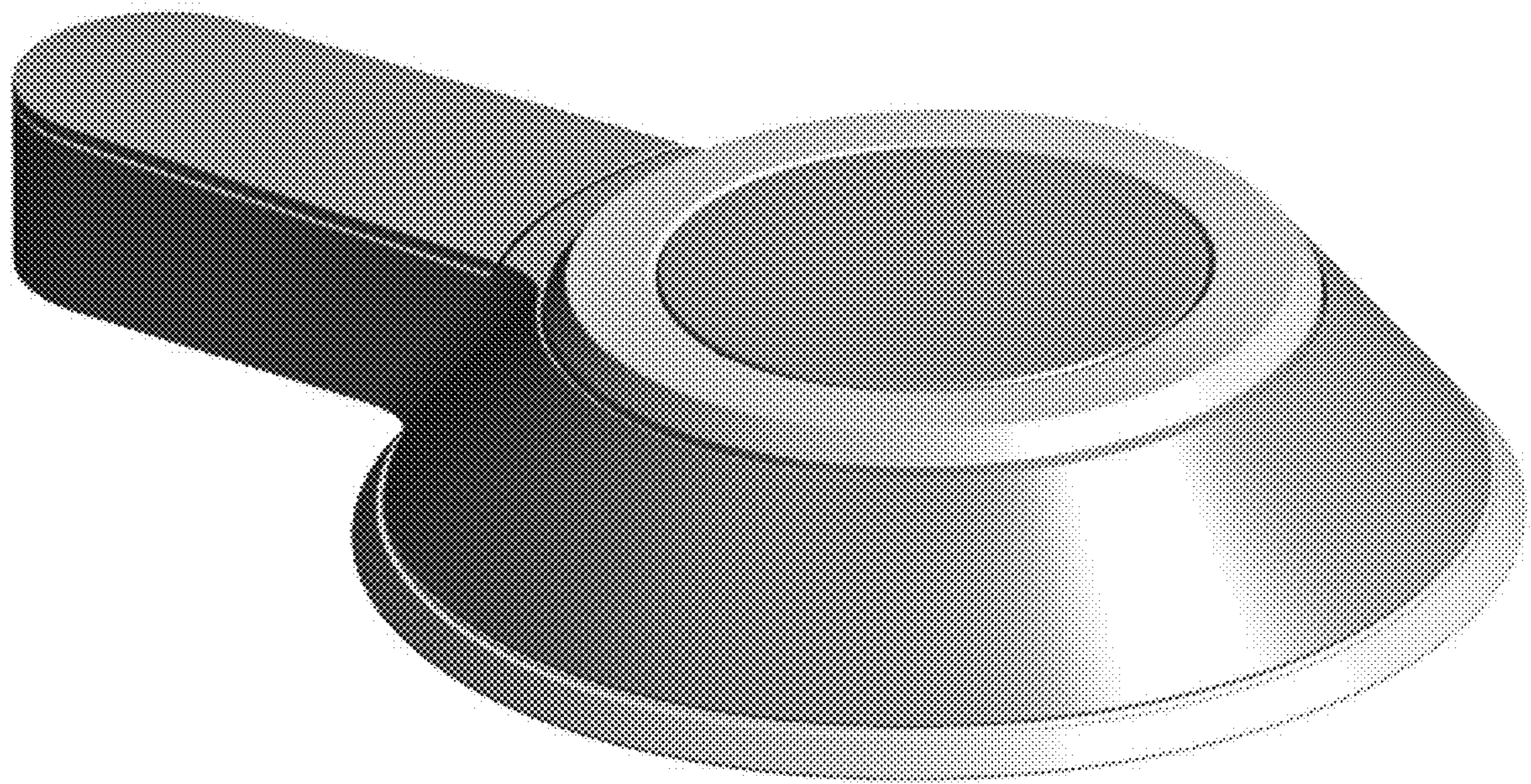
