(57) **CLAIM**

The ornamental design for a medical face guard, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a medical face guard showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top, front and right side perspective view thereof in a state that a transparent shield is removed from the state shown in FIG. 1;
 FIG. 8 is a front elevational view thereof in a state that a transparent shield is removed from the state shown in FIG. 2;
 FIG. 9 is a rear elevational view thereof in a state that a transparent shield is removed from the state shown in FIG. 3;
 FIG. 10 is a right side elevational view thereof in a state that a transparent shield is removed from the state shown in FIG. 6; and,
 FIG. 11 is a right side elevational view thereof in a state of being attached to the head.
 The broken lines showing the portions in FIG. 11 are for illustrative purposes only and form no part of the claimed design.

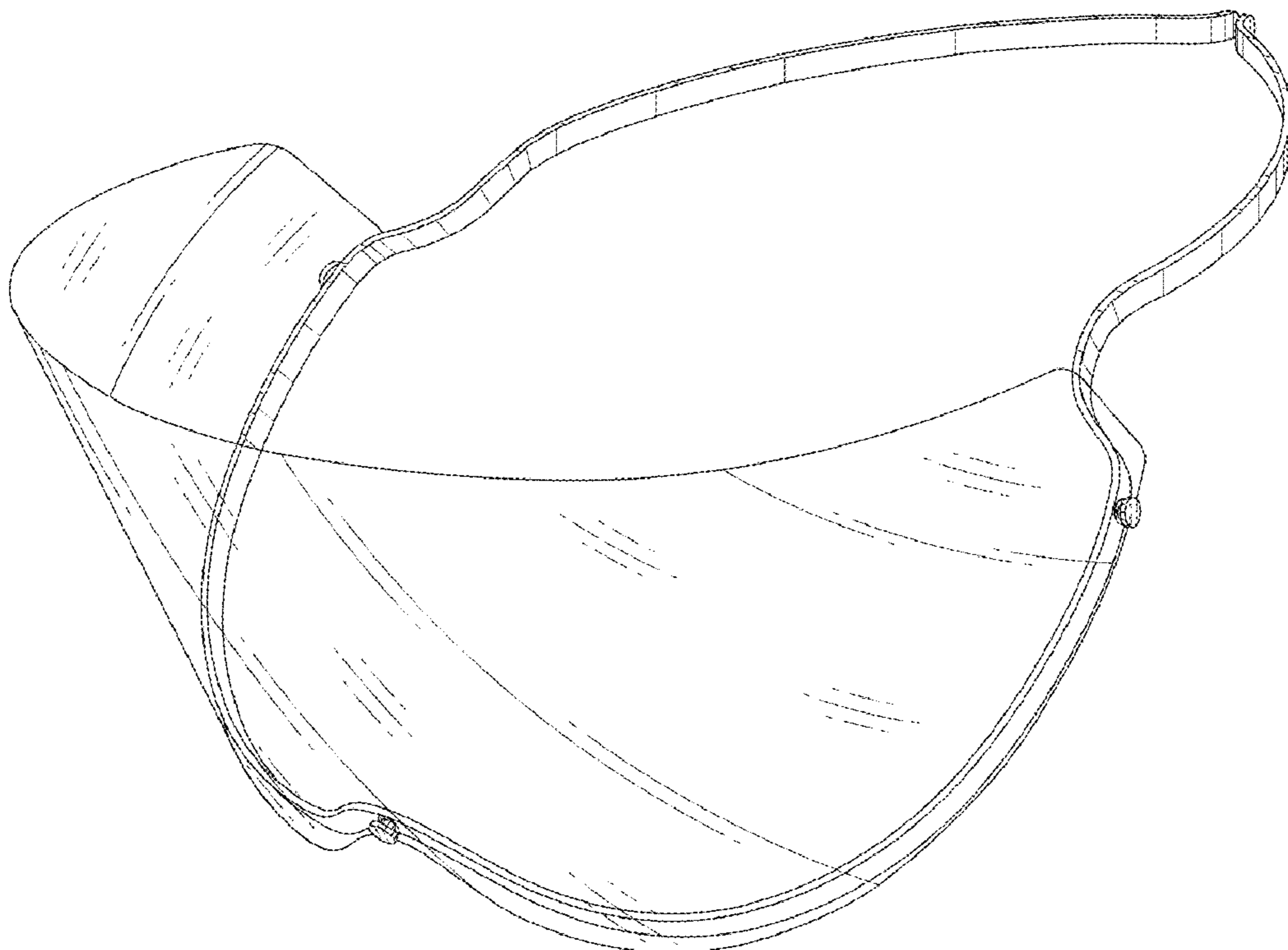

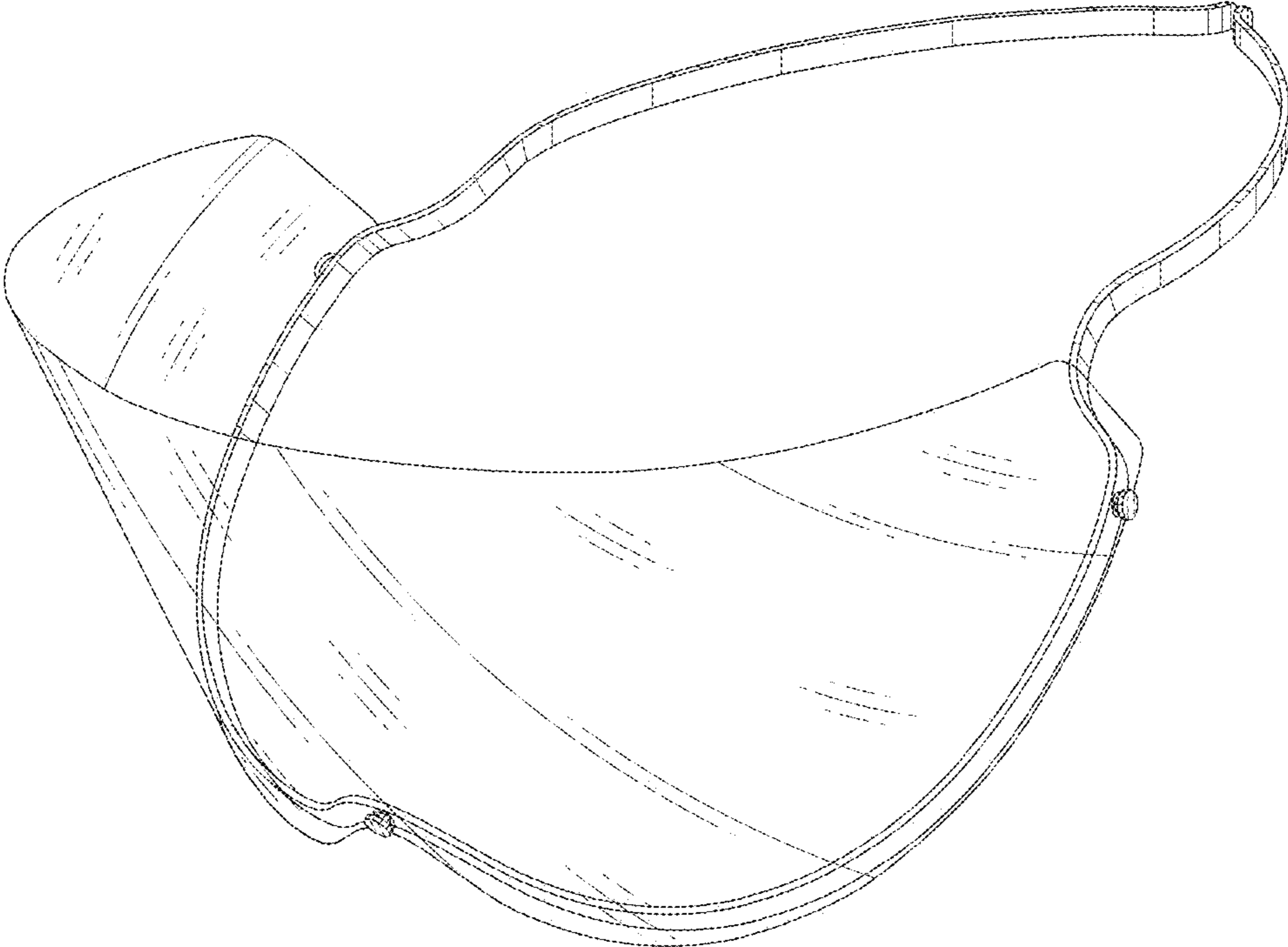

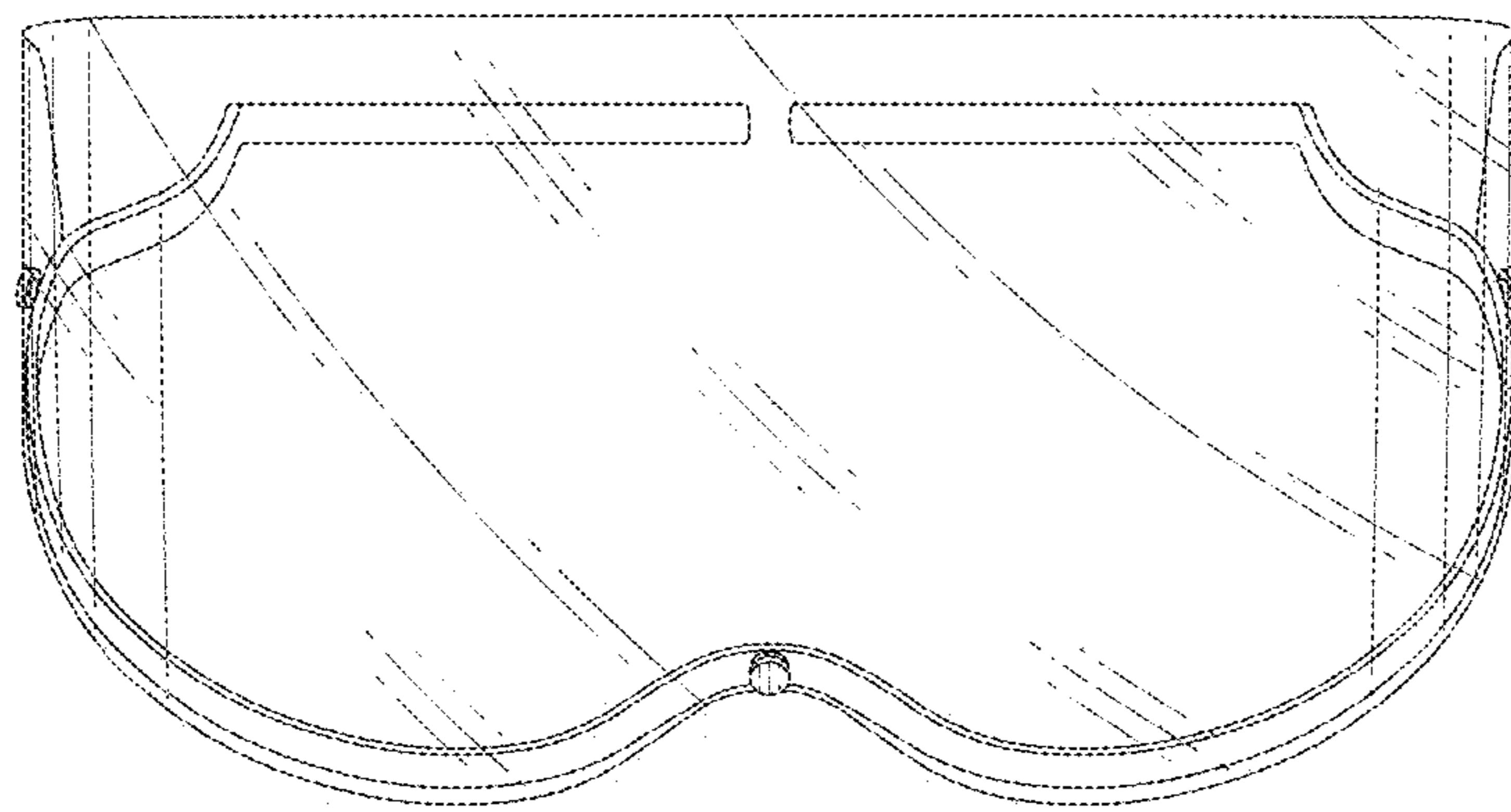

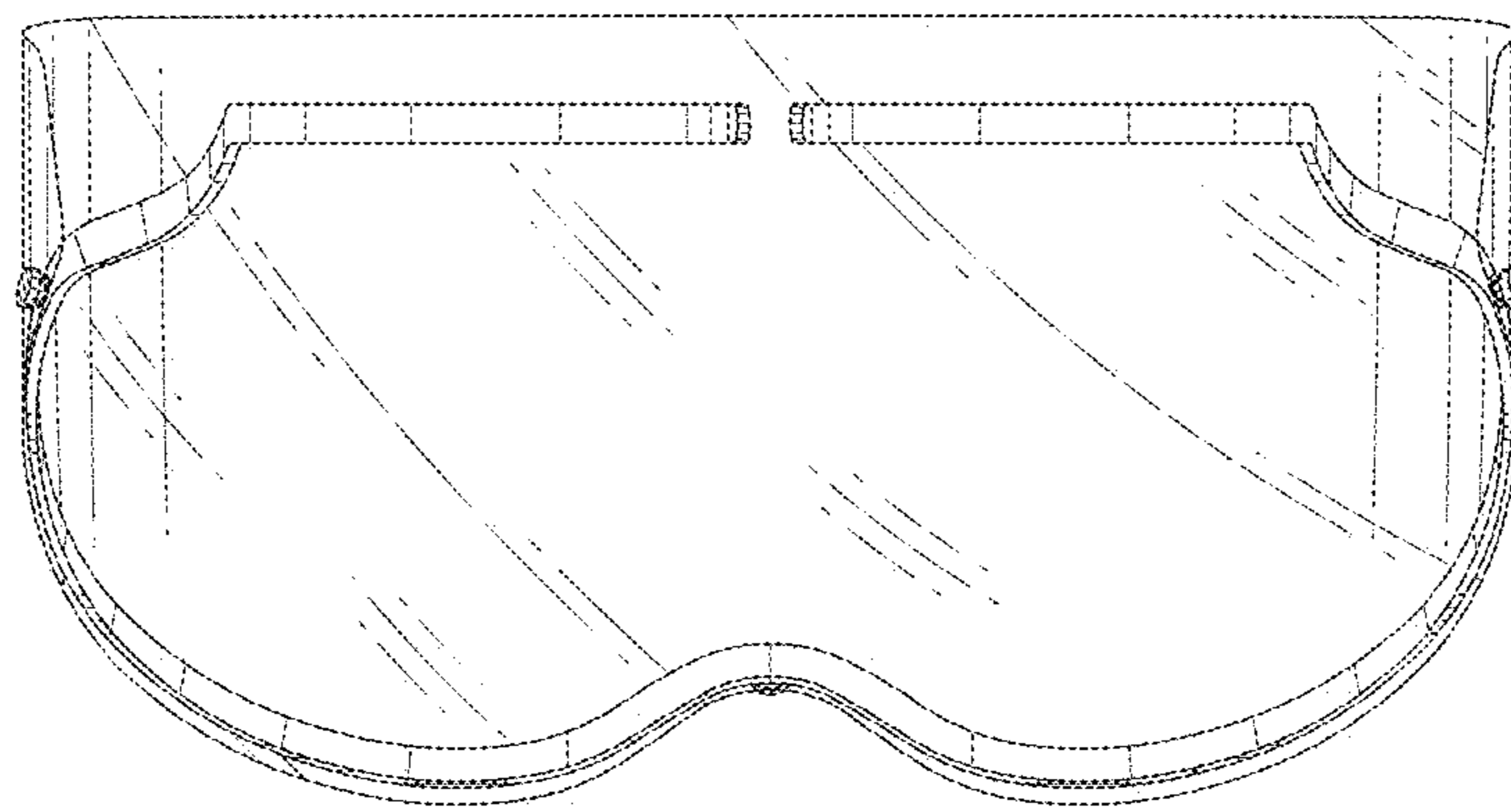

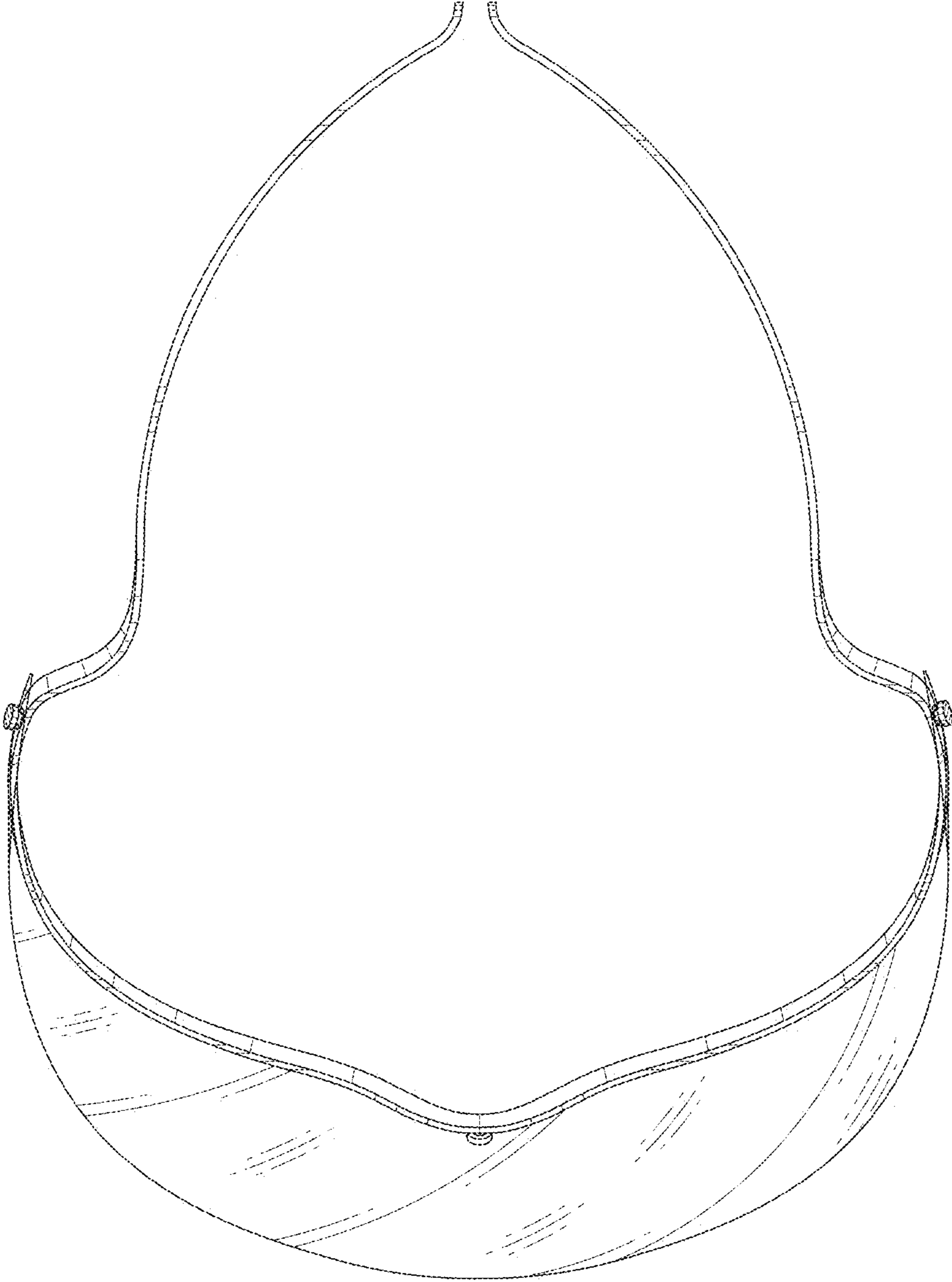

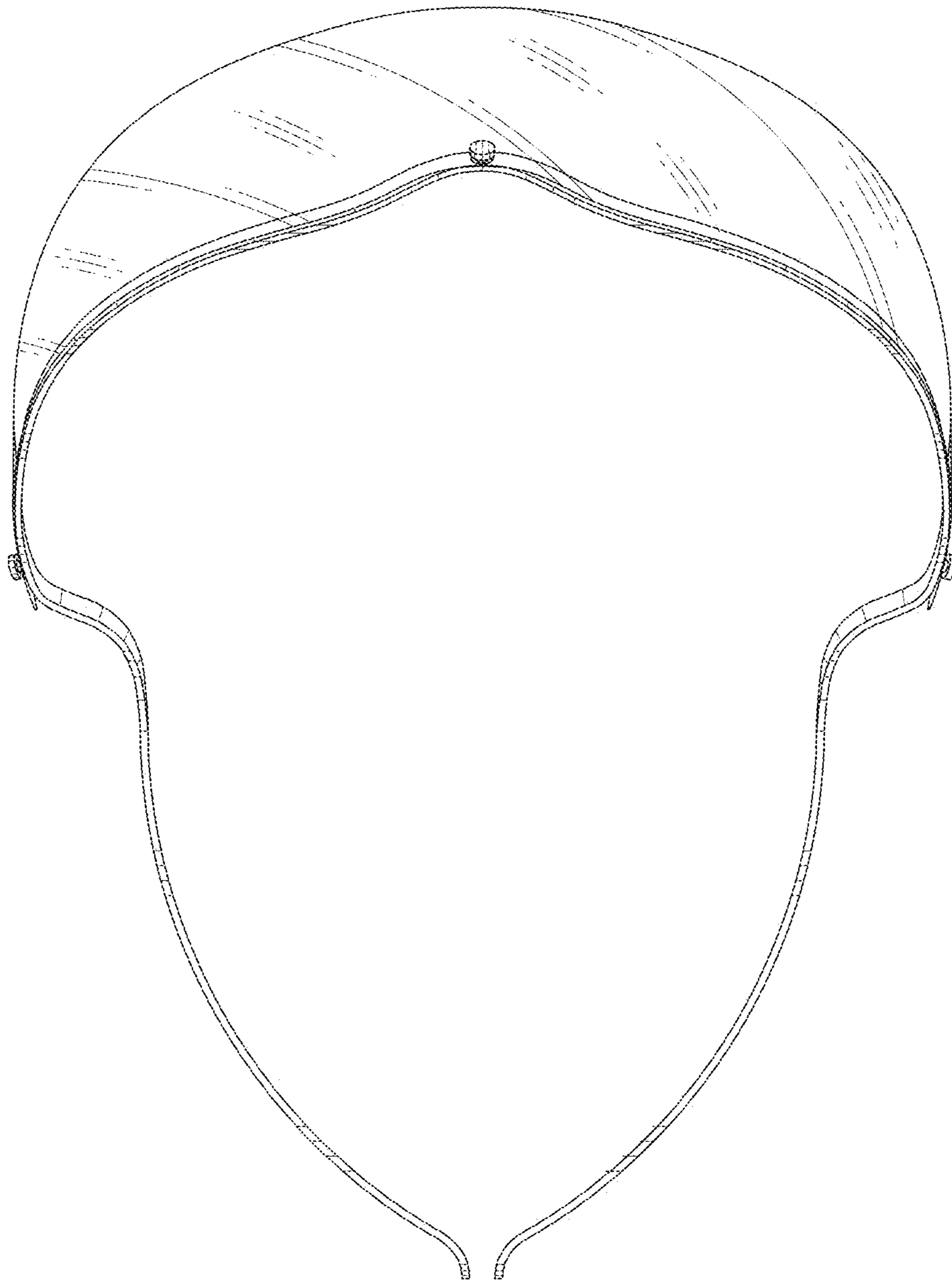

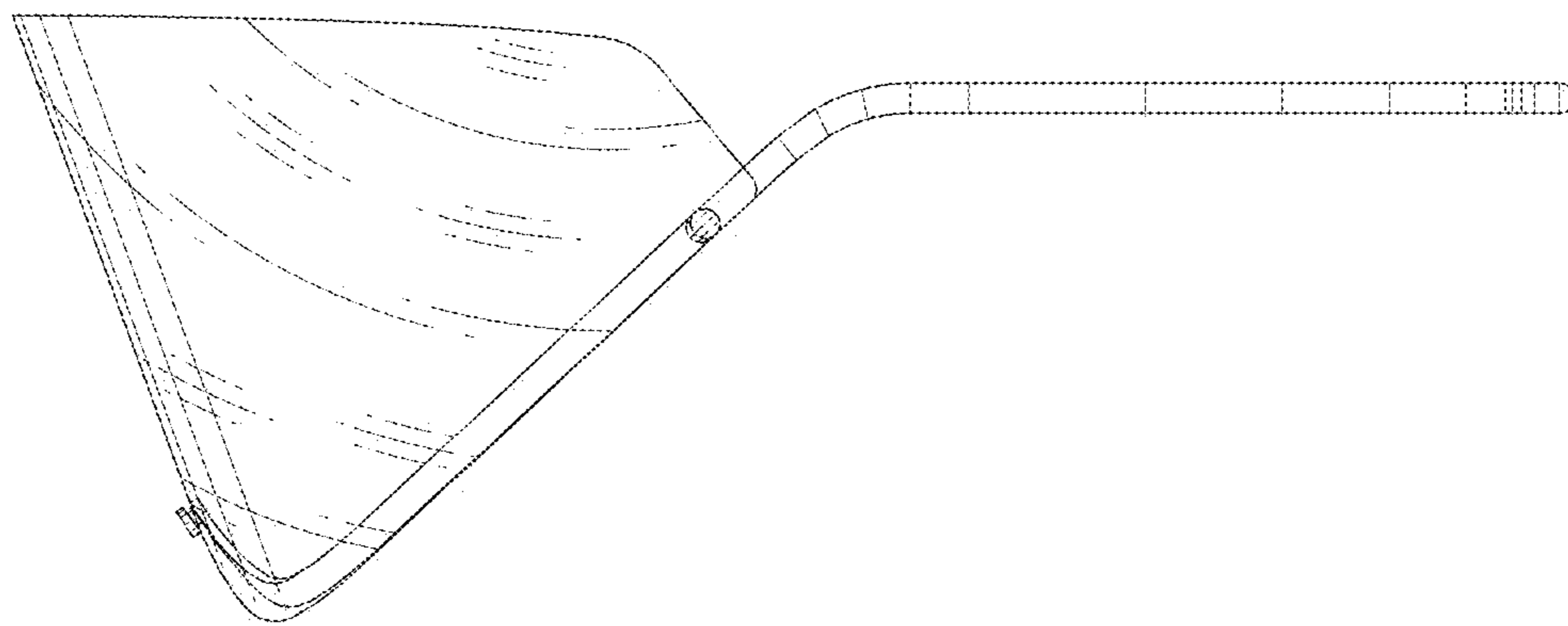

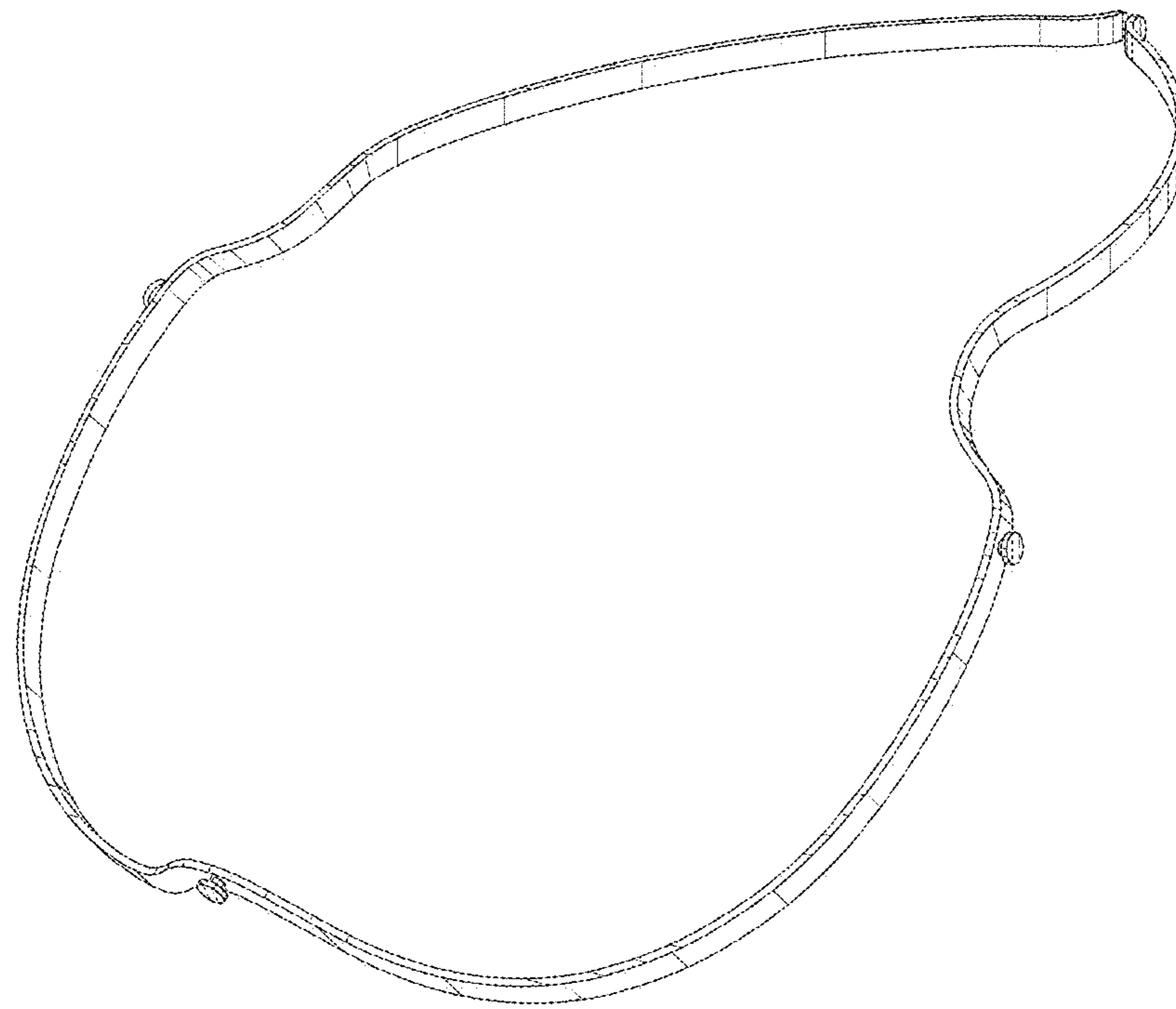

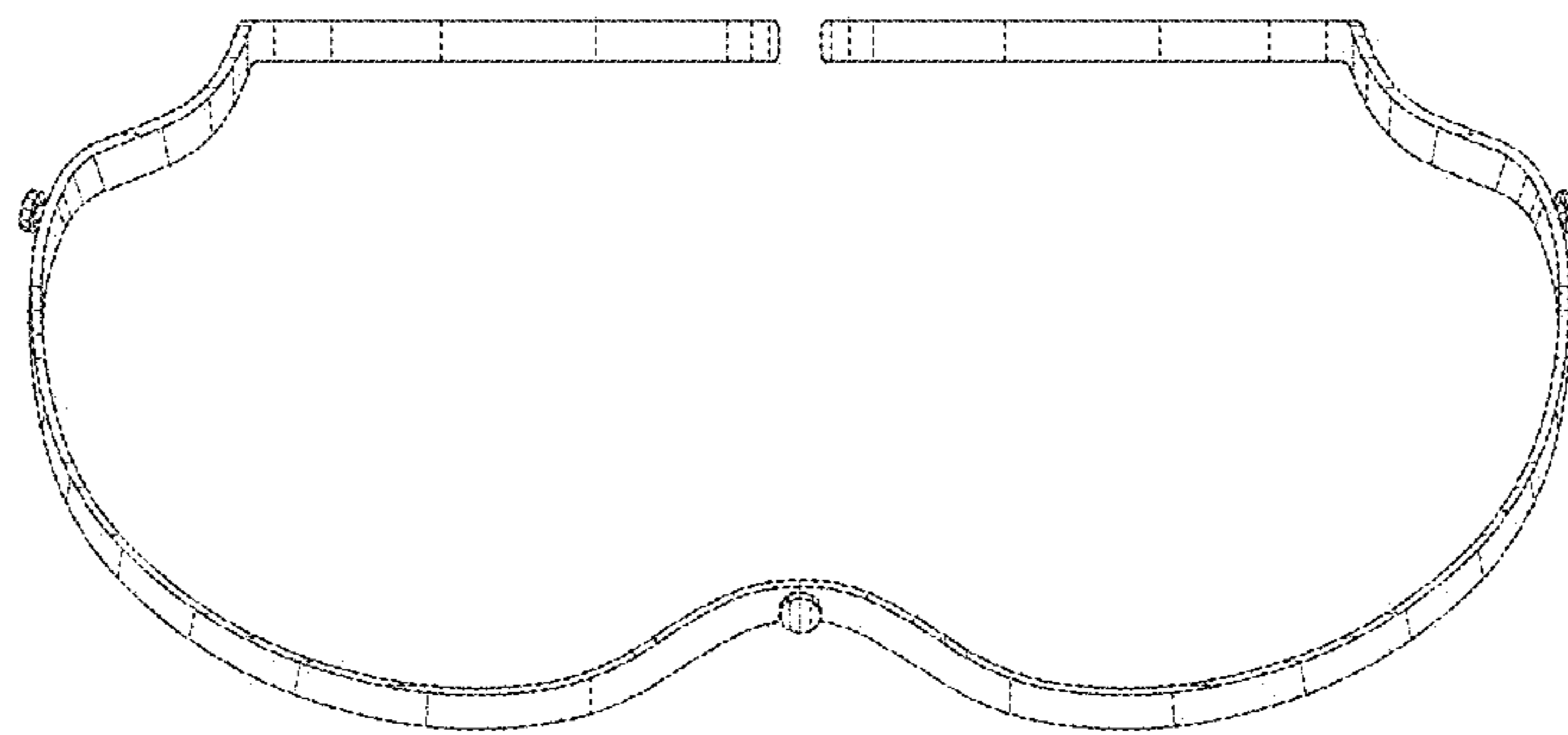

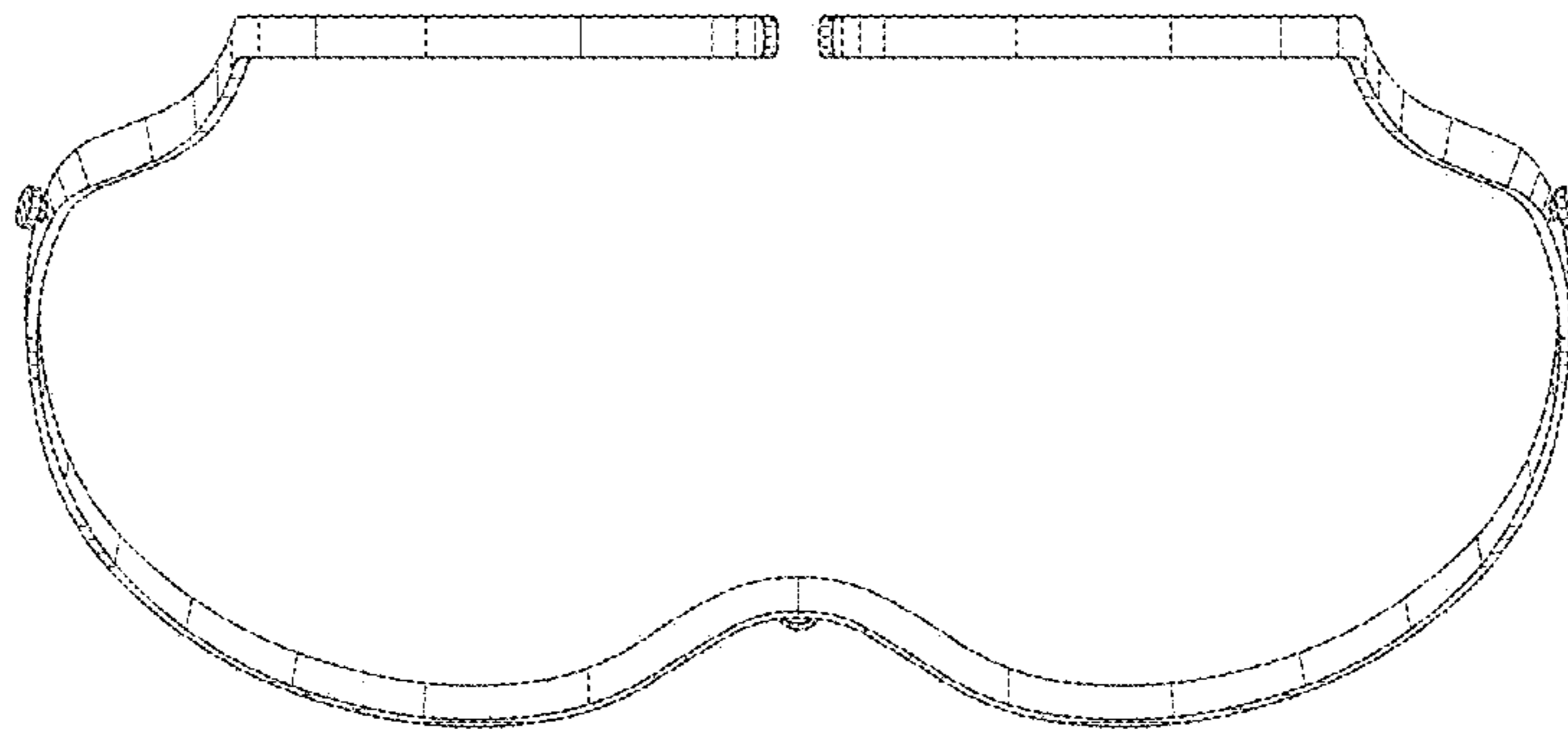

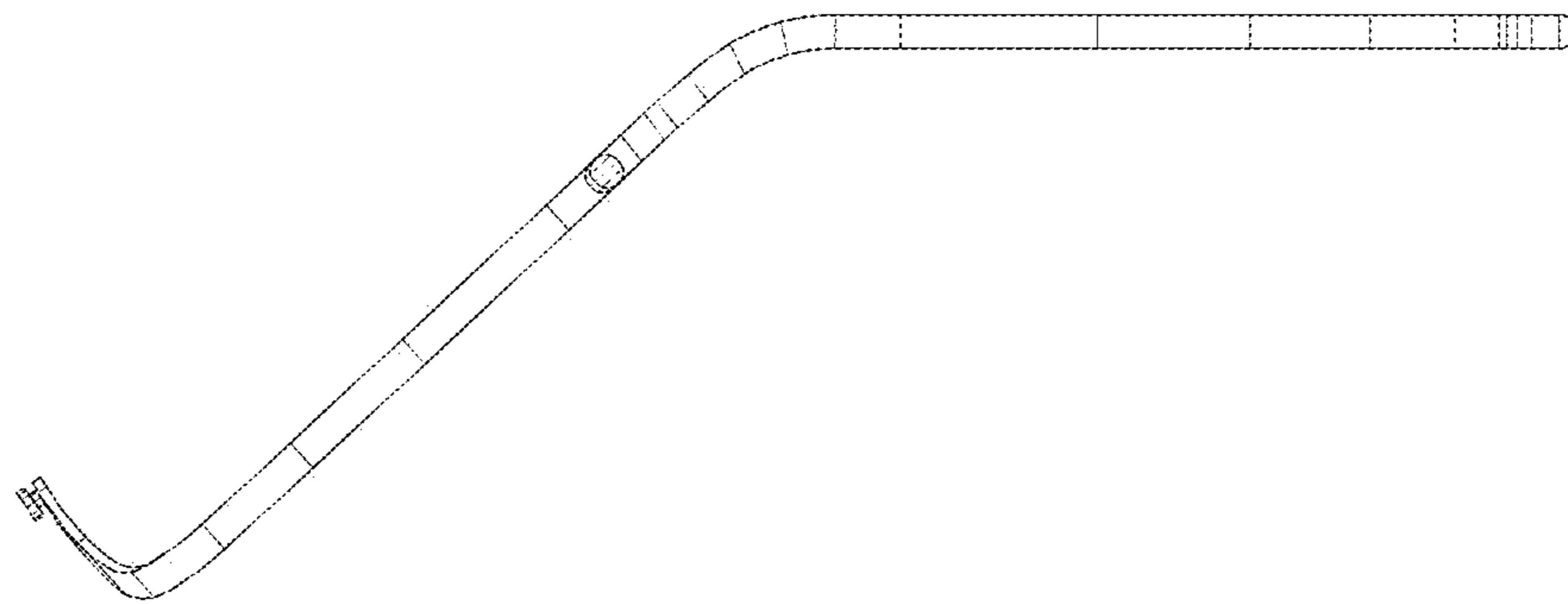
