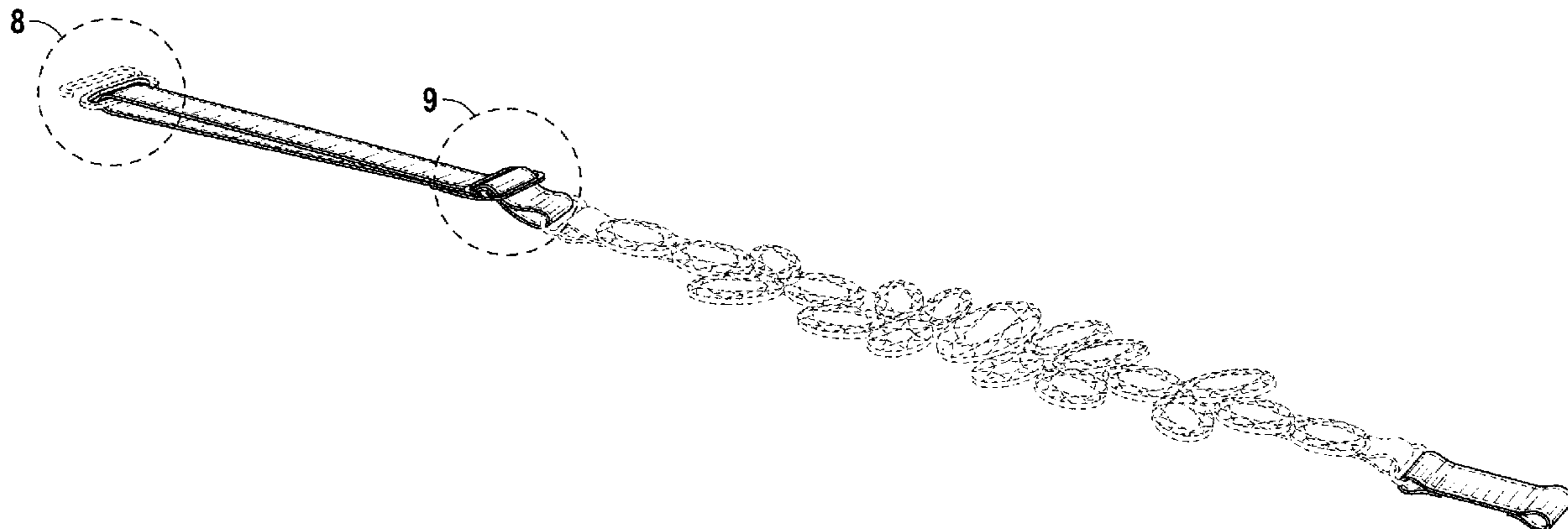
(57) **CLAIM**

The ornamental design for a garter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garter showing the claimed design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged detail view of the area 8 in FIG. 1; and,
FIG. 9 is an enlarged detail view of the area 9 in FIG. 1.
The dashed broken lines in the figures show portions of the garter that form no part of the claimed design. The dot-dash broken lines in the figures show boundaries that form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation.

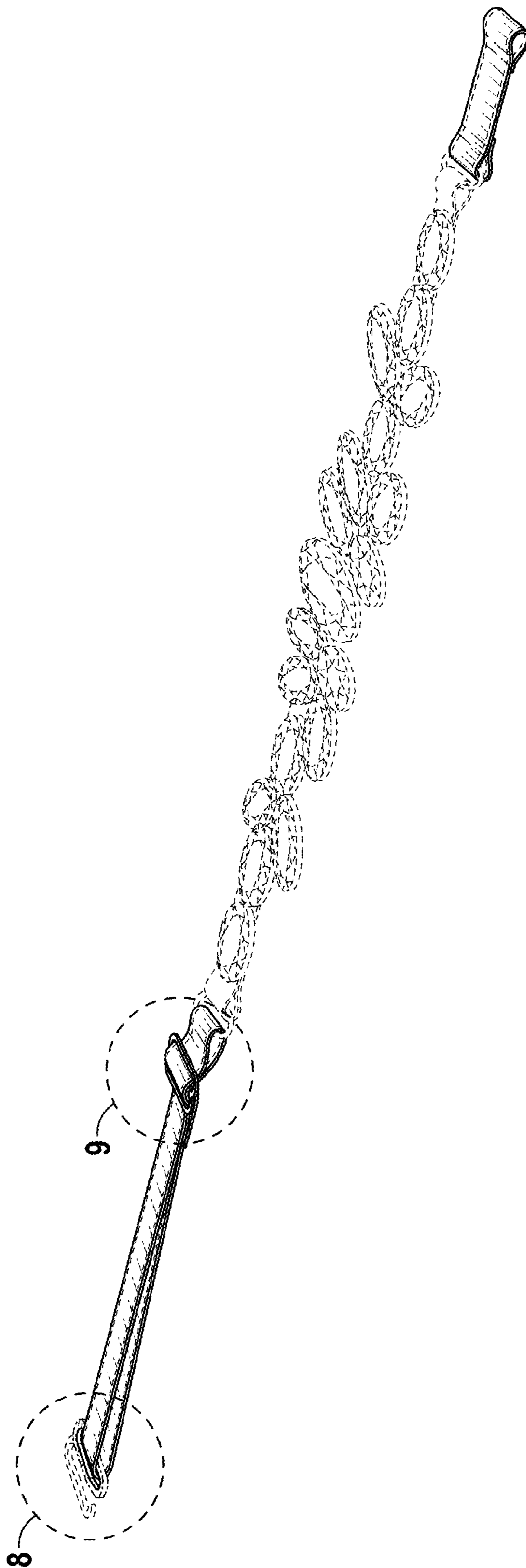

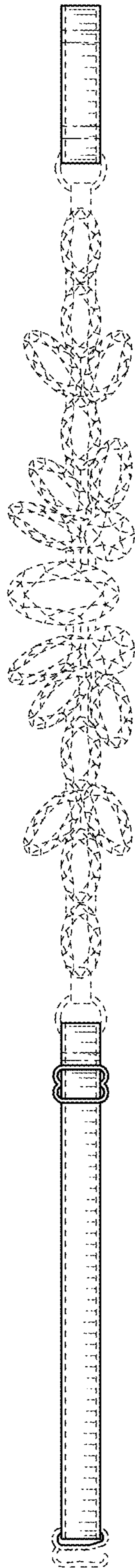

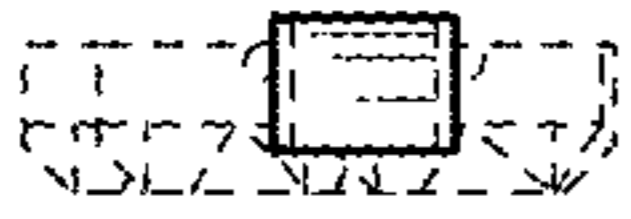

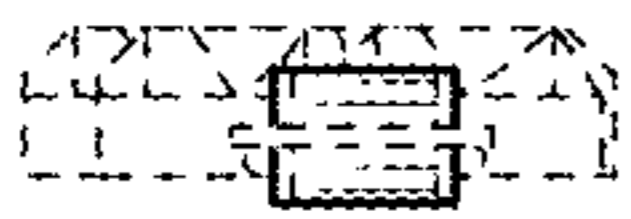

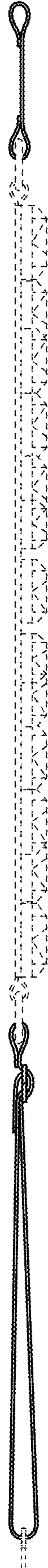

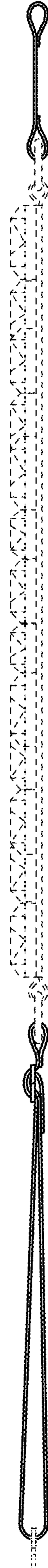

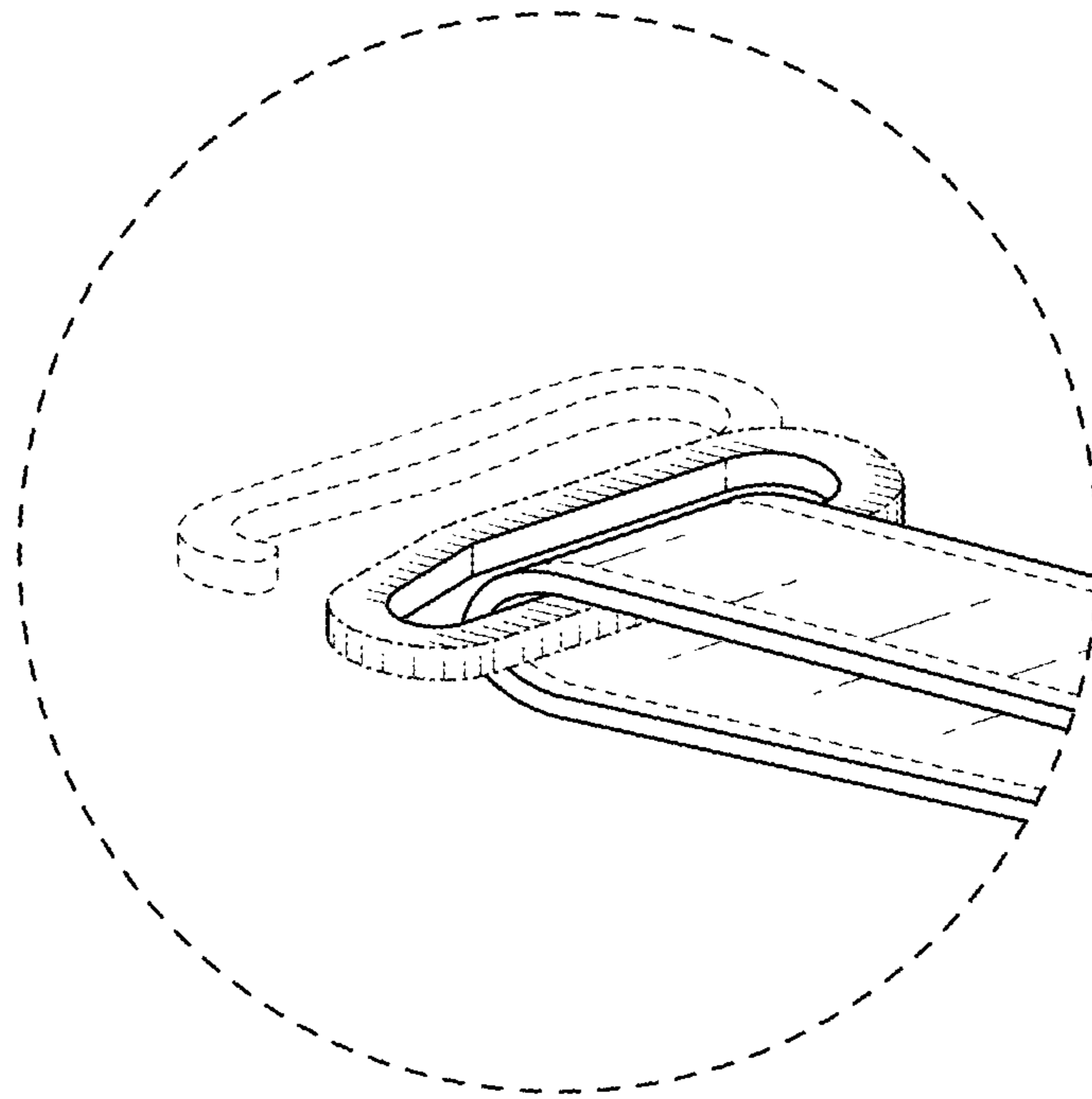

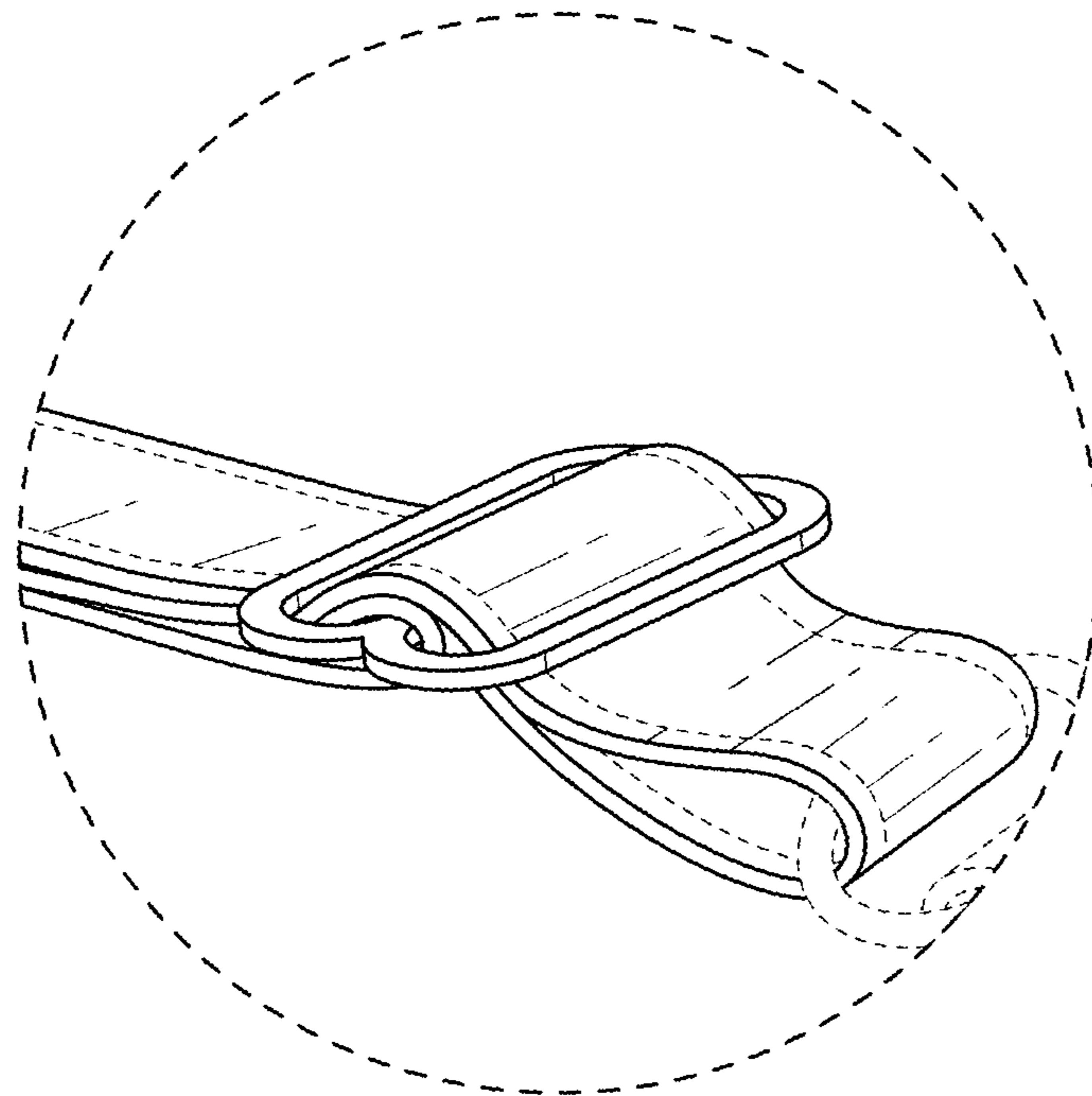
