(57) **CLAIM**

The ornamental design for a combination scarf and vest, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a combination scarf and vest according to the present invention.

FIG. 2 is a back view of the combination scarf and vest of FIG. 1.

FIG. 3 is a first right side view of the combination scarf and vest of FIG. 1. The combination scarf and vest of FIG. 1 also has a first left side view, not illustrated, which is a mirror image of the right side.

FIG. 4 is a second right side view of the combination scarf and vest of FIG. 1. The combination scarf and vest of FIG. 1 also has a second left side view, not illustrated, which is a mirror image of the alternative right side view.

FIG. 5 is an exploded, deconstructed and flat view of the combination scarf and vest of FIG. 1.

FIG. 6 is a top view of the combination scarf and vest of FIG. 1, shown separate from the person.

FIG. 7 is a top view of the combination scarf and vest of FIG. 1, shown worn on a person; and,

FIG. 8 is a bottom view of the combination scarf and vest of FIG. 6.

The broken line showing of the person depicts environment and forms no part of the claimed design.

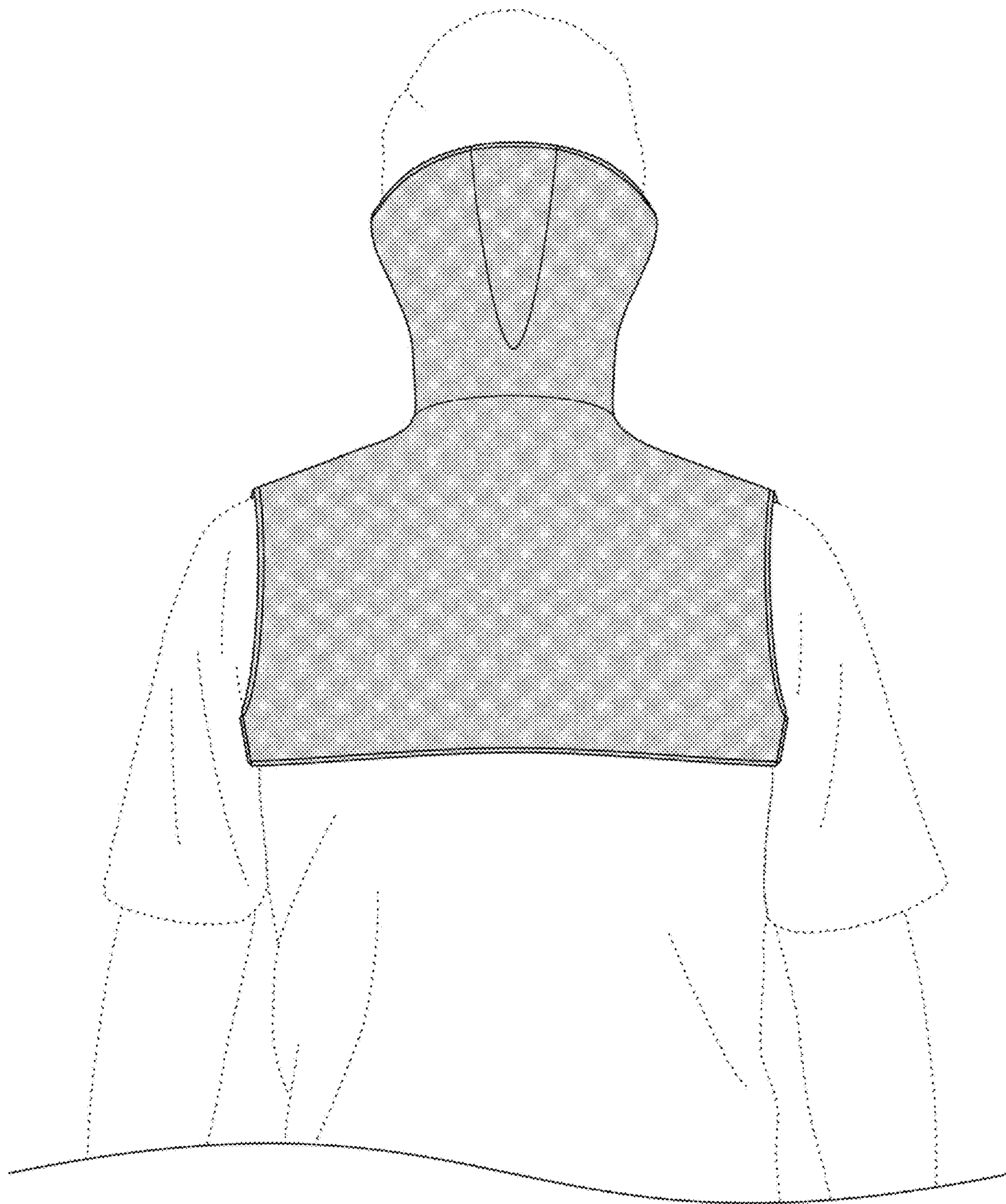

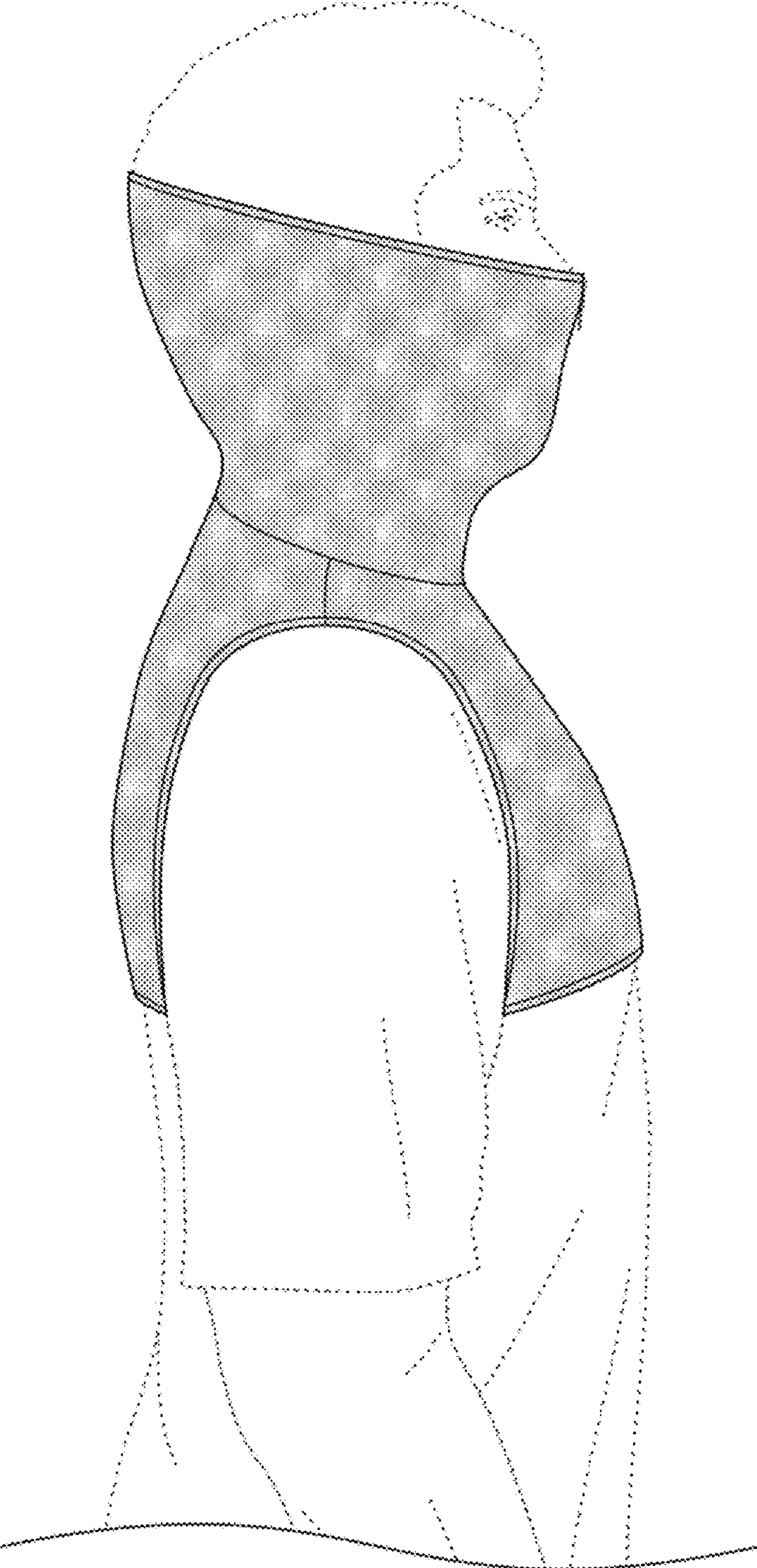

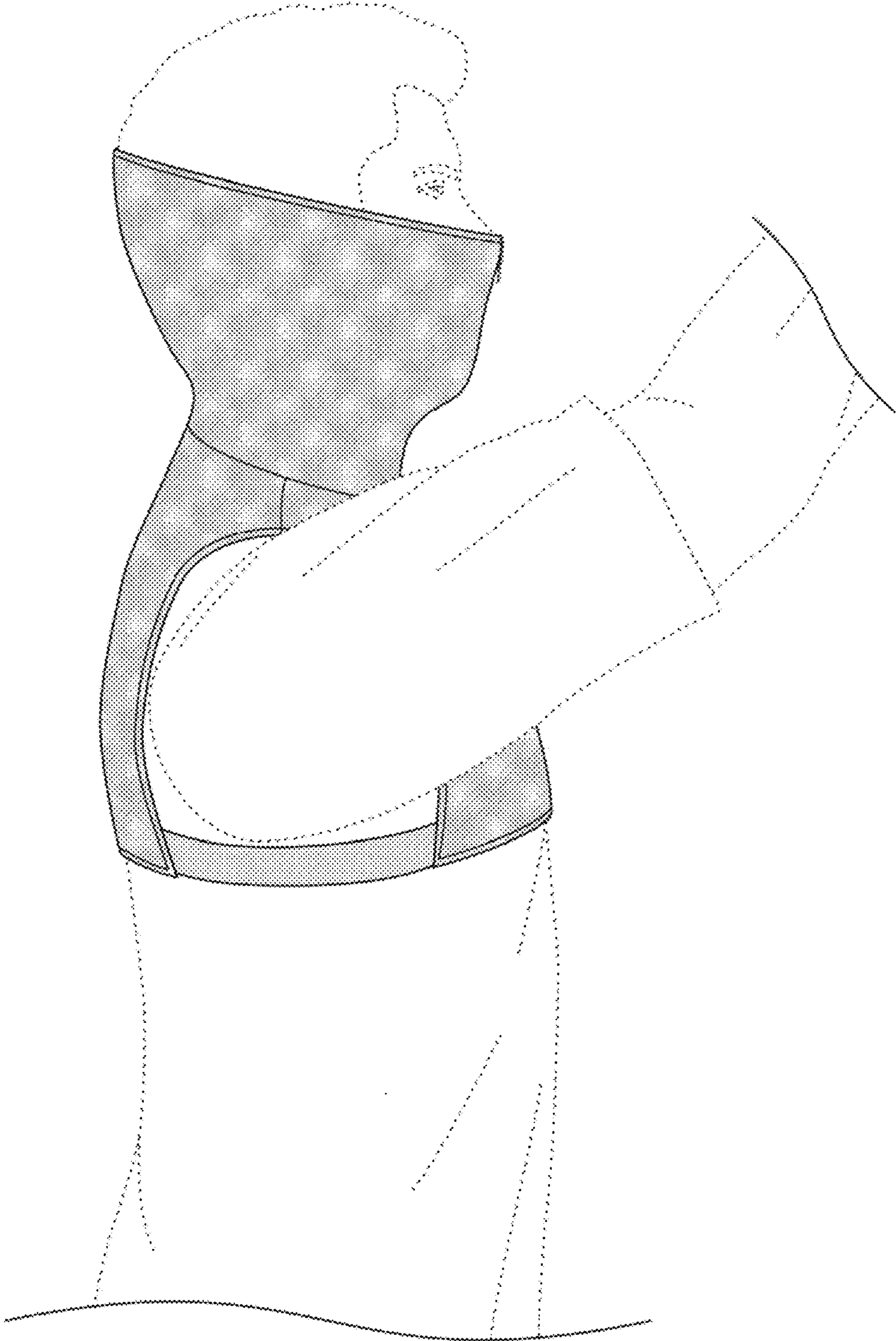

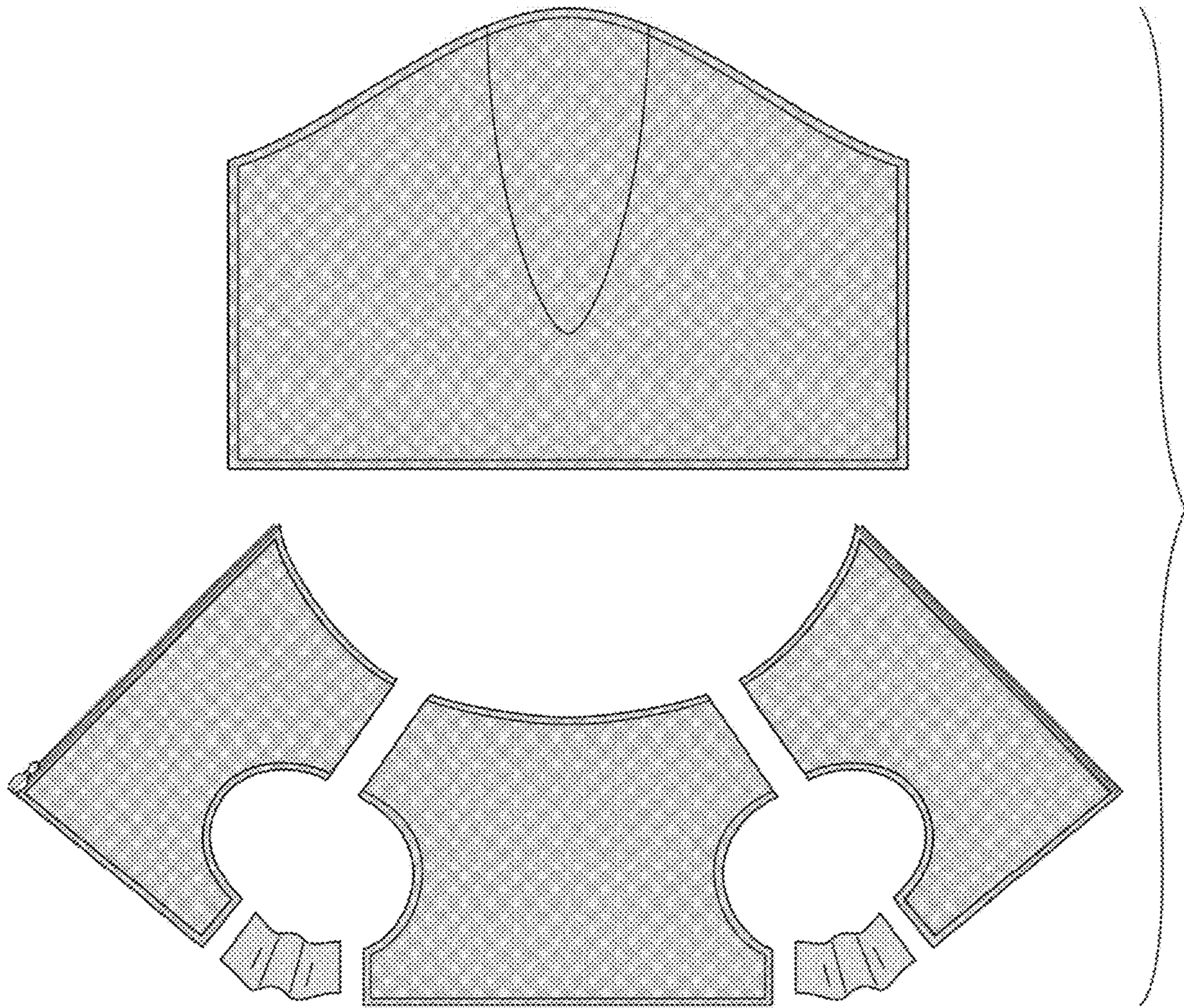

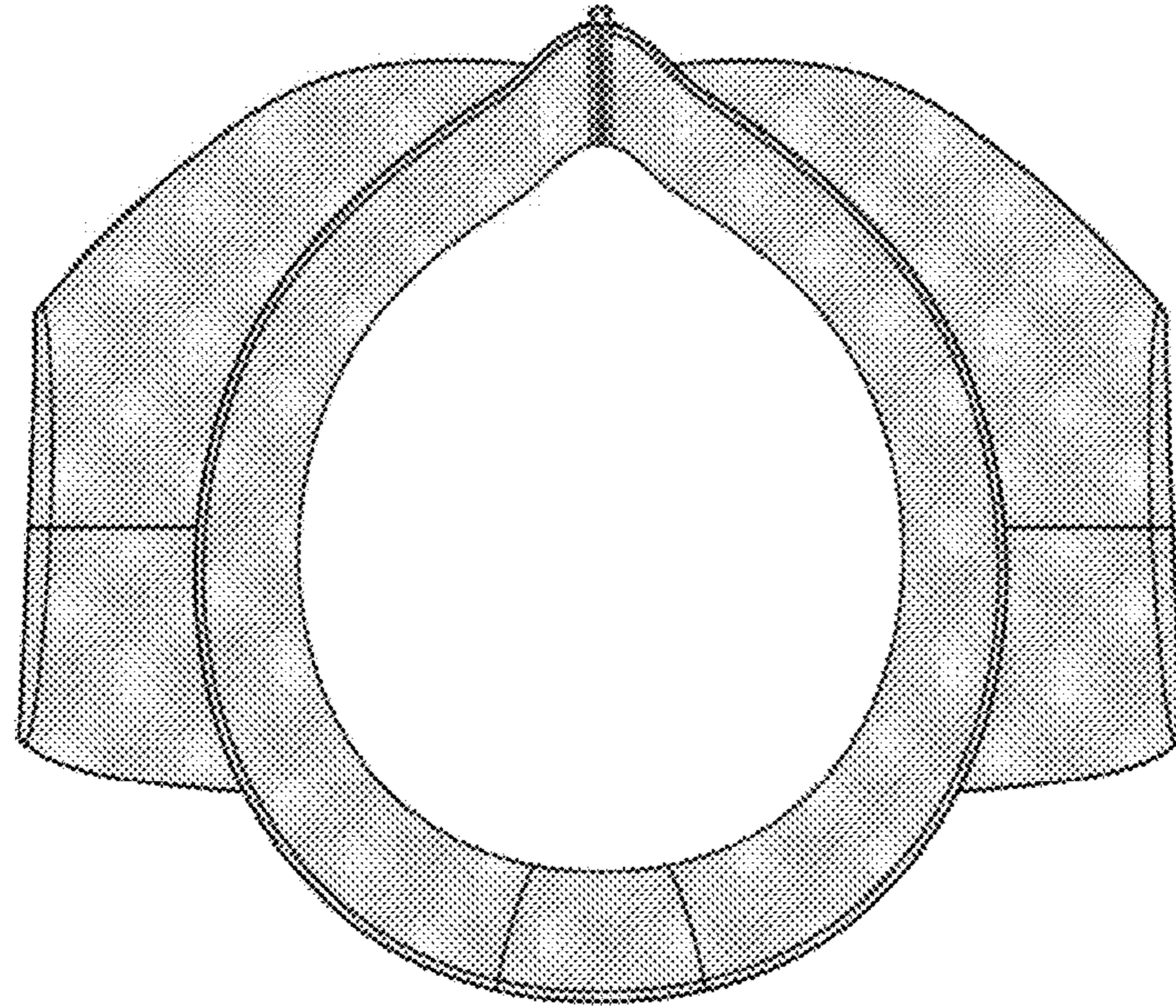

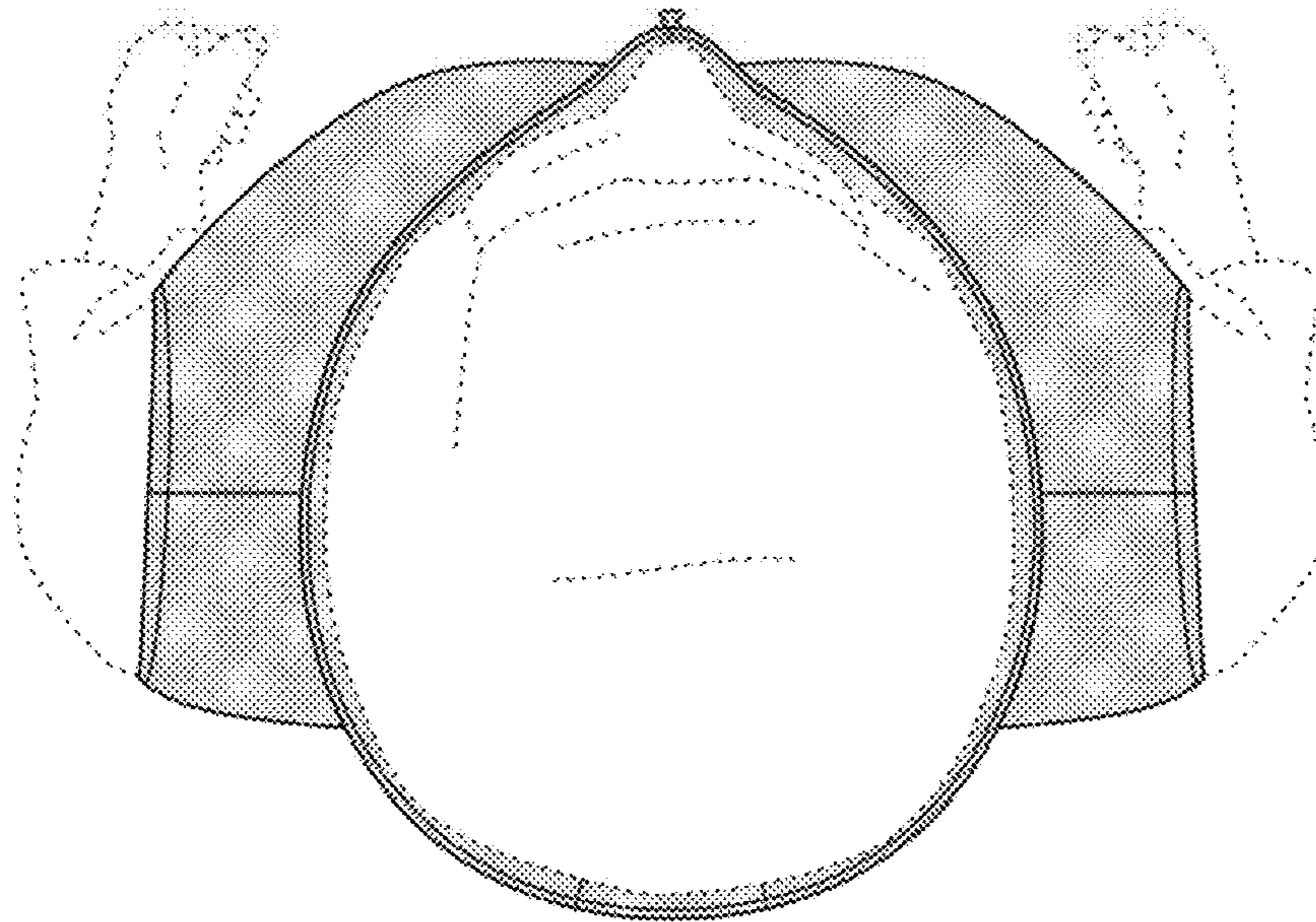

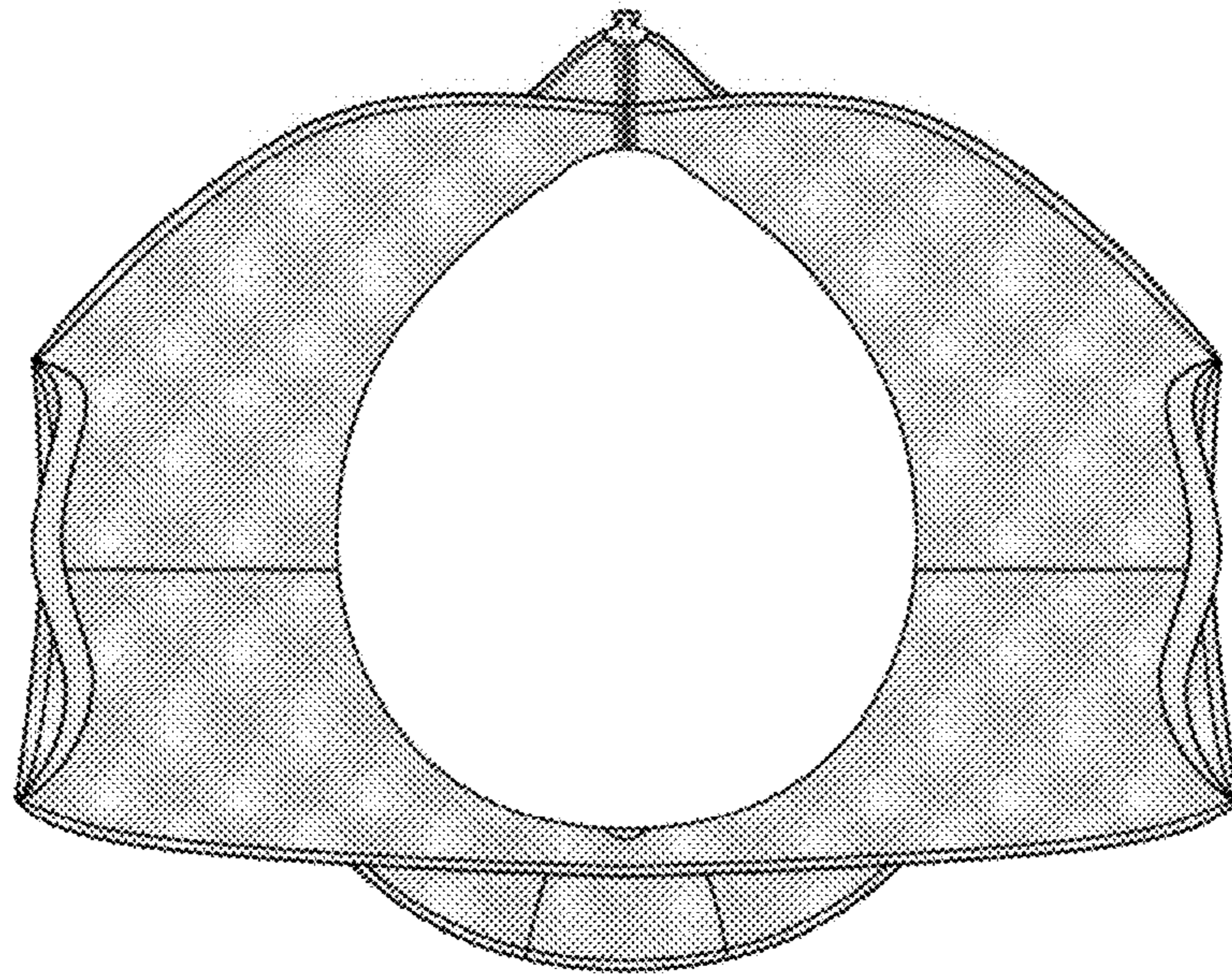
