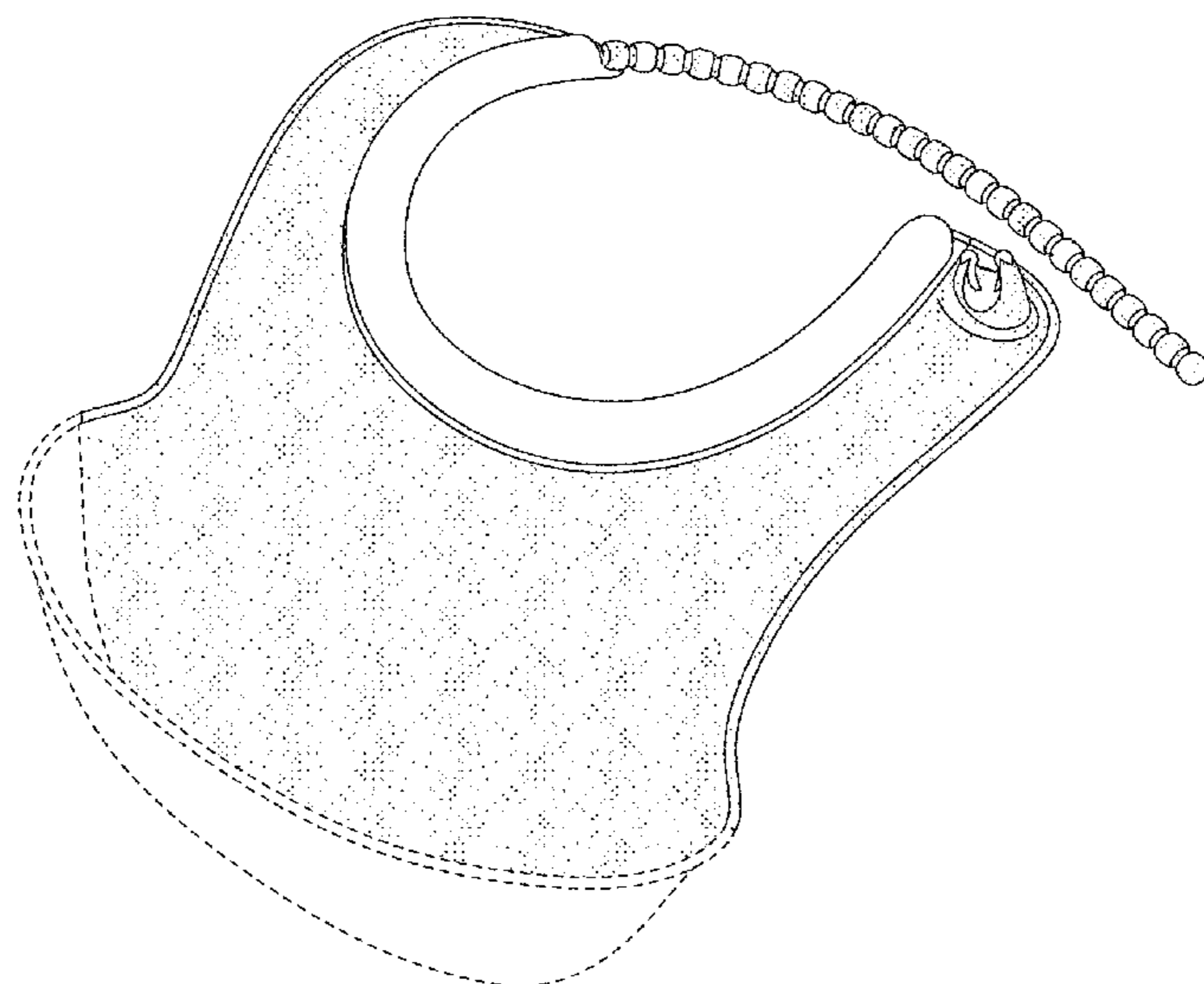
(57) **CLAIM**

FIG. 1 is a front perspective view showing our new design for a bib,

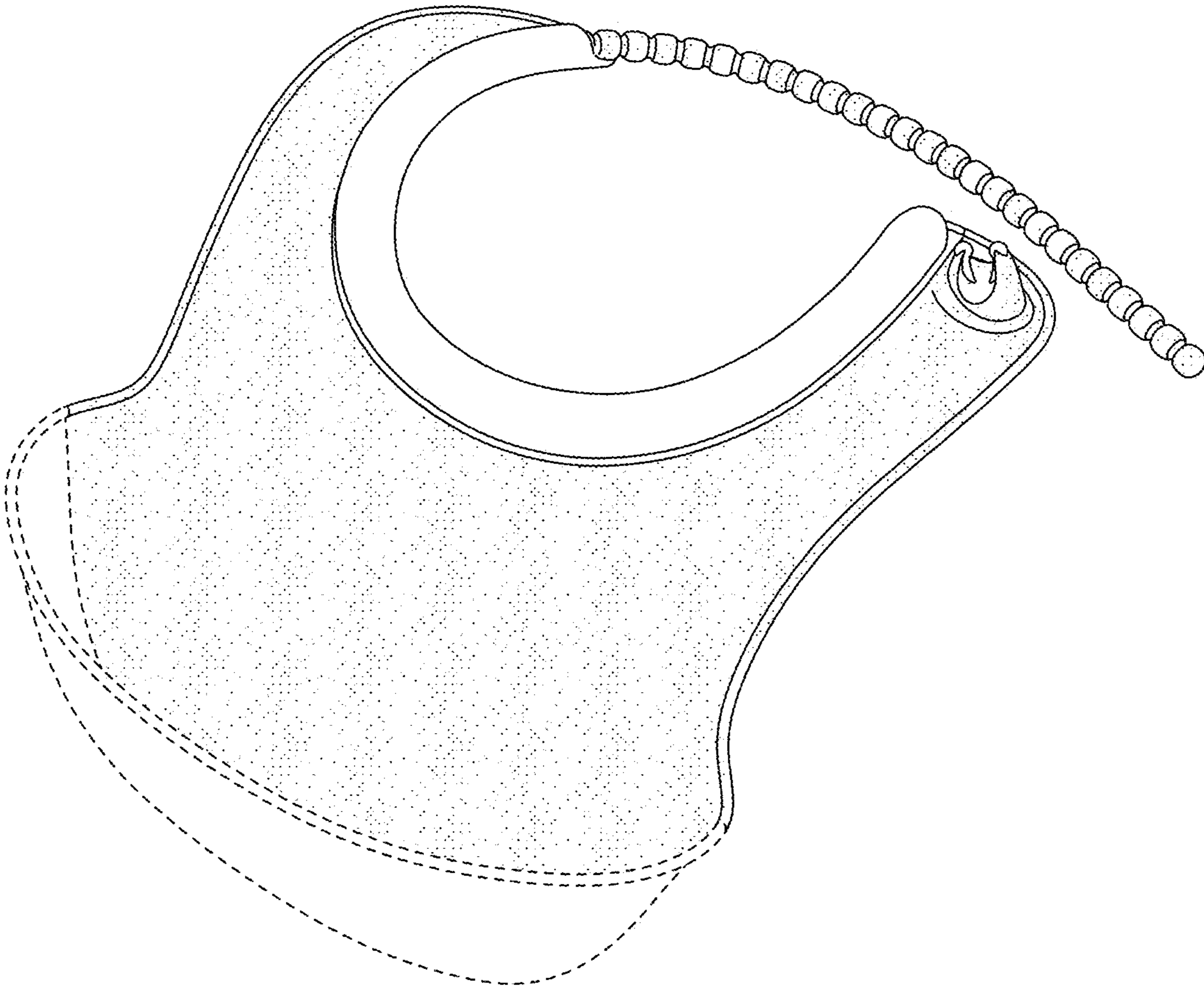

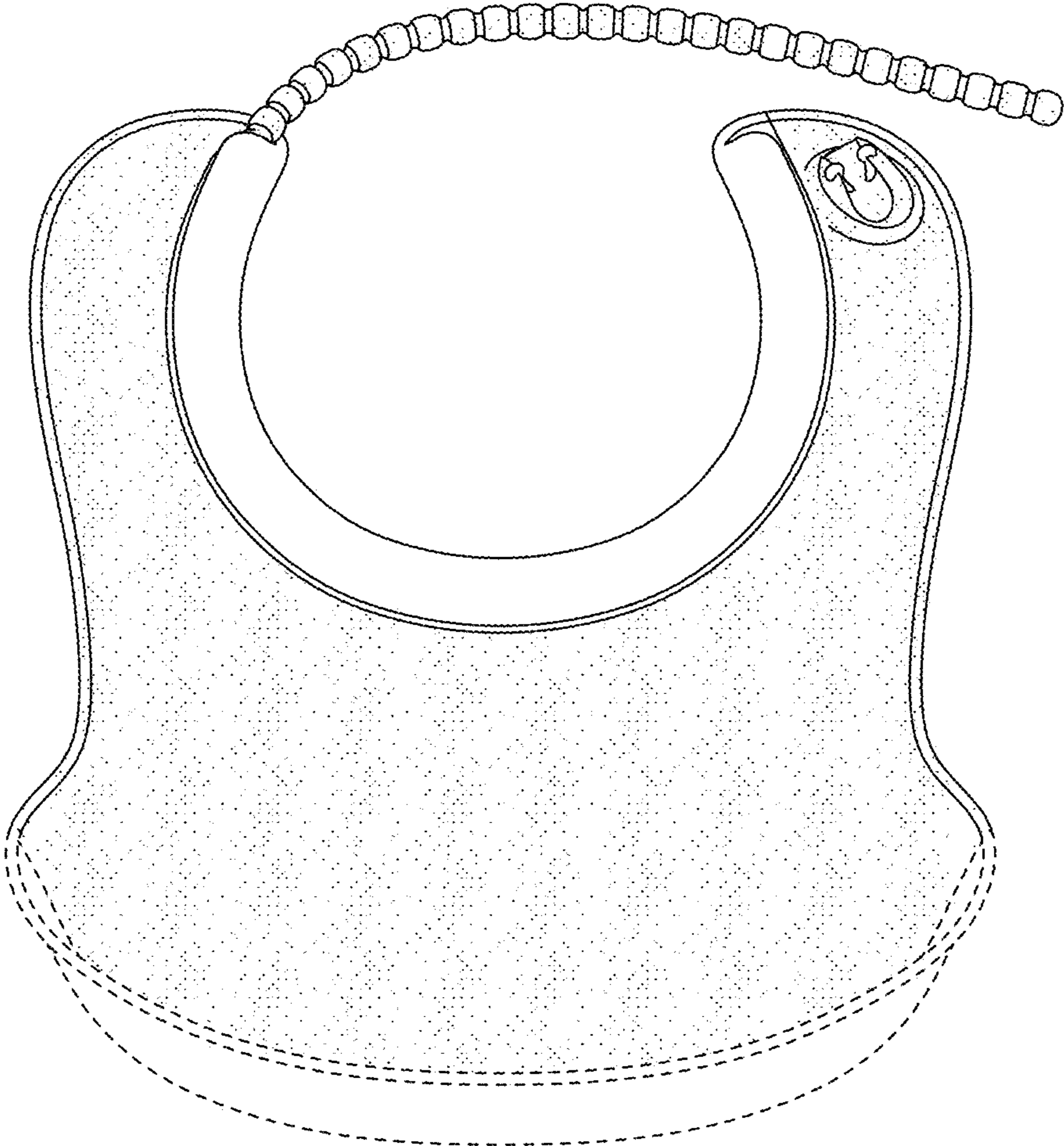

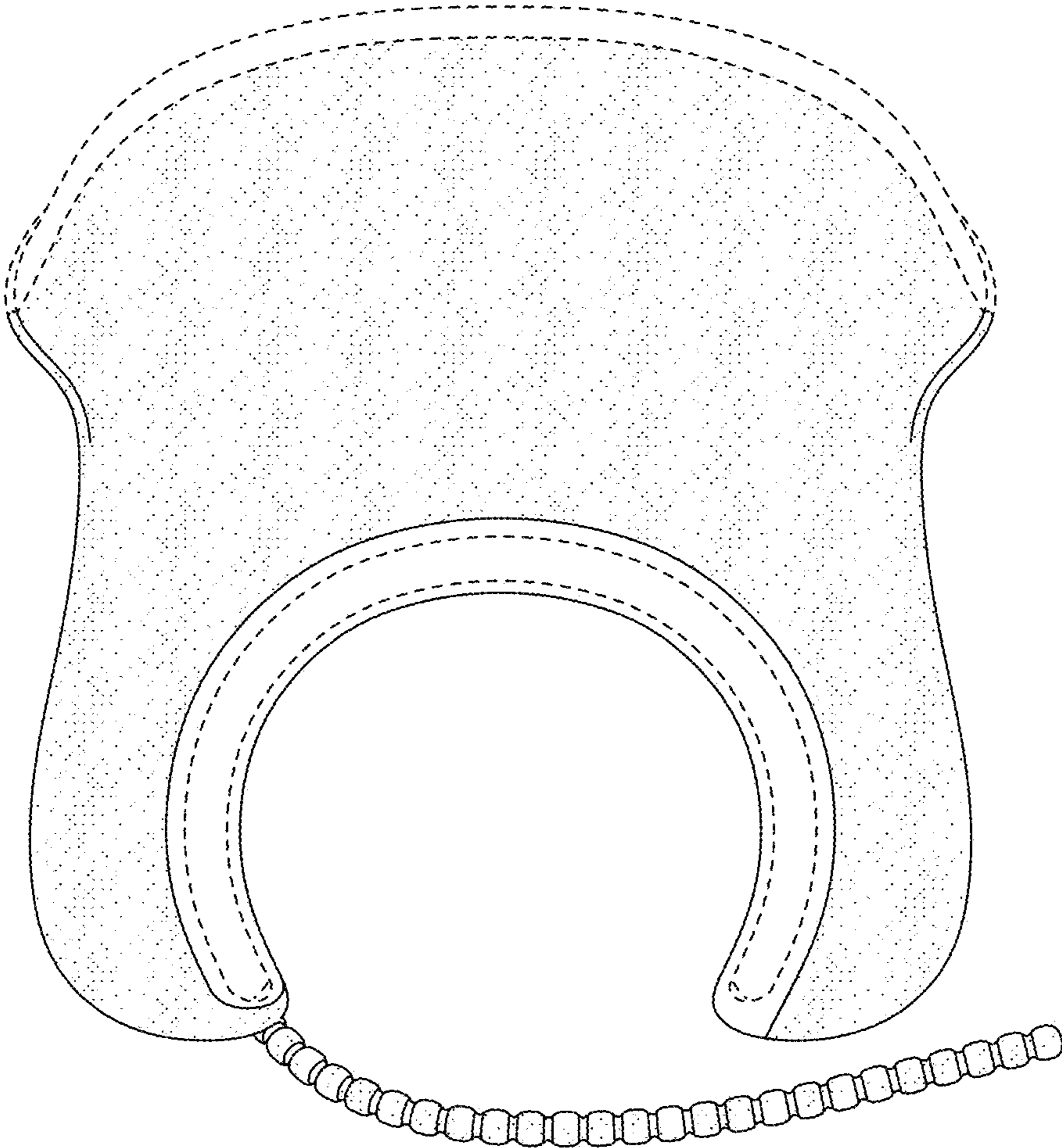

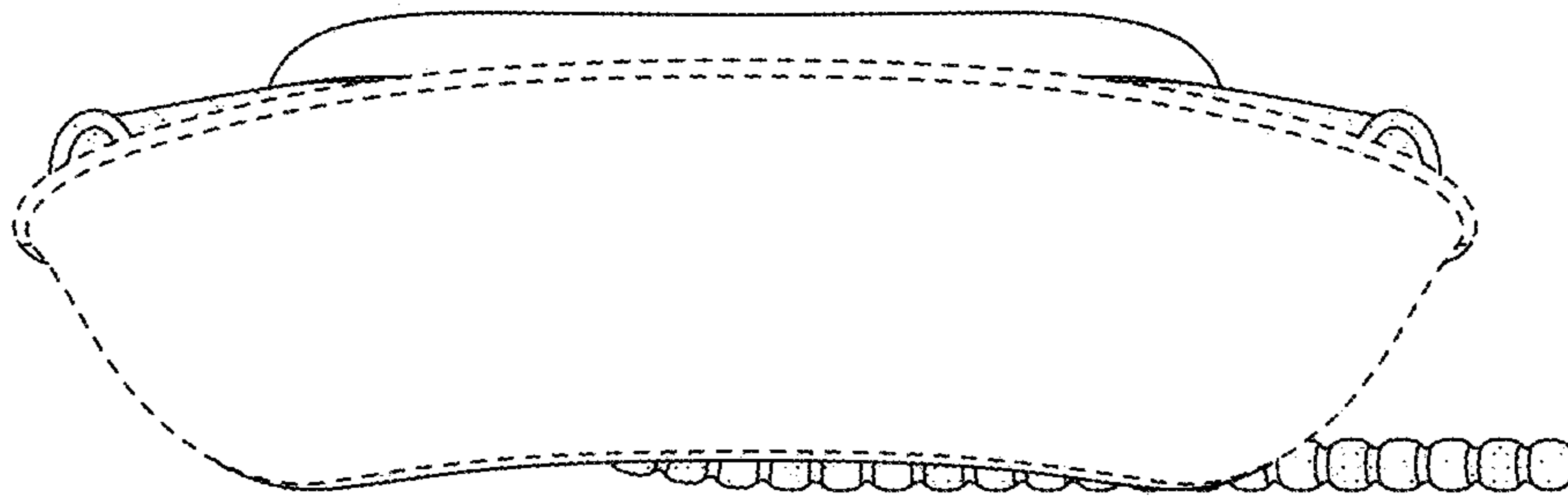

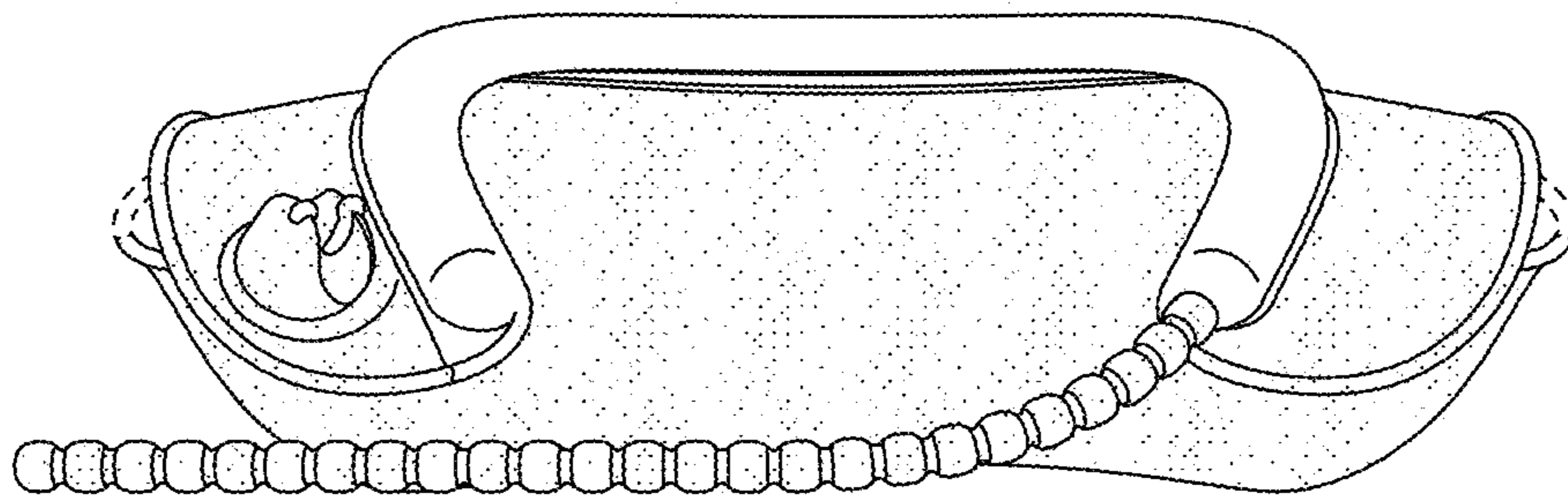

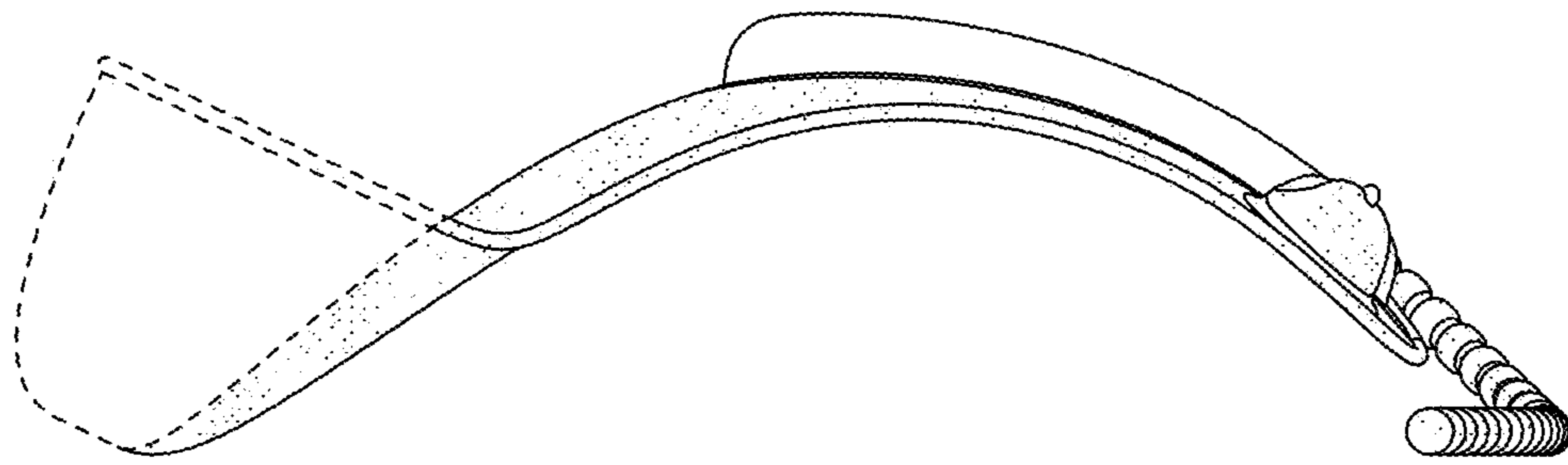

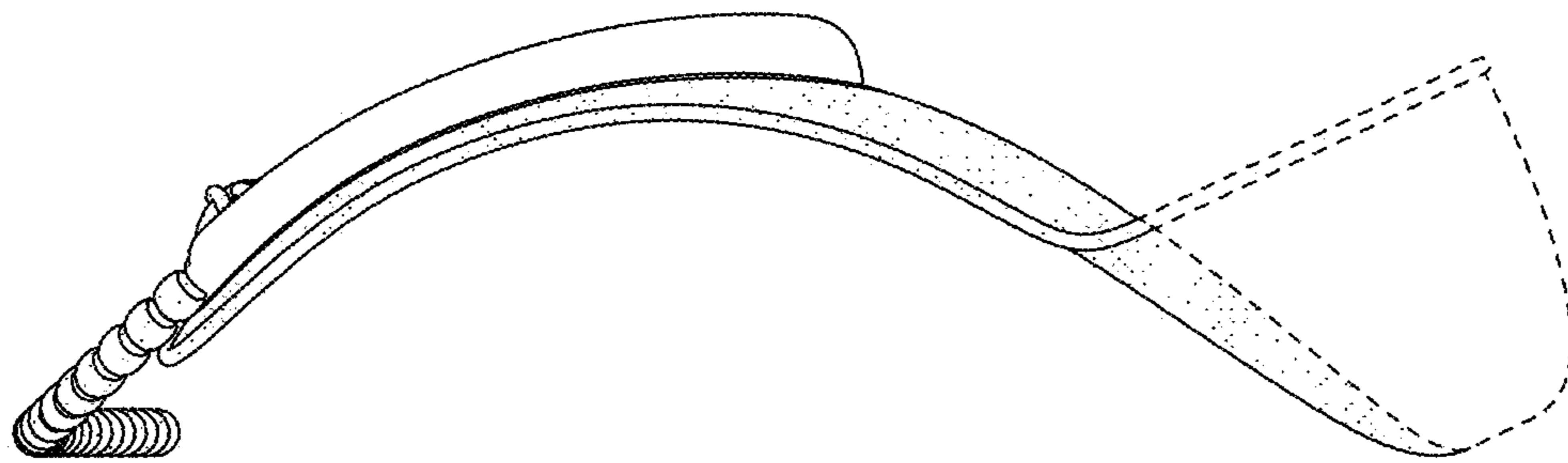
