FIG. 4 is a top view thereof;


FIG. 5 is a left side view thereof;


FIG. 6 is a bottom view thereof;

FIG. 7 is a right side view thereof; and,


FIG. 8 is a back view thereof.

The broken lines in the drawing depict portions of the dispenser for hygiene paper rolls that form no part of the claimed design.












