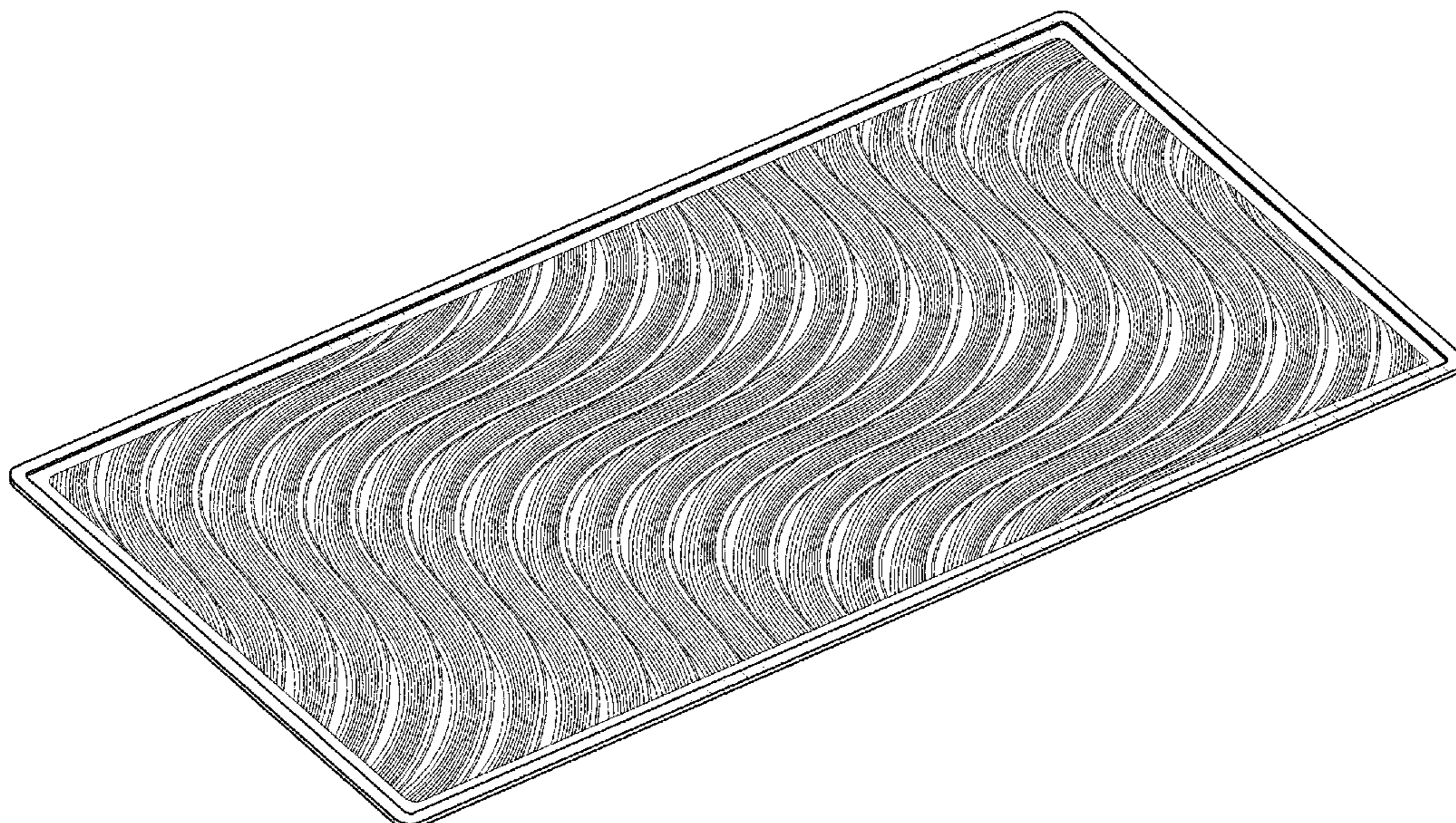
FIG. 1 is a perspective view of a bath mat;

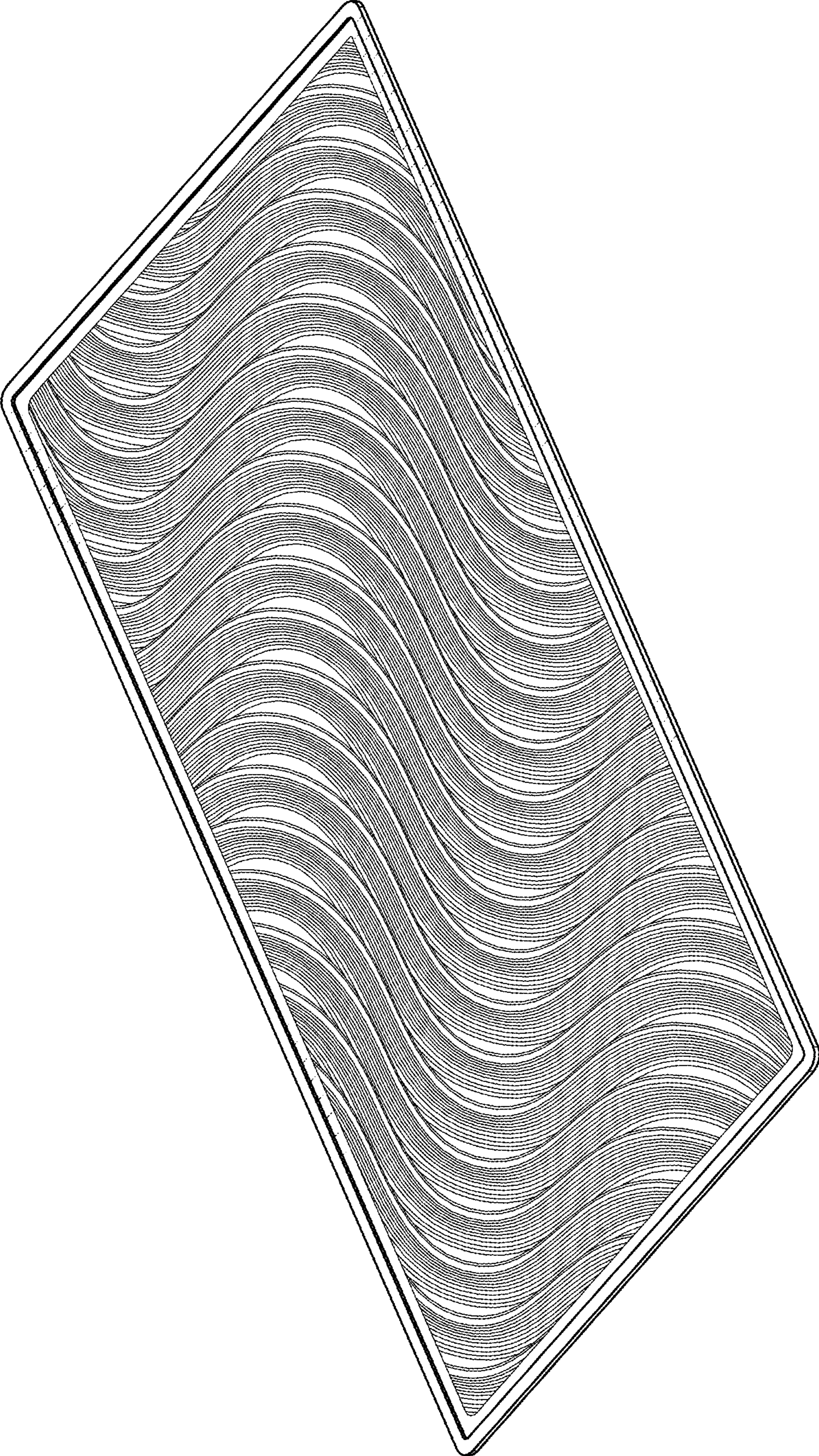

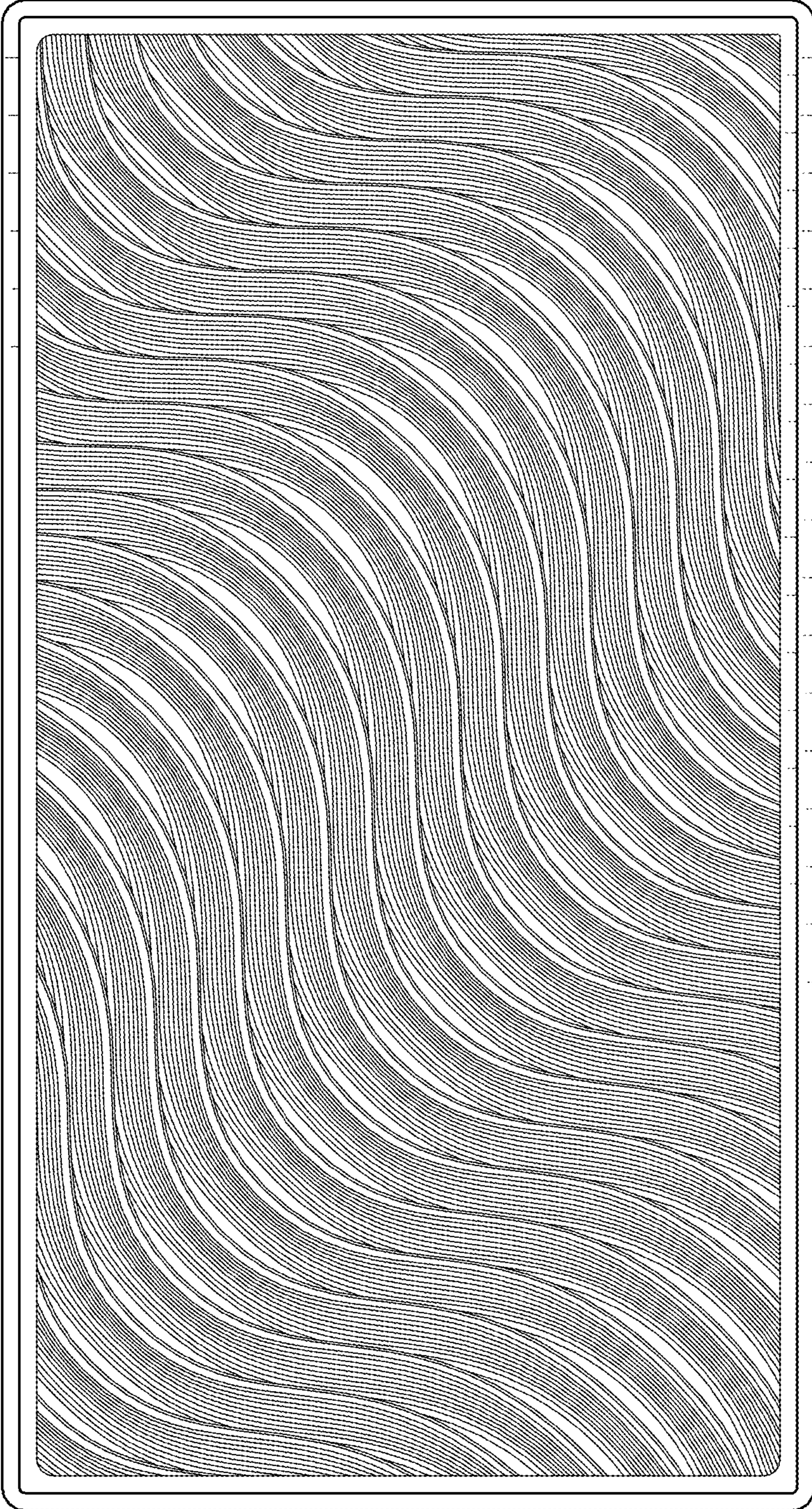

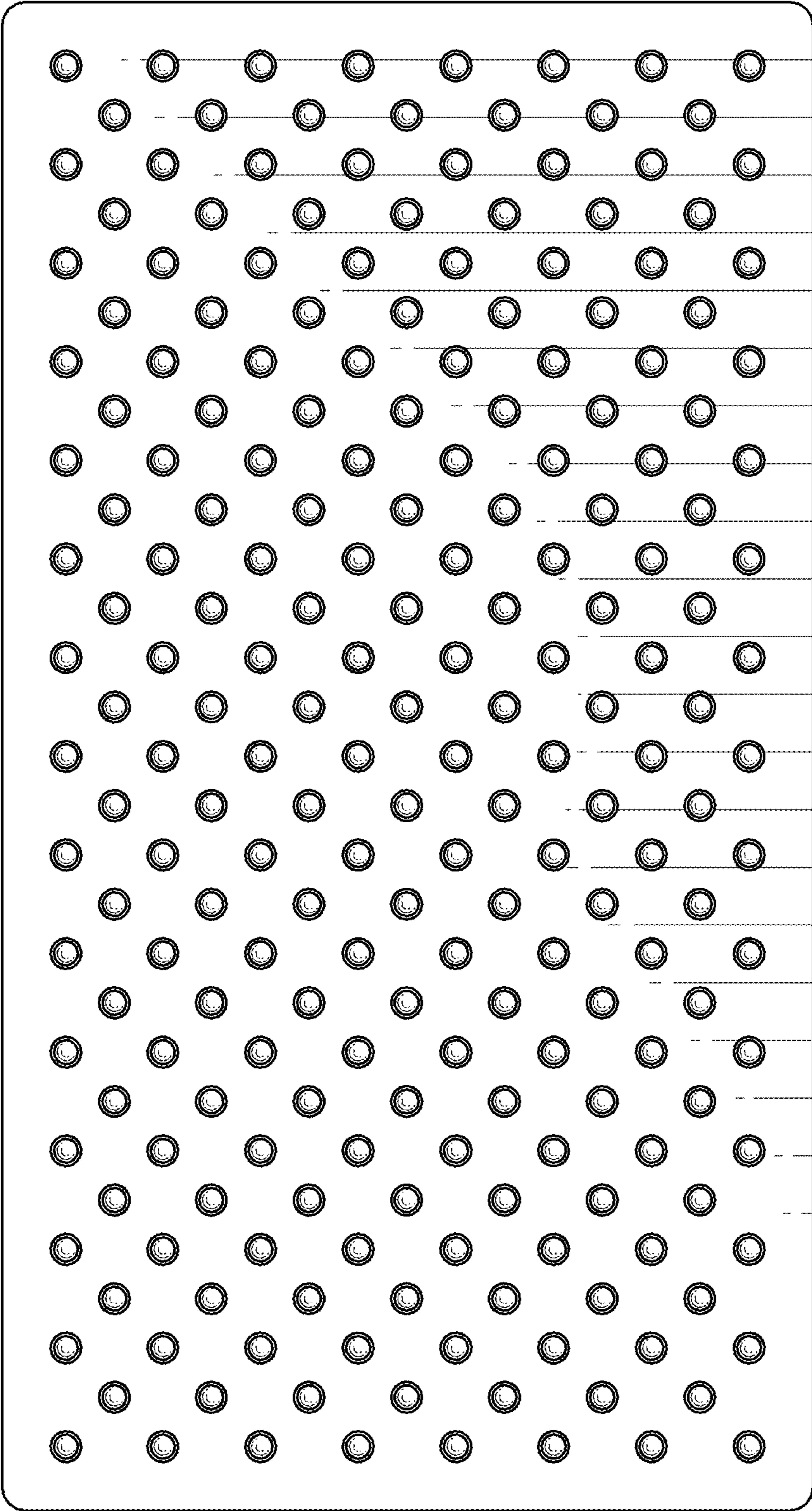
