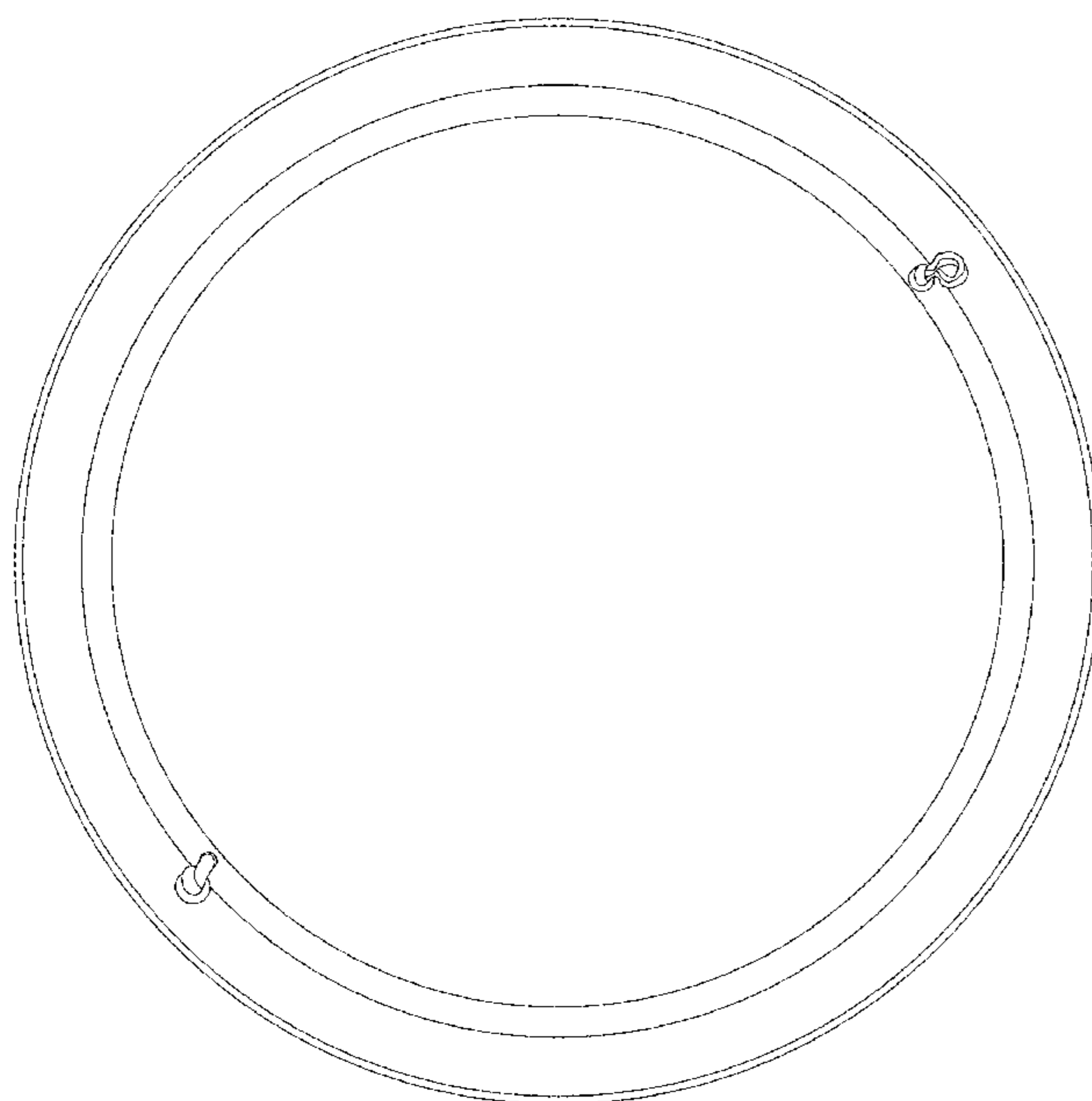
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a baby play mat showing my new design;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a perspective view thereof, showing the baby play mat cinched with the string closure as untied; and,
 FIG. 4 is a perspective view thereof, showing the baby play mat cinched with the string closure as tied.

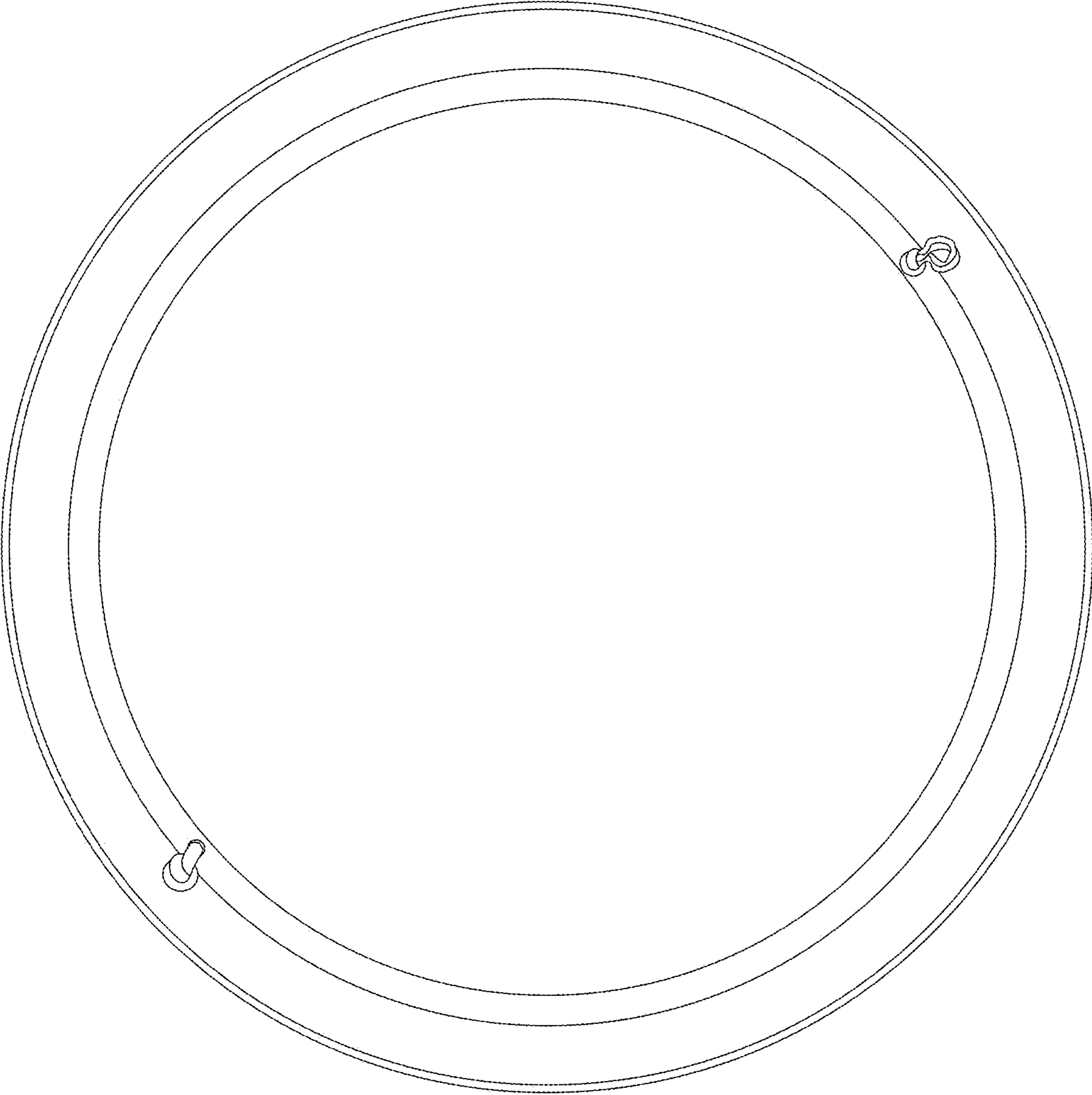

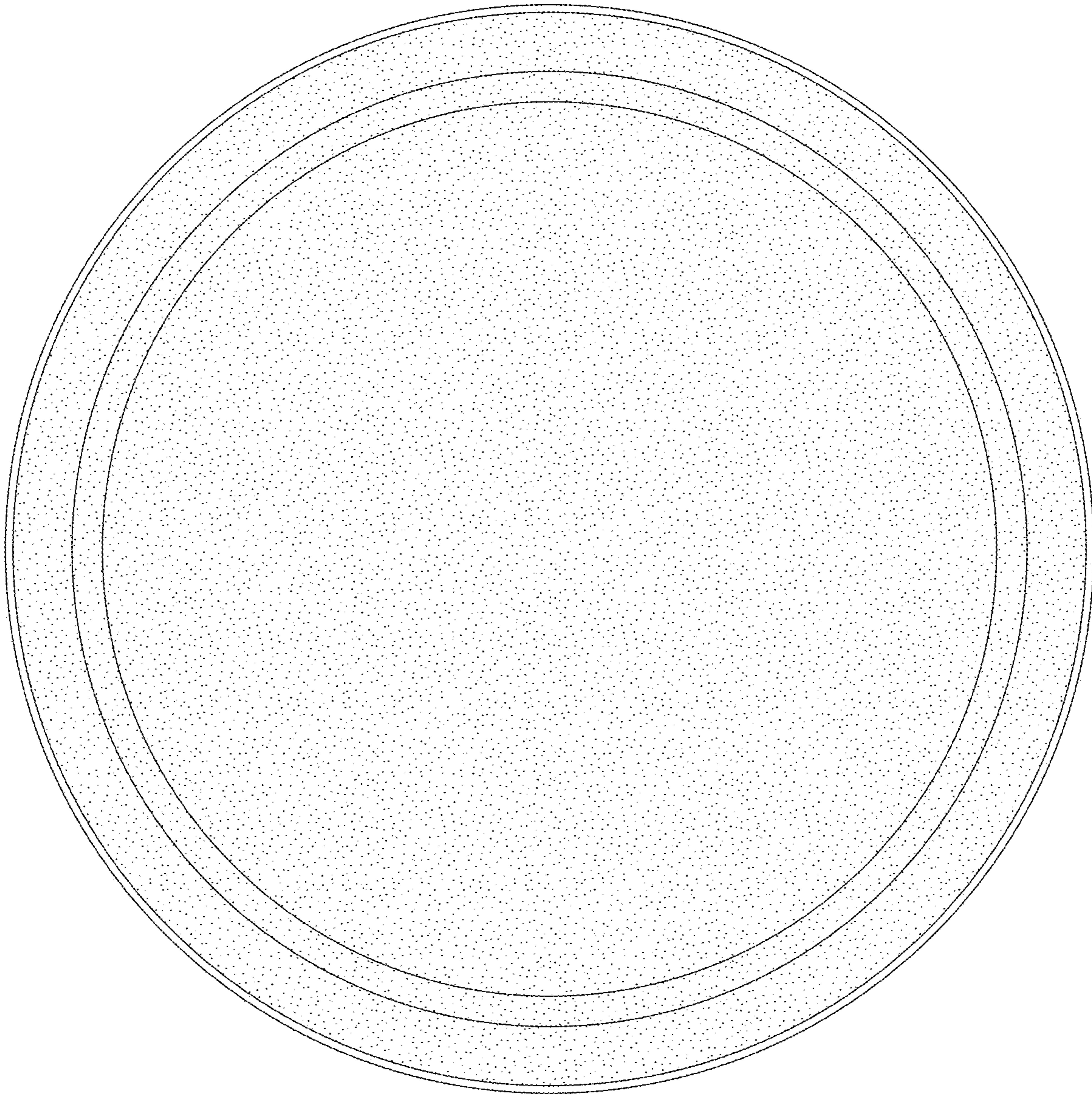

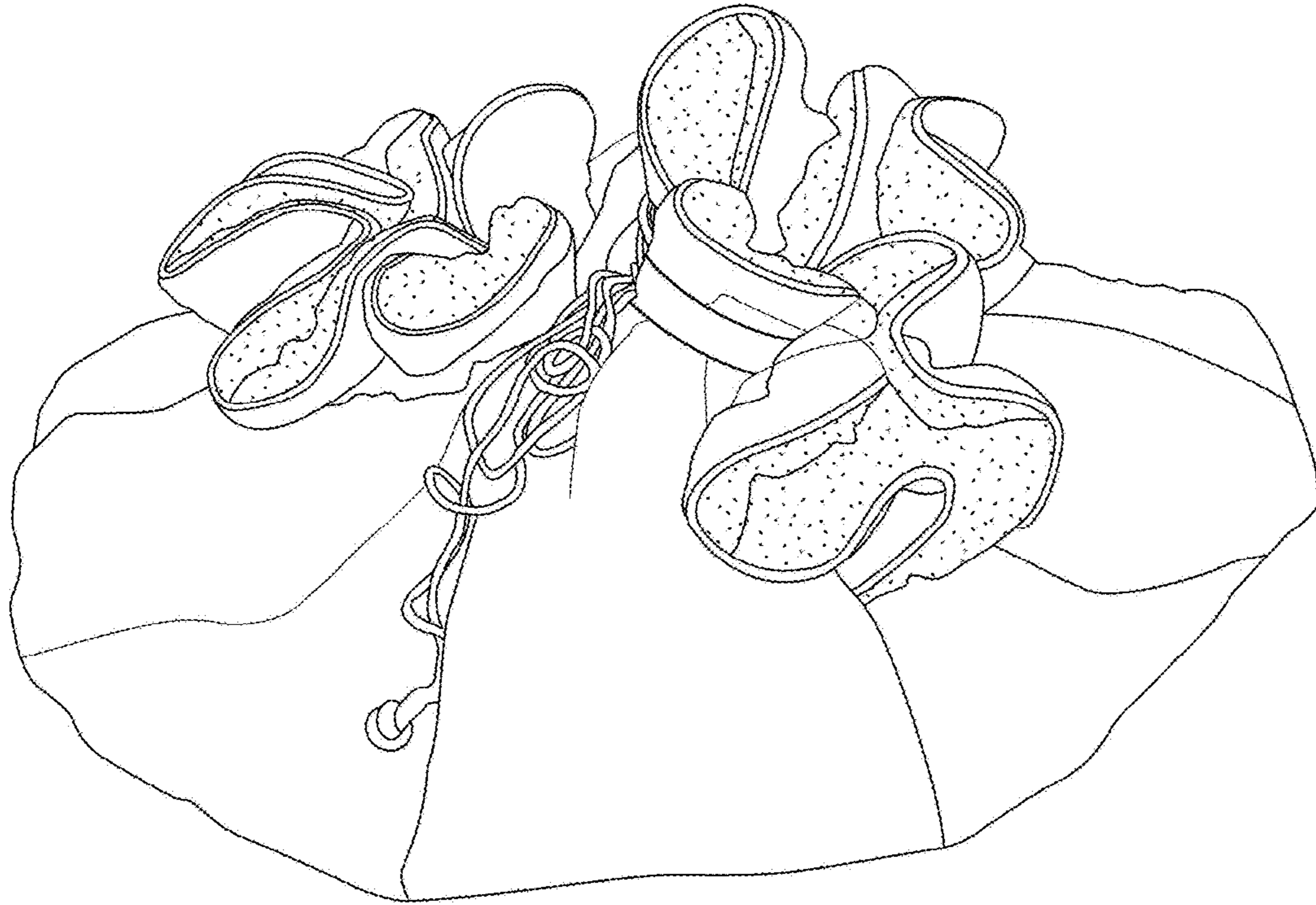
