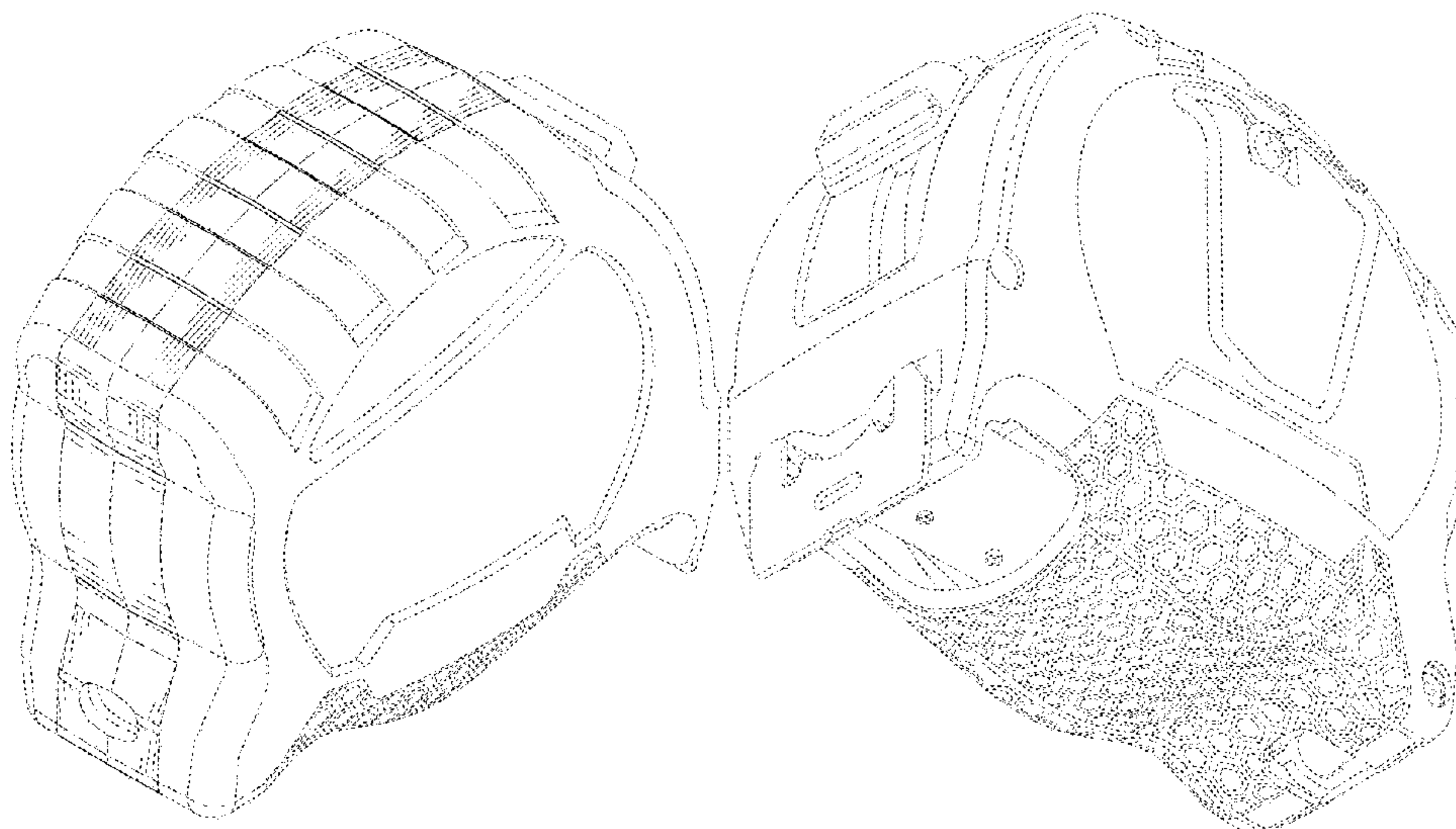
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear perspective view from above of an embodi-
ment of the claimed design;

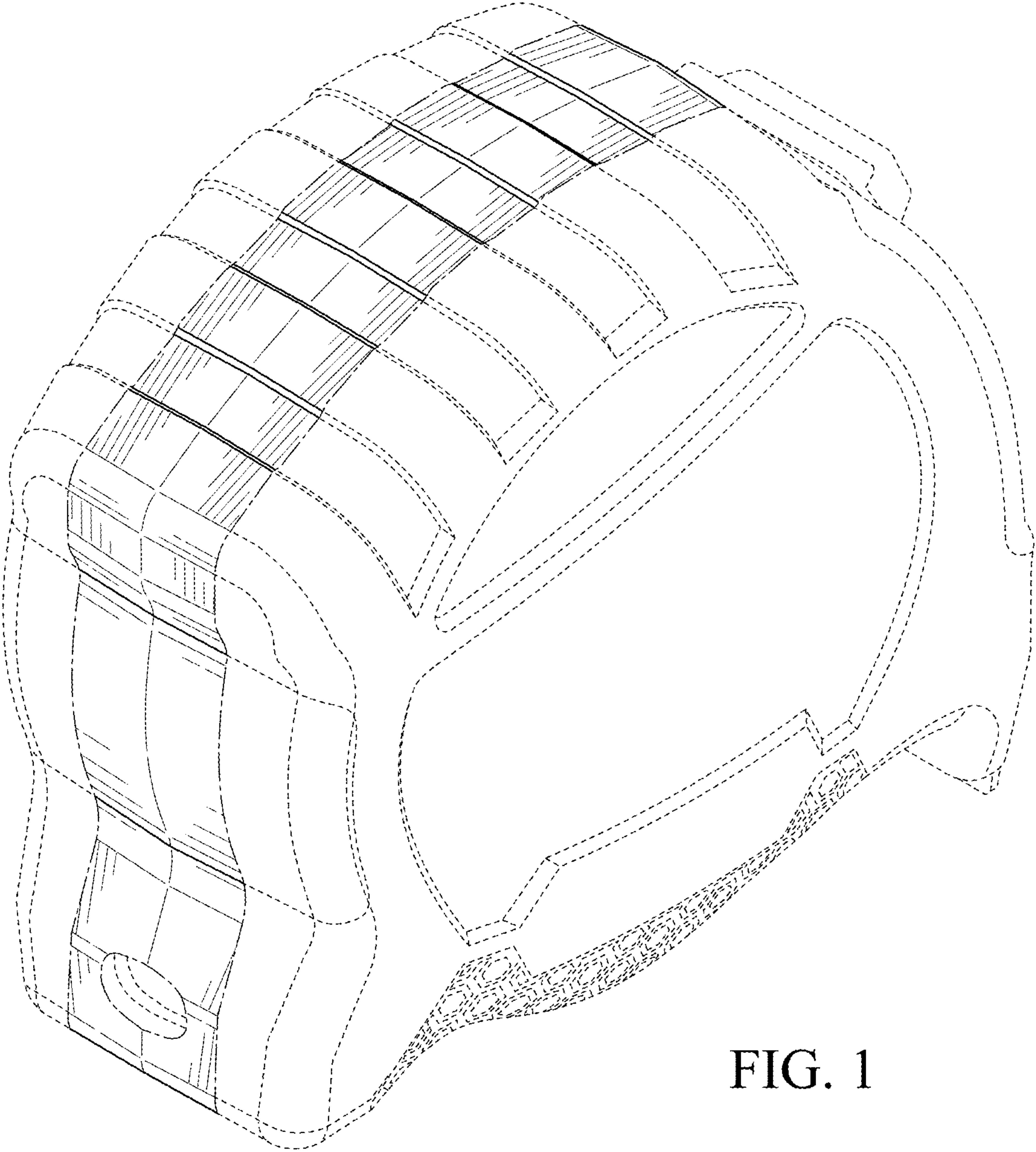

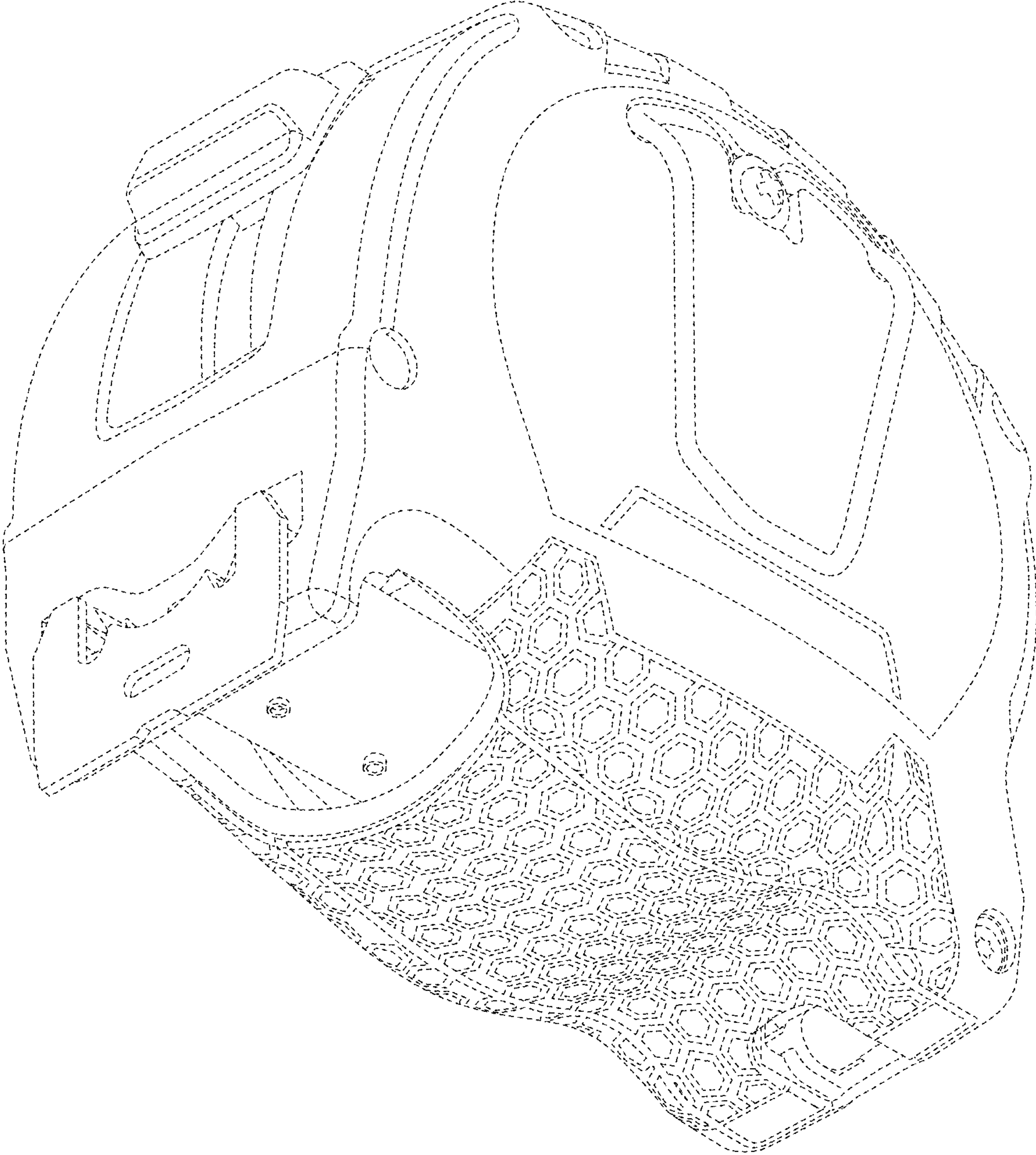

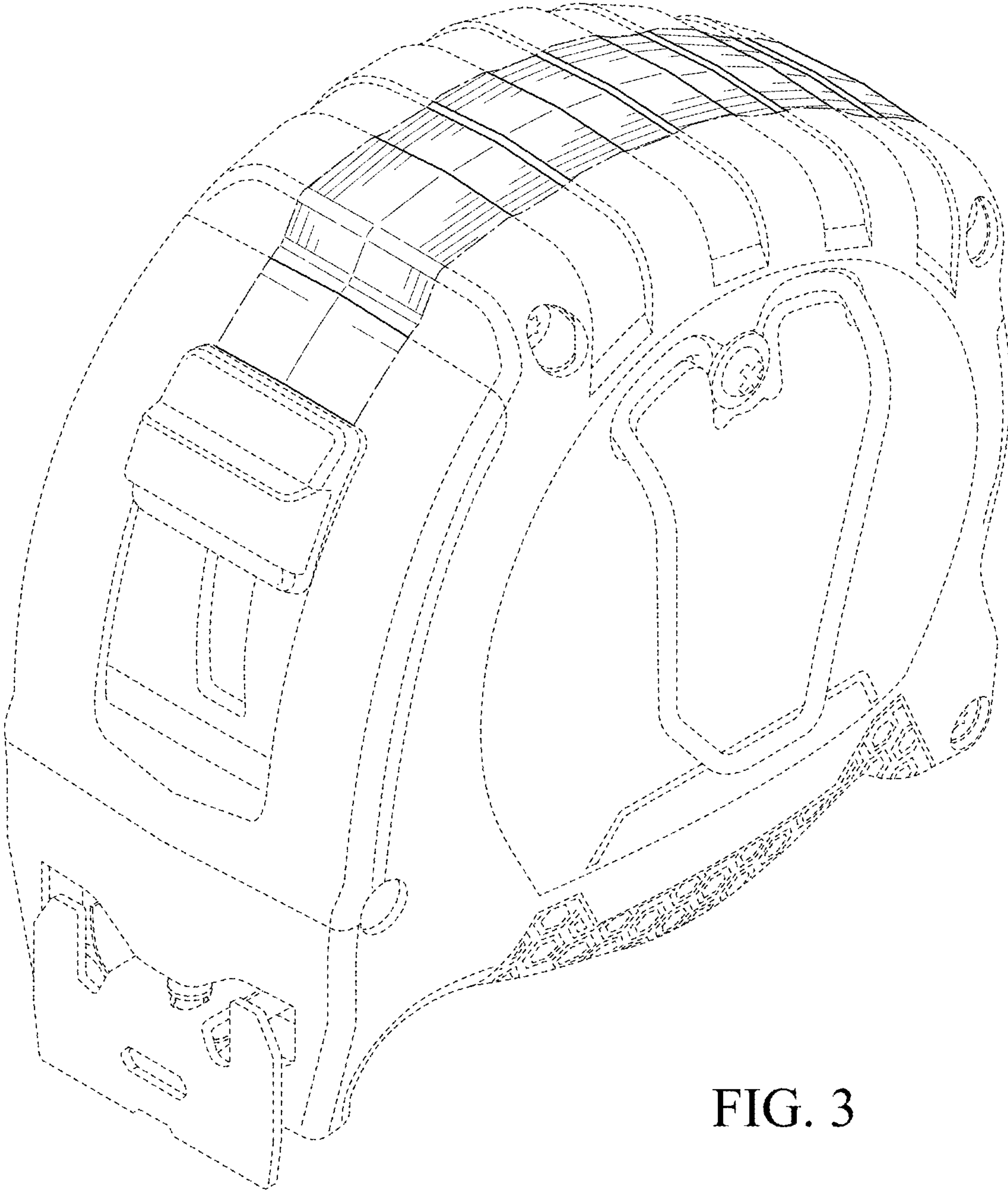

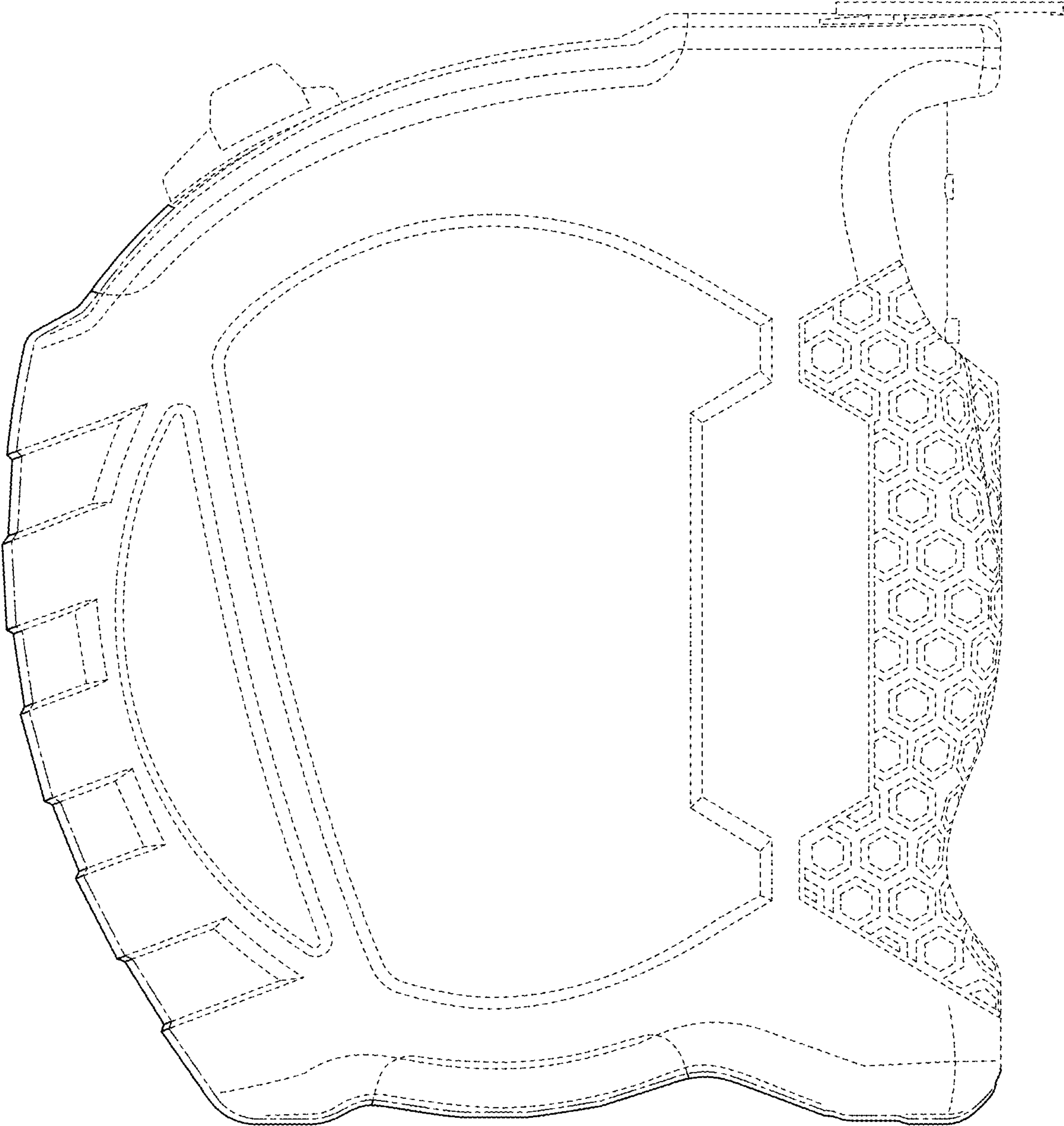

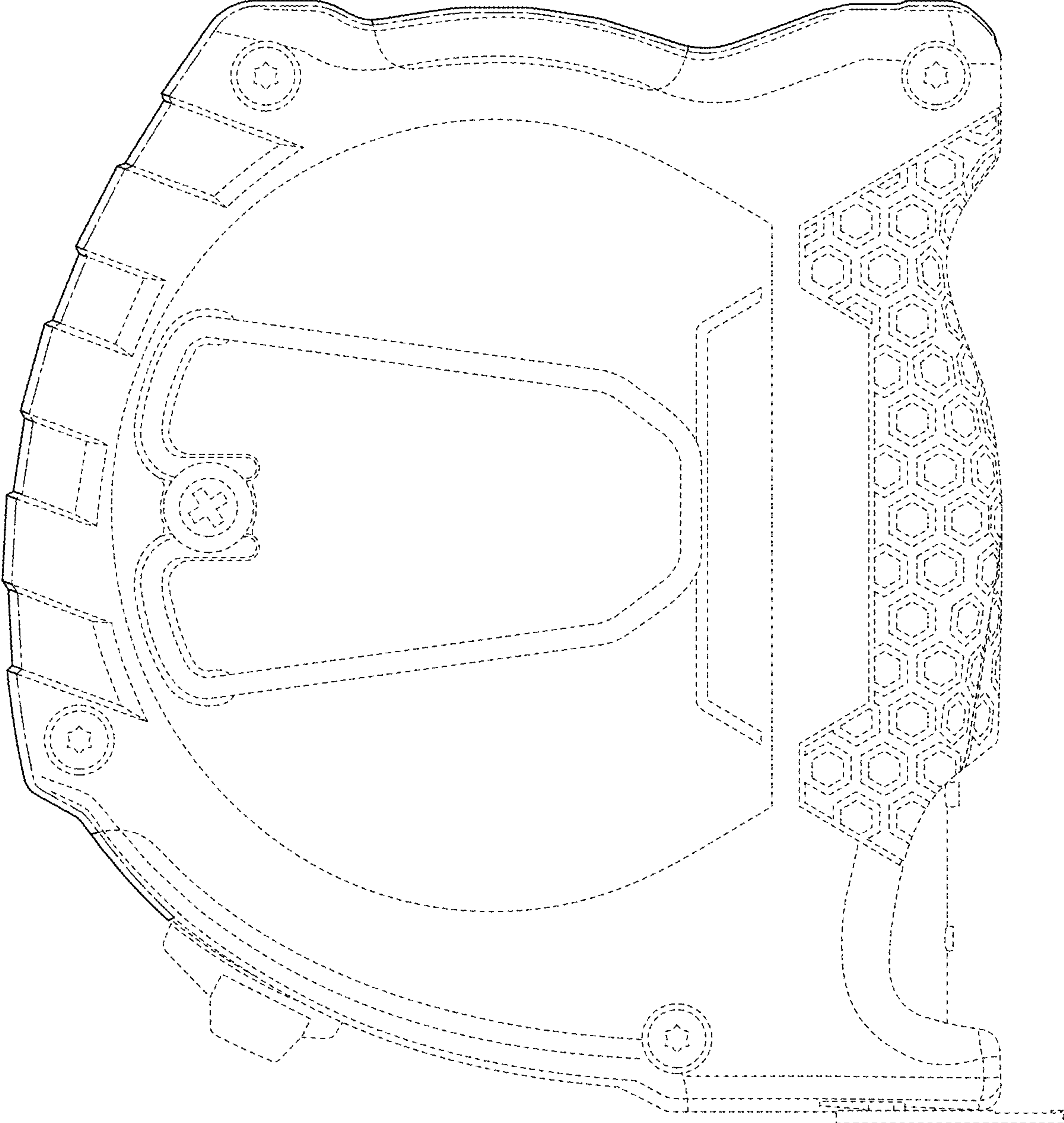

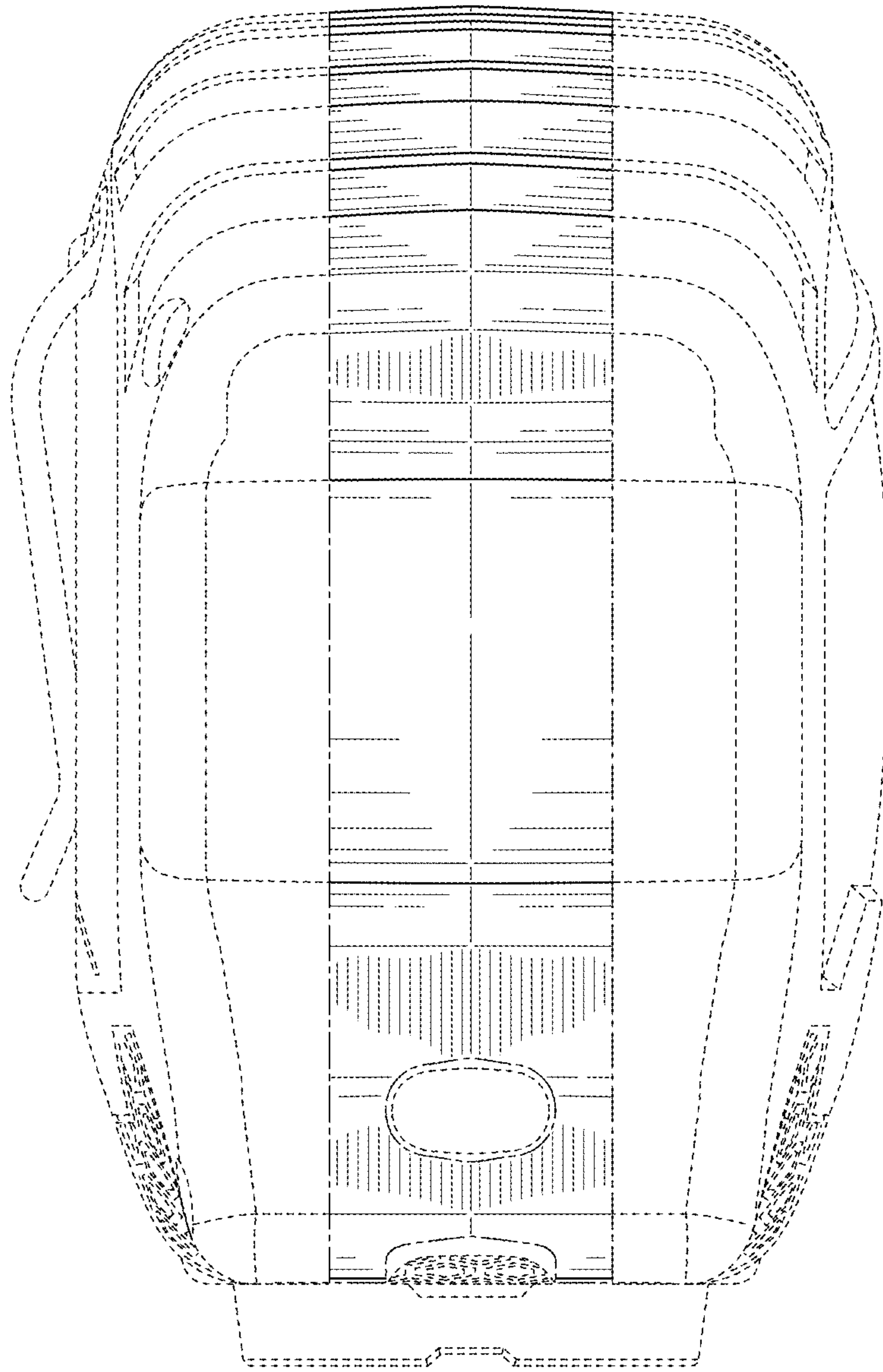

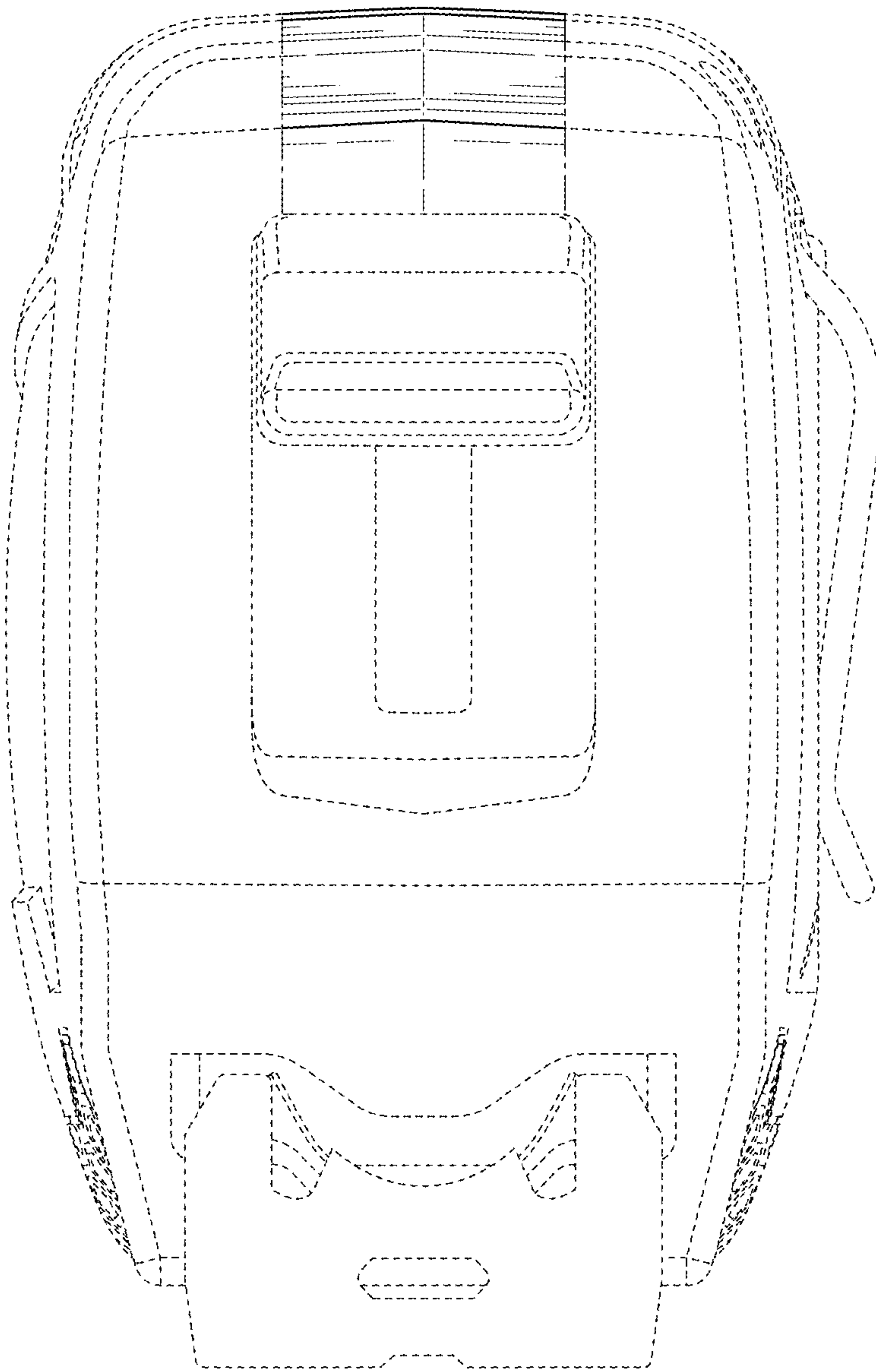

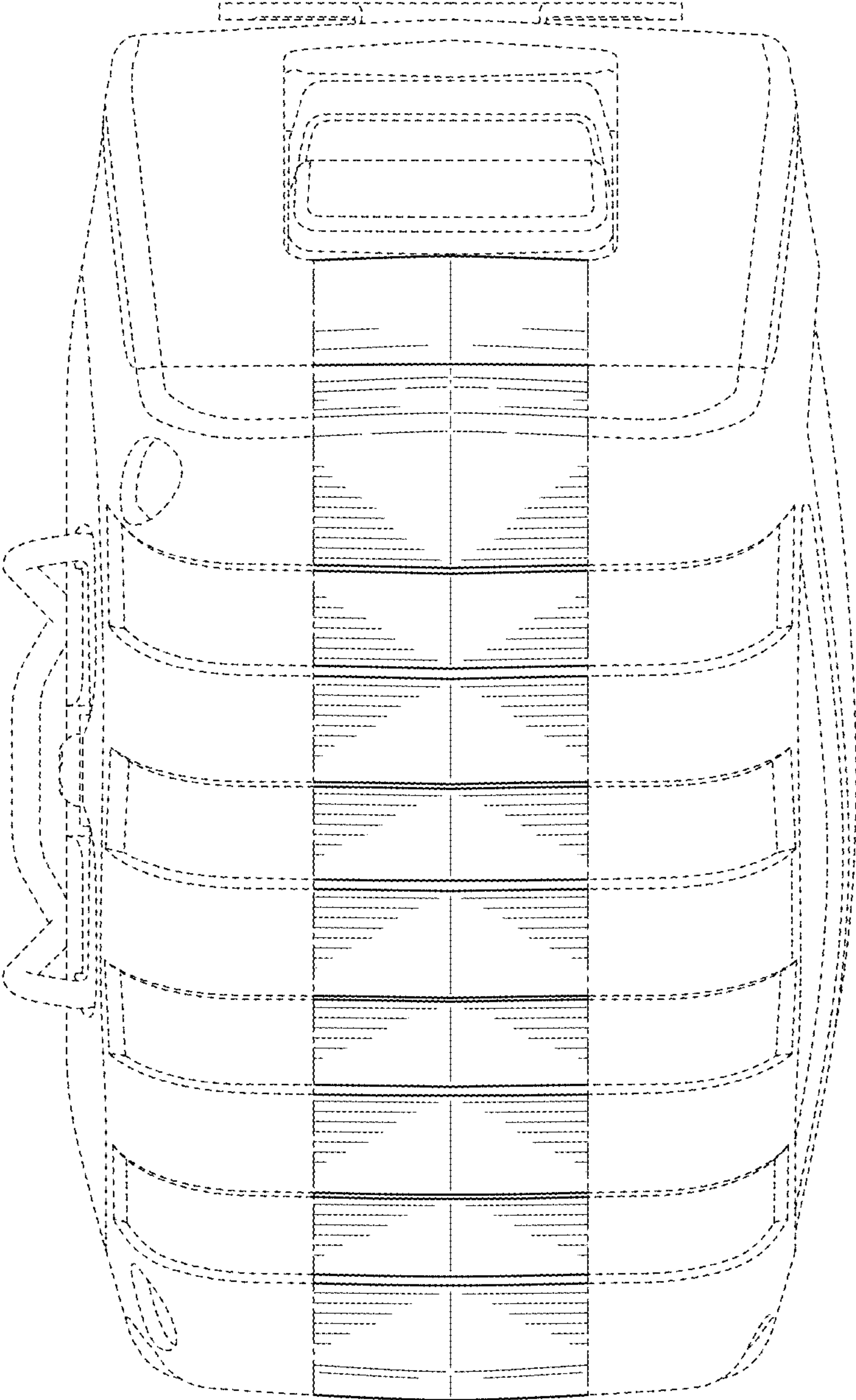

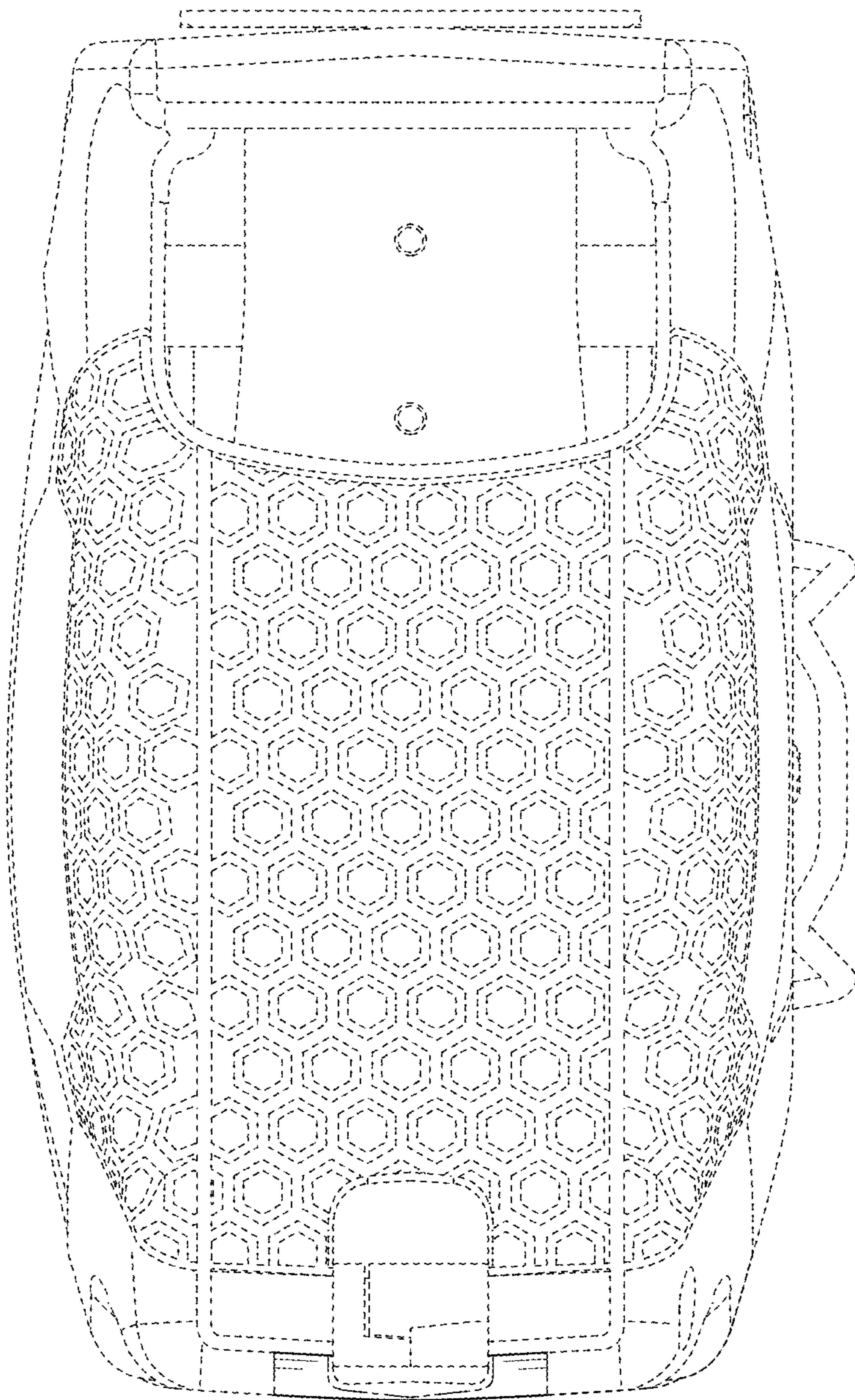
