I claim the ornamental design for a warning light, as shown and described.

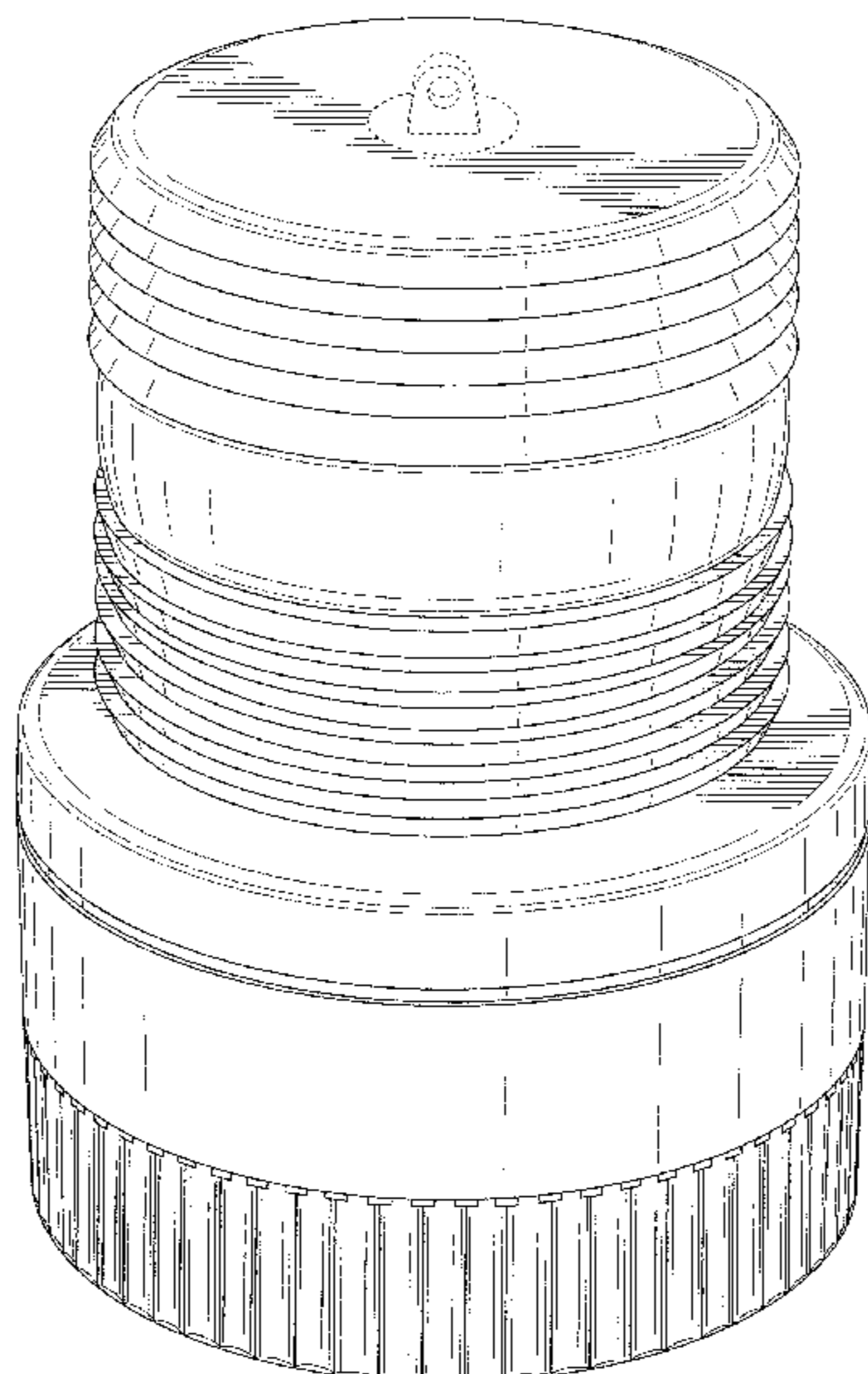

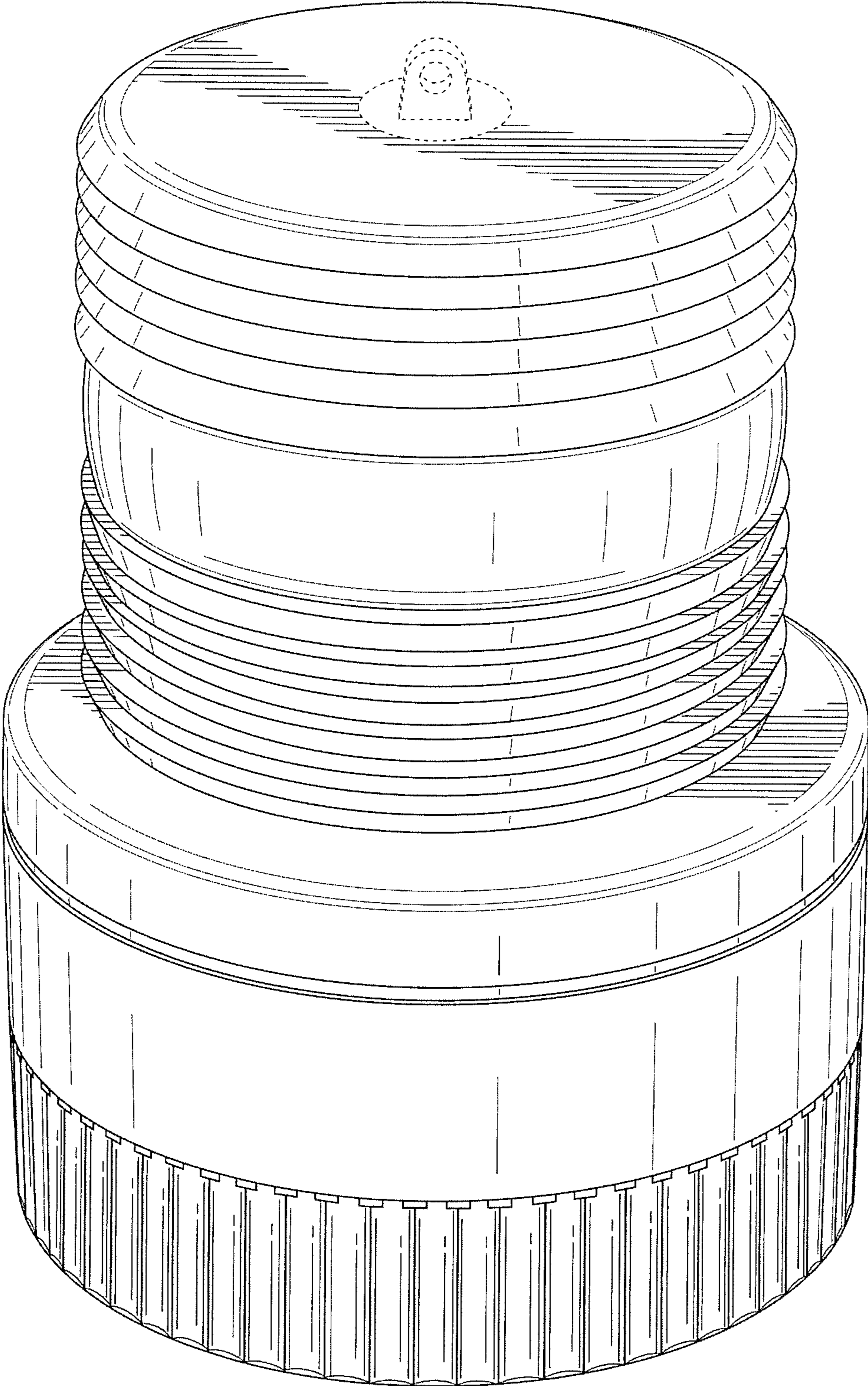

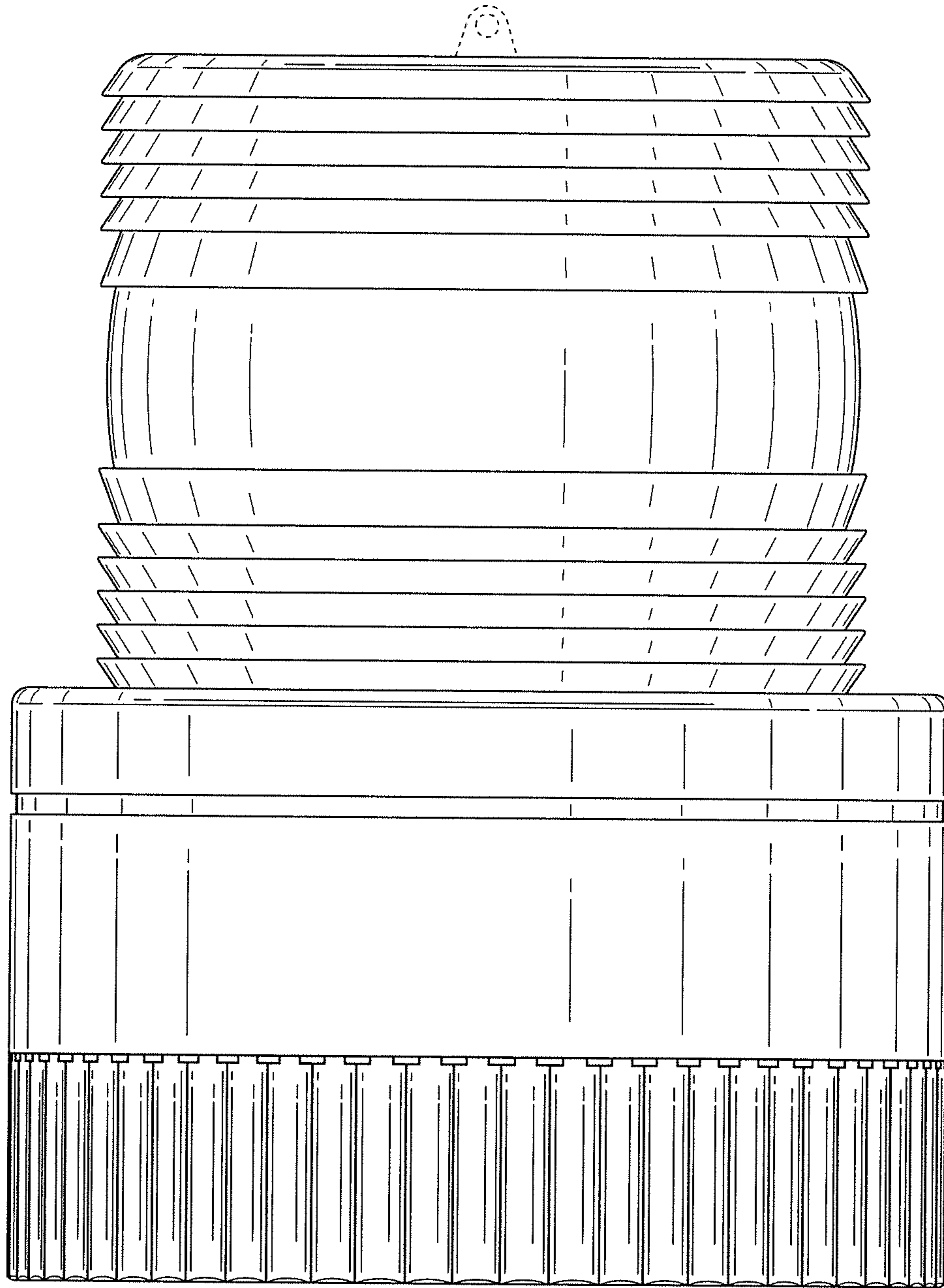

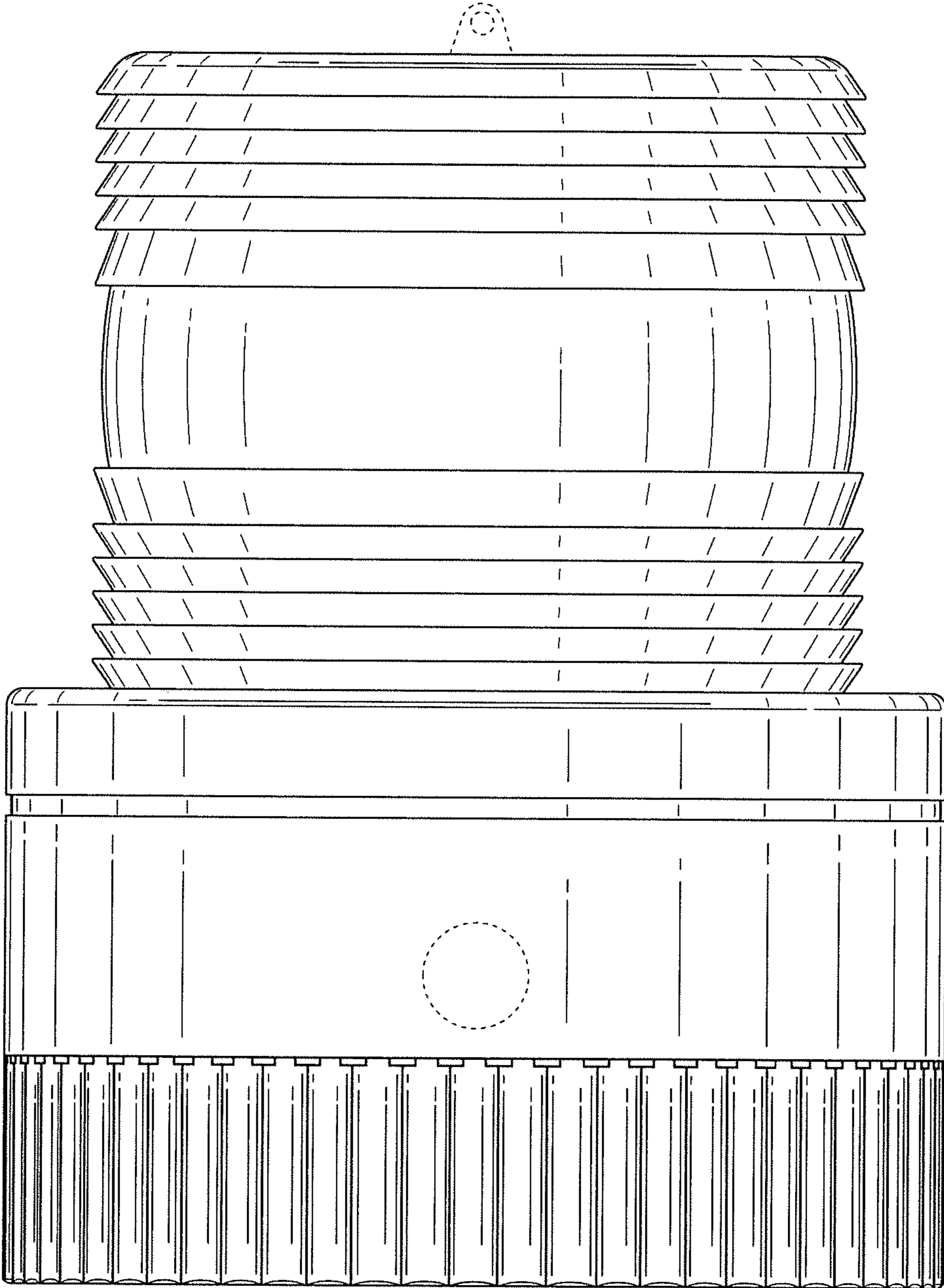

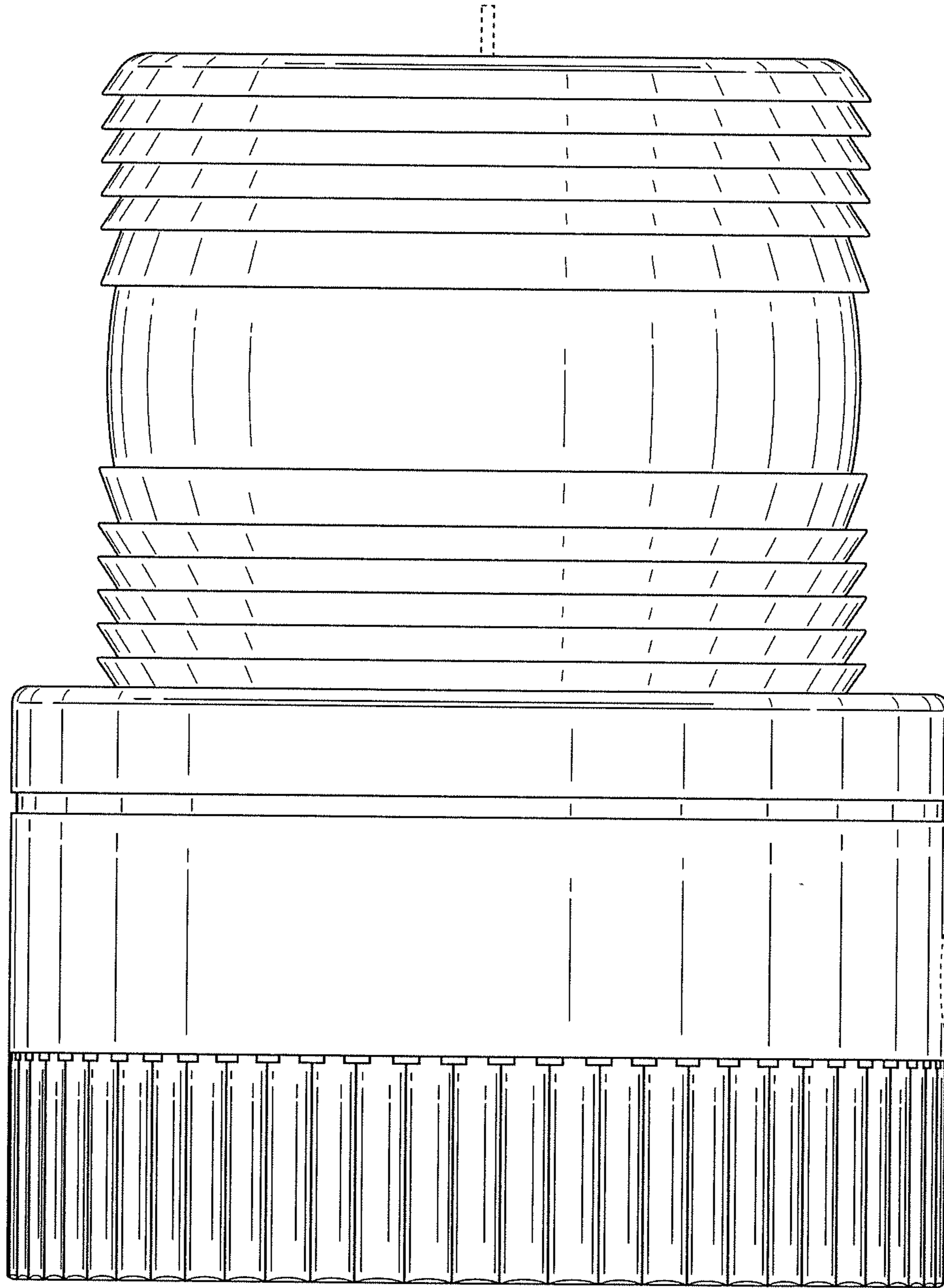

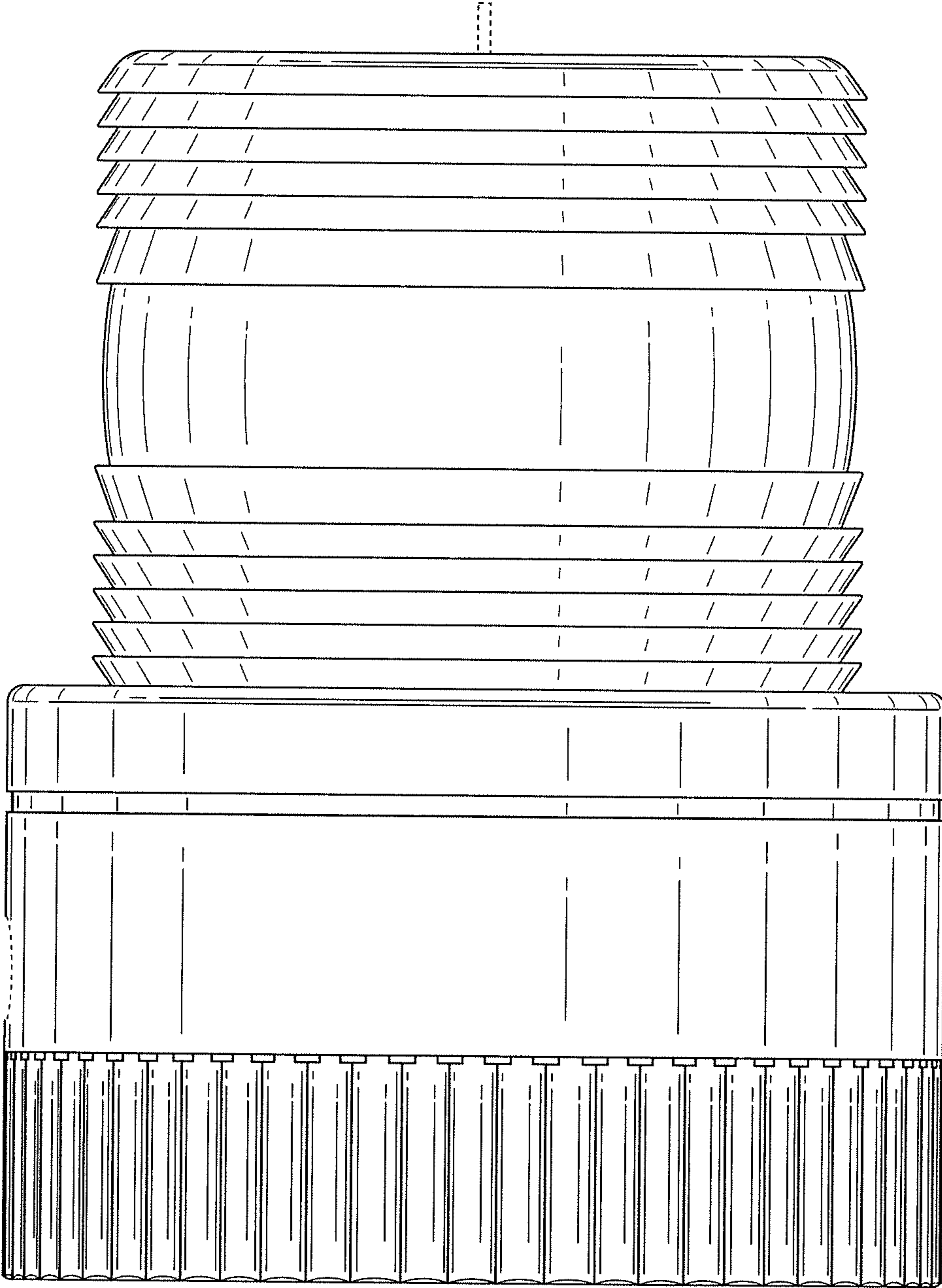

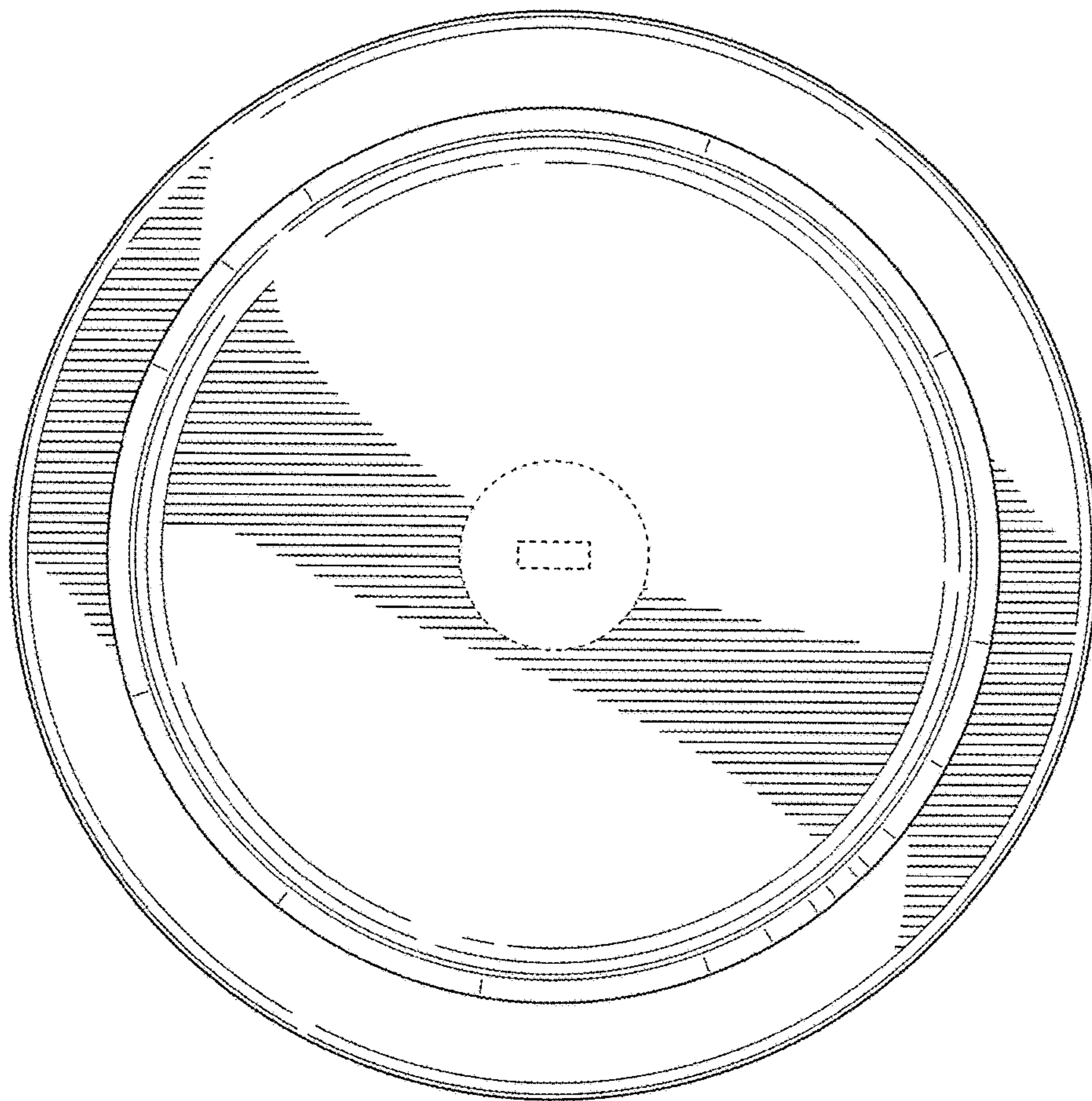

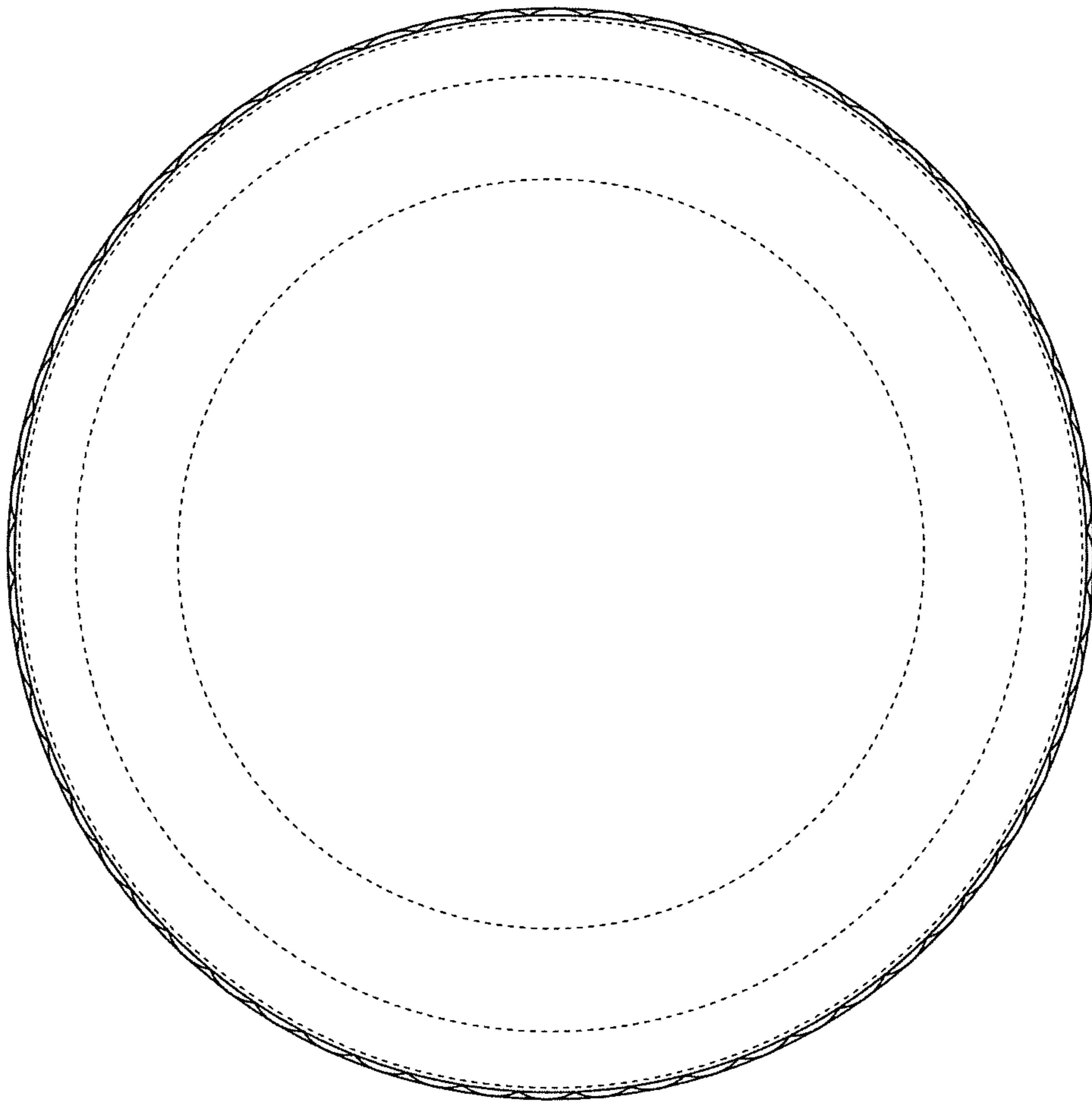
