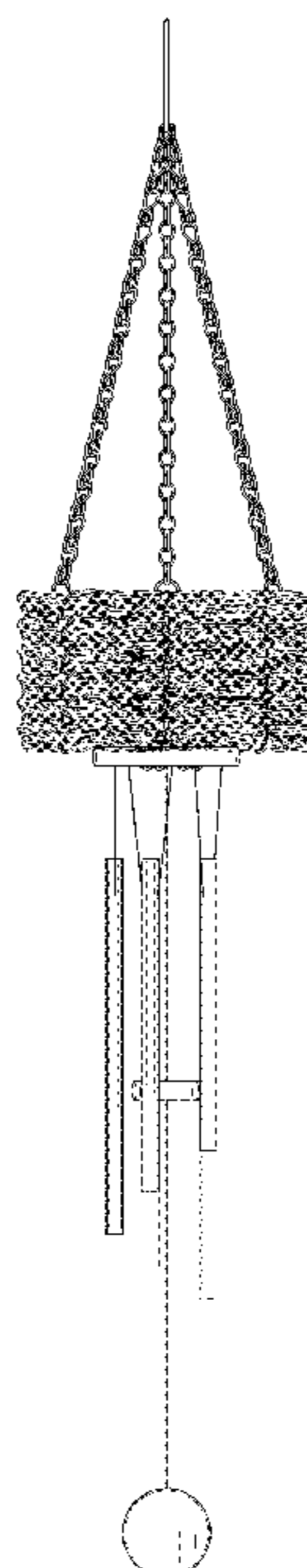
(57) **CLAIM**

The ornamental design for a combined hanging basket and wind chimes, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged top view of the combined hanging basket and wind chimes, showing my new design;

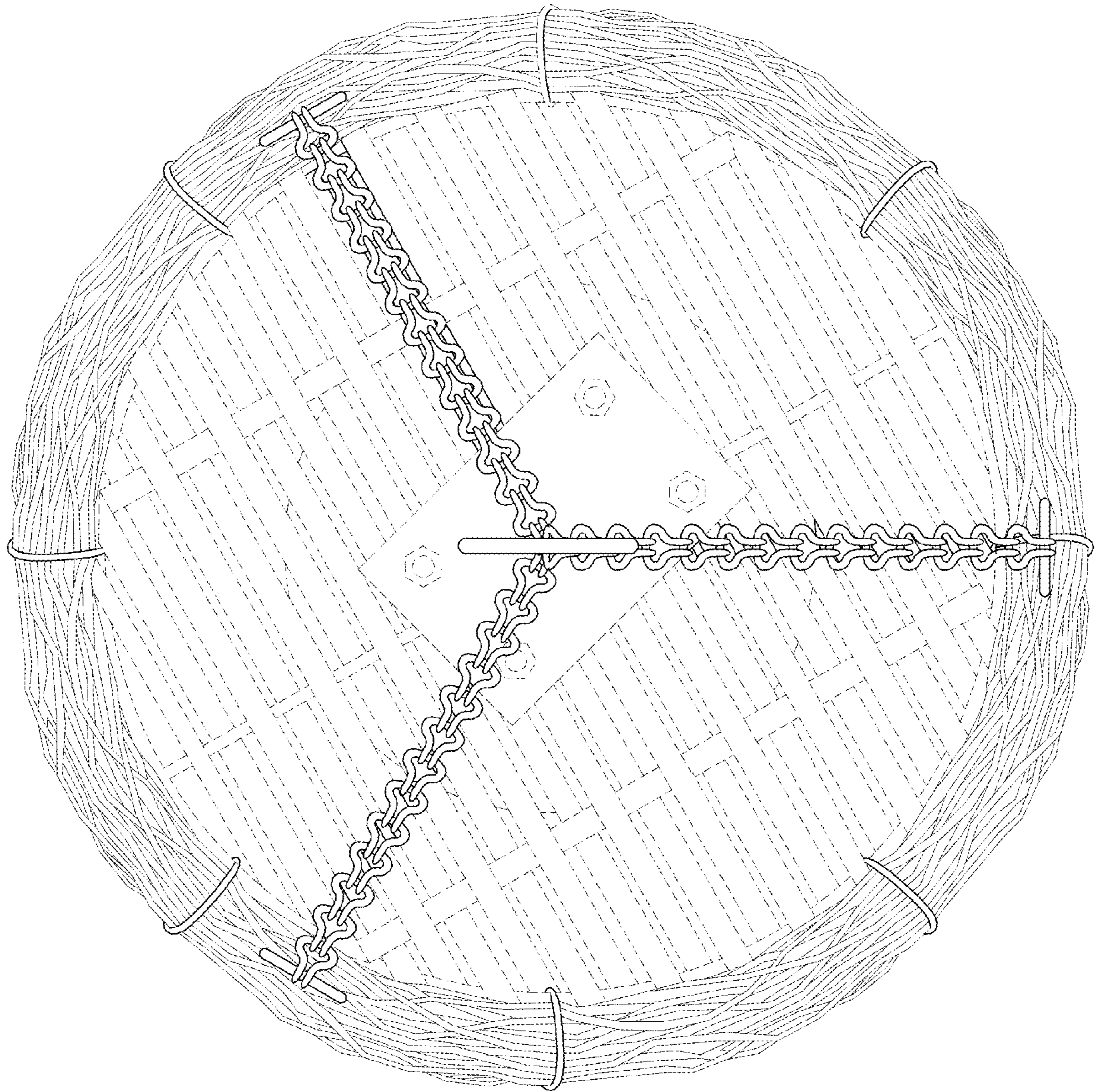

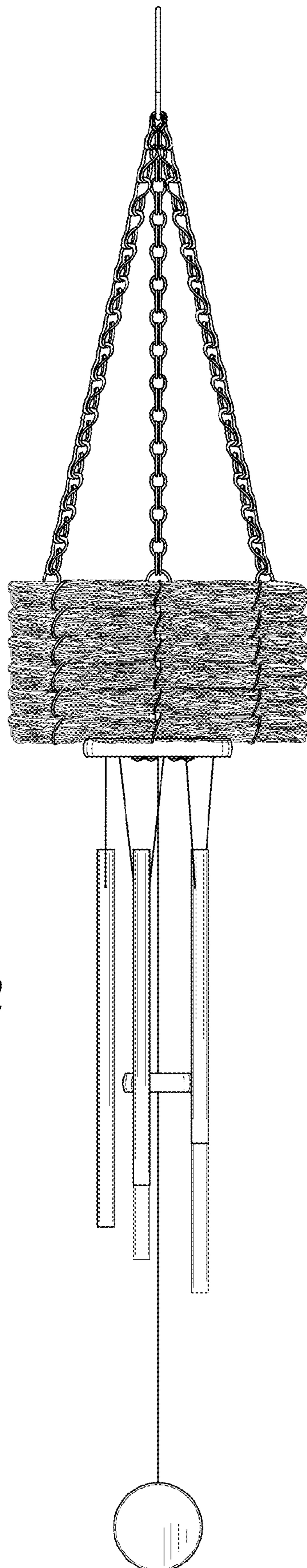

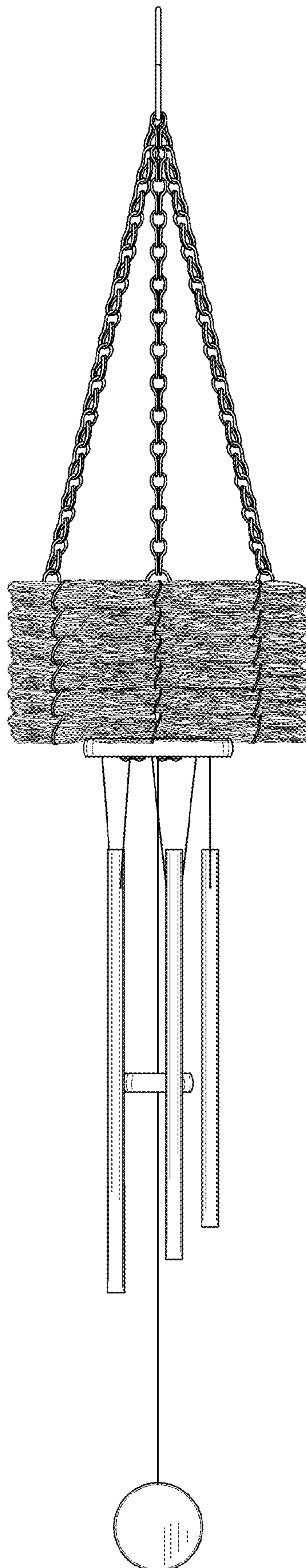
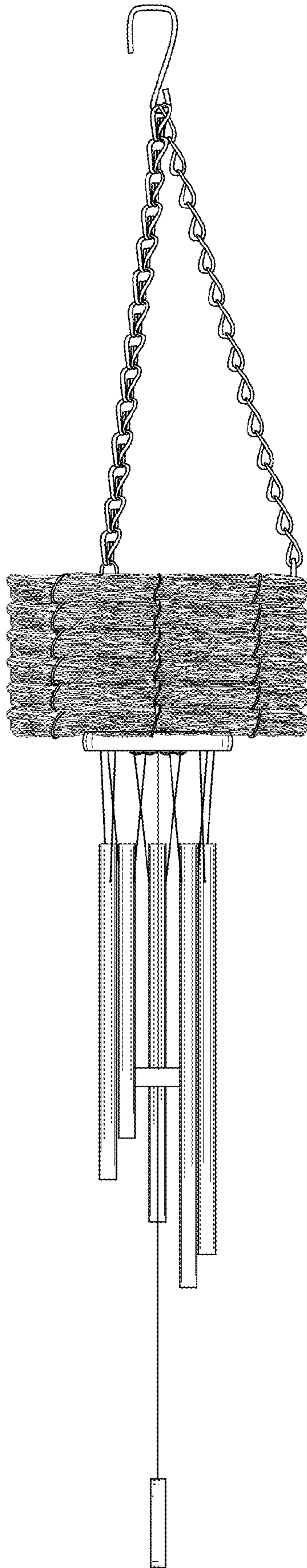

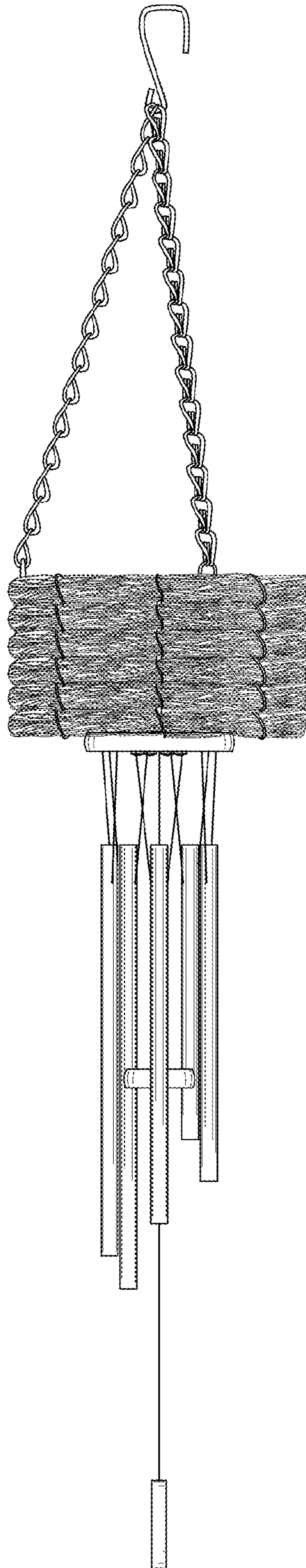

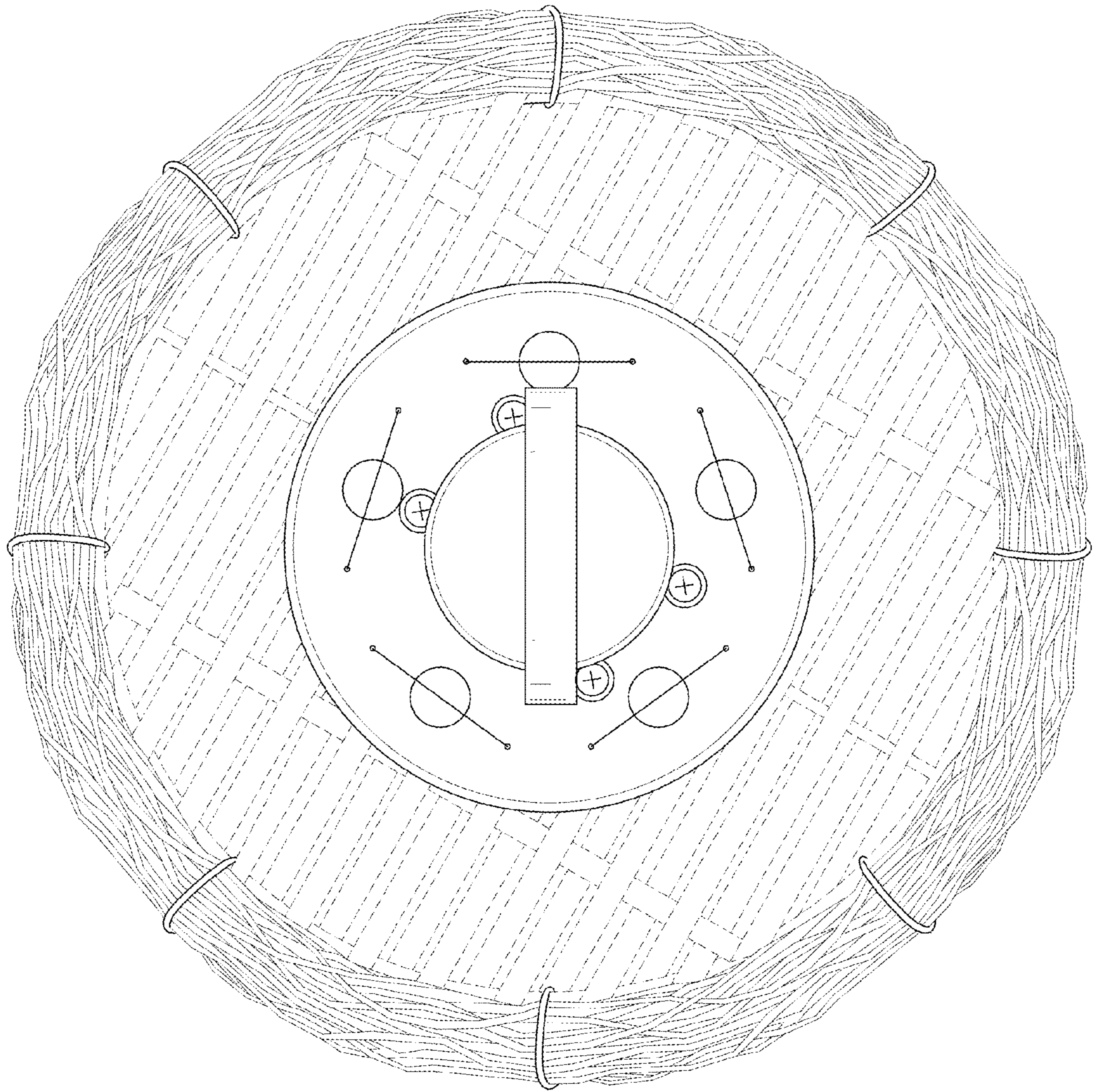
