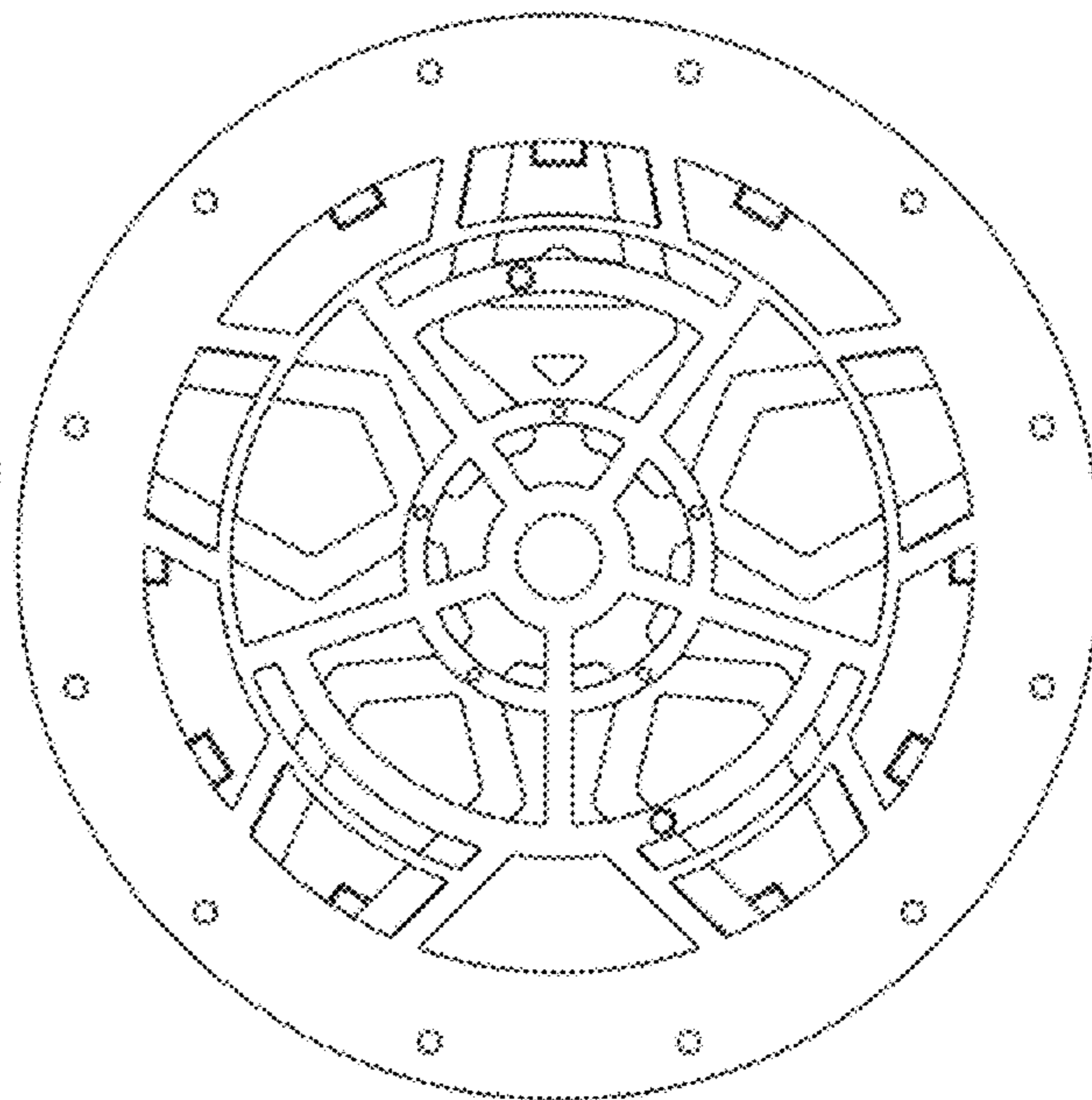
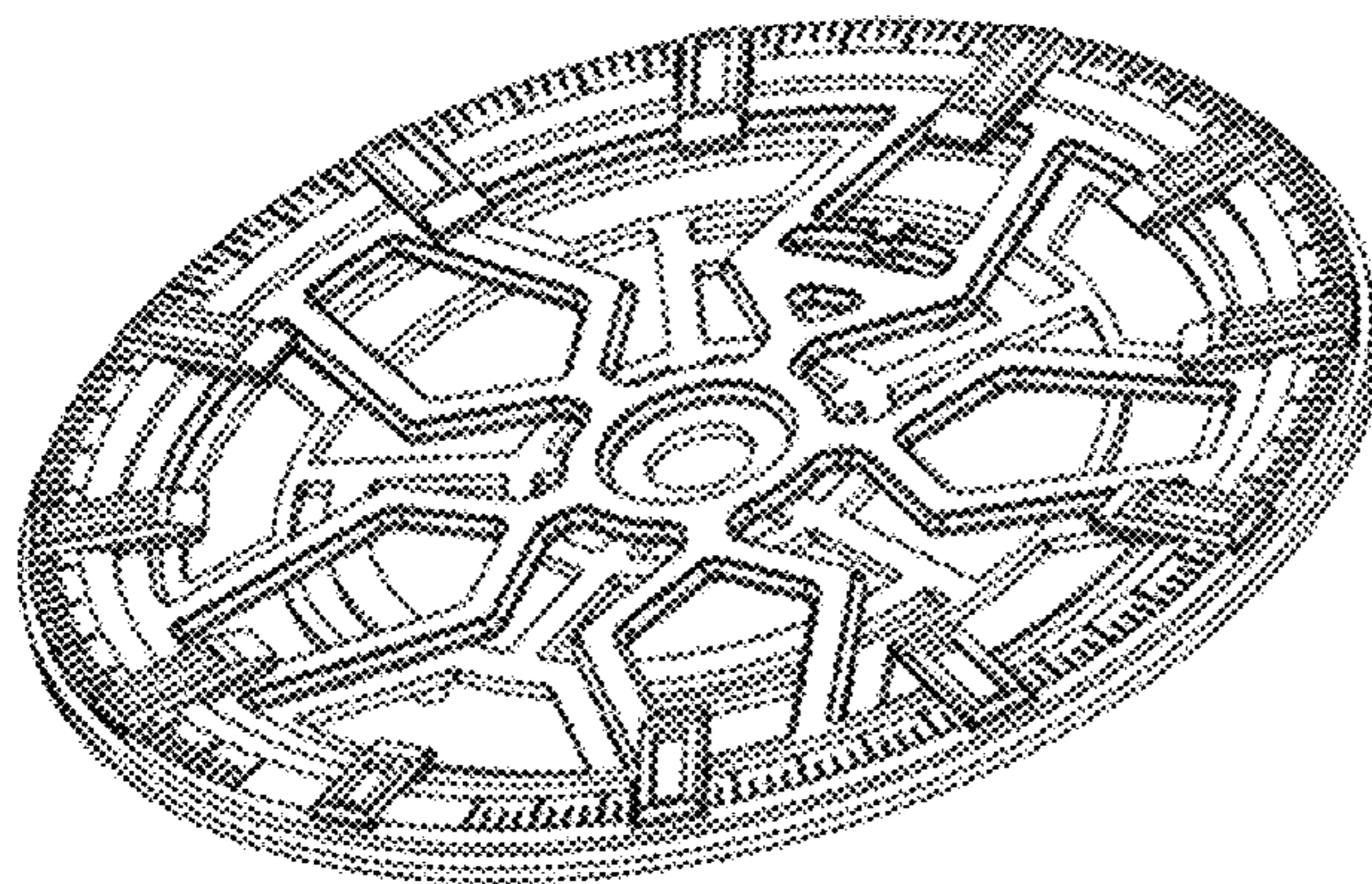
The ornamental design for a watch dial, as shown and described.

**DESCRIPTION**

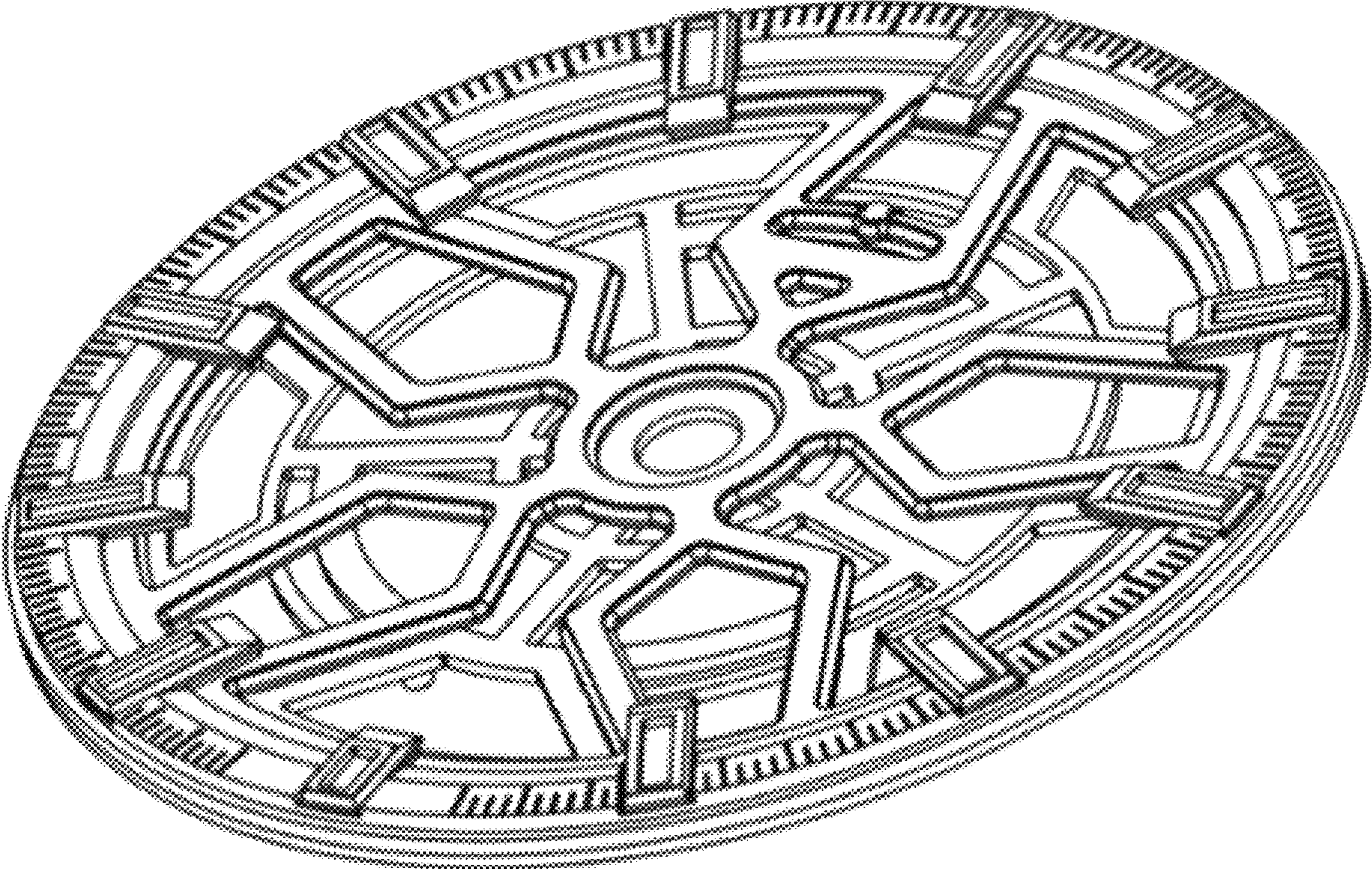
- 1. Watch dial

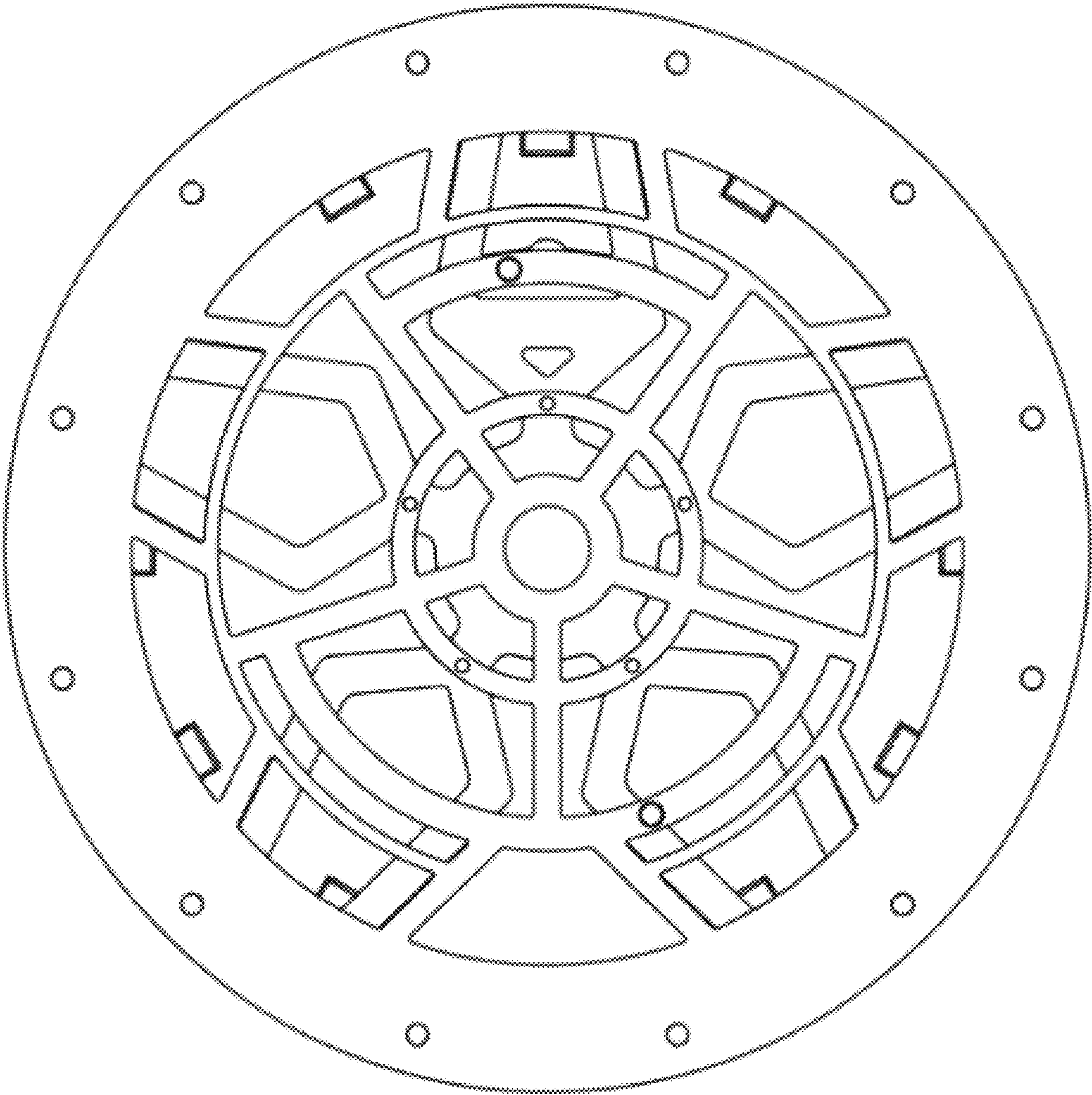

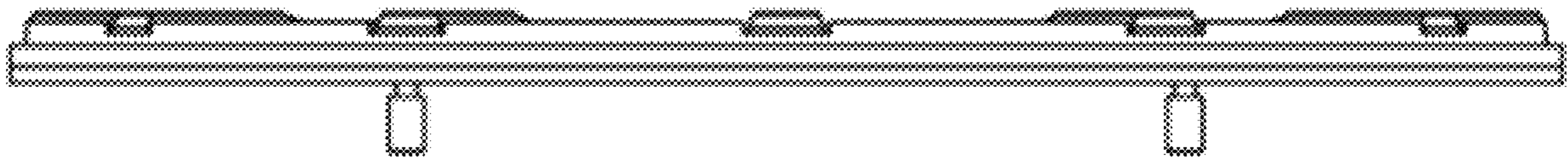

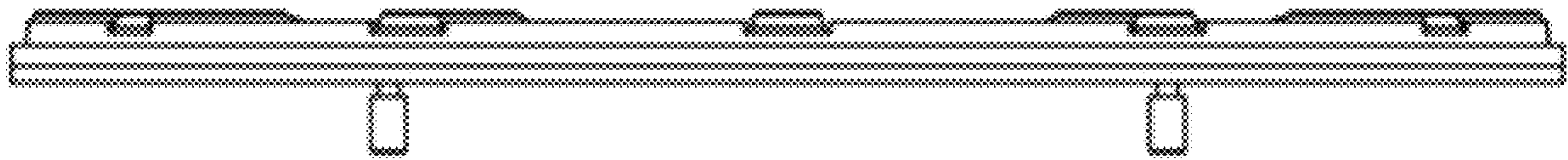

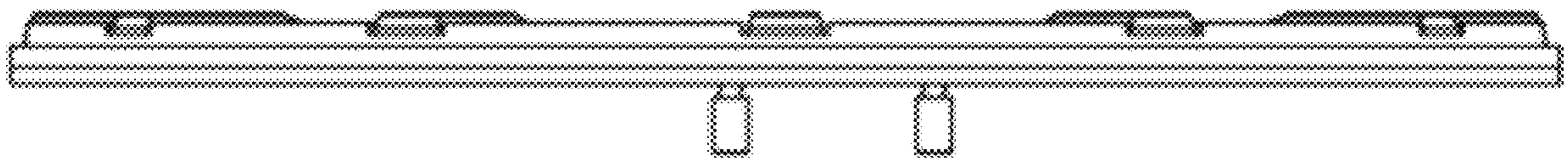

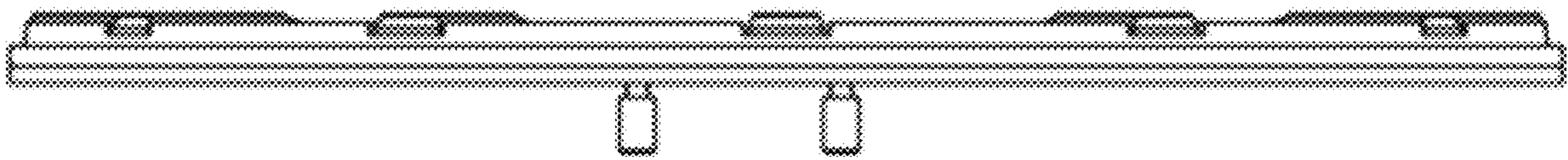
