DESCRIPTION

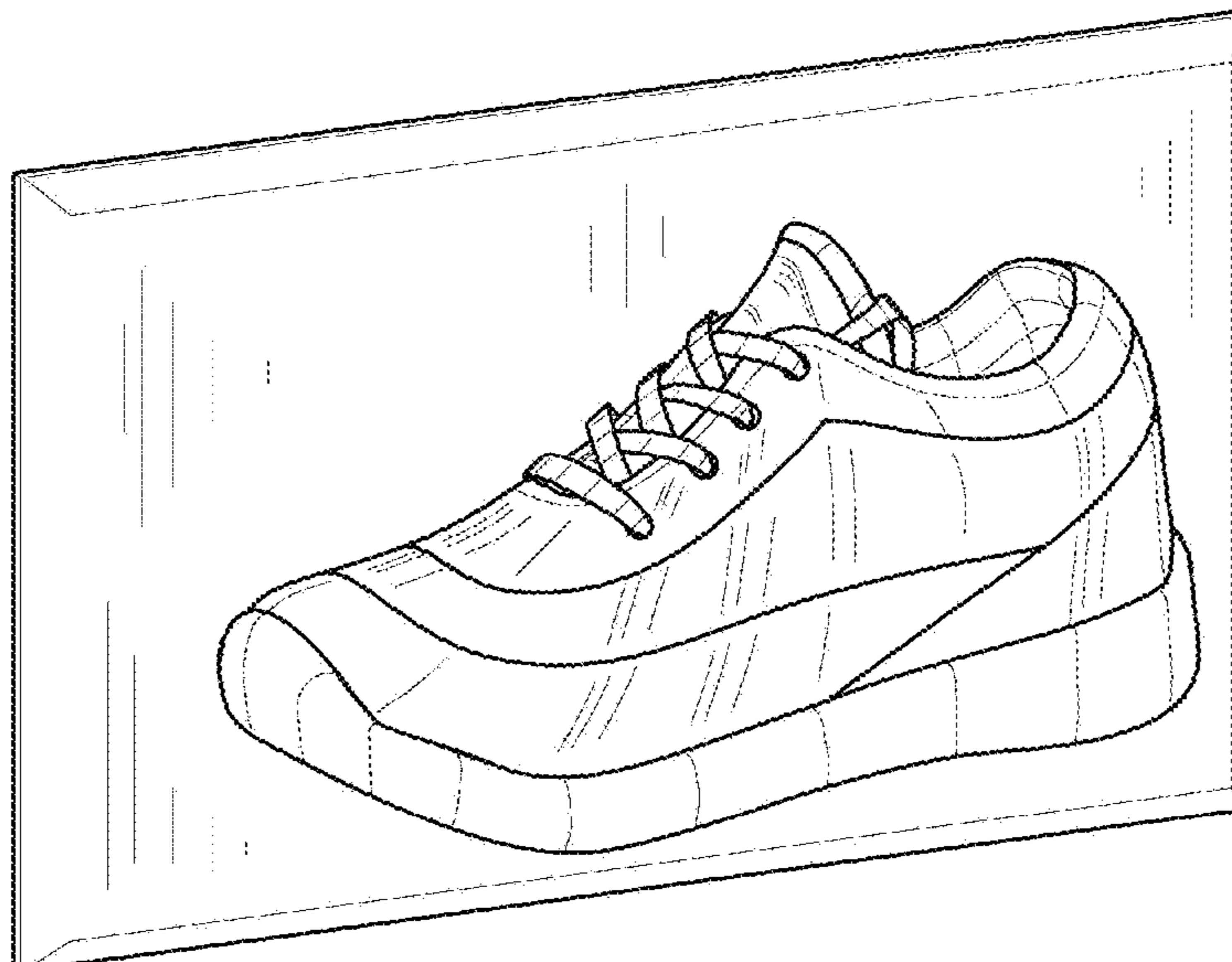
FIG. 1 is a front perspective view of the shoe plaque showing my new design;

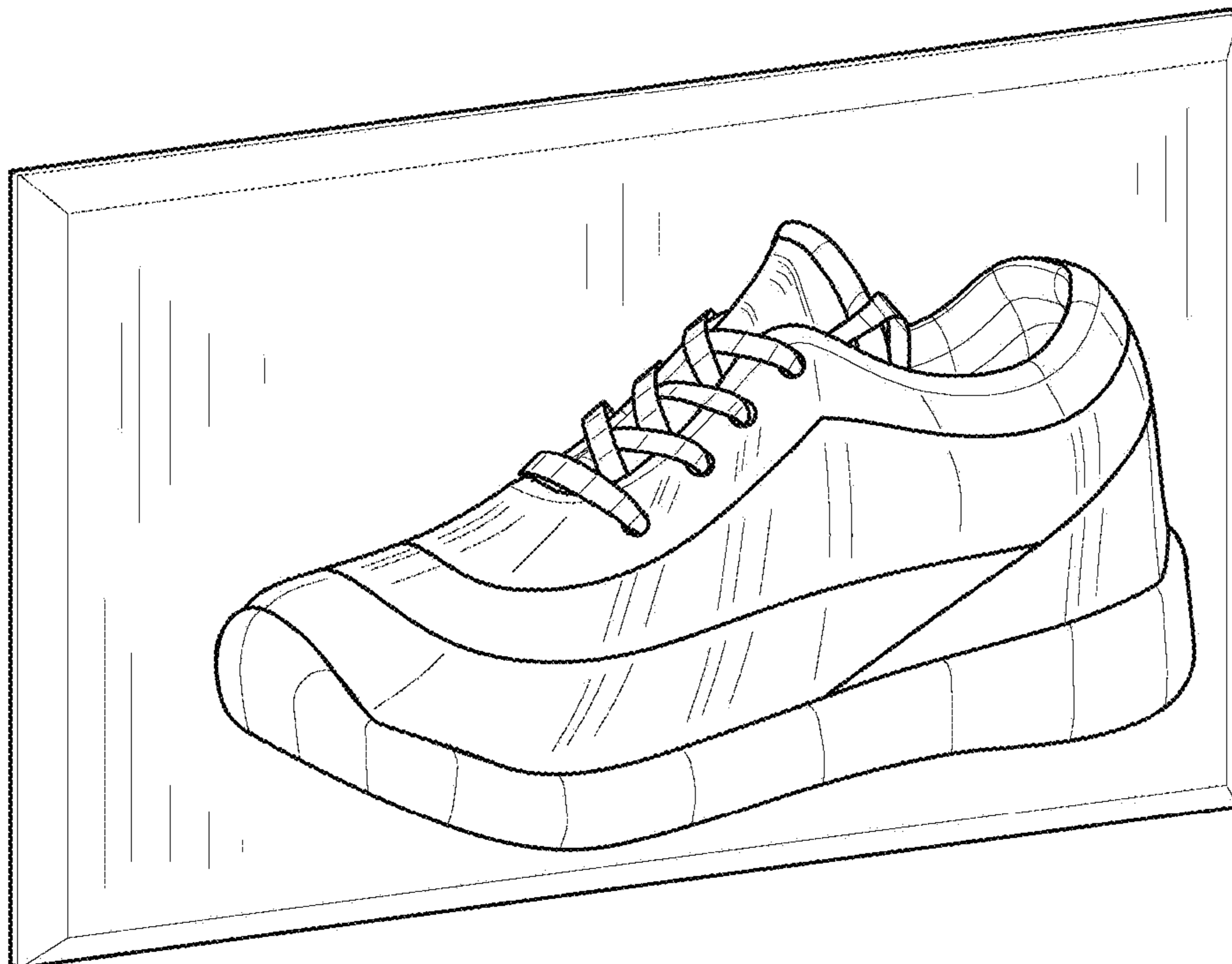

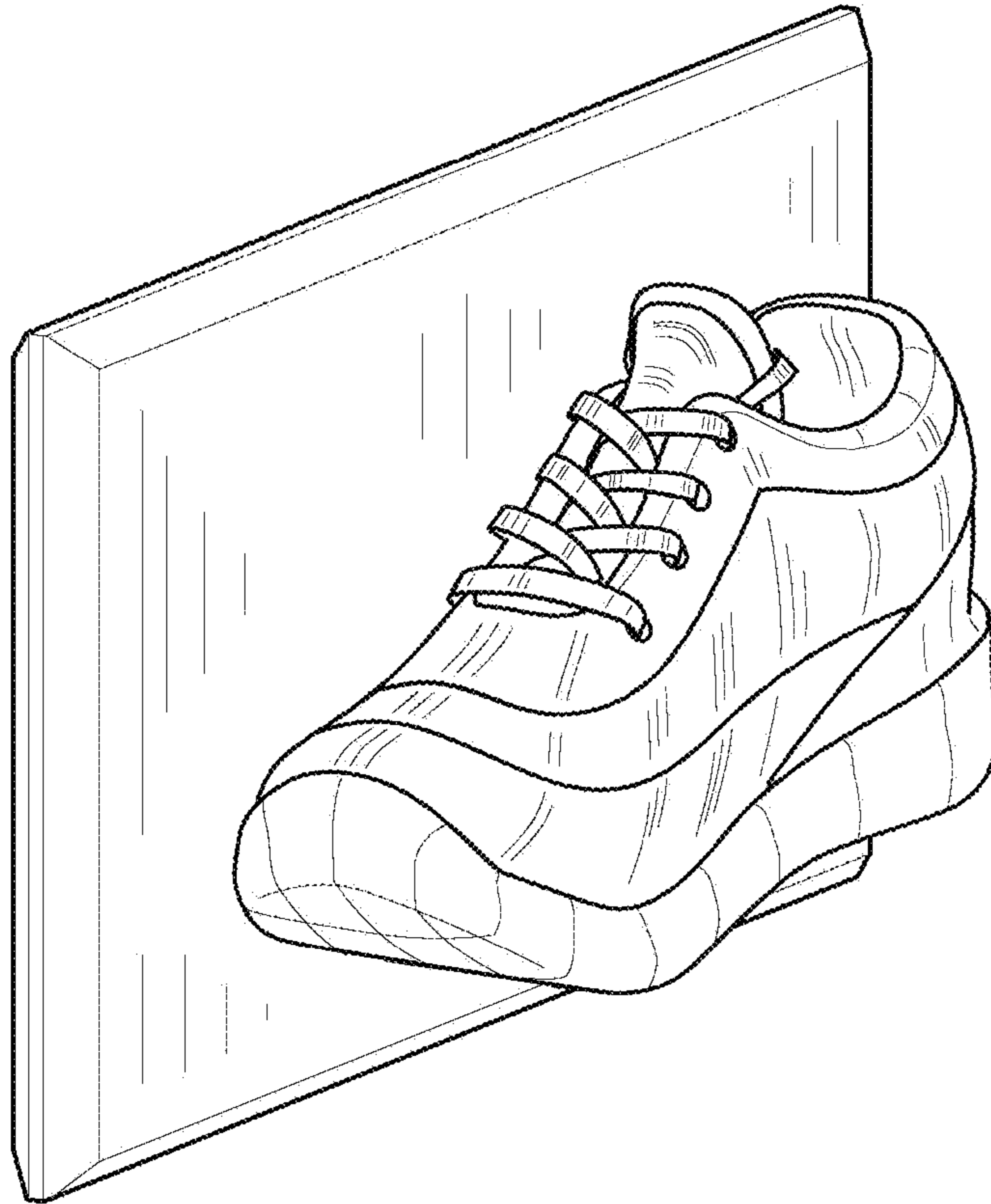

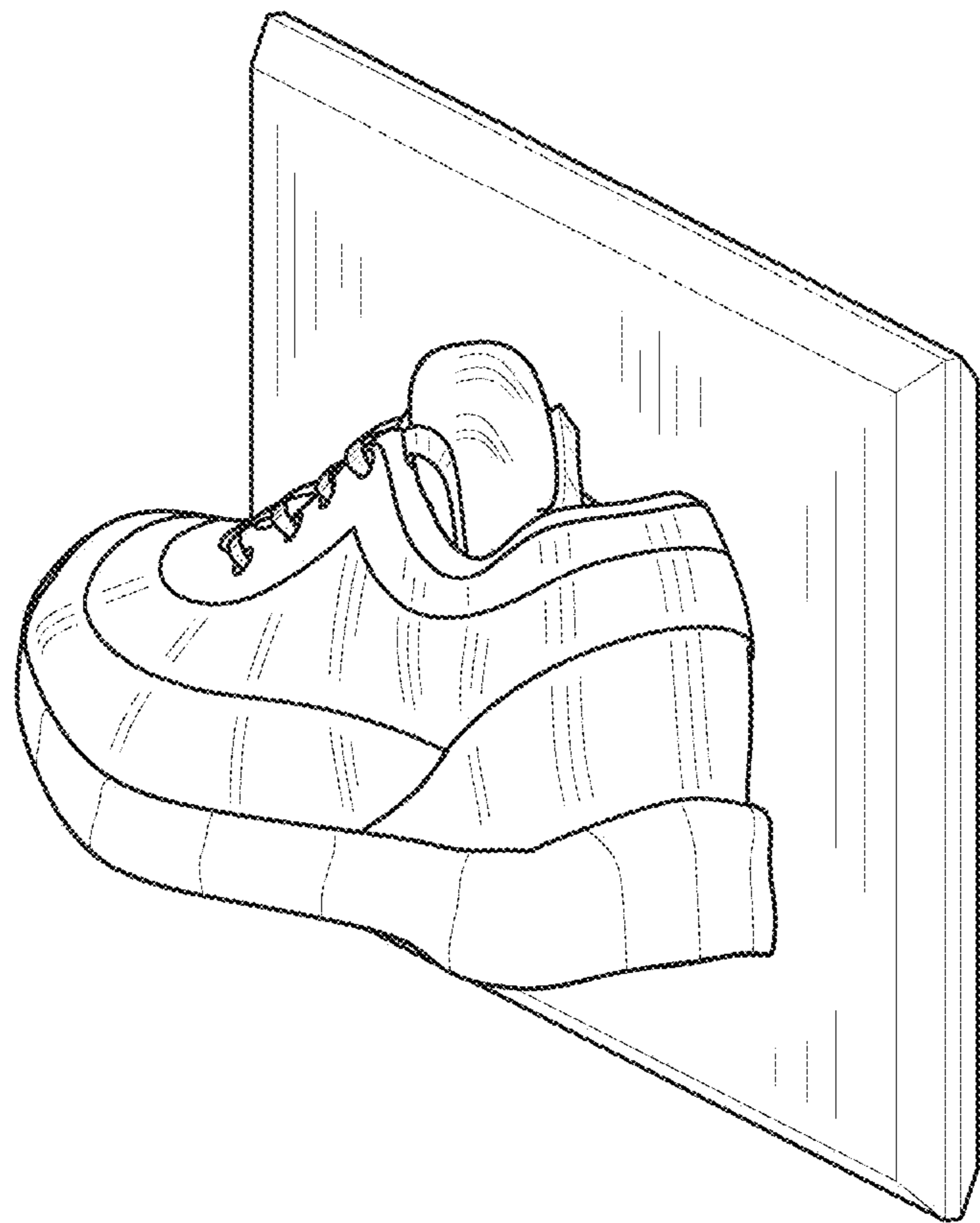

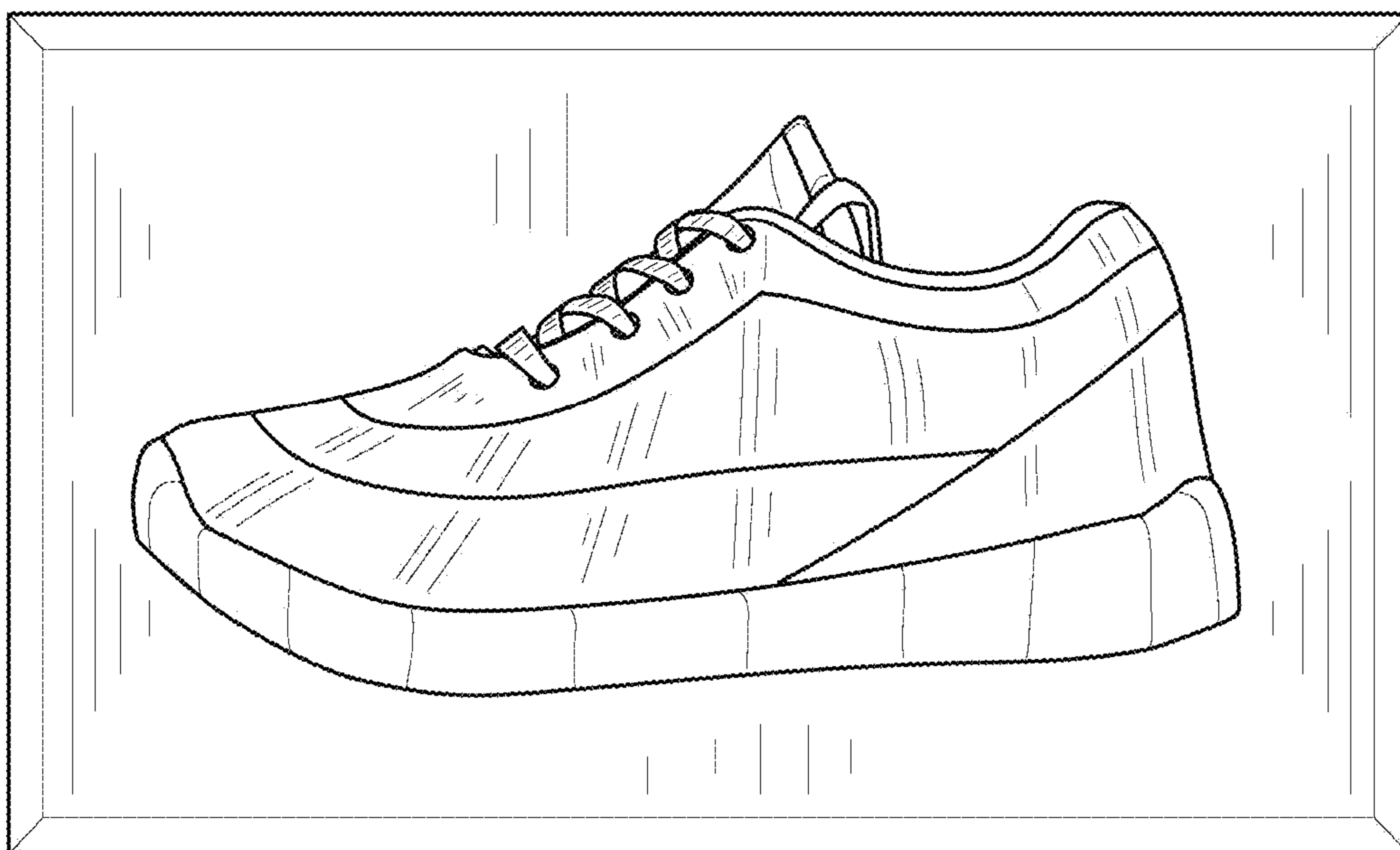

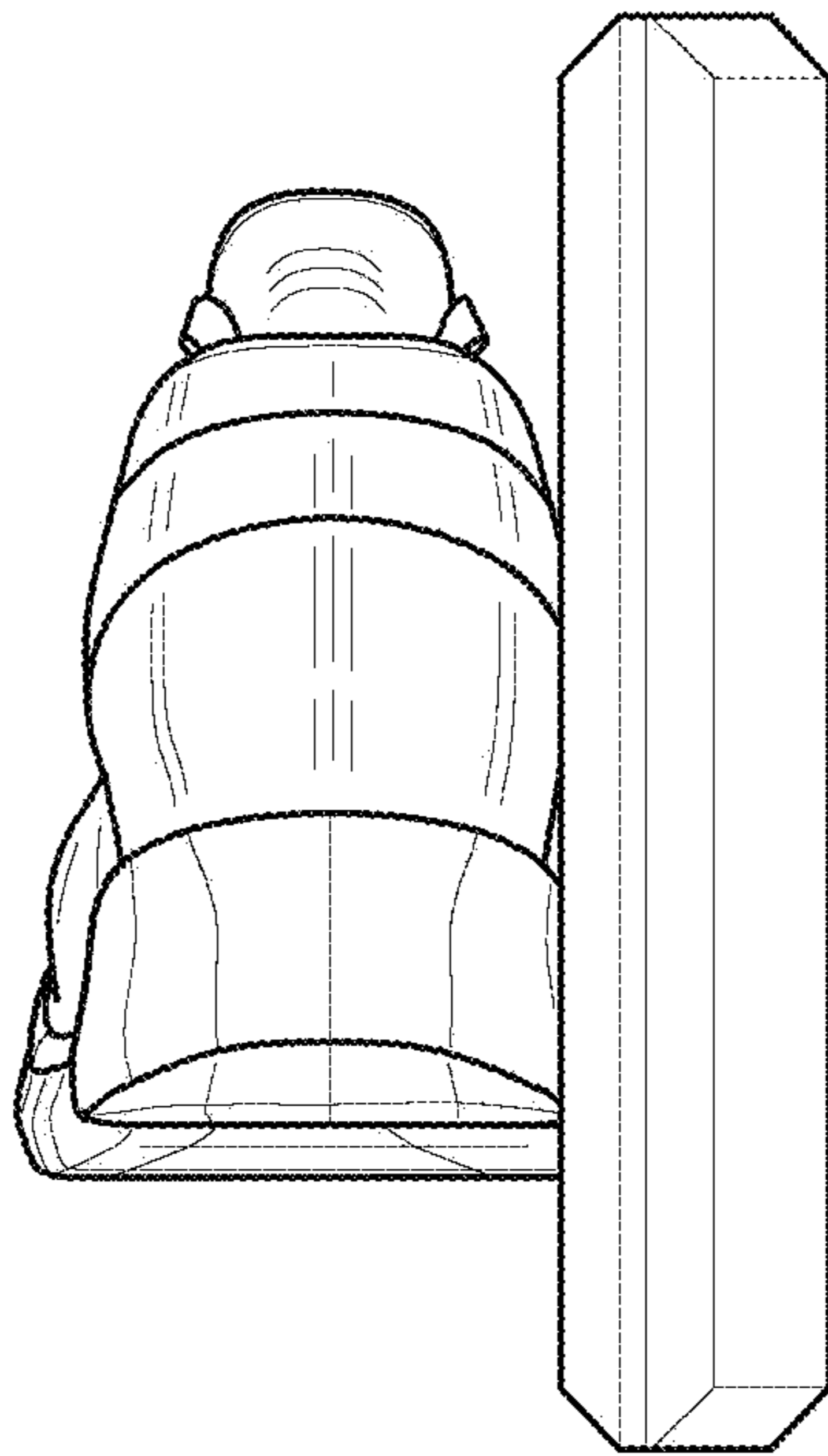

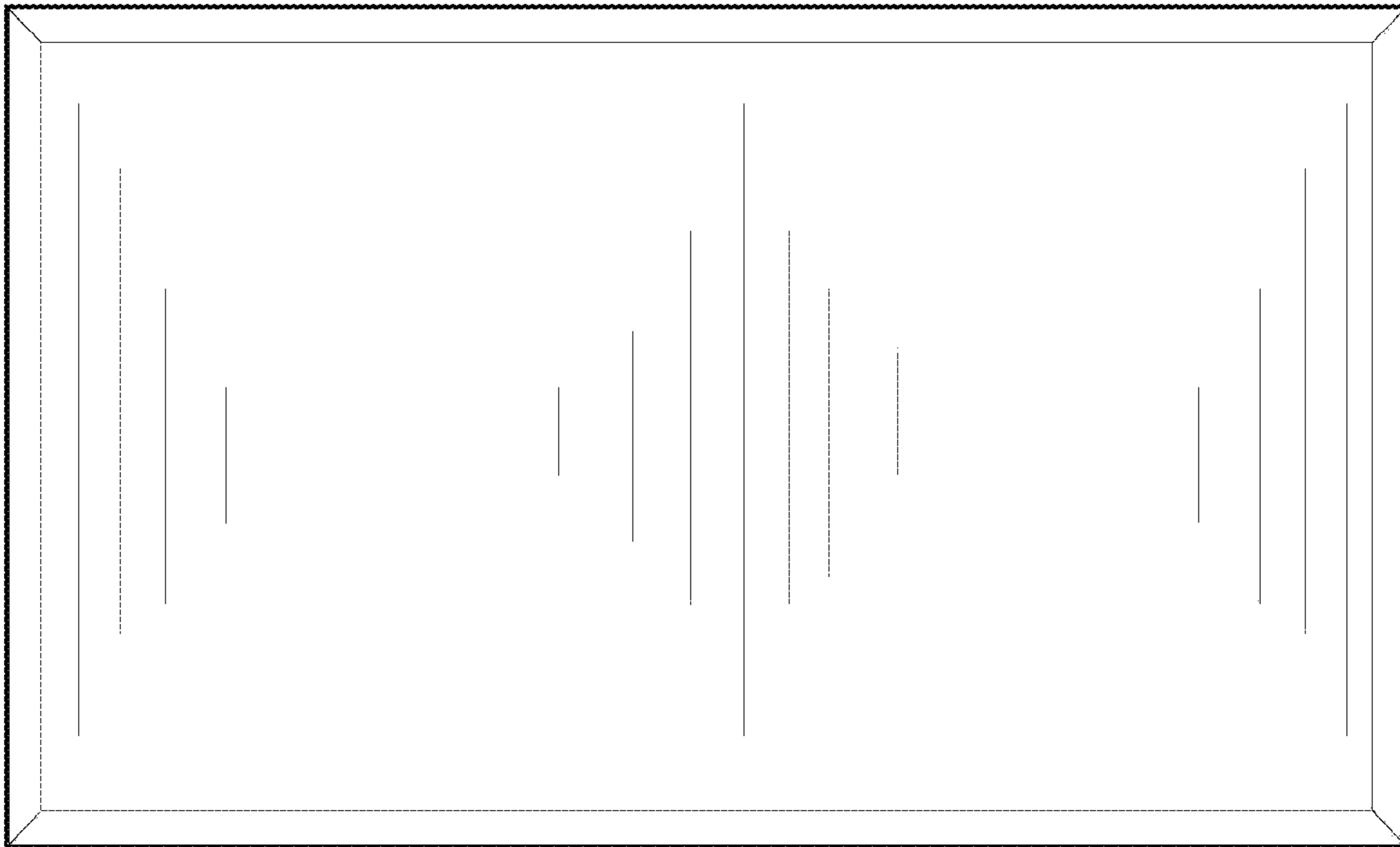

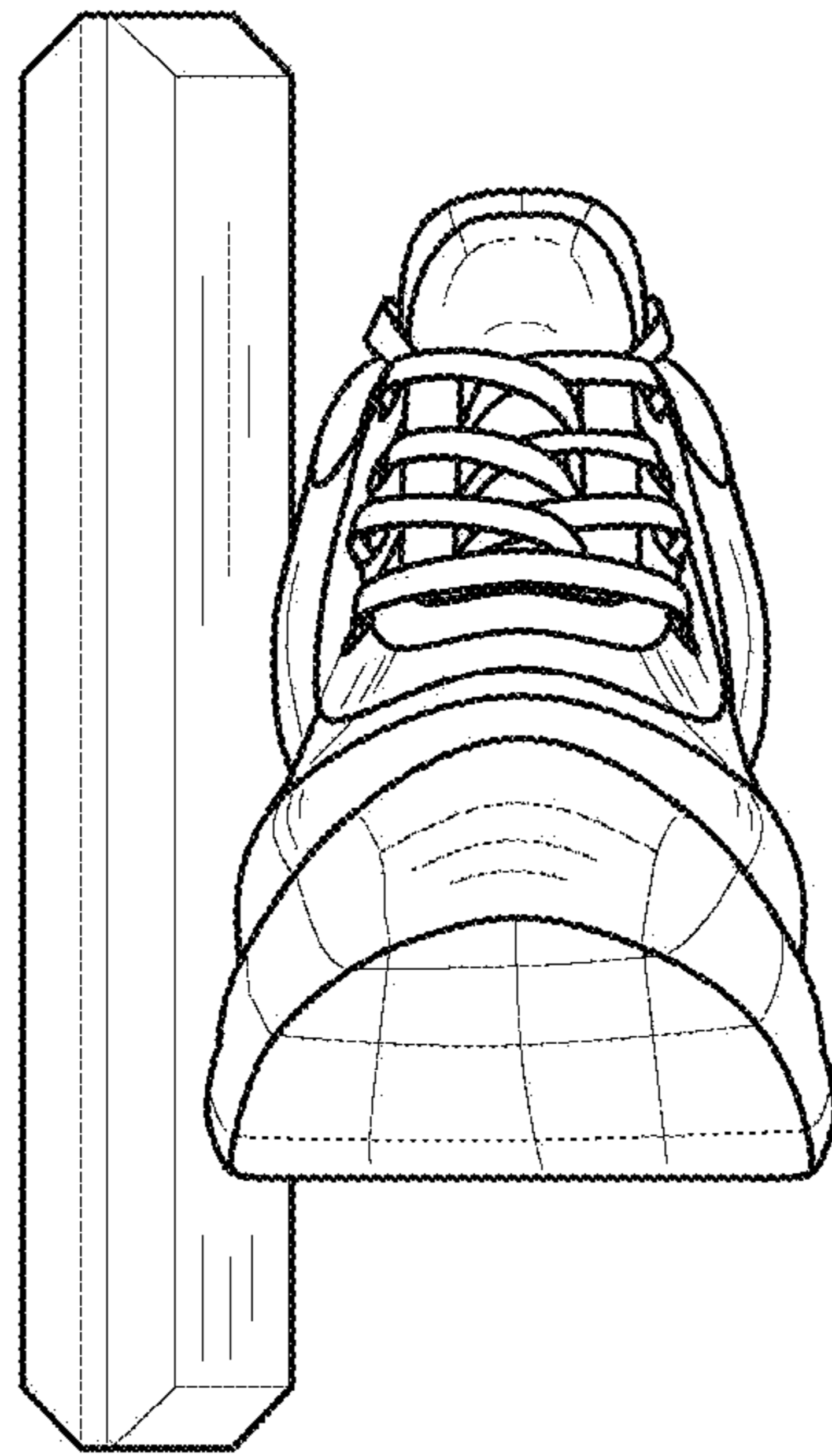

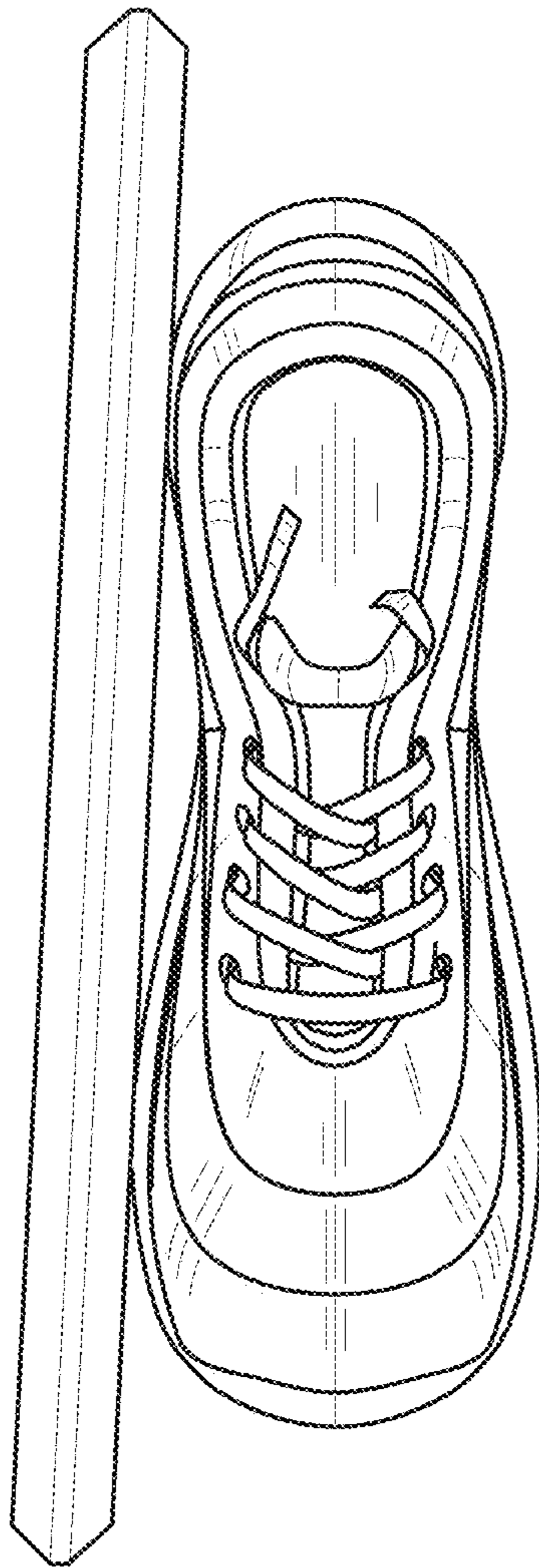

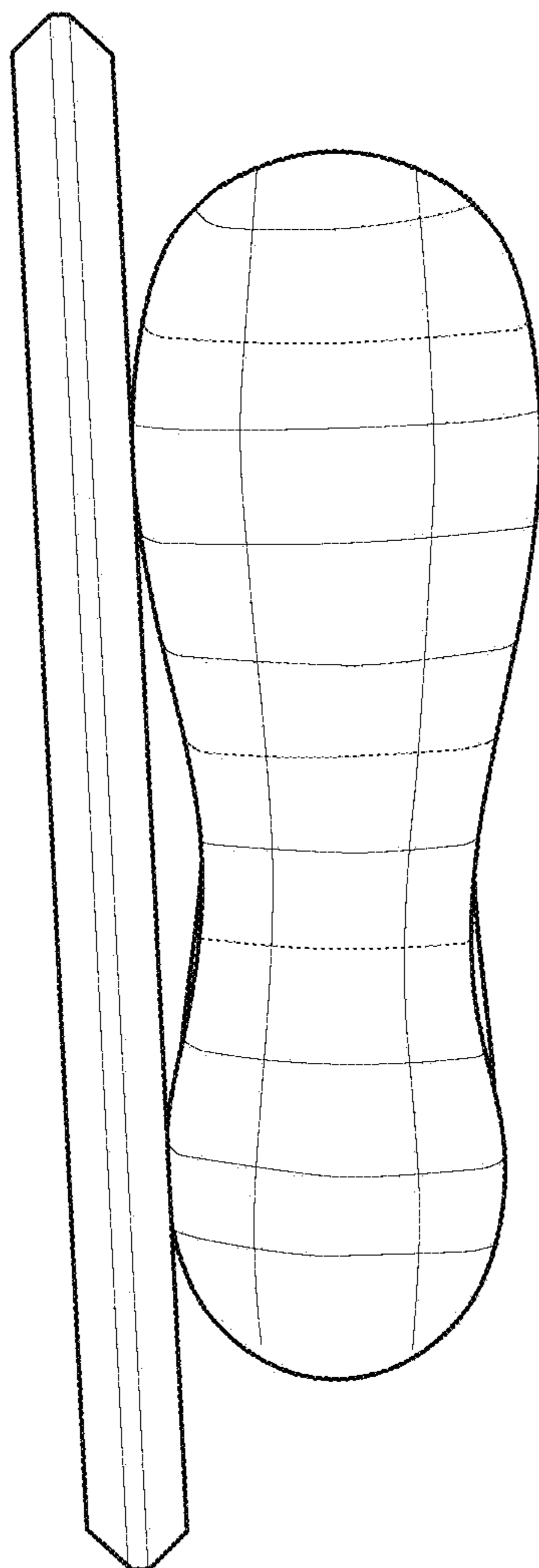
