DESCRIPTION

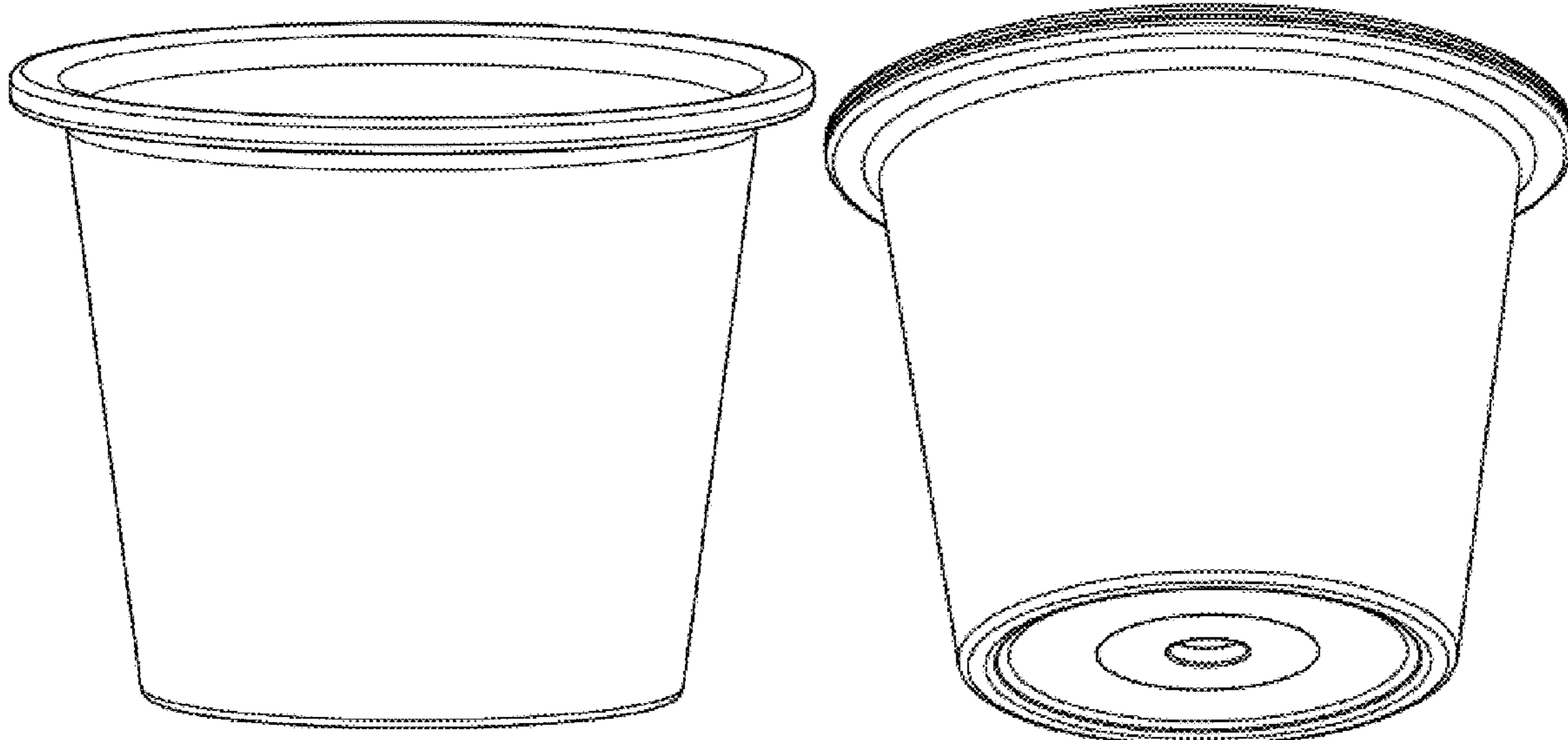
FIG. 1 is a perspective view of a flower pot cover showing my new design;

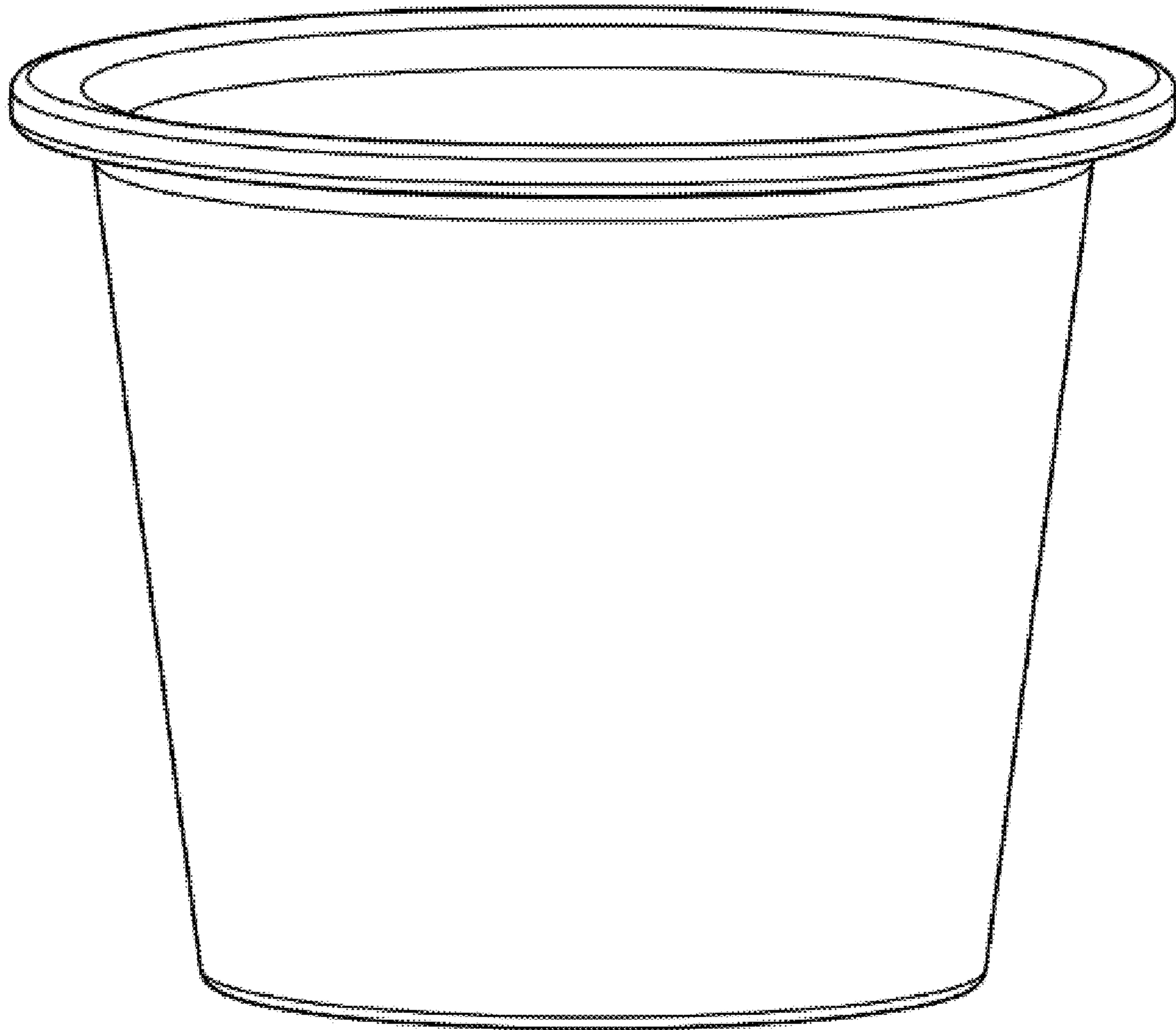

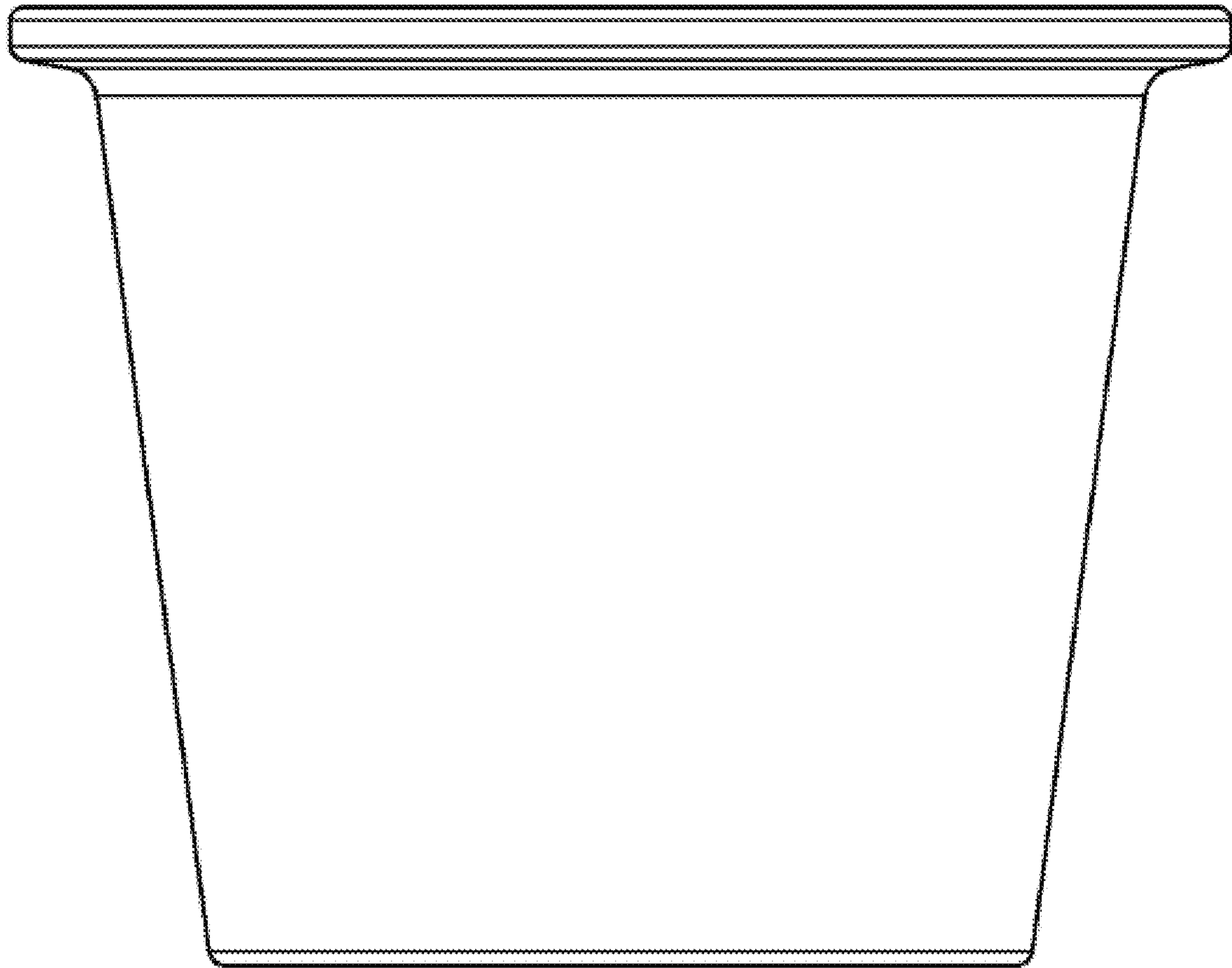

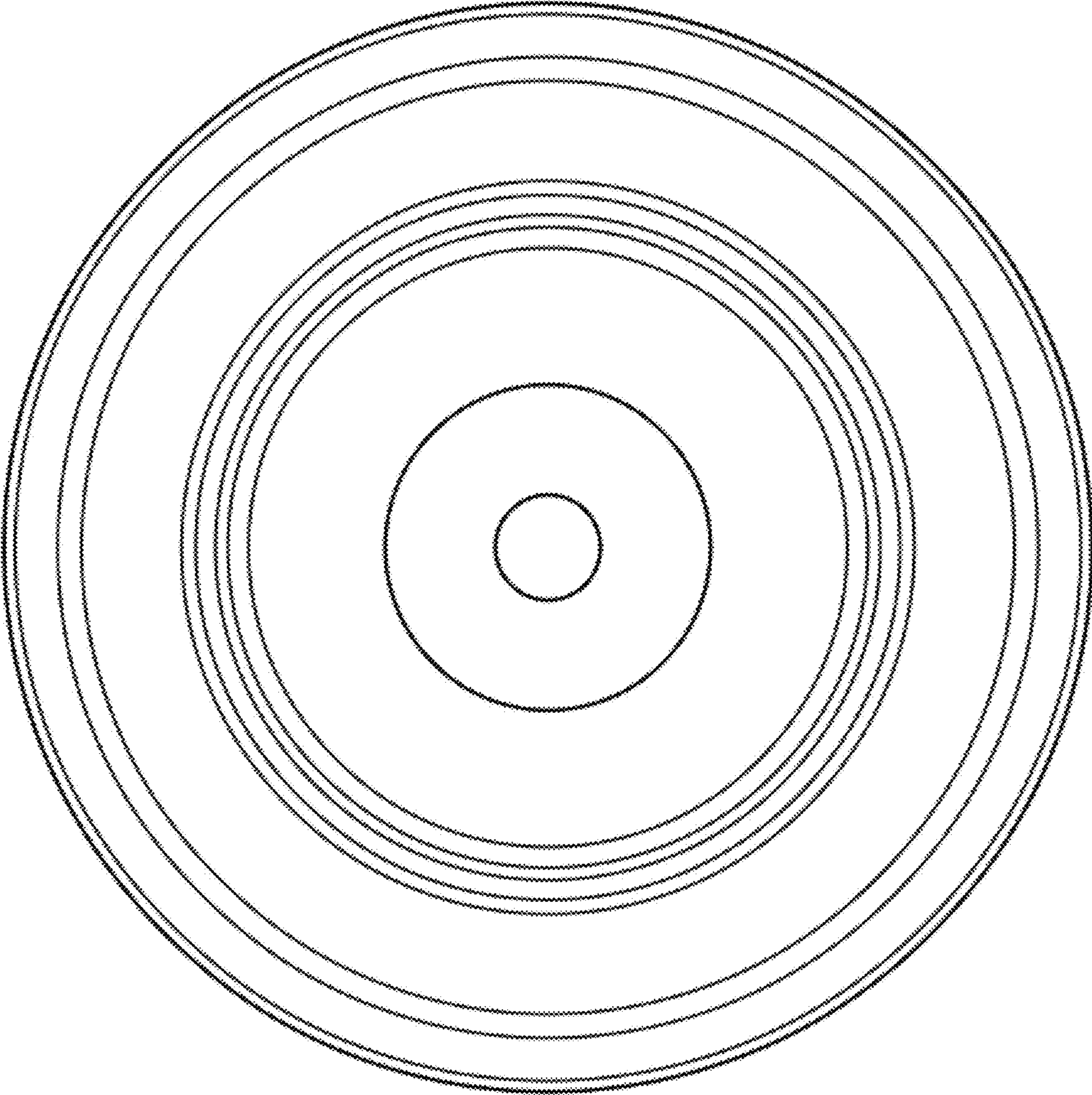

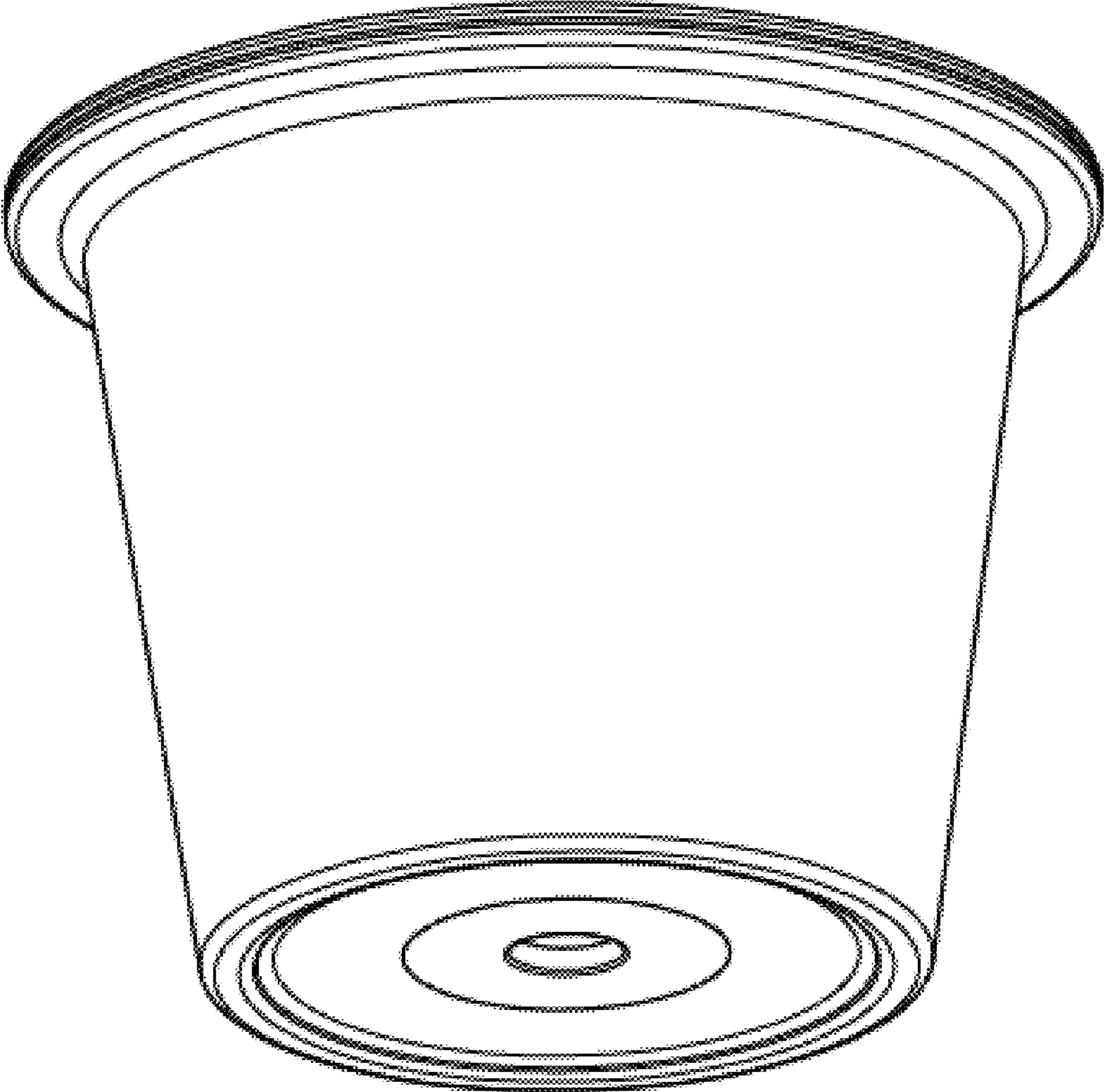
