DESCRIPTION

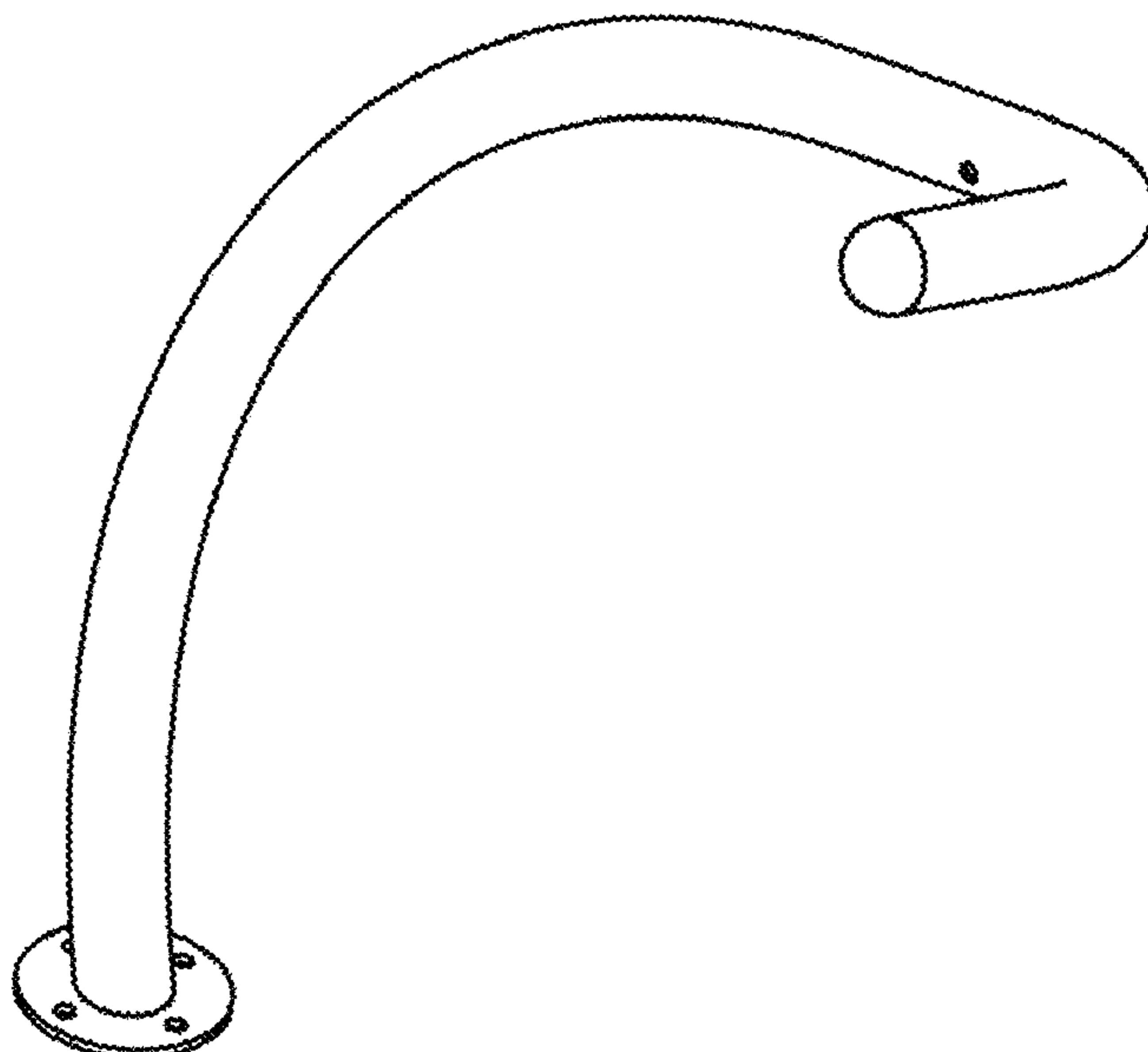
FIG. 1 is a perspective view of a bicycle rack showing our new design.

FIG. 3 is a second side view of the bicycle rack.
FIG. 4 is a front view of the bicycle rack.

FIG. 6 is a perspective view of the bicycle rack in use with a like bicycle rack shown in broken lines; and,
FIG. 7 is a side view of the bicycle rack attached to a like bicycle rack, shown in broken lines, with a bicycle, shown in broken lines.

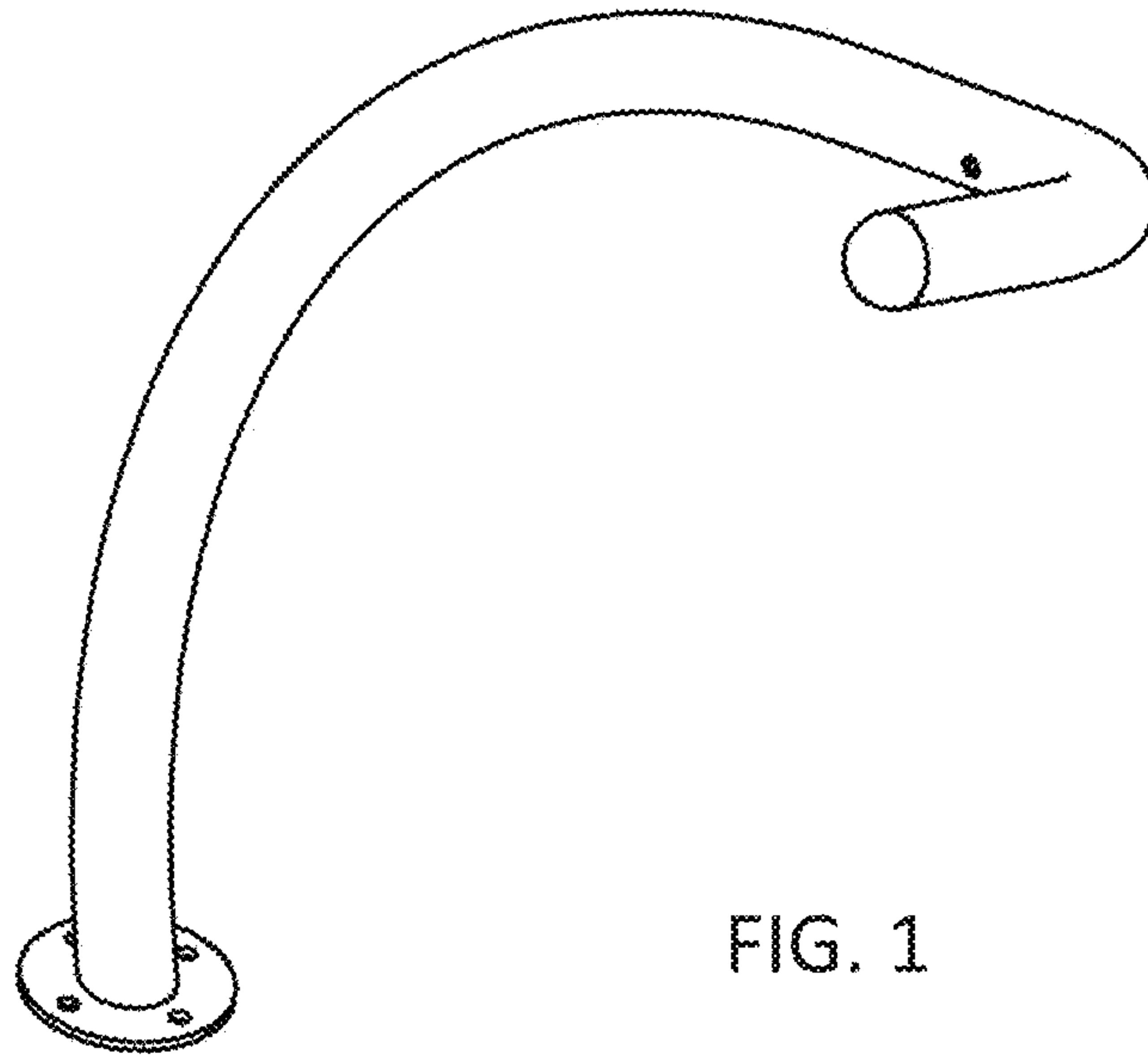

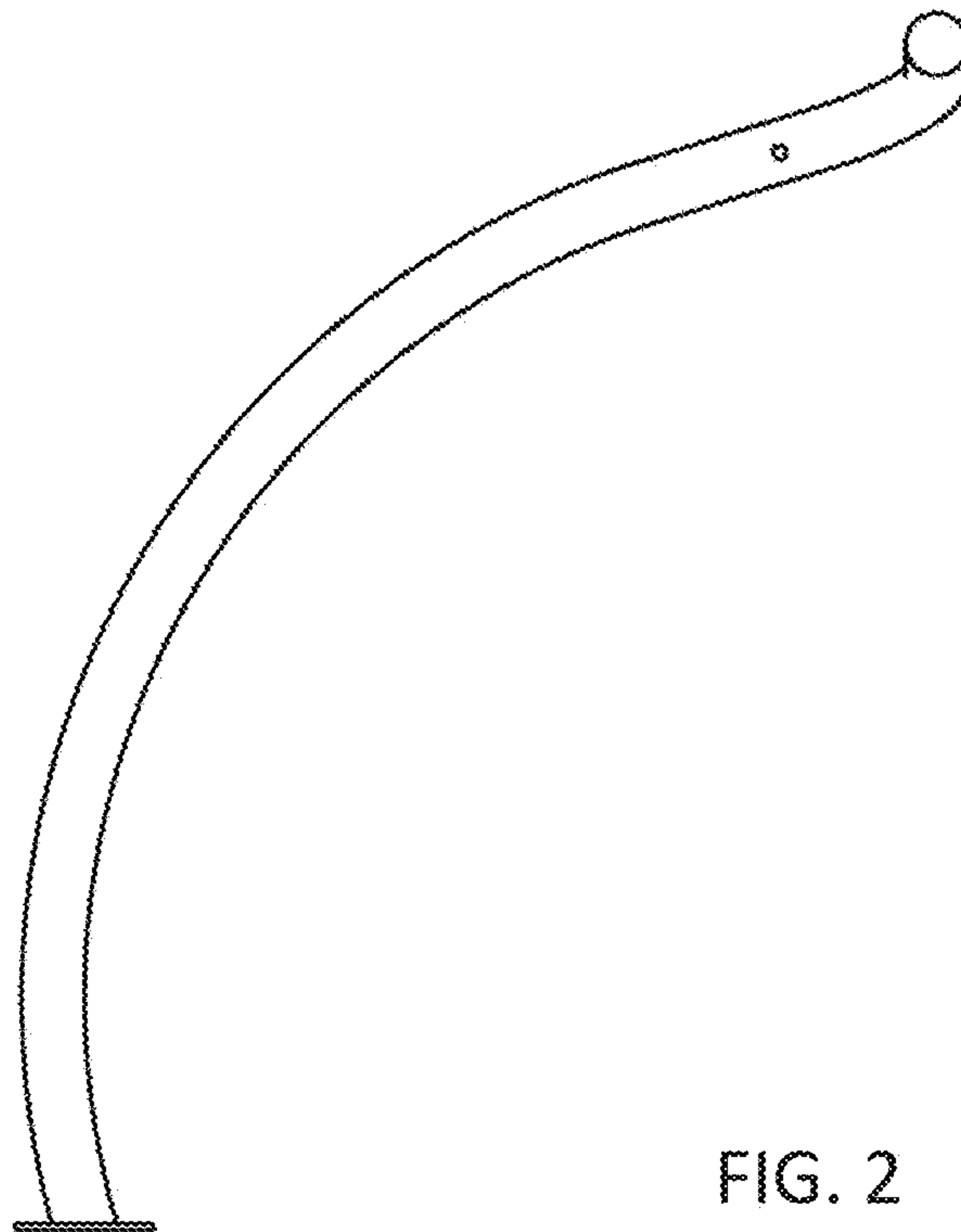

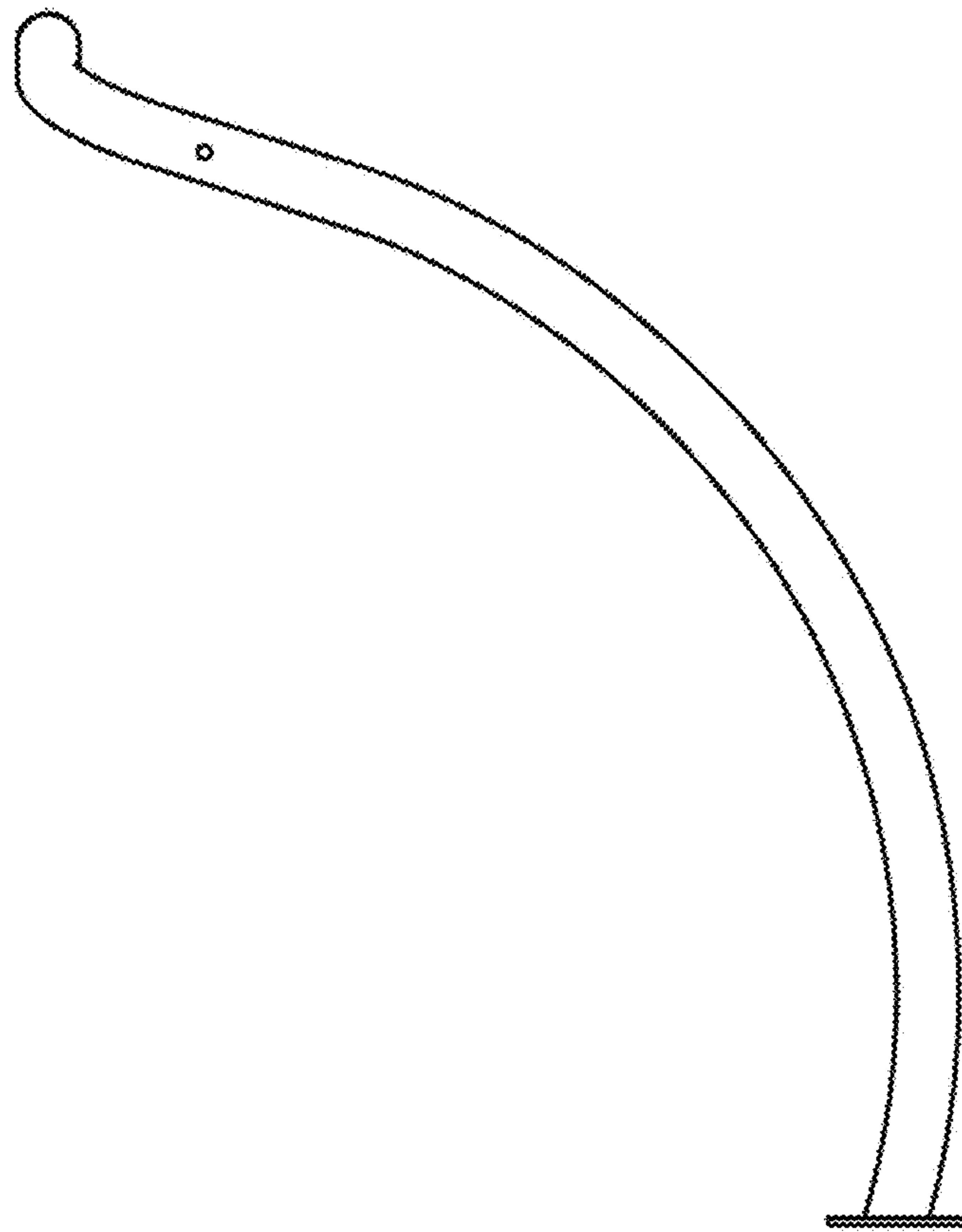

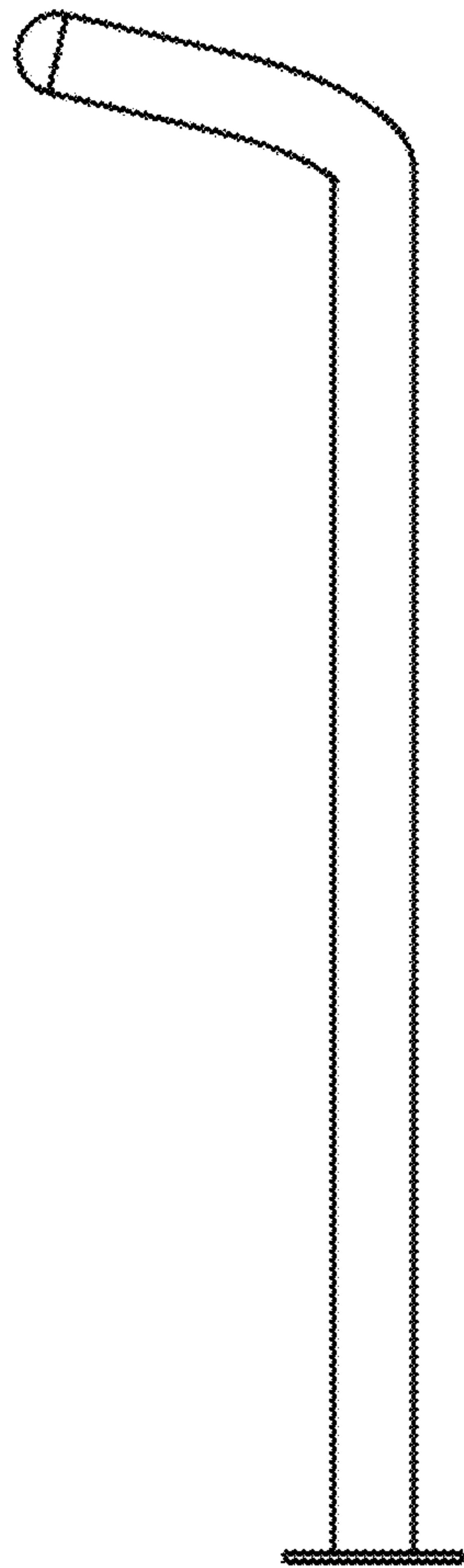

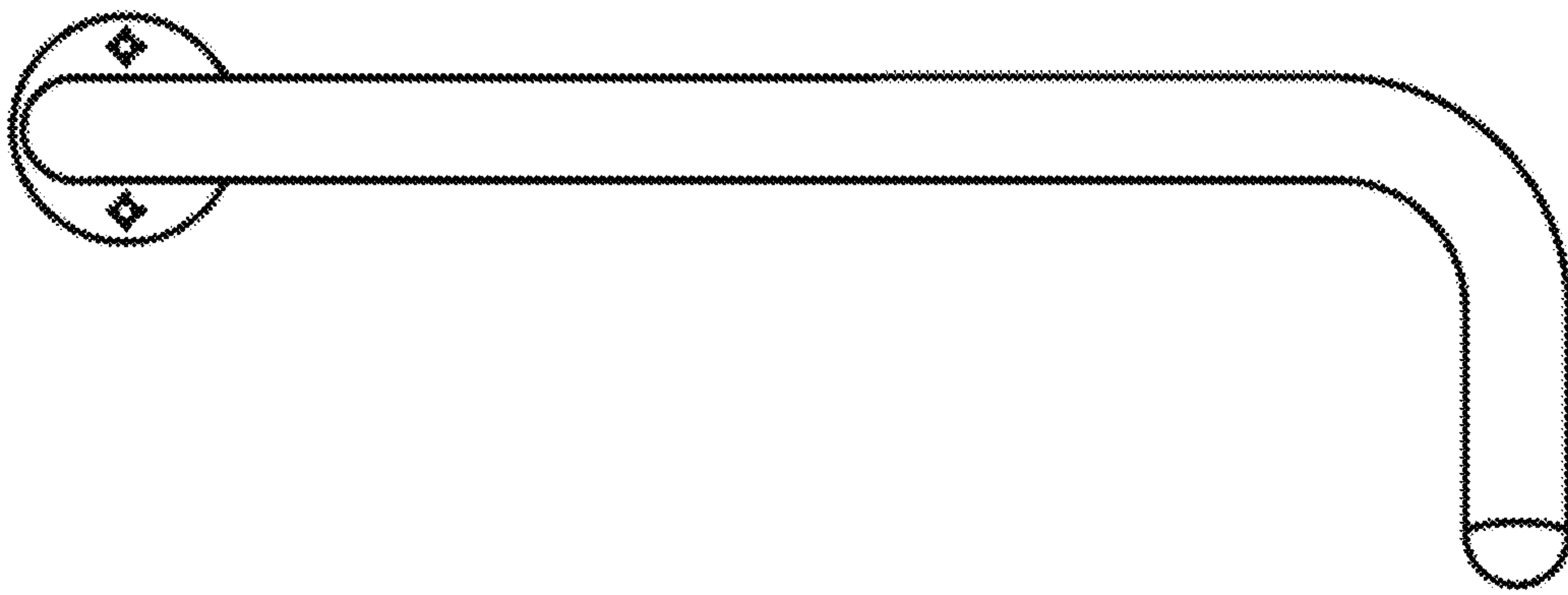

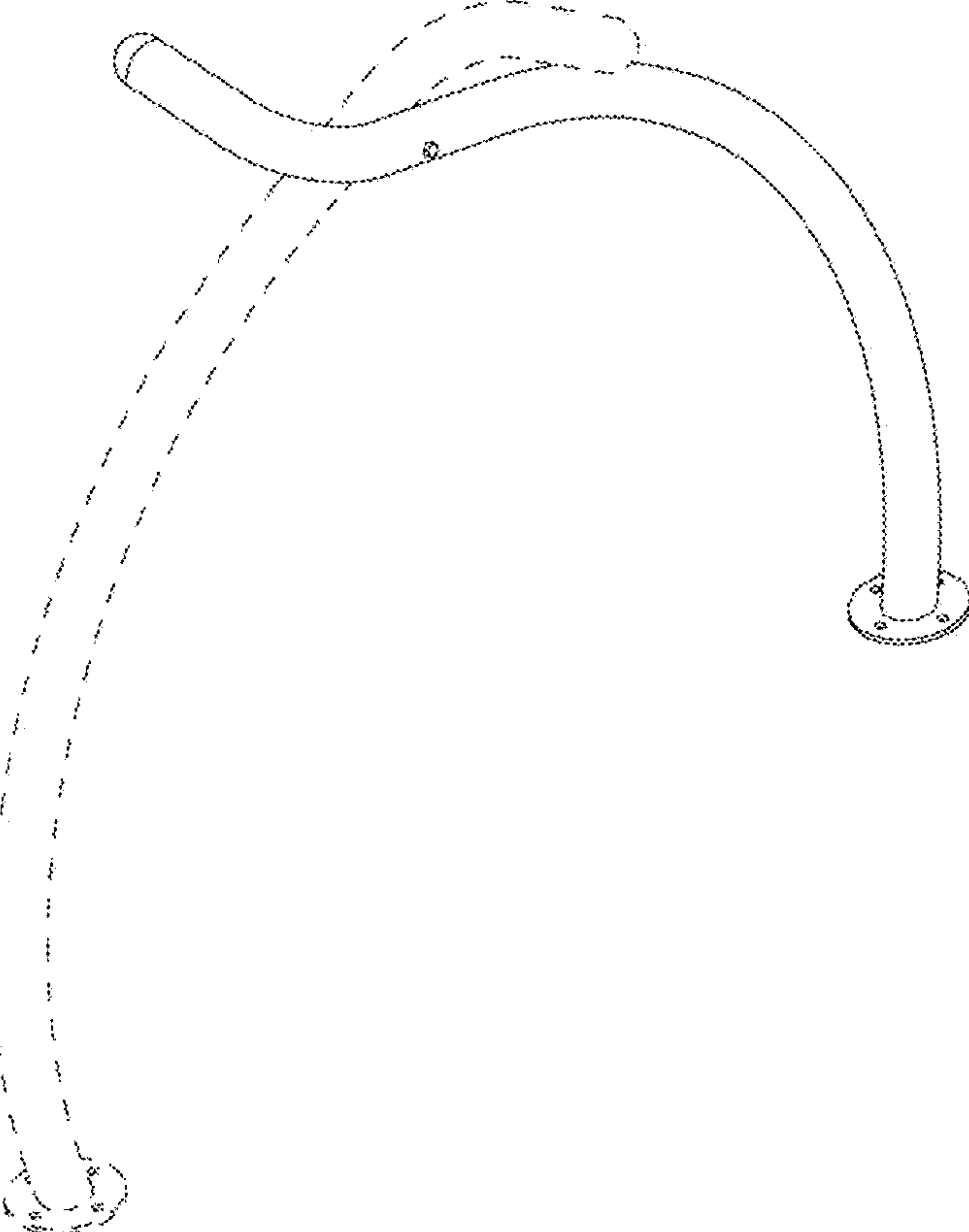

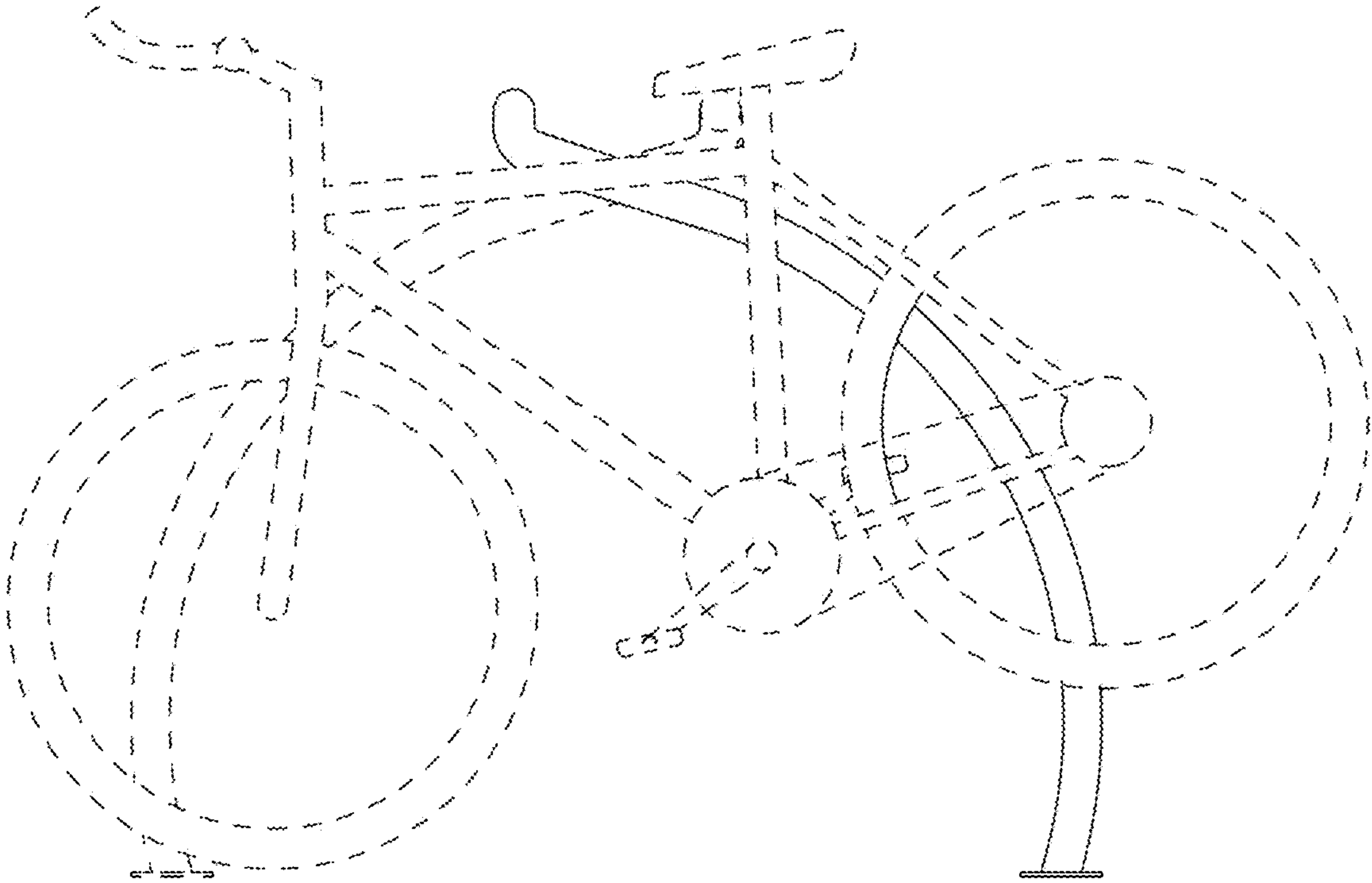
