FIG. 10 is a front, left perspective view of the mobile phone of FIG. 1 in the closed state;

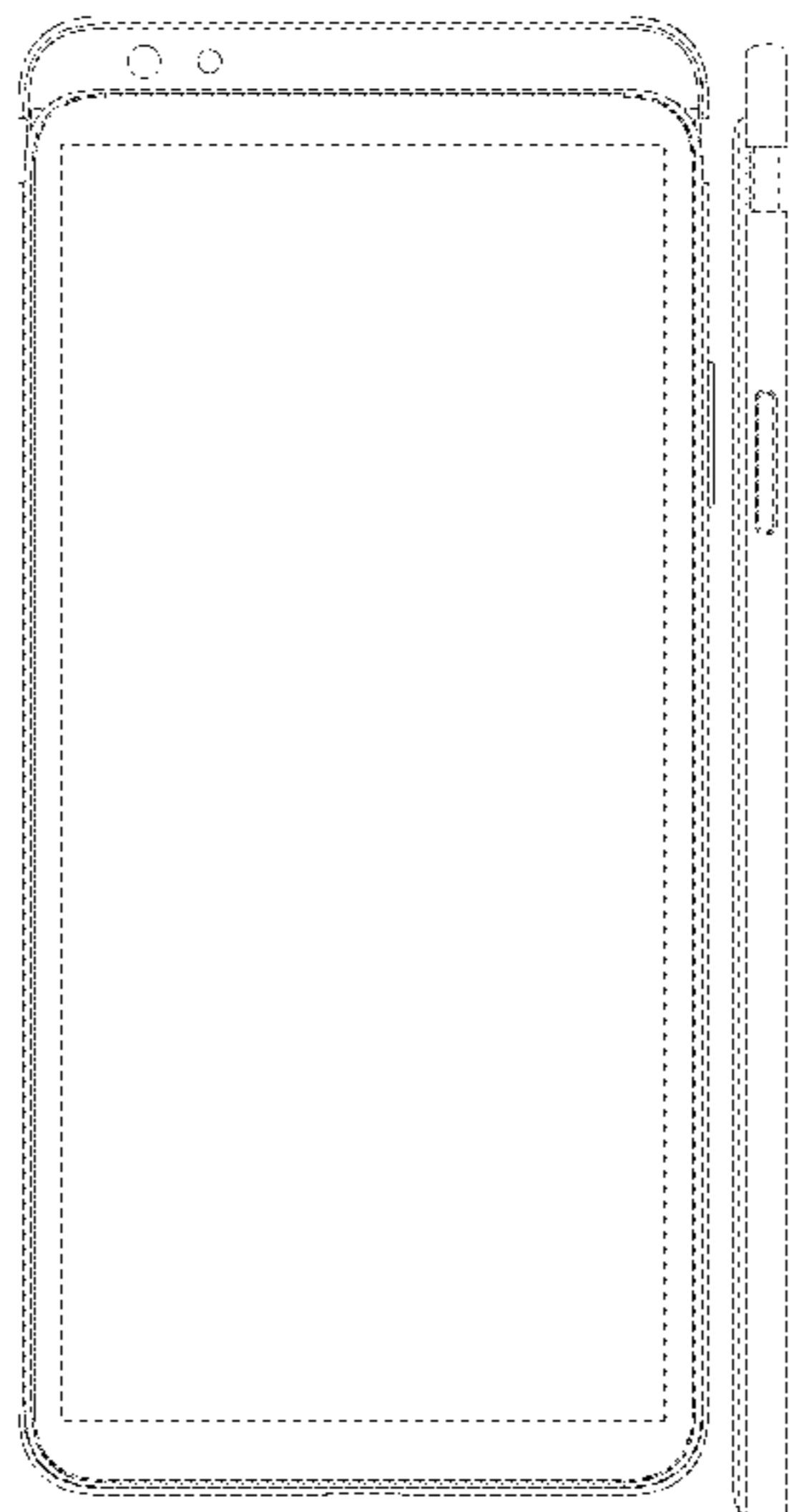
FIG. 11 is a front view of the mobile phone of FIG. 1 in the closed state;

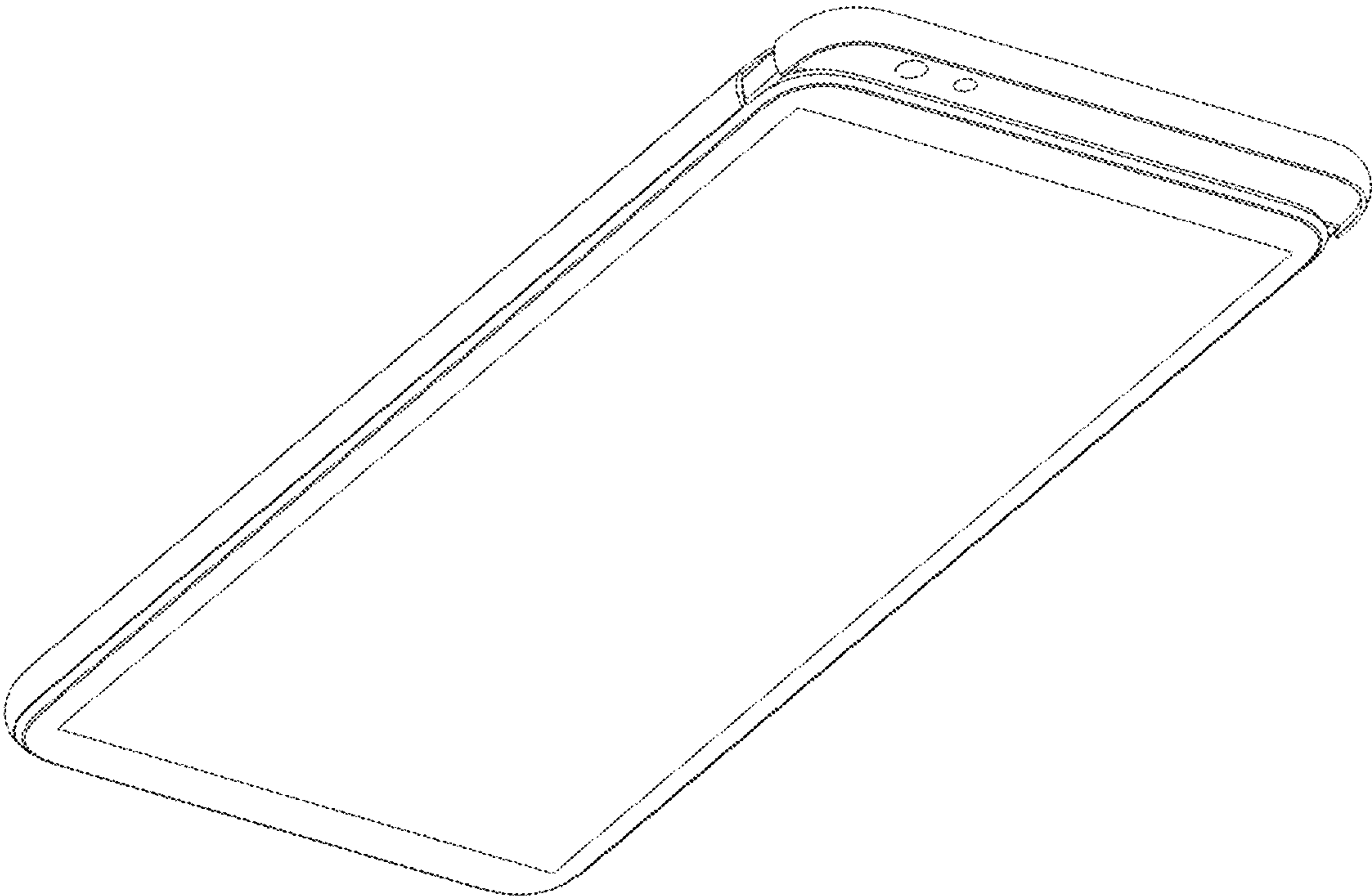

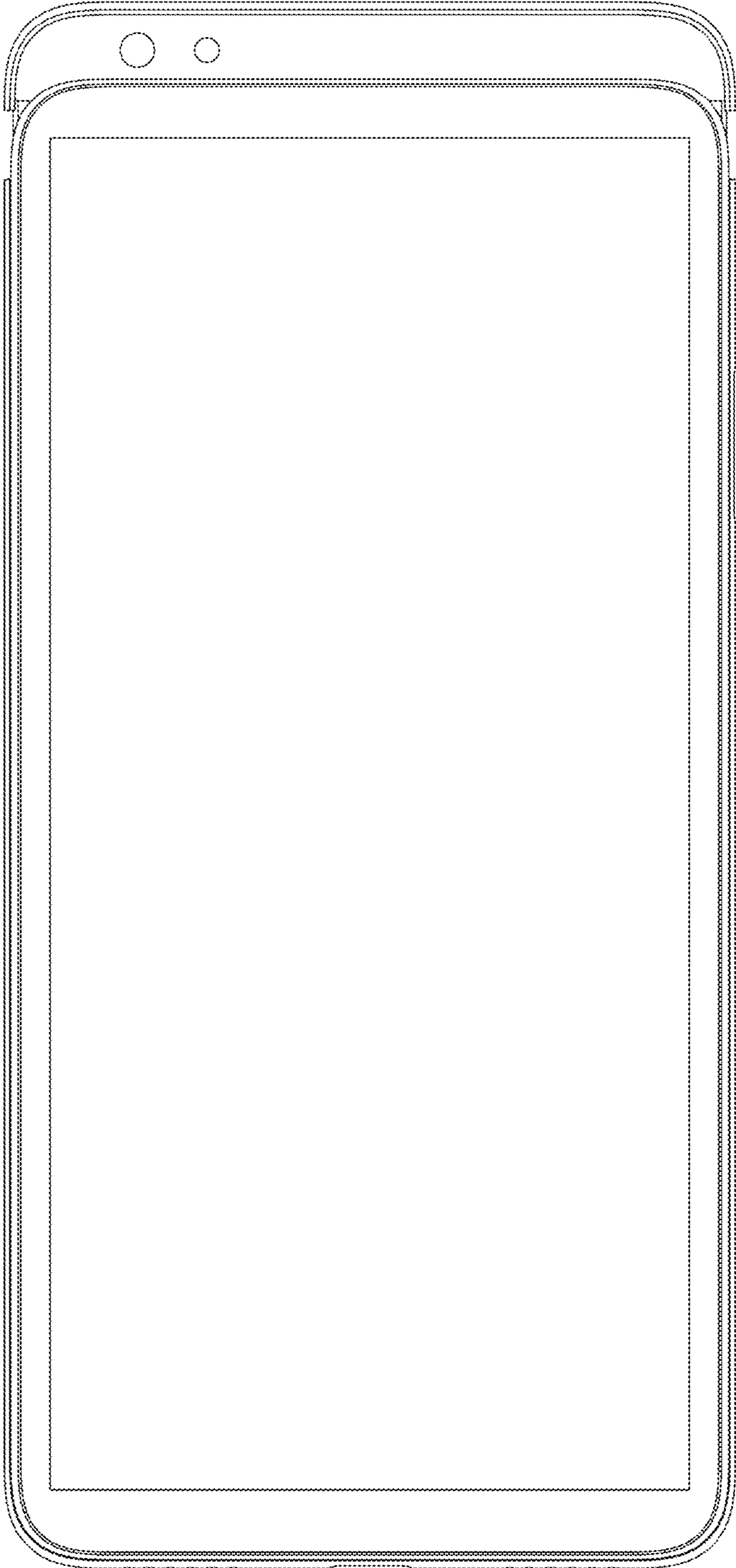

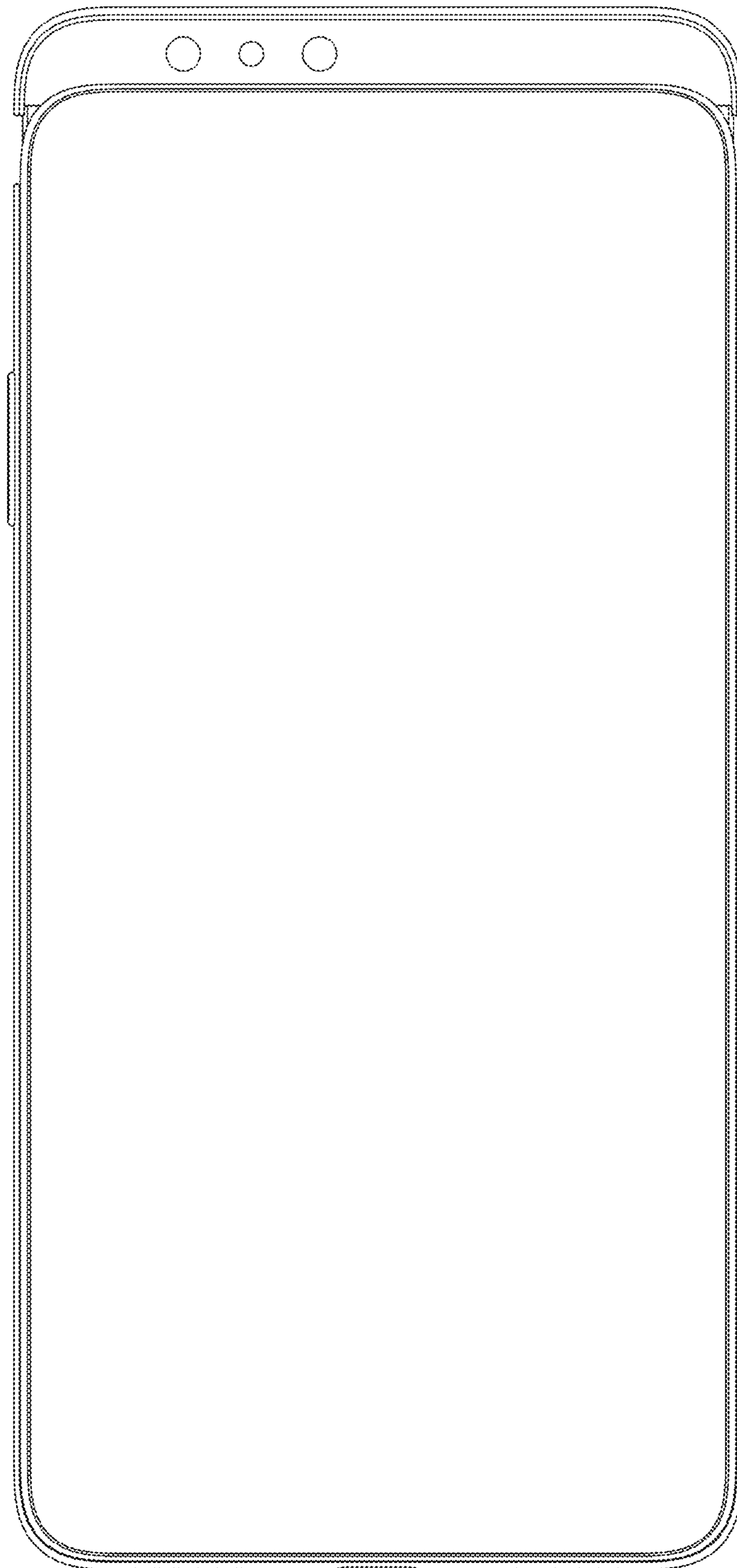
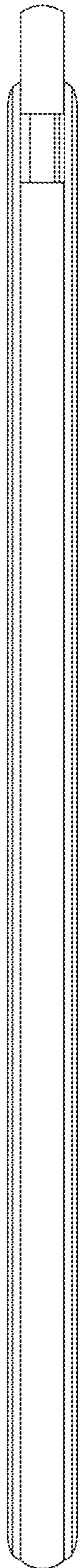
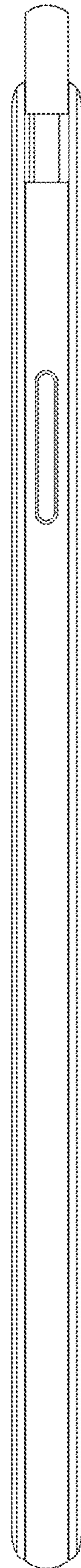


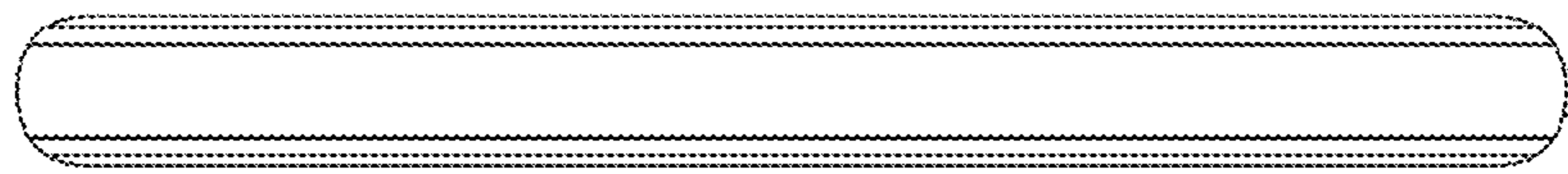

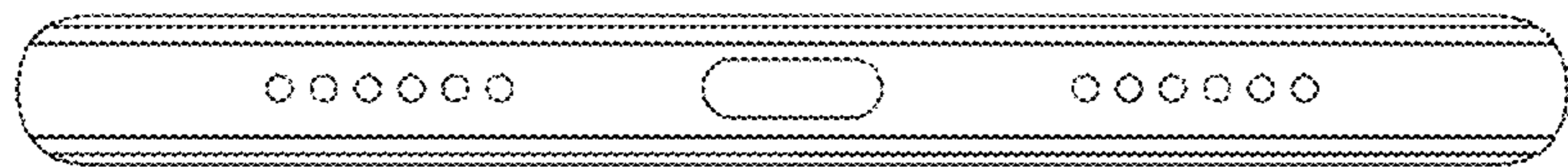

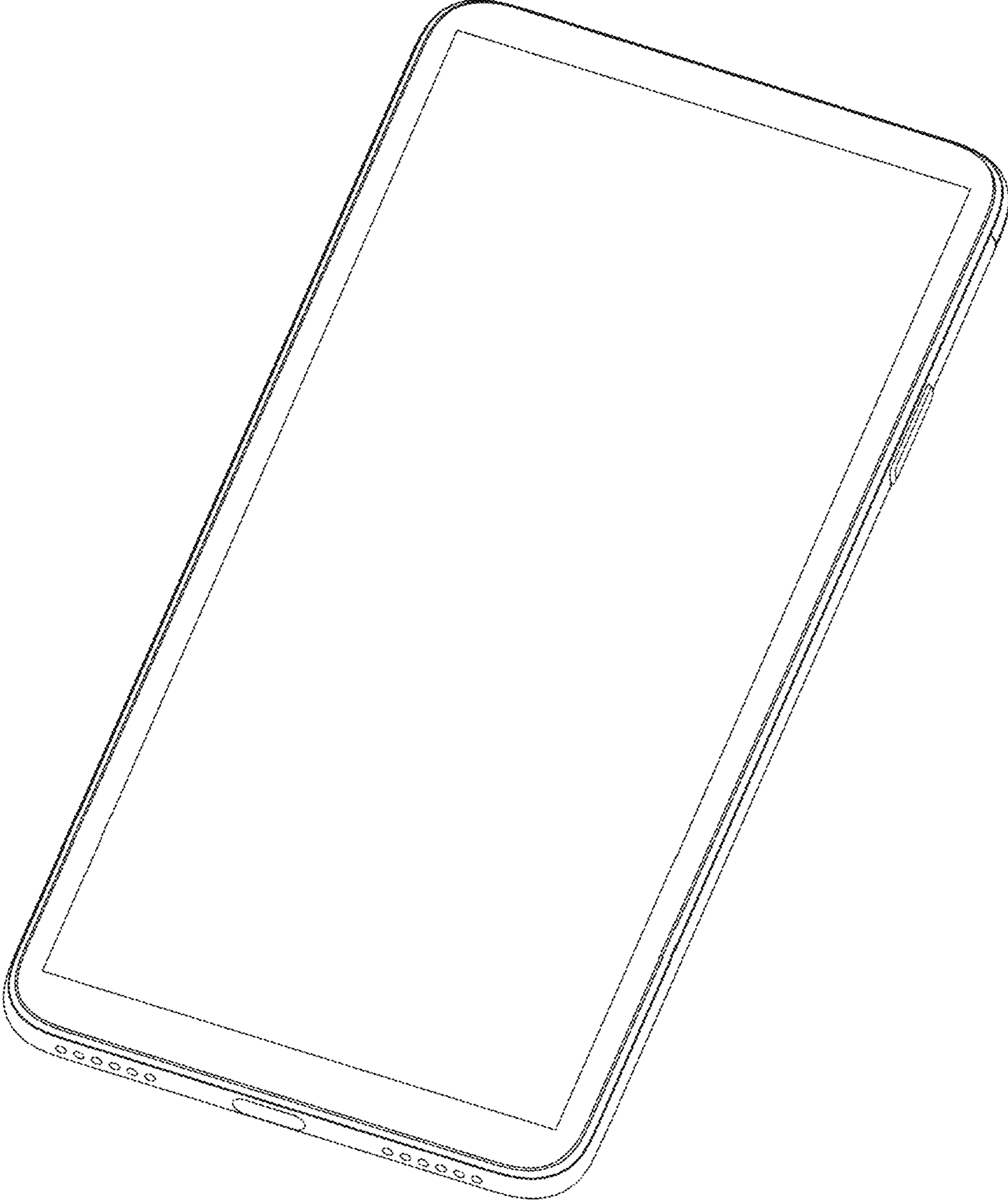

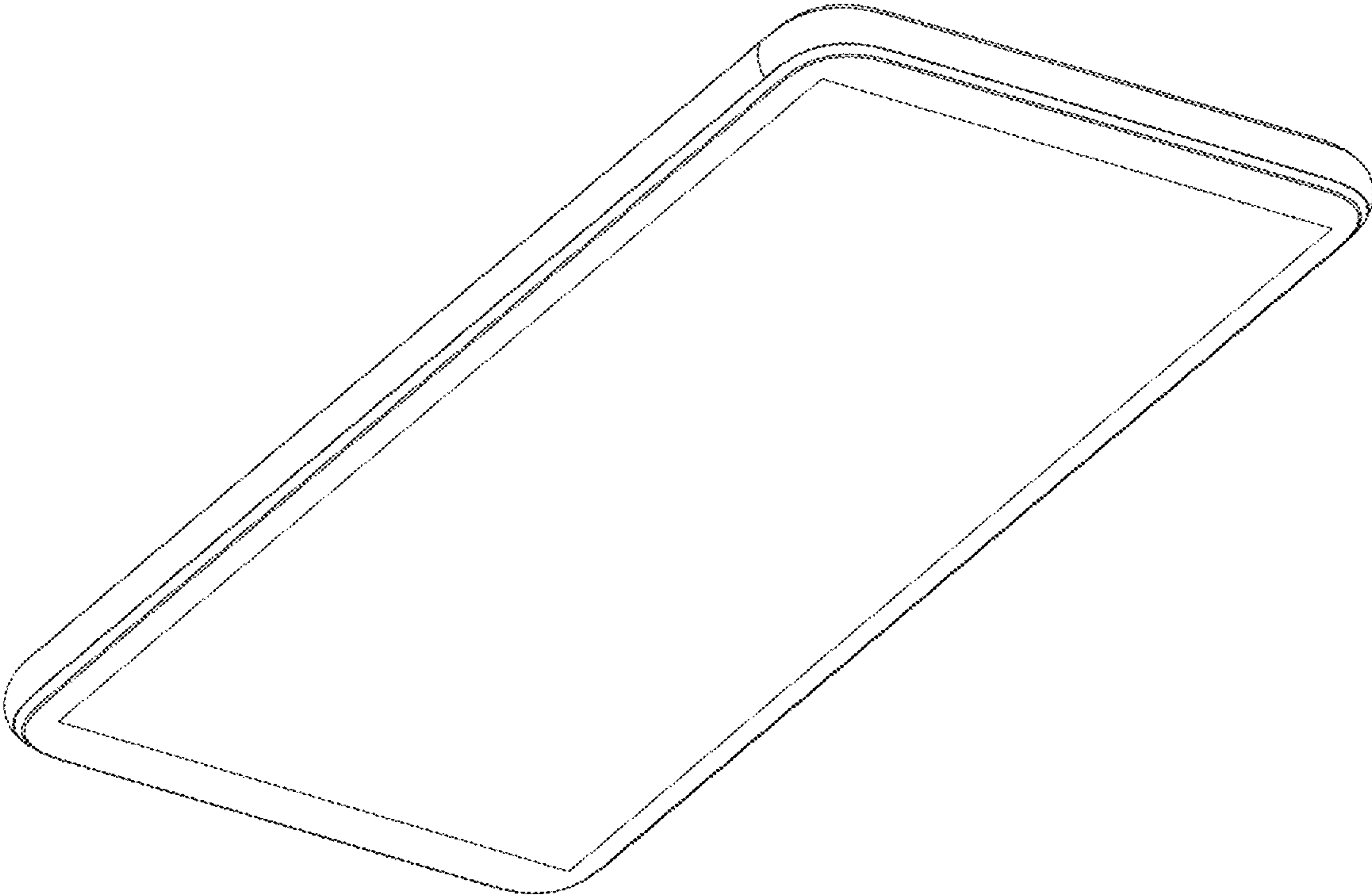

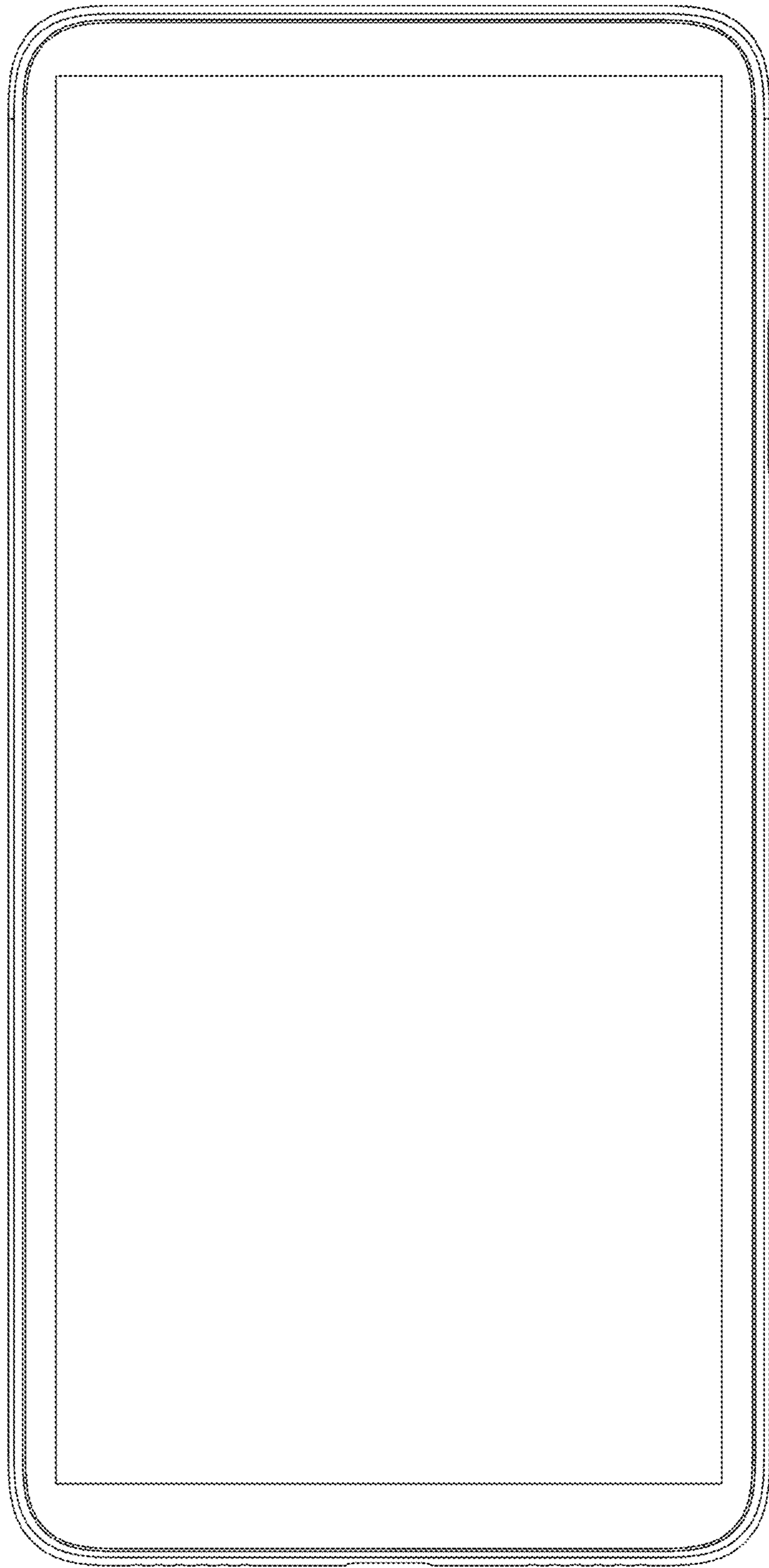




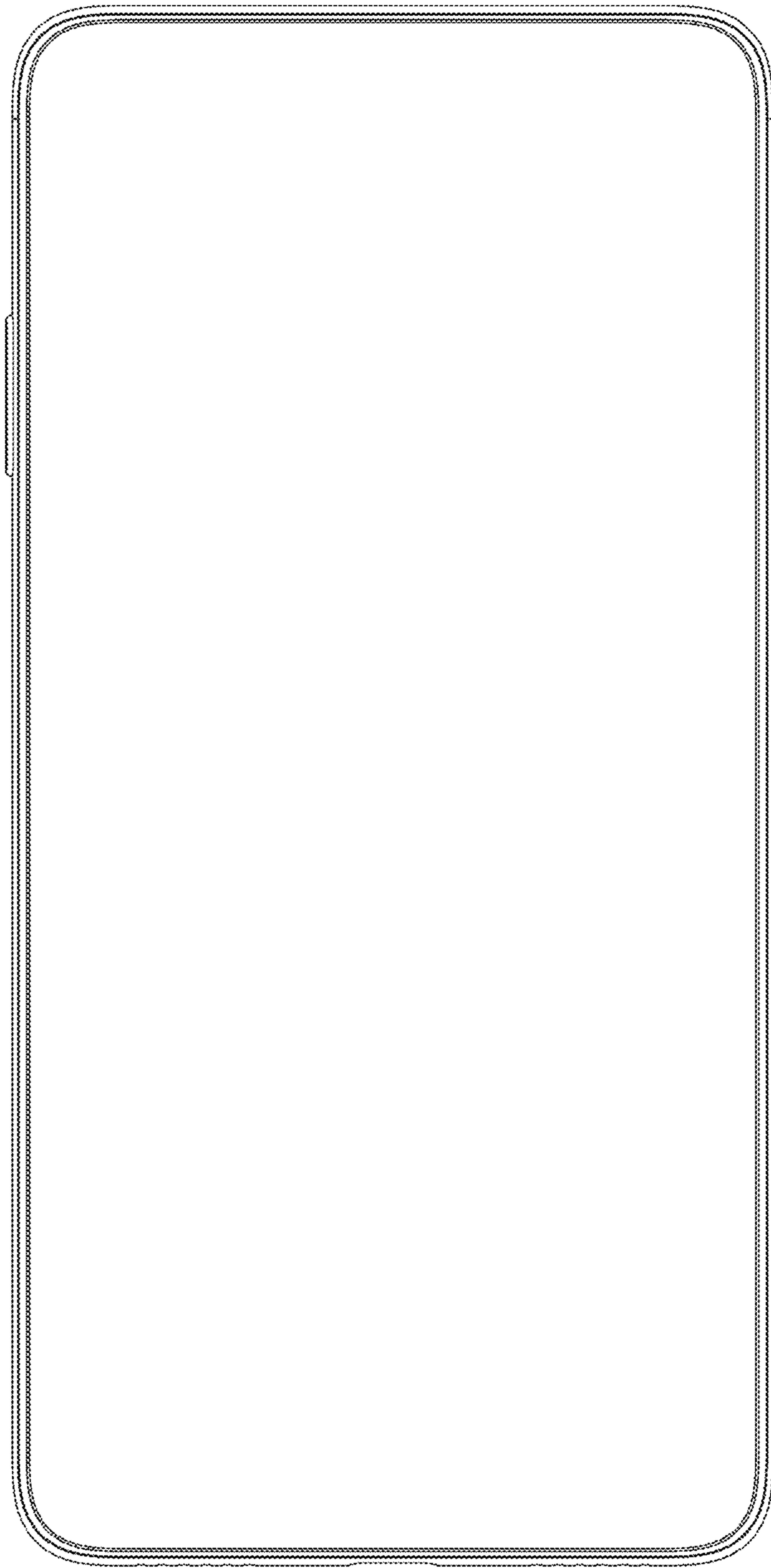

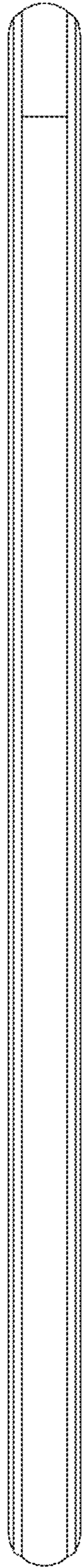

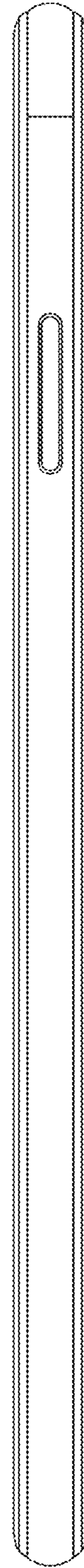
