(57) **CLAIM**

The ornamental design for a cell phone case with LCD screen and detachable cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cell phone case with LCD screen and detachable cover showing my new design, with the detachable cover in a closed position.

FIG. 2 is a front exploded, perspective view thereof.

FIG. 3 is a front perspective view with the detachable cover in an opened position.

FIG. 4 is a rear perspective view thereof.

FIG. 5 is a front elevational view thereof with the detachable cover in a closed position.

FIG. 6 is a rear elevational view thereof.

FIG. 7 is a left side view thereof.

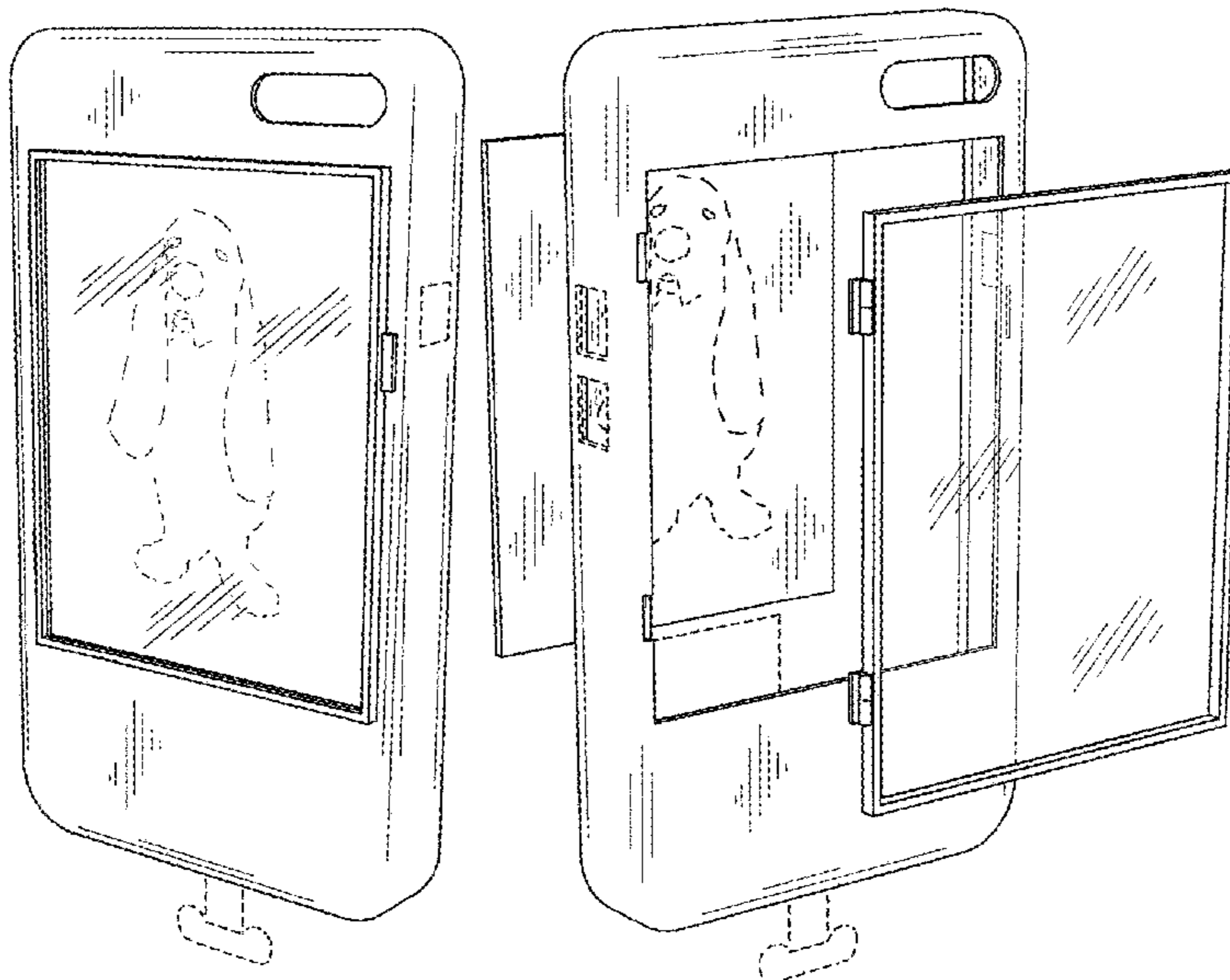
FIG. 8 is a right side view thereof.

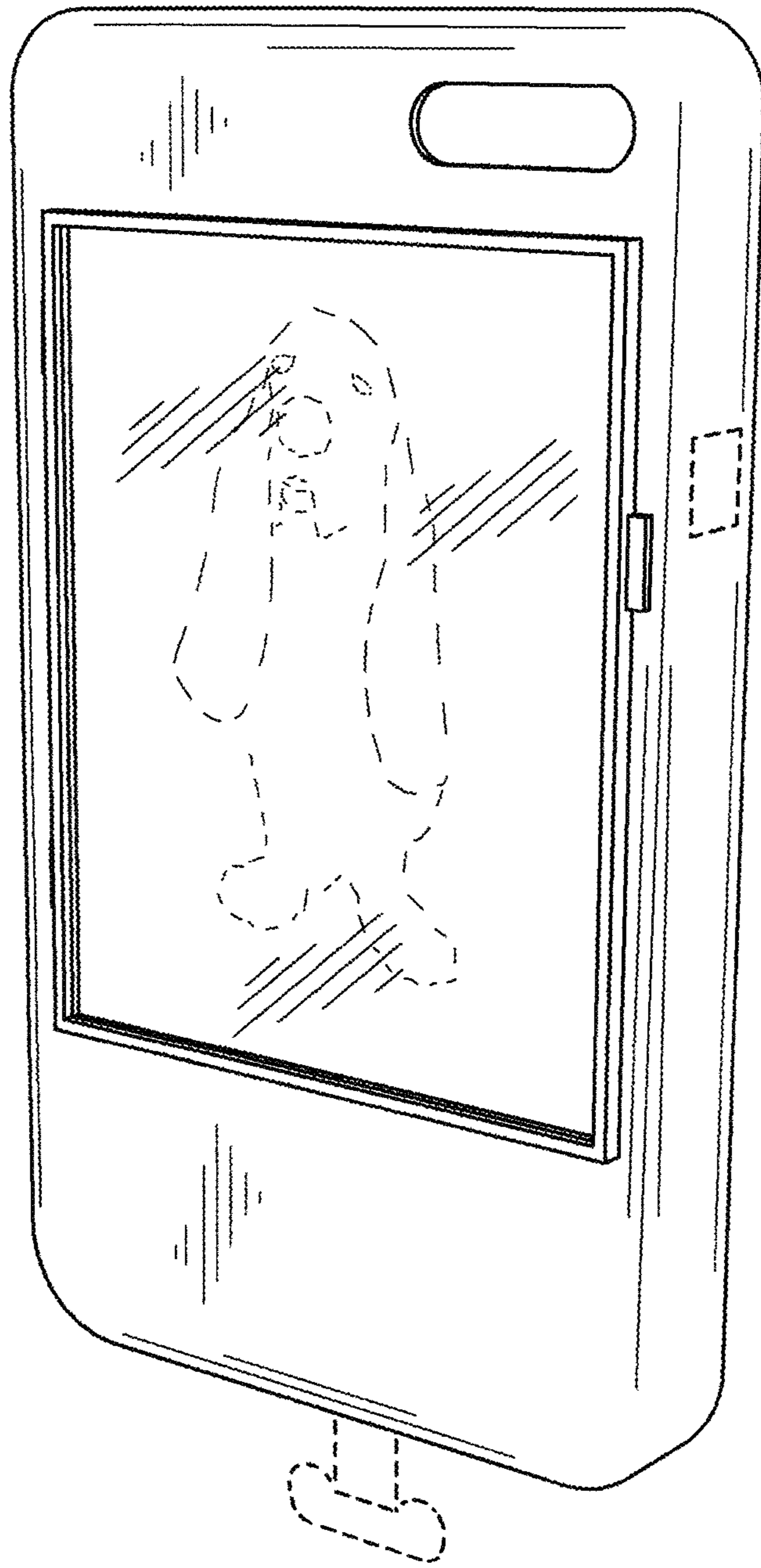

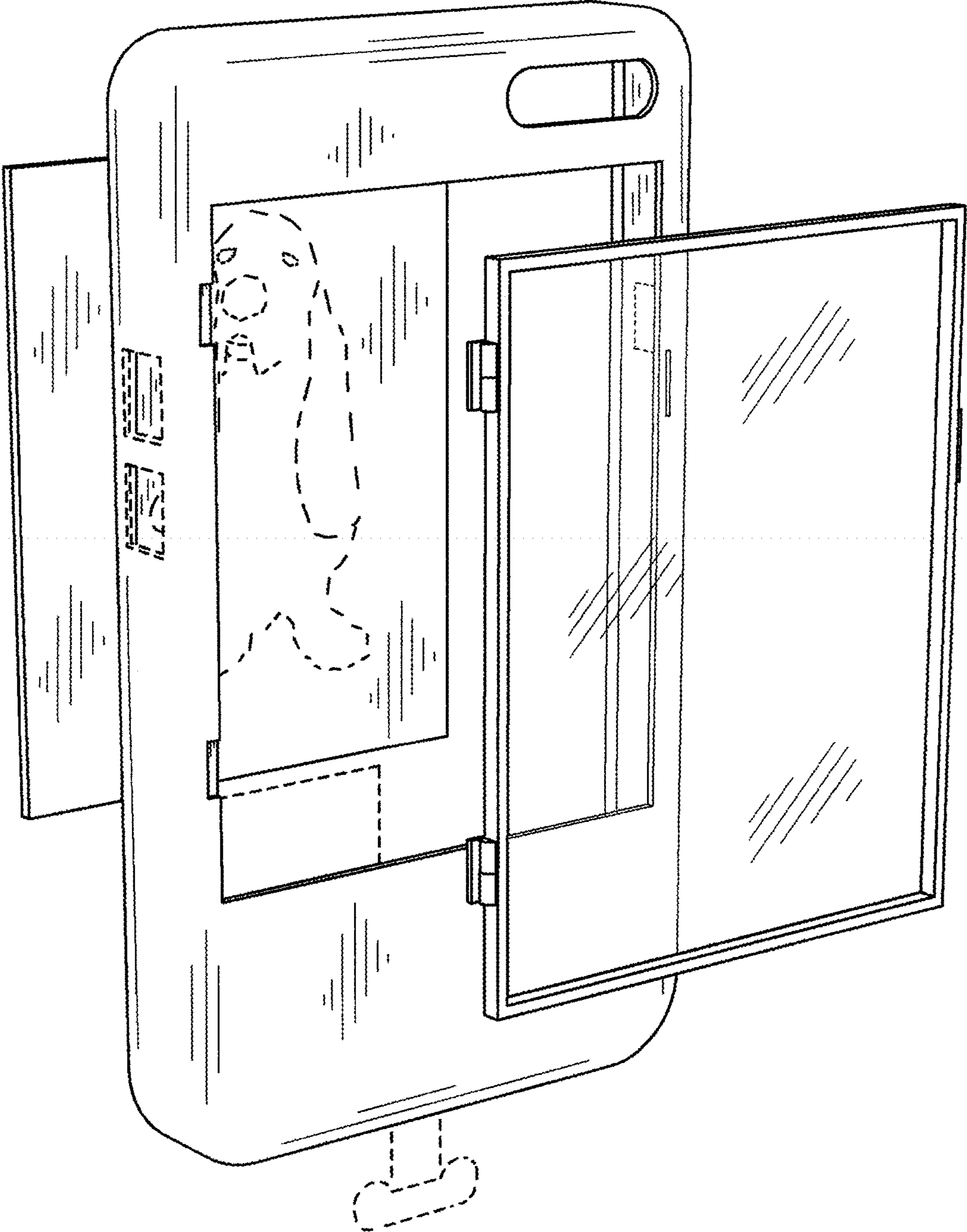

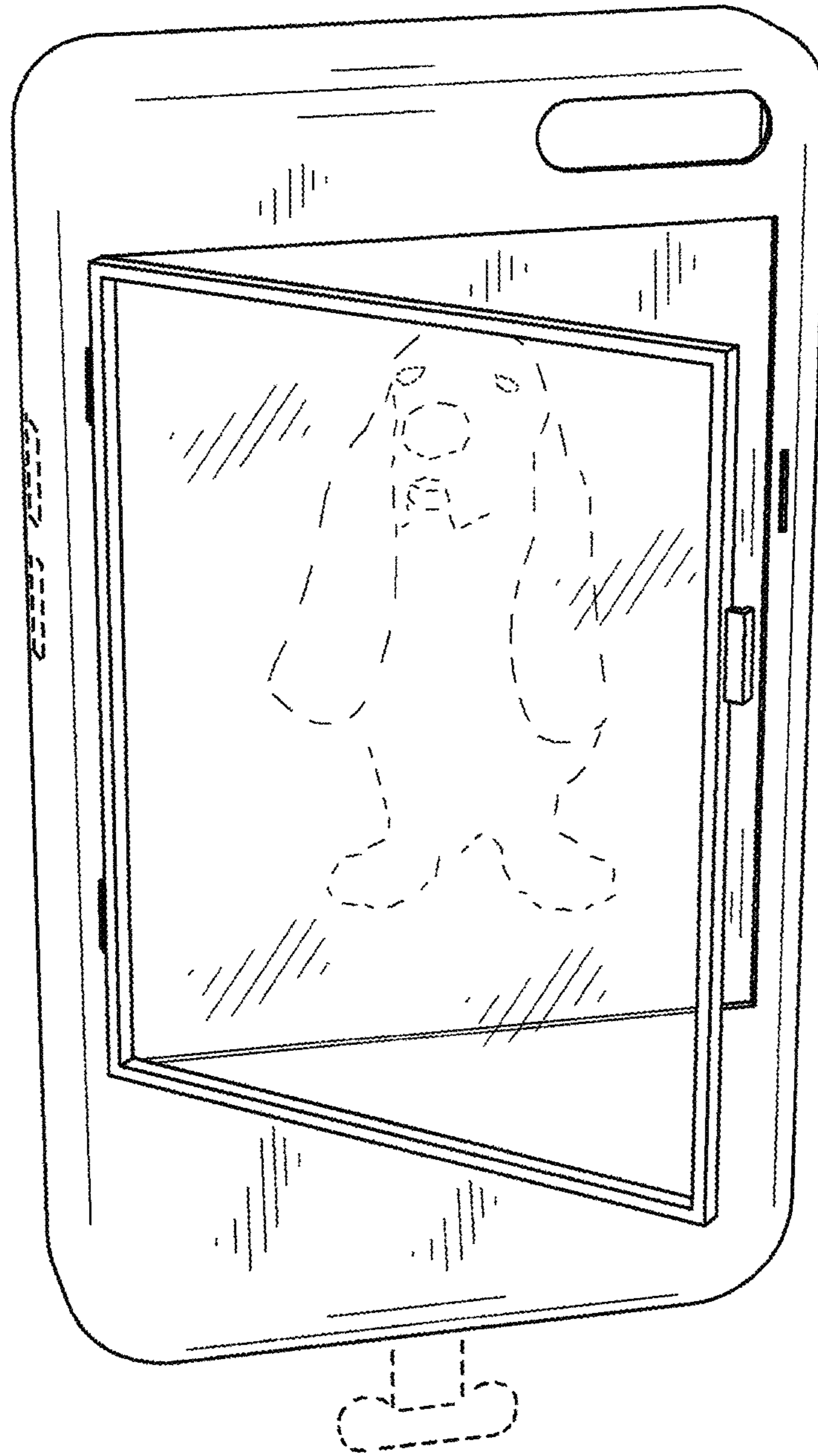

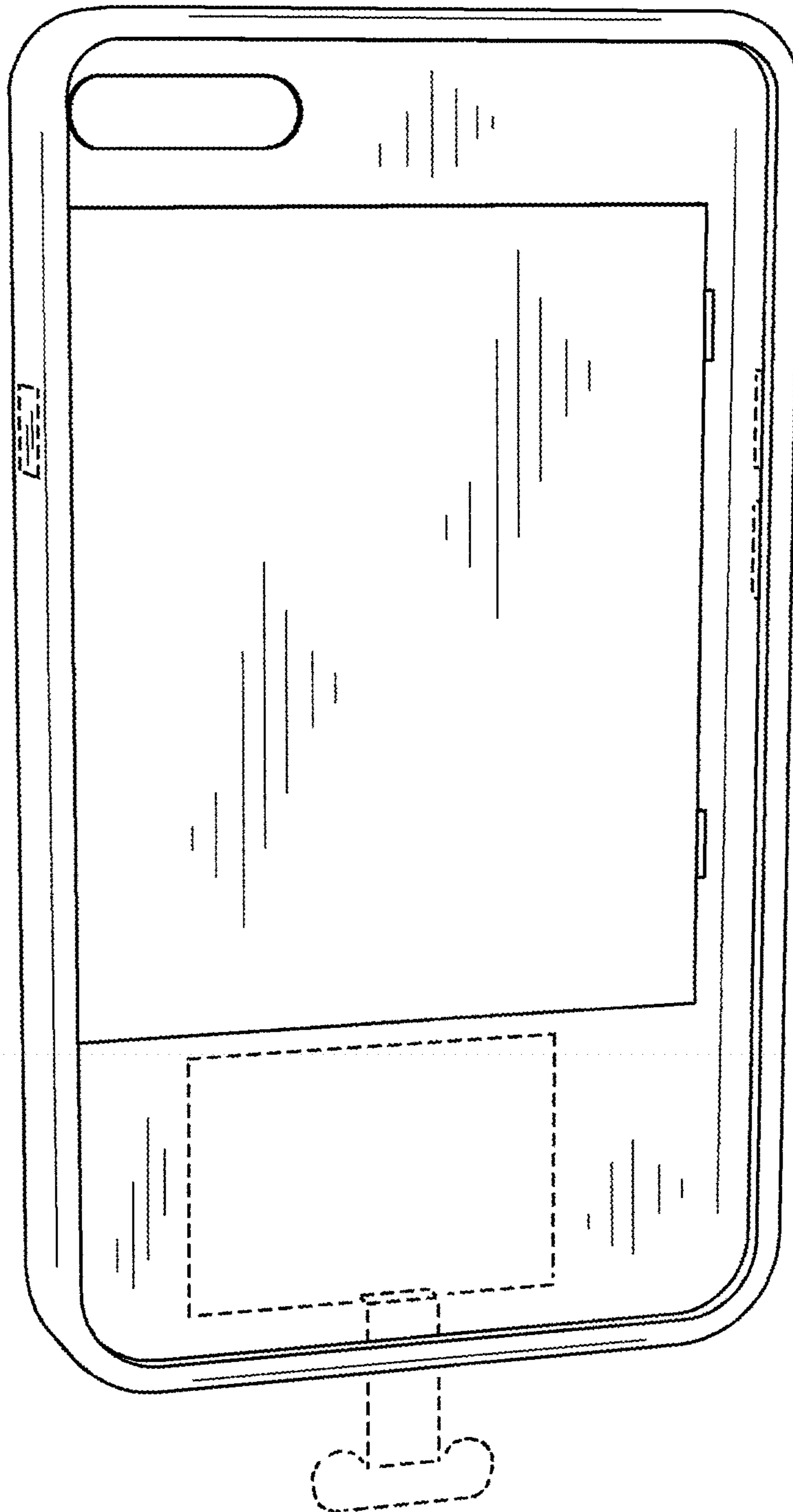

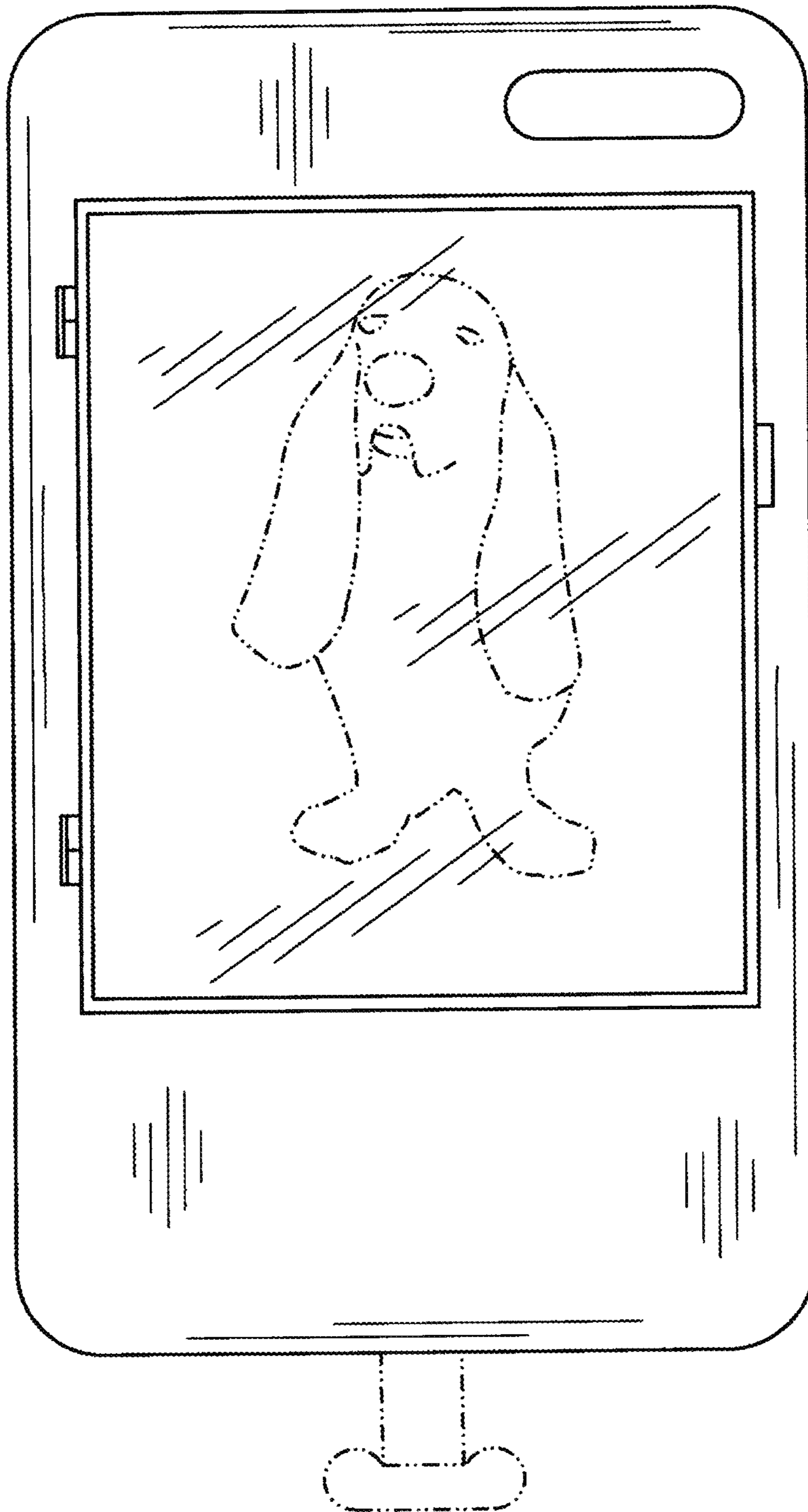

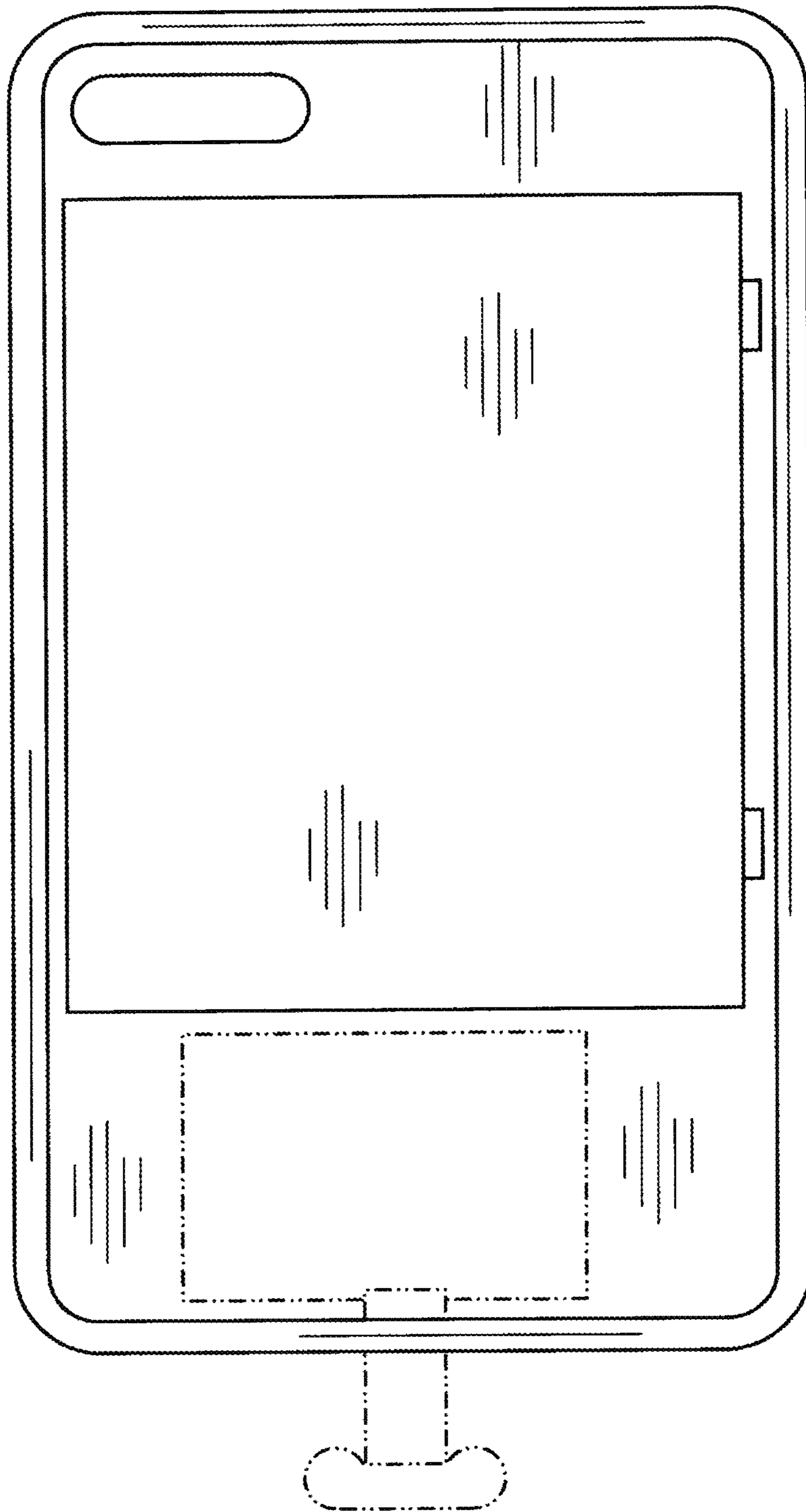

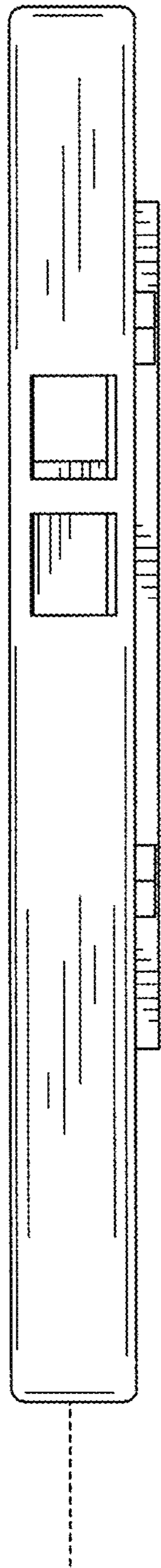

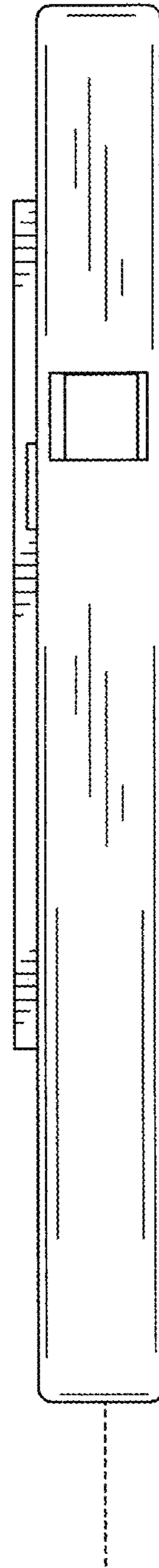

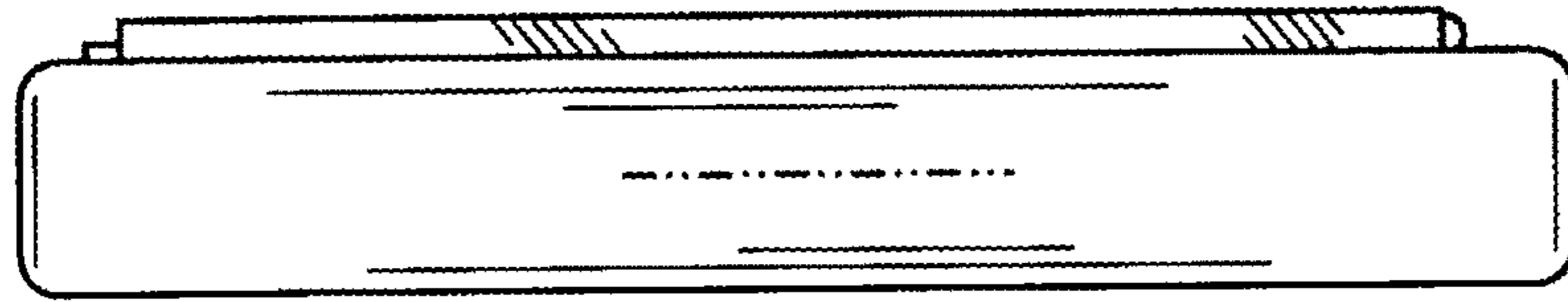

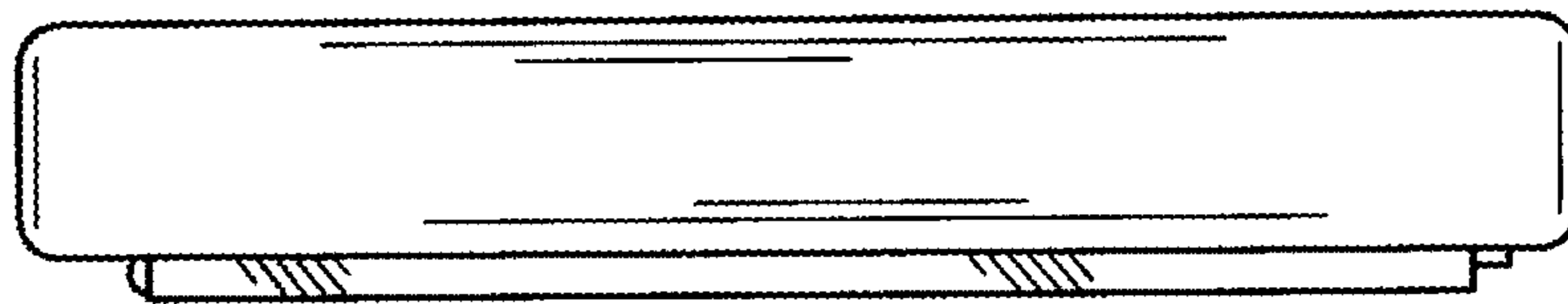
