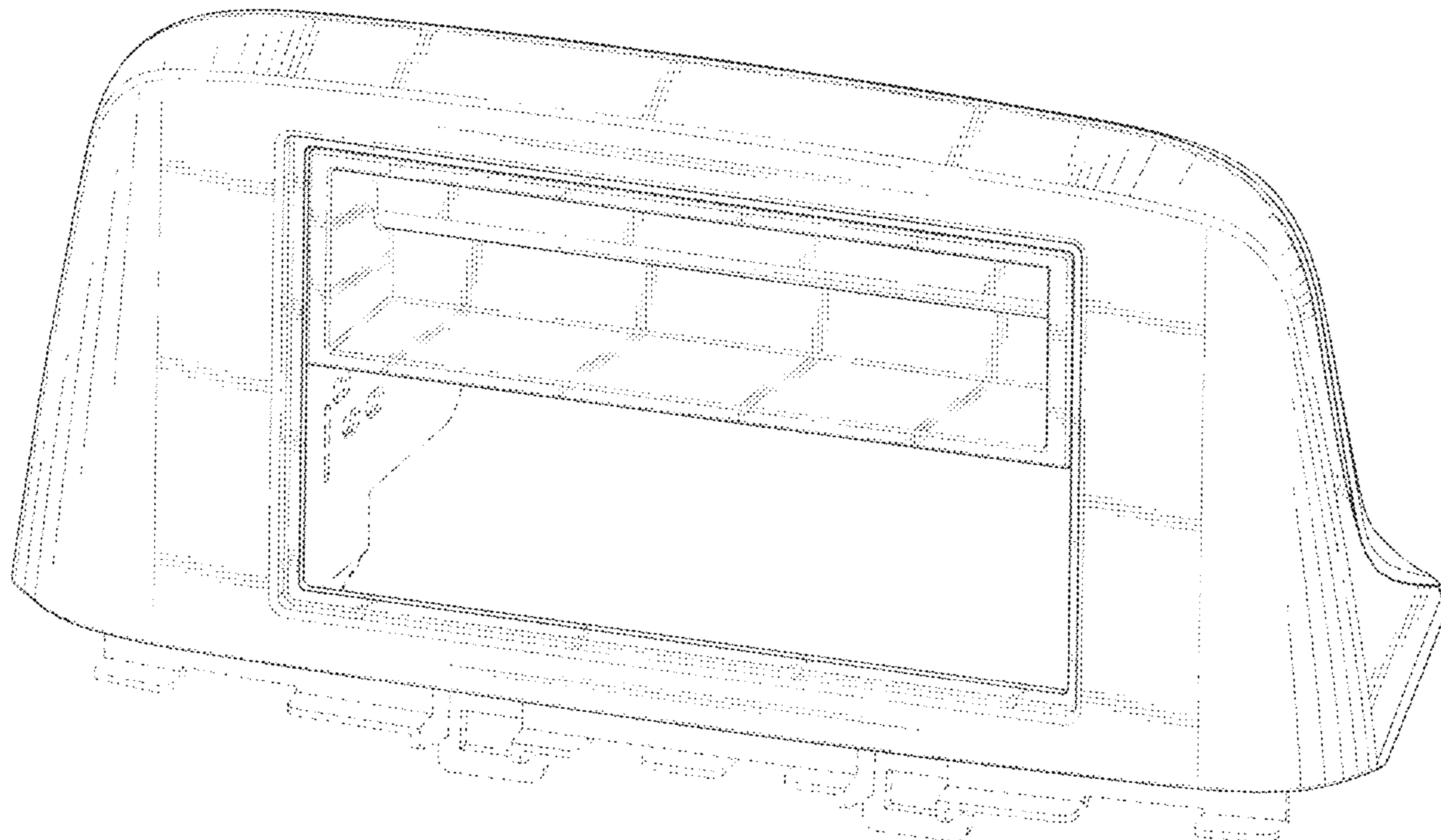
FIG. 1 is a perspective view of an auto stereo mounting device, showing my design;

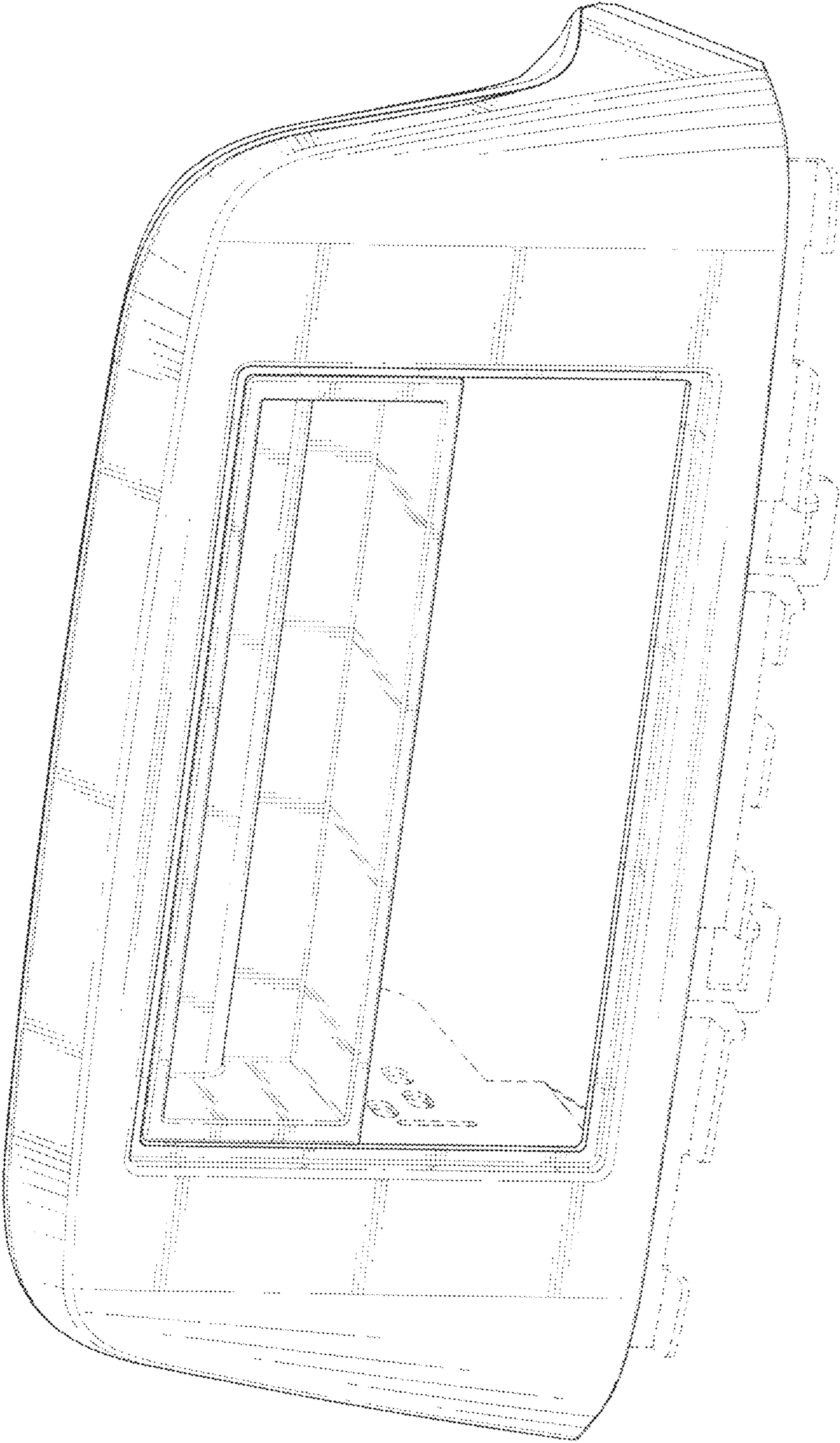

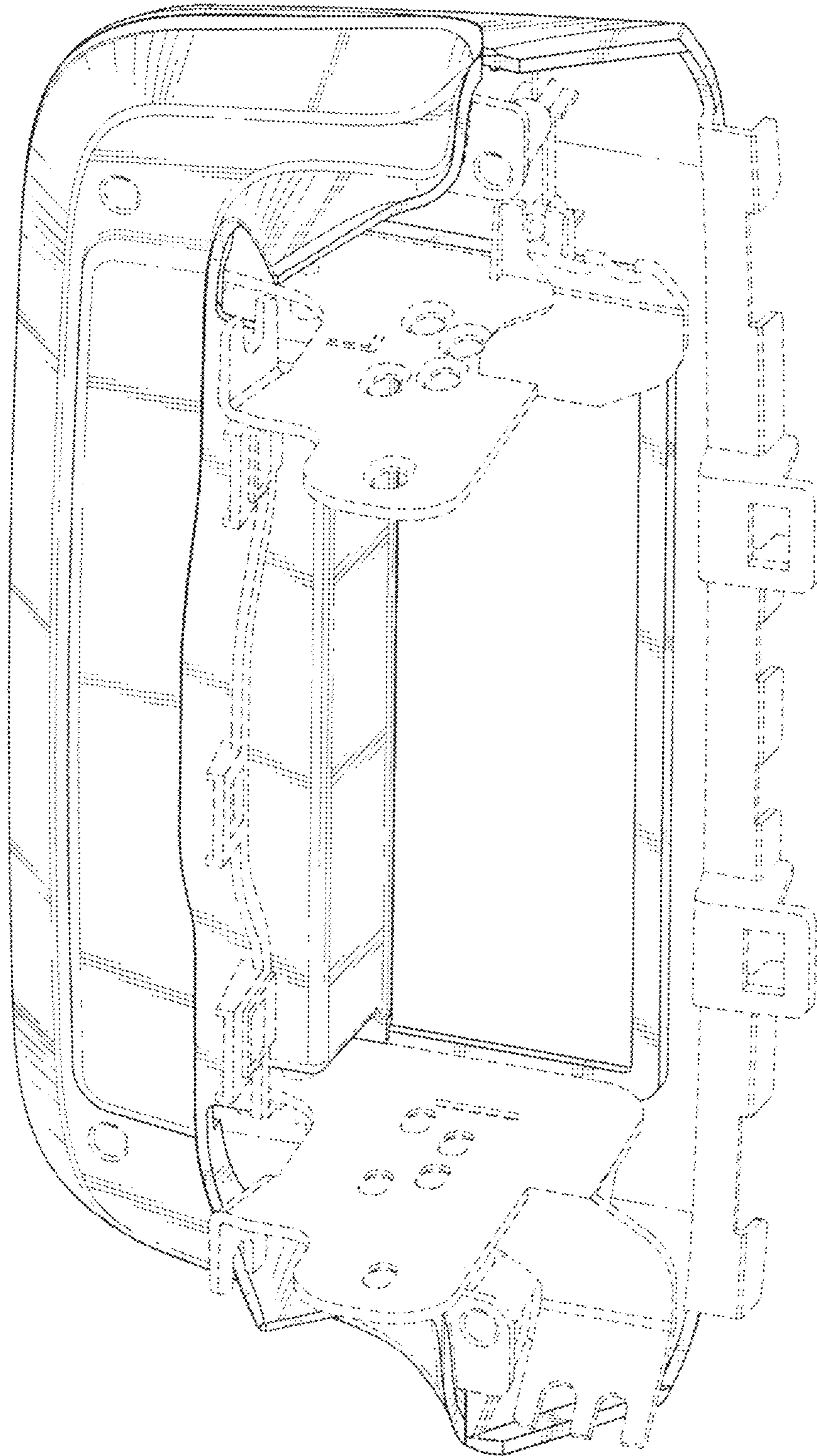

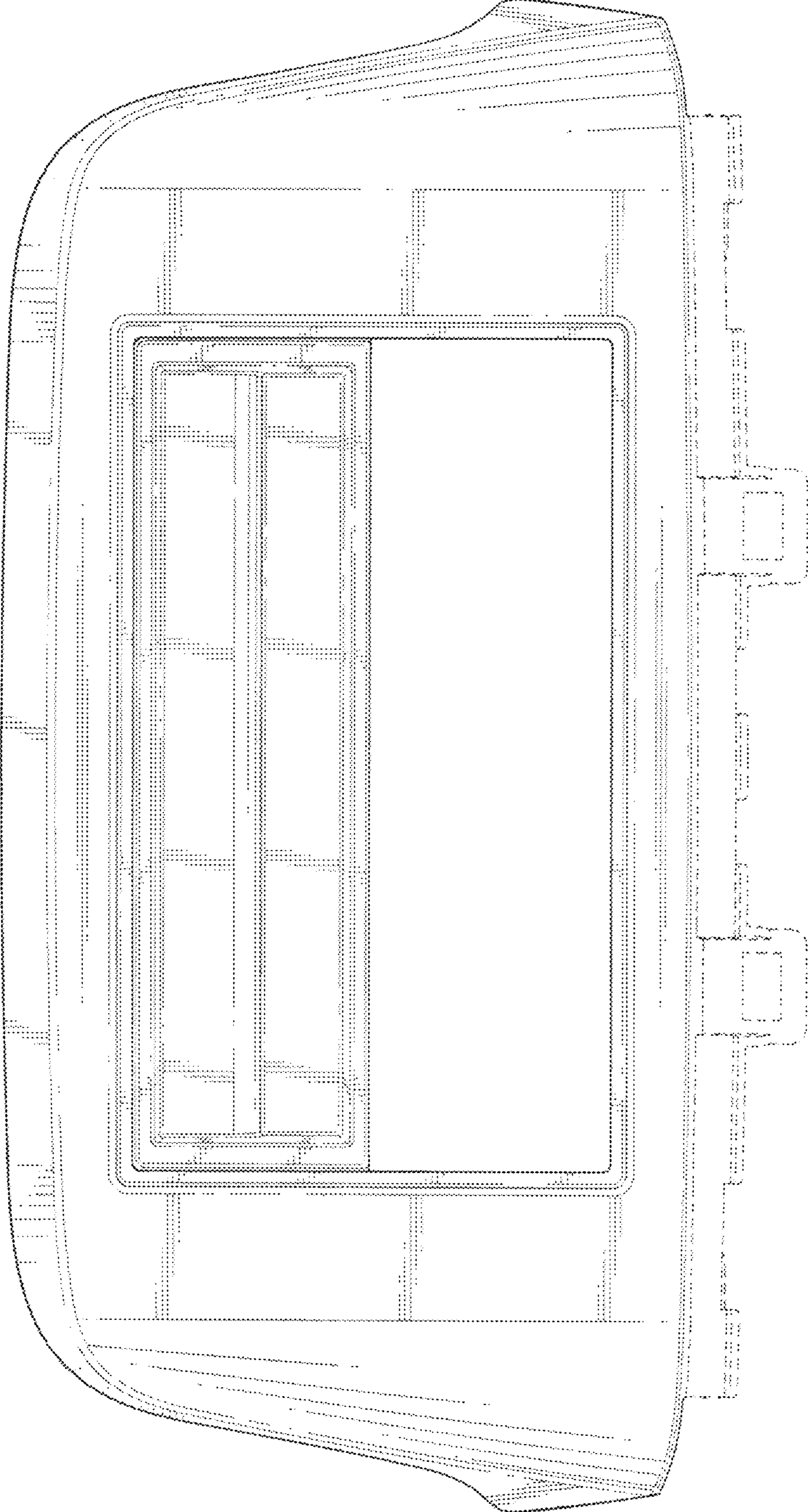

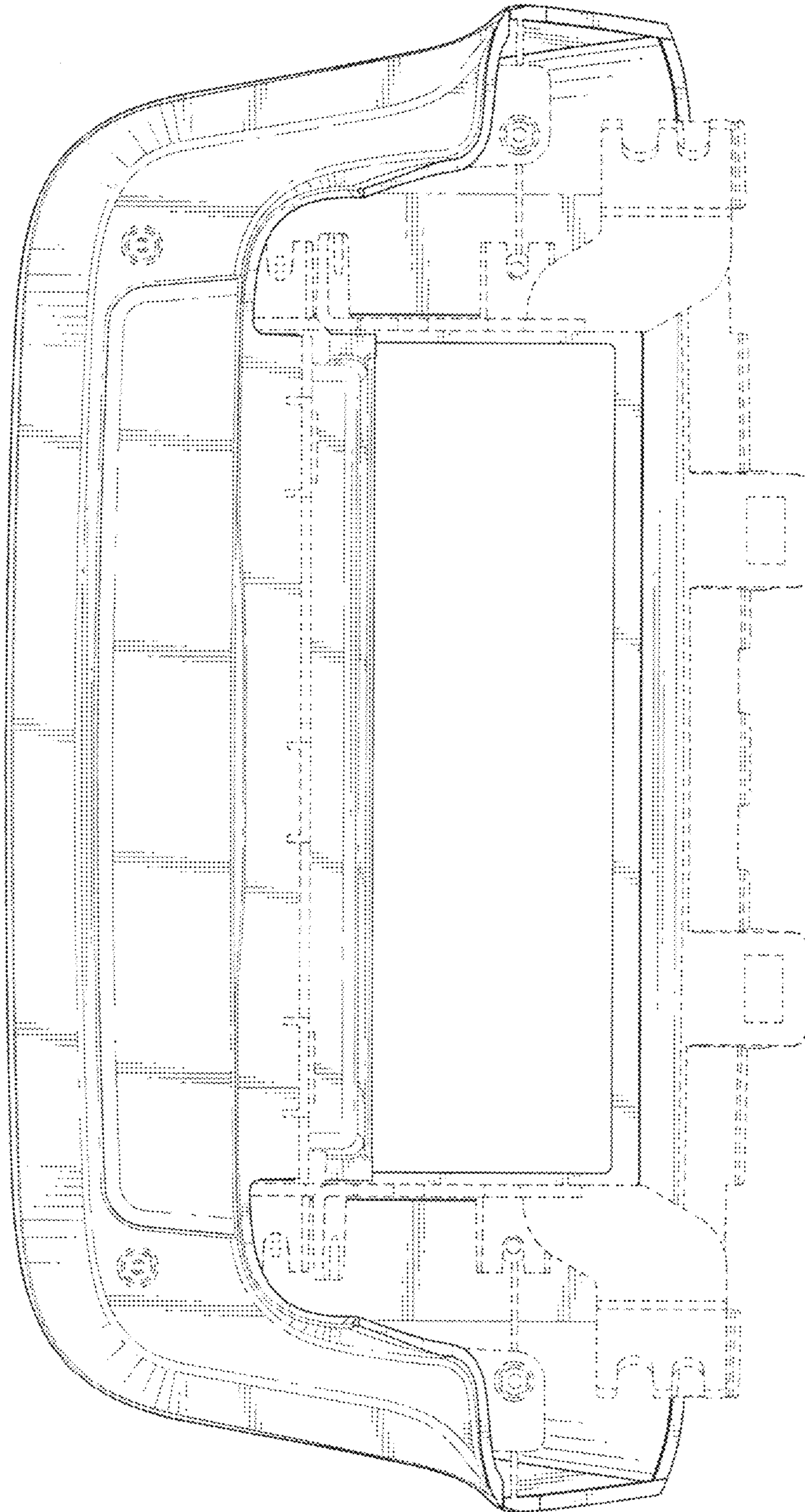

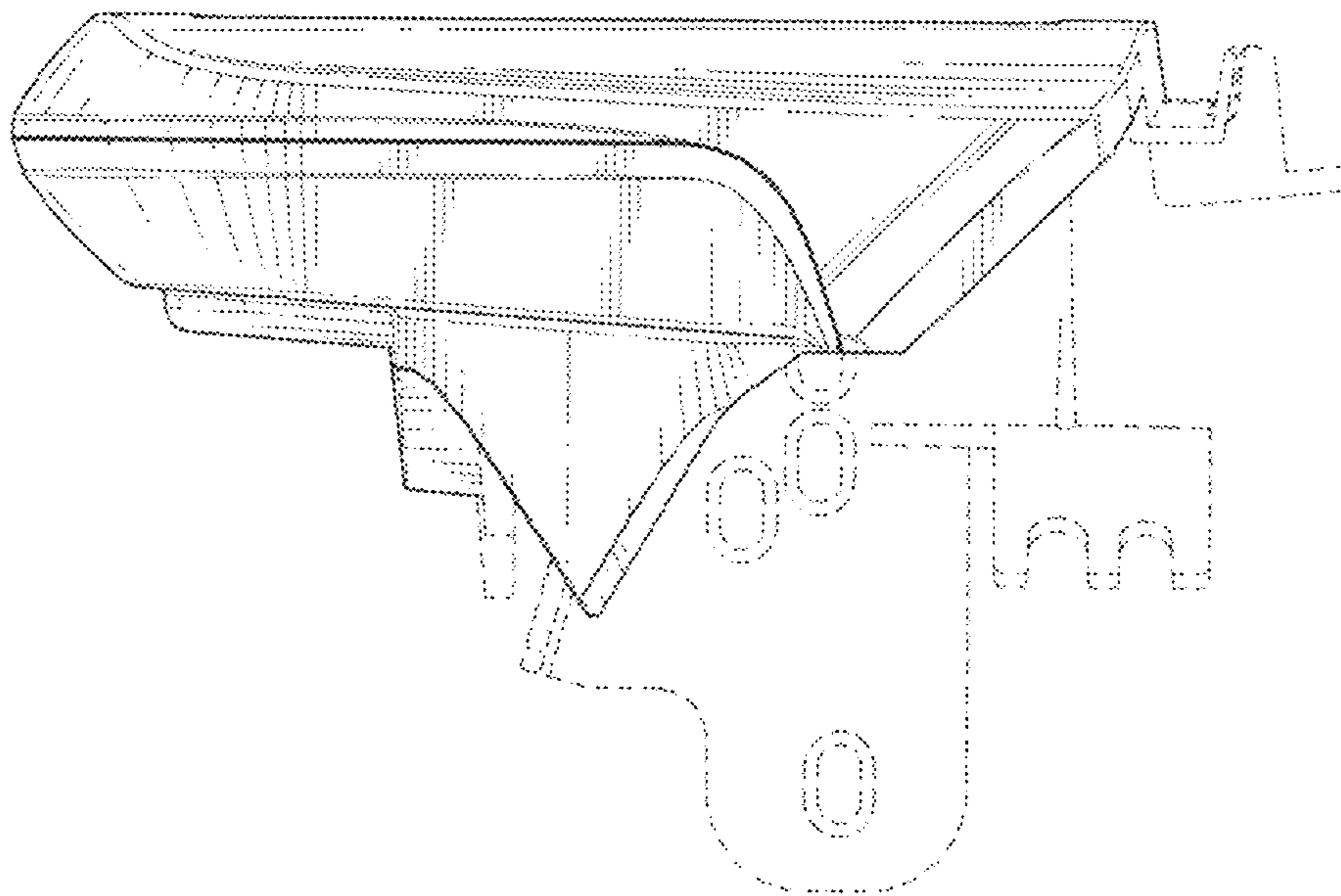

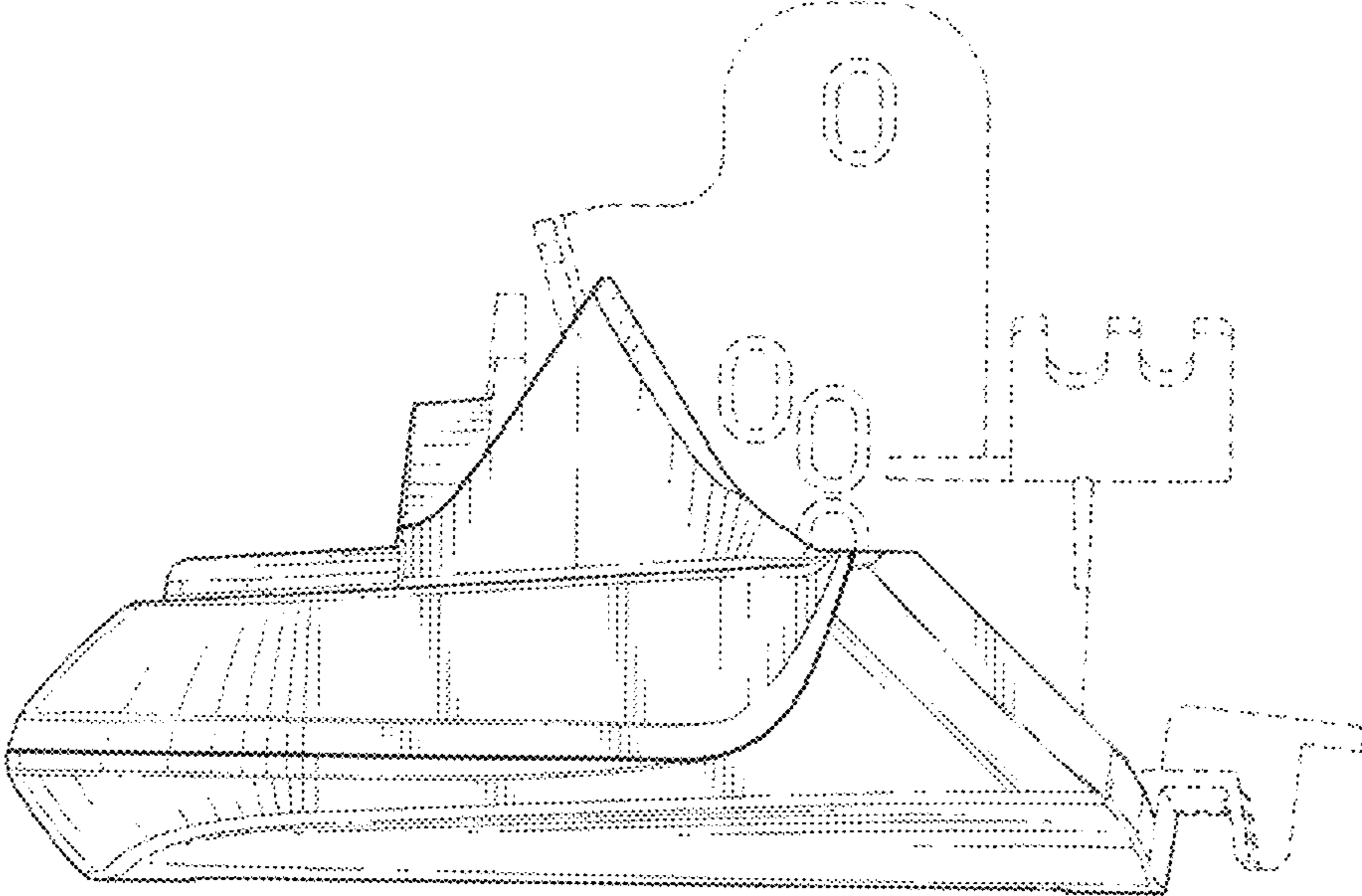

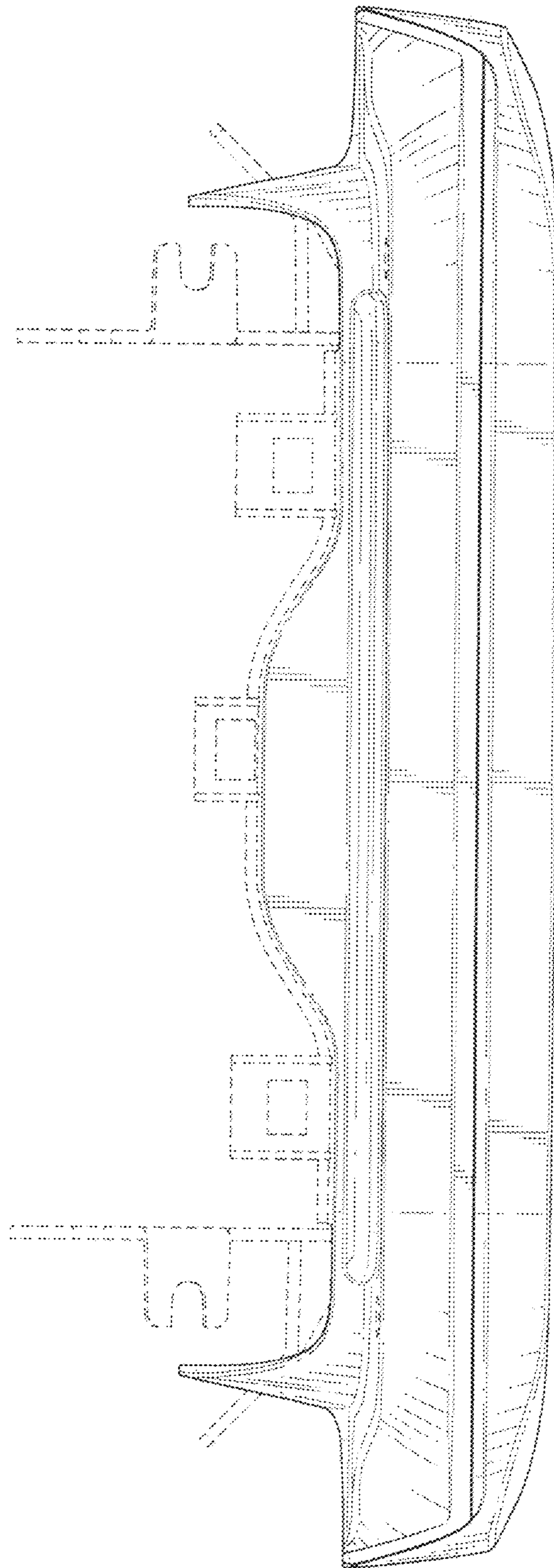

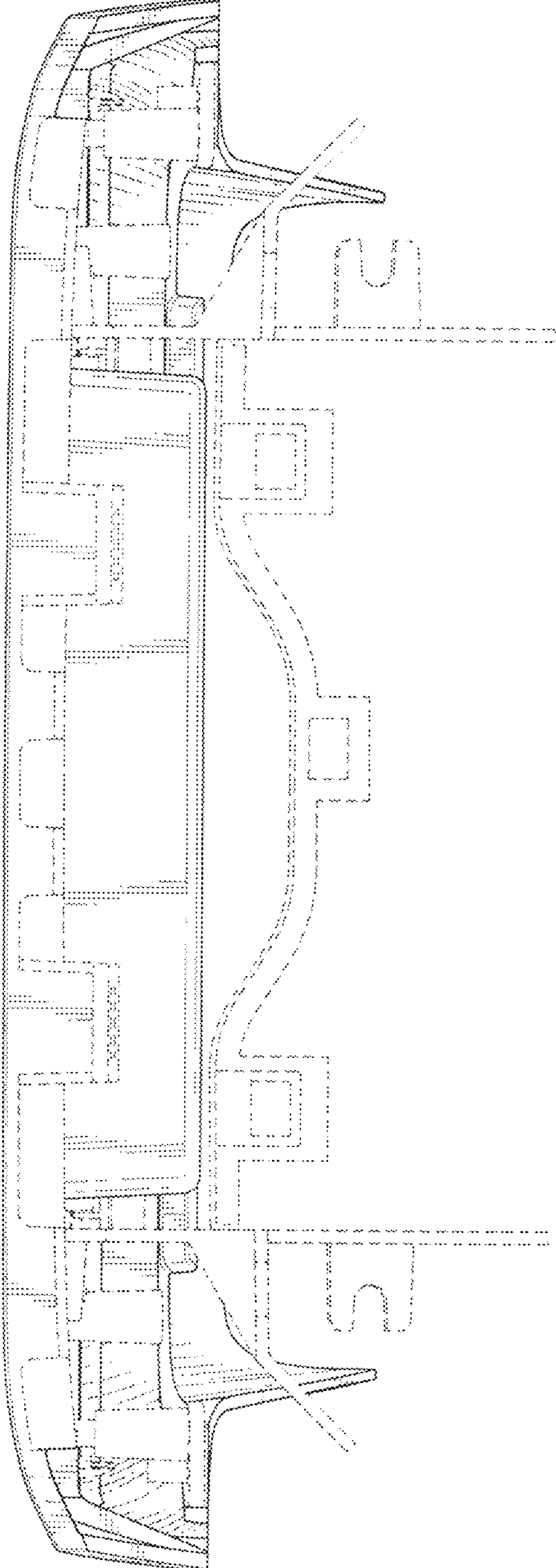
