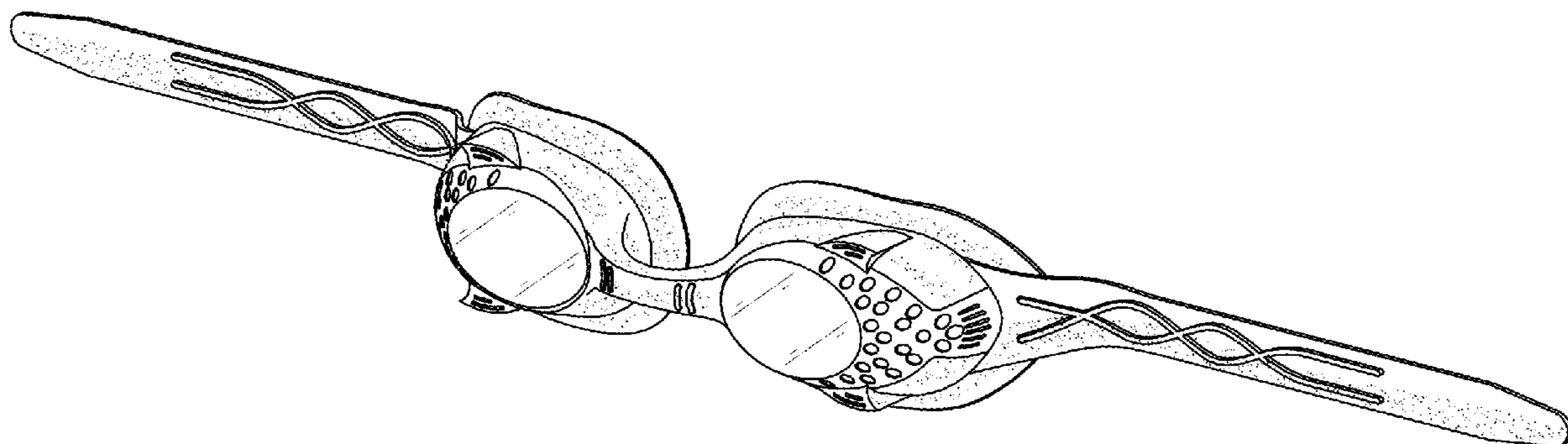
(57) **CLAIM**

The ornamental design for a pair of children's goggles, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a pair of children's goggles showing the claimed new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plane view thereof; FIG. 7 is a bottom plane view thereof; and, FIG. 8 is a usage plane view thereof. The broken lines immediately adjacent to the claimed portions are boundaries, all other broken lines are environmental structures; all the broken lines form no part of the claimed design.

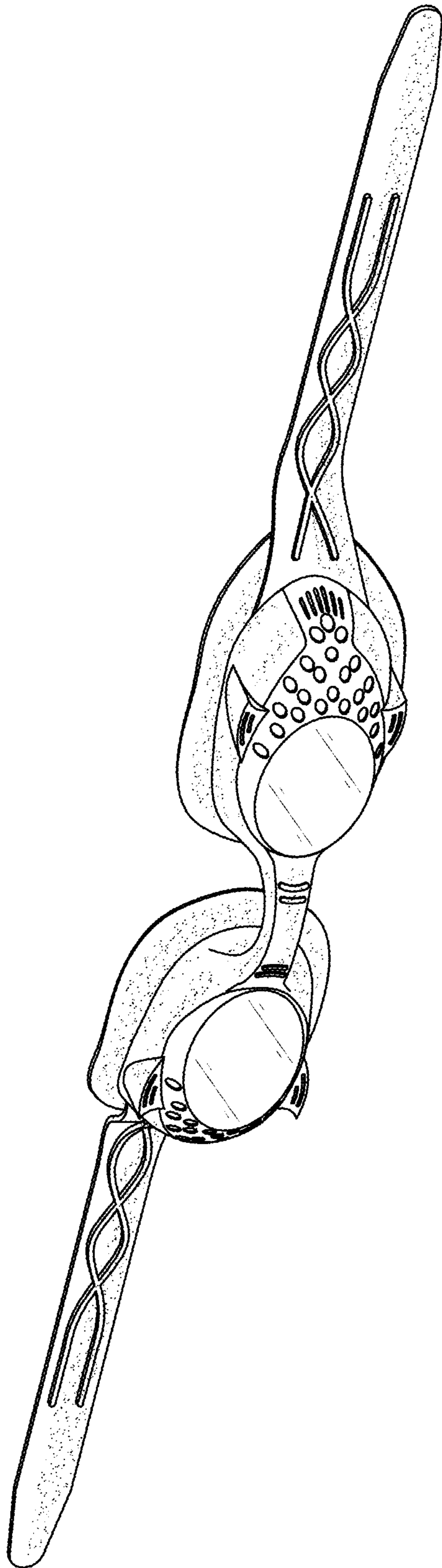

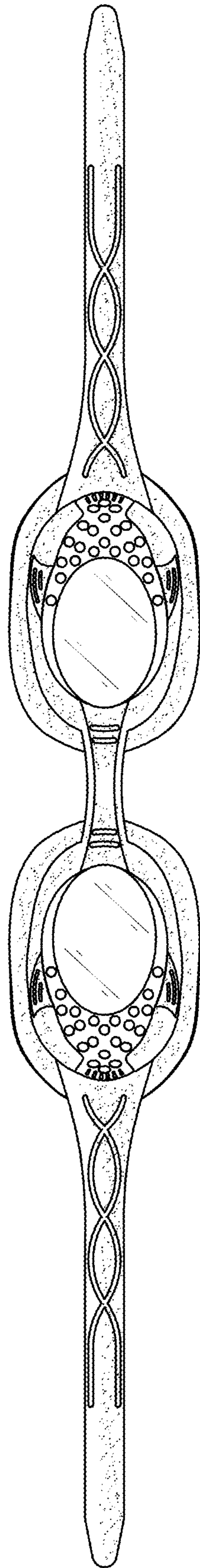

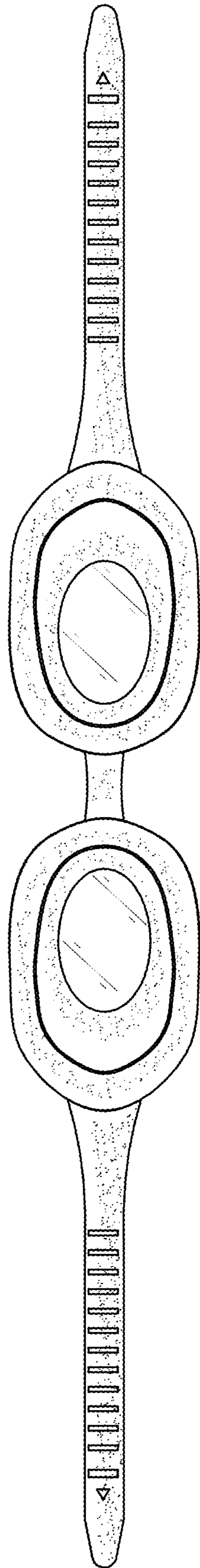

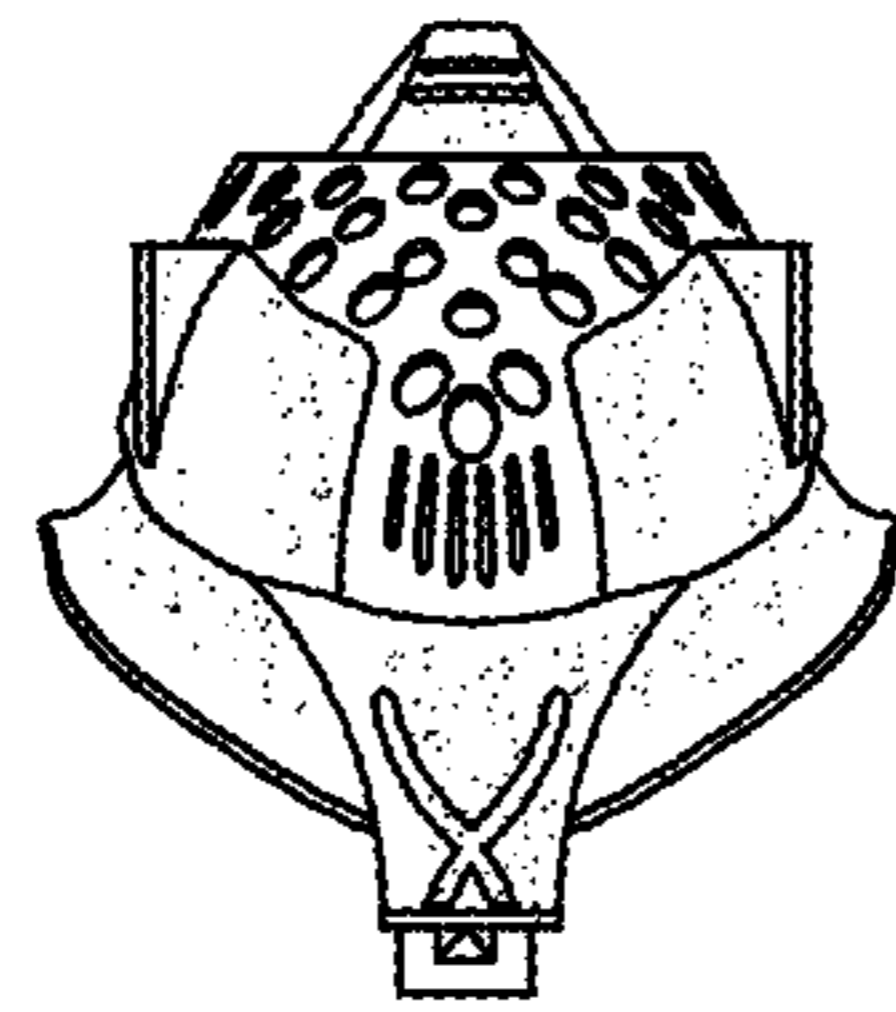

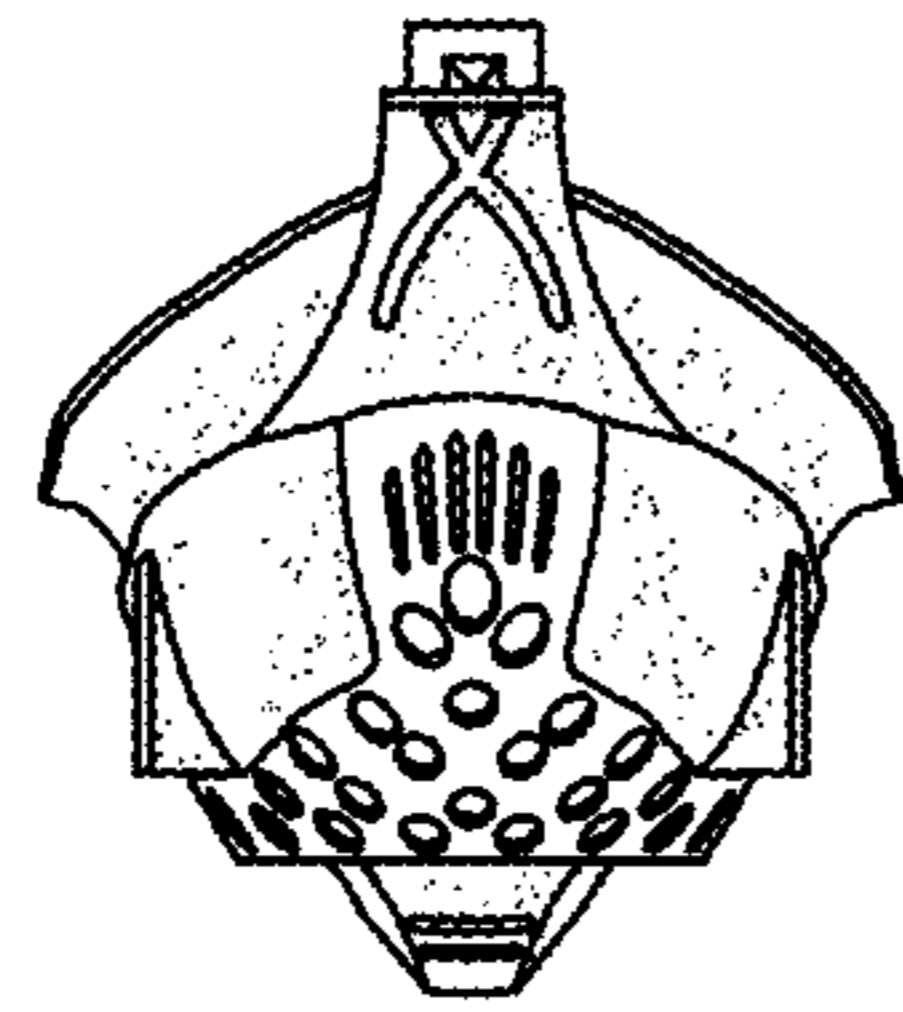

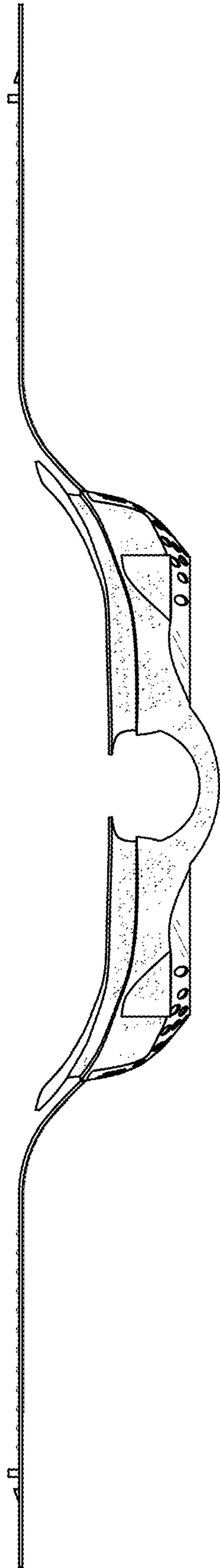

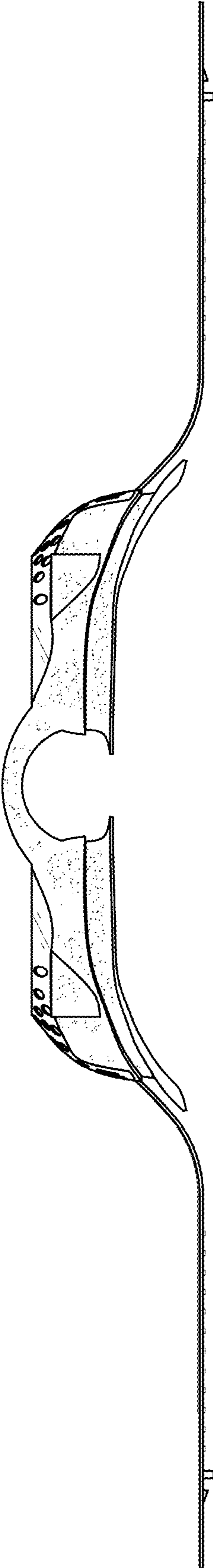

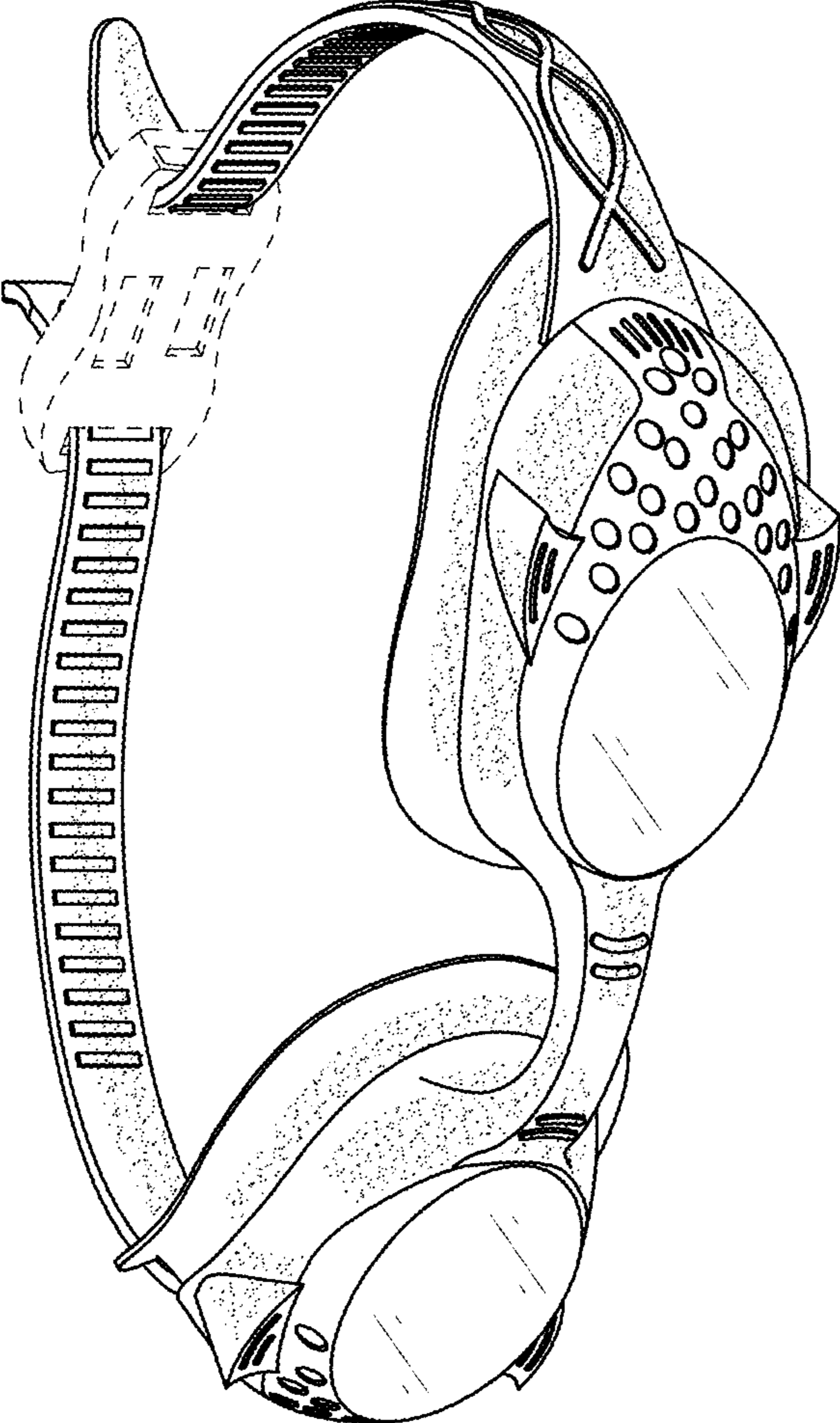
