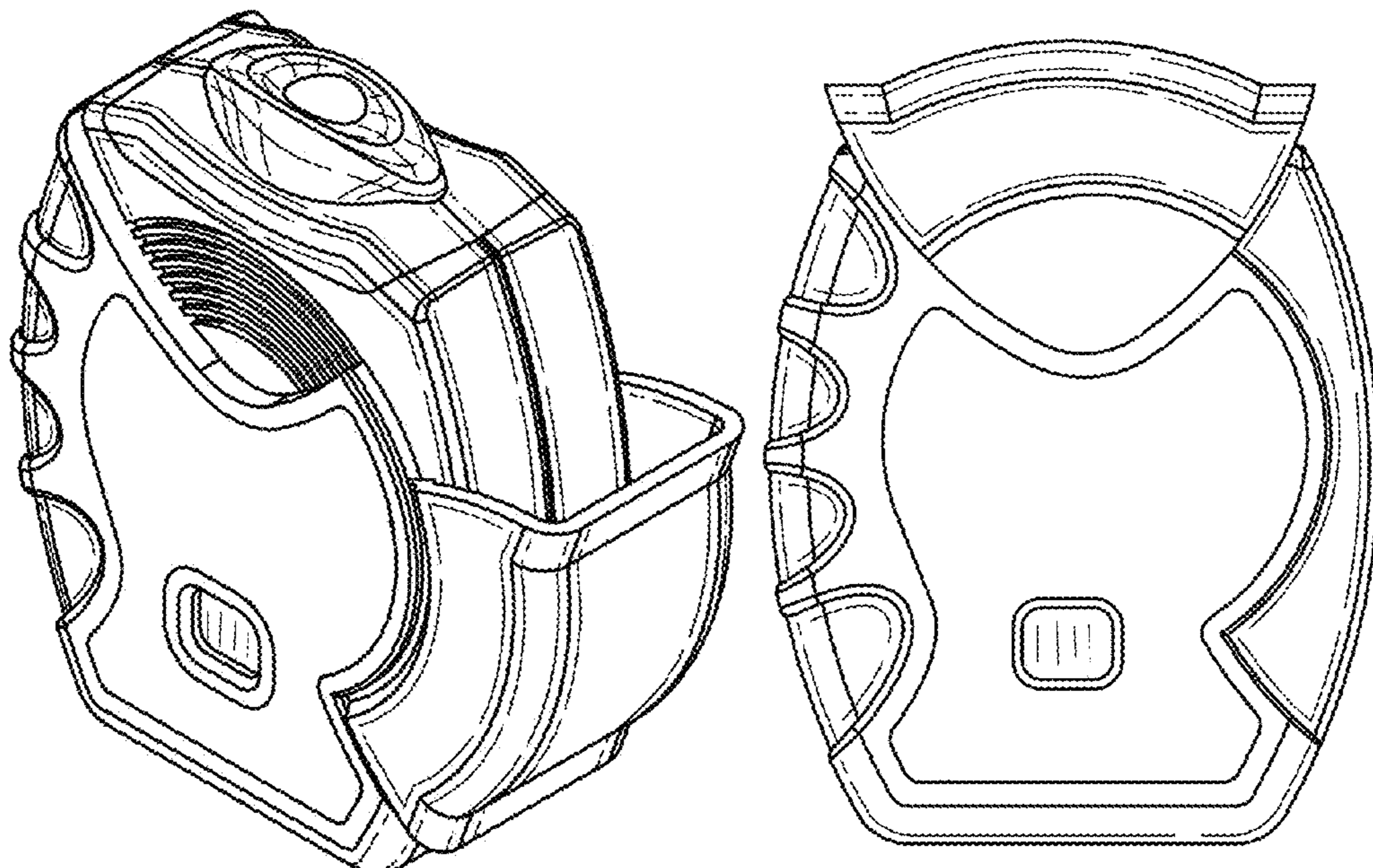
(57) **CLAIM**

The ornamental design for an inhaler for powdered medicaments, as shown and described.

**DESCRIPTION**

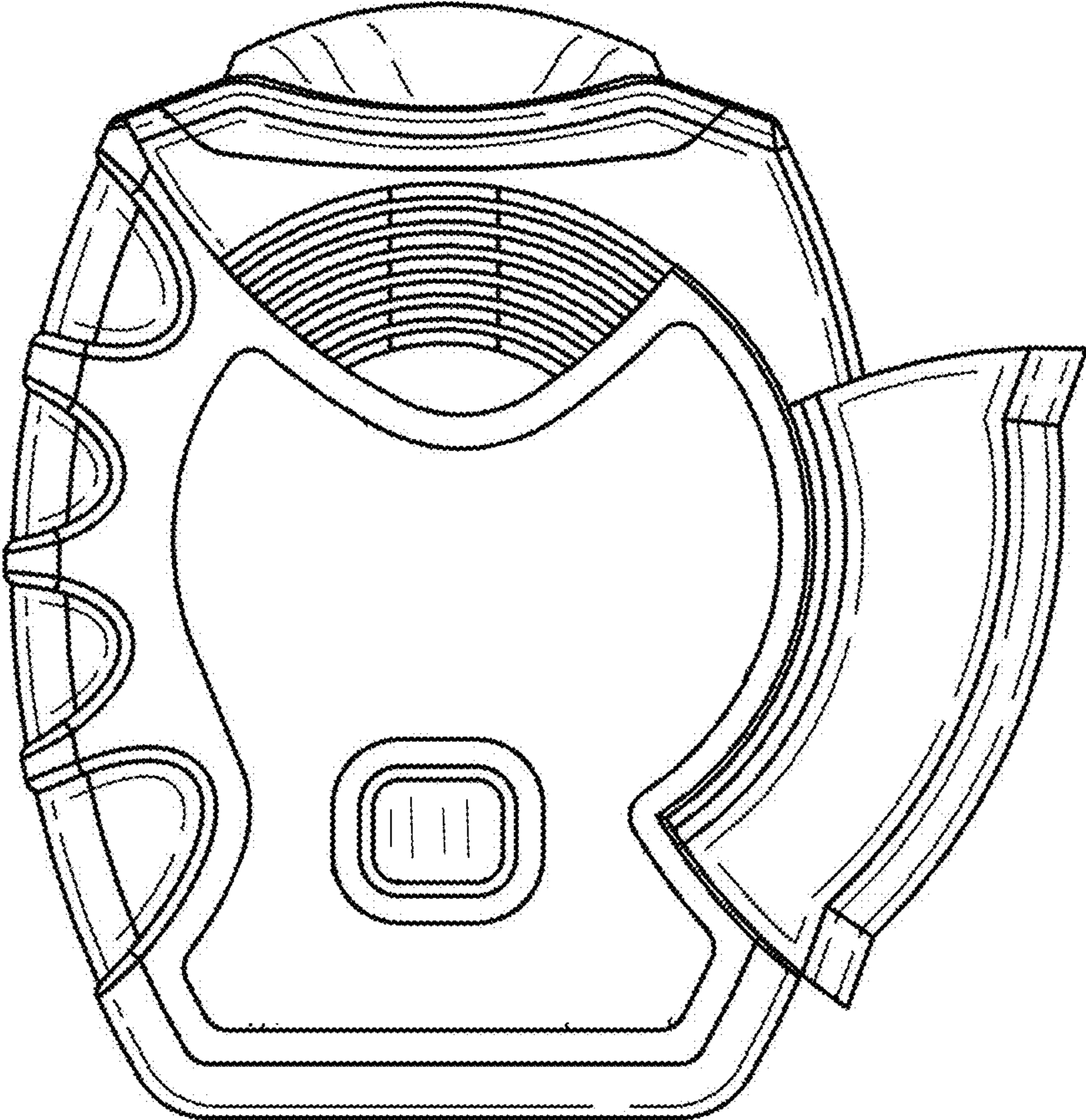

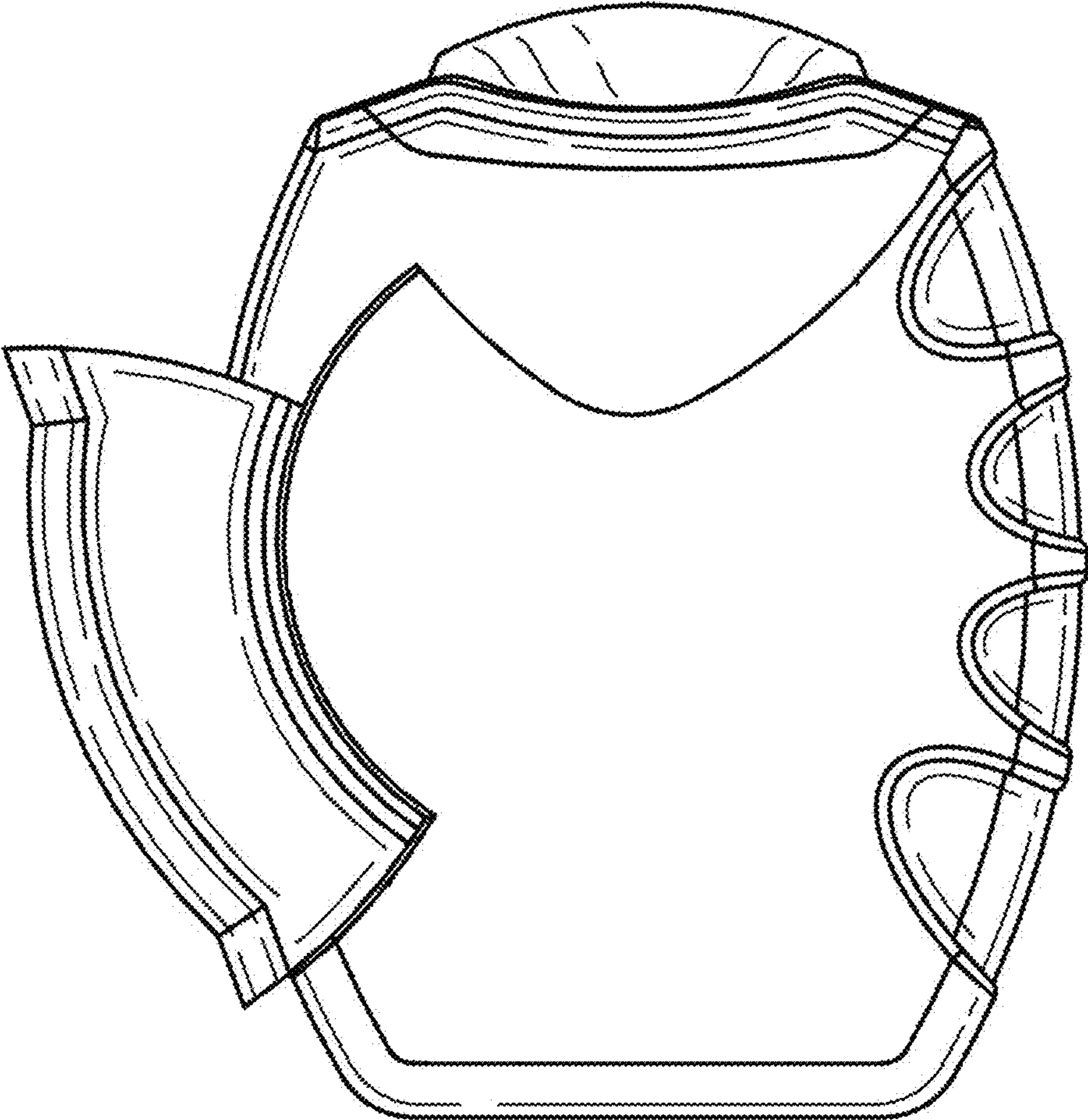

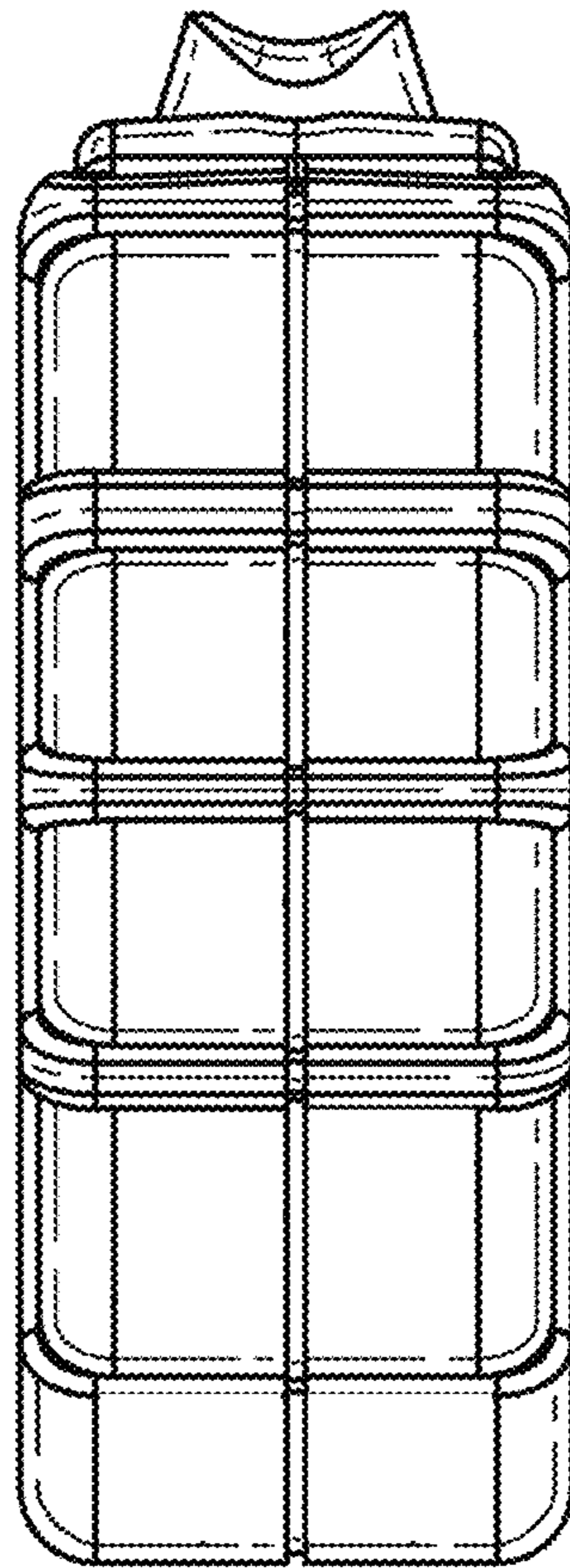

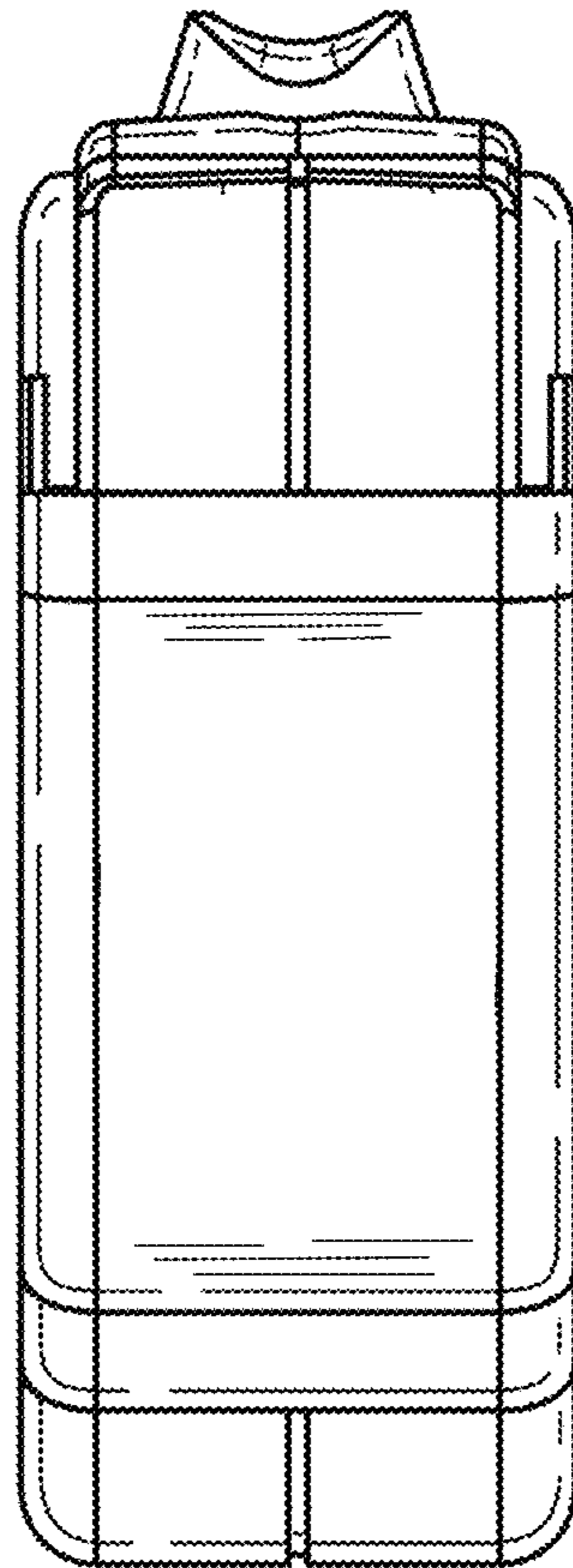

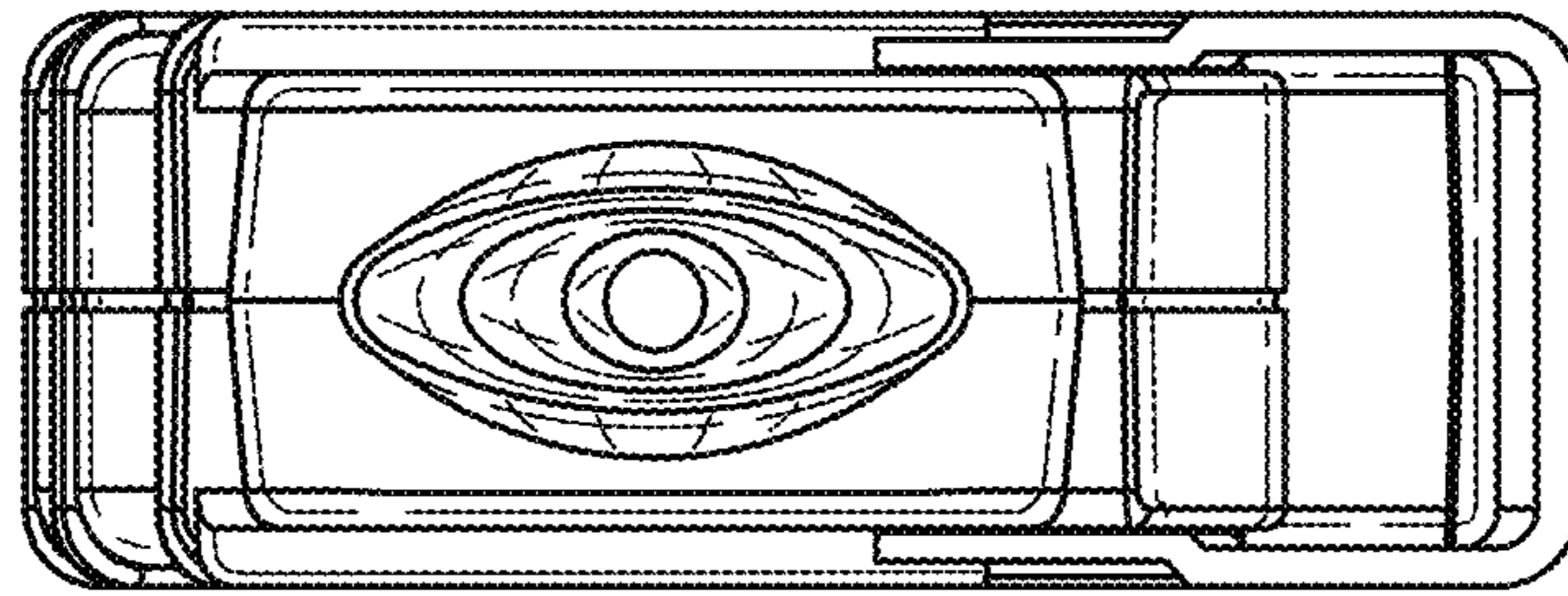

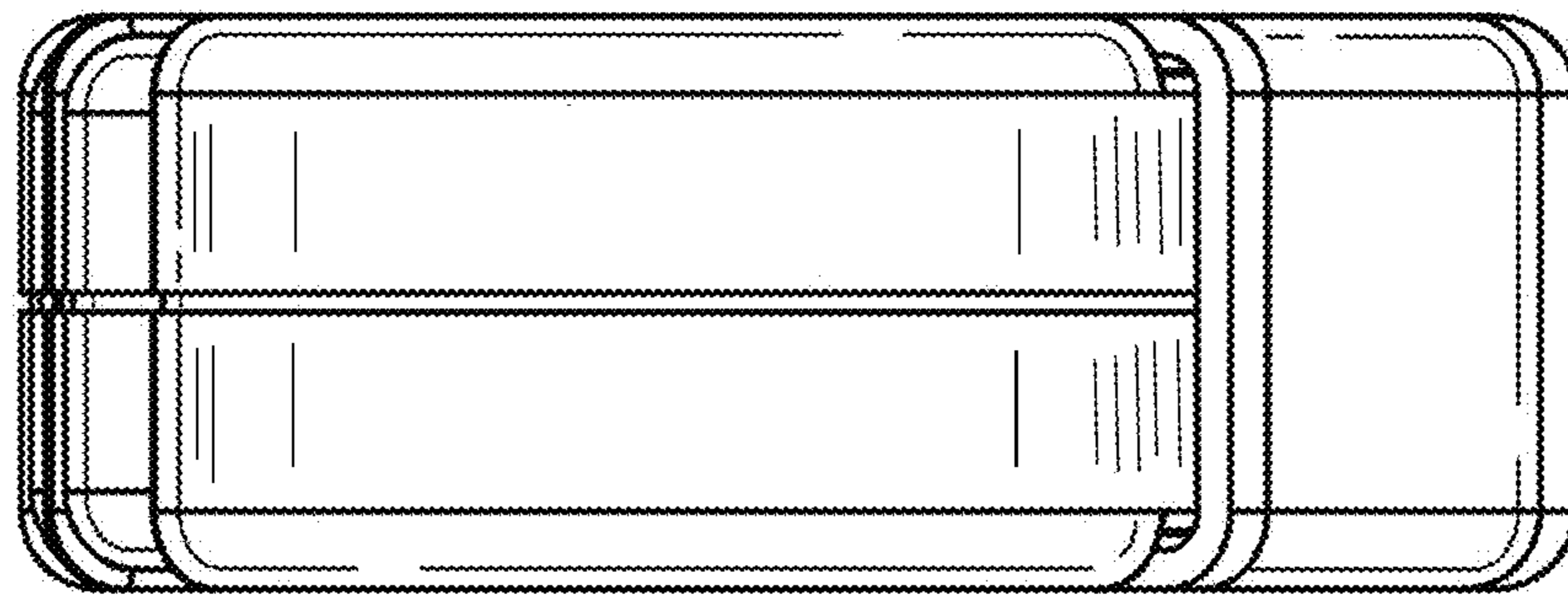

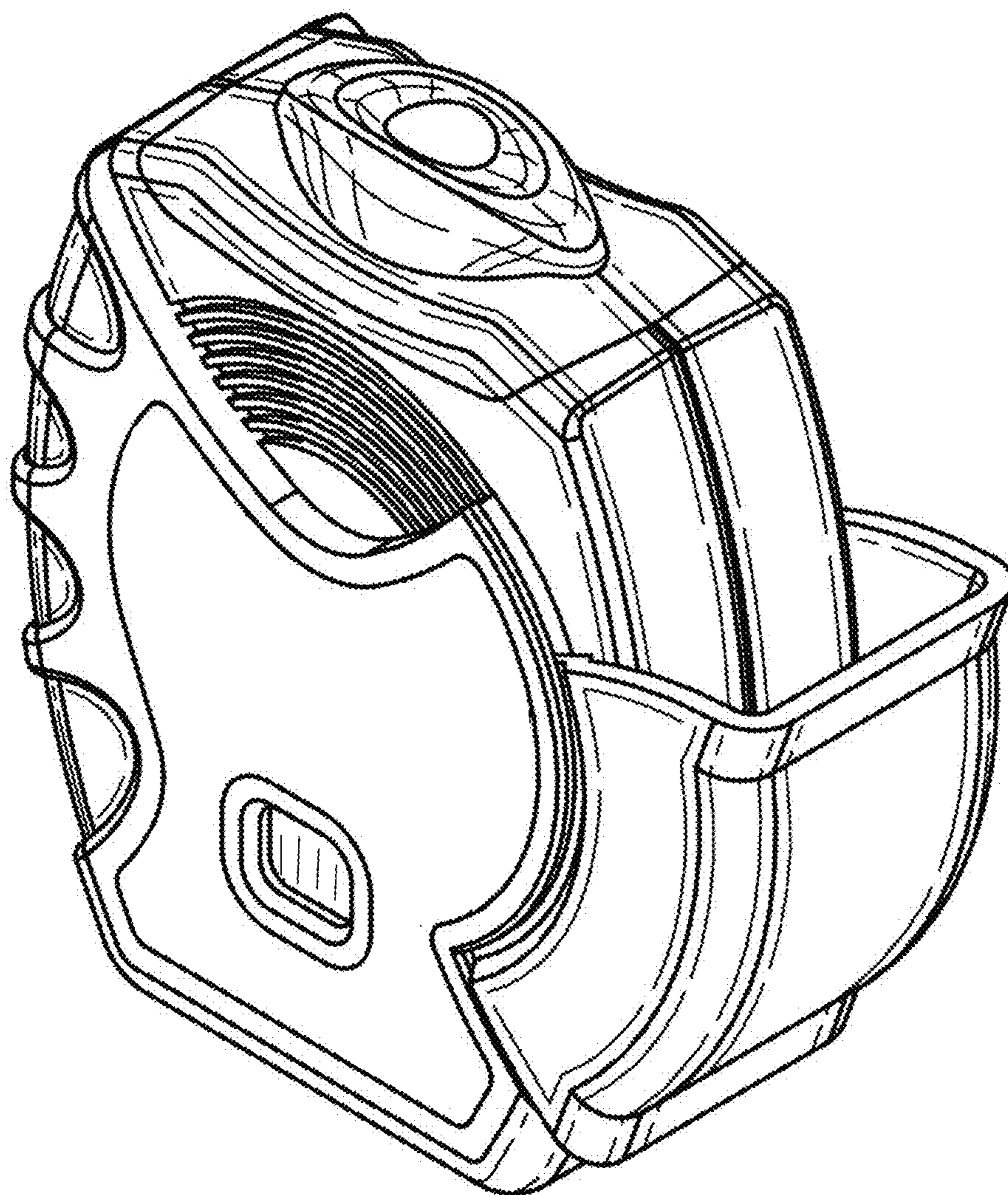

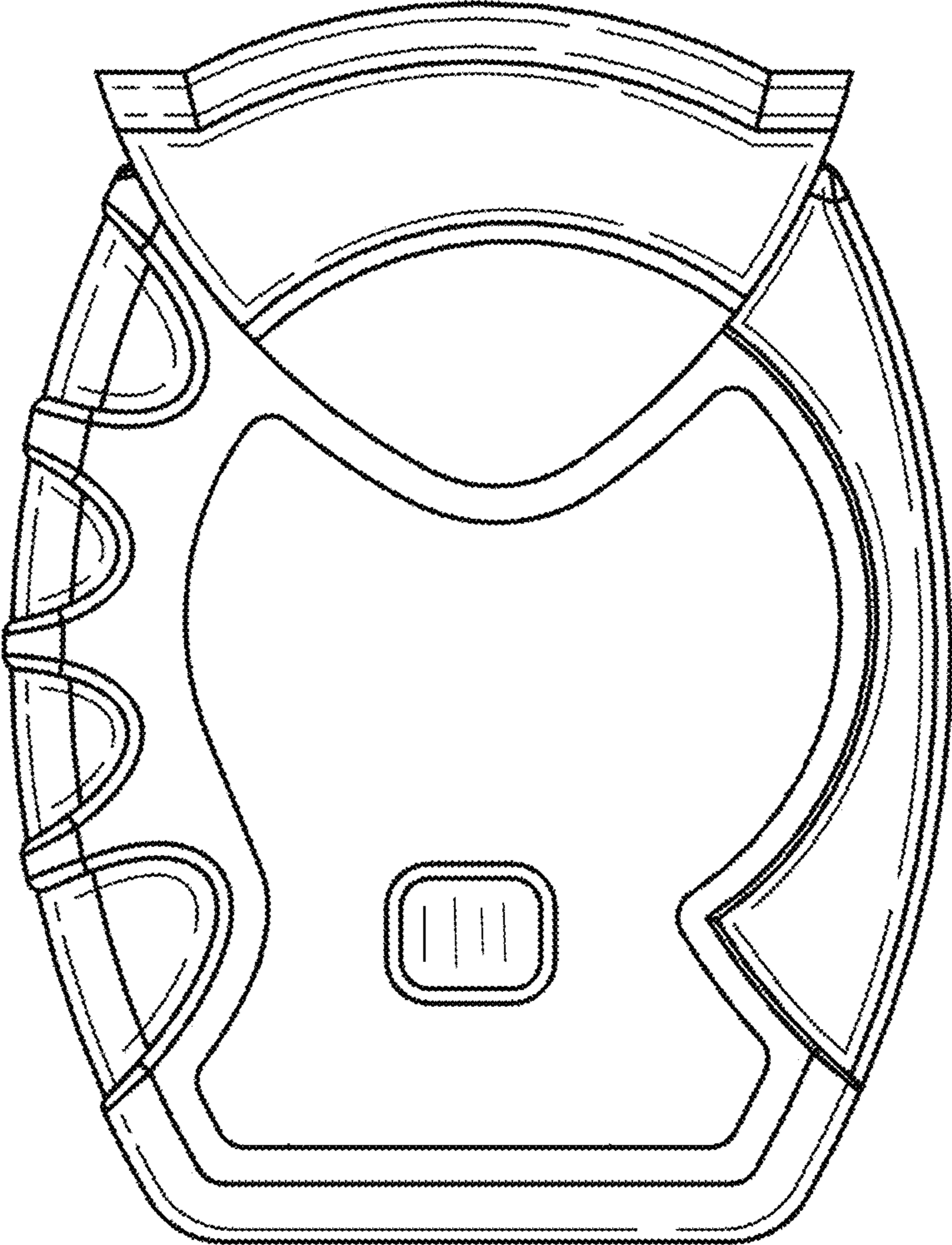

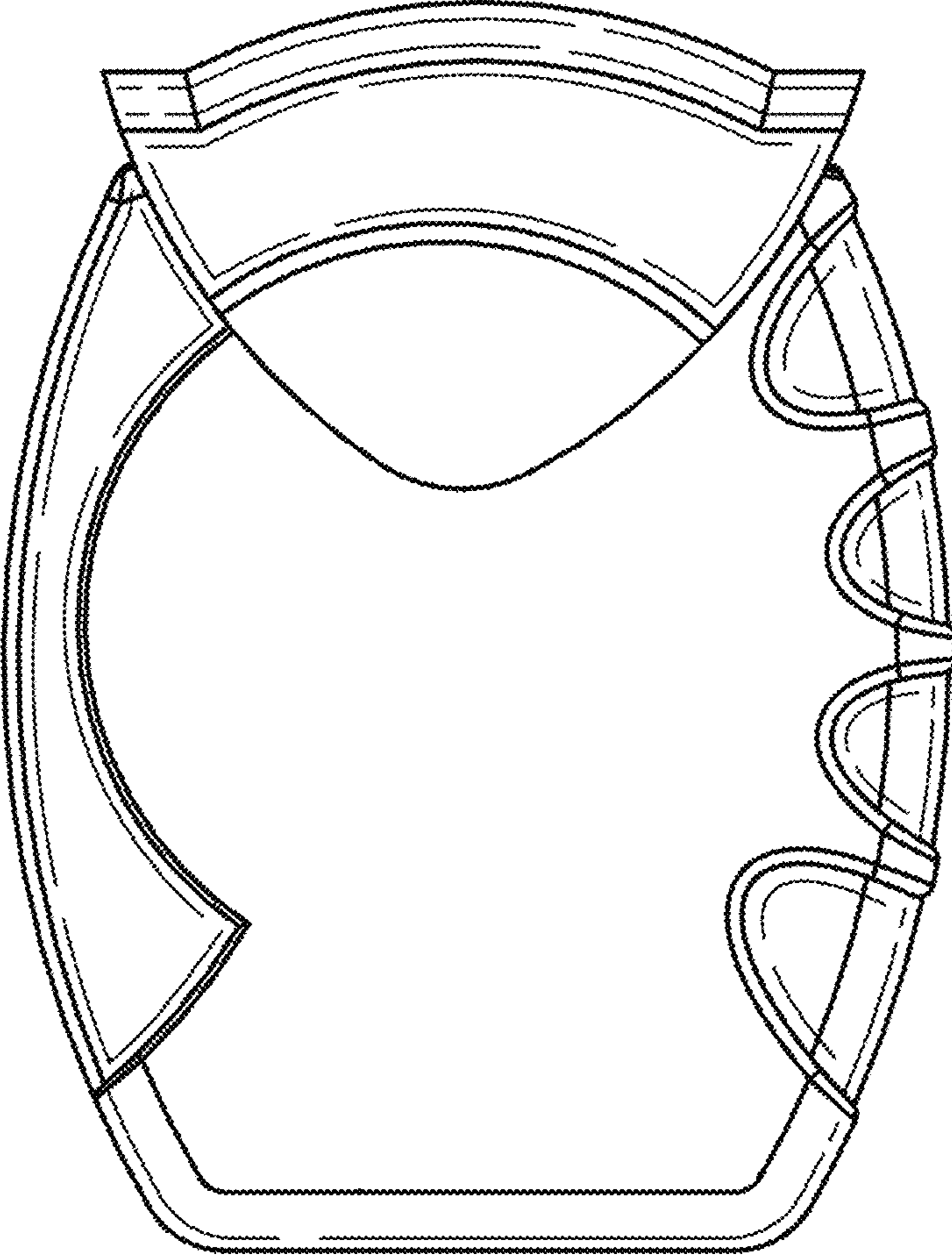

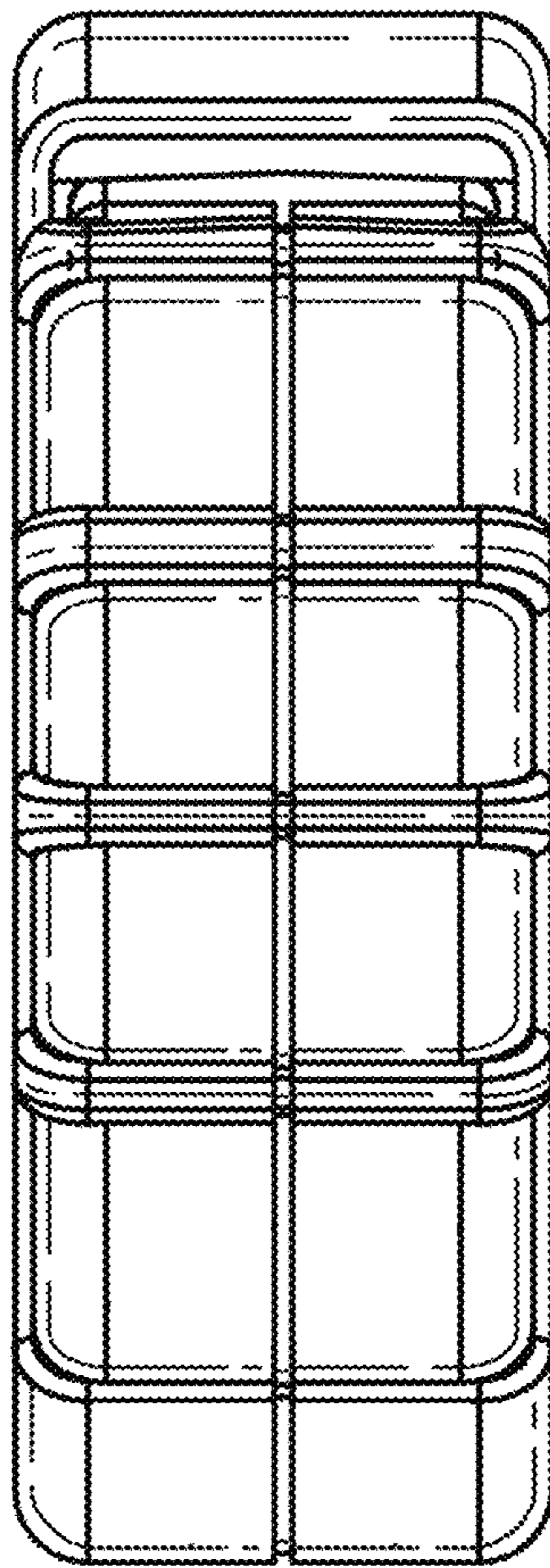

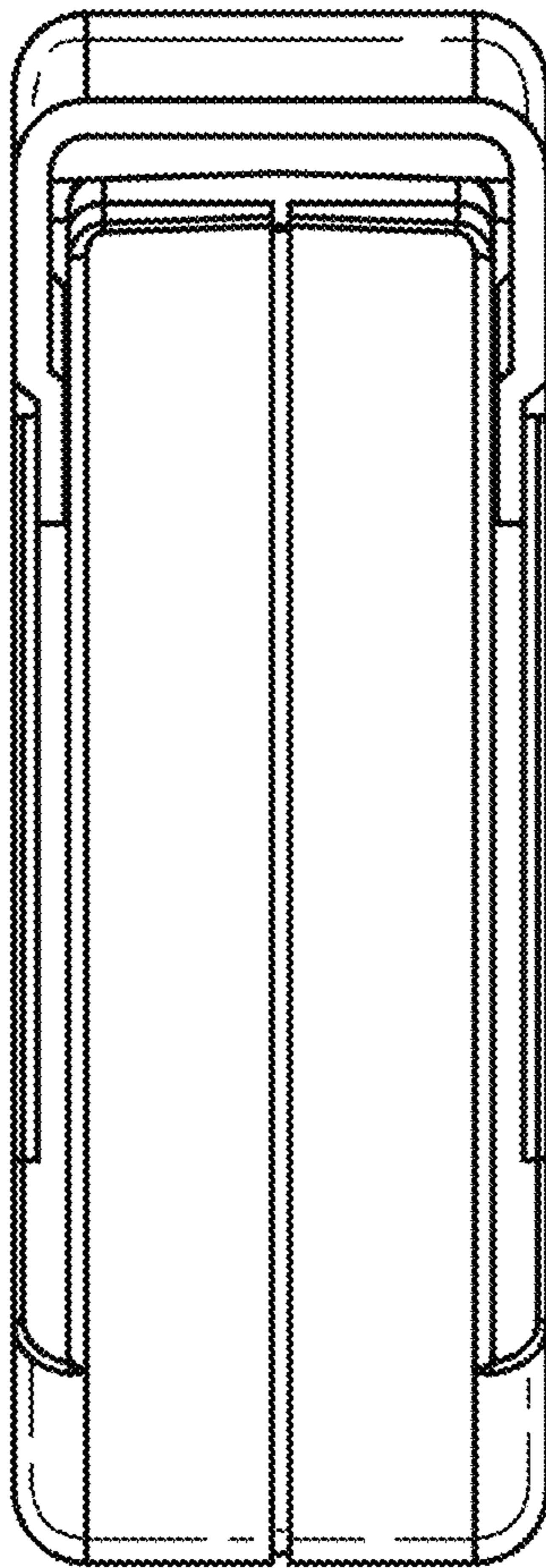

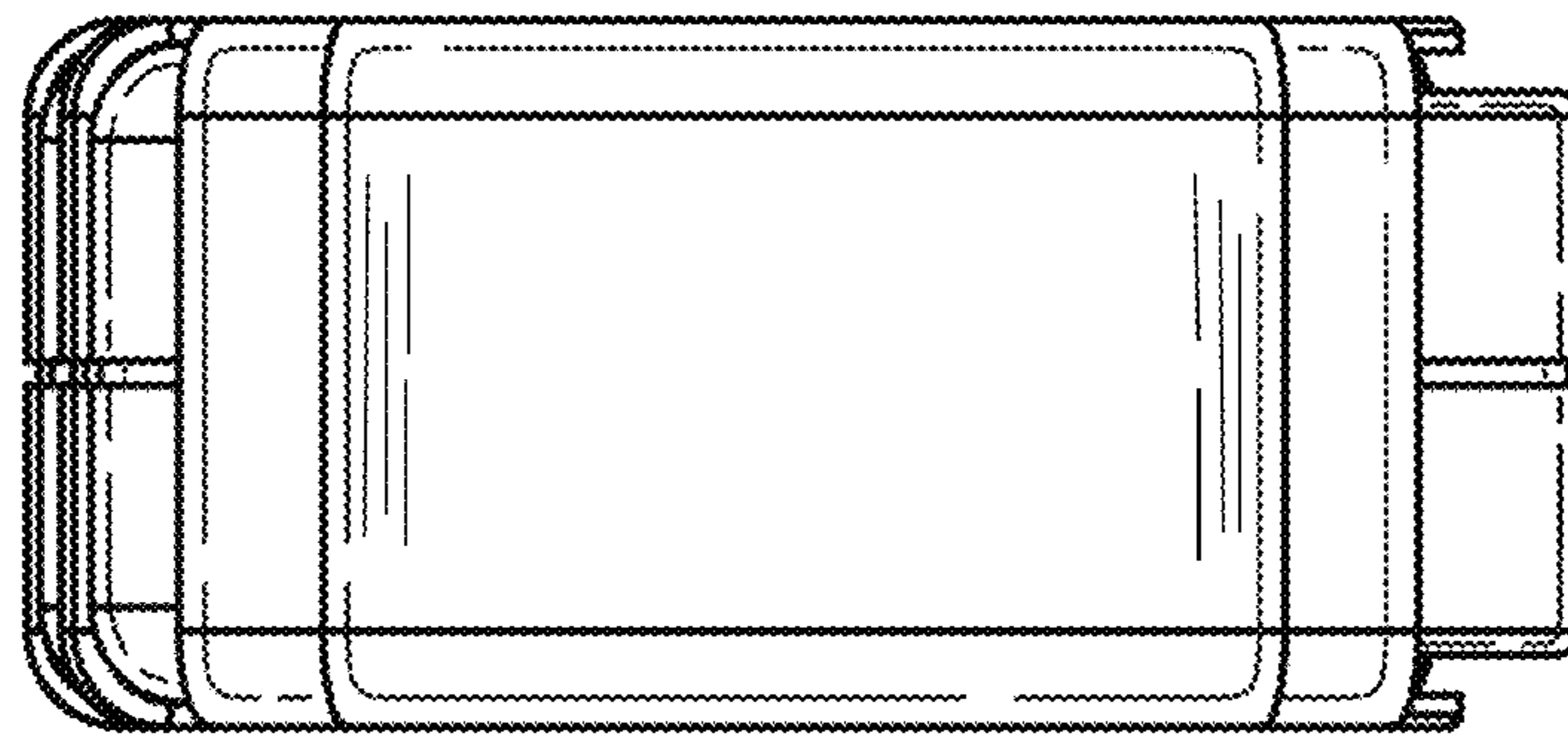

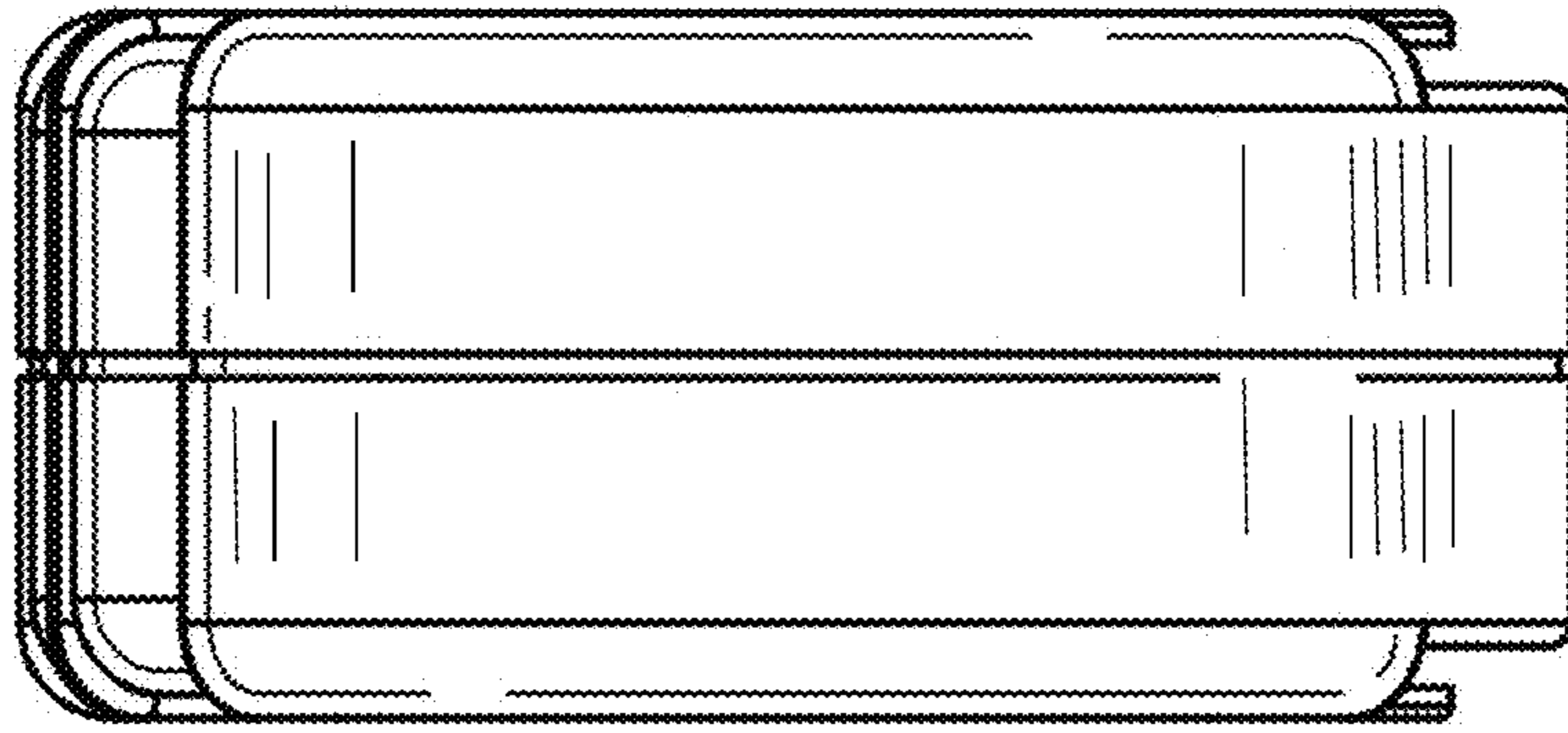

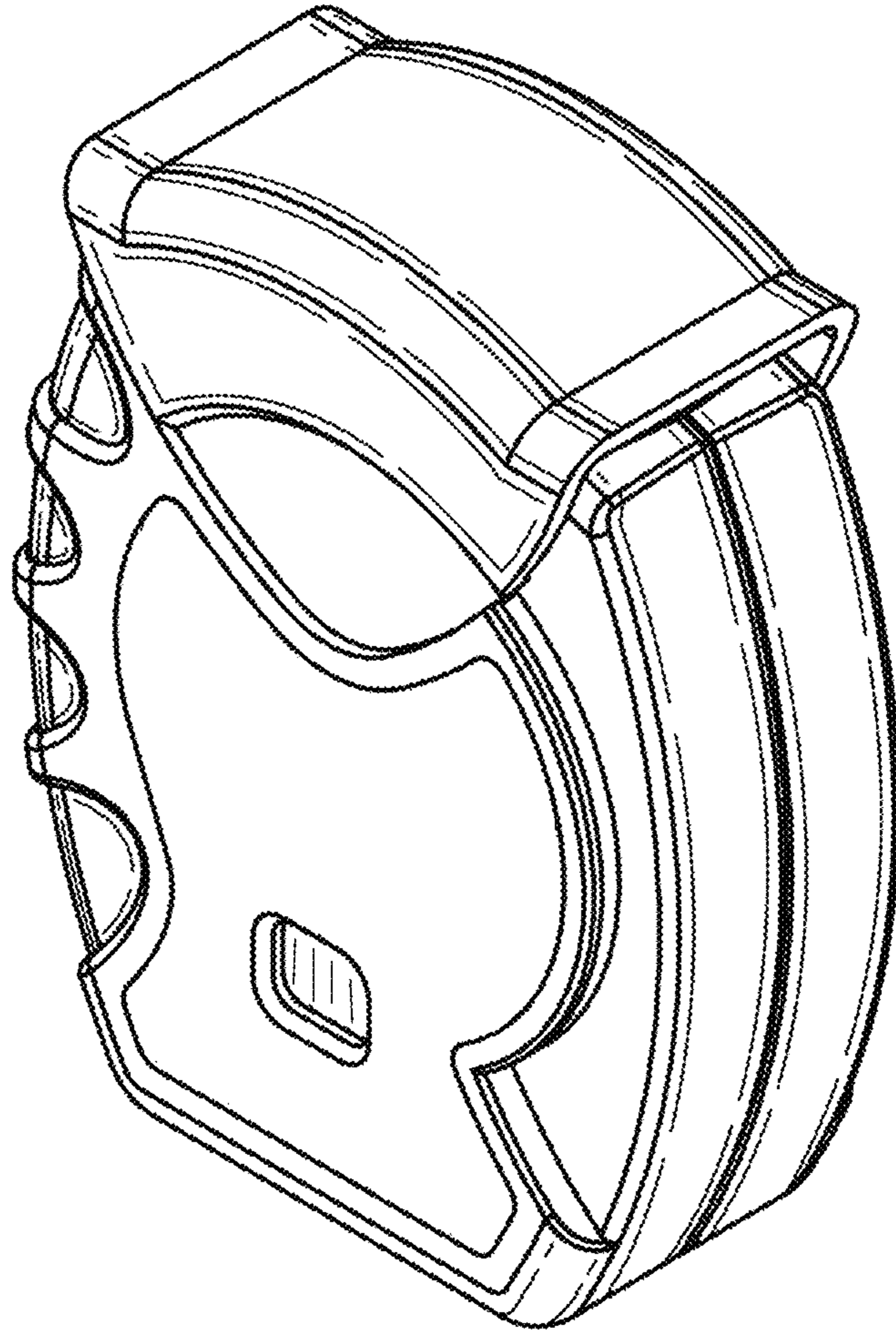
