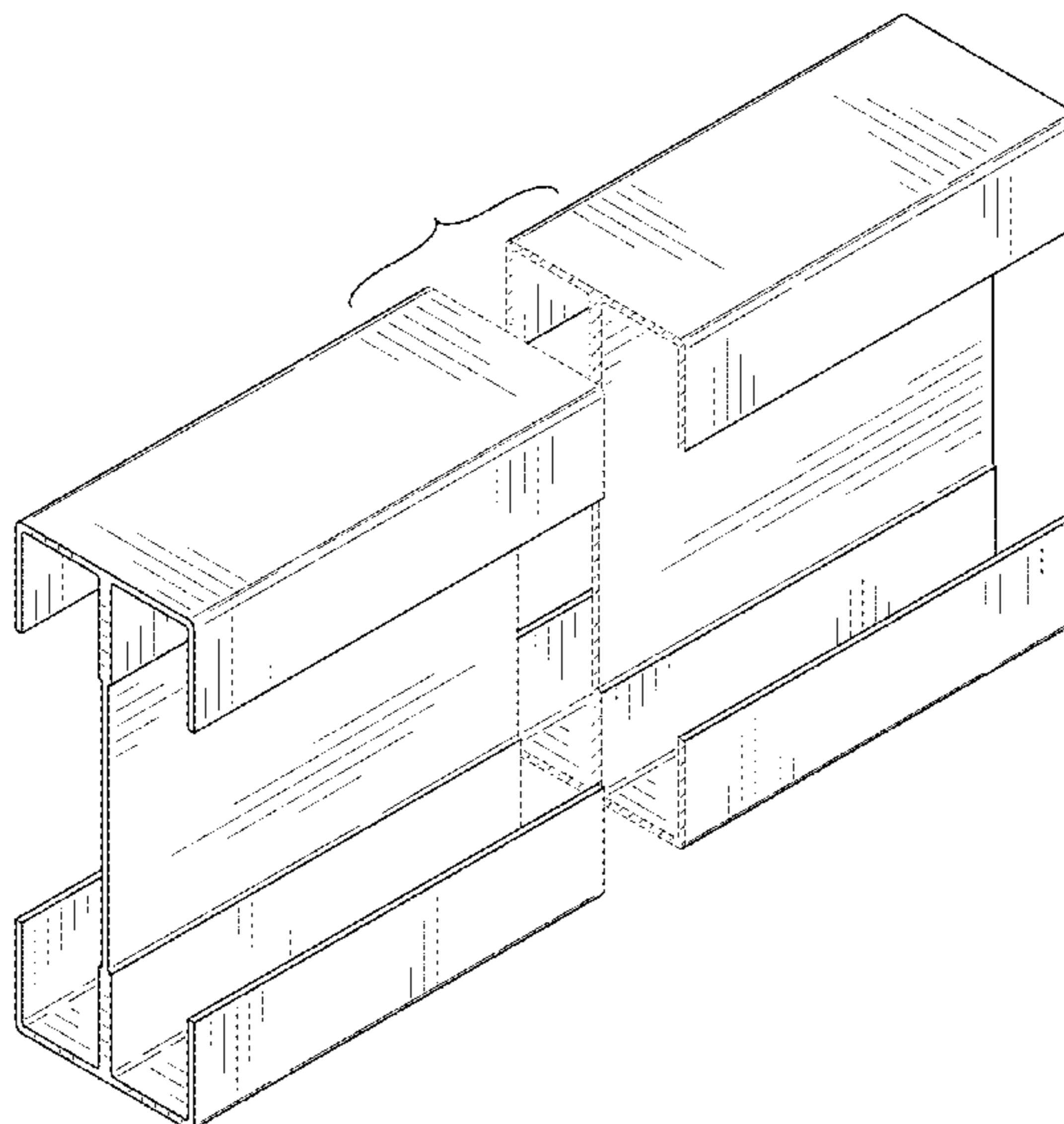
(57) **CLAIM**

We claim the ornamental design for a beam, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a beam showing my new  
design;  
FIG. 2 is a back elevation thereof;  
FIG. 3 is a left-side elevation view thereof;  
FIG. 4 is a right-side elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a perspective view thereof, showing the beam.  
The break lines shown in FIGS. 3-7 indicate a symbolic  
break in length. The appearance of any portion of the article  
between the break lines forms no part of the claimed design.

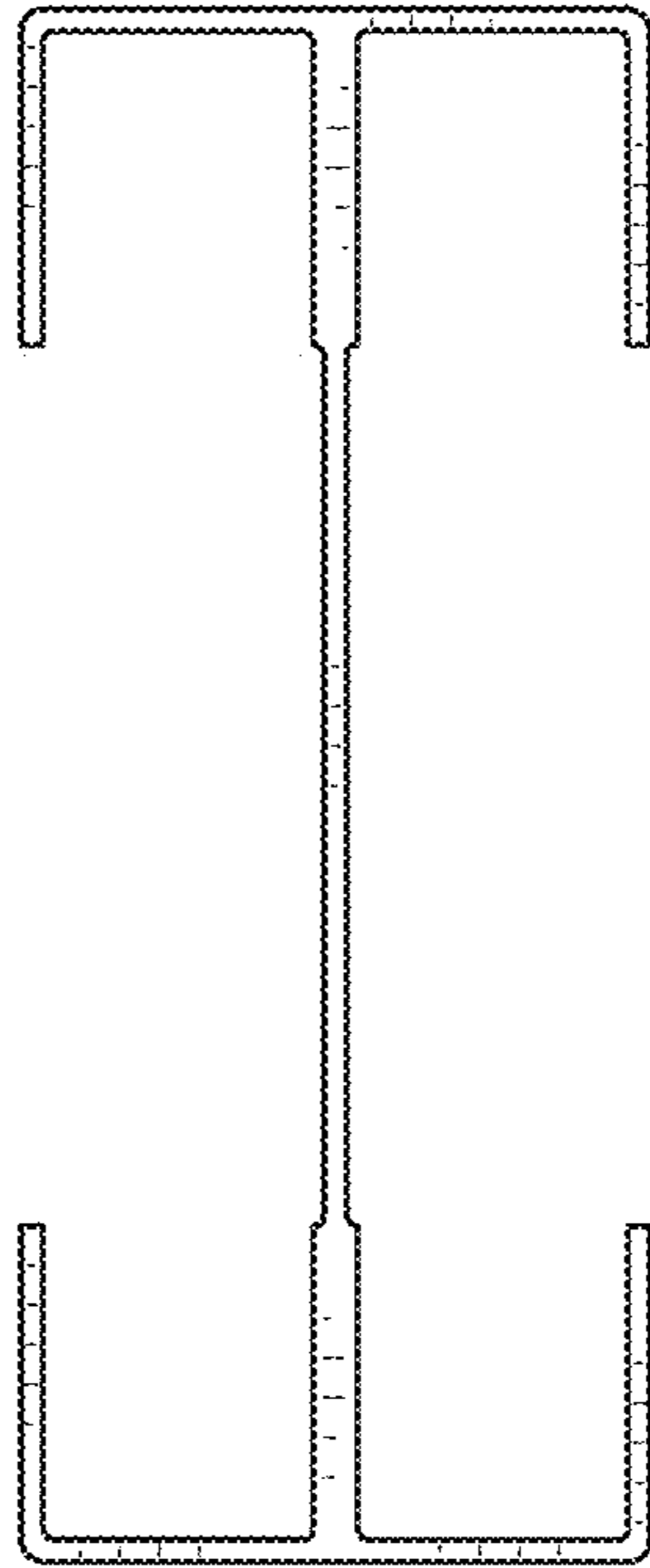

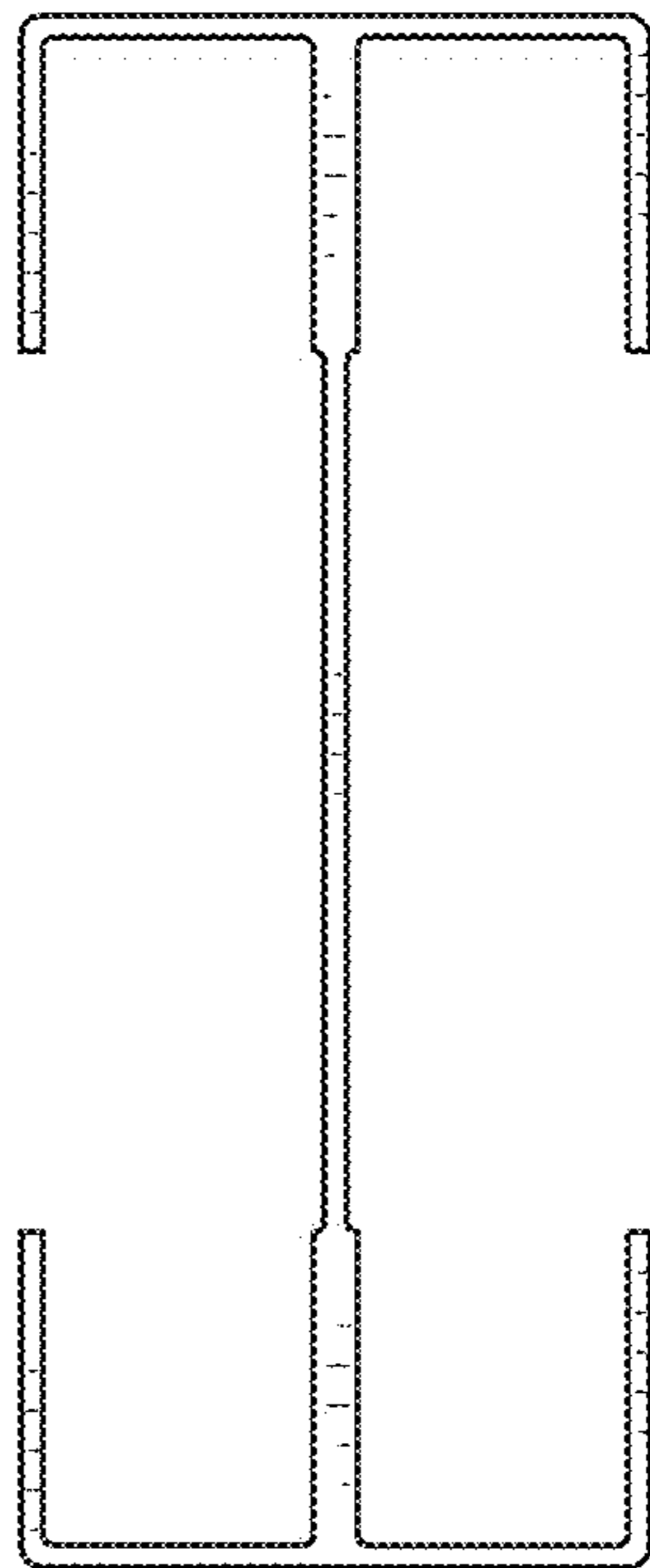

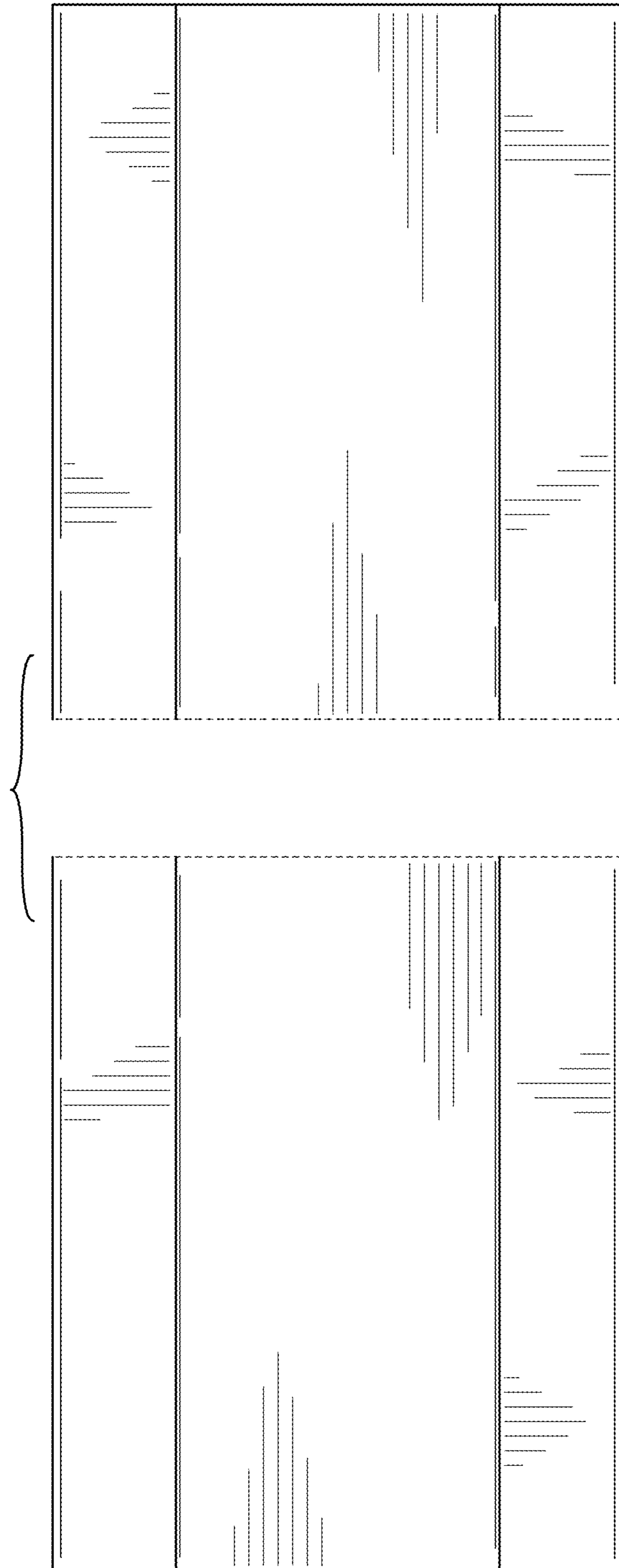

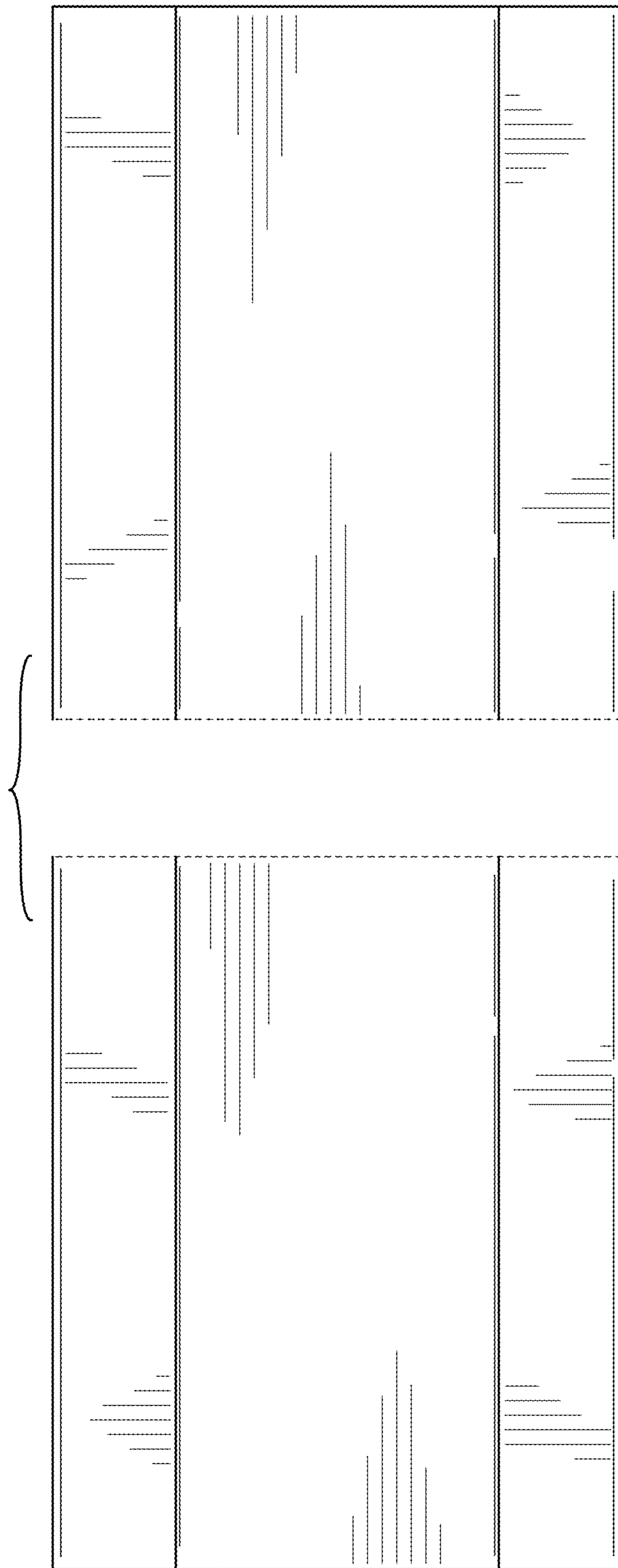

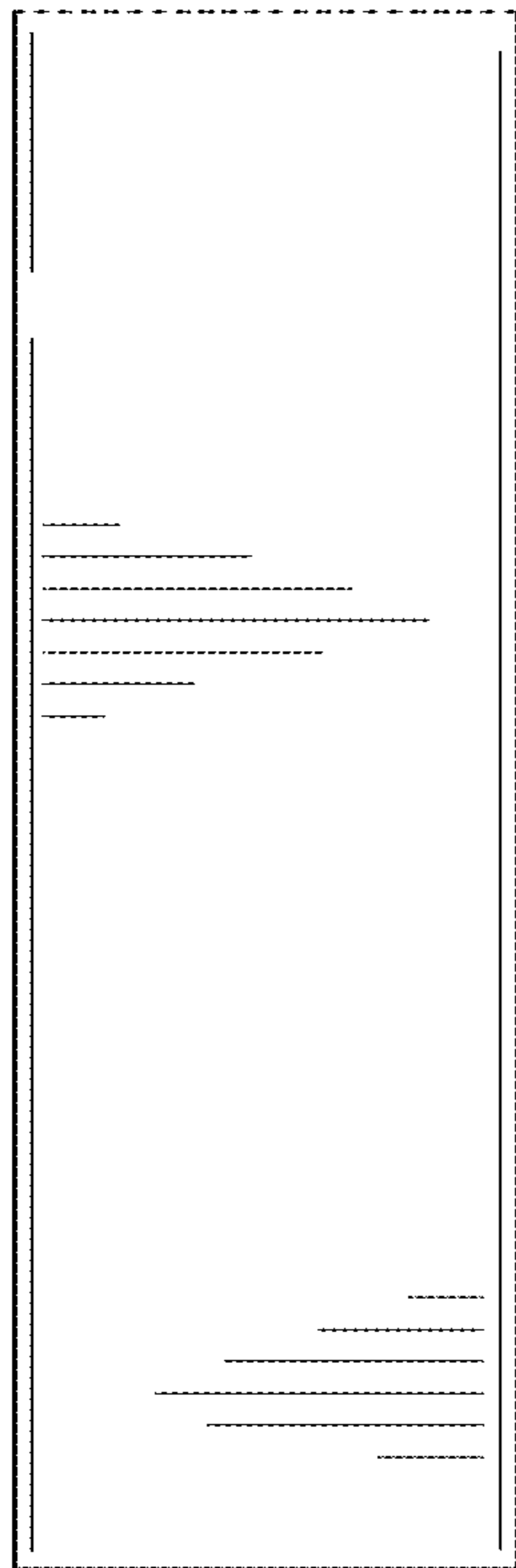
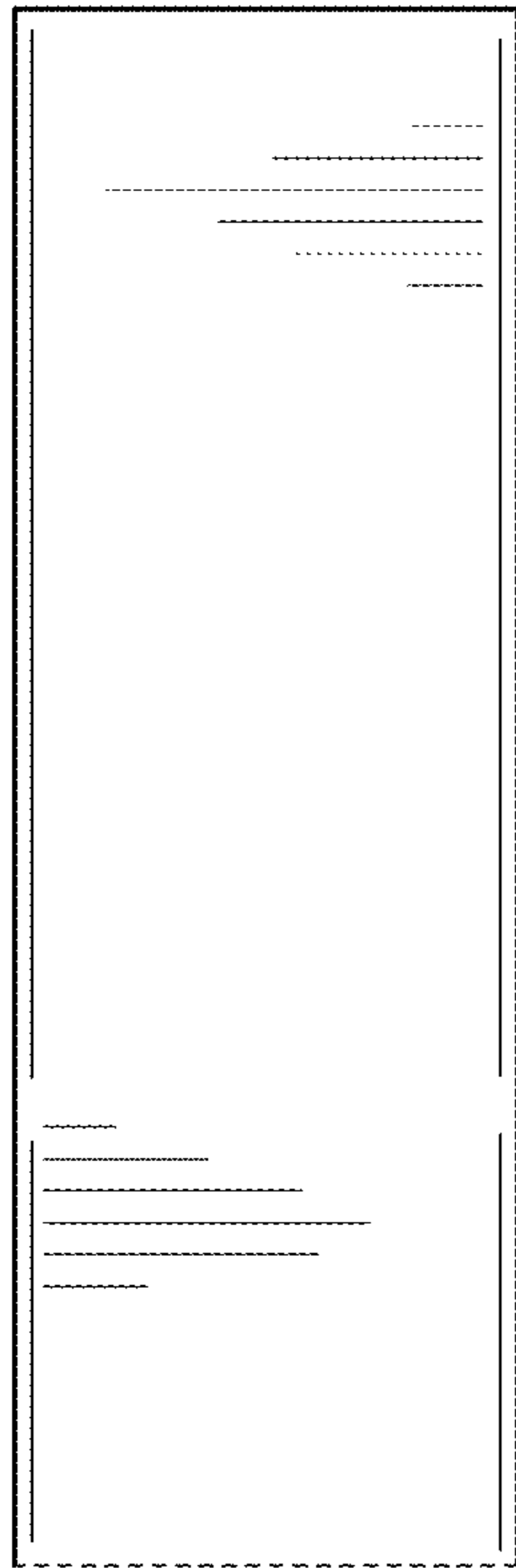

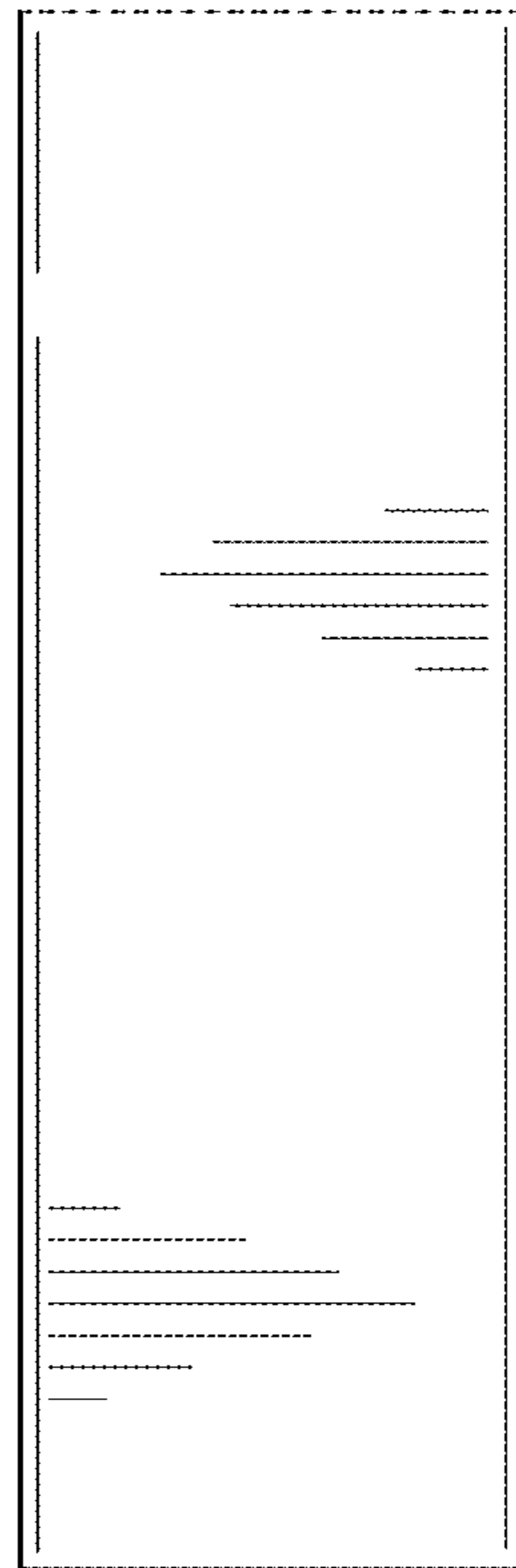
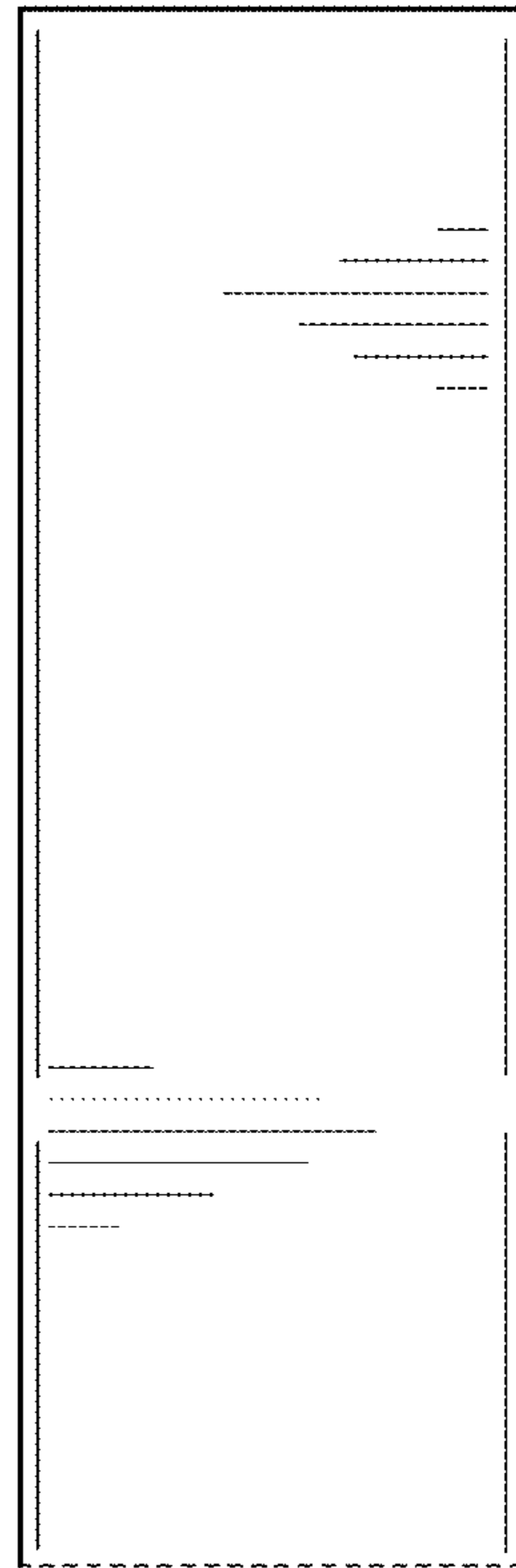

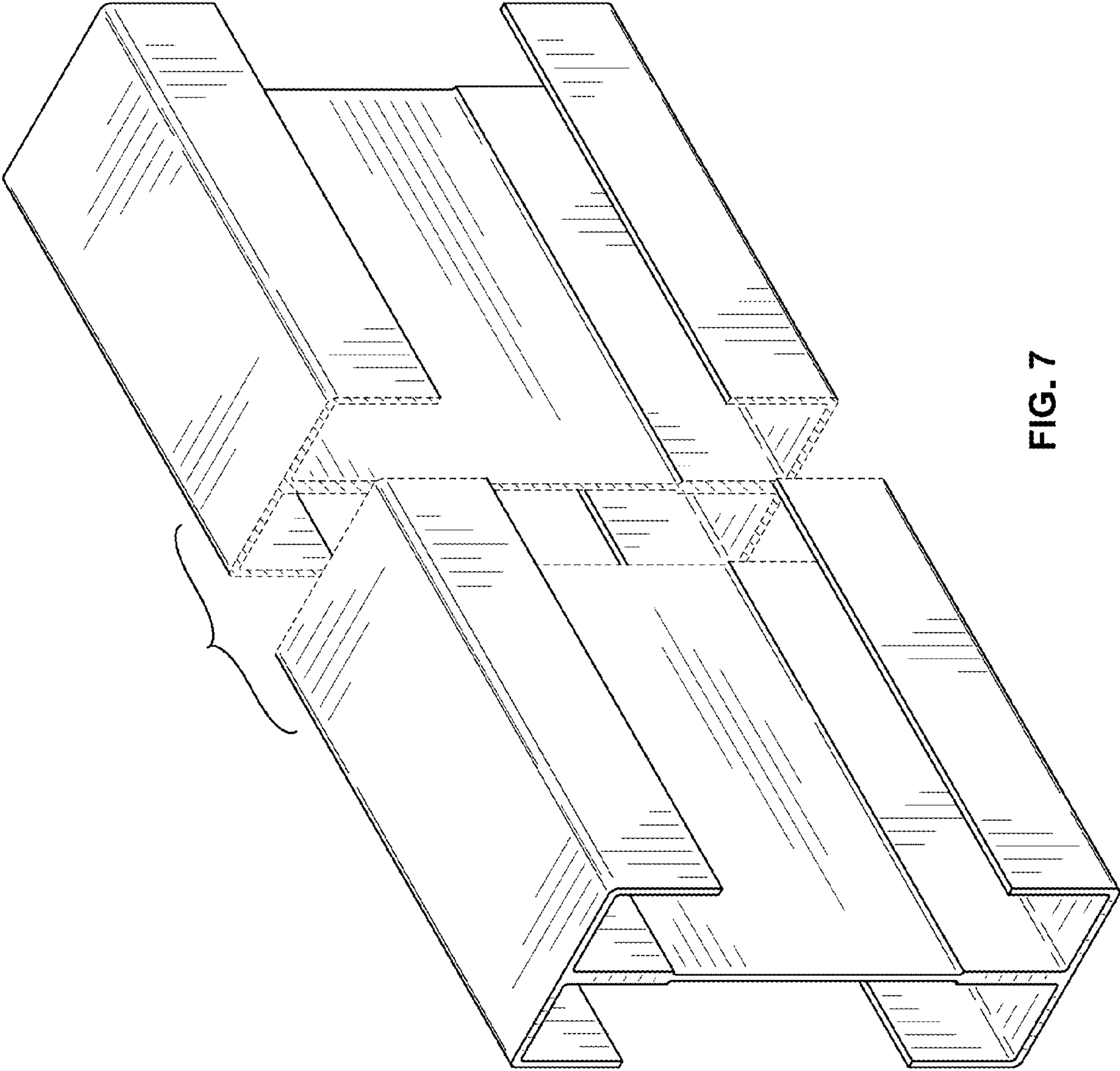
