DESCRIPTION

illustrating a first light emitting surface.

FIG. 5 is a front view of the luminaire of FIG. 1.

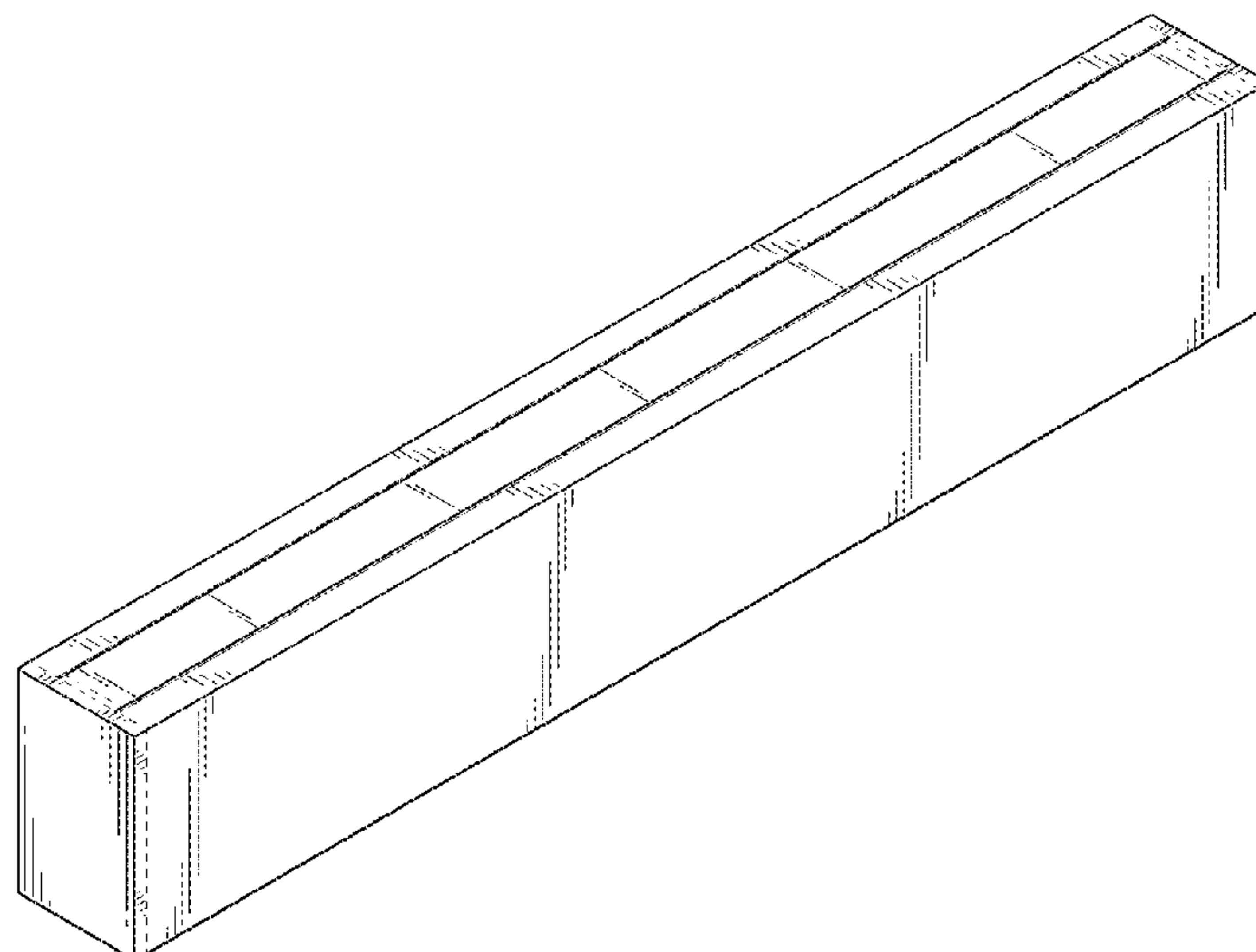
FIG. 6 is a rear view of the luminaire of FIG. 1.

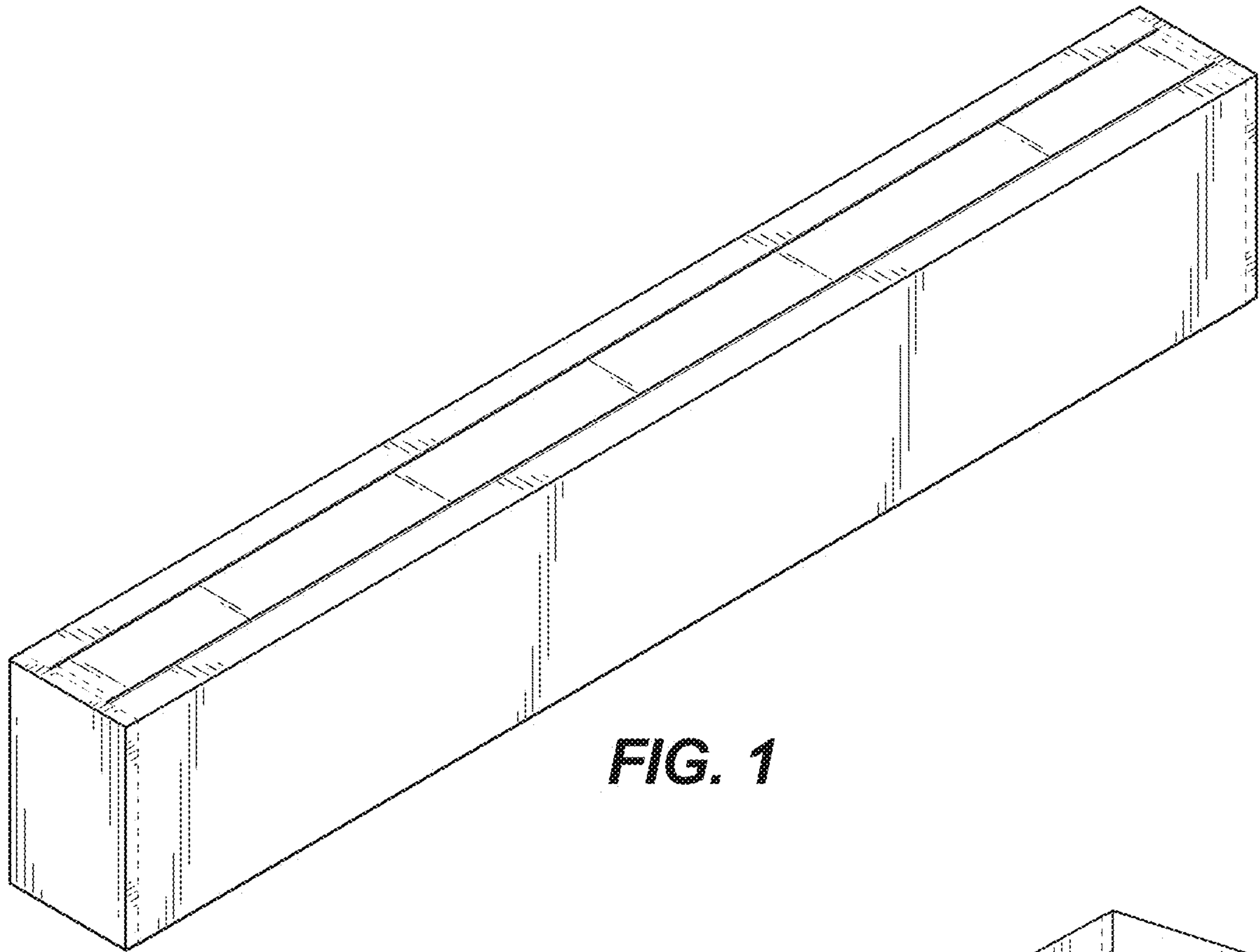

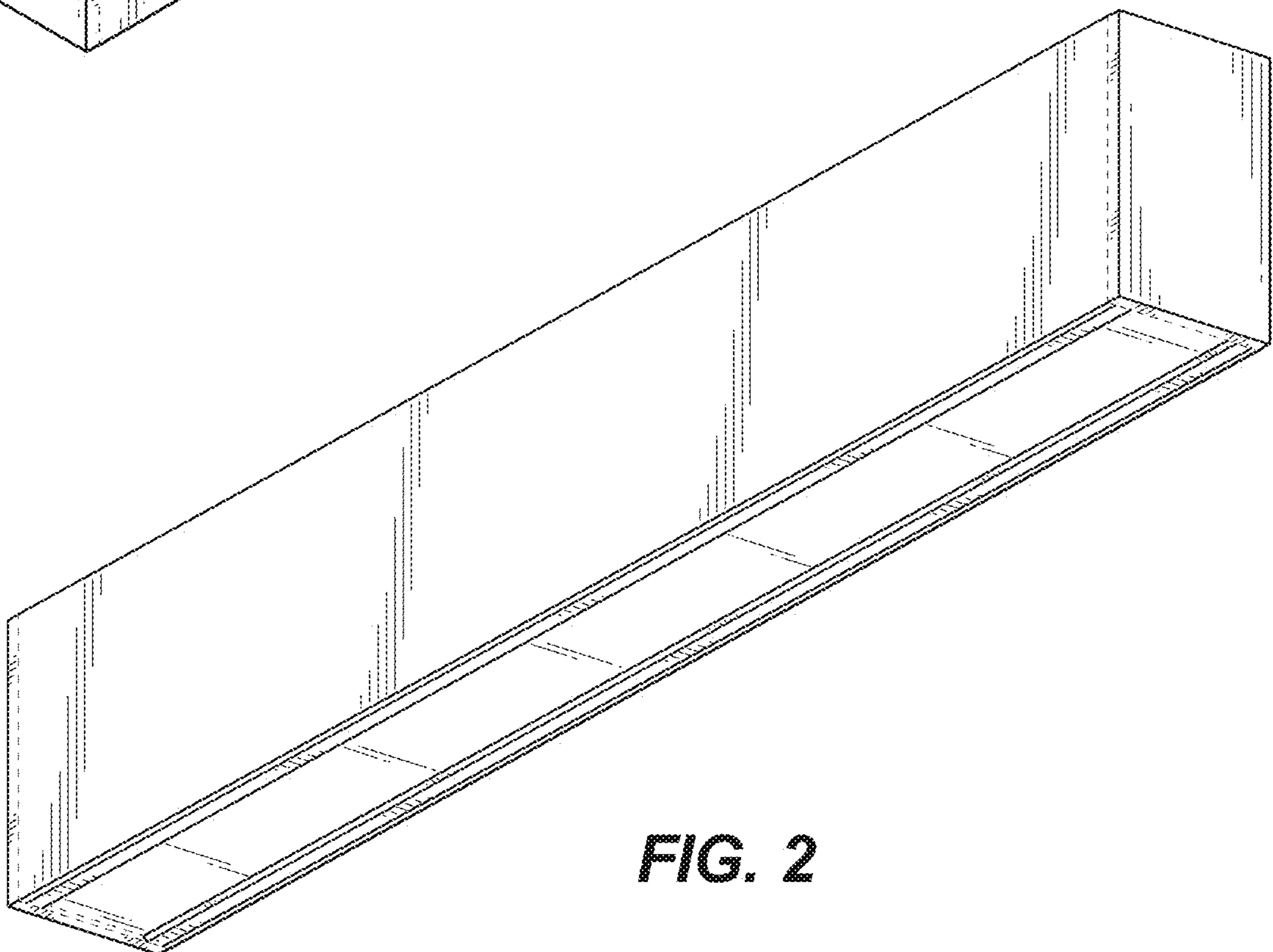

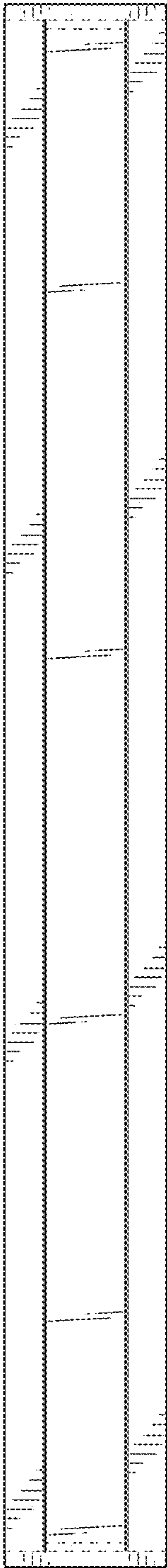

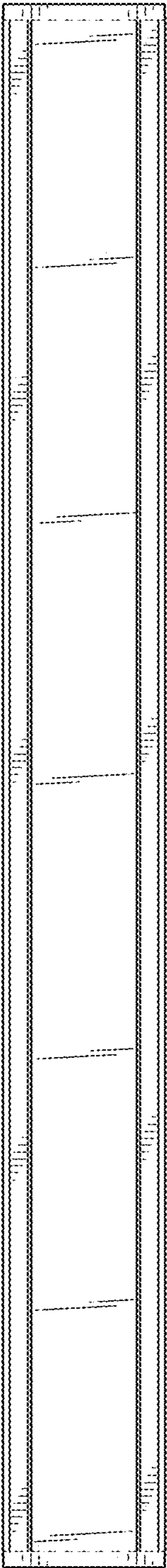

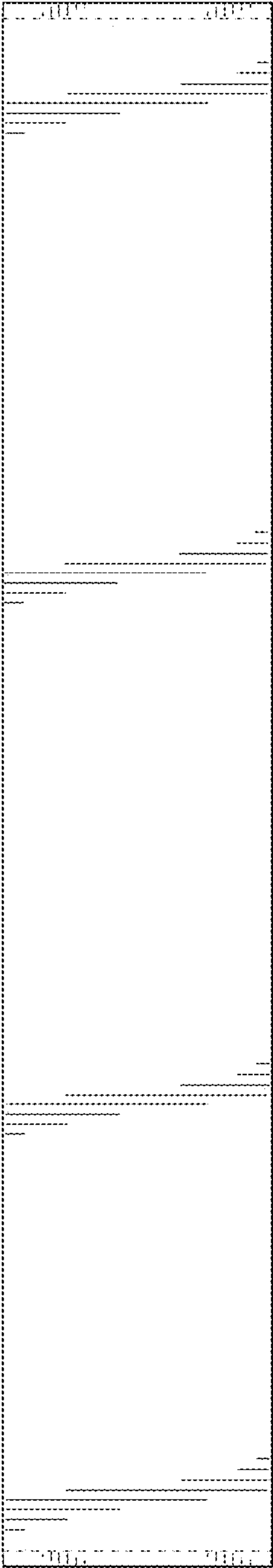

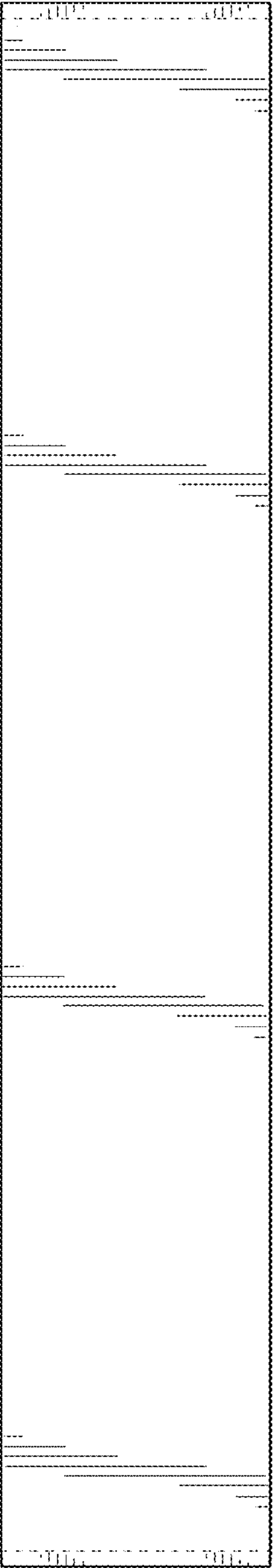
