(57) **CLAIM**

I claim the ornamental design for a hair clipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hair clipper showing my new design;

FIG. 2 is a front view of the hair clipper as shown in FIG. 1;

FIG. 3 is a back view of the hair clipper as shown in FIG. 1;

FIG. 4 is a left-side view of the hair clipper as shown in FIG. 1;

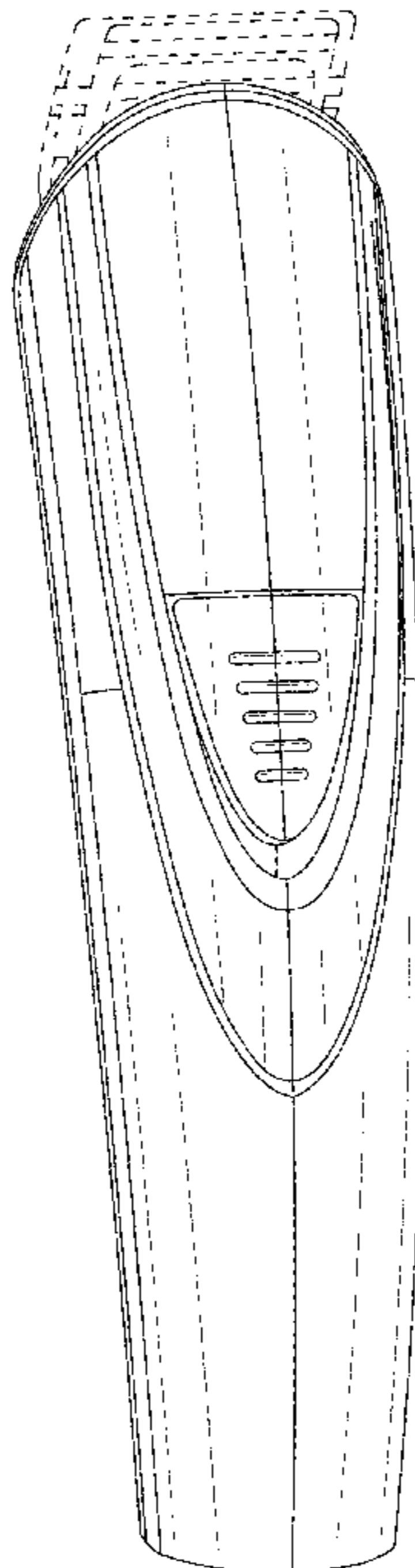
FIG. 5 is a right-side view of the hair clipper as shown in FIG. 1;

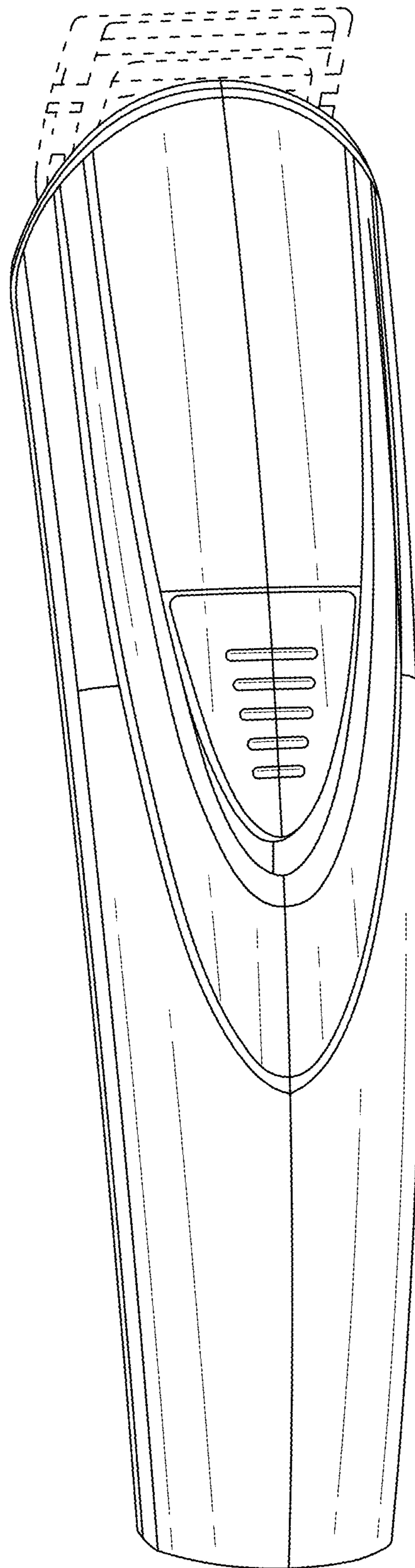

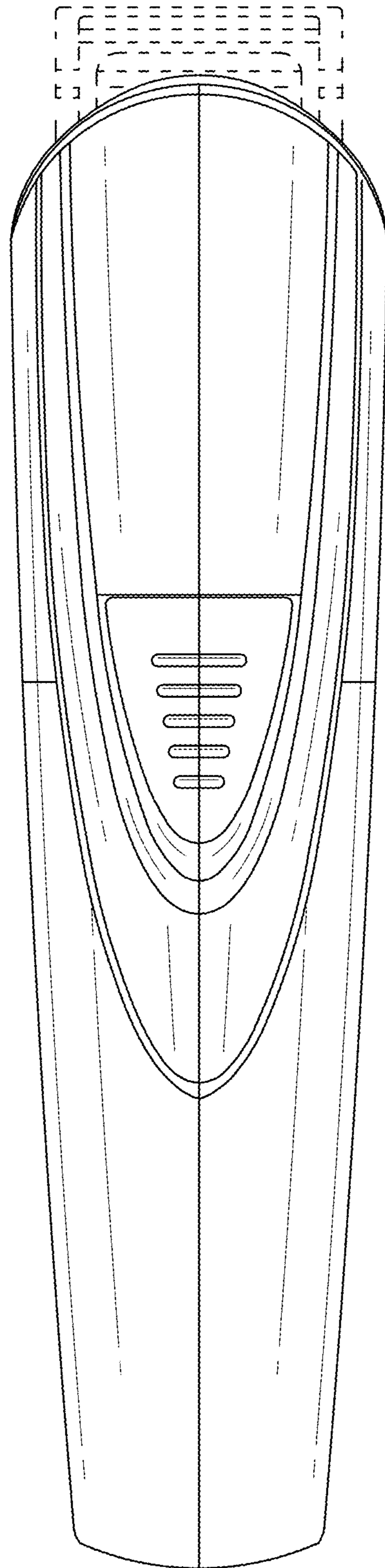

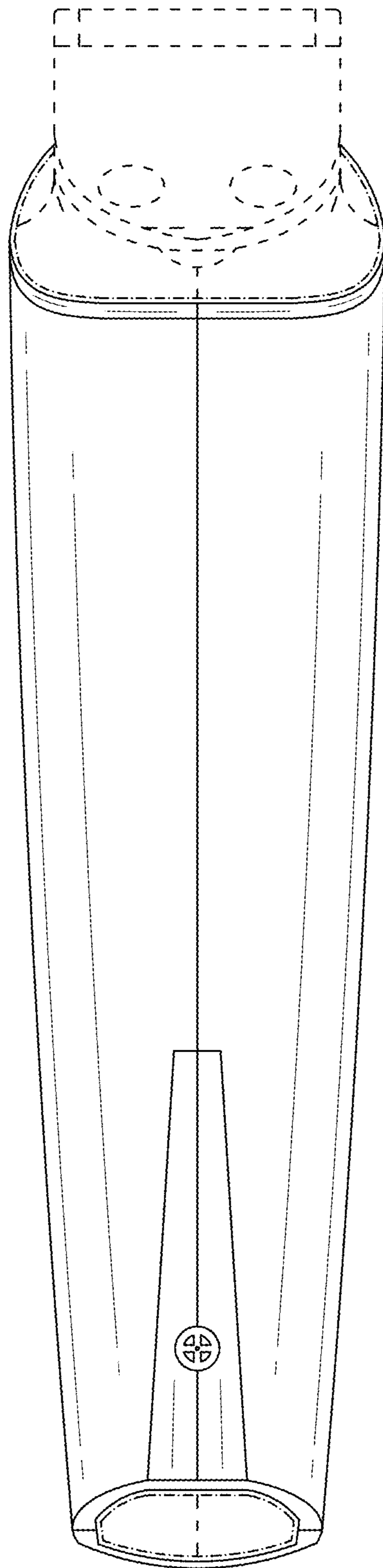

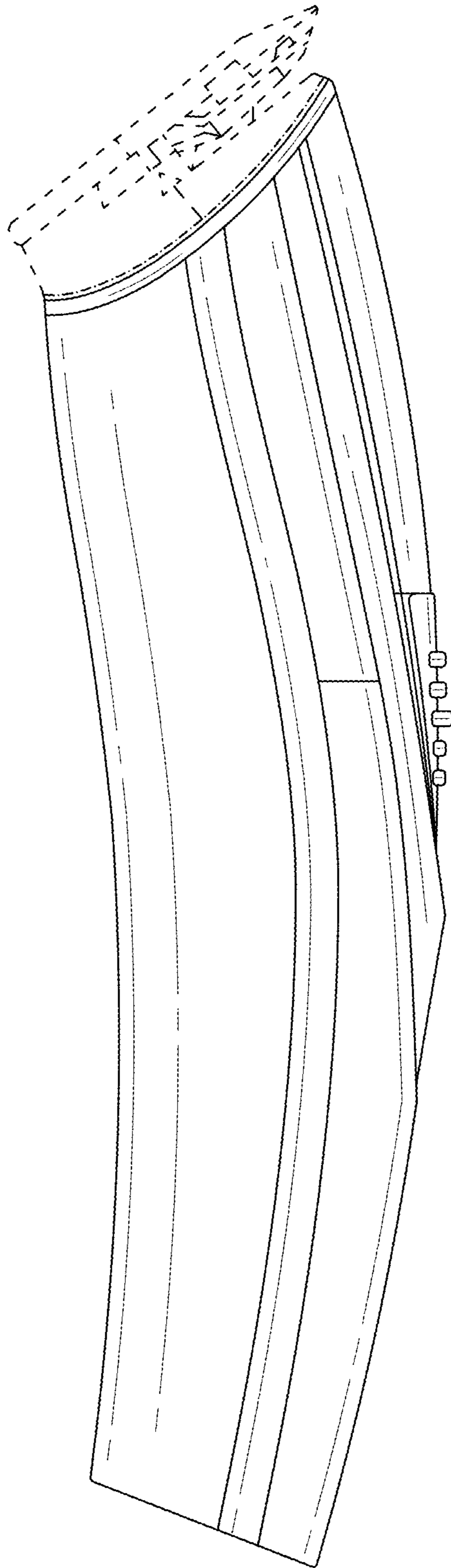

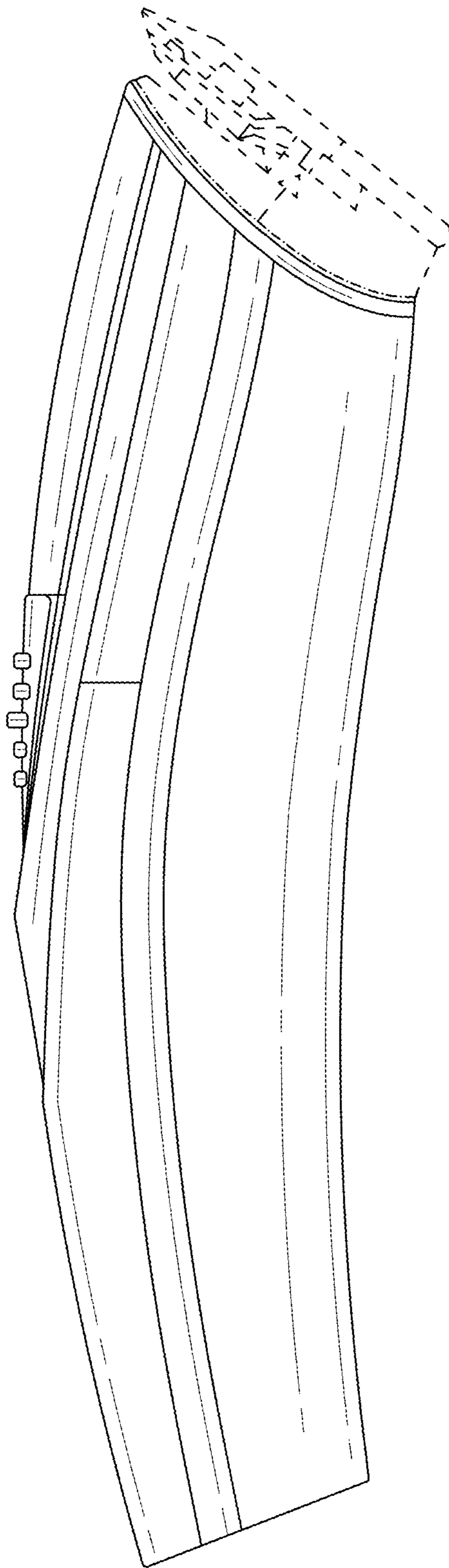

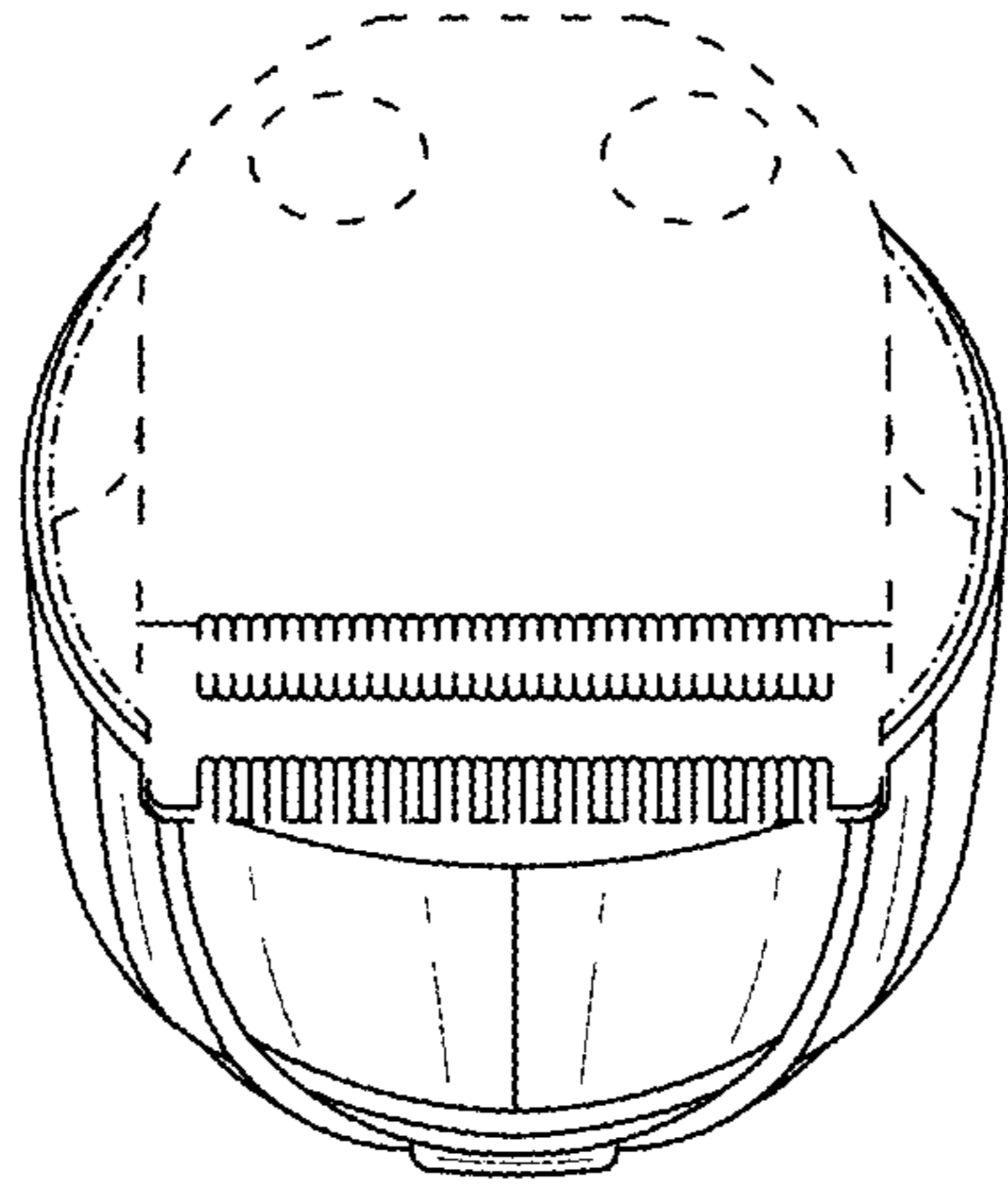

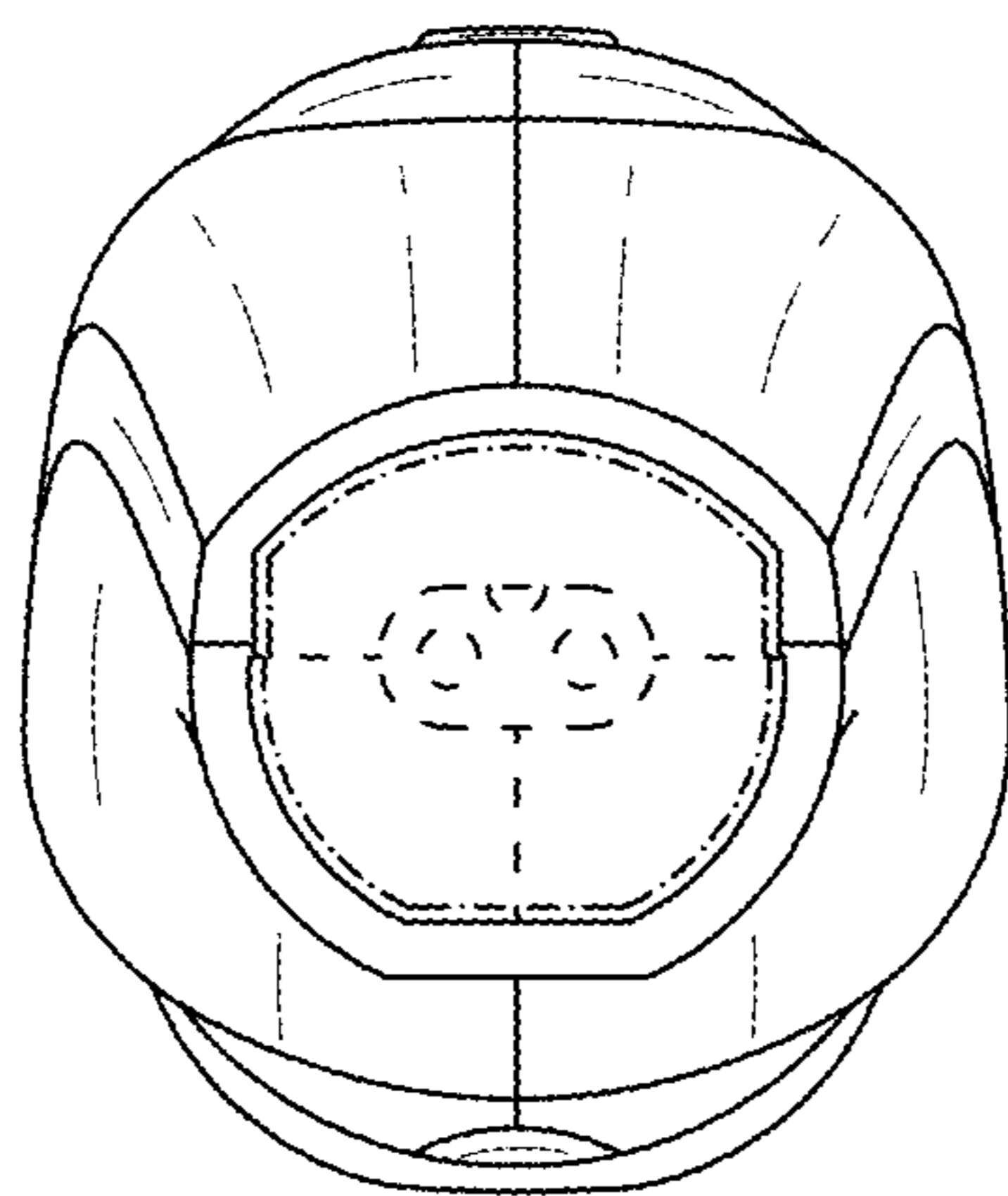
