The ornamental design for an oral care device, as shown and described.

DESCRIPTION

FIG. 1 is a rear, top perspective view of an oral care device showing my new design;

FIG. 5 is a bottom view thereof;

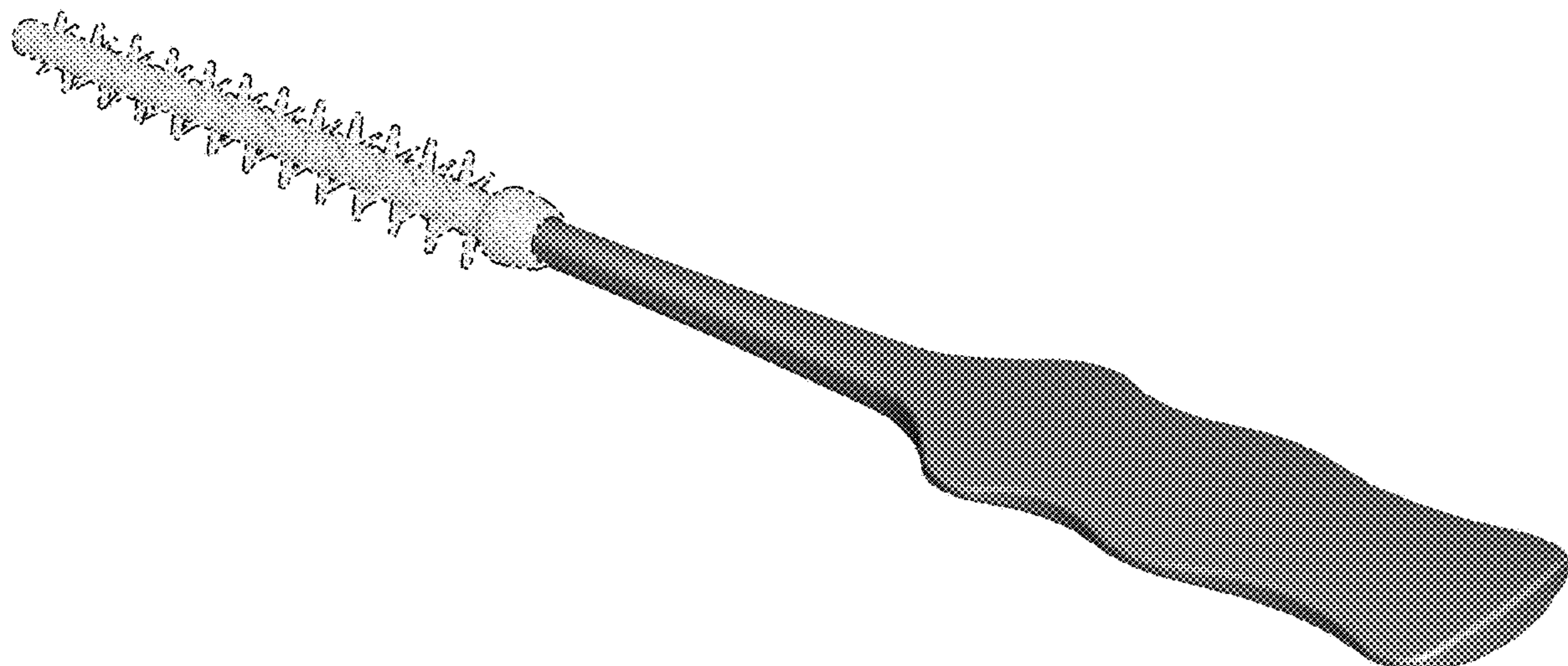
FIG. 6 is a rear view thereof; and,

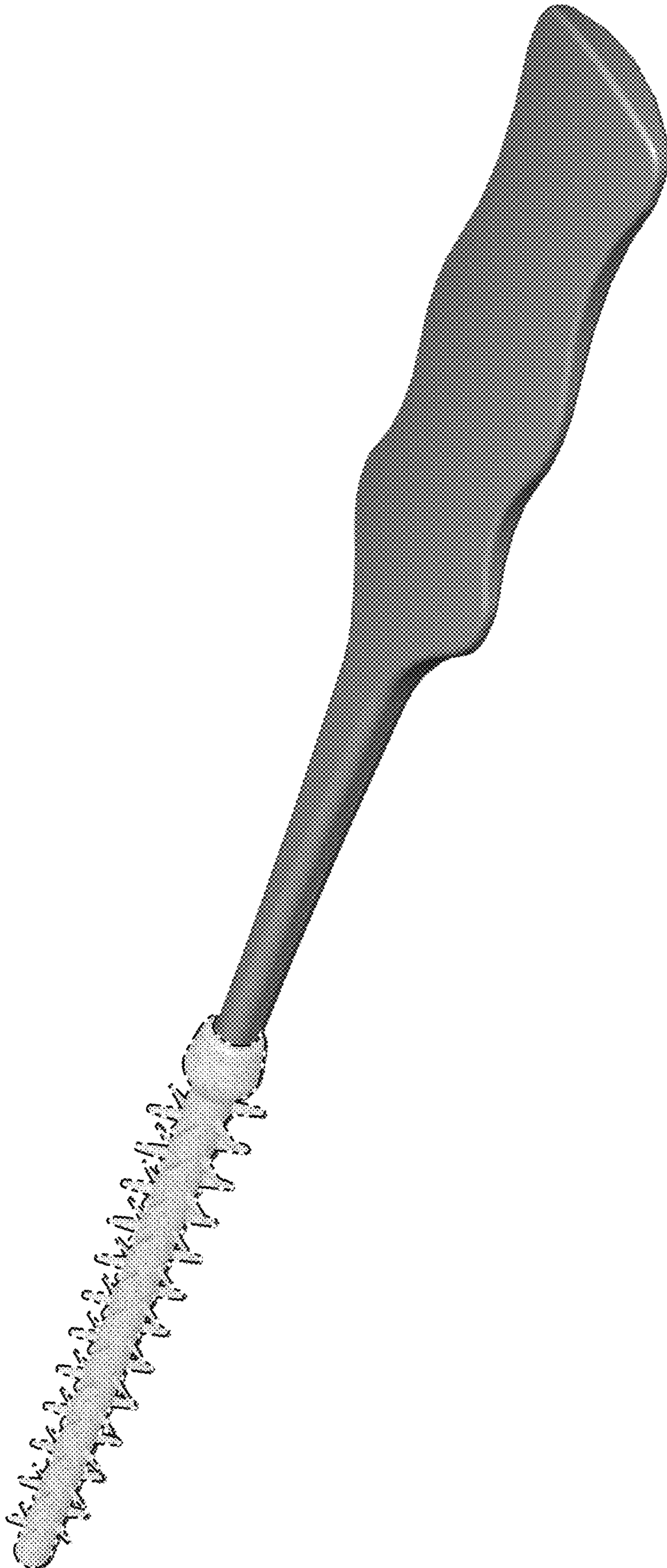

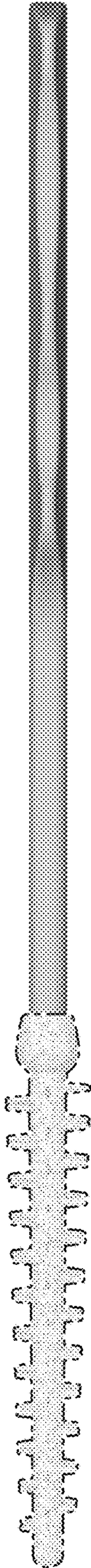

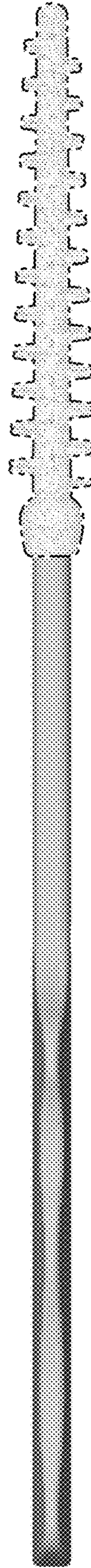

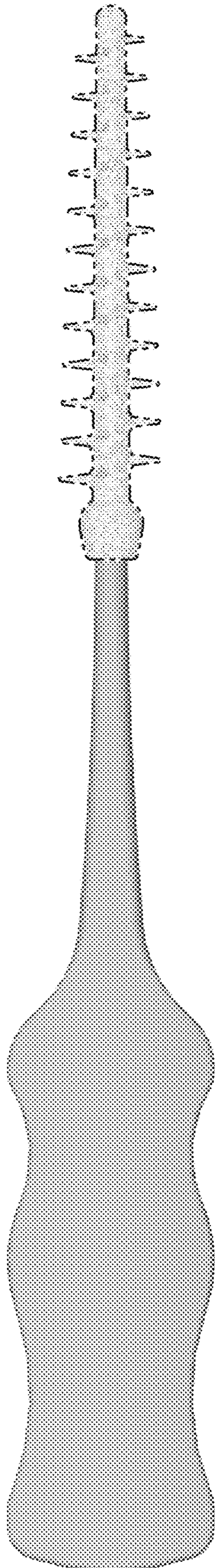

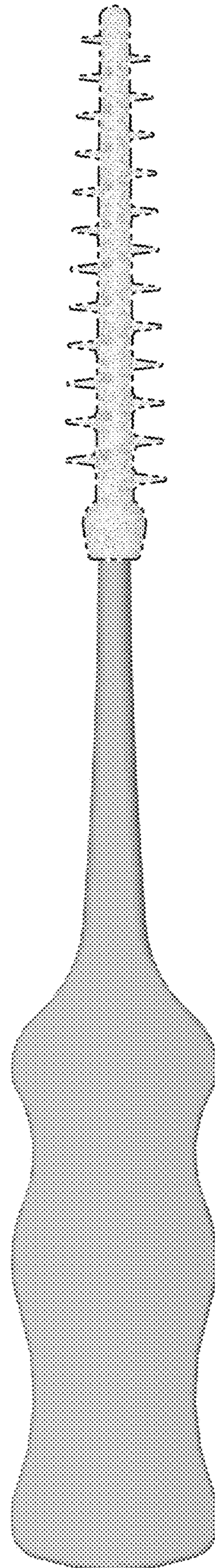

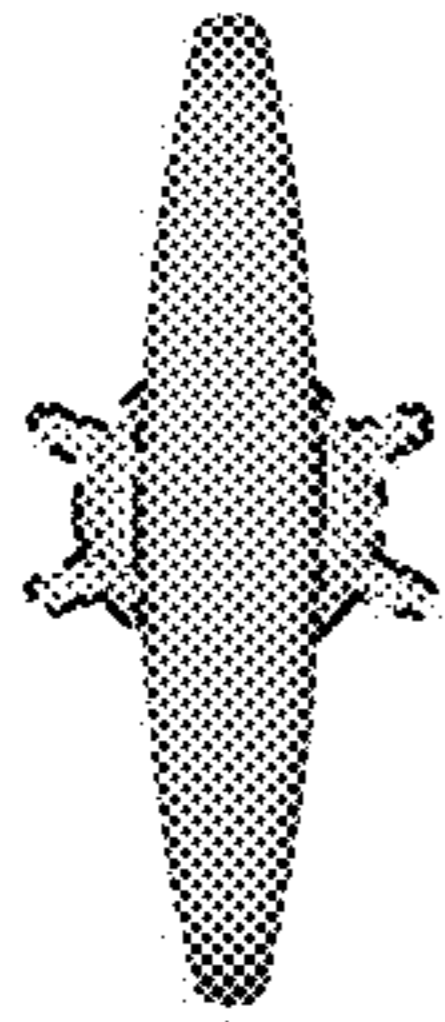

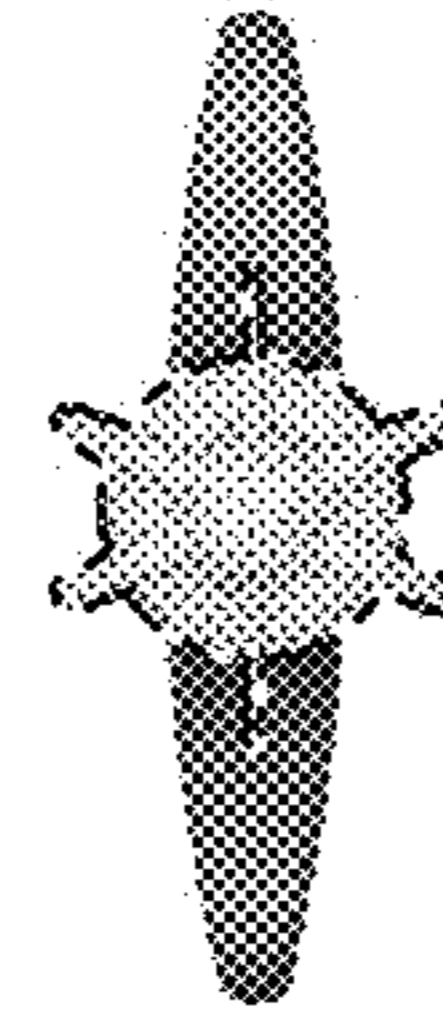
