The ornamental design for a pair of gloves, as shown and described.

DESCRIPTION

FIG. 1.4 is a dorsal perspective view of a left-hand glove thereof.

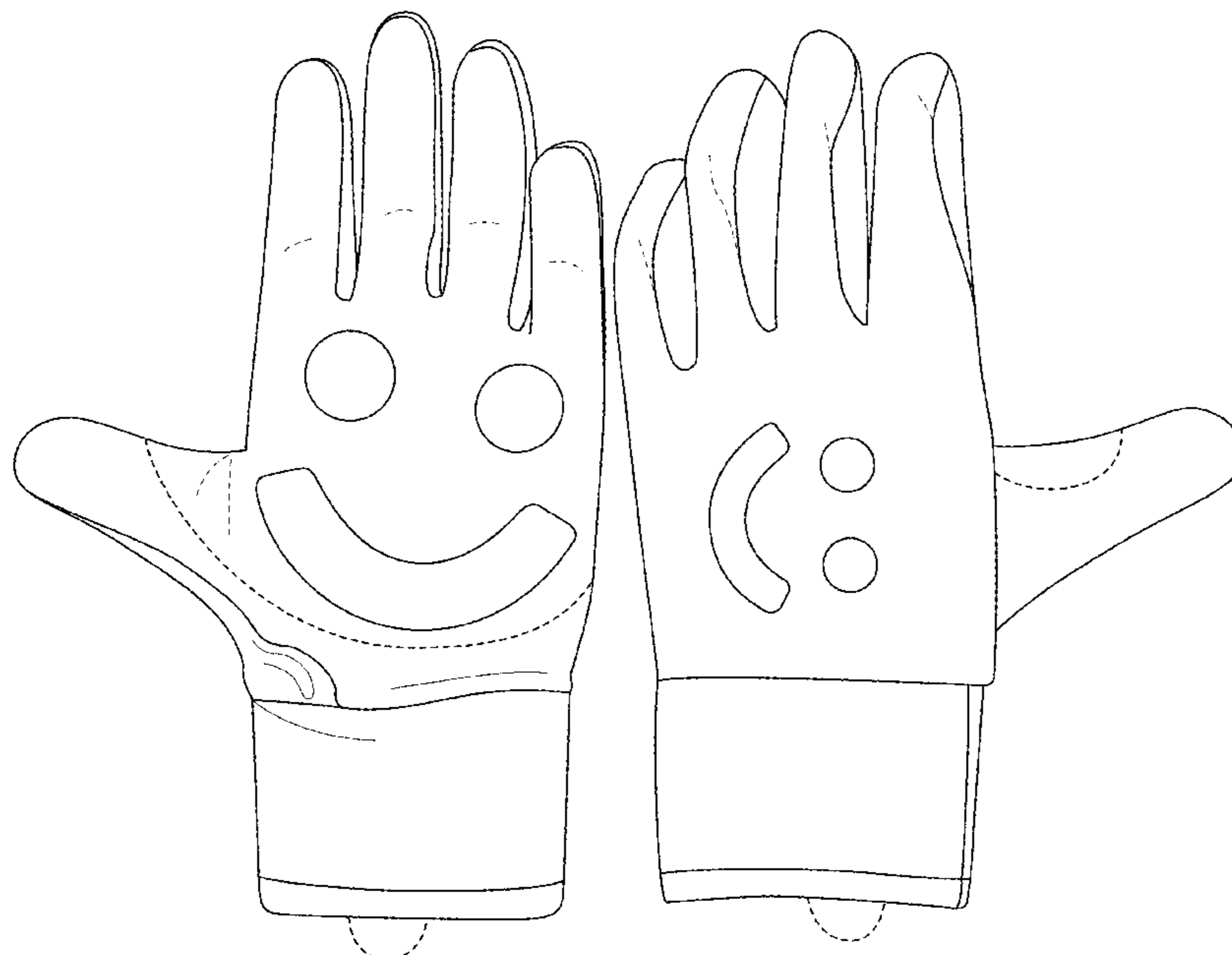
FIG. 1.5 is a palmar perspective view of a left-hand glove thereof.

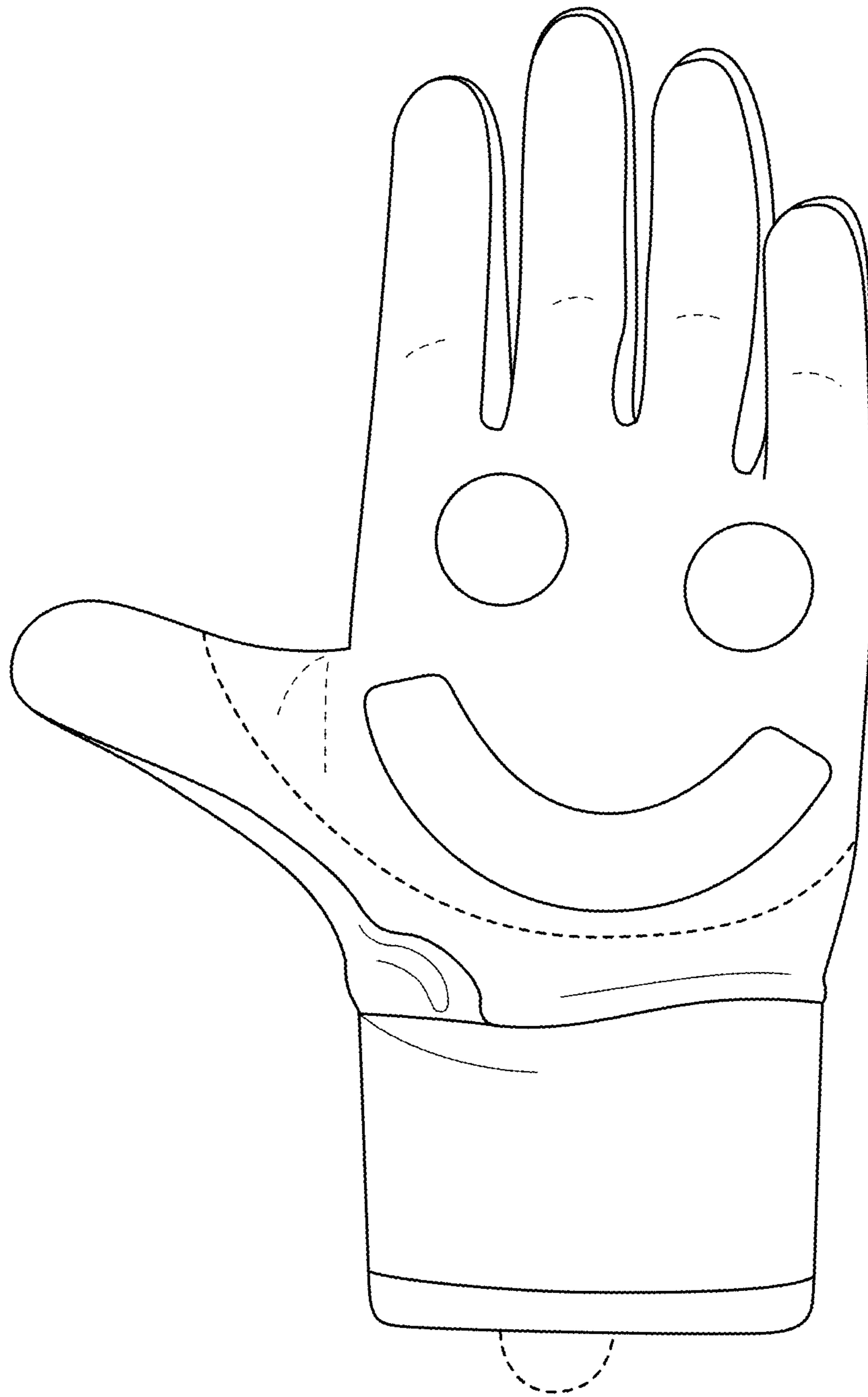
FIG. 1.6 is a palmar perspective view of a right-hand glove thereof.

FIG. 1.7 is a dorsal perspective view of a right-hand glove thereof.

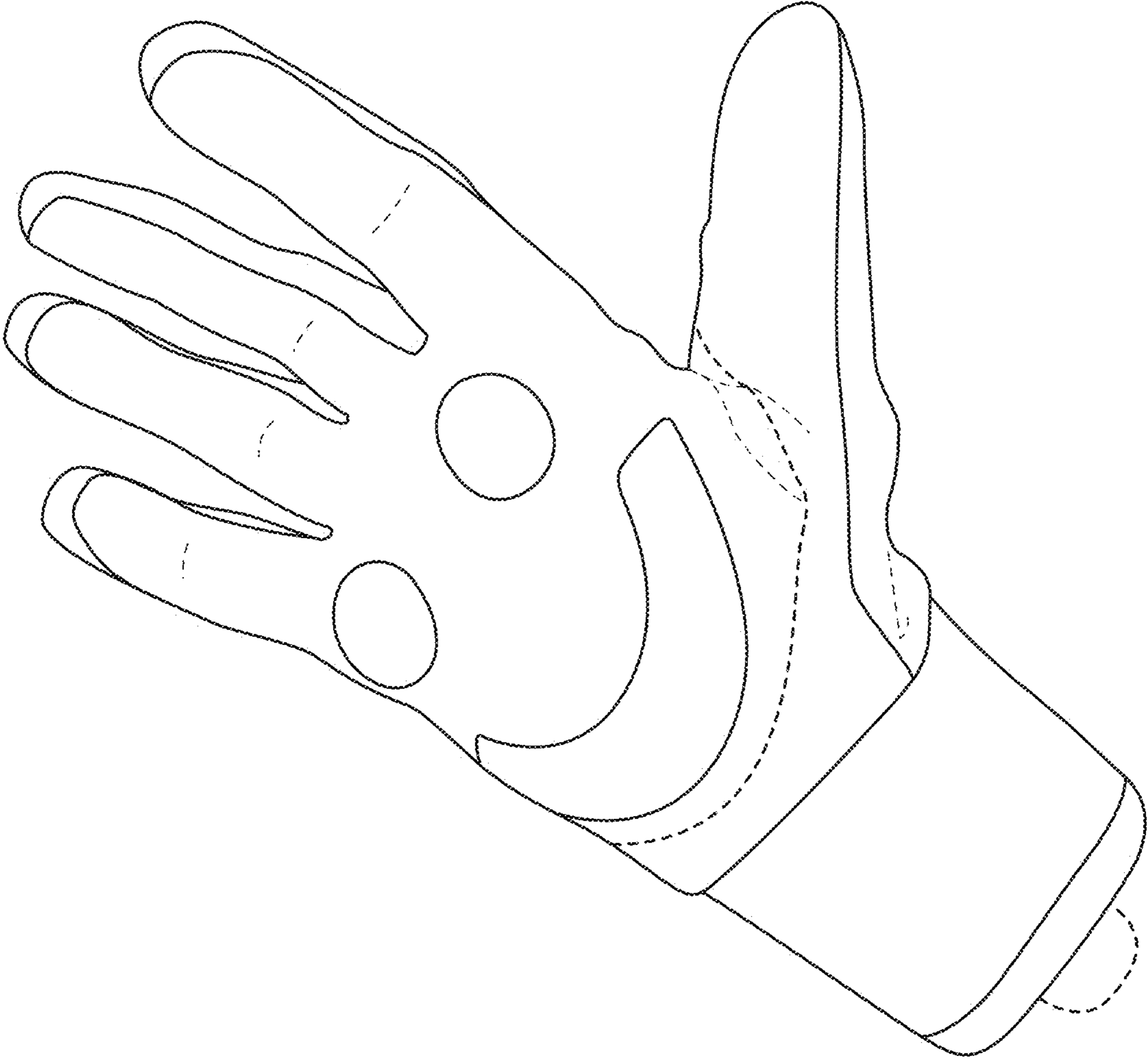
The broken lines show portions of the article that form no part of the claimed design.

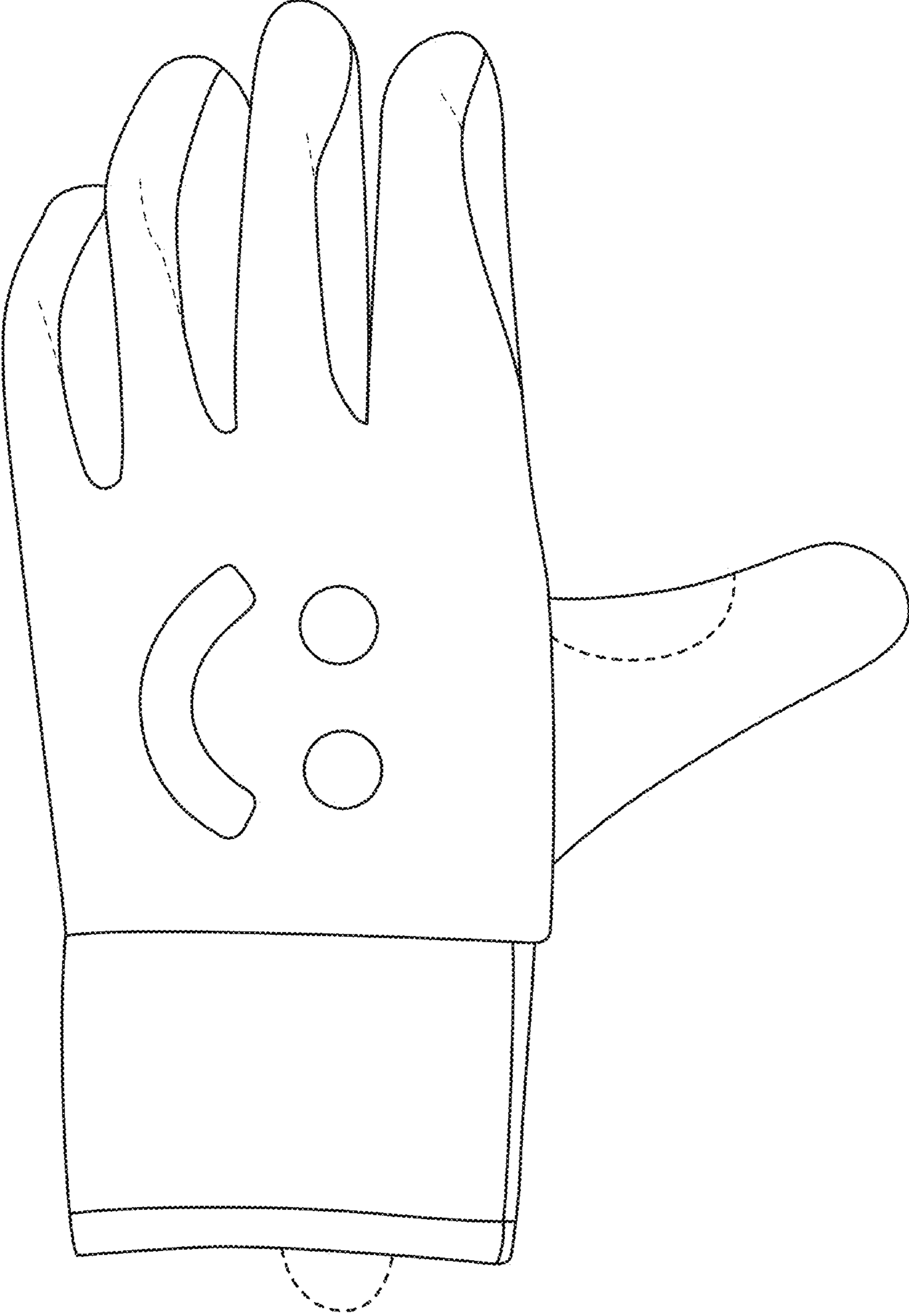




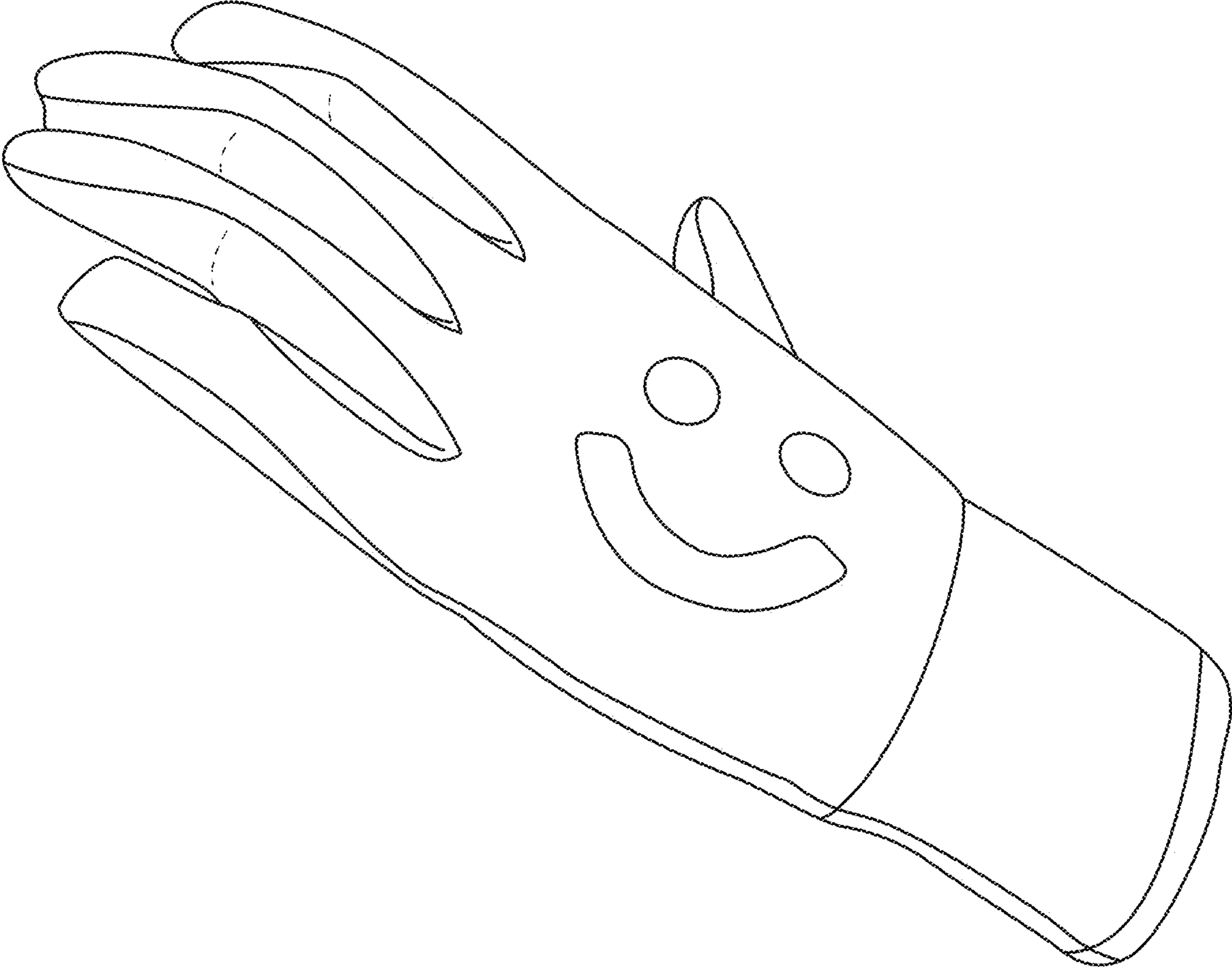

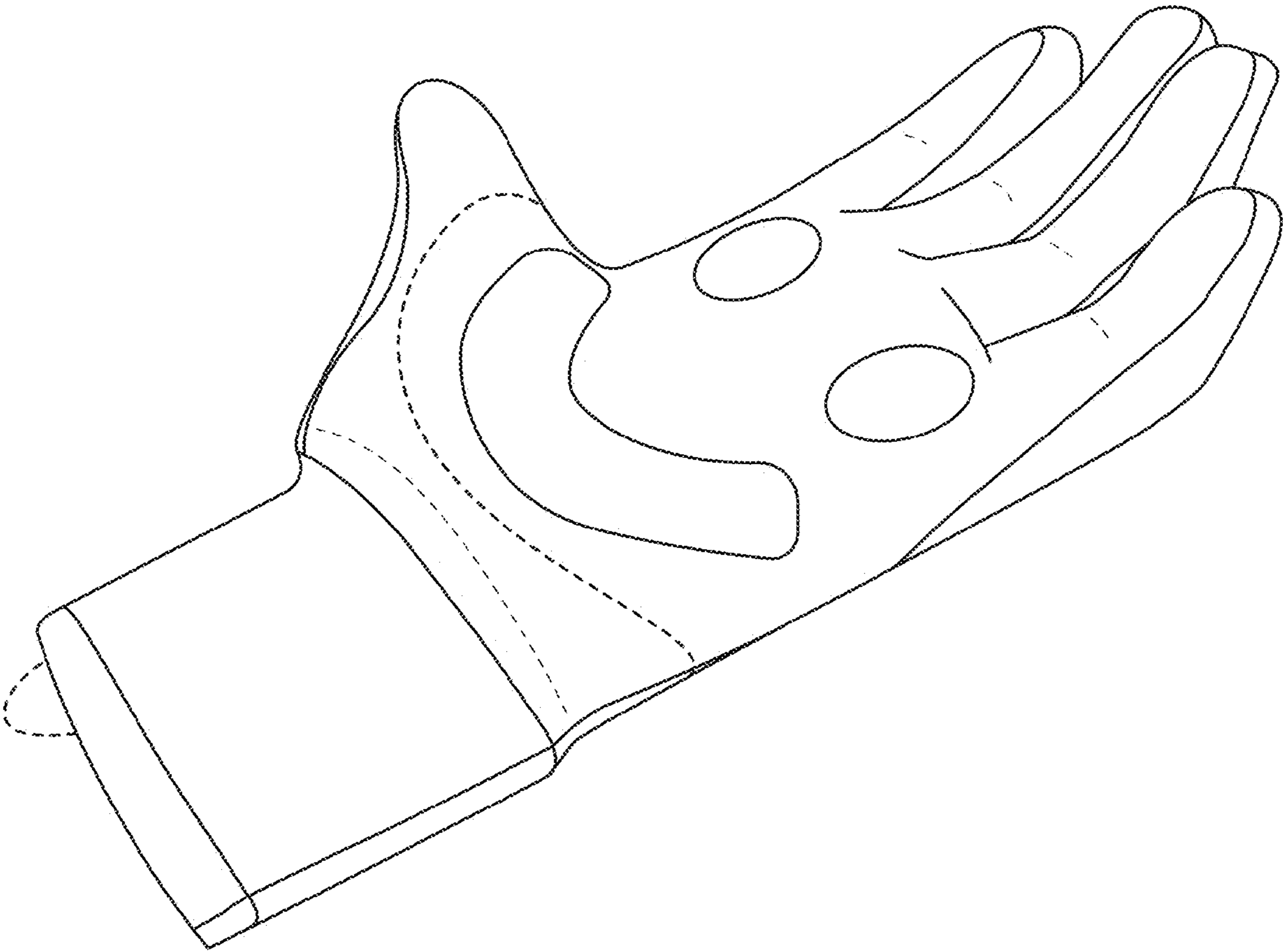

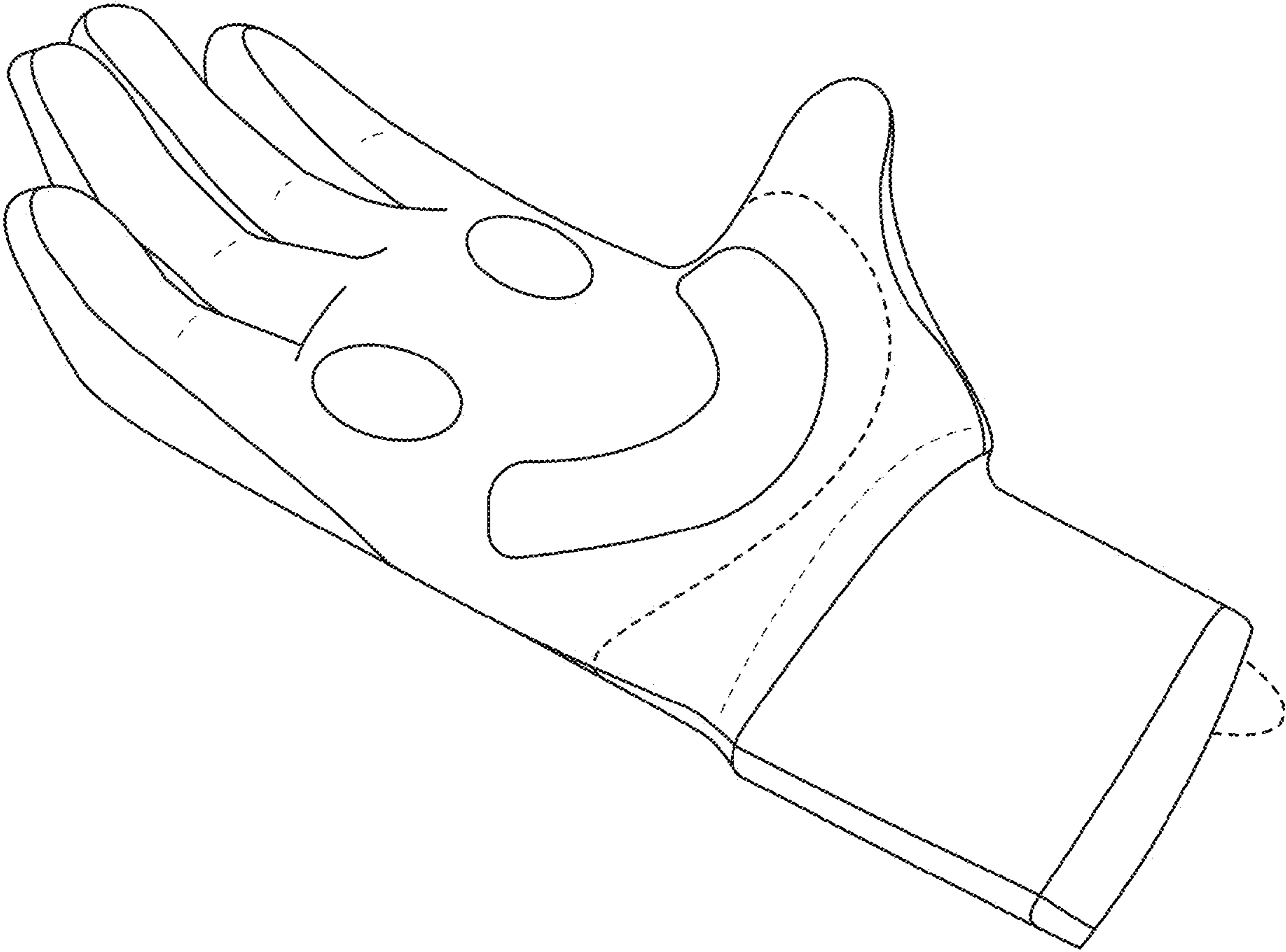

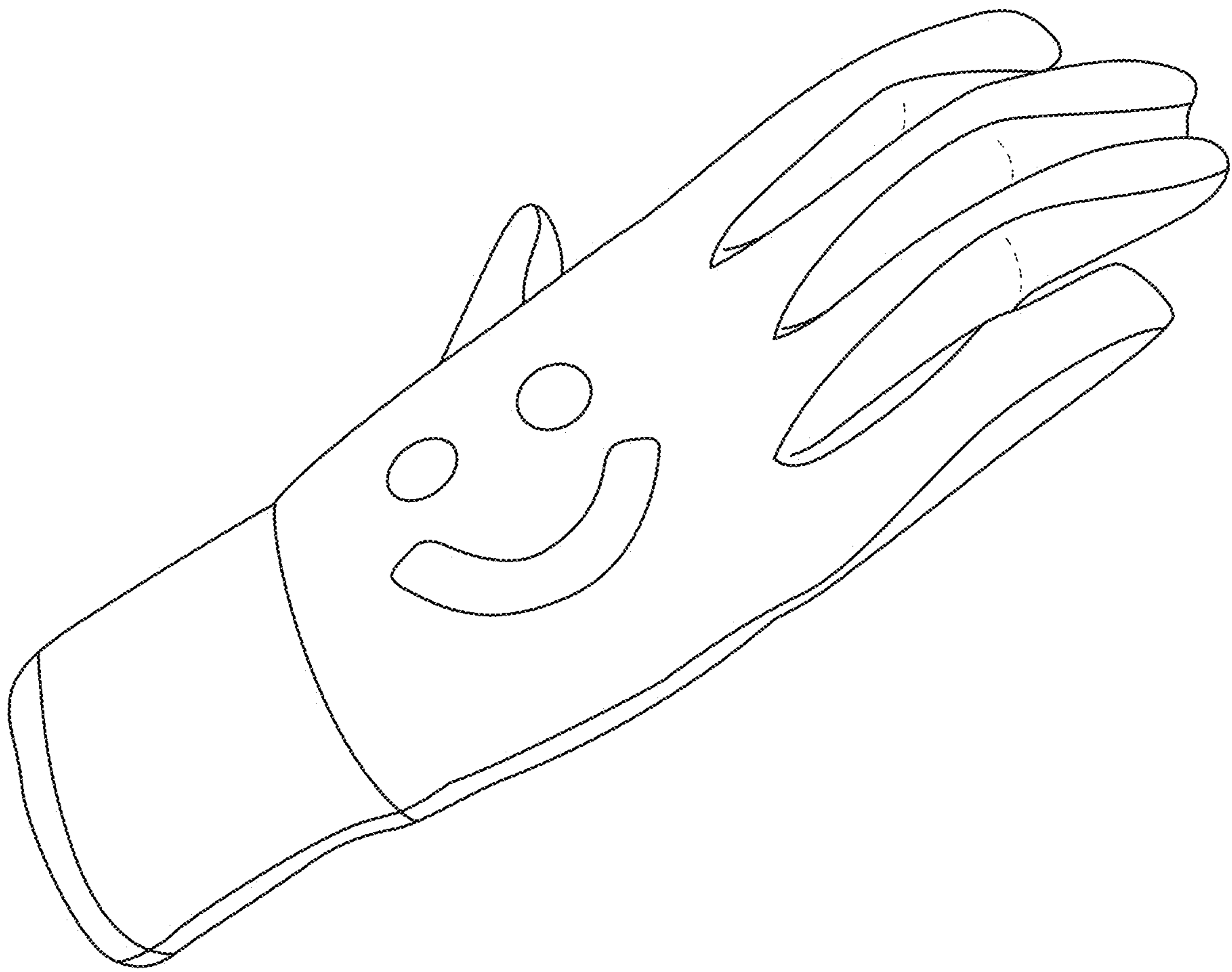
