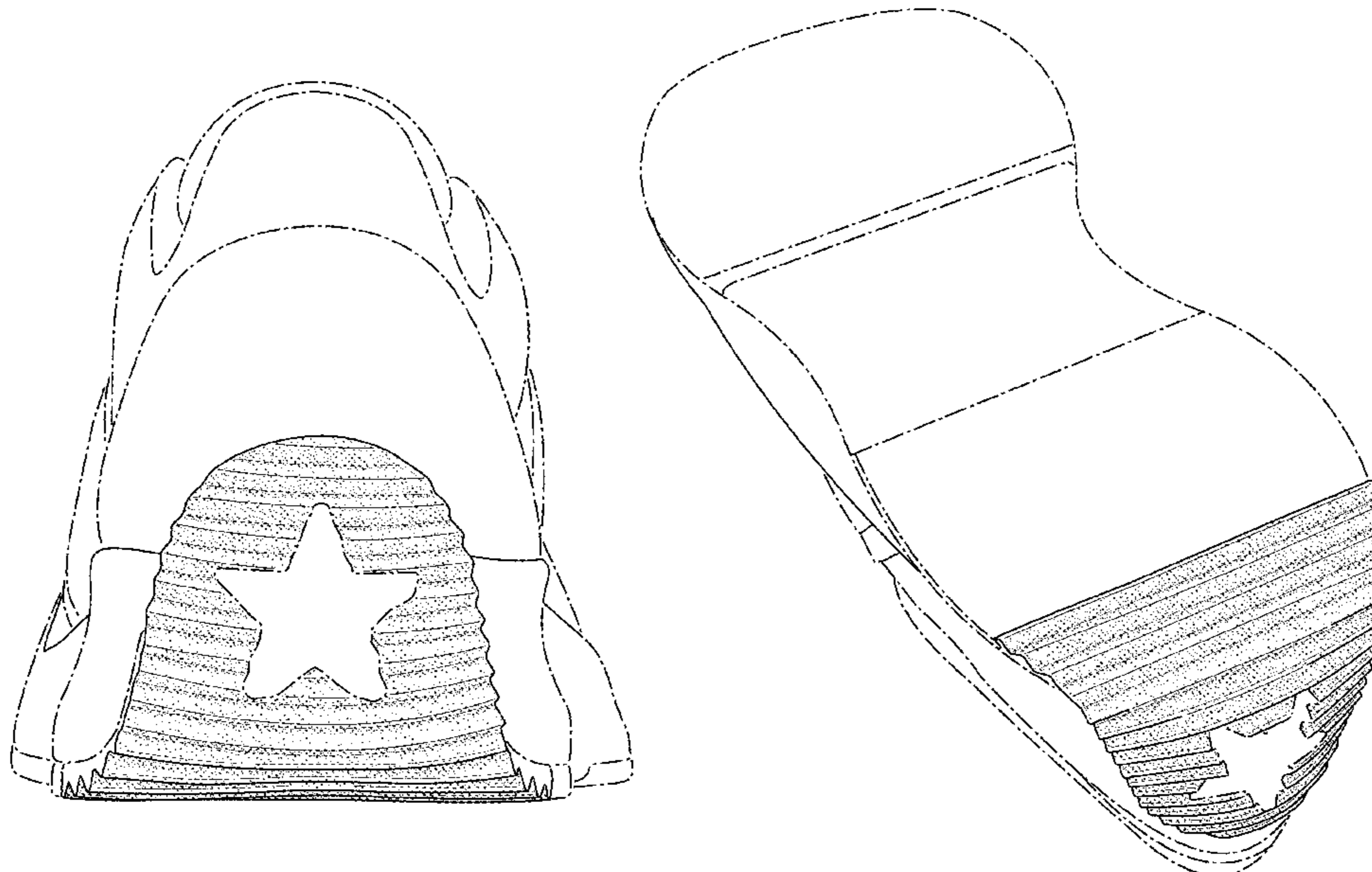
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a second rear perspective view thereof;
FIG. 4 is a side view thereof; and,
FIG. 5 is a bottom perspective view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The unshaded region within the shaded area that is demarcated by a broken line forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

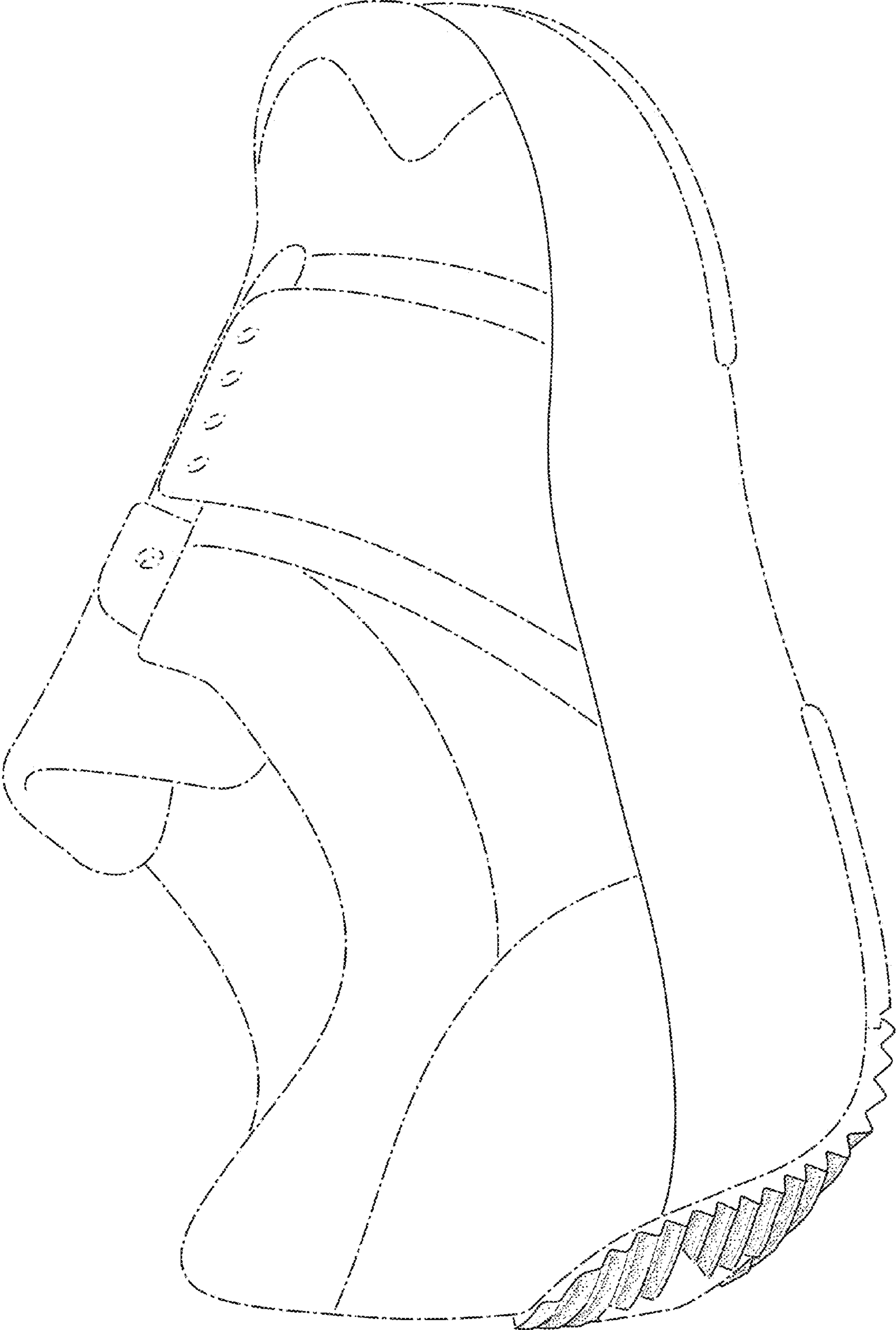

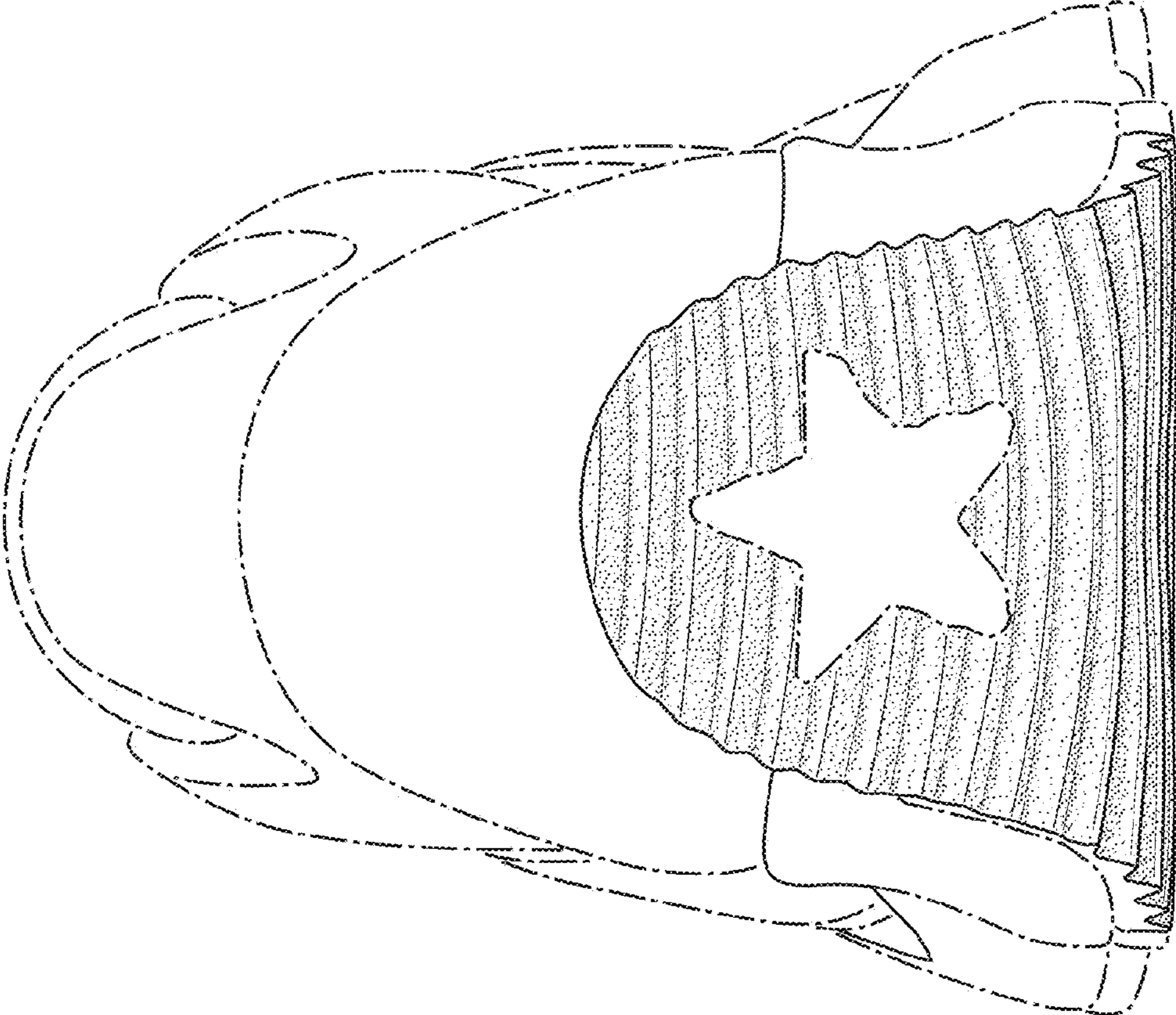

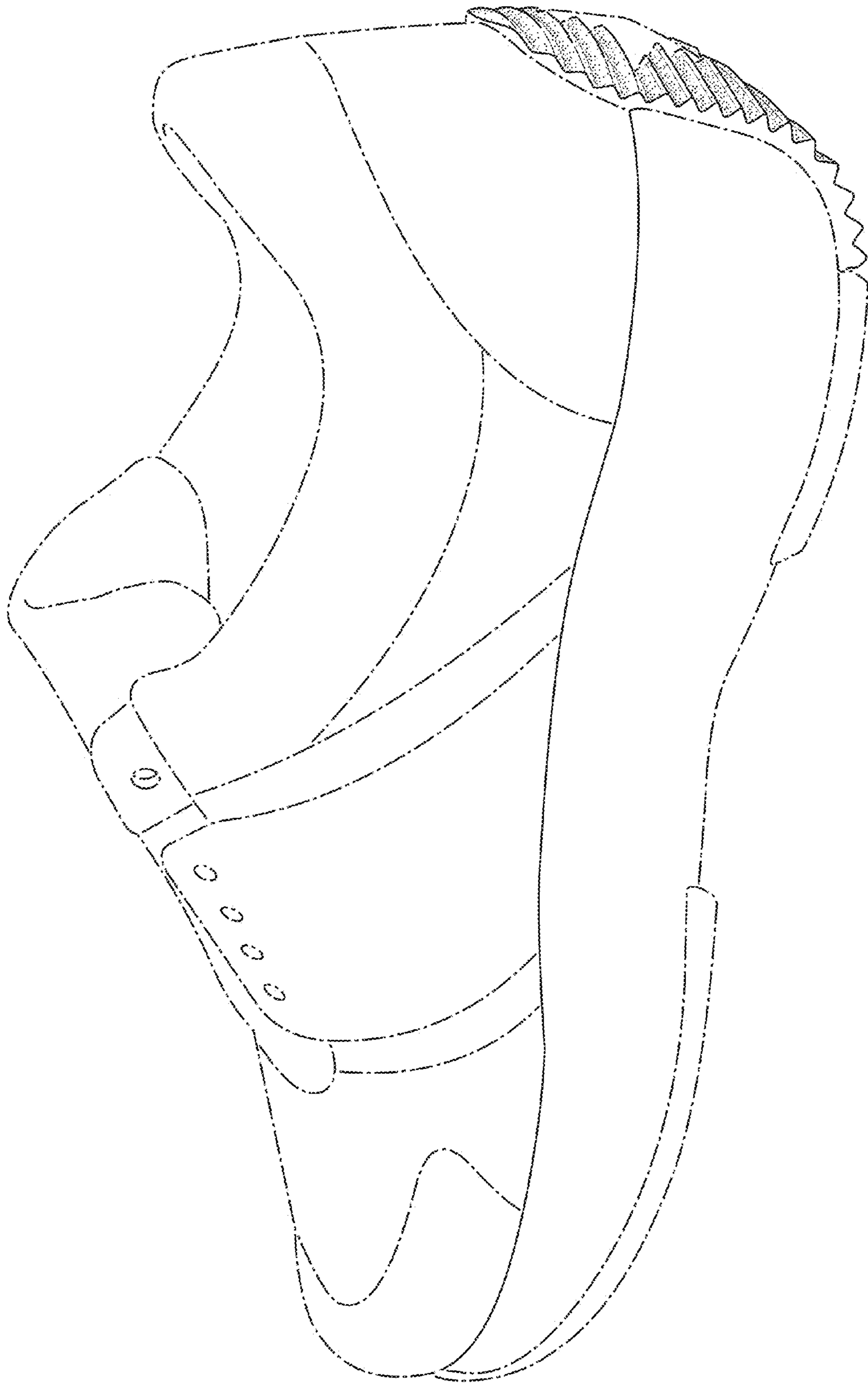

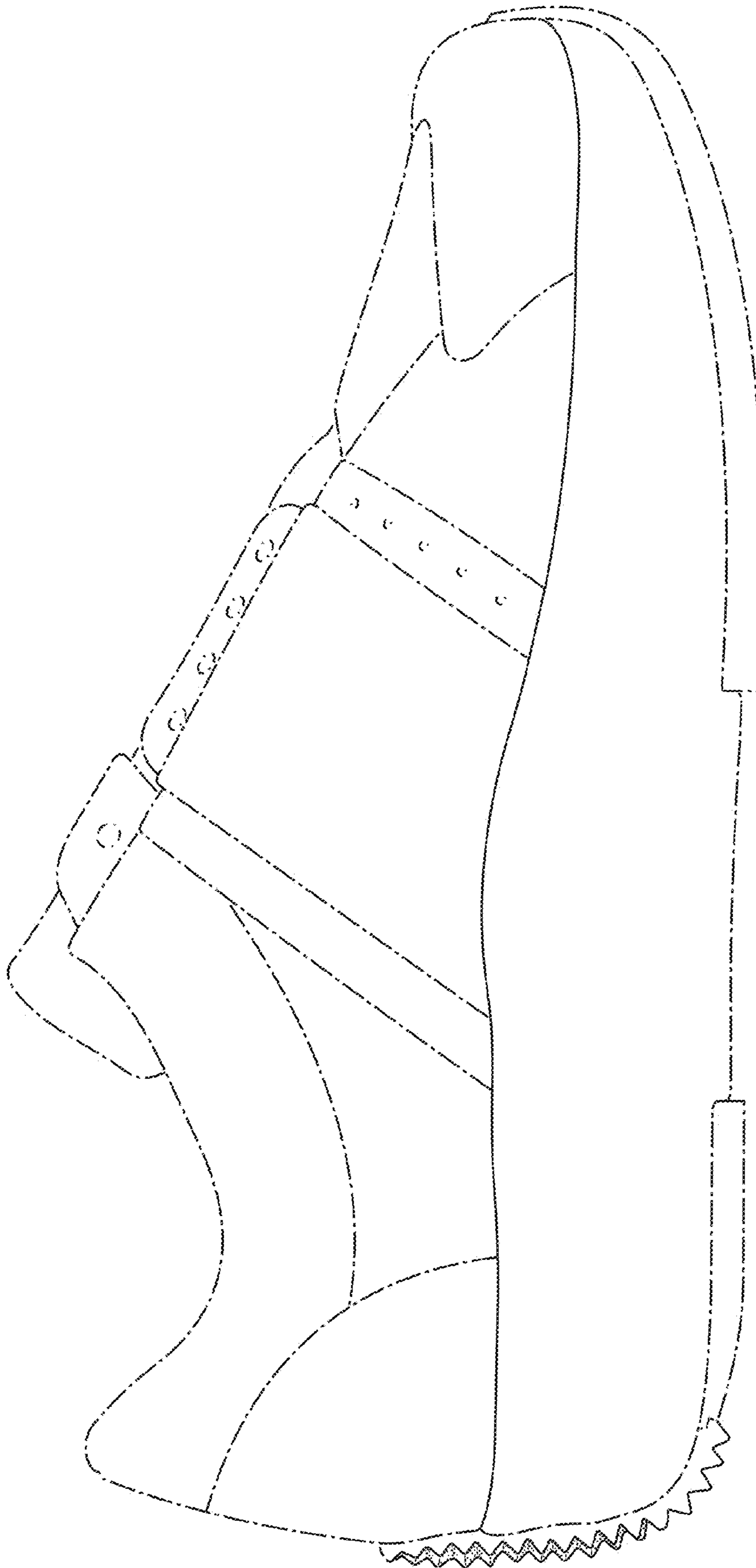

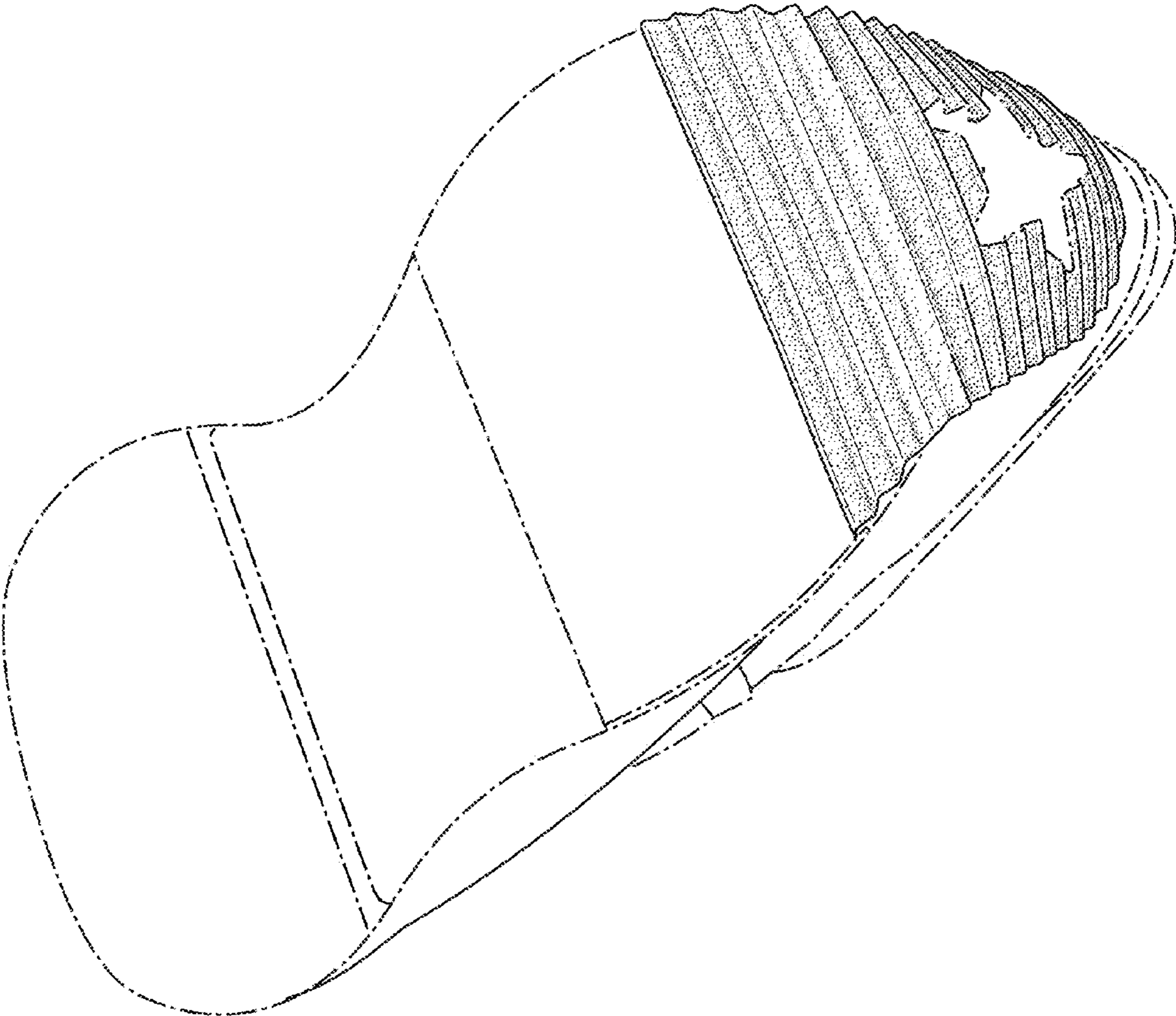
