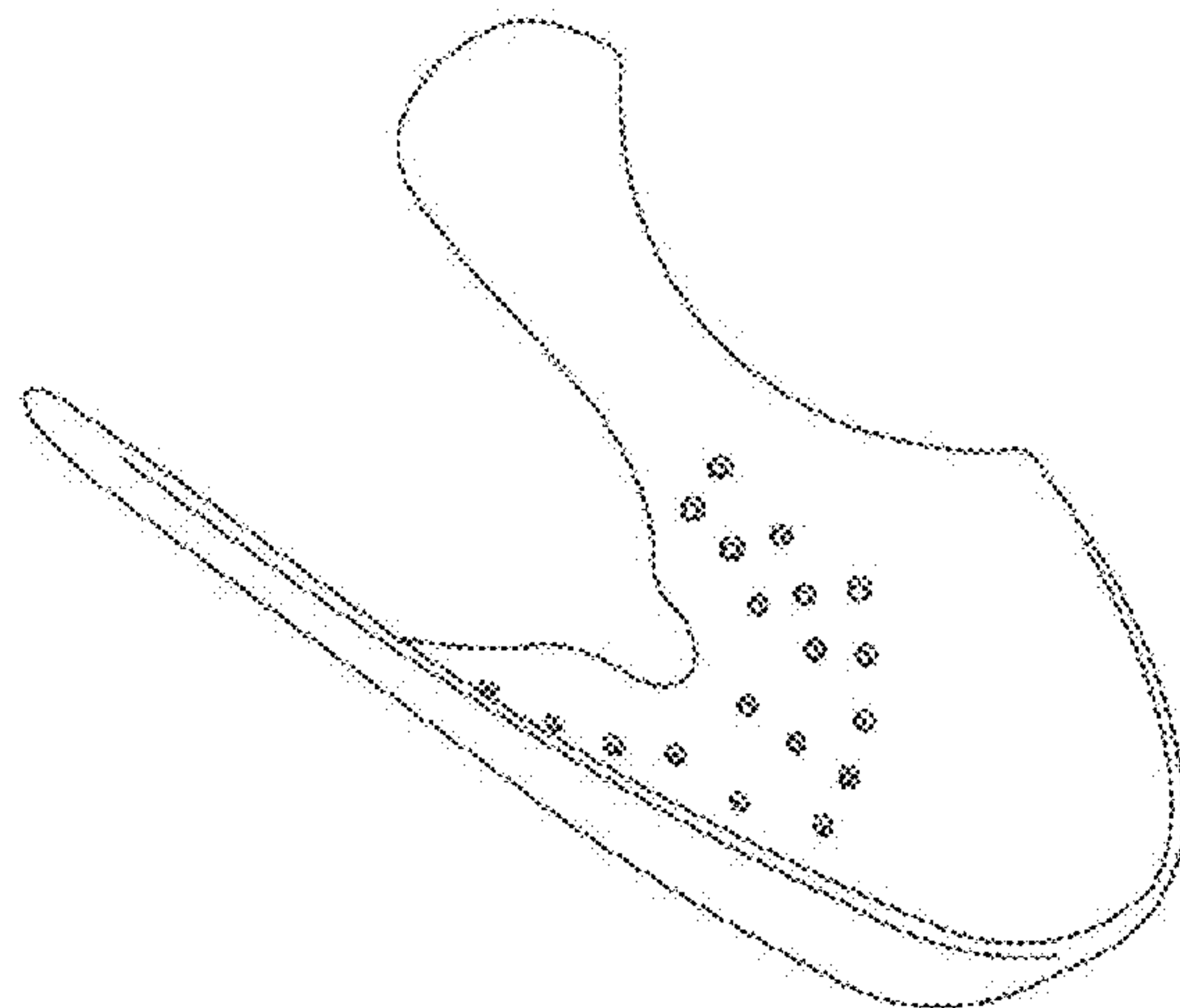
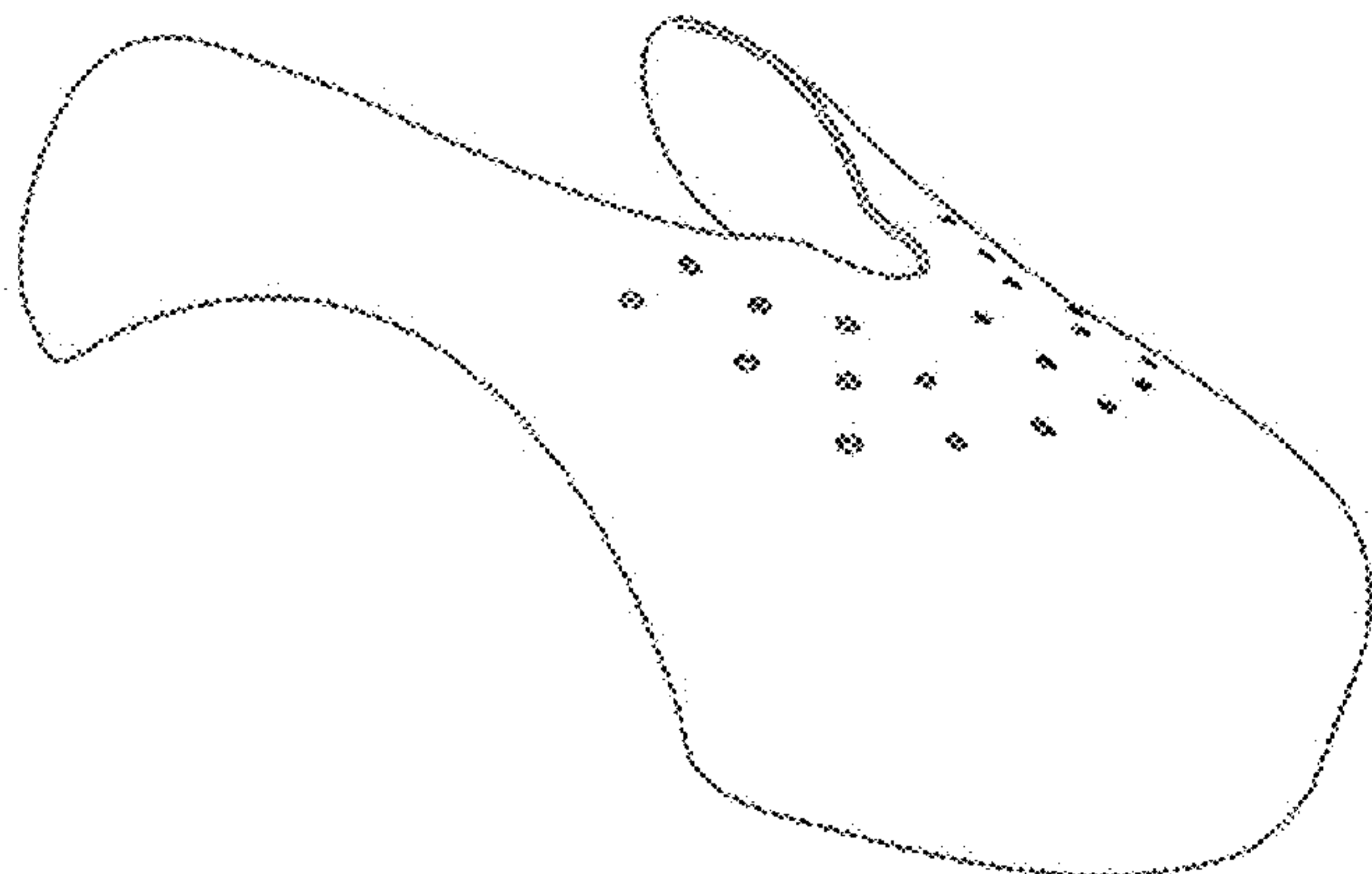
(57) **CLAIM**

We claim the ornamental design for a right shoe shaper, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper right perspective view of a right shoe shaper, showing our new design;  
FIG. 2 is an lower left perspective view thereof;  
FIG. 3 is an upper left perspective view thereof; and  
FIG. 4 is a lower right perspective view thereof.  
FIG. 5 is a front view of the right shoe shaper of FIG. 1;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a top view thereof;  
FIG. 8 is a right side view thereof; and  
FIG. 9 is a back view thereof; and,  
FIG. 10 is a bottom view of the right shoe shaper of FIG. 1.

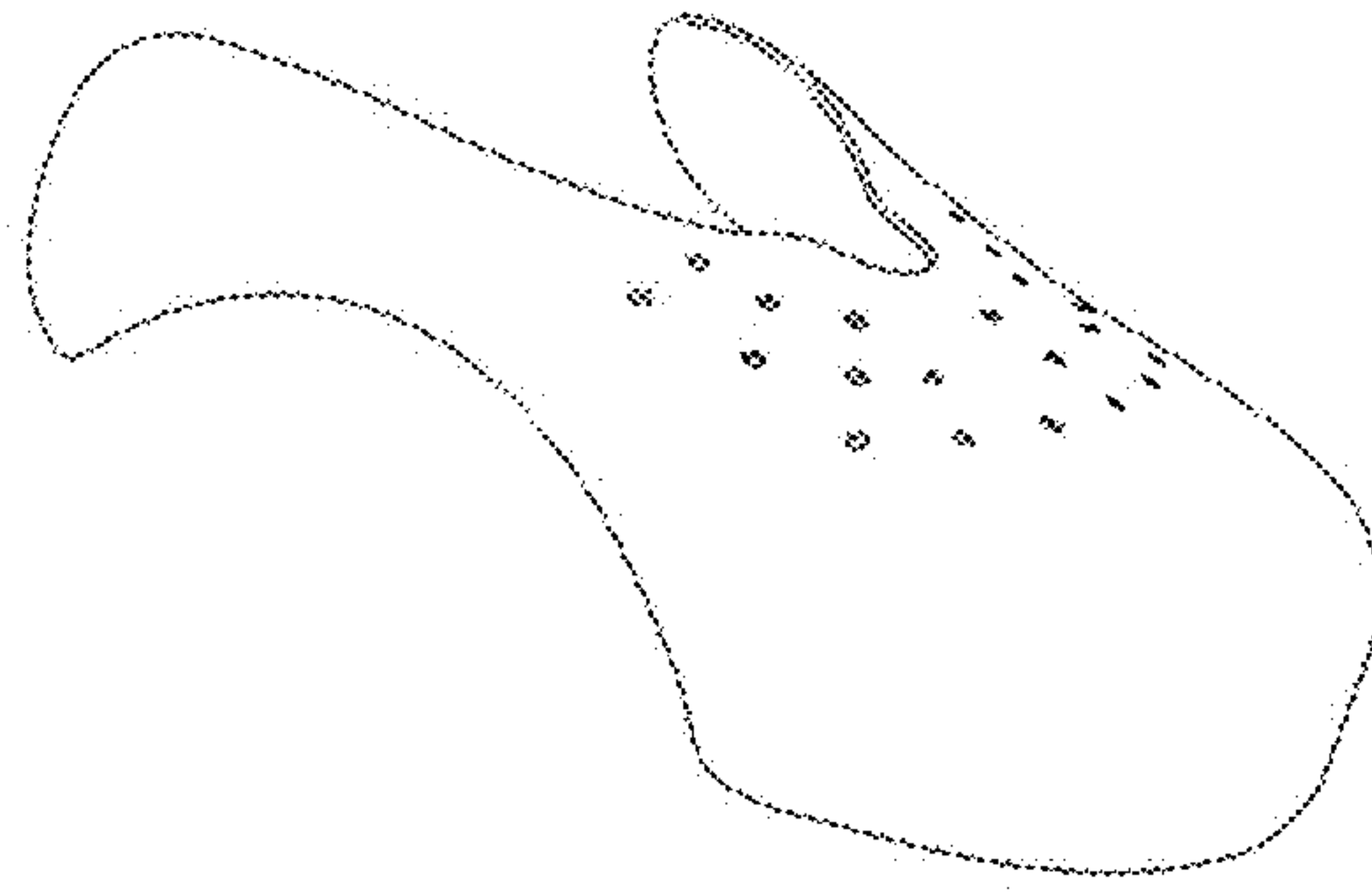

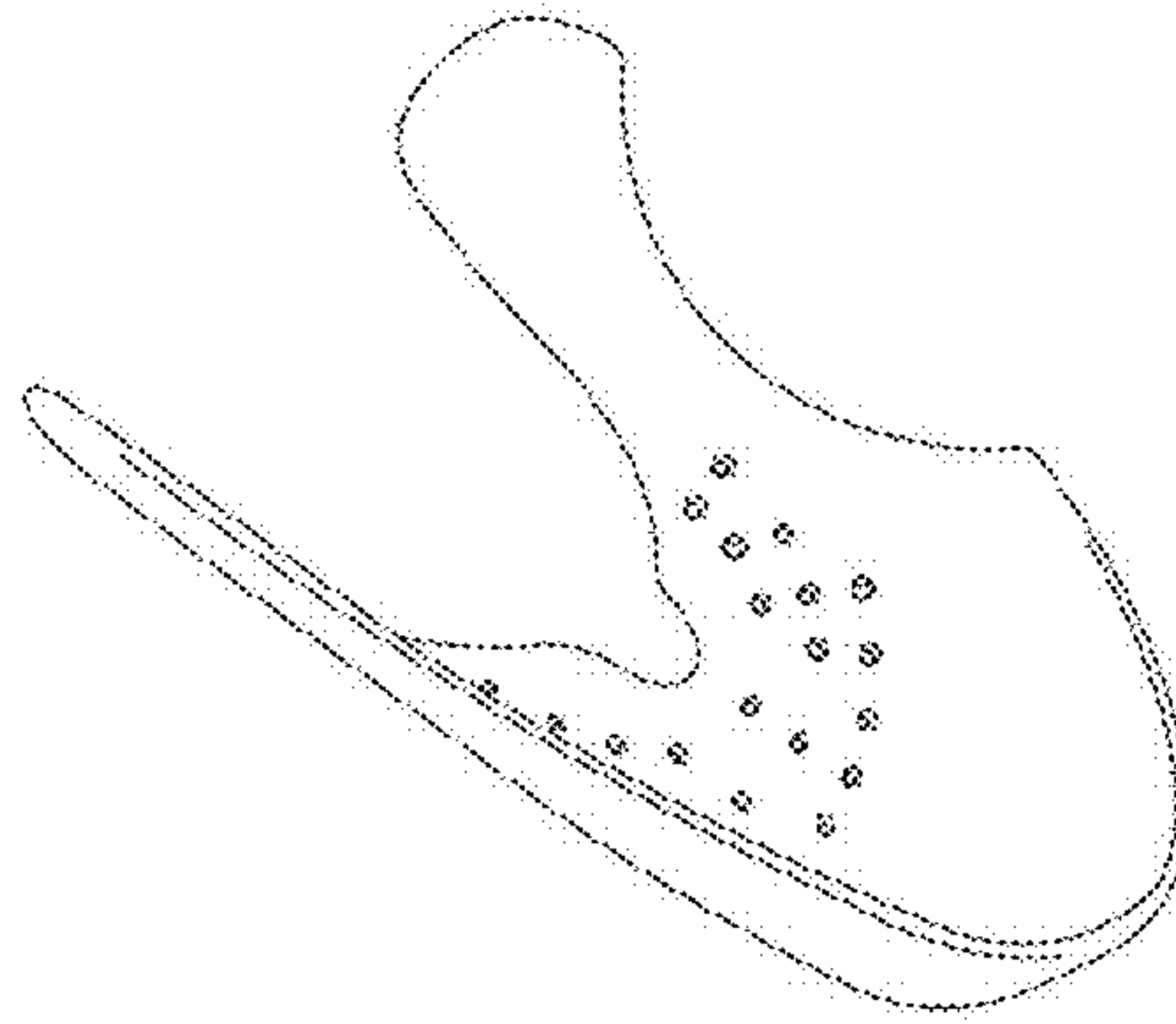

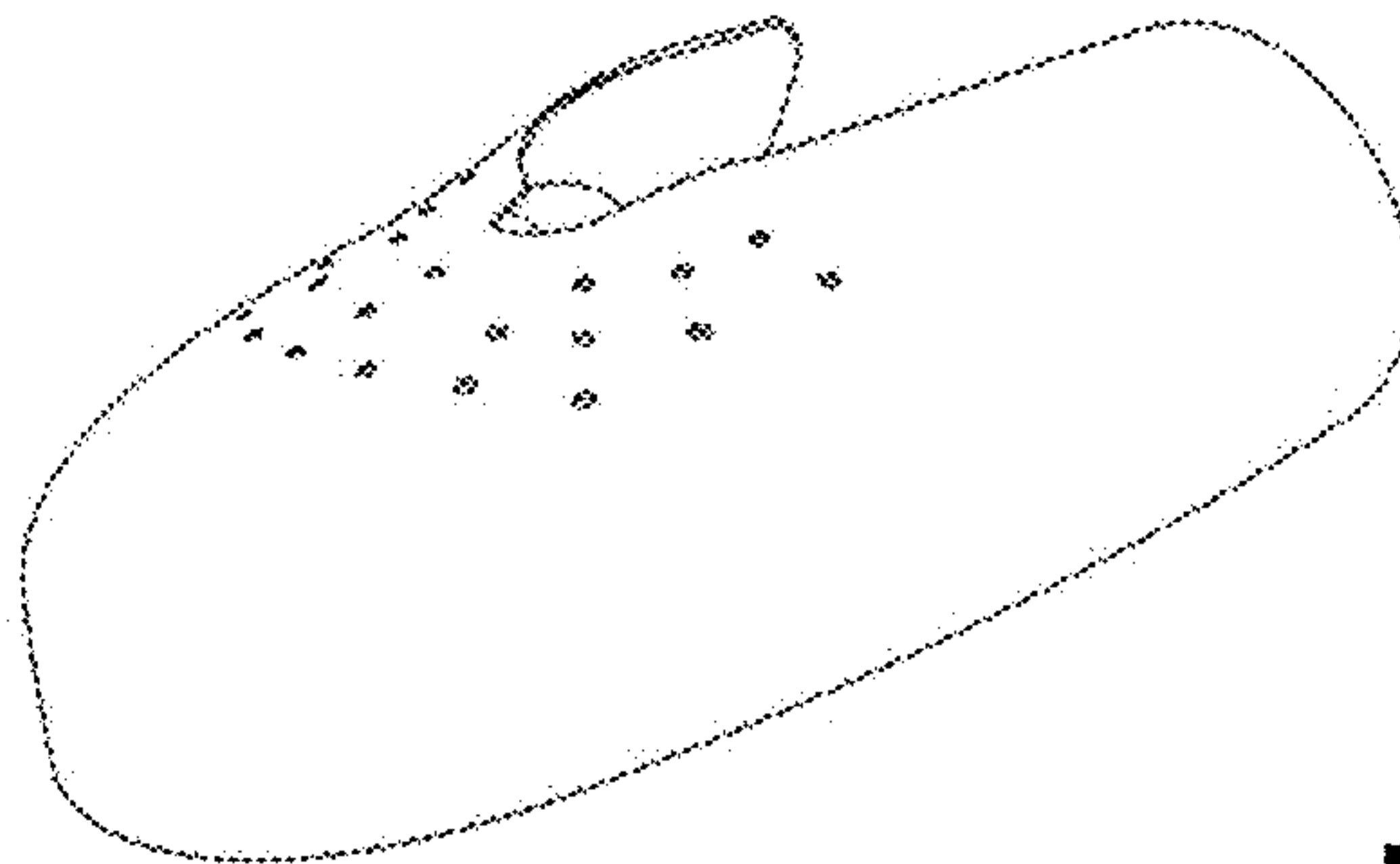

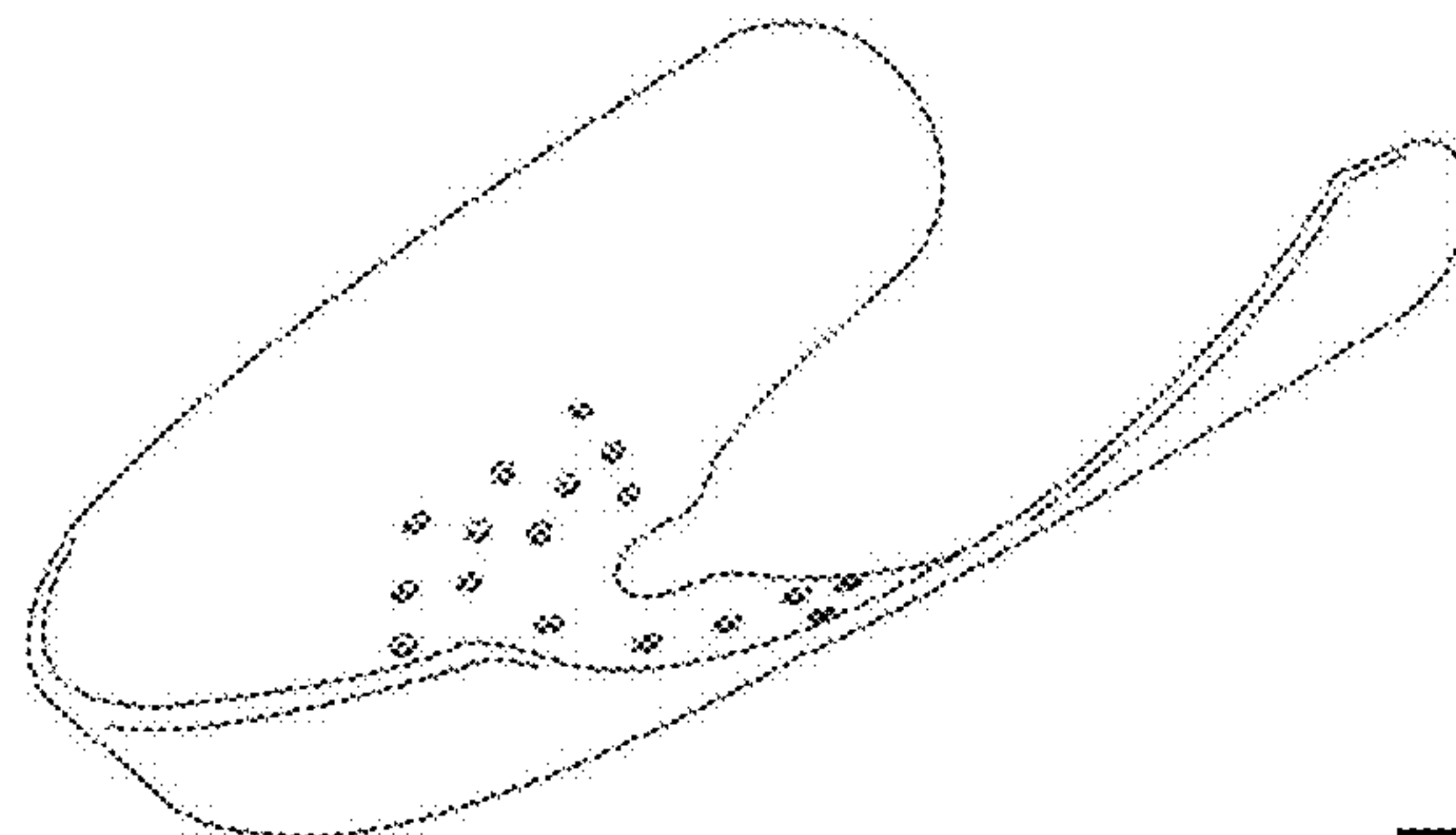

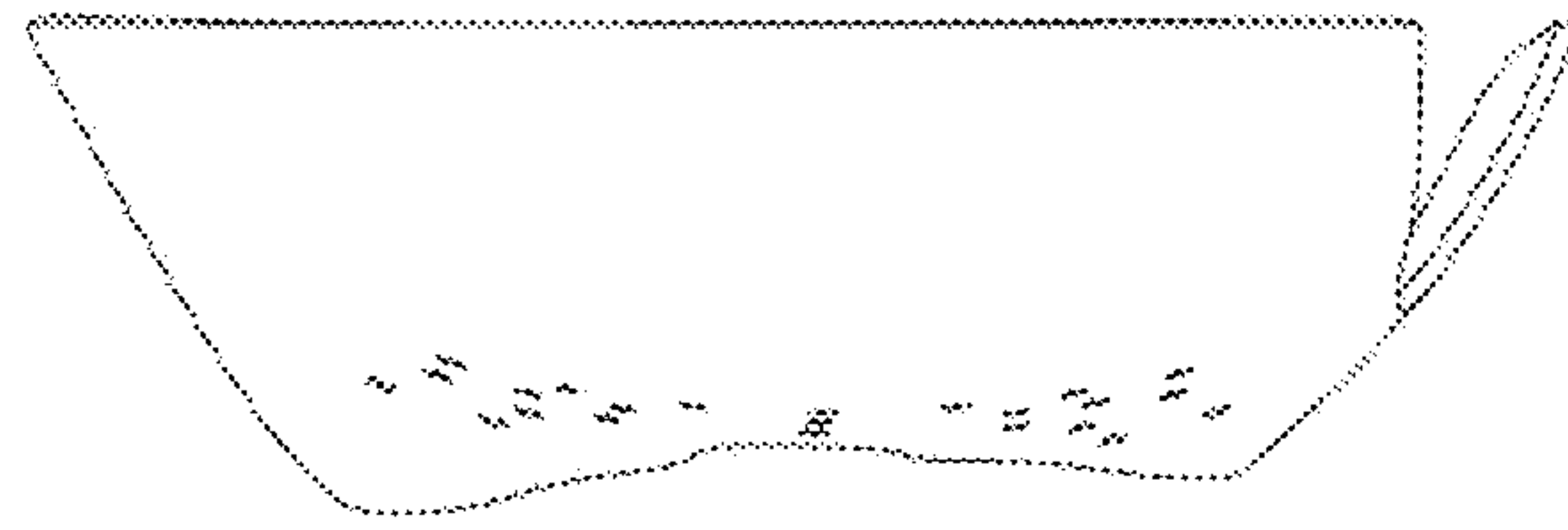

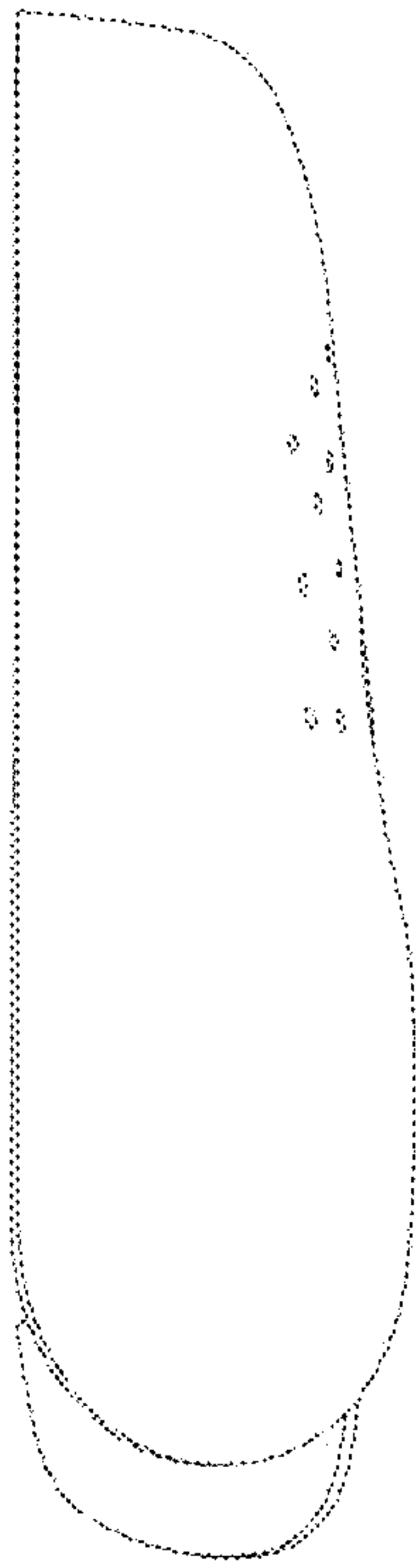

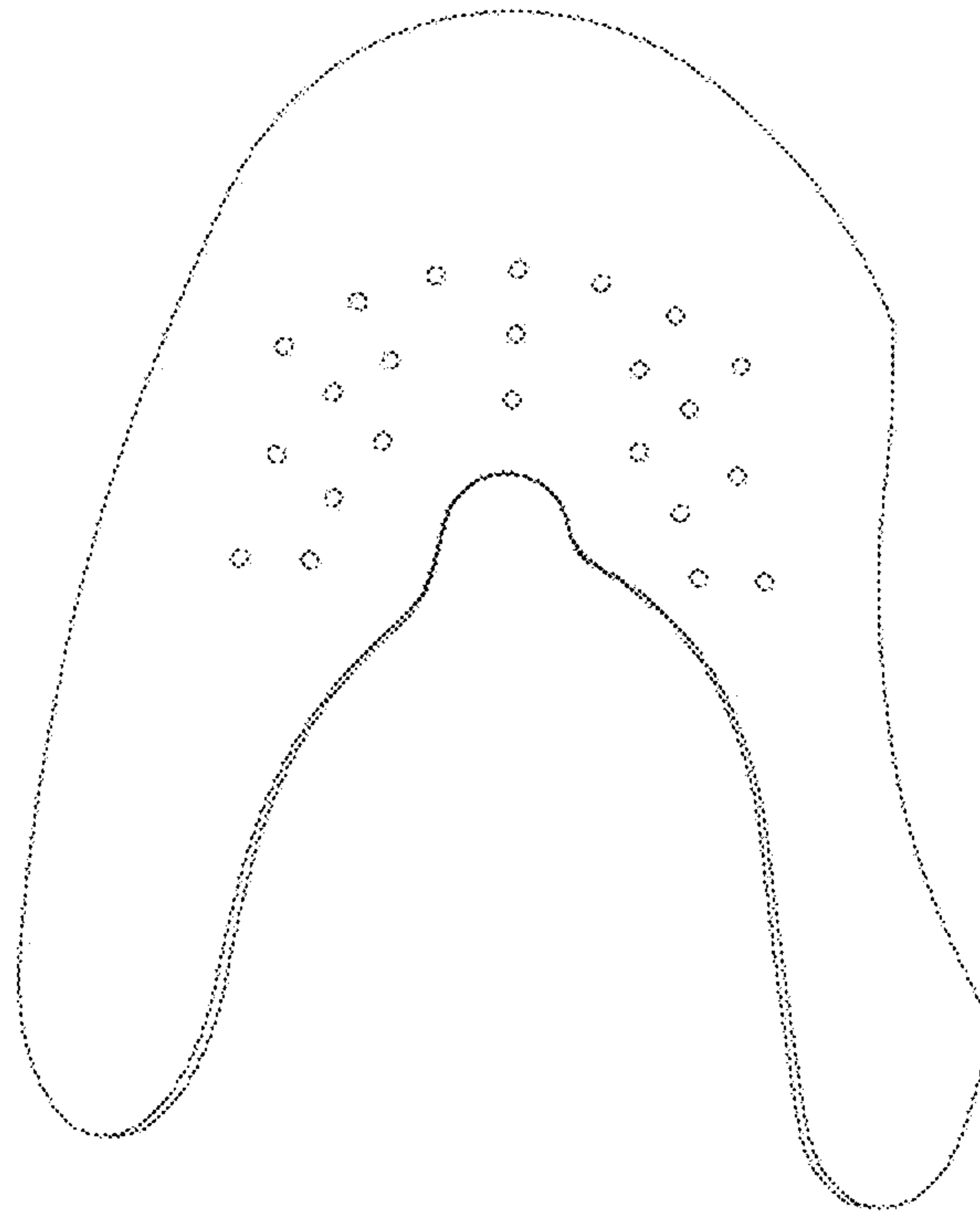

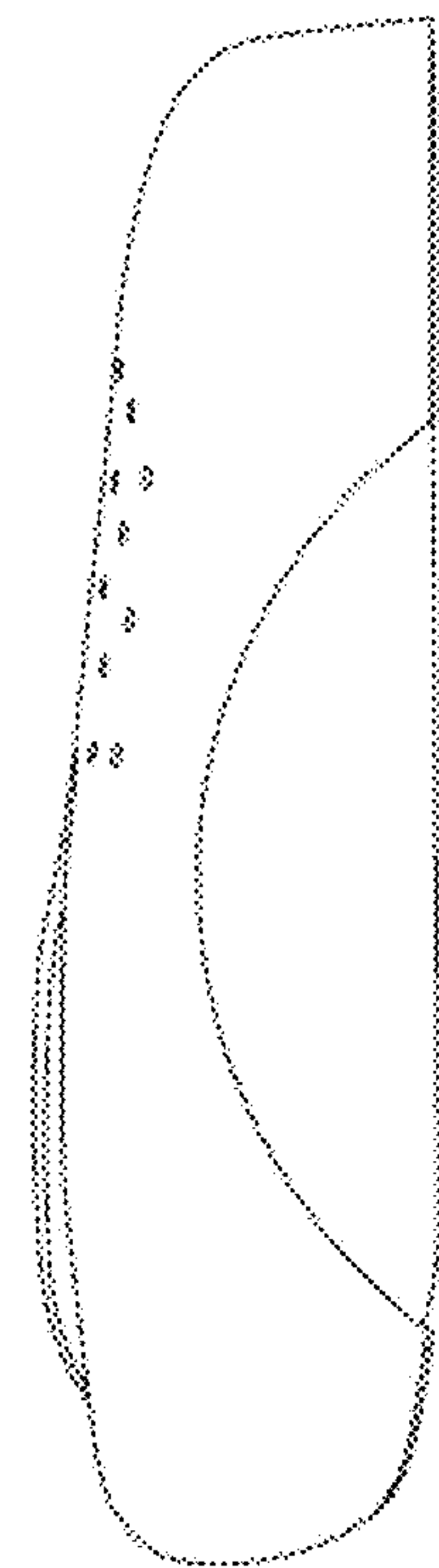

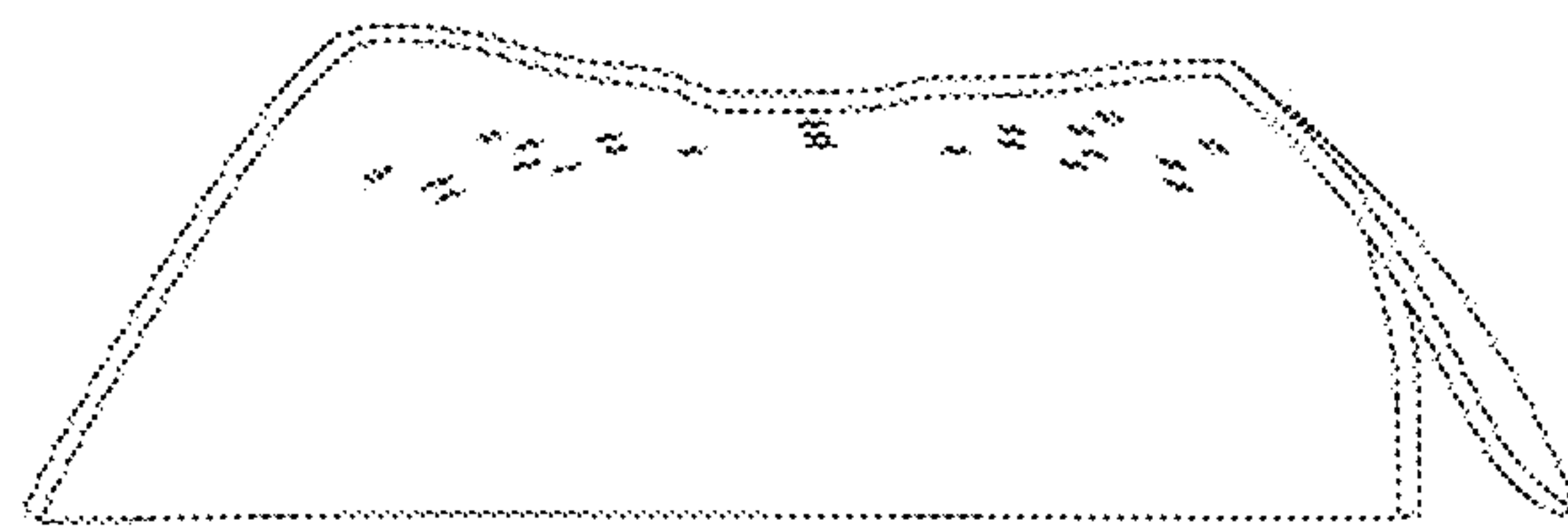

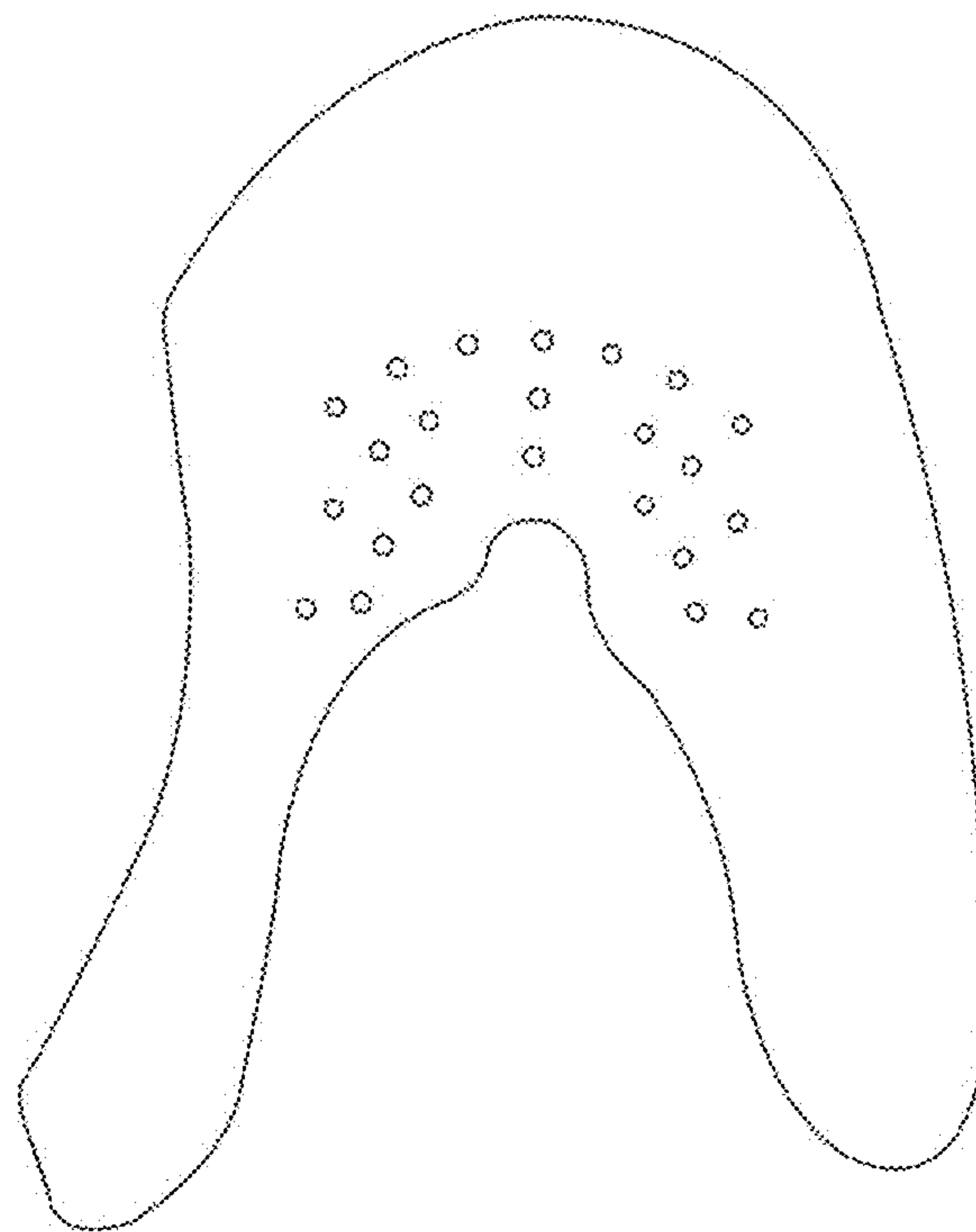
