(57) **CLAIM**

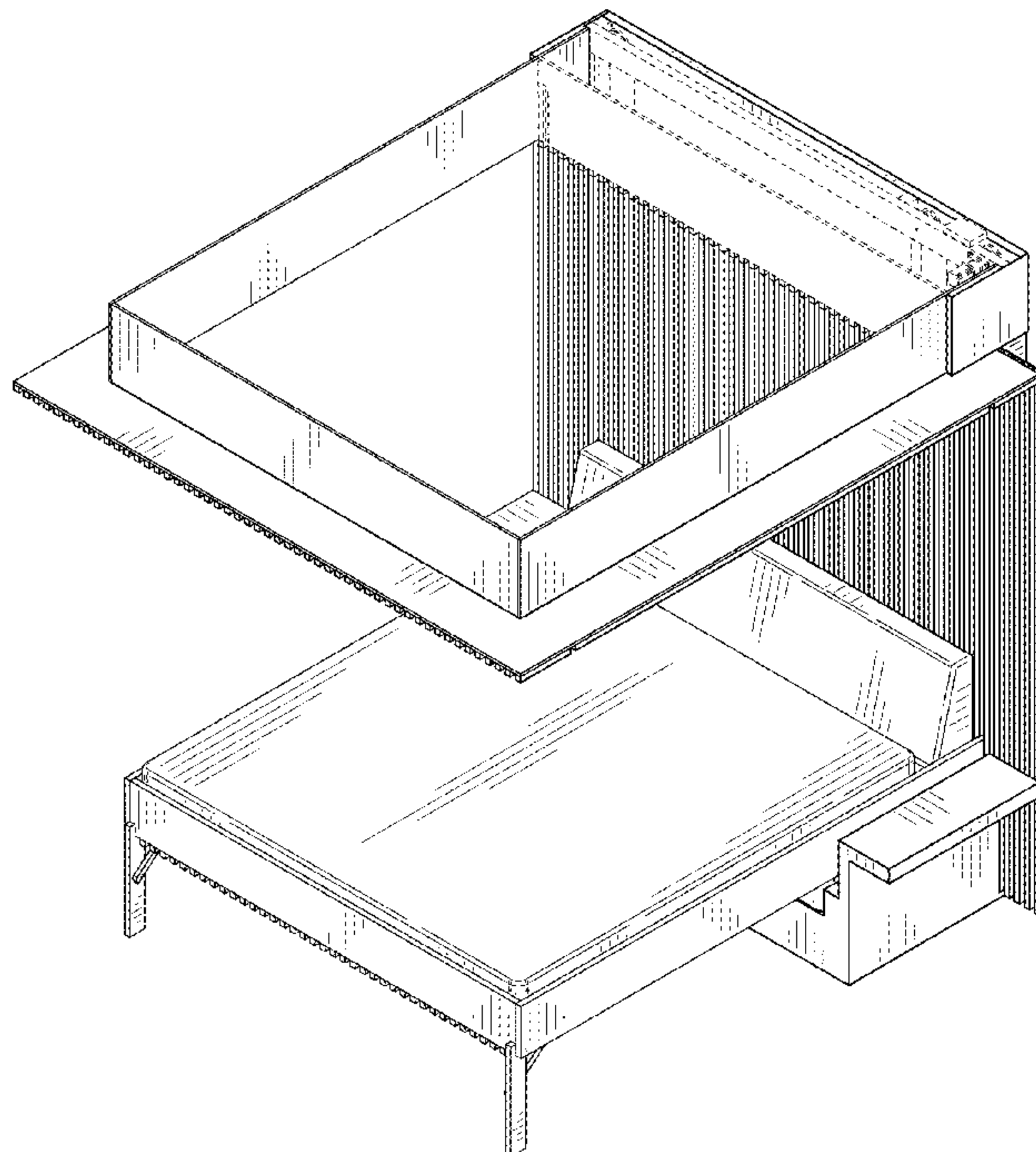
The ornamental design for the furniture item, as shown and described.

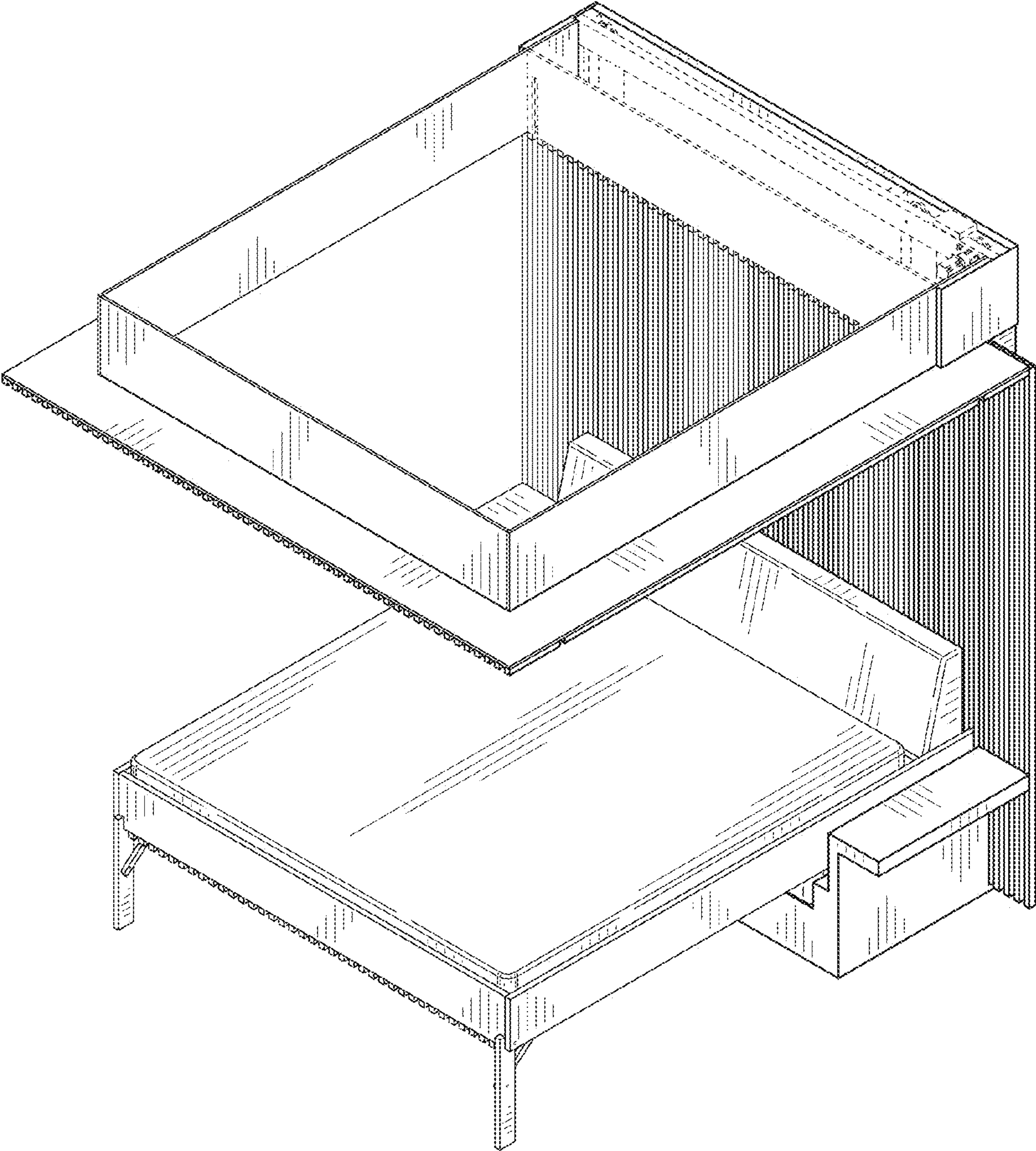

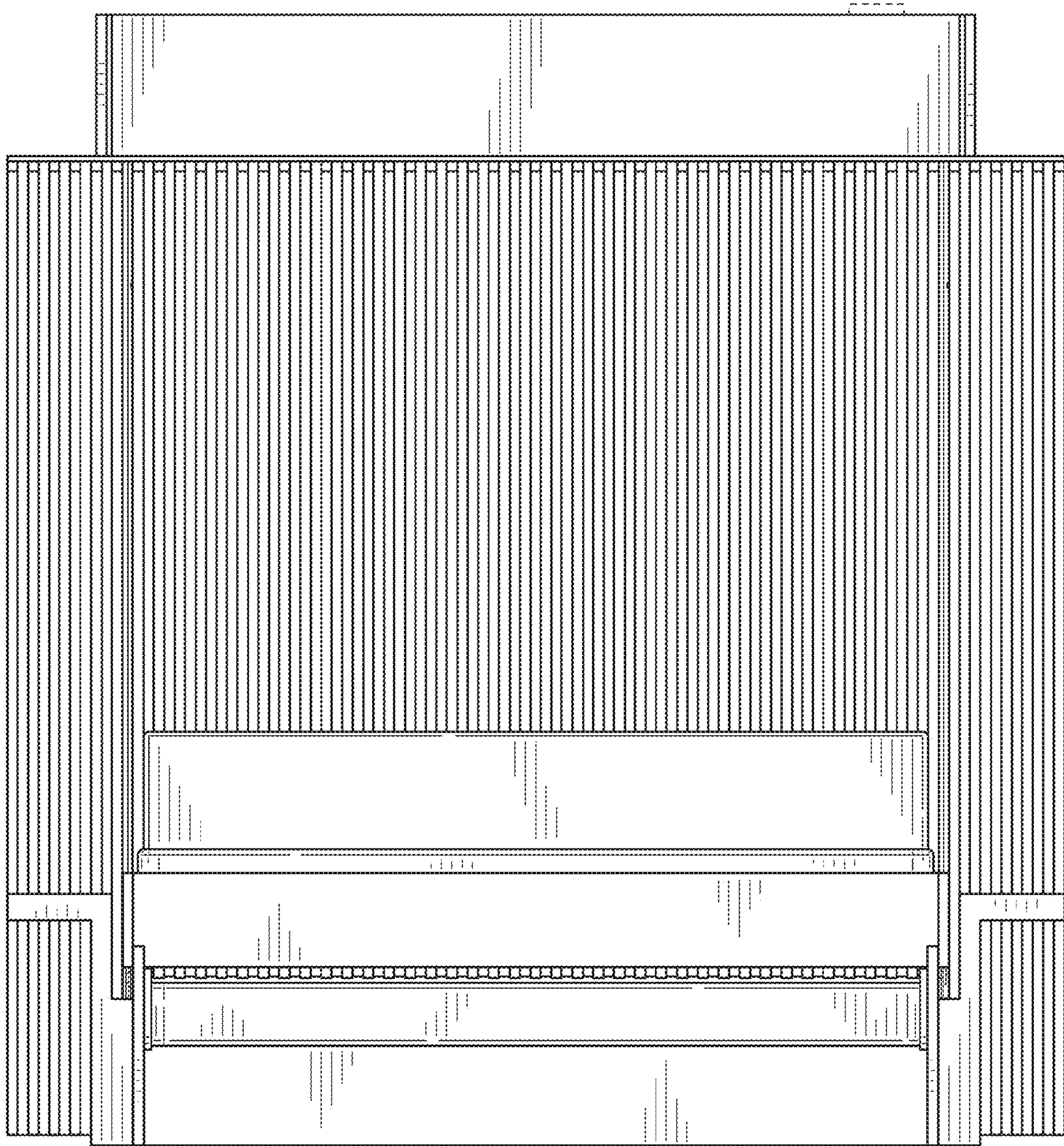

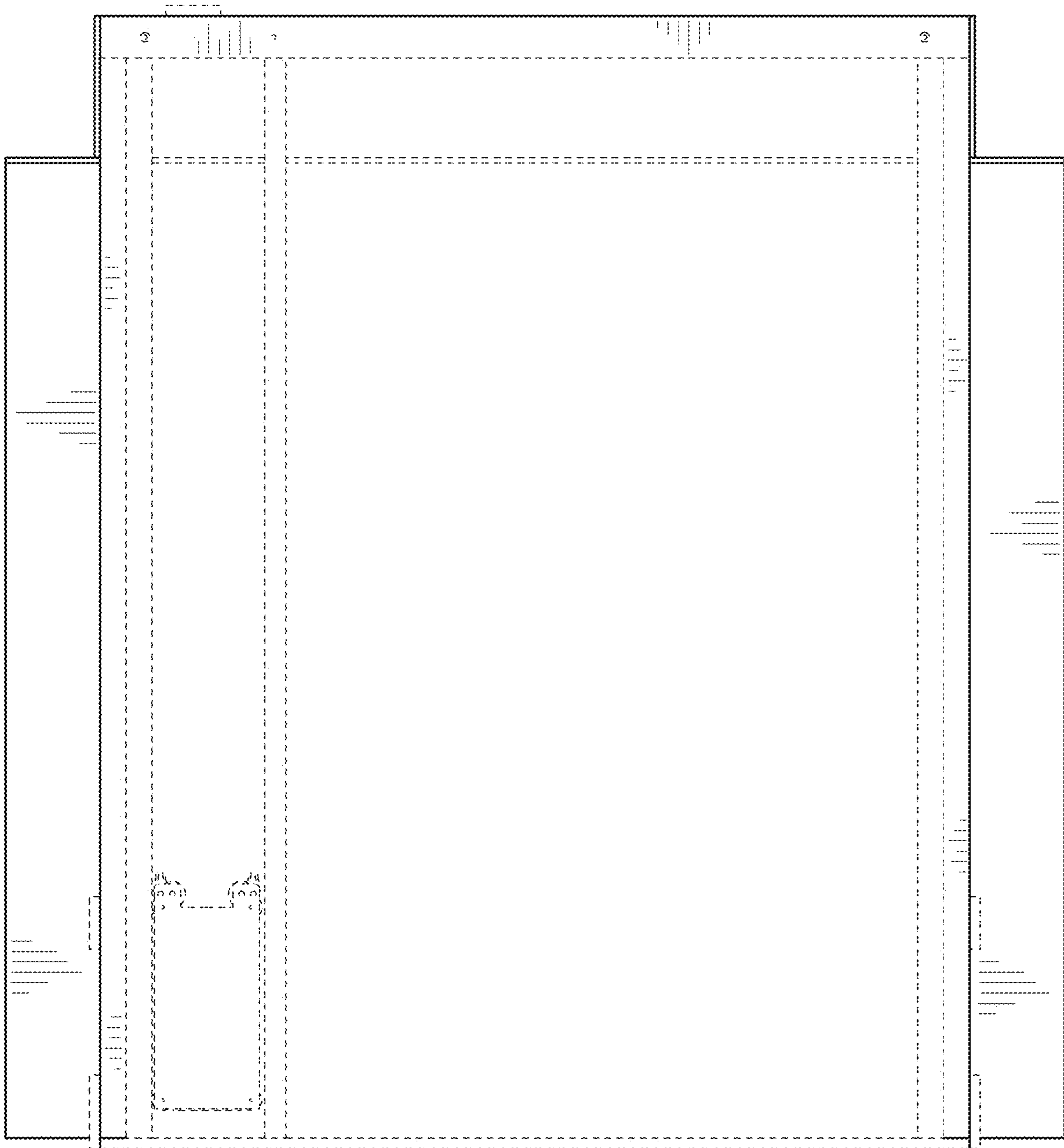

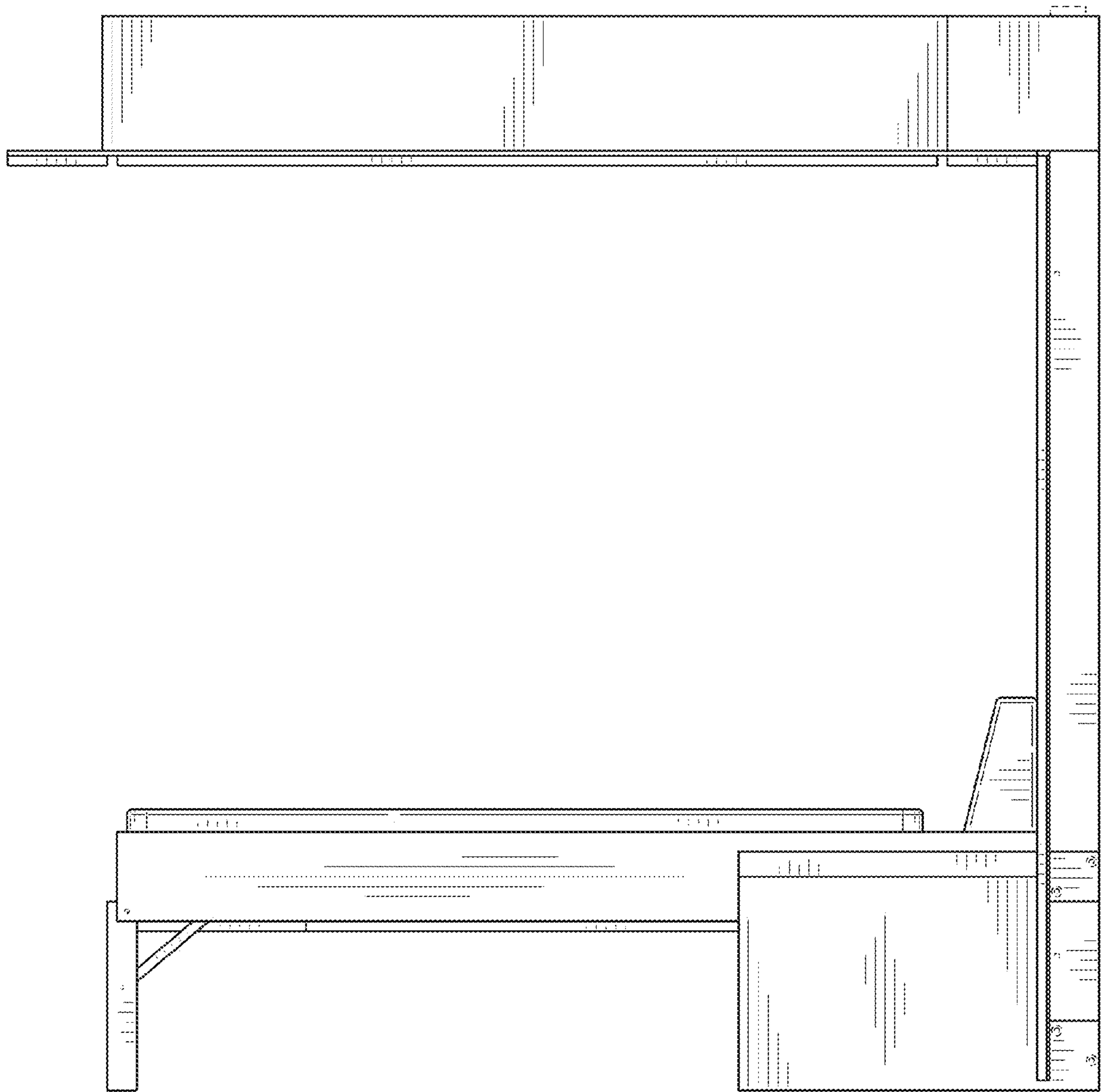

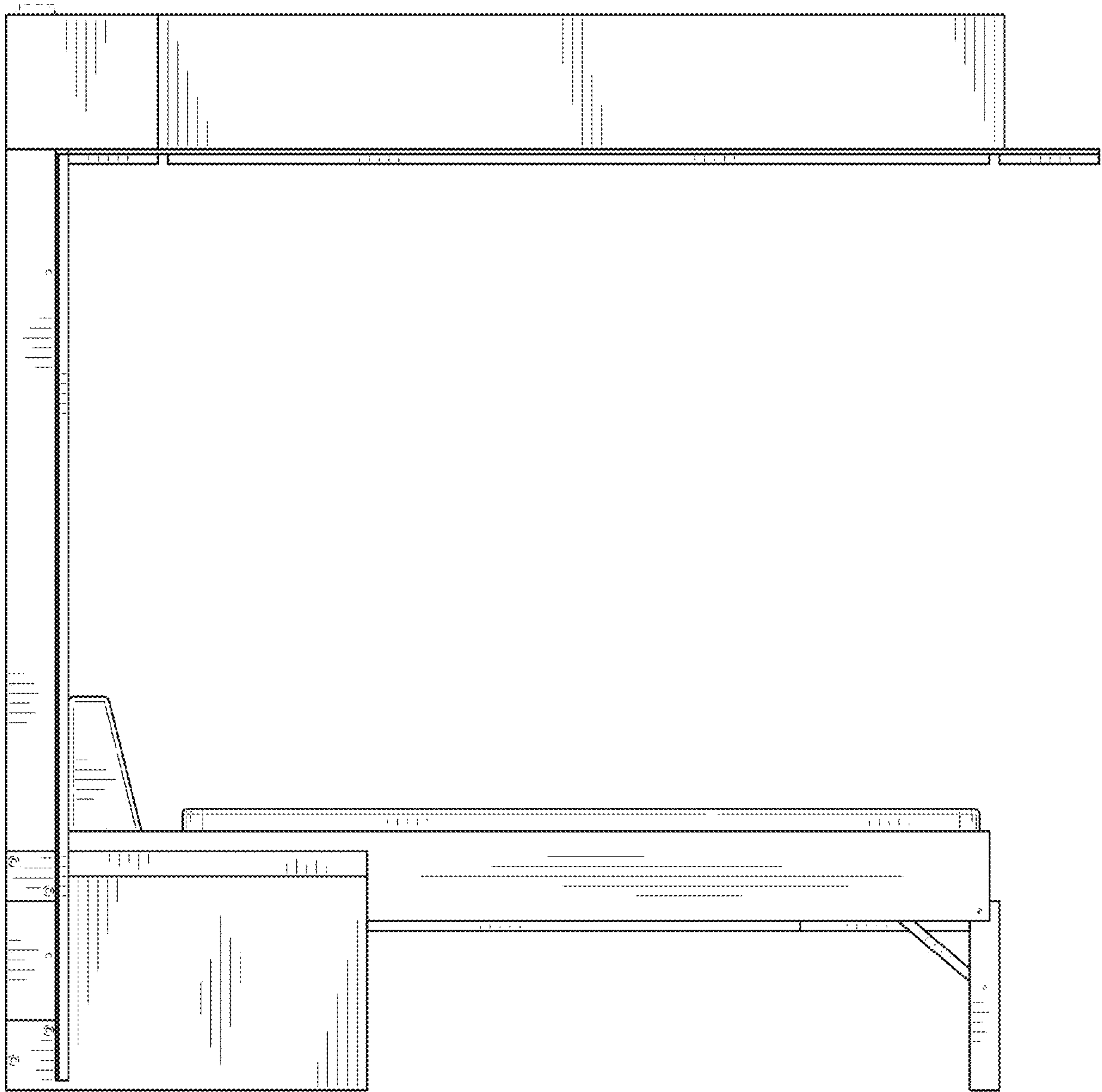

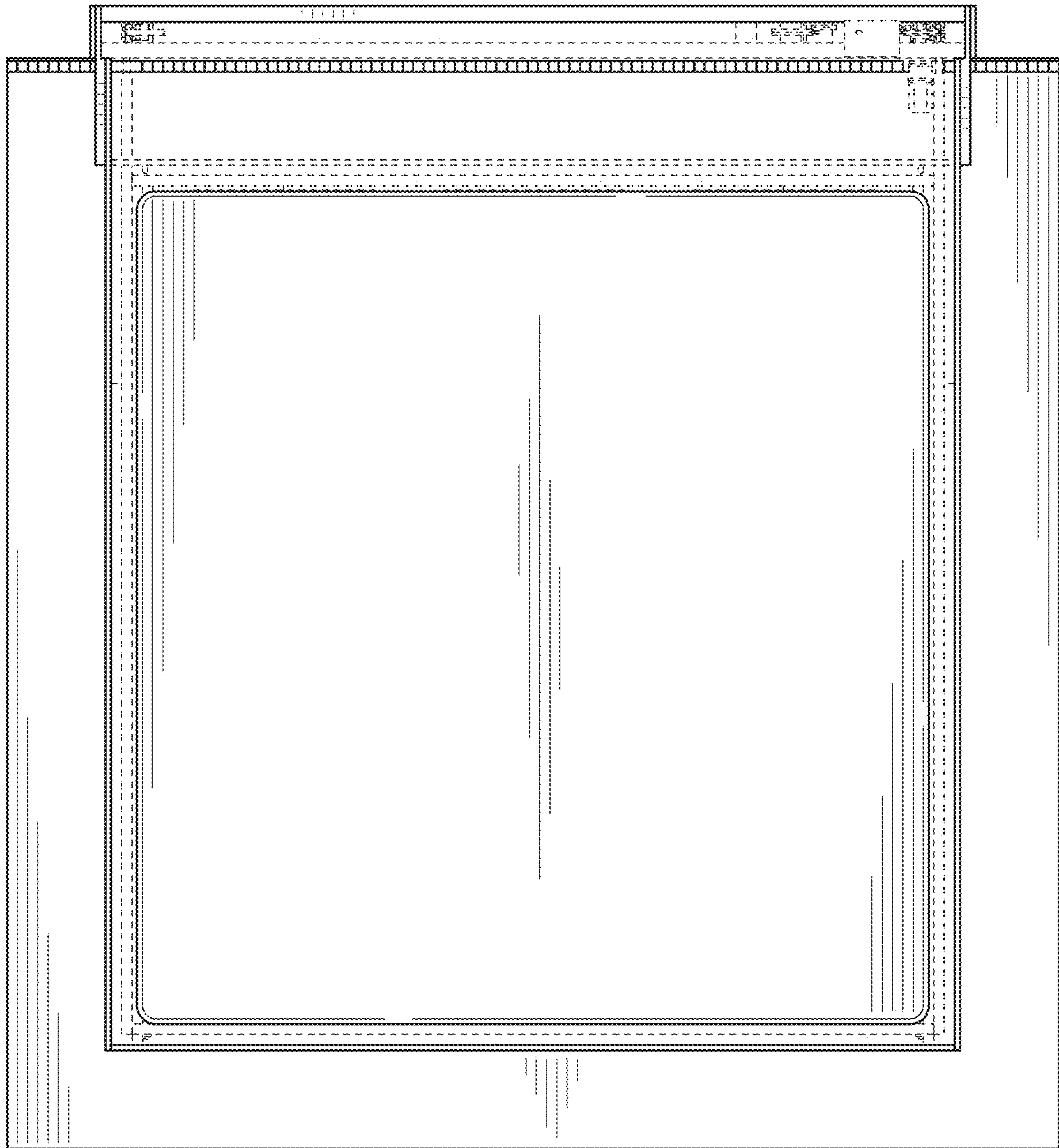

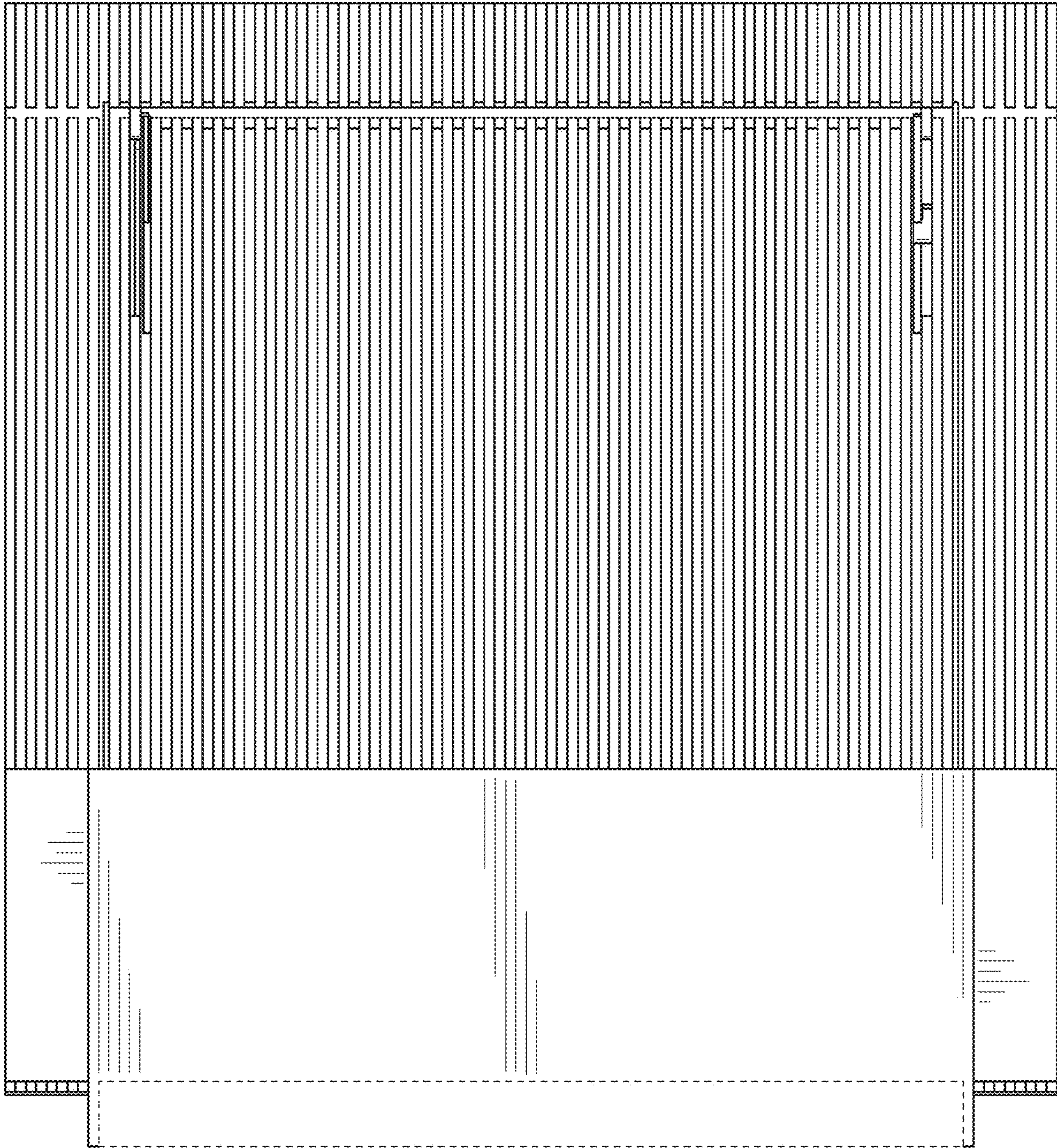

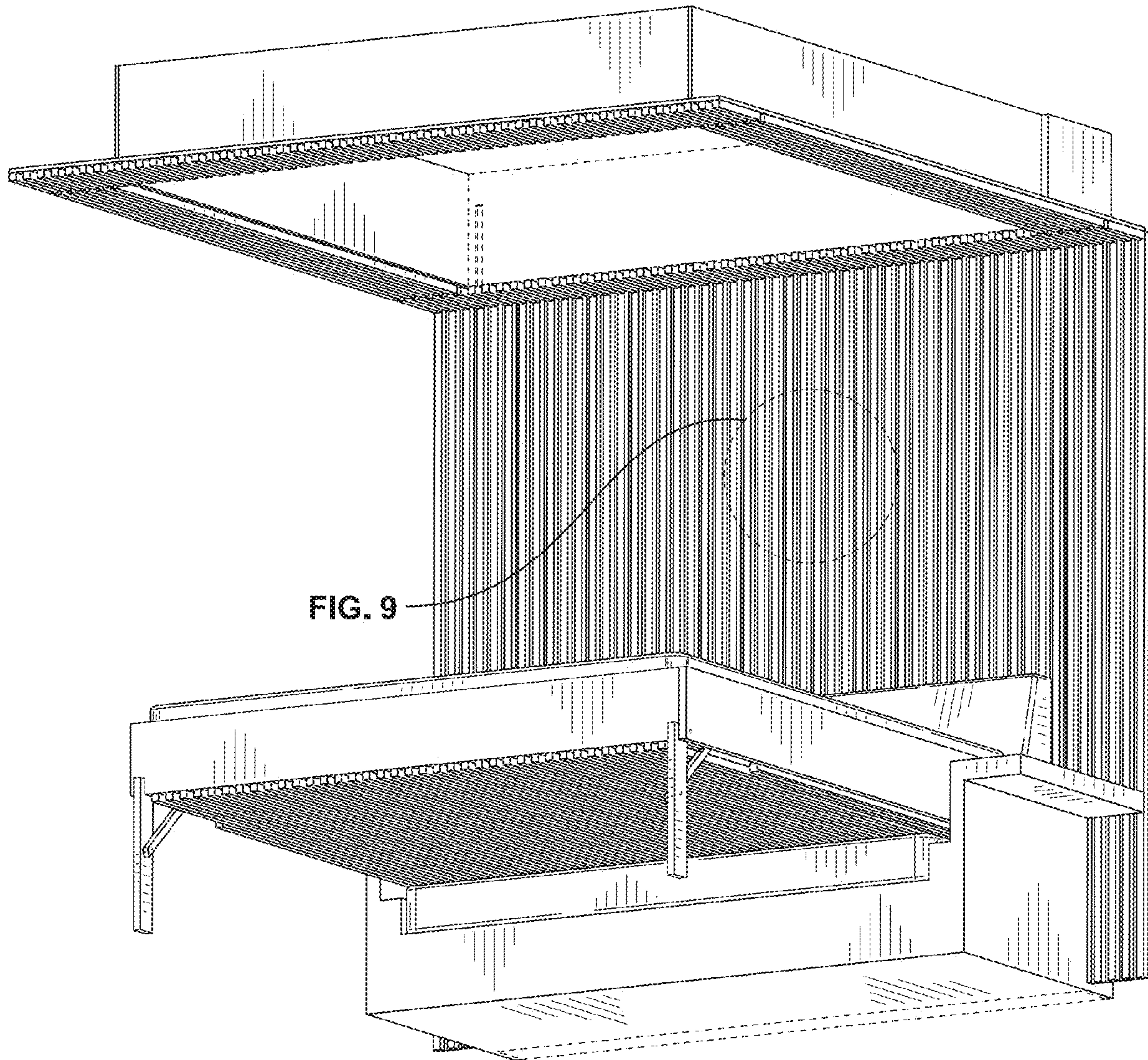

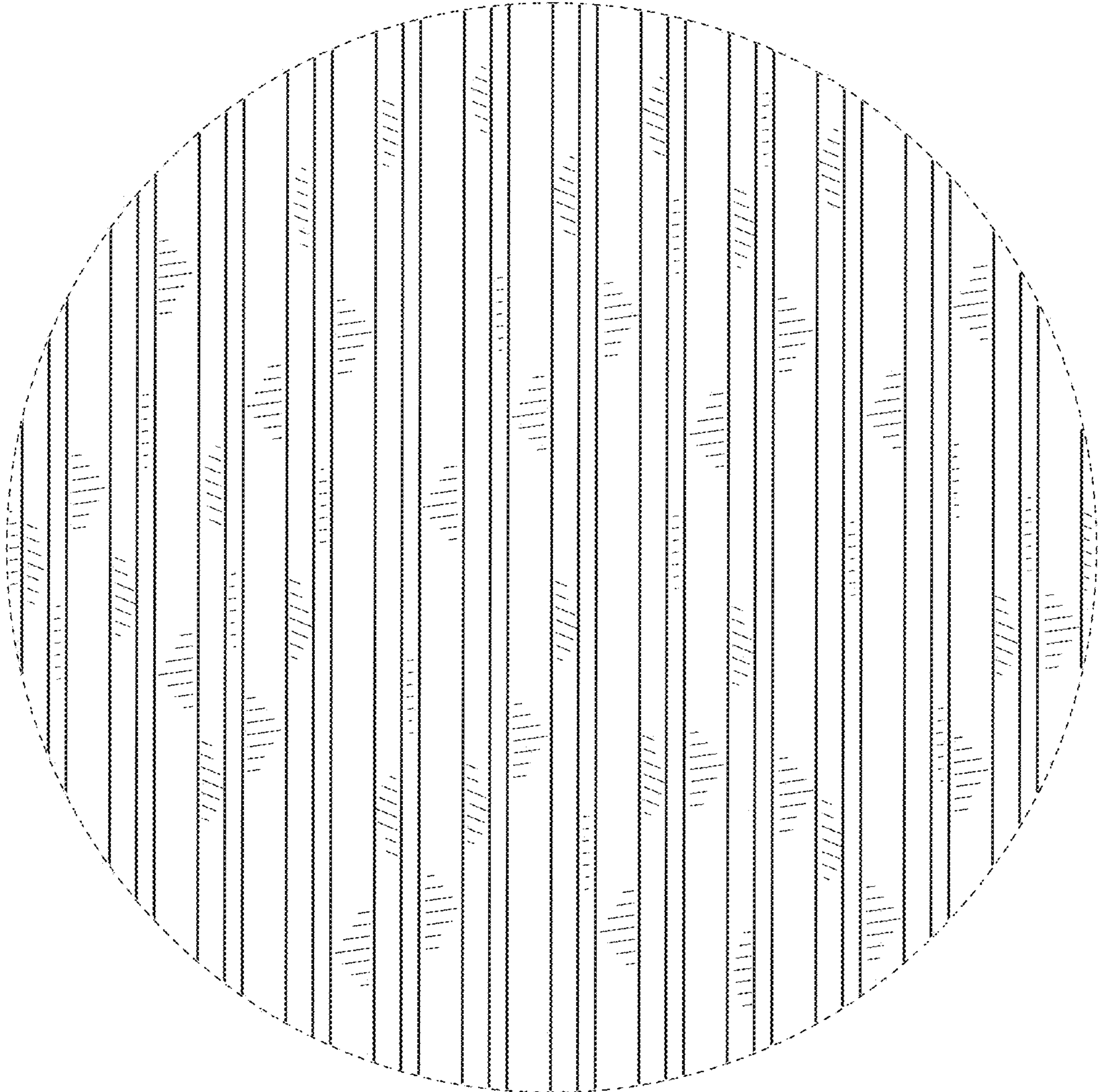
