FIG. 7 is a bottom view of the locker with angled panels of FIG. 1.

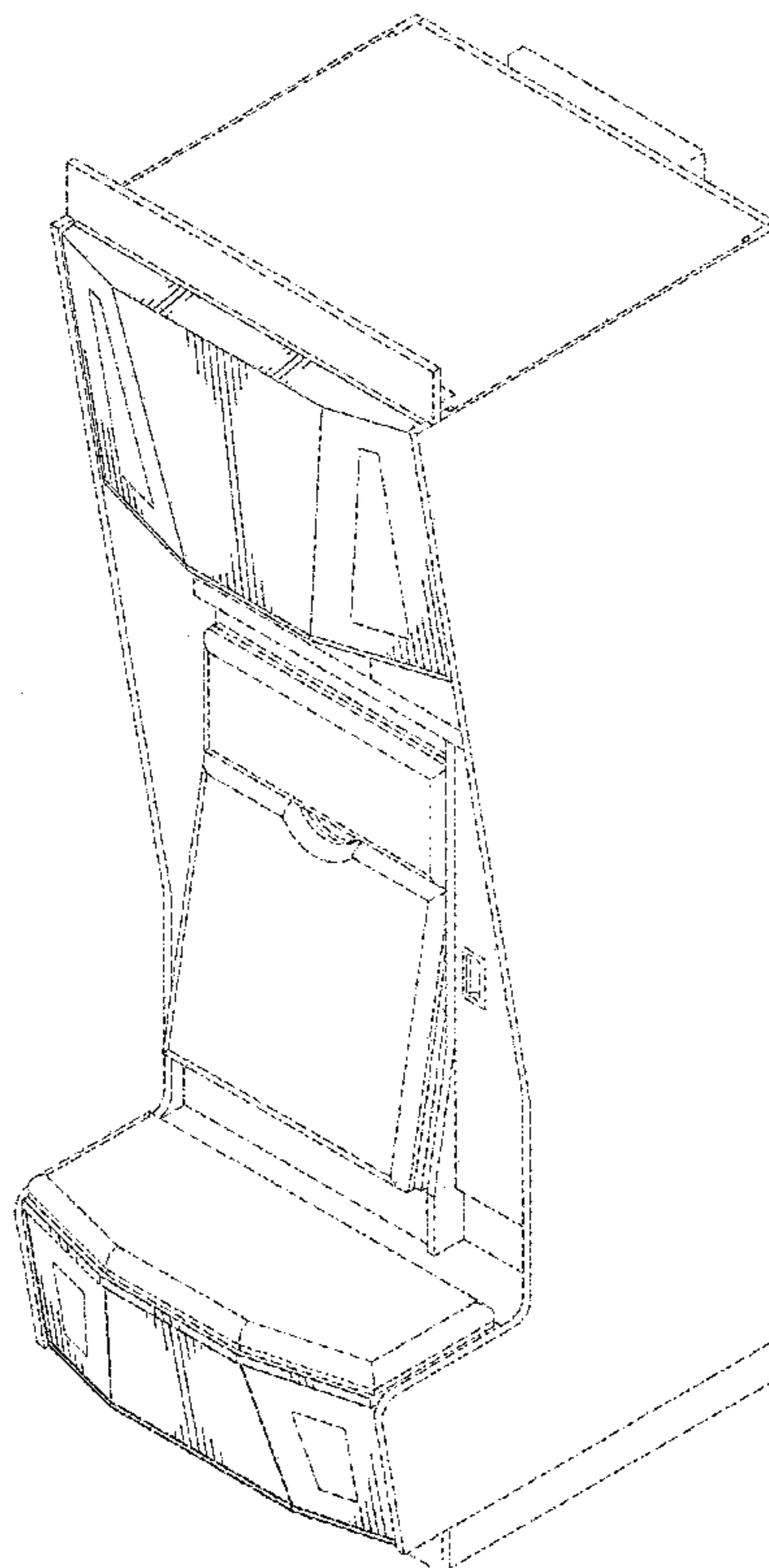

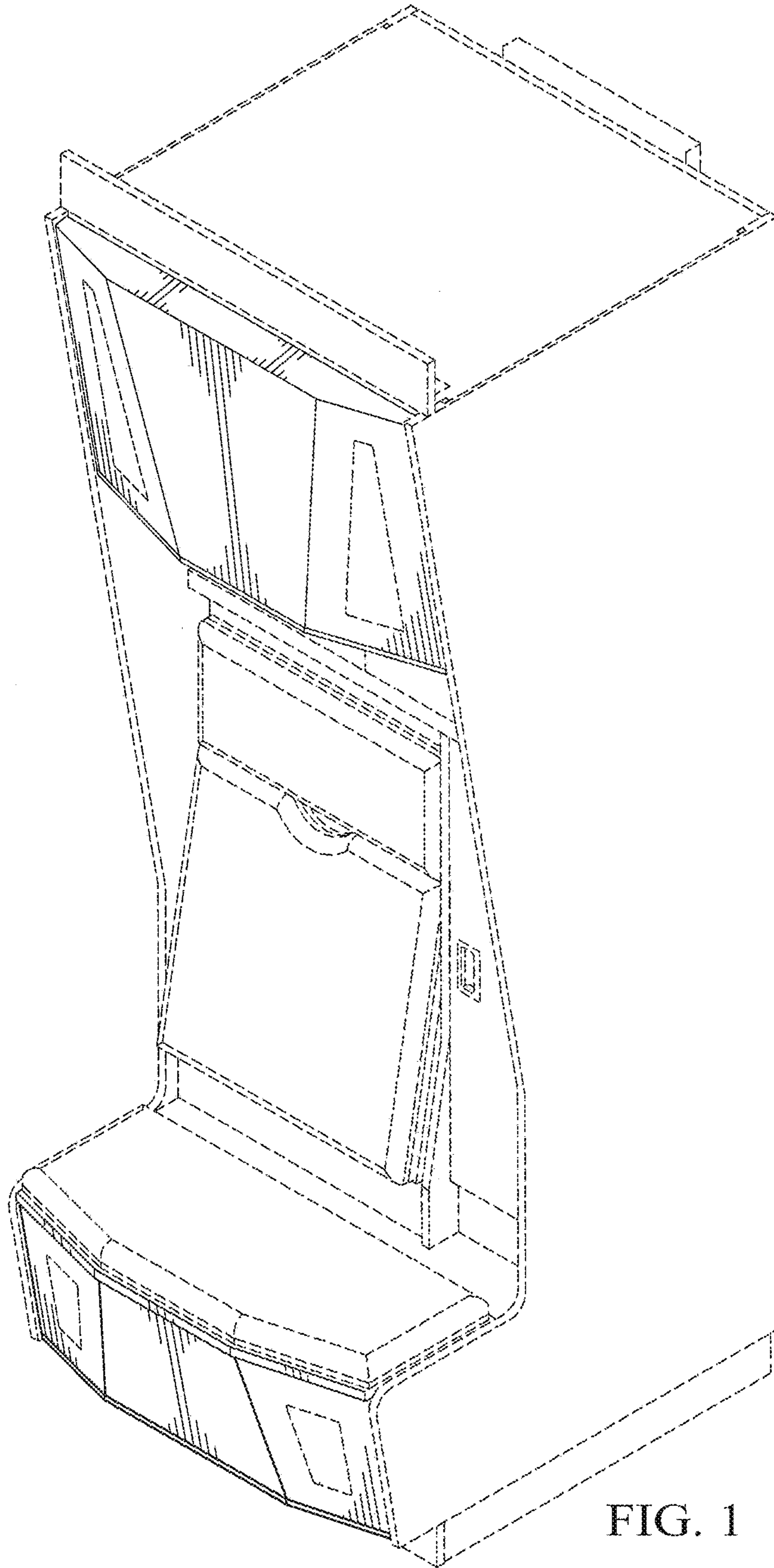

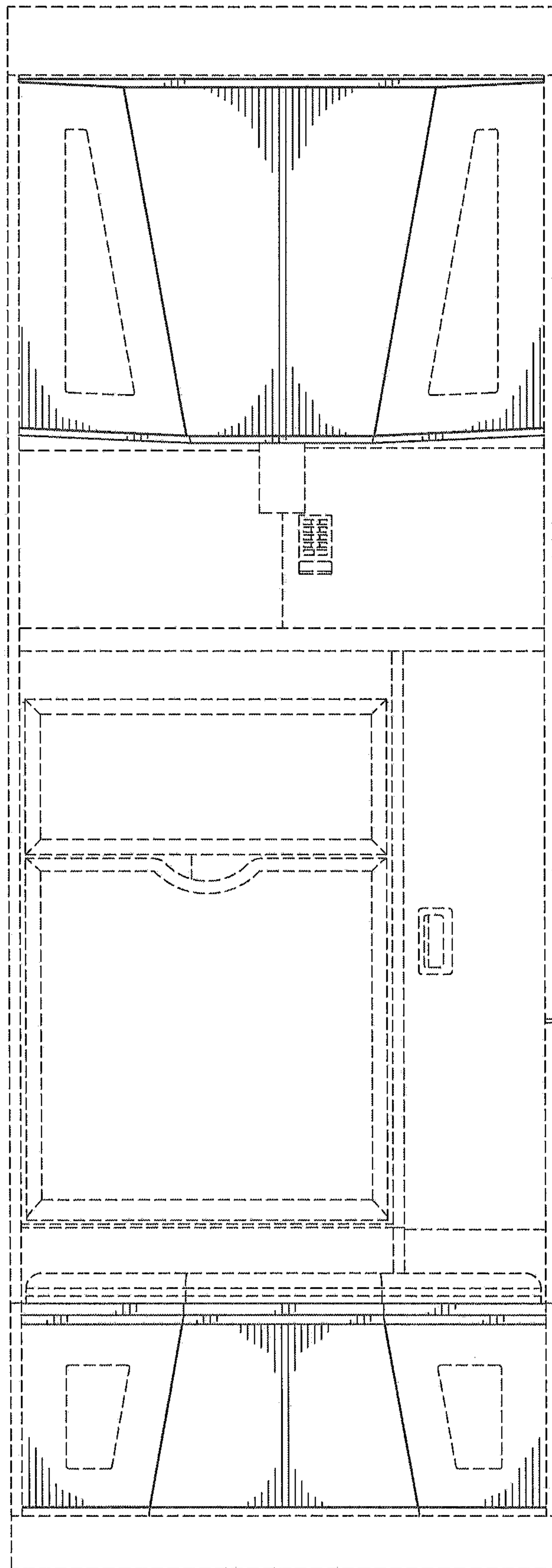

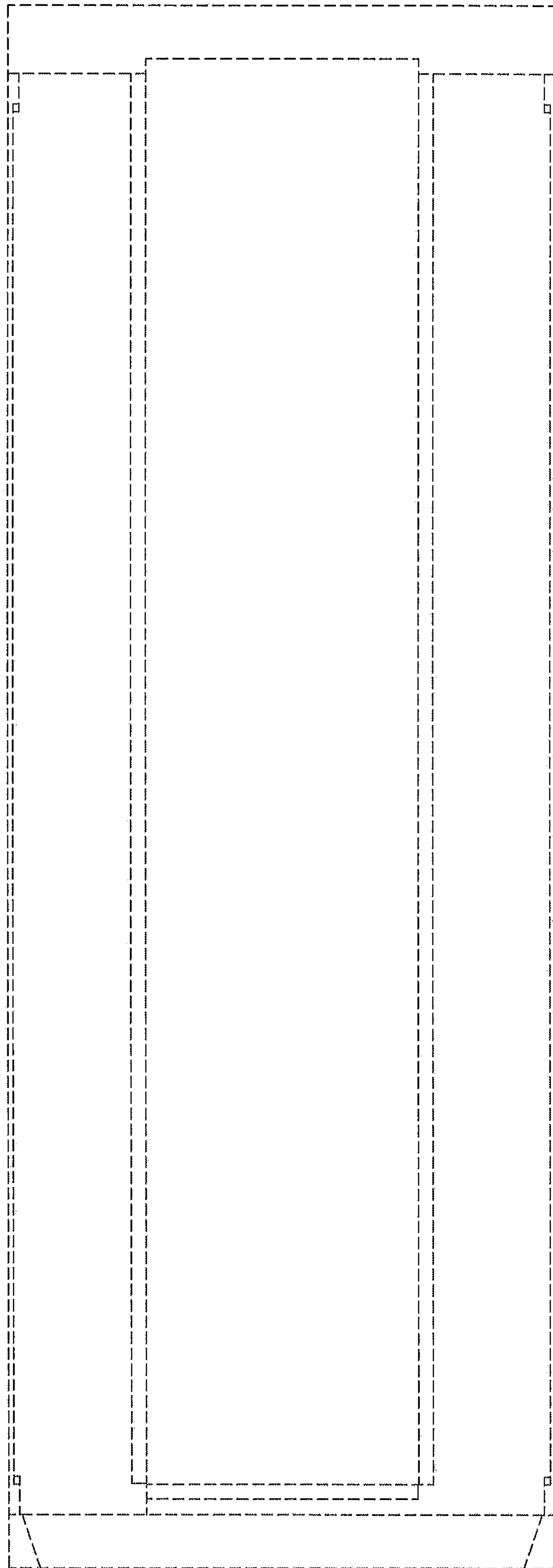

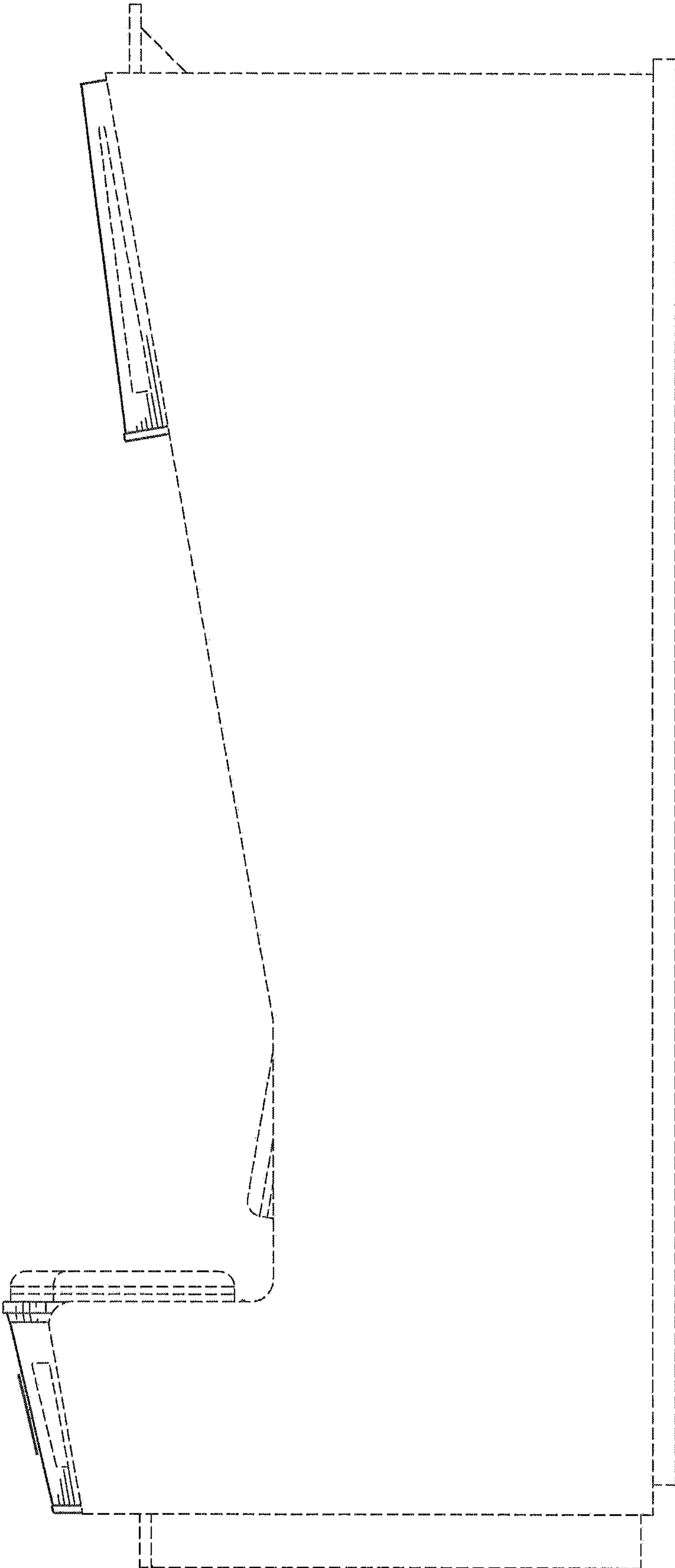

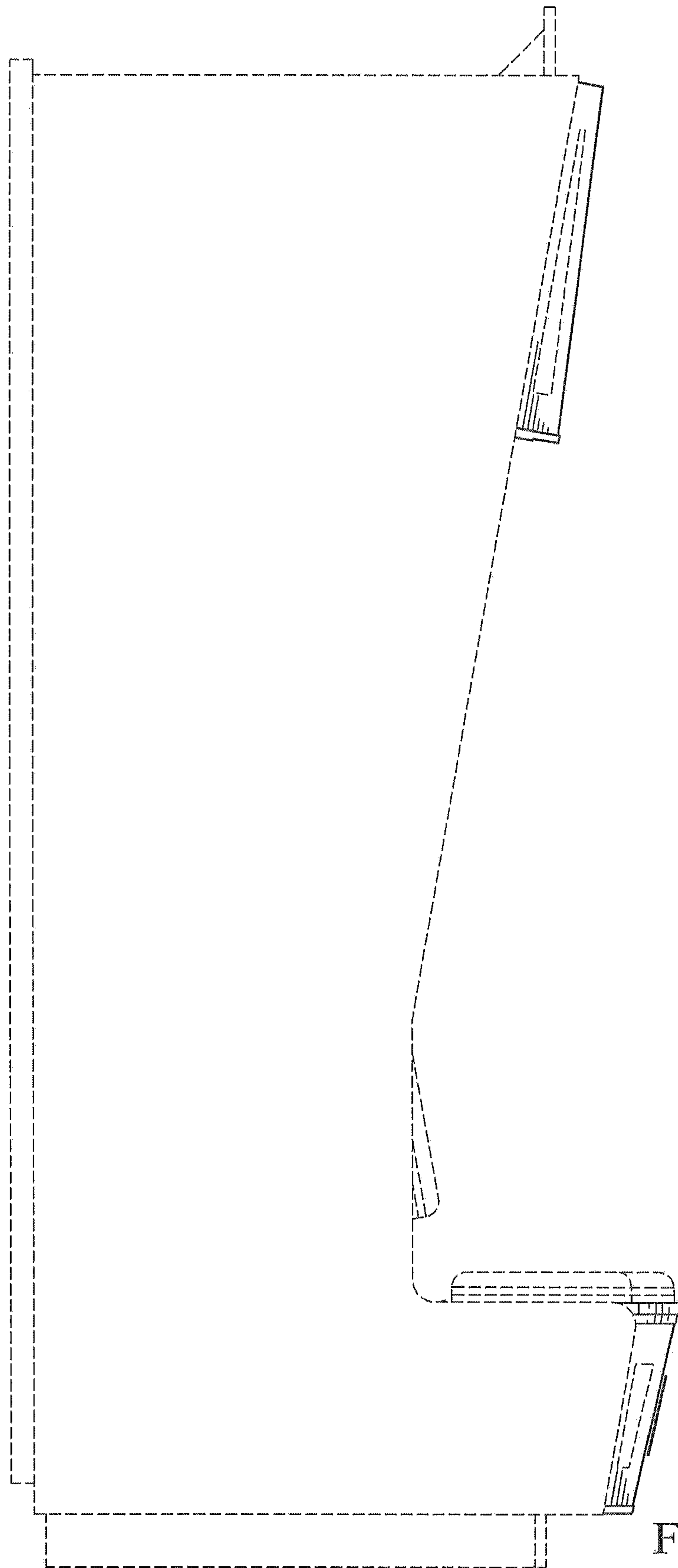

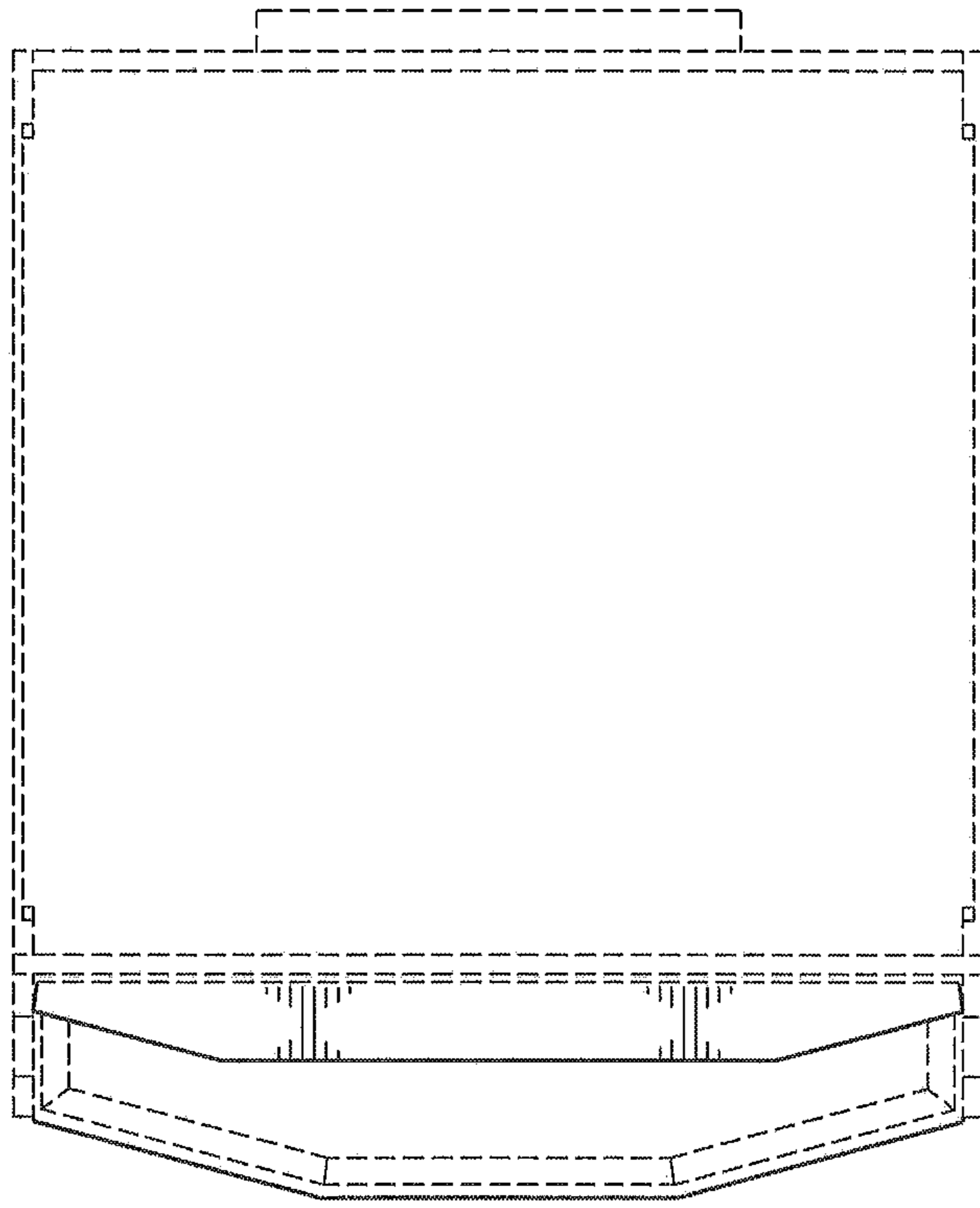

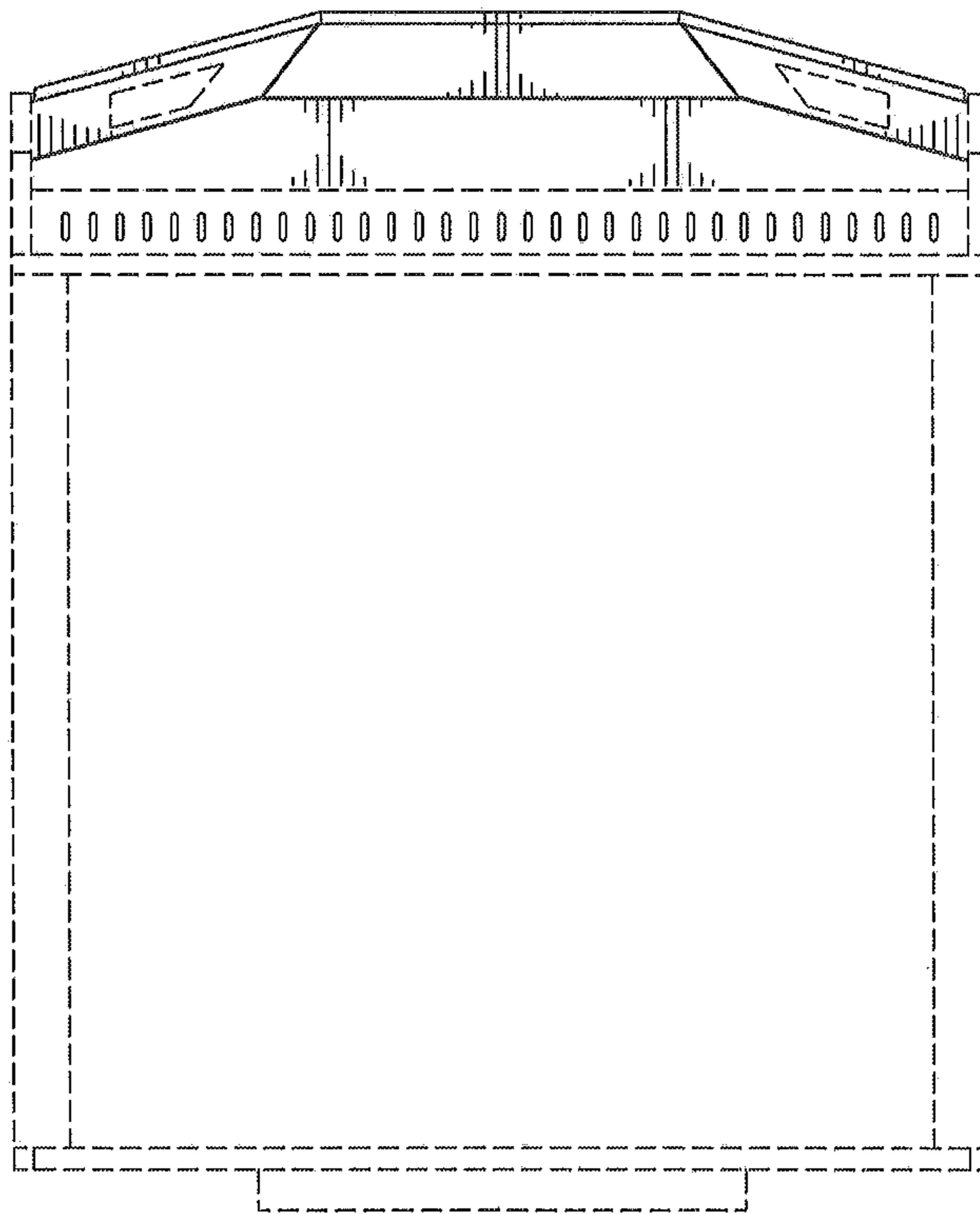
