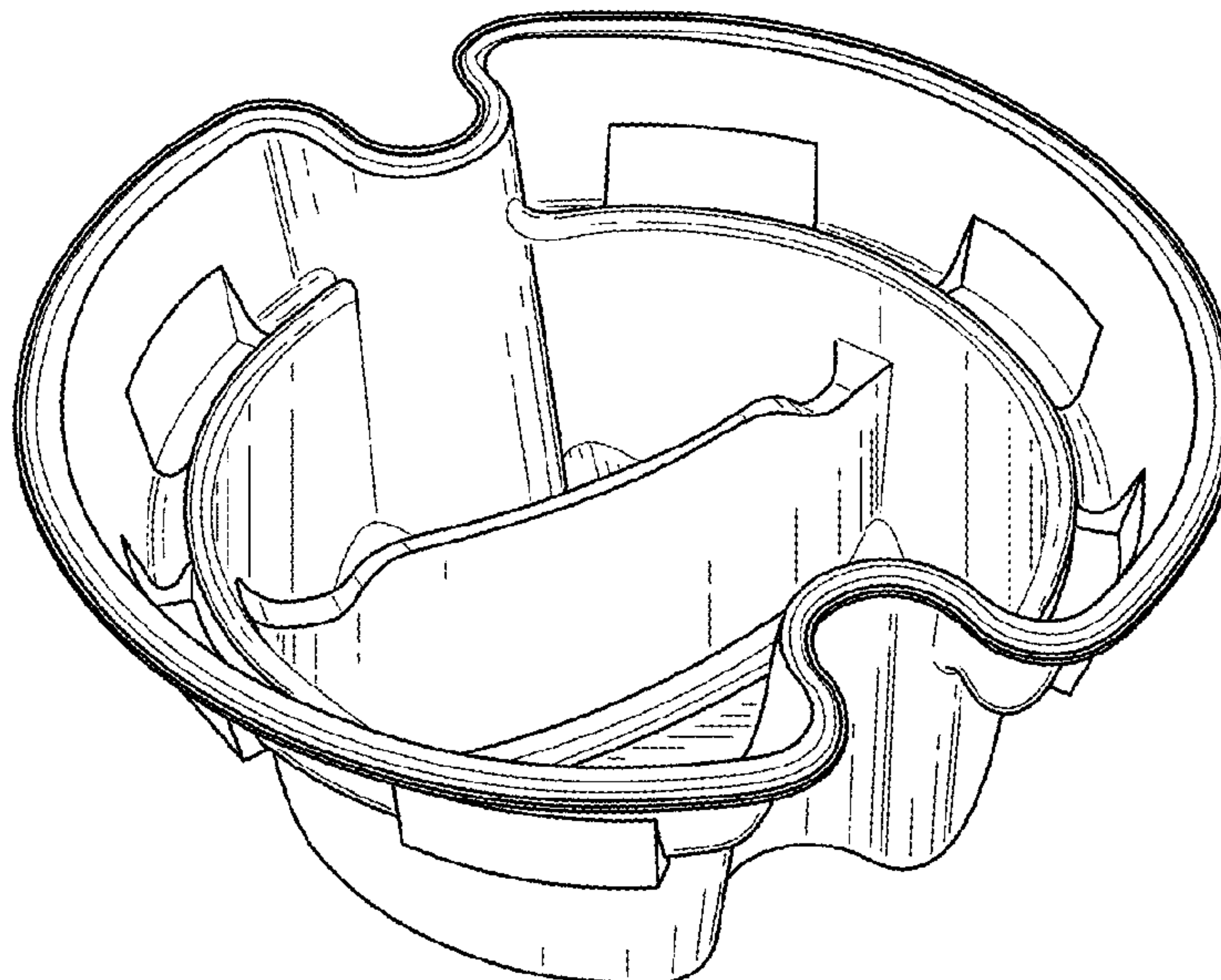
(57) **CLAIM**

We claim the ornamental design for the food and drink receptacle, as shown and described.

**DESCRIPTION**

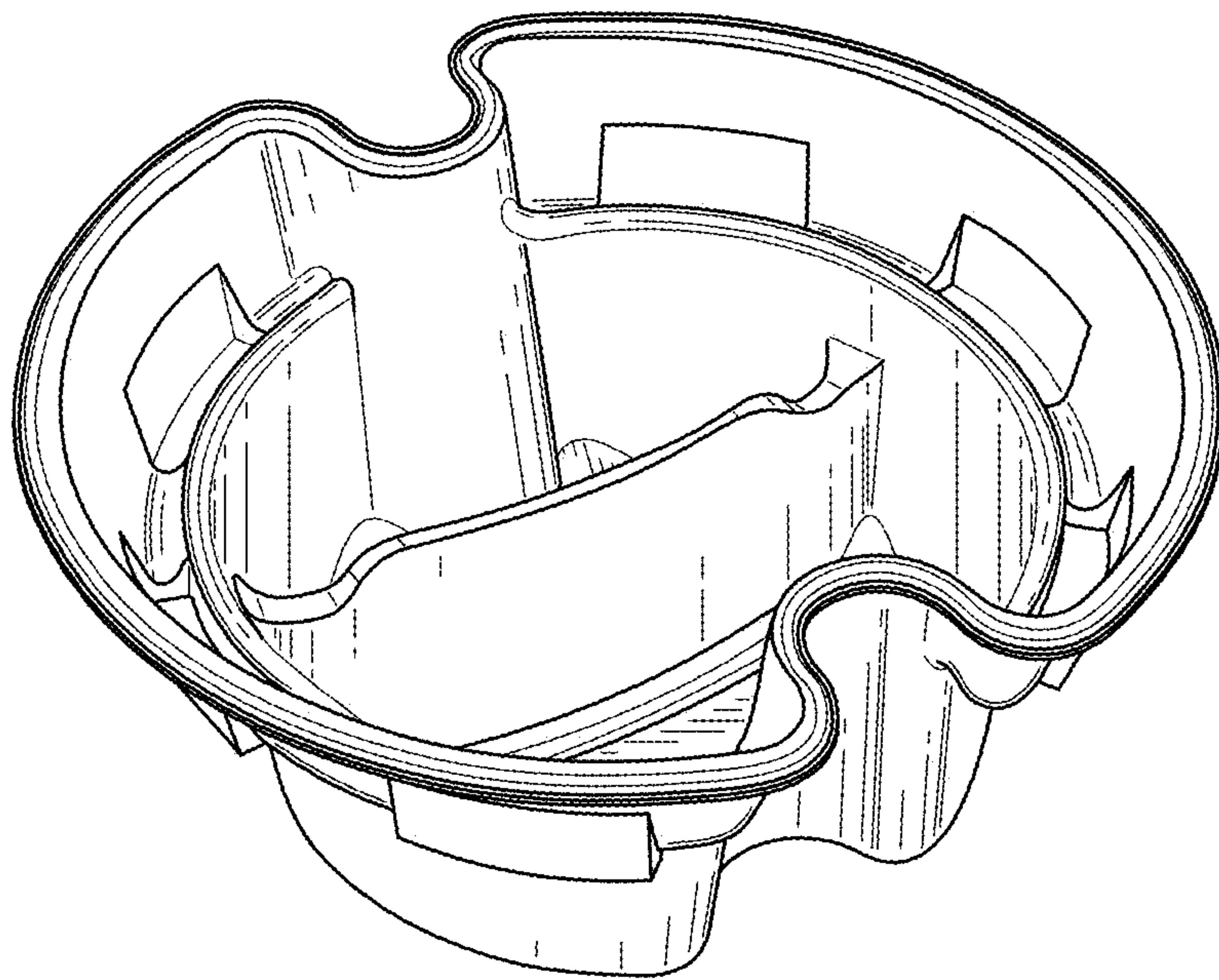

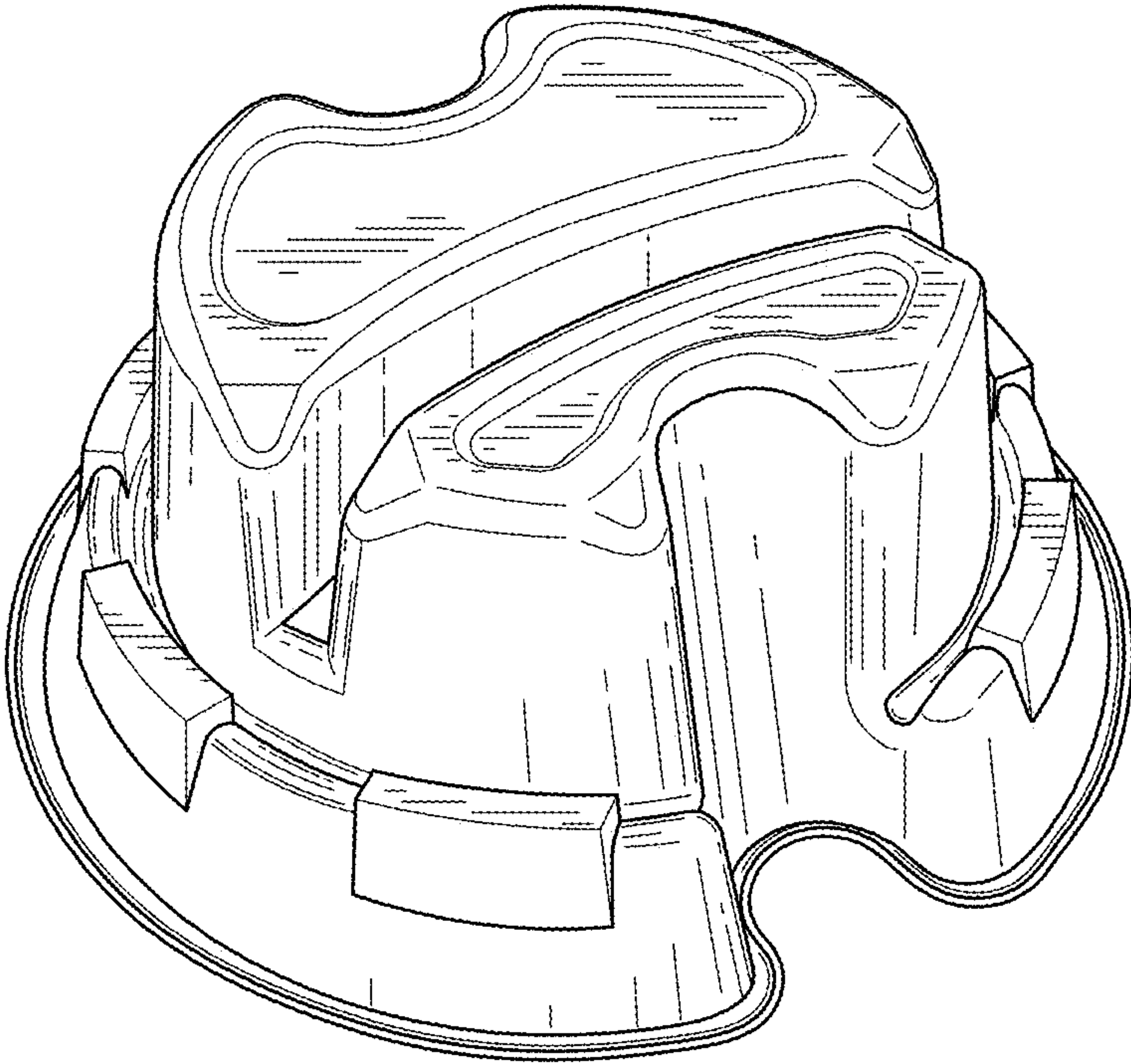

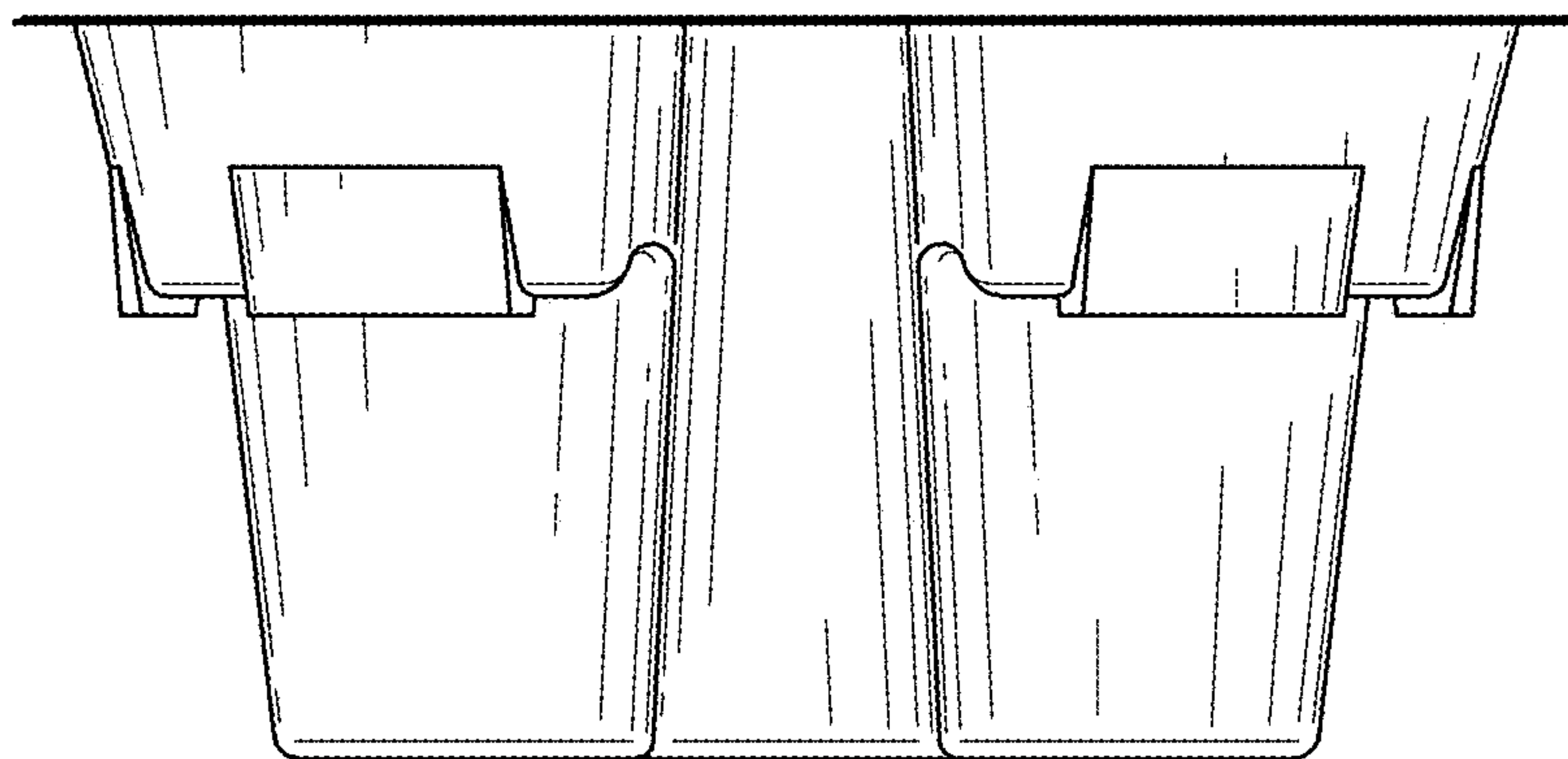

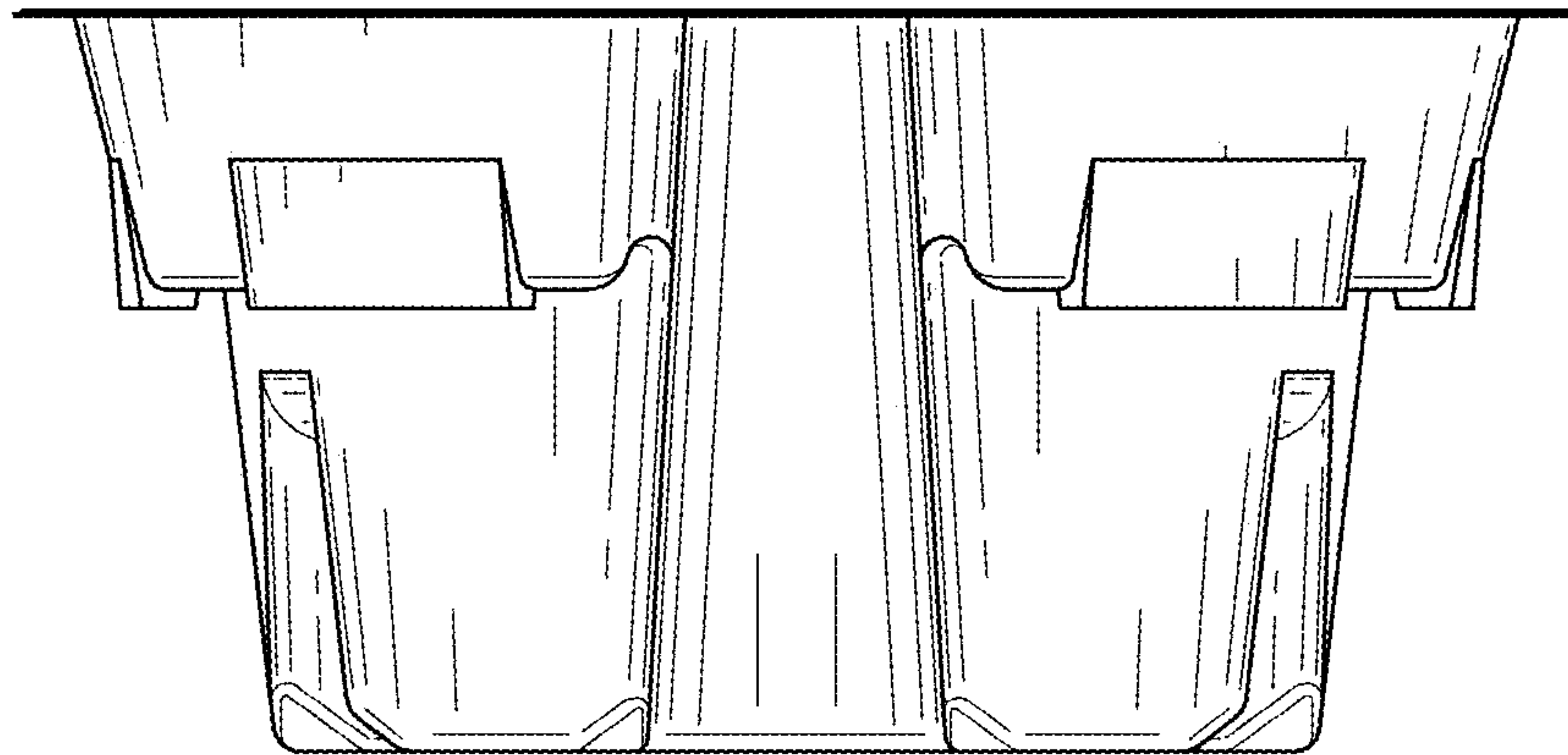

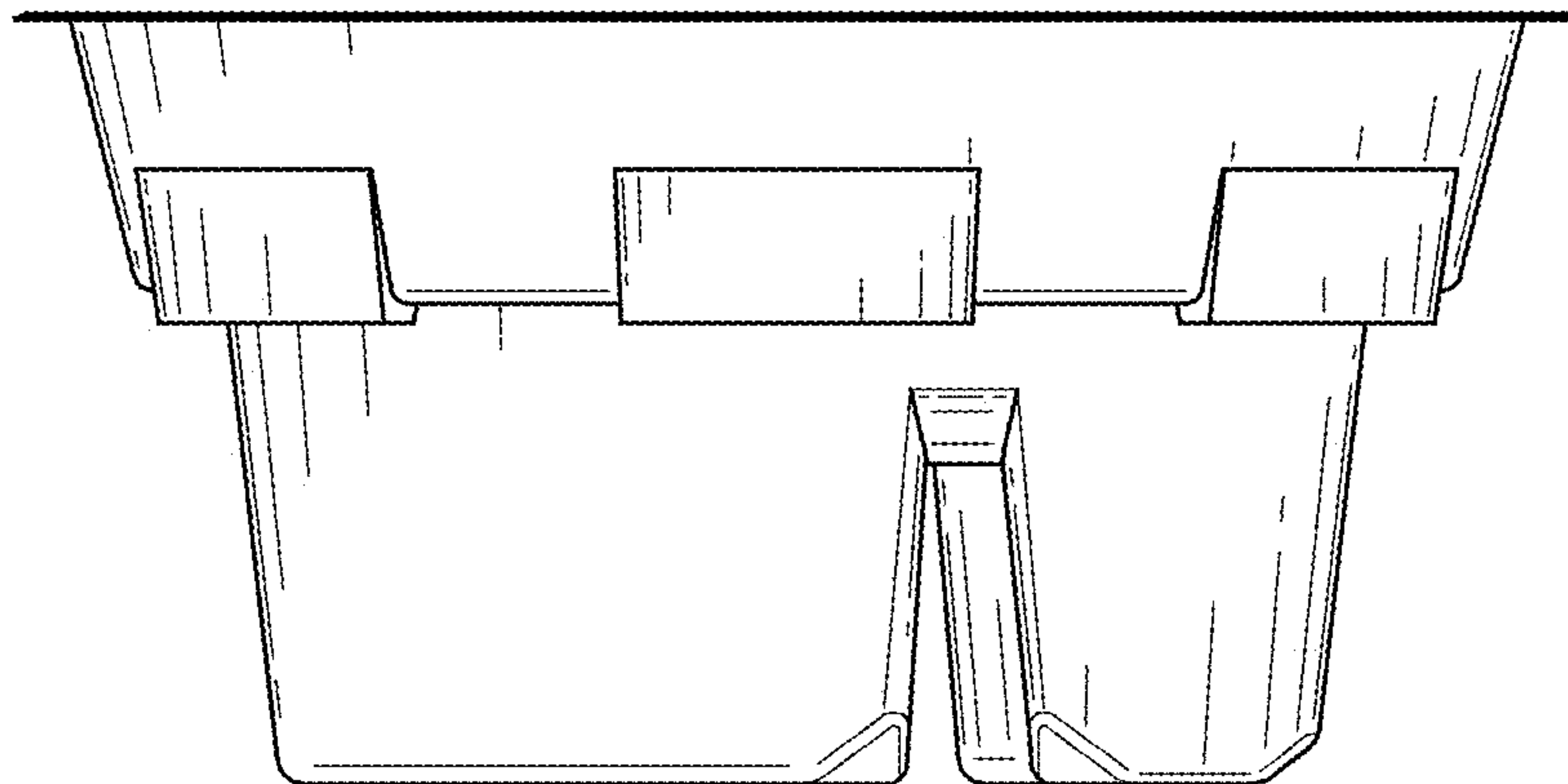

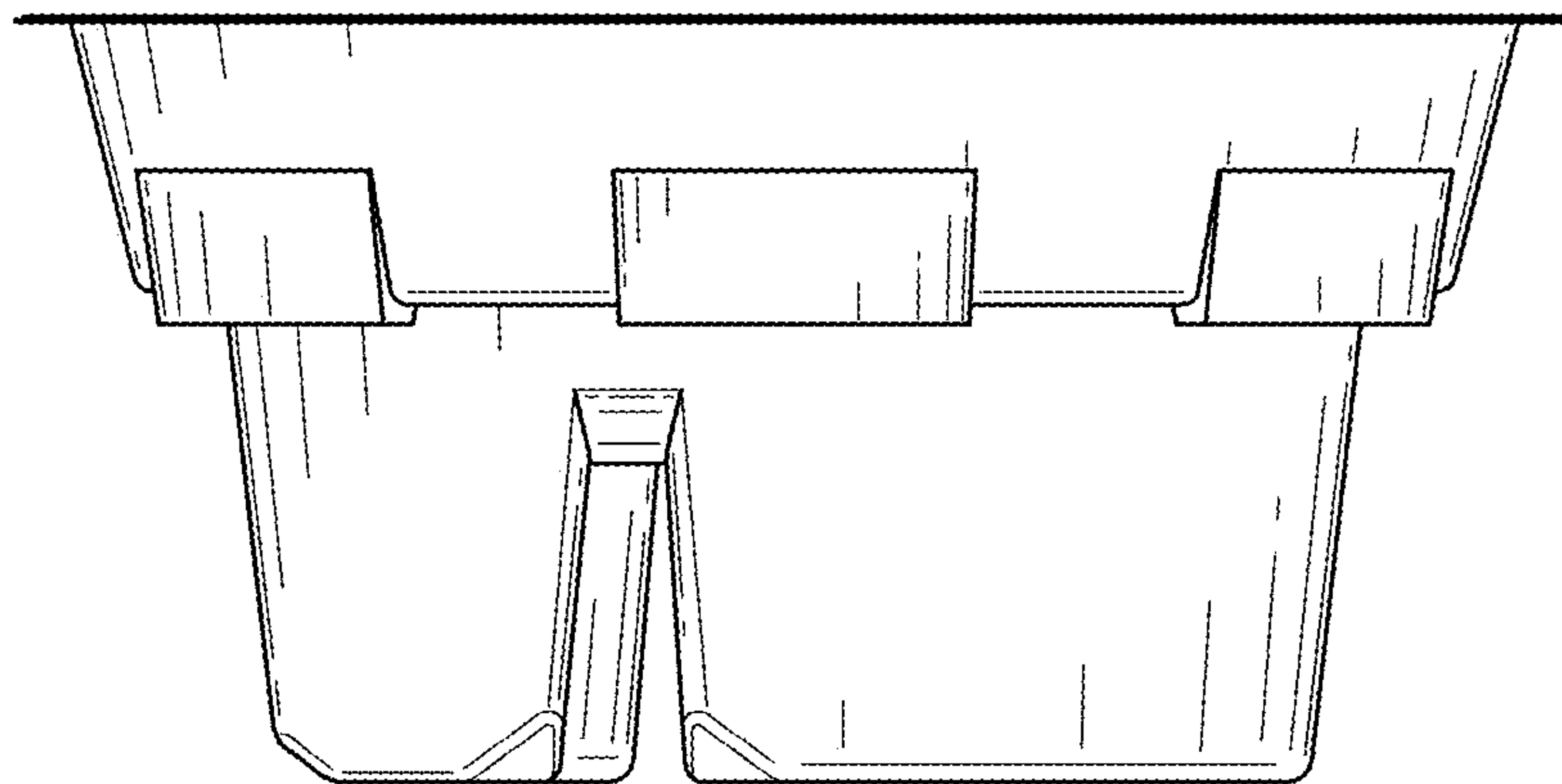

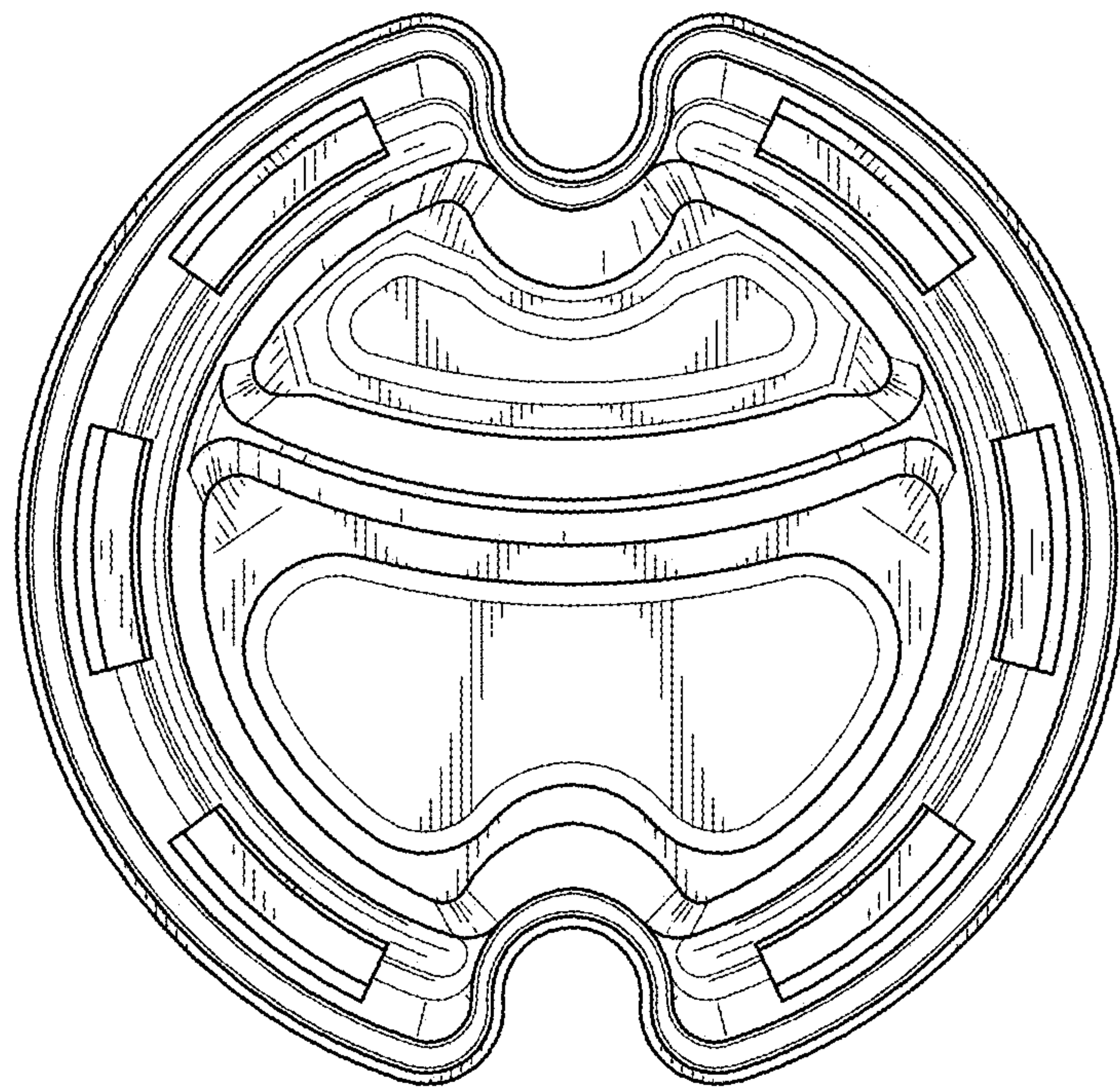
